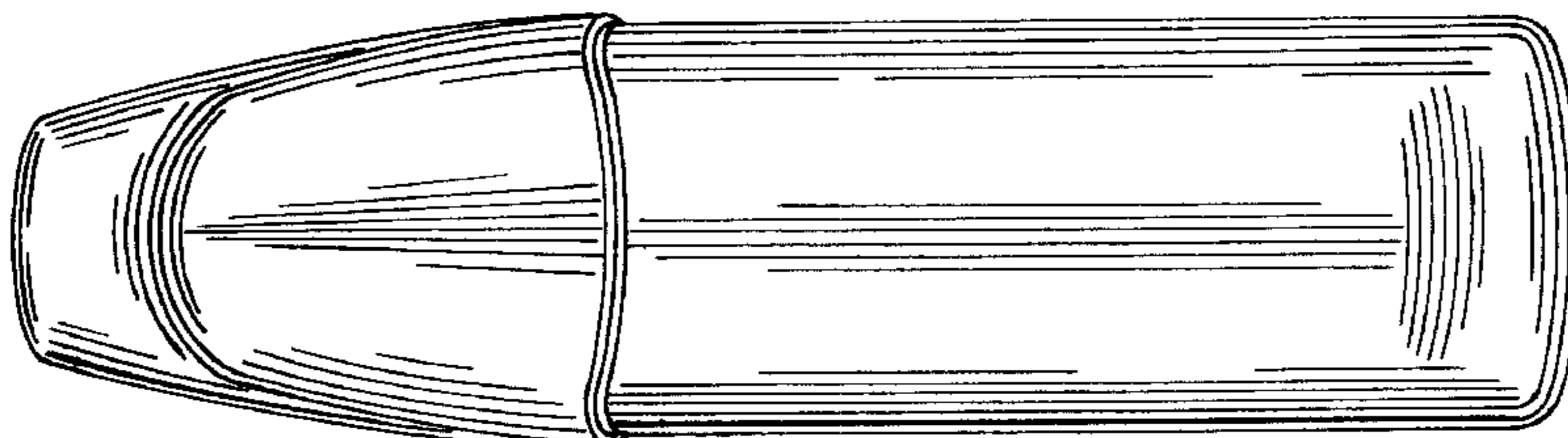
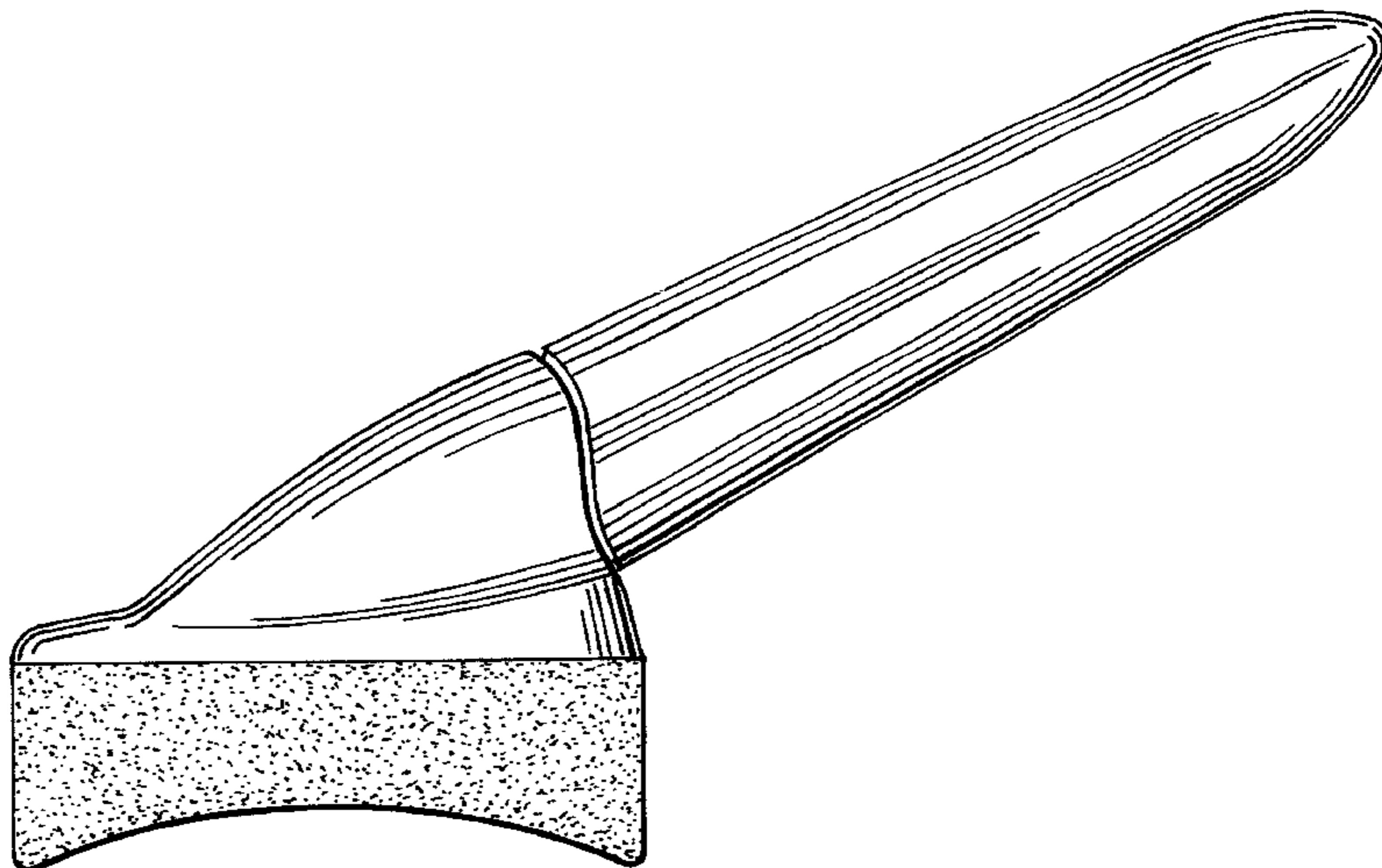
(57) **CLAIM**

The ornamental design for a combined tire sidewall protectant dispenser and applicator, as shown and described.

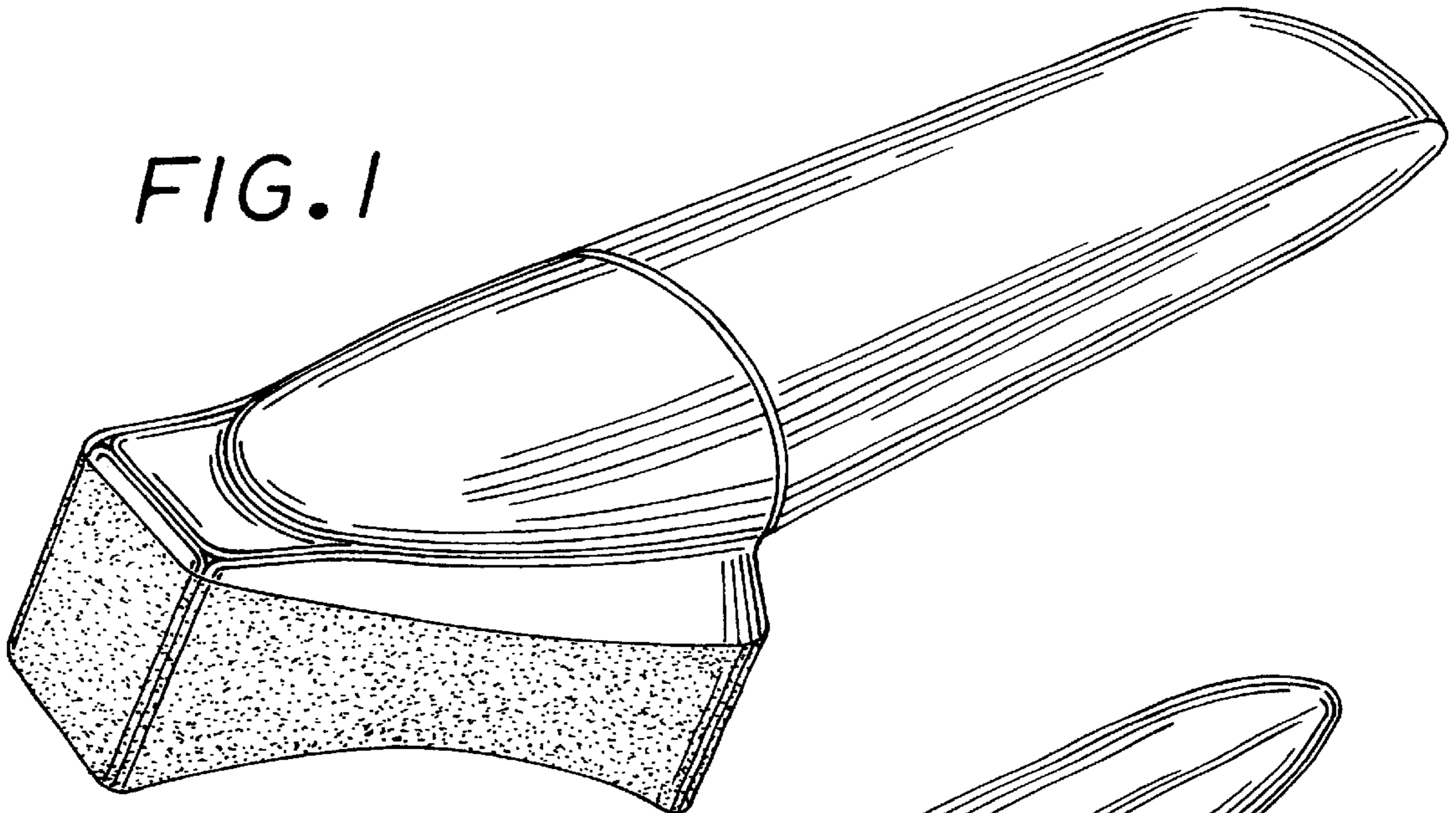
**DESCRIPTION**

FIG. 1 is a perspective view of a combined tire sidewall protectant dispenser and applicator showing our new design; FIG. 2 is a front view thereof, the opposite side being a mirror image of that shown; FIG. 3 is a top view thereof; FIG. 4 is a bottom view thereof; FIG. 5 is a left end view thereof; and, FIG. 6 is a right end view thereof.

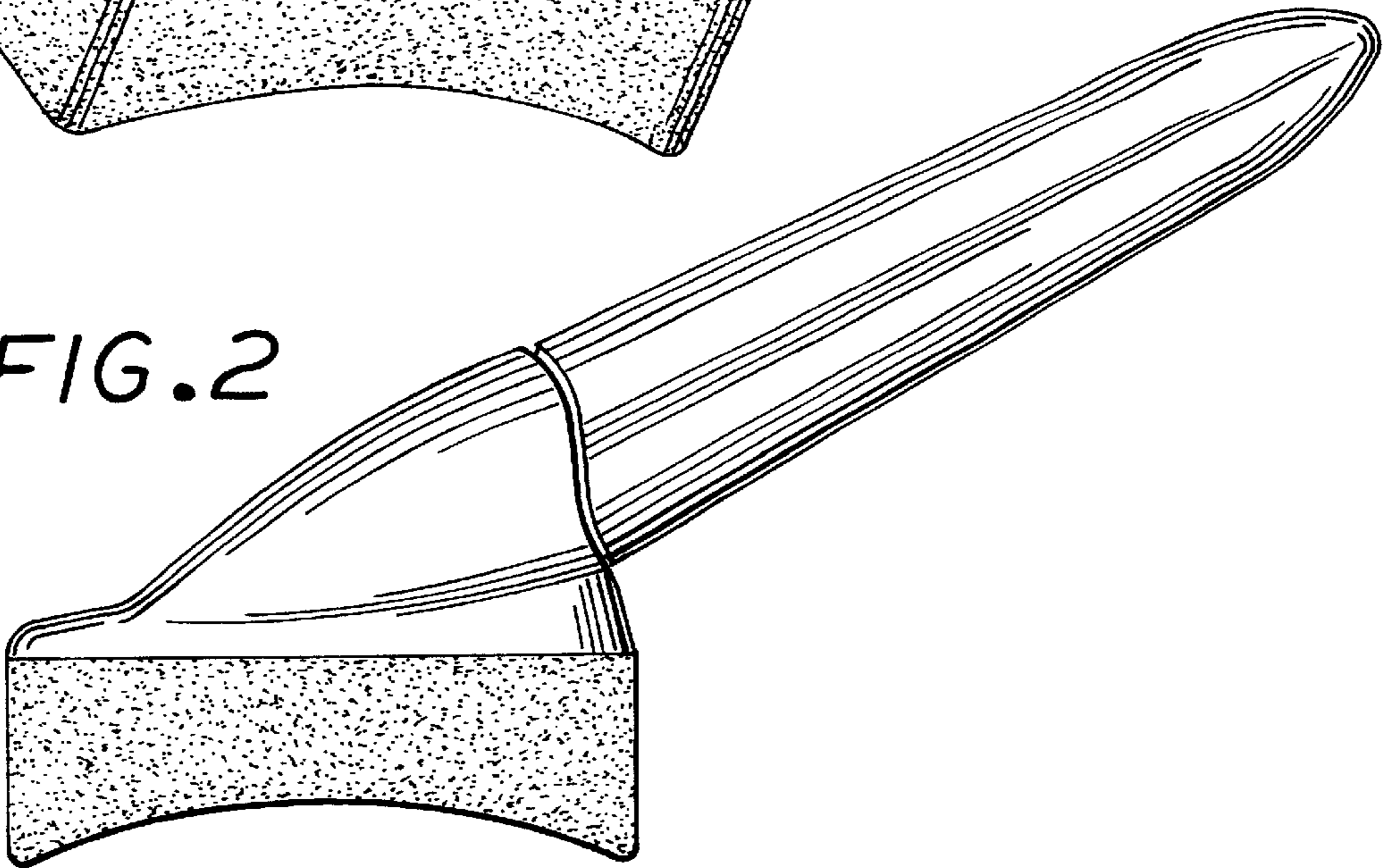

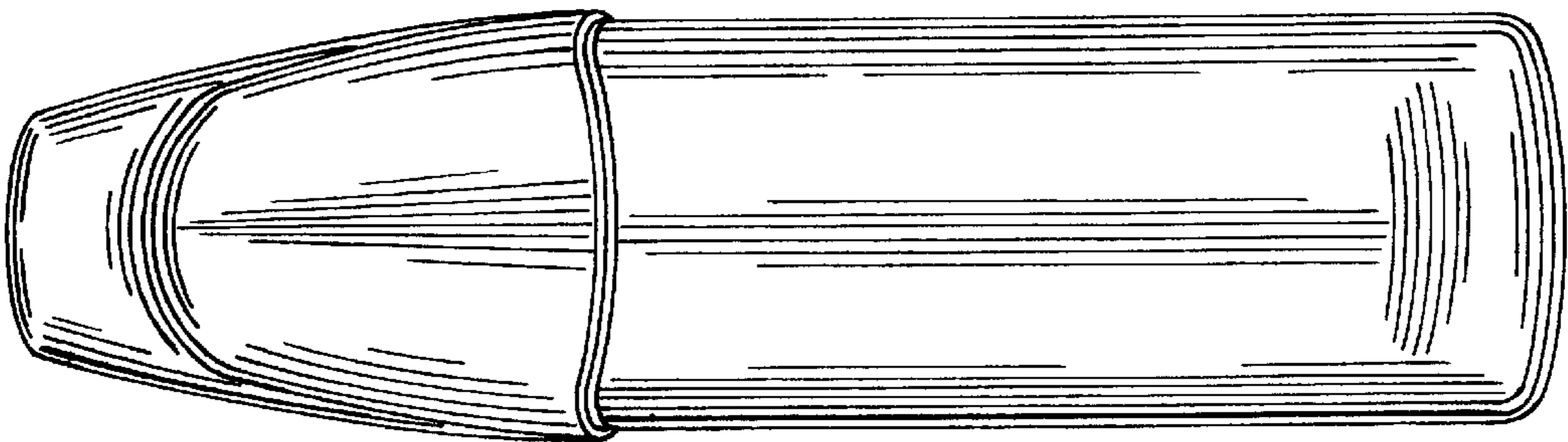

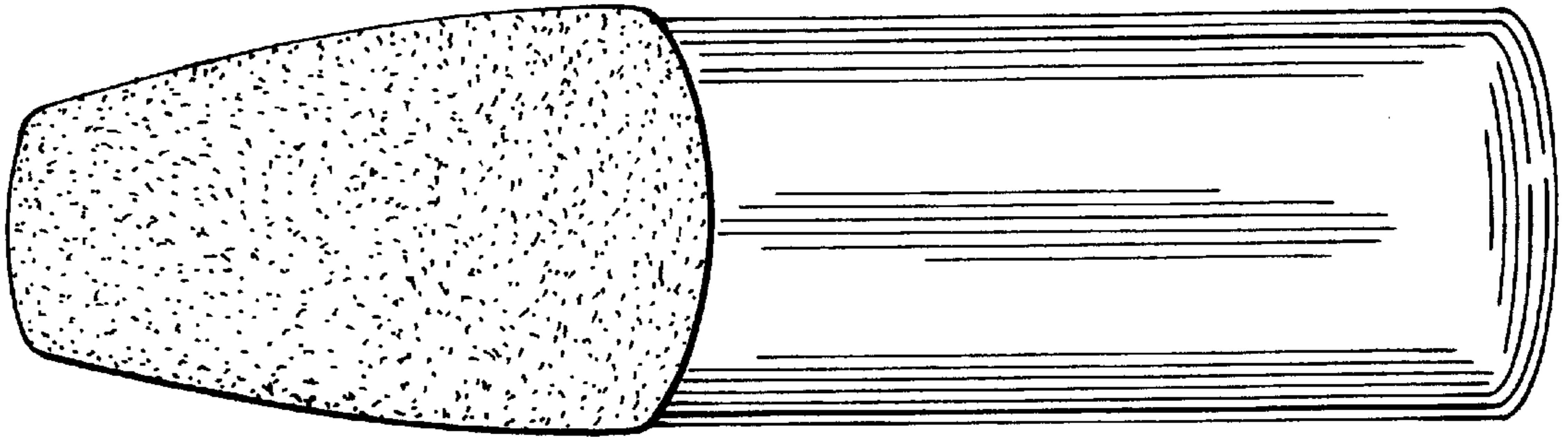

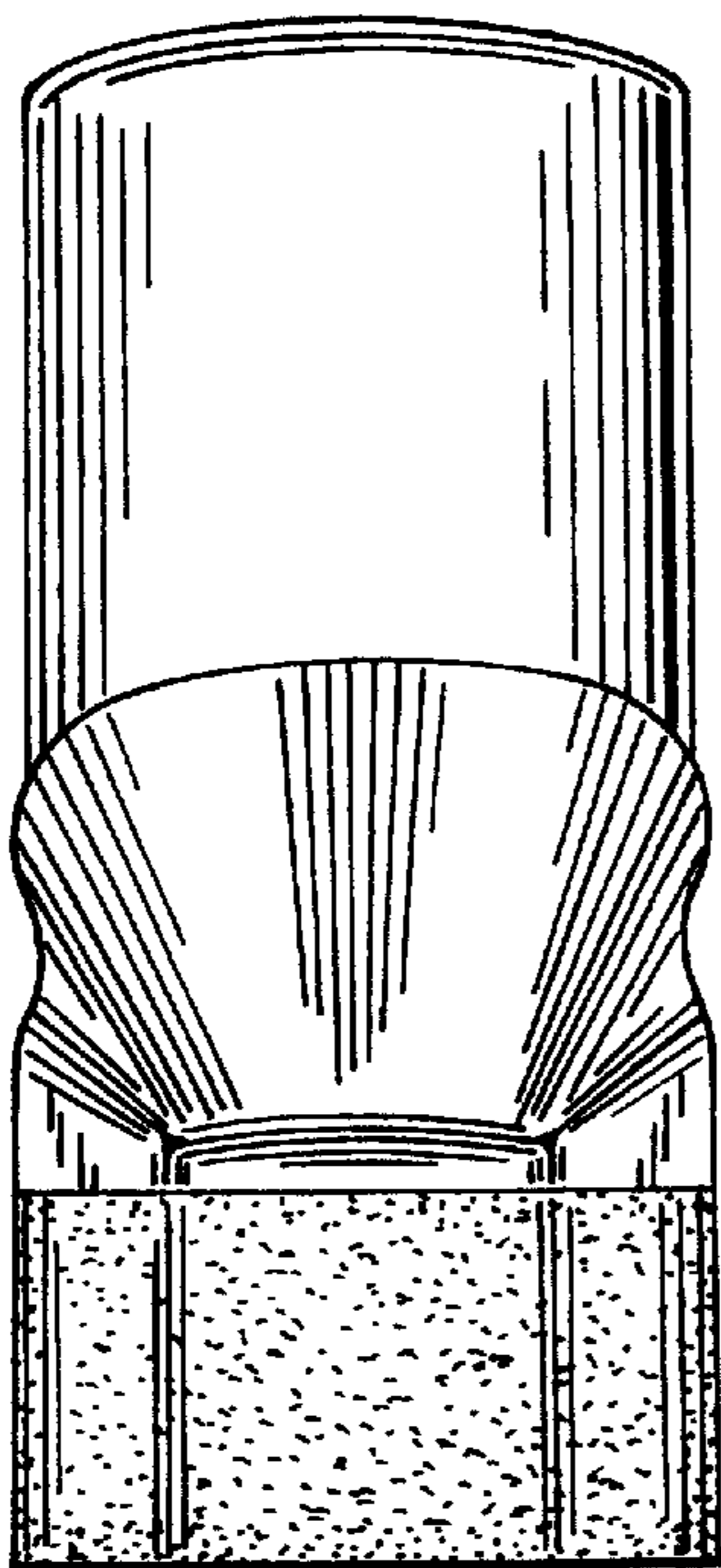
