(57) **CLAIM**

The ornamental design for a housekeeping cart, as shown and described.

**DESCRIPTION**

FIG. 1 is a frontal perspective view of a housekeeping cart according to our new design;  
FIG. 2 is a top view of the cart shown in FIG. 1;  
FIG. 3 is a bottom view of the cart shown in FIG. 1;  
FIG. 4 is a right side view of the cart shown in FIG. 1;  
FIG. 5 is left side view of the cart shown in FIG. 1;

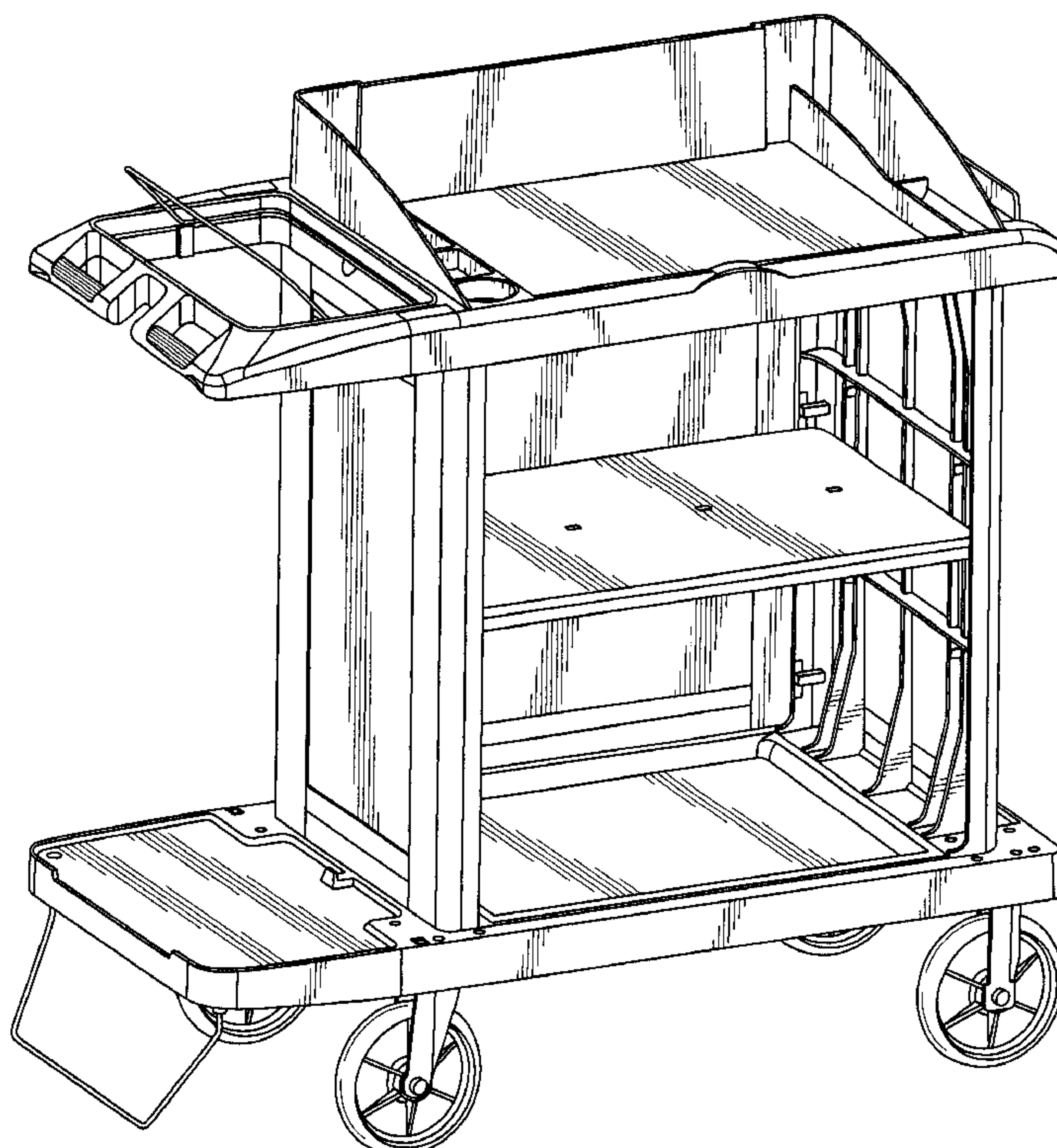

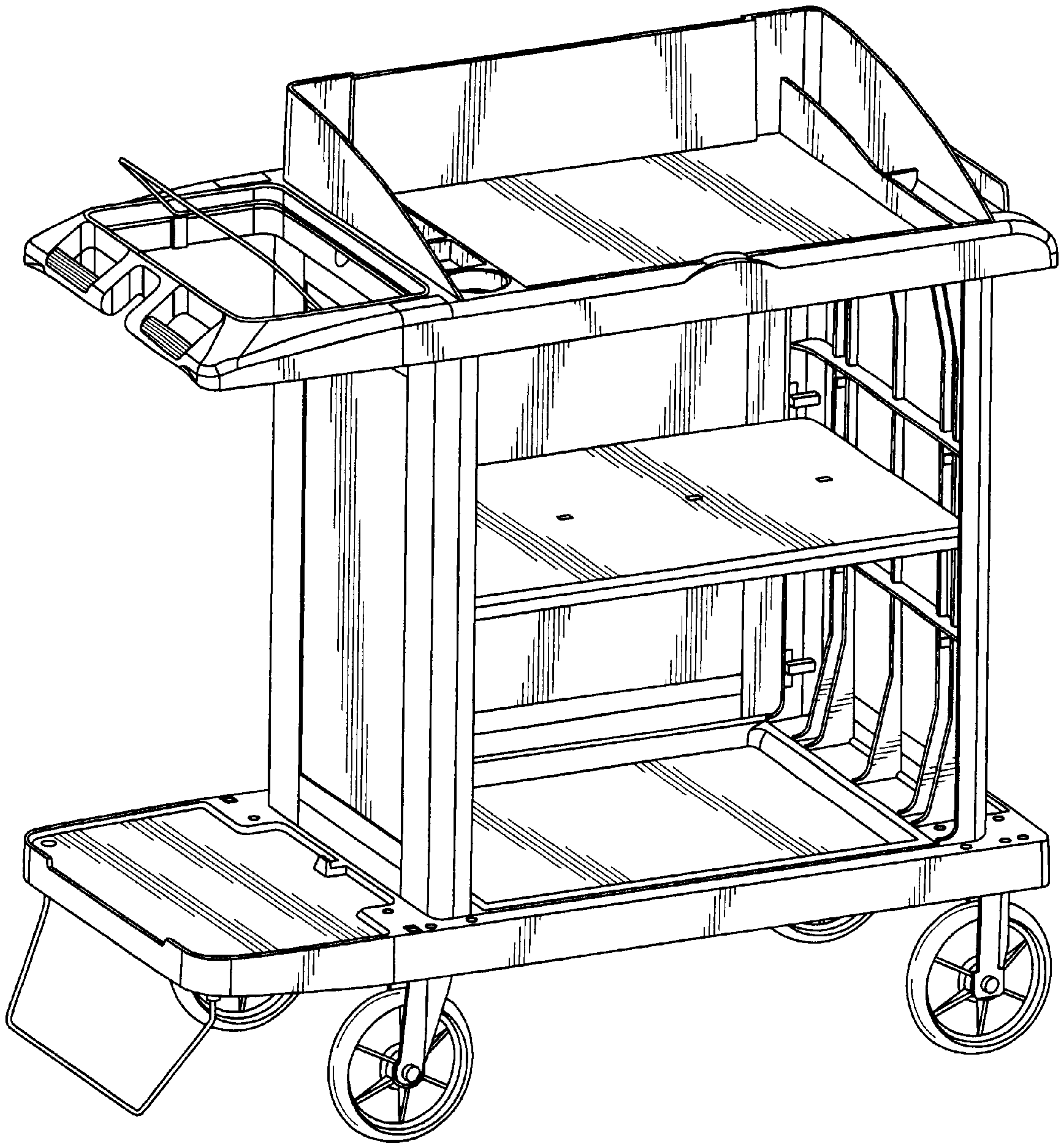

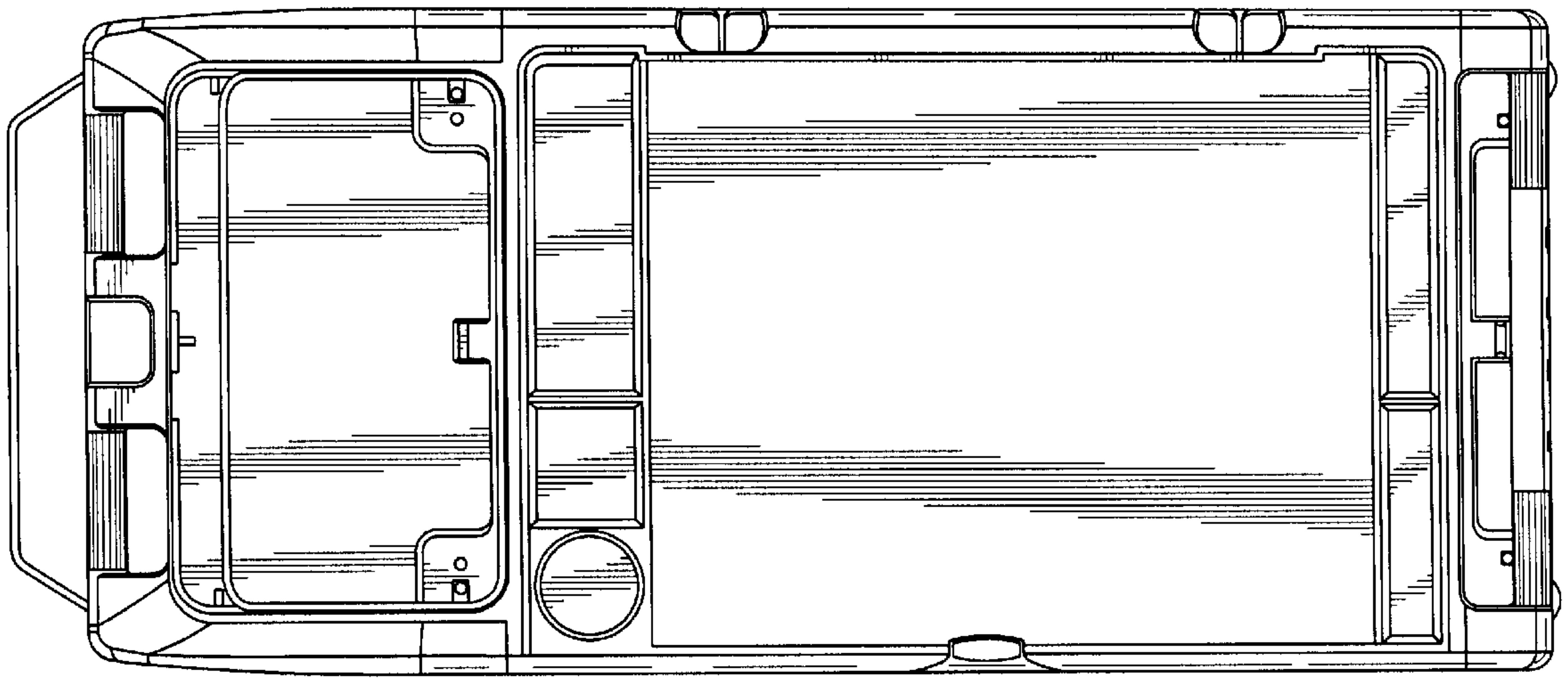

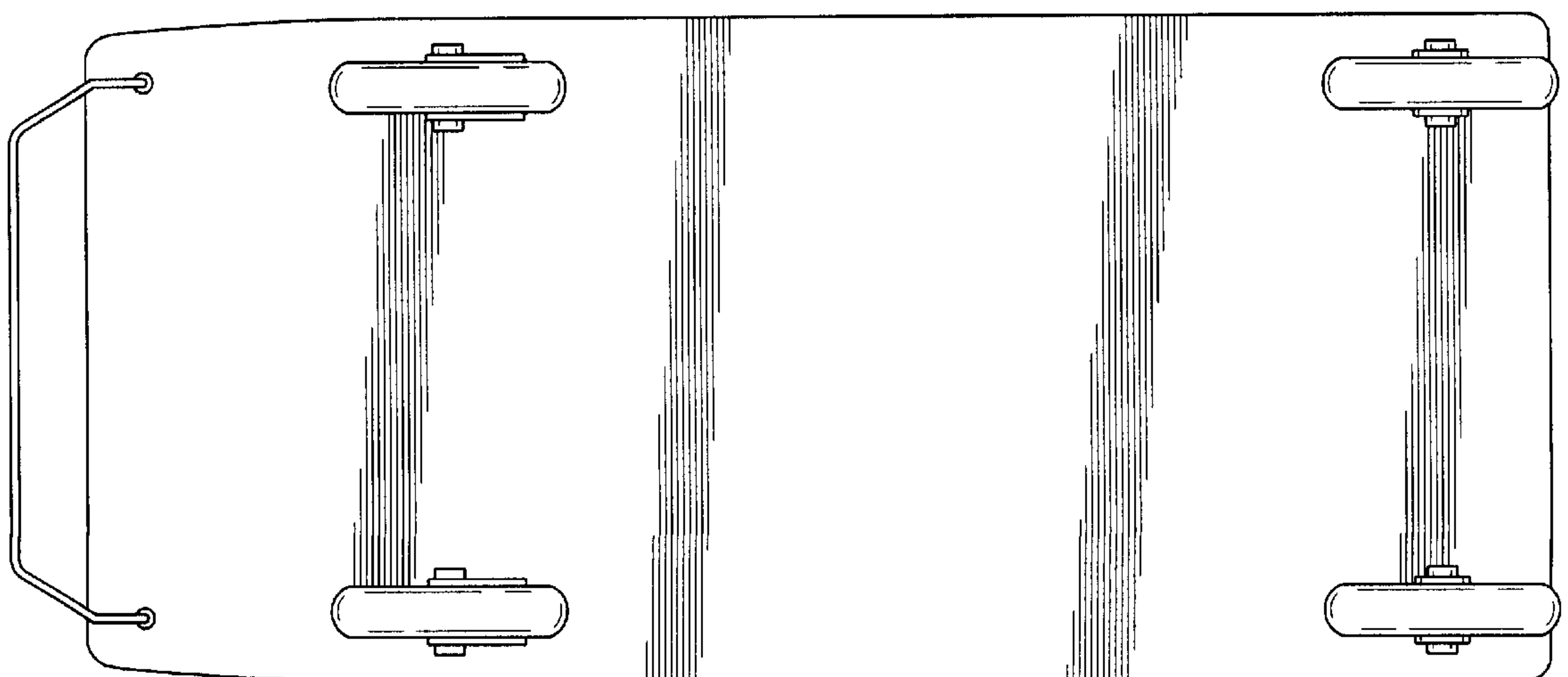

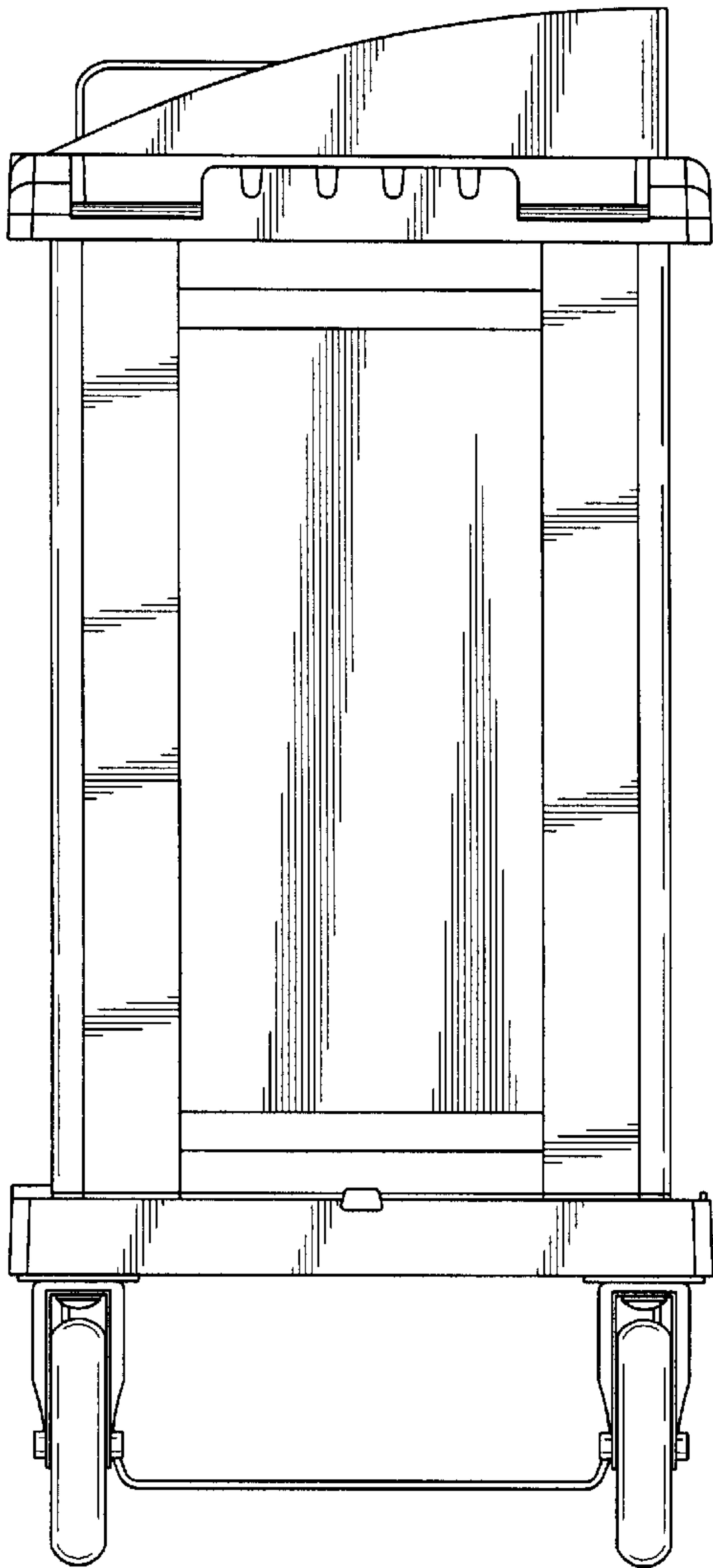

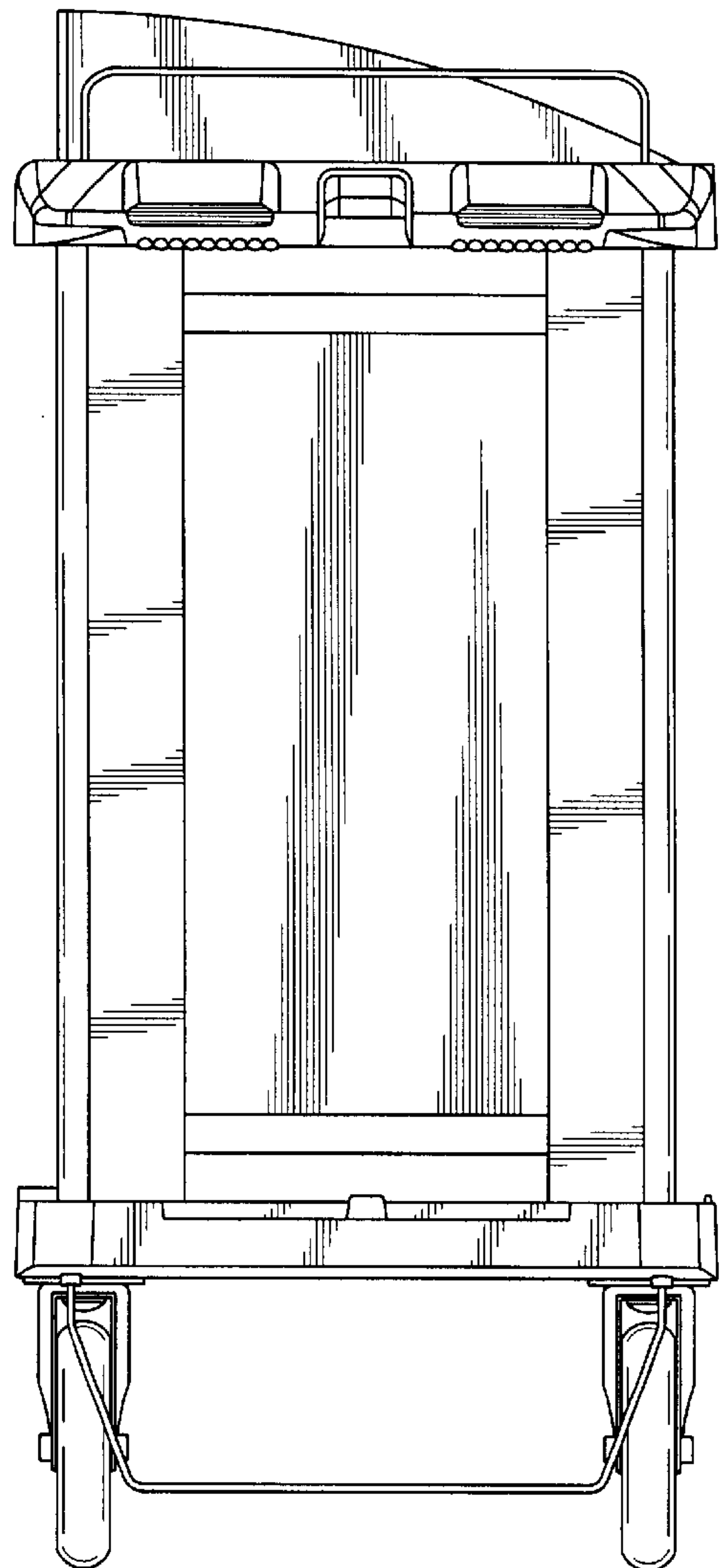

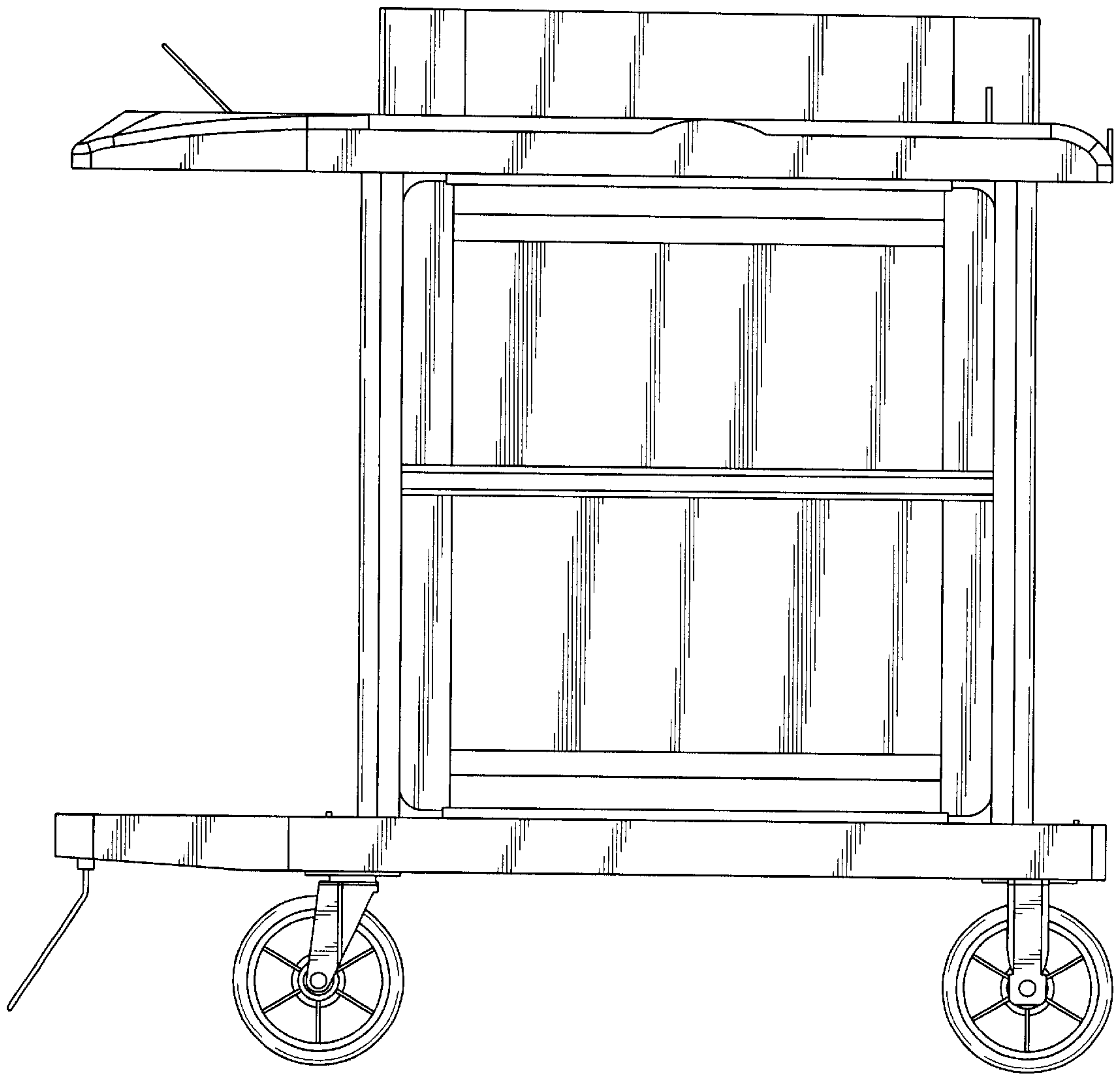
