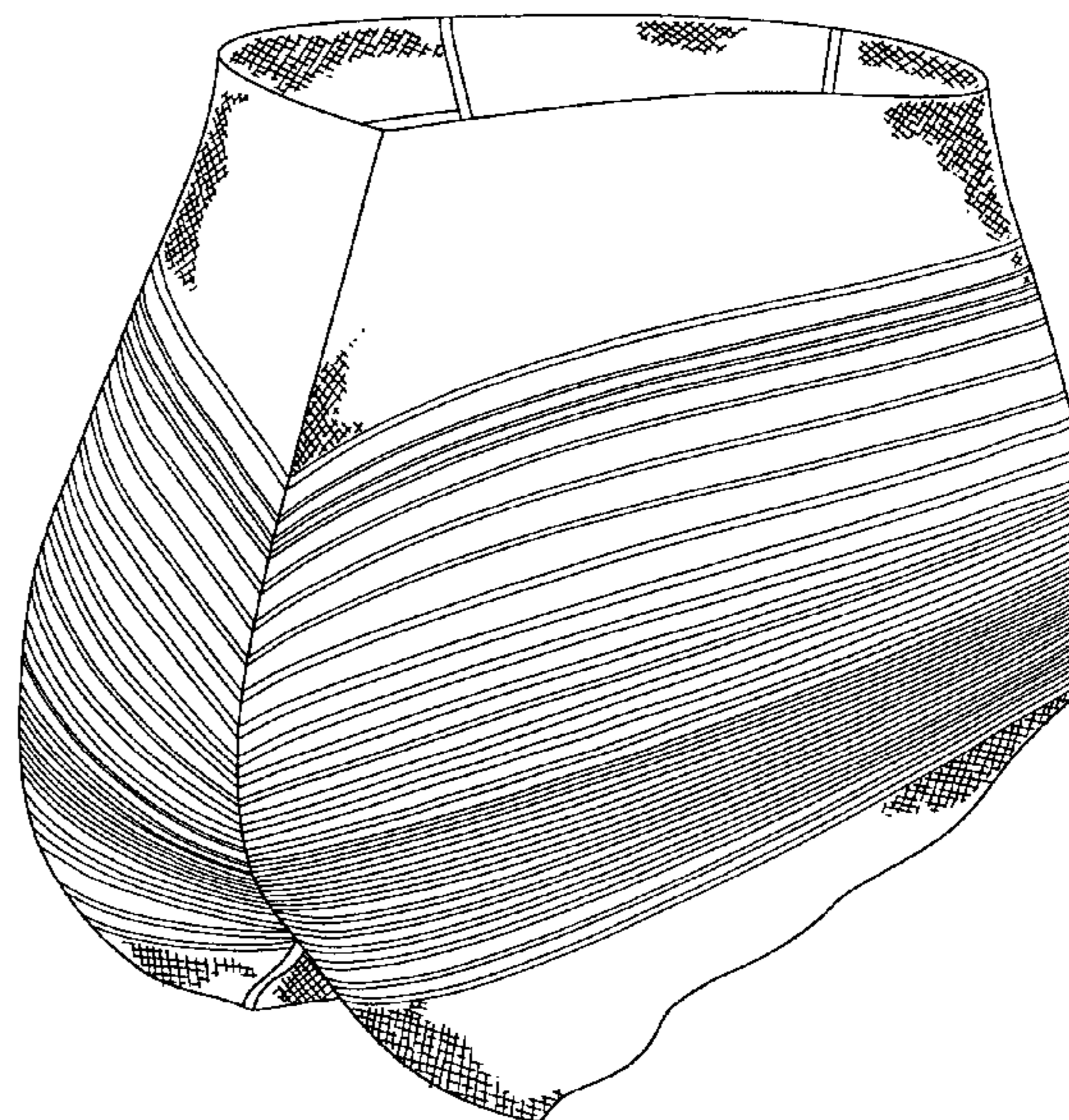
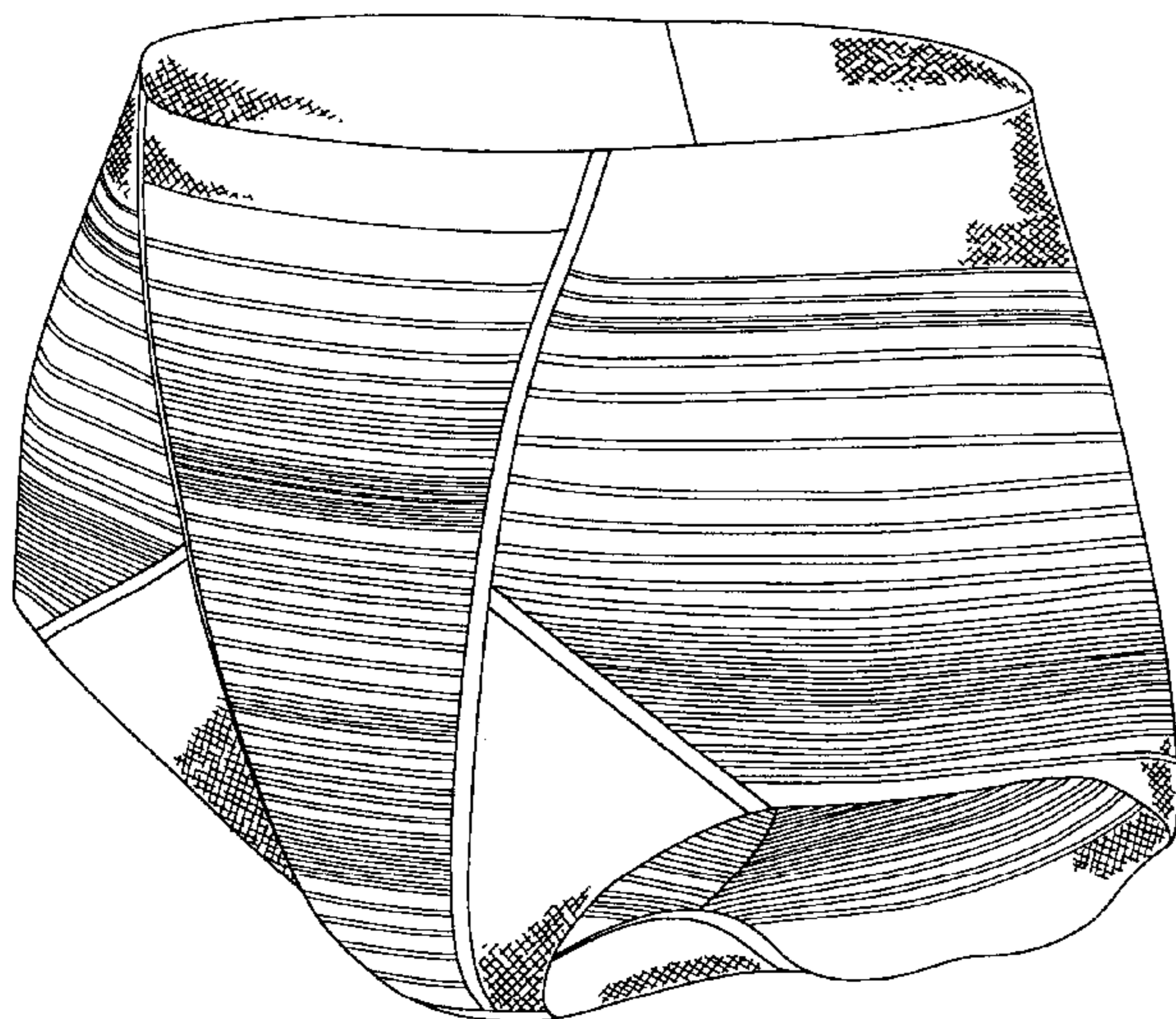
The ornamental design for a girdle, as described and shown.

**DESCRIPTION**

FIG. 1 is a front view of a girdle of the present invention. FIG. 2 is a rear view of the girdle of FIG. 1. FIG. 3 is a left side view of the girdle of FIG. 1. FIG. 4 is a right side view of the girdle of FIG. 1. FIG. 5 is a plan view of the girdle of FIG. 1. FIG. 6 is a bottom view of the girdle of FIG. 1. FIG. 7 is a front perspective view of the girdle of FIG. 1. FIG. 8 is a rear perspective view of the girdle of FIG. 1. FIG. 9 is a front perspective view of the girdle of FIG. 1 in use; and, FIG. 10 is a rear perspective view of the girdle of FIG. 1 in use.

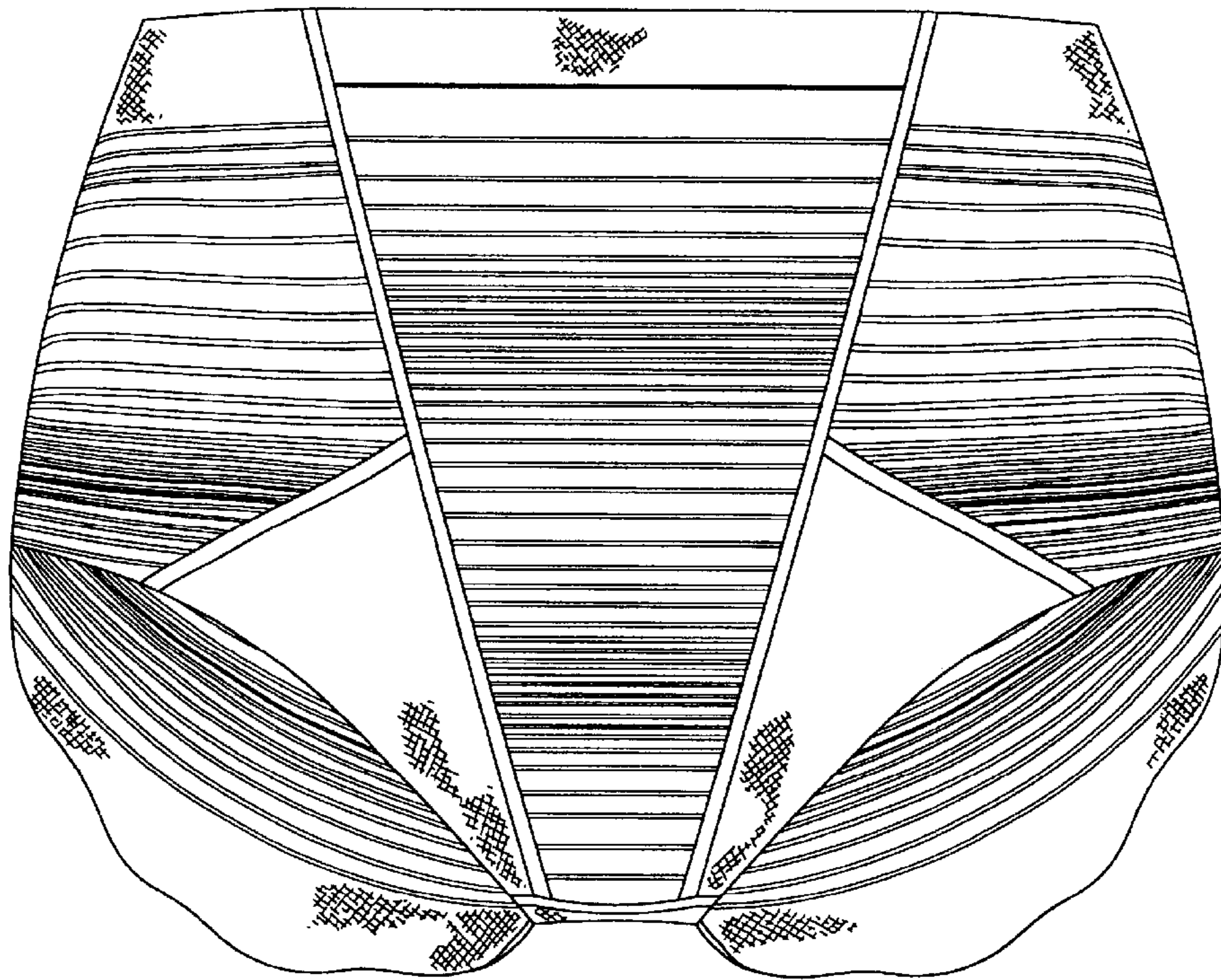

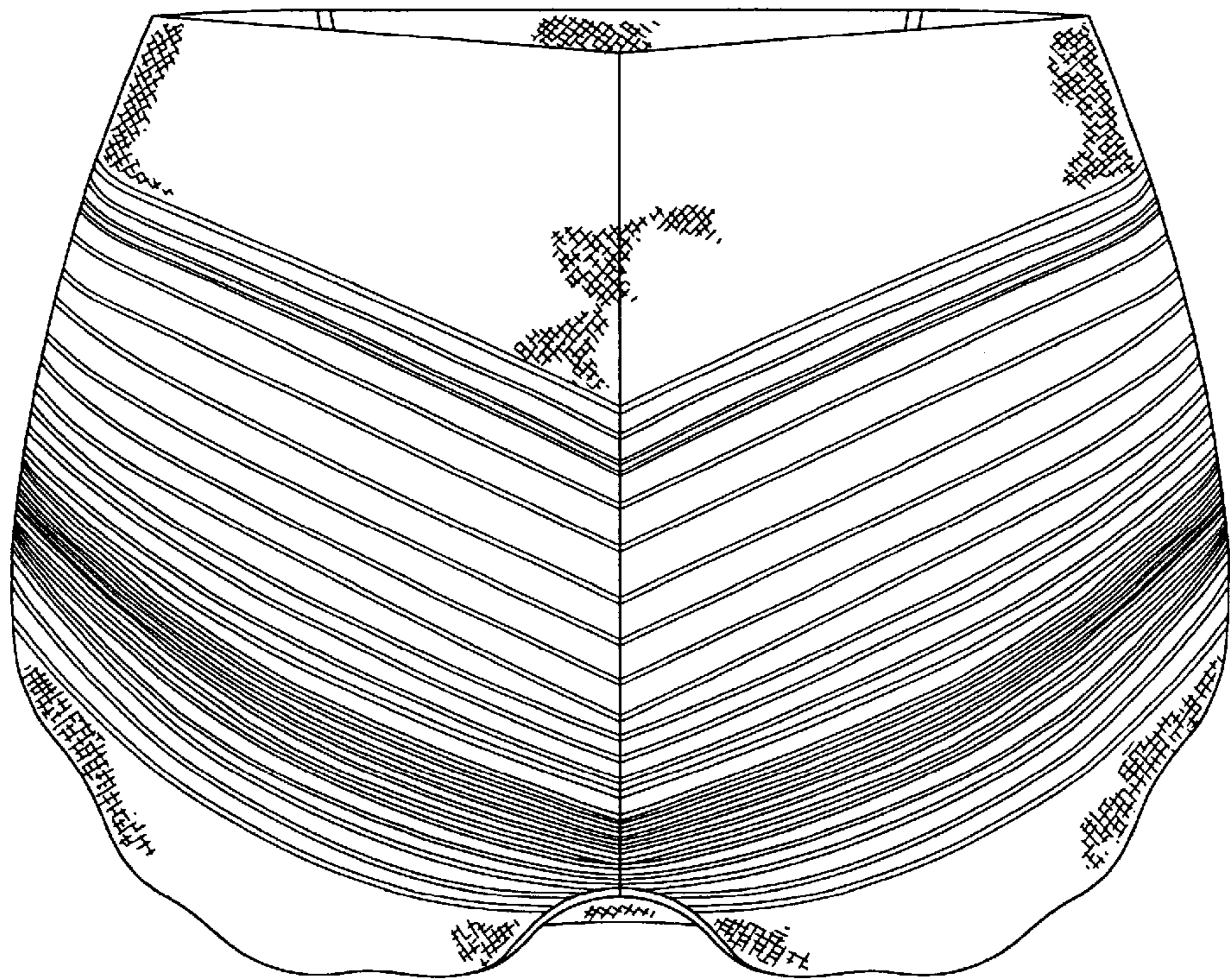

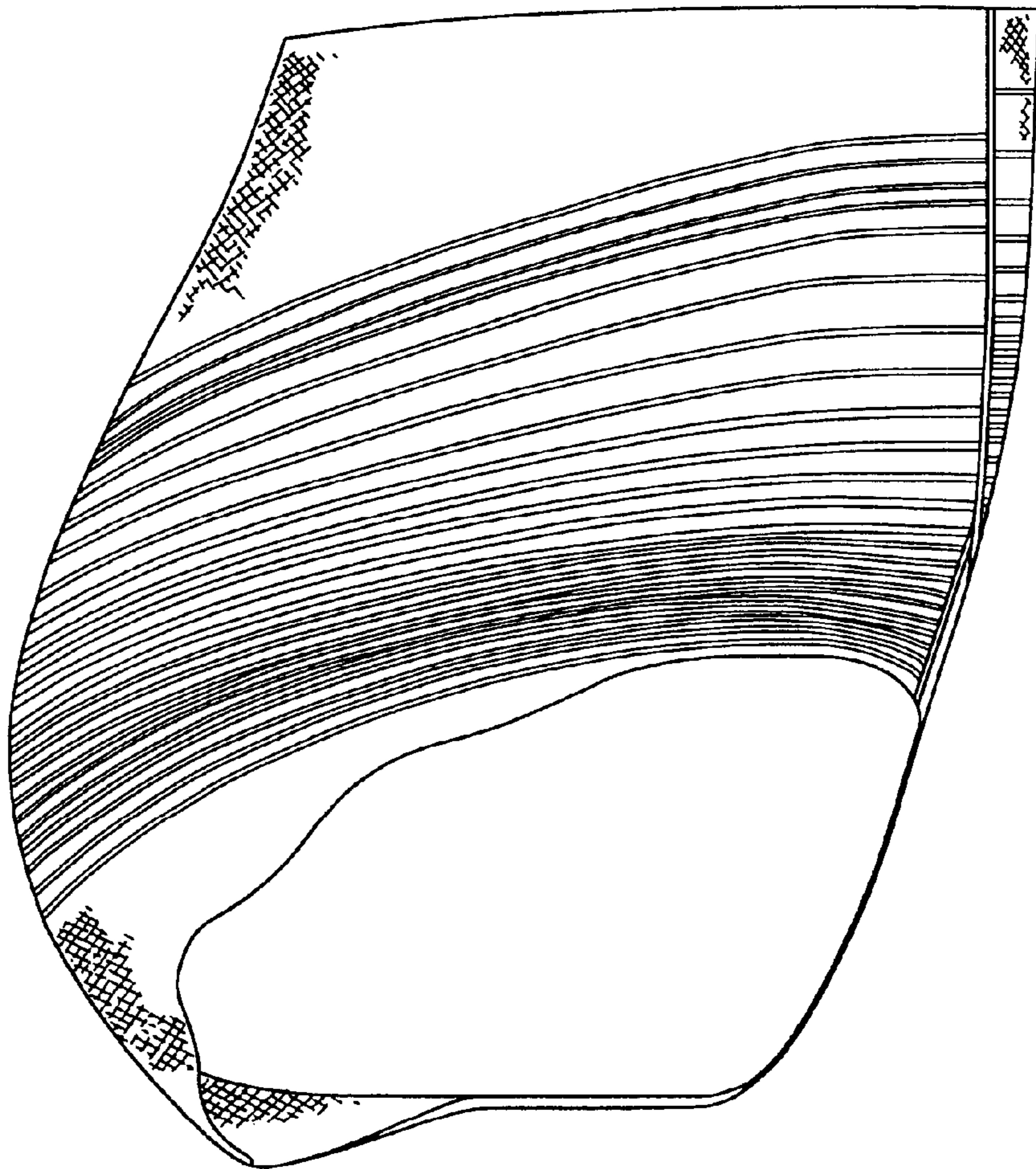

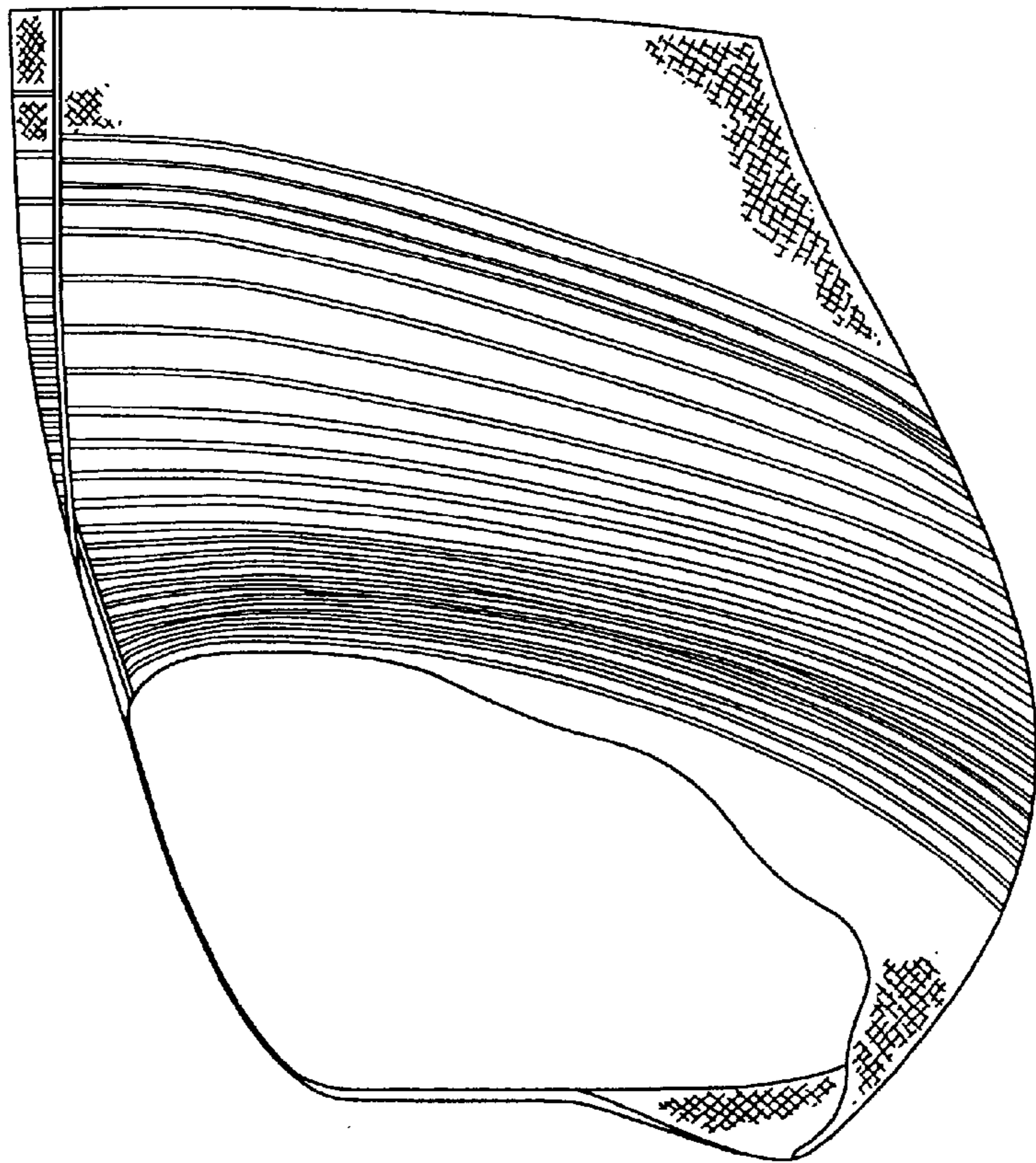

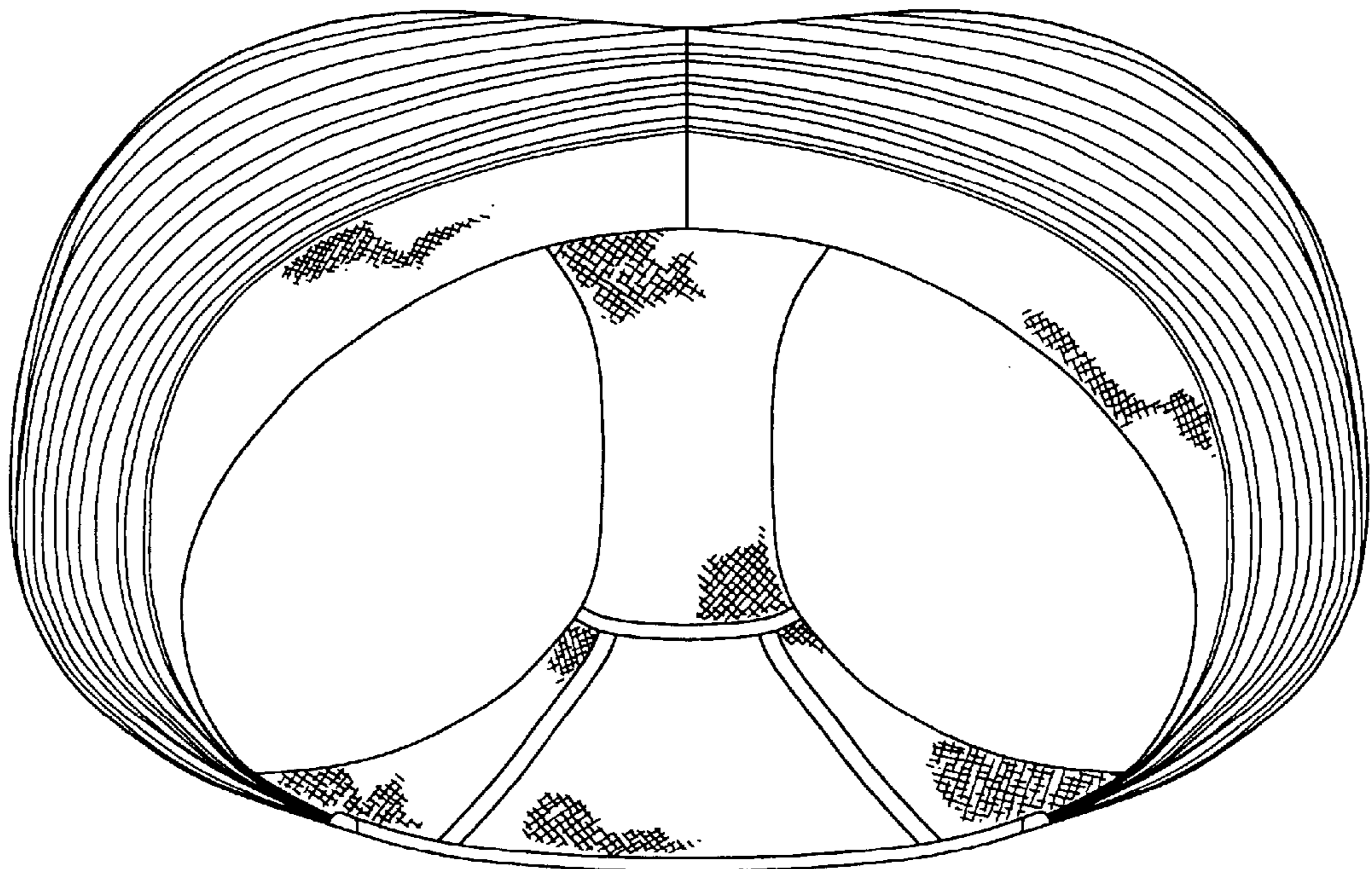

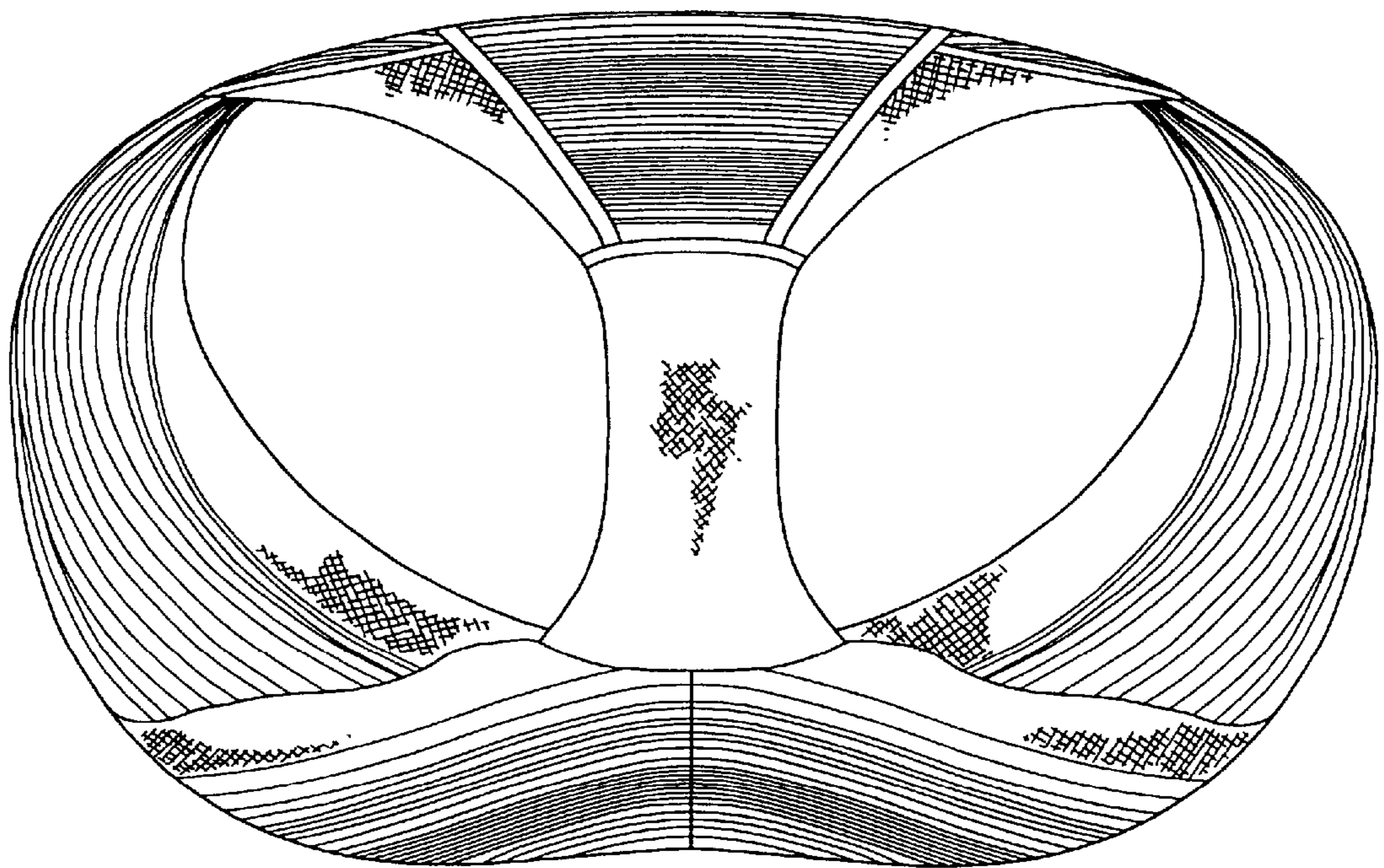

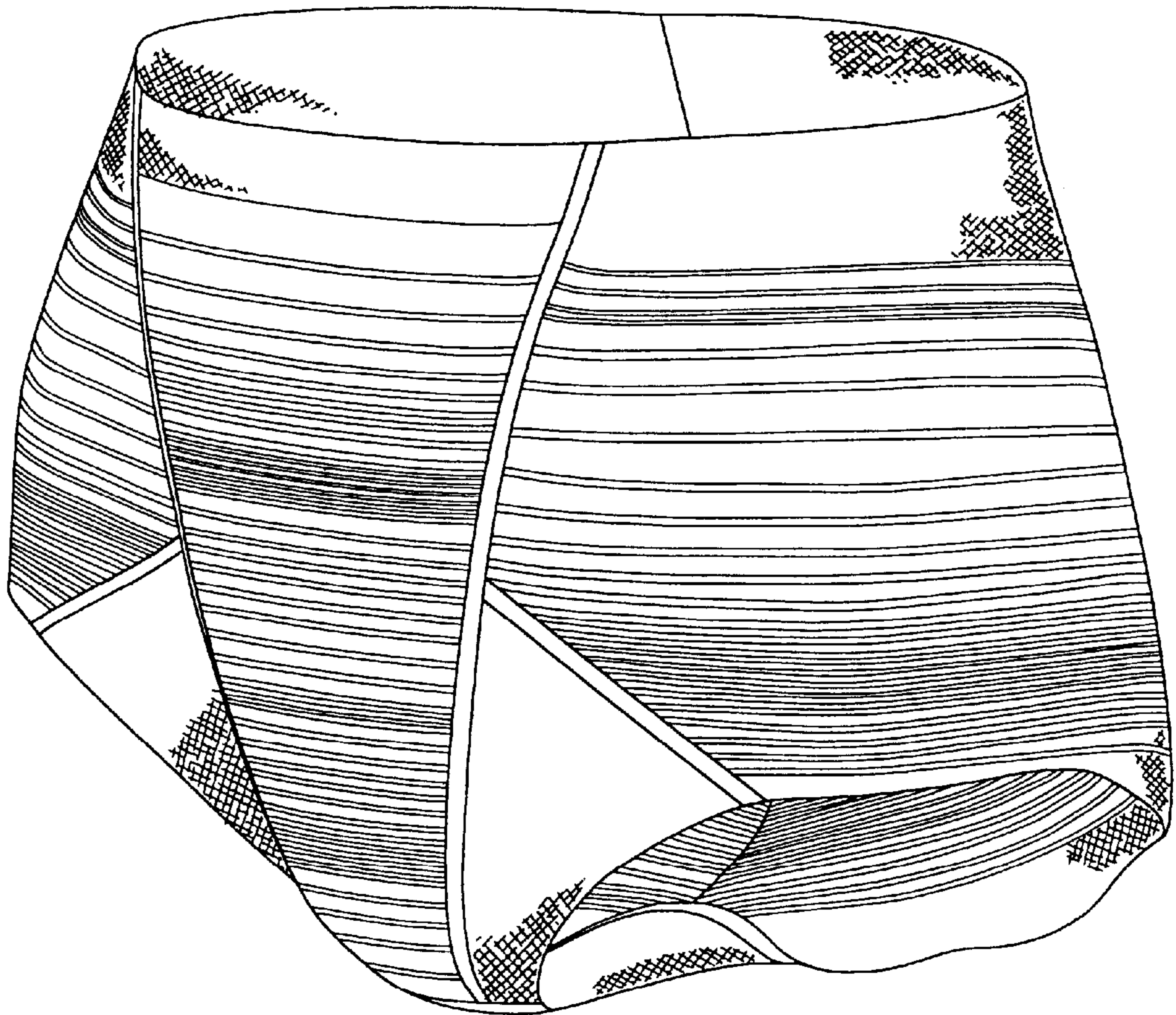

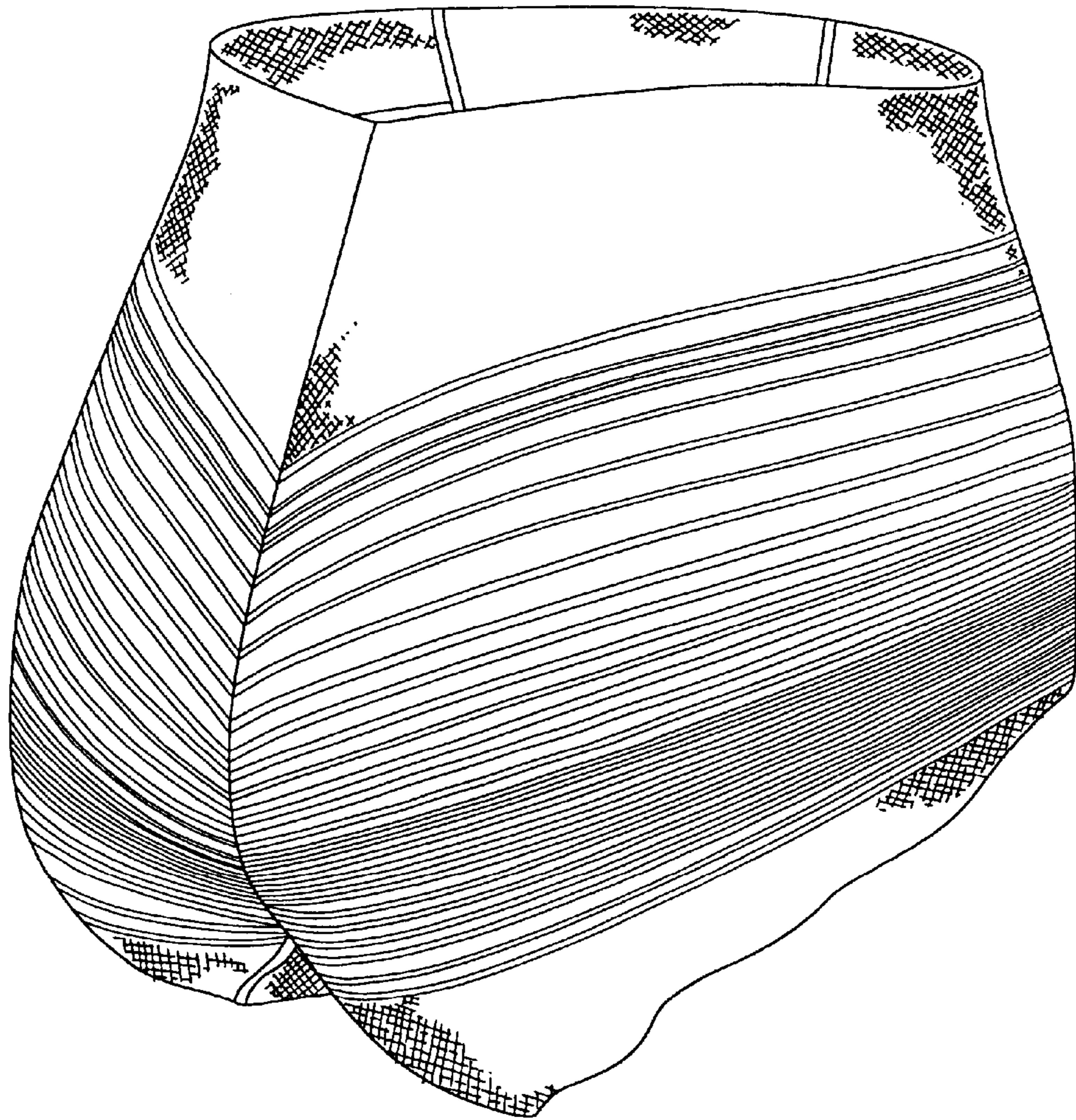

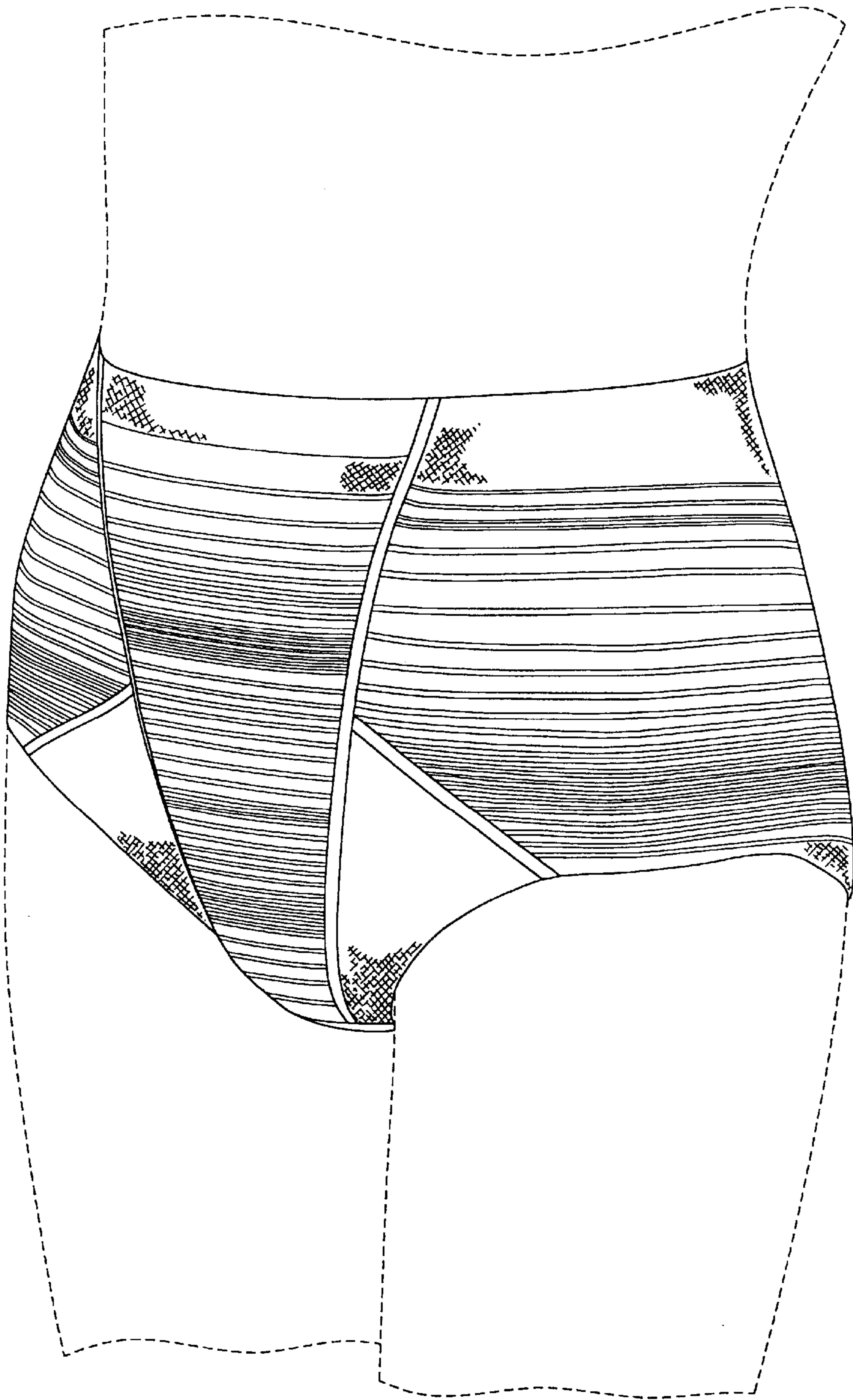

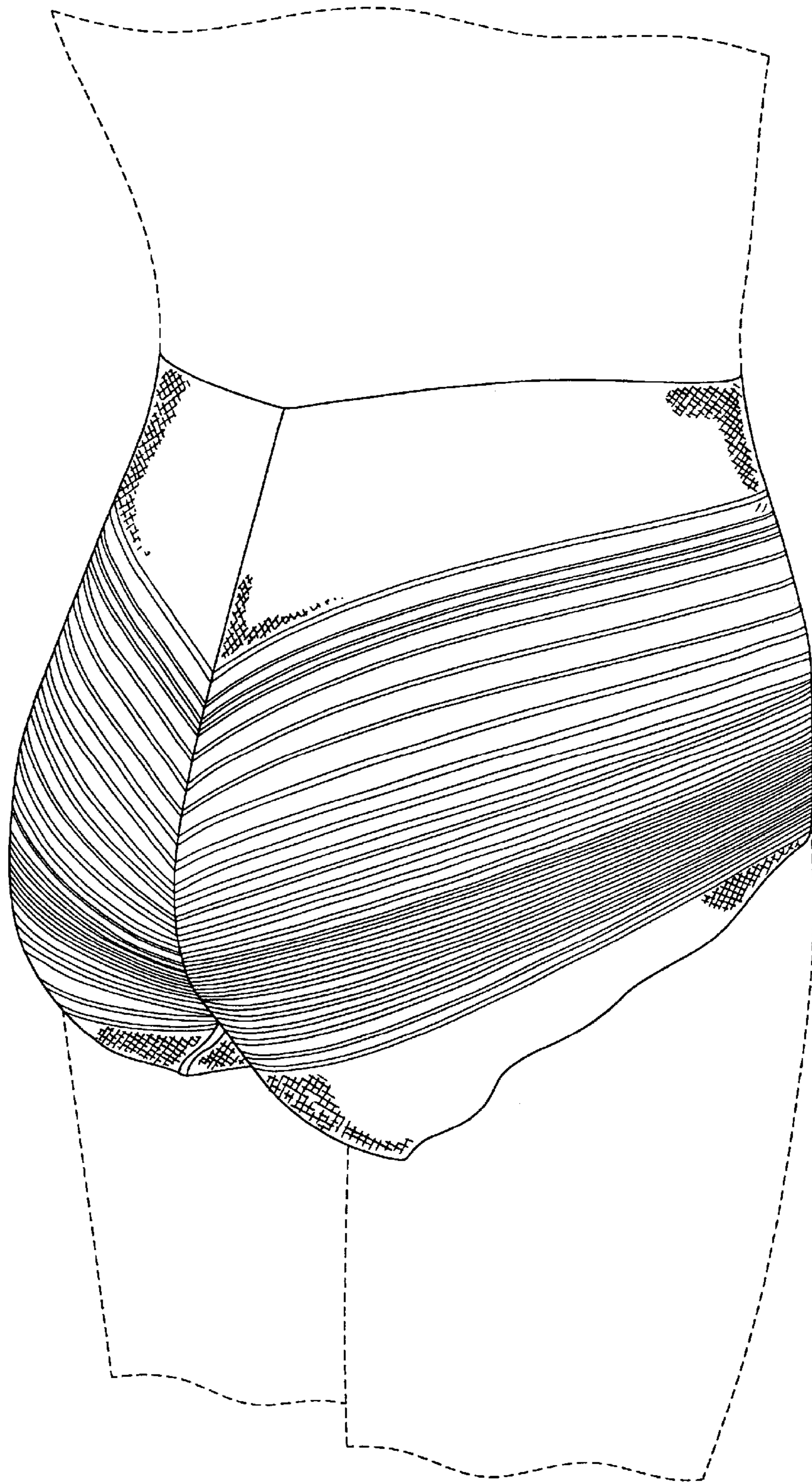
