**DESCRIPTION**

FIG. 3. Is a top plan view thereof;

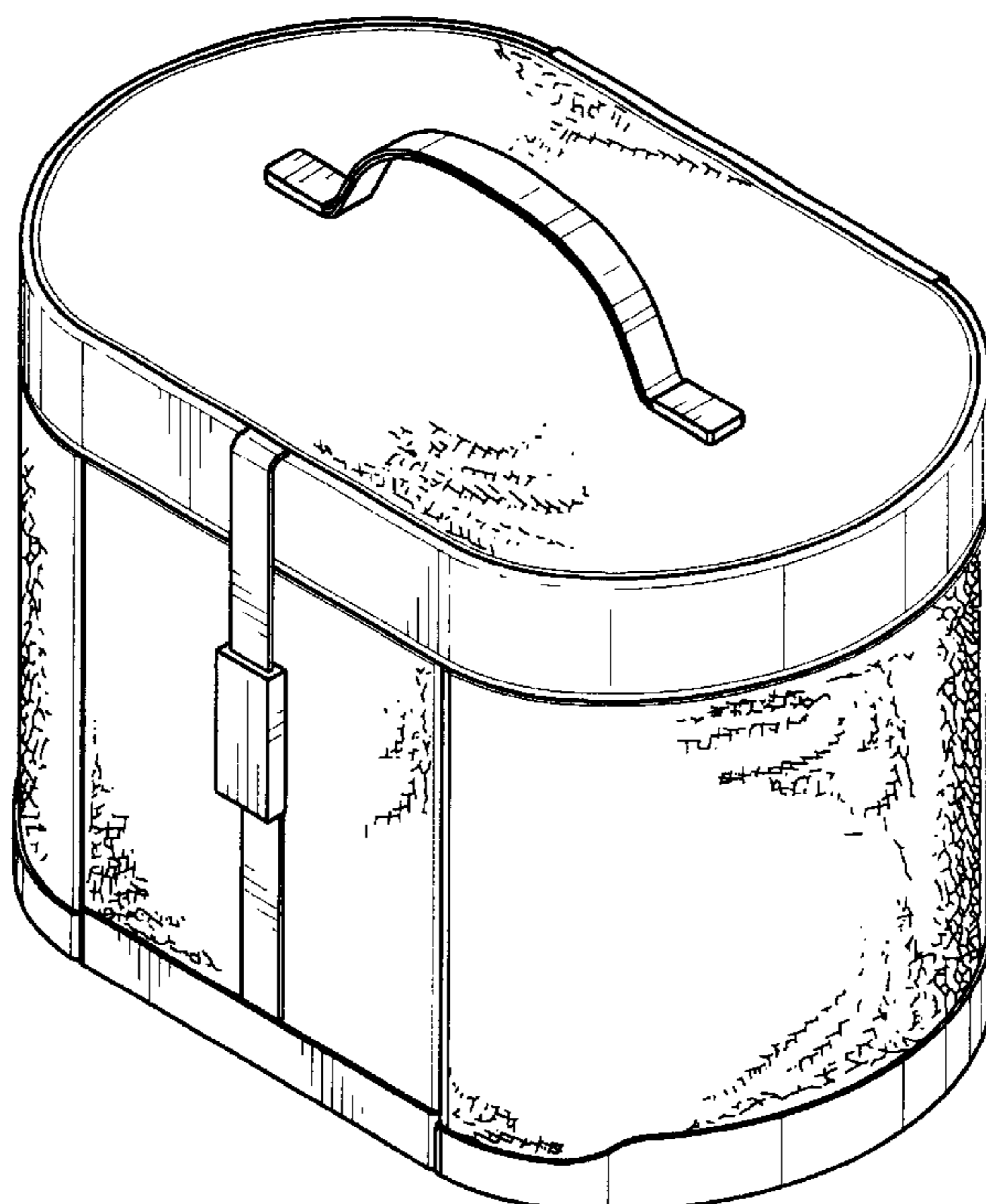
FIG. 4. Is a bottom plan view thereof;

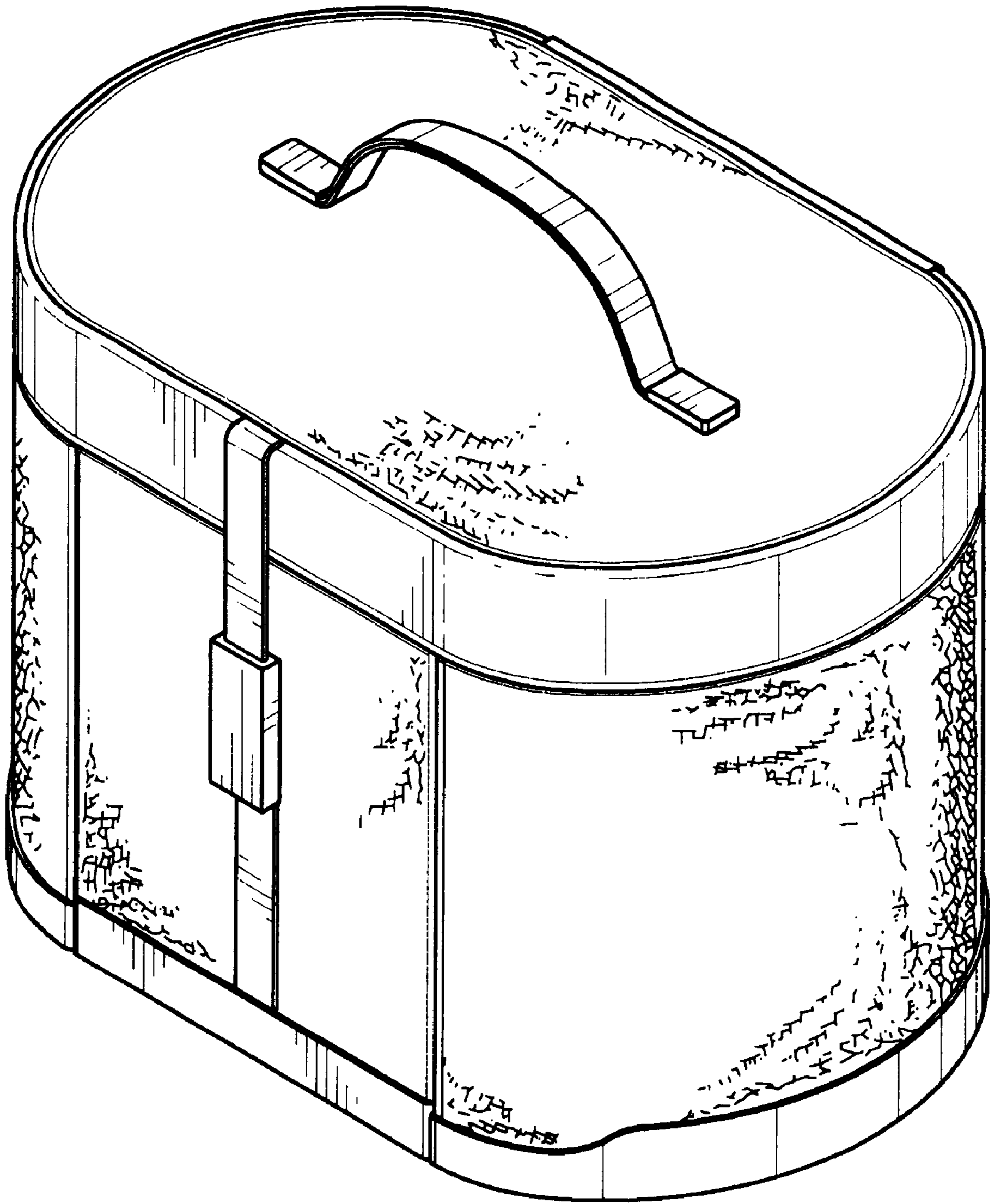

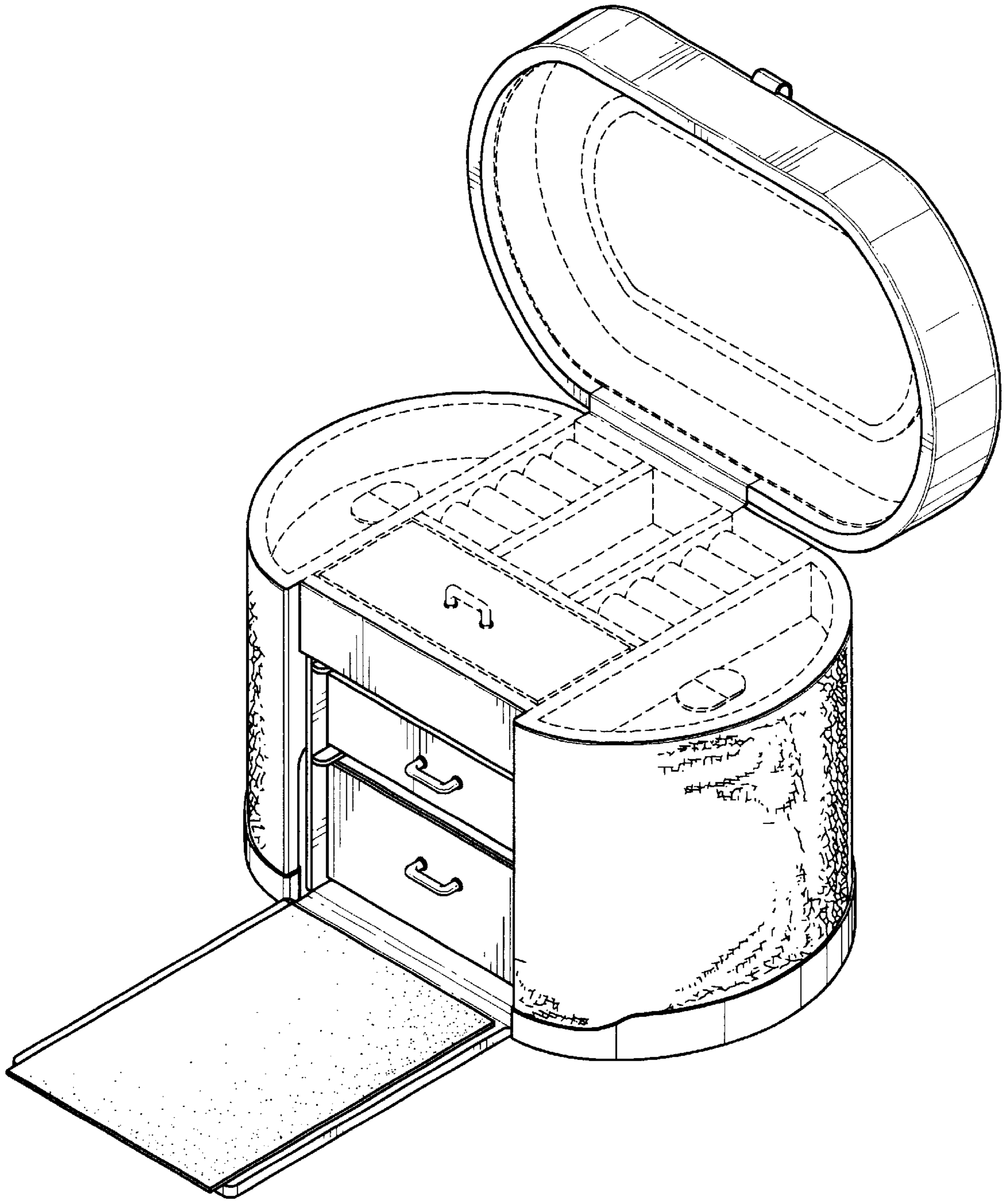

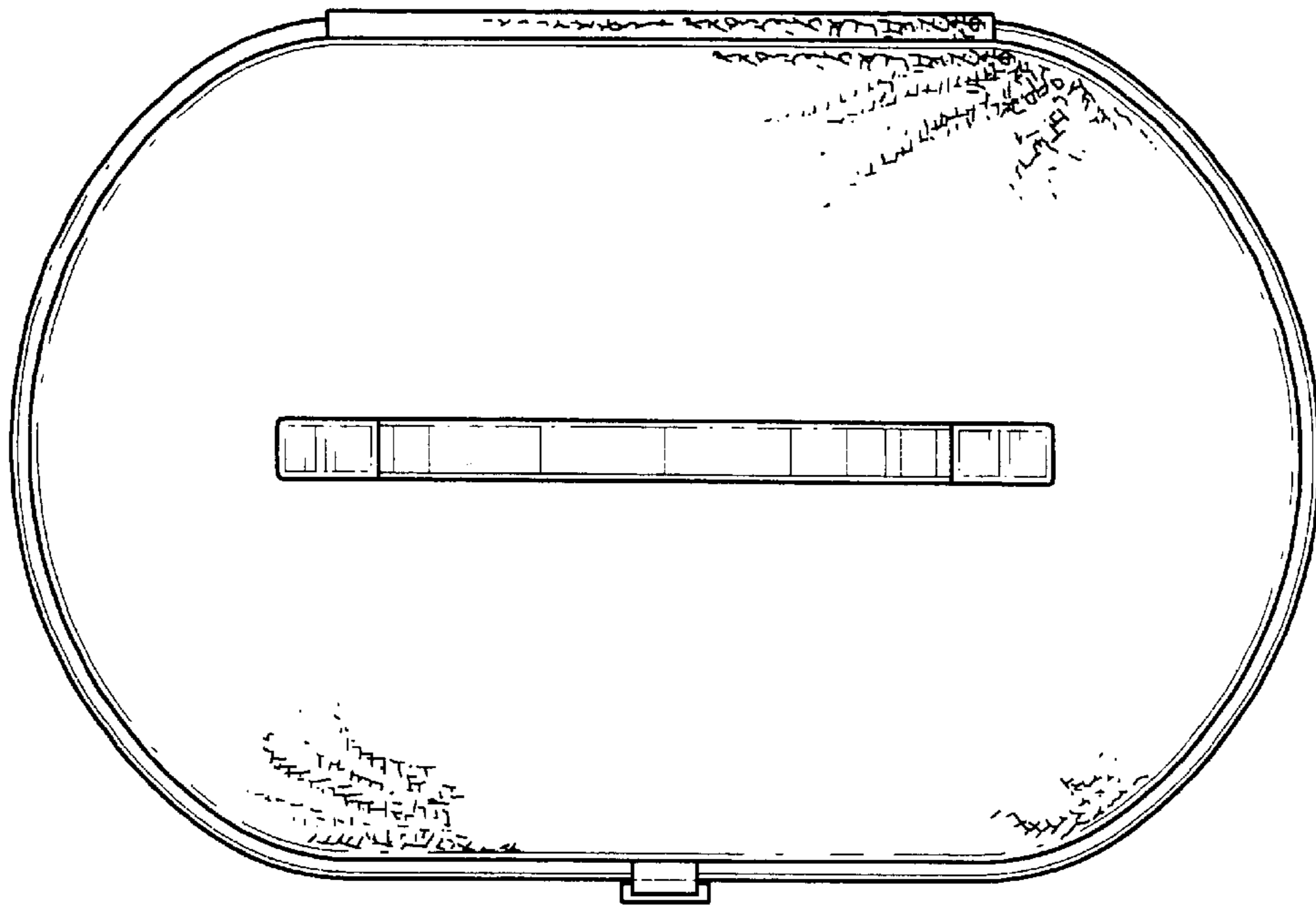

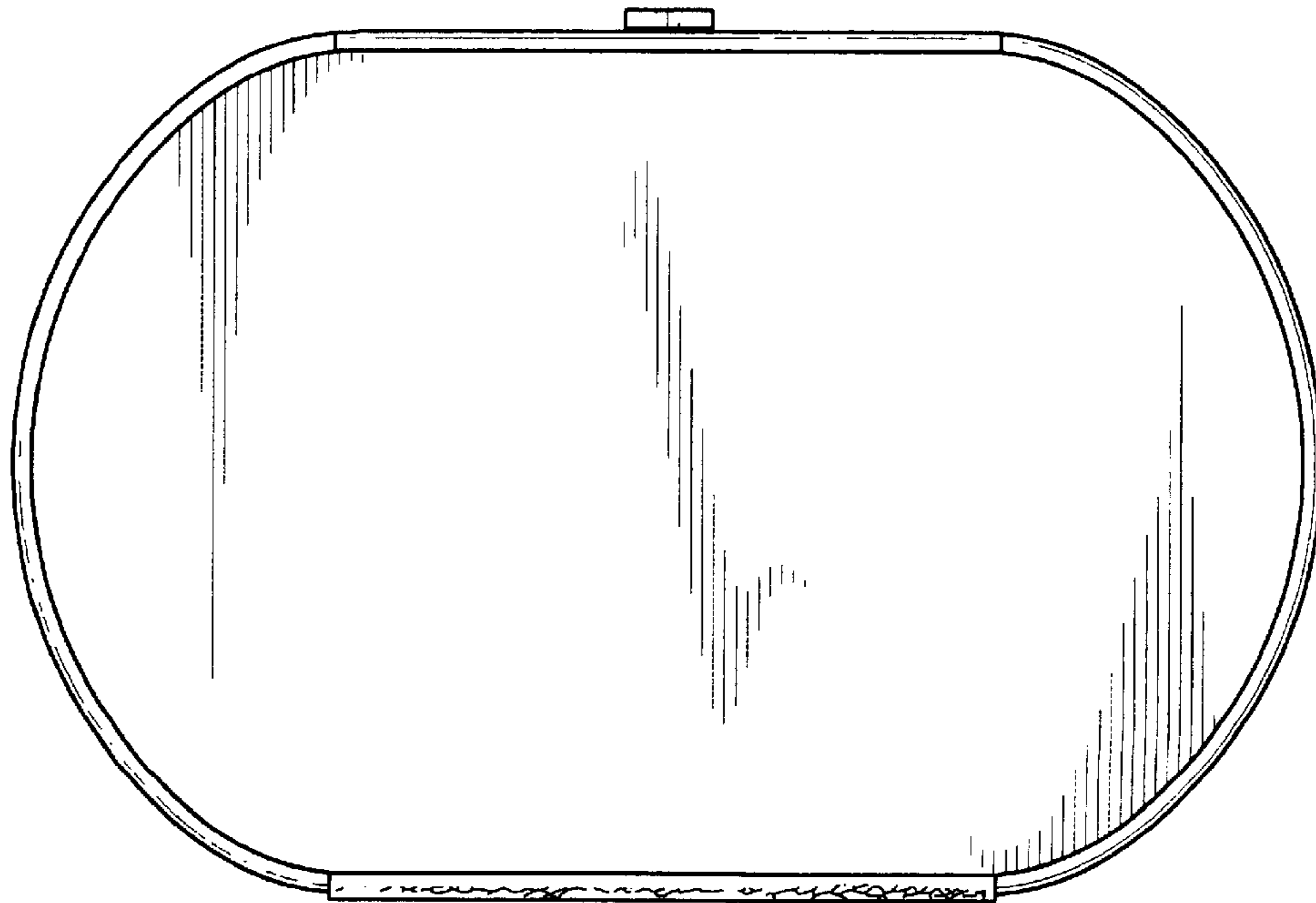

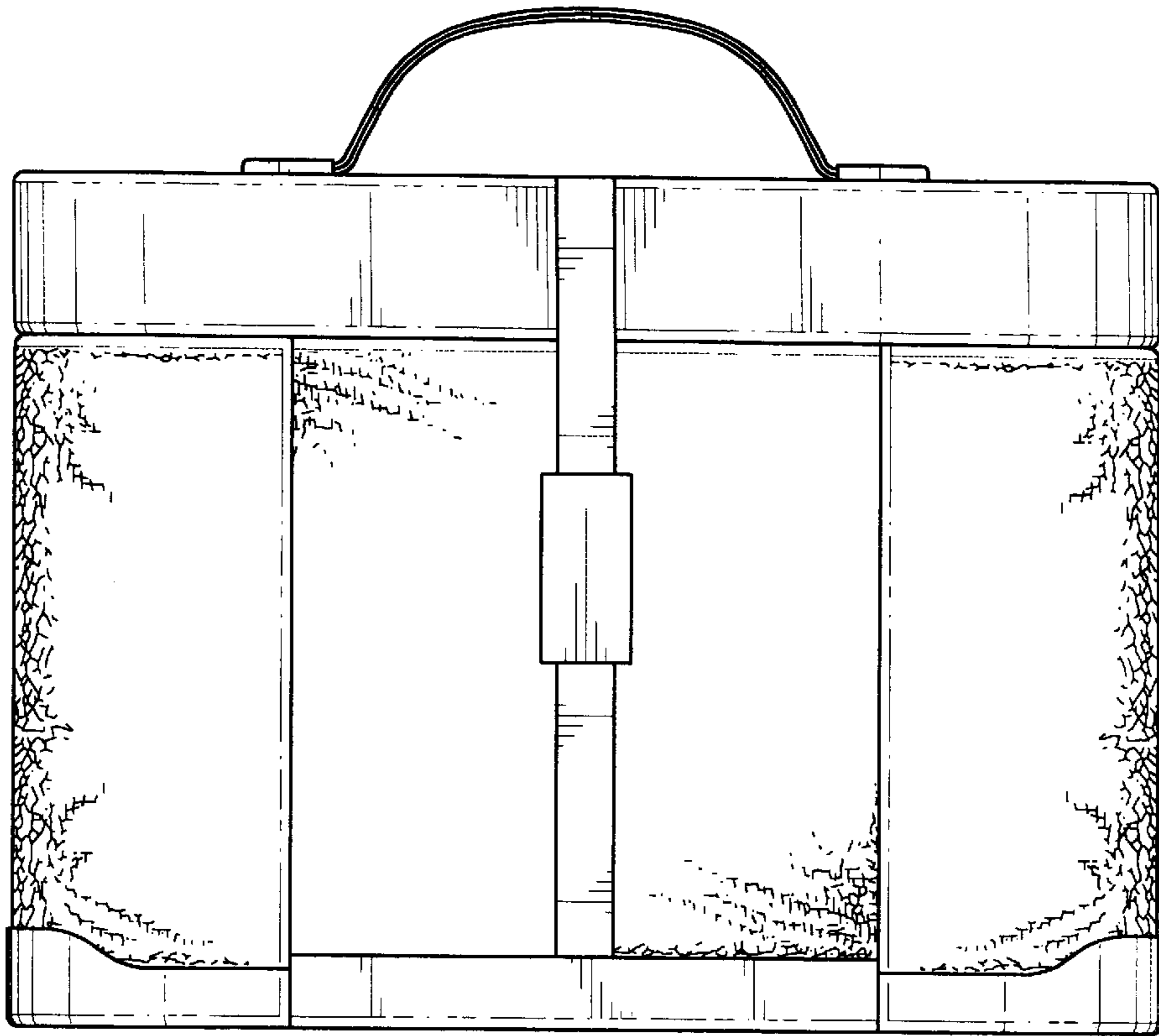

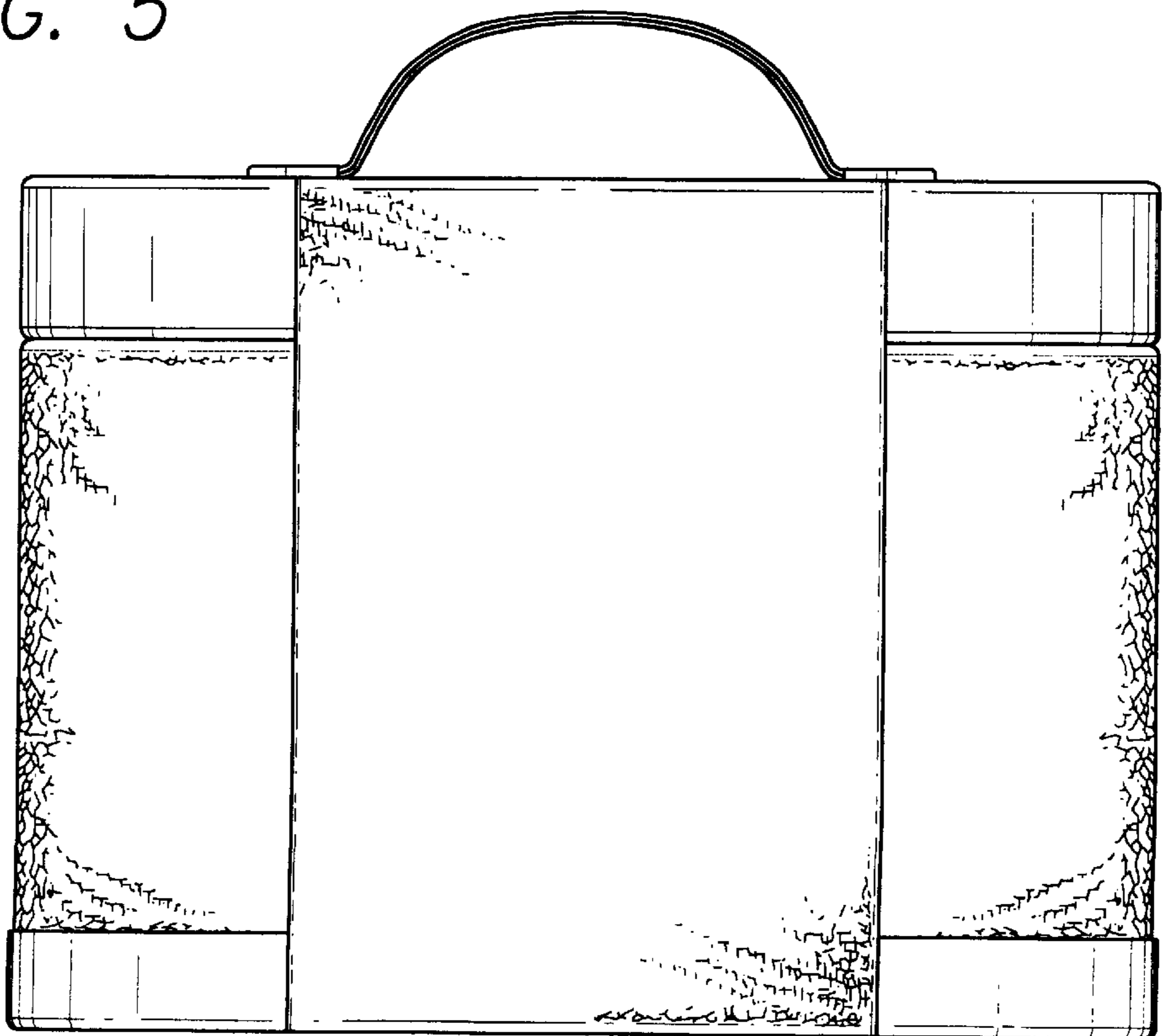
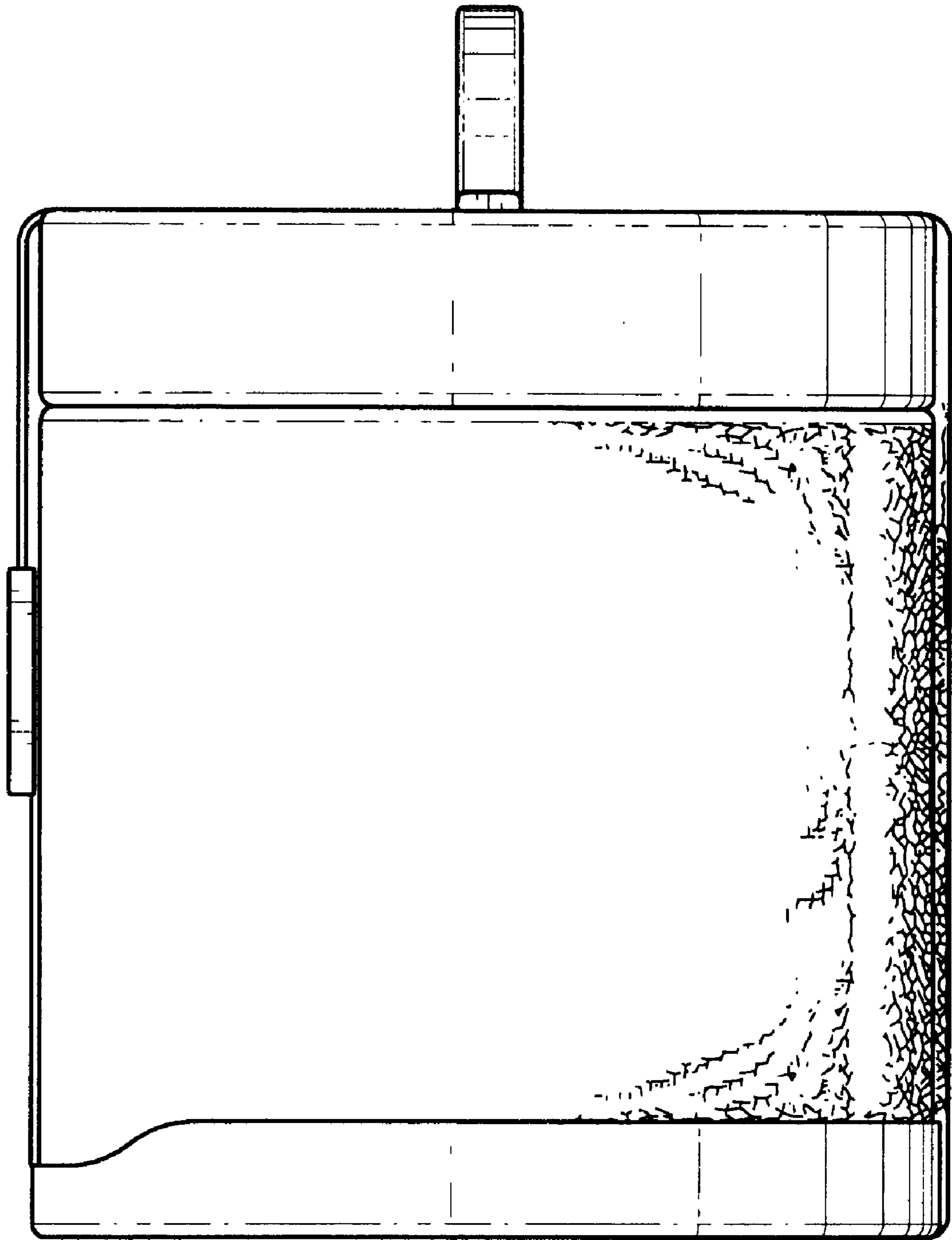
