FIG. 3 is a front view of the article;

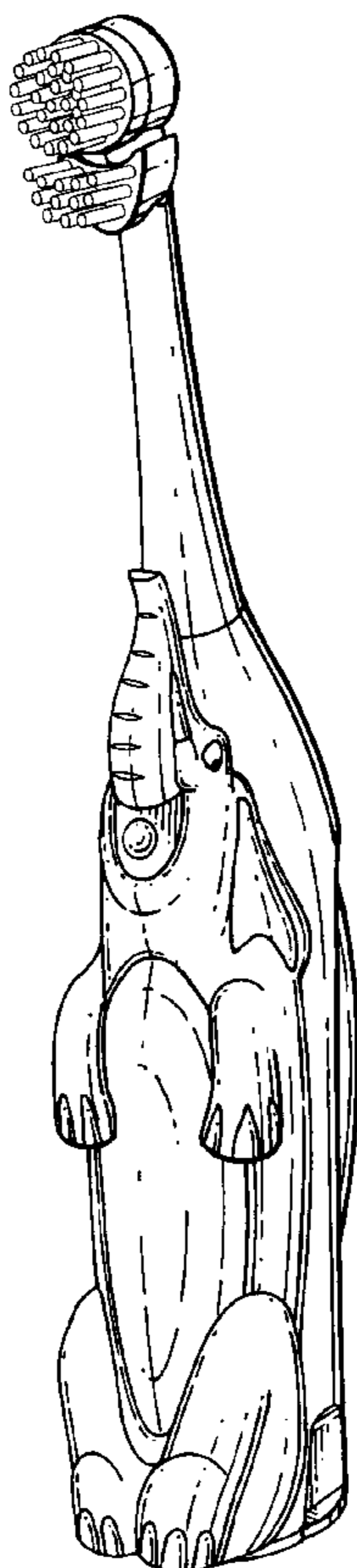
FIG. 4 is a rear view of the article;

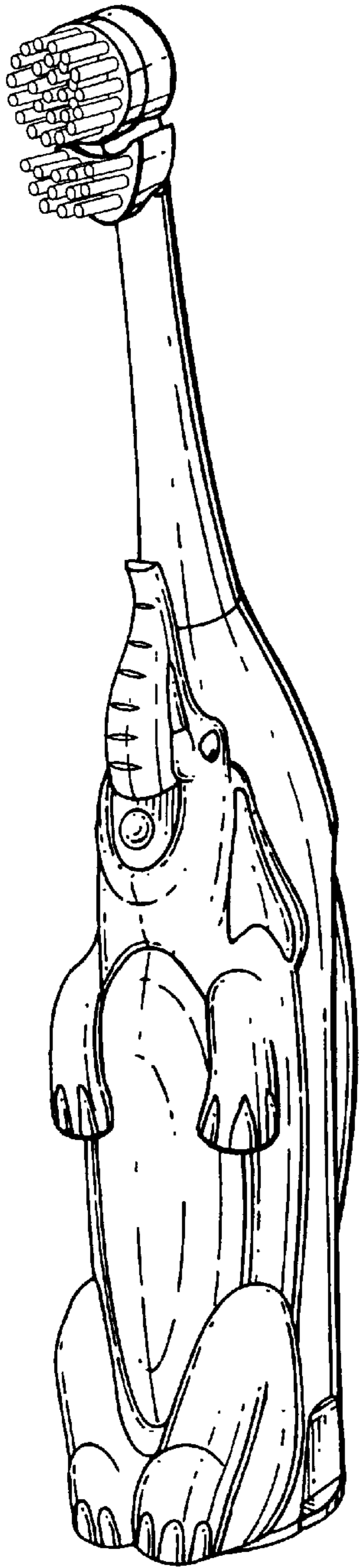

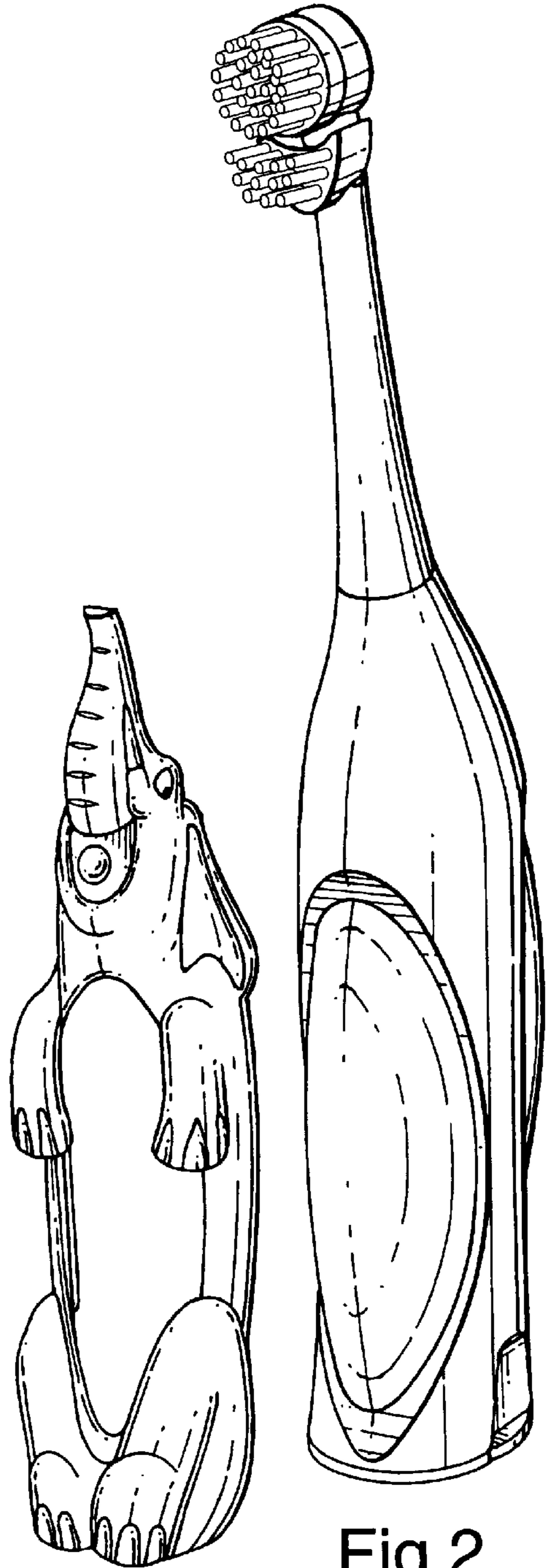

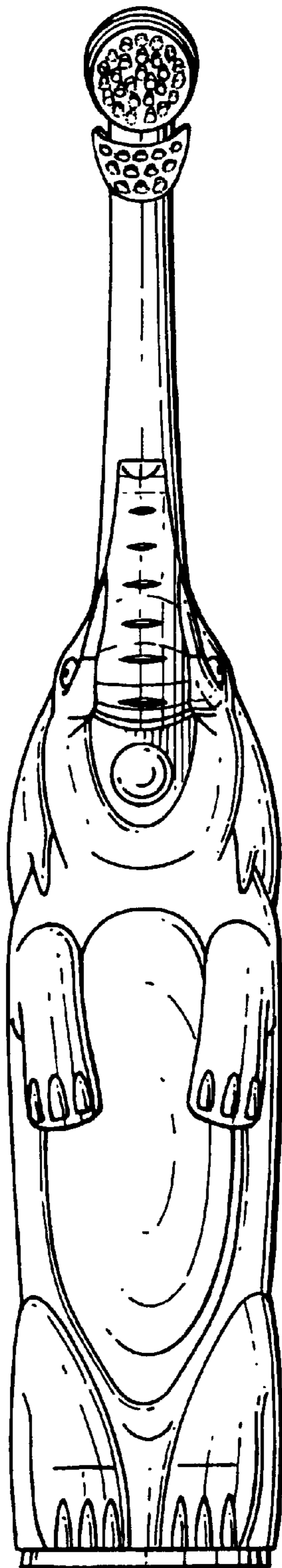

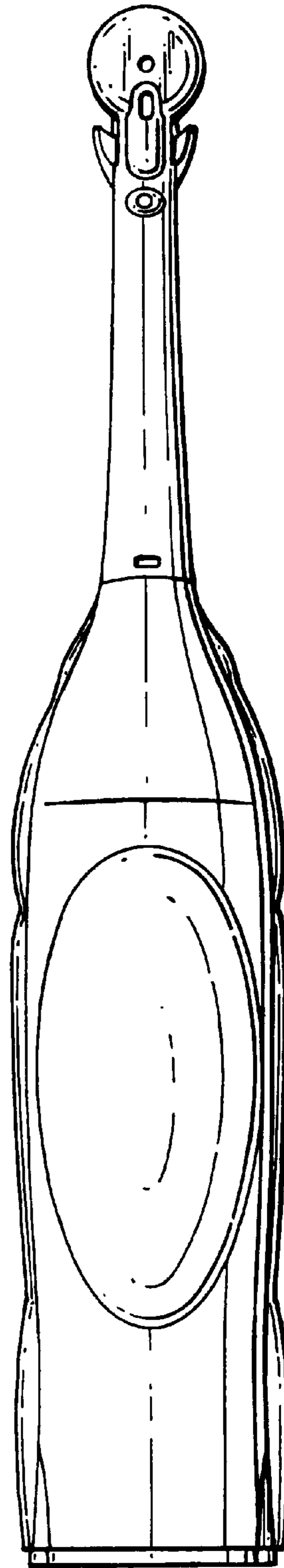

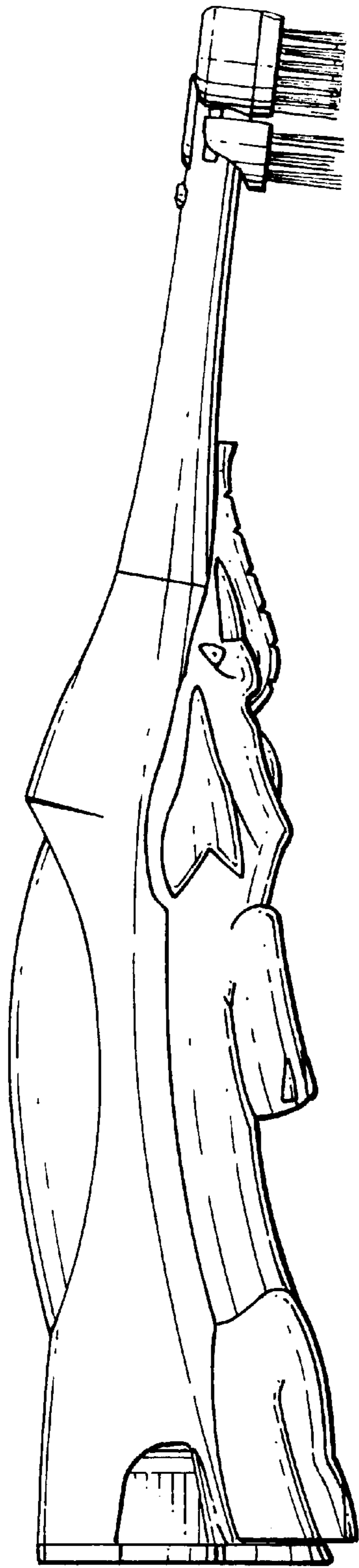

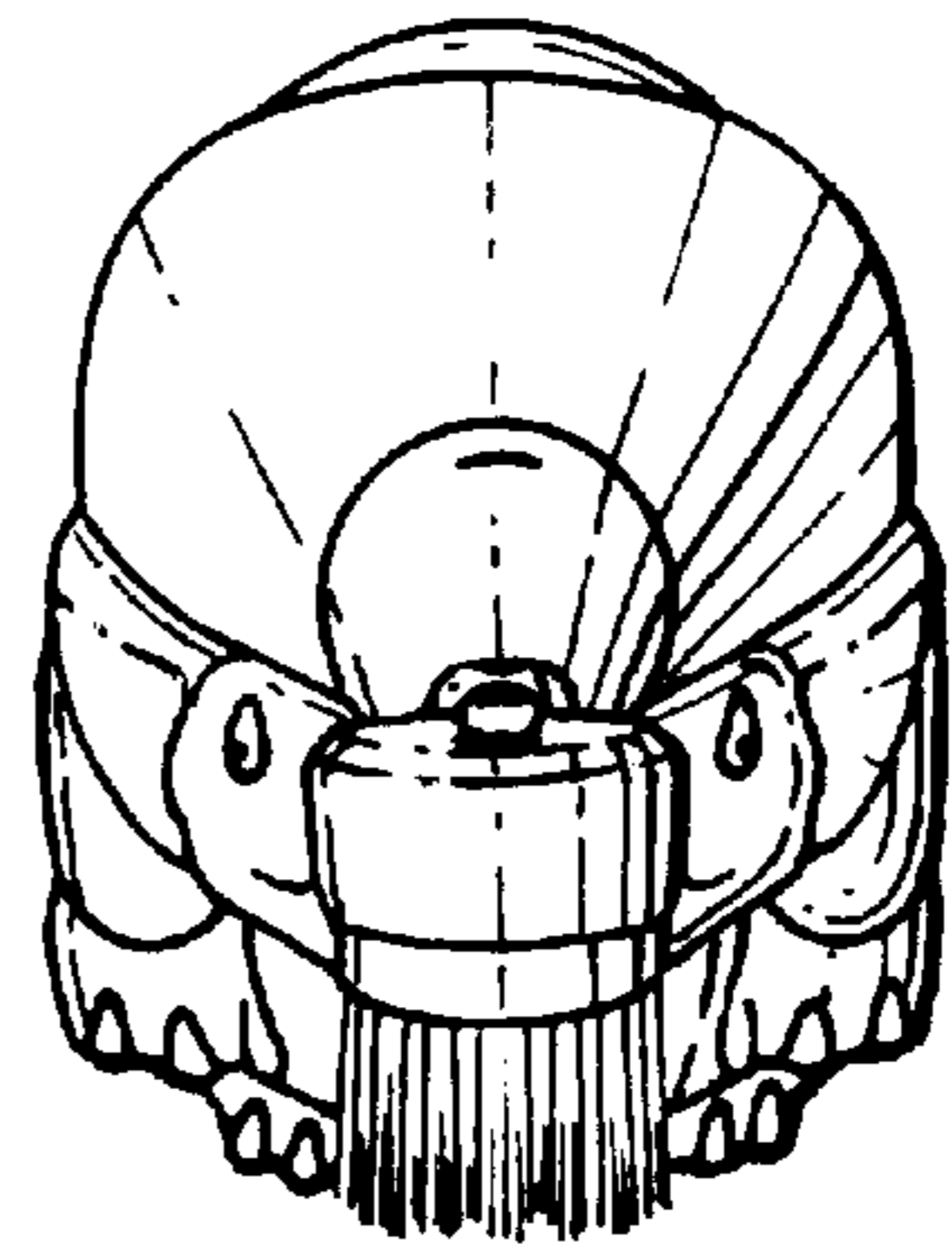

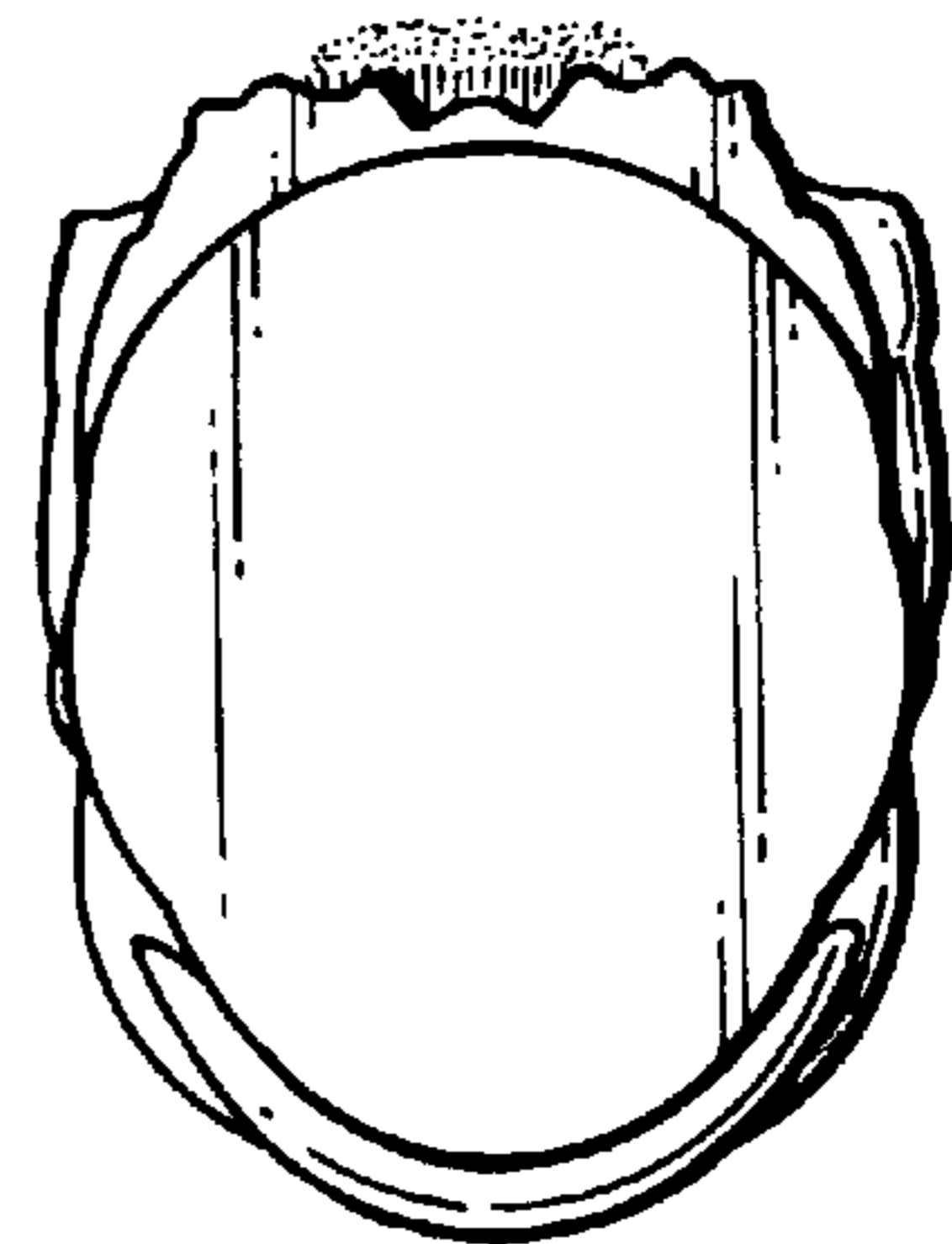
