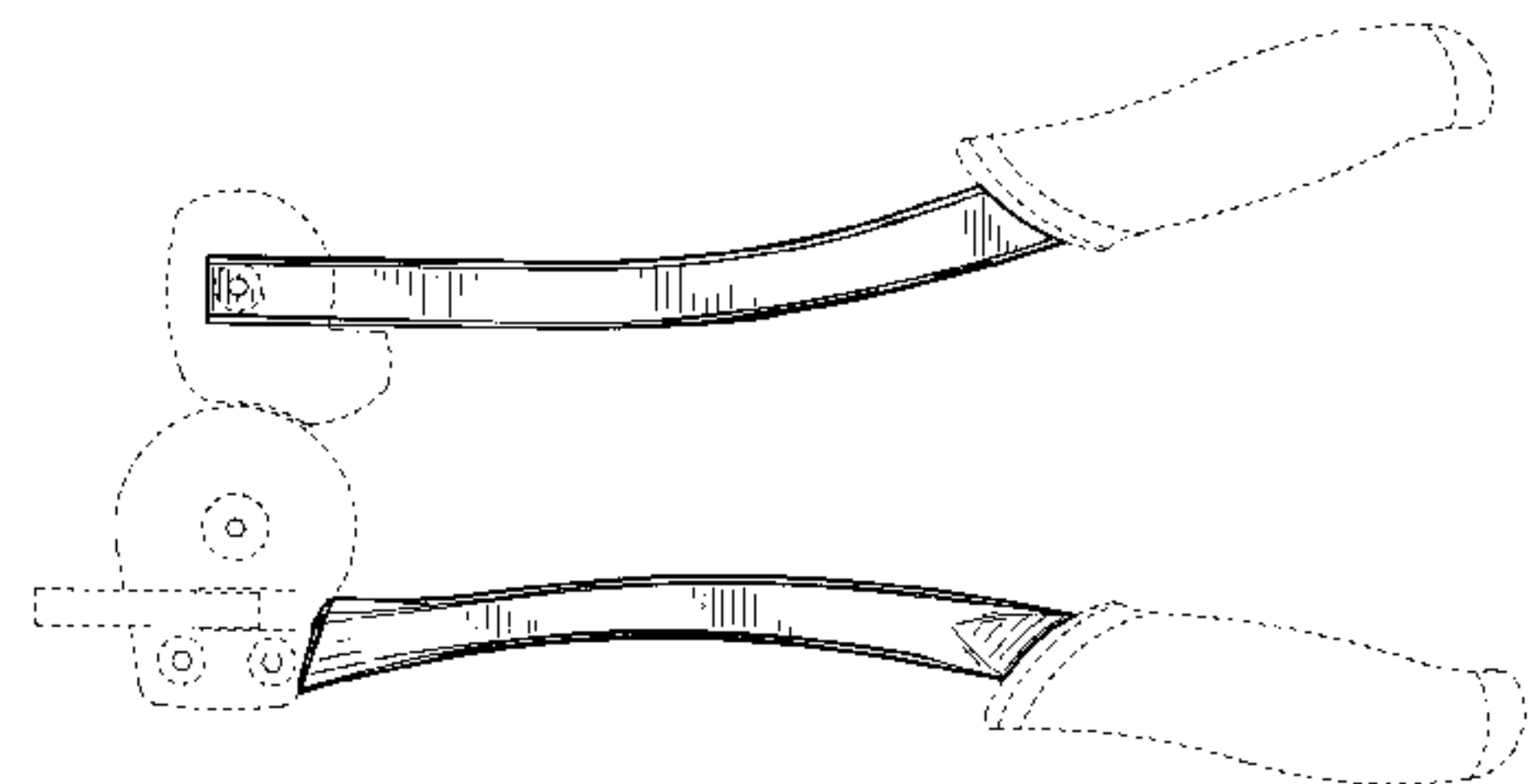
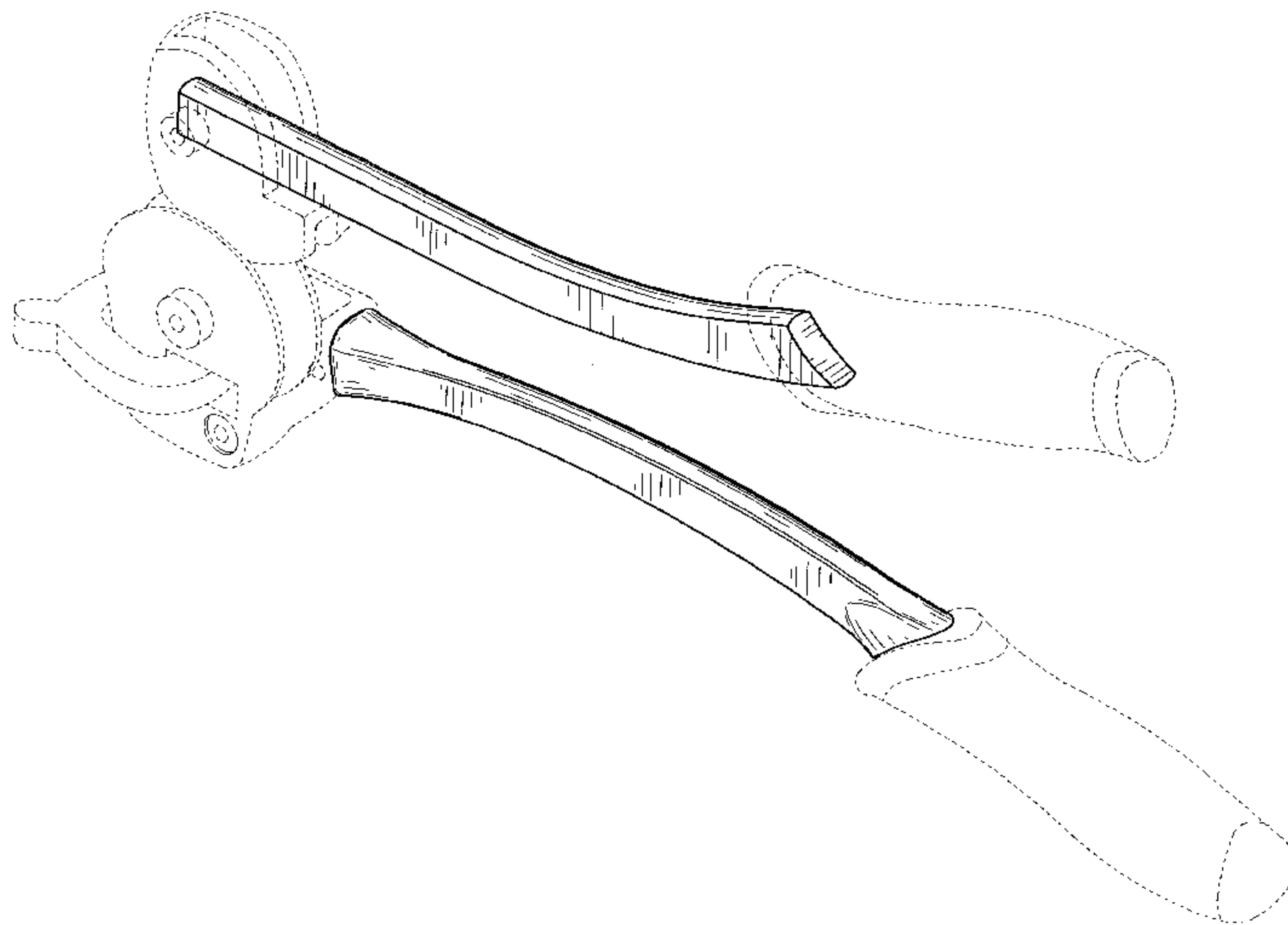
The ornamental design for a pair of tool handles, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tube bender tool having a pair of tool handles illustrating my new design; FIG. 2 is a bottom plan view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a rear elevational view thereof; FIG. 6 is a right side elevational view thereof; FIG. 7 is a left side elevational view thereof; and, FIG. 8 is a perspective view of an alternate embodiment of a tube bender tool having a pair of tool handles illustrating my new design.

The components of the tube bender tool, other than the pair of tool handles, are shown in broken lines for illustrative purposes only and form no part of the claimed design.

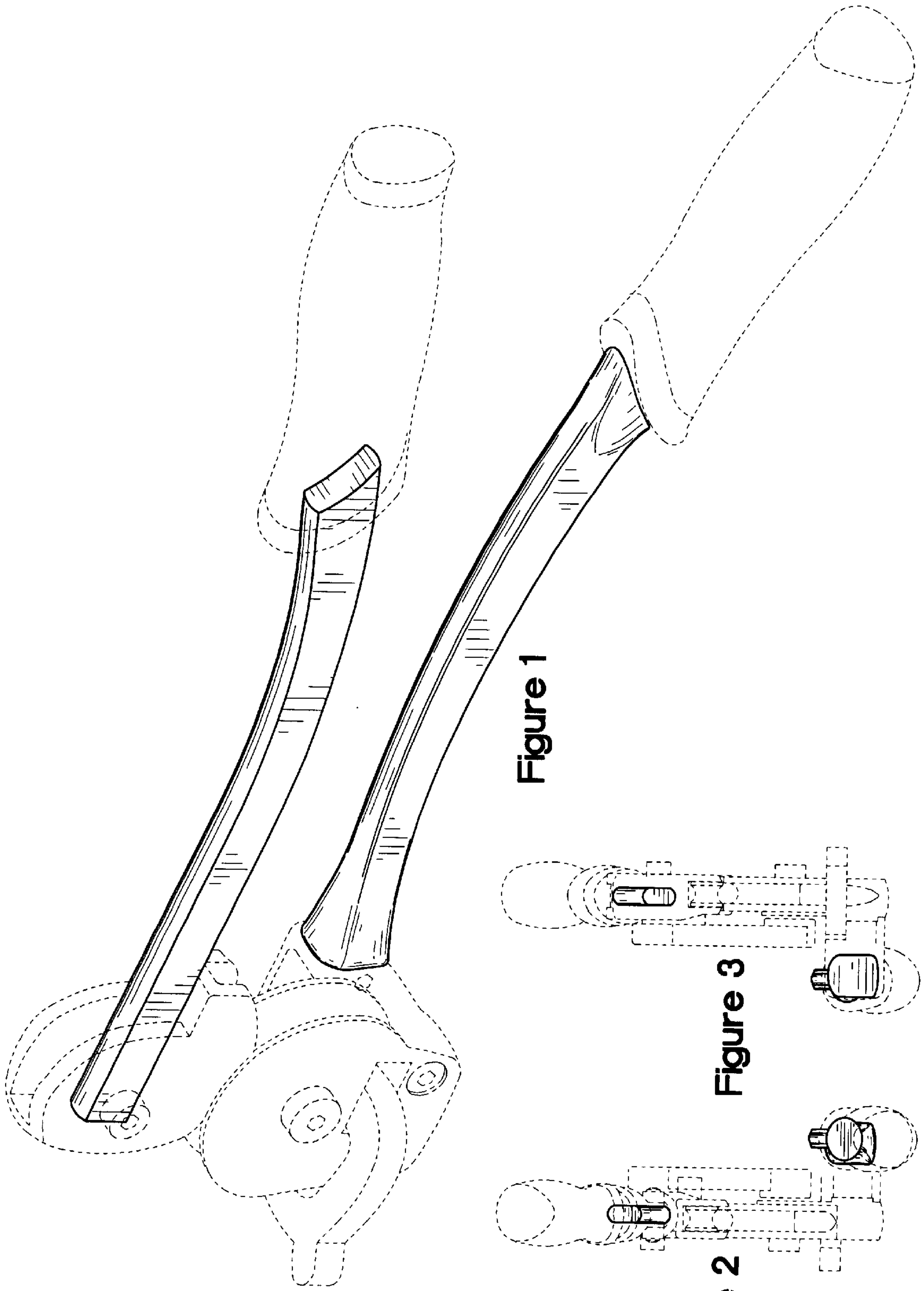
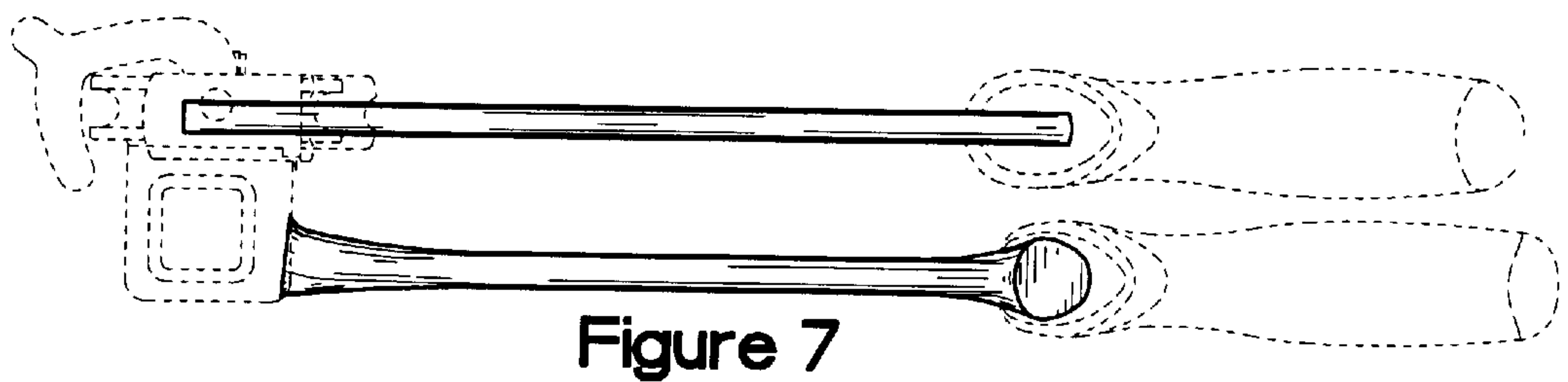
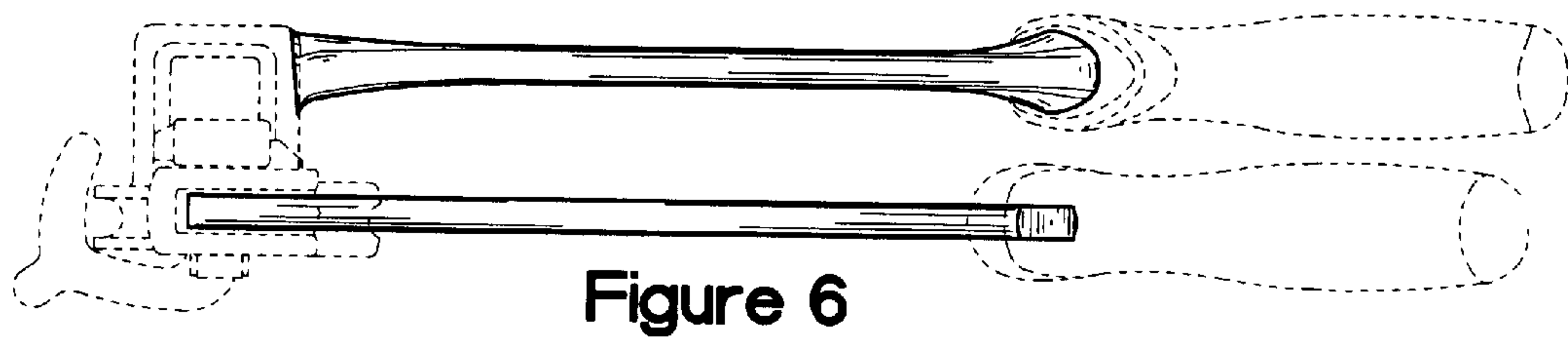
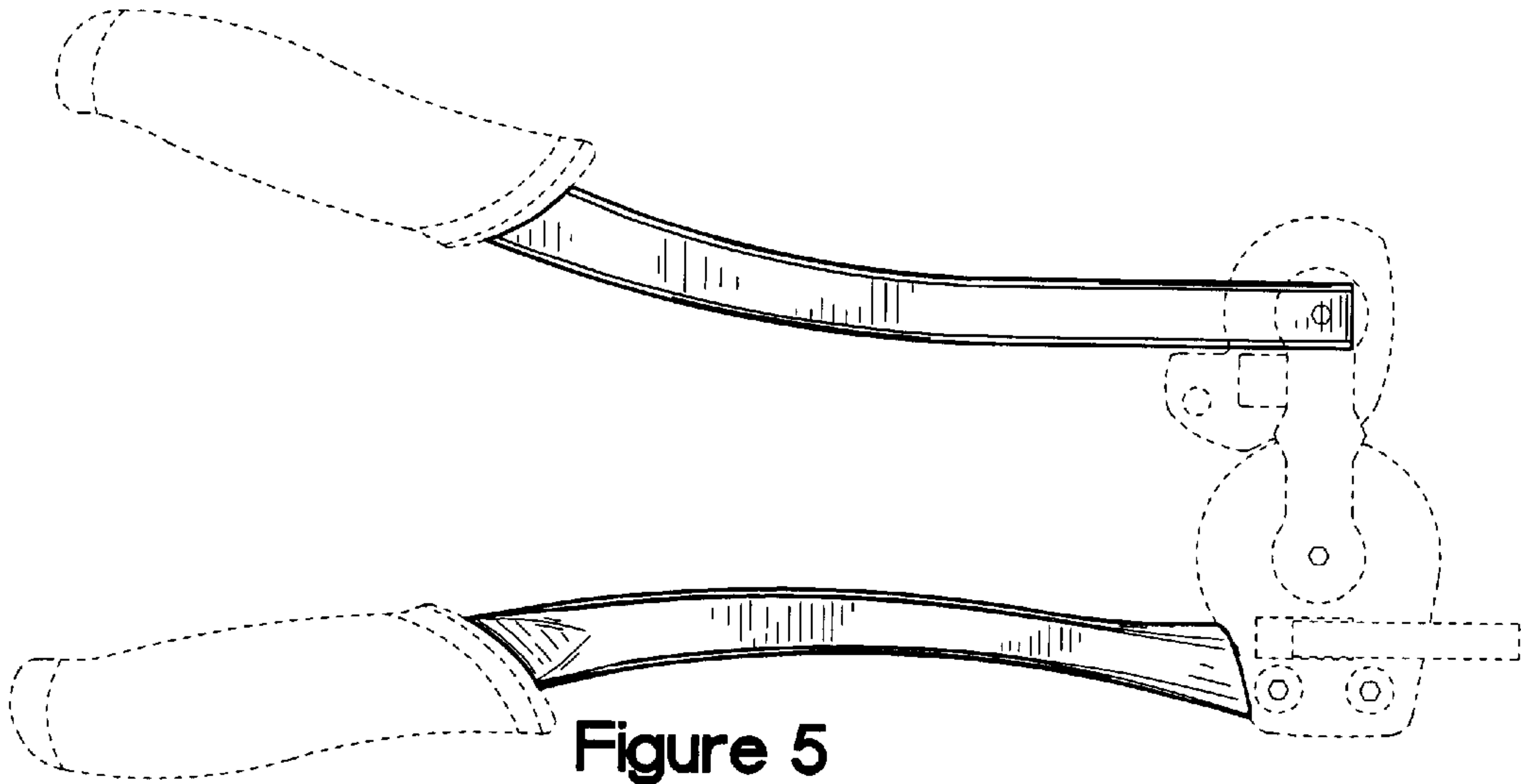
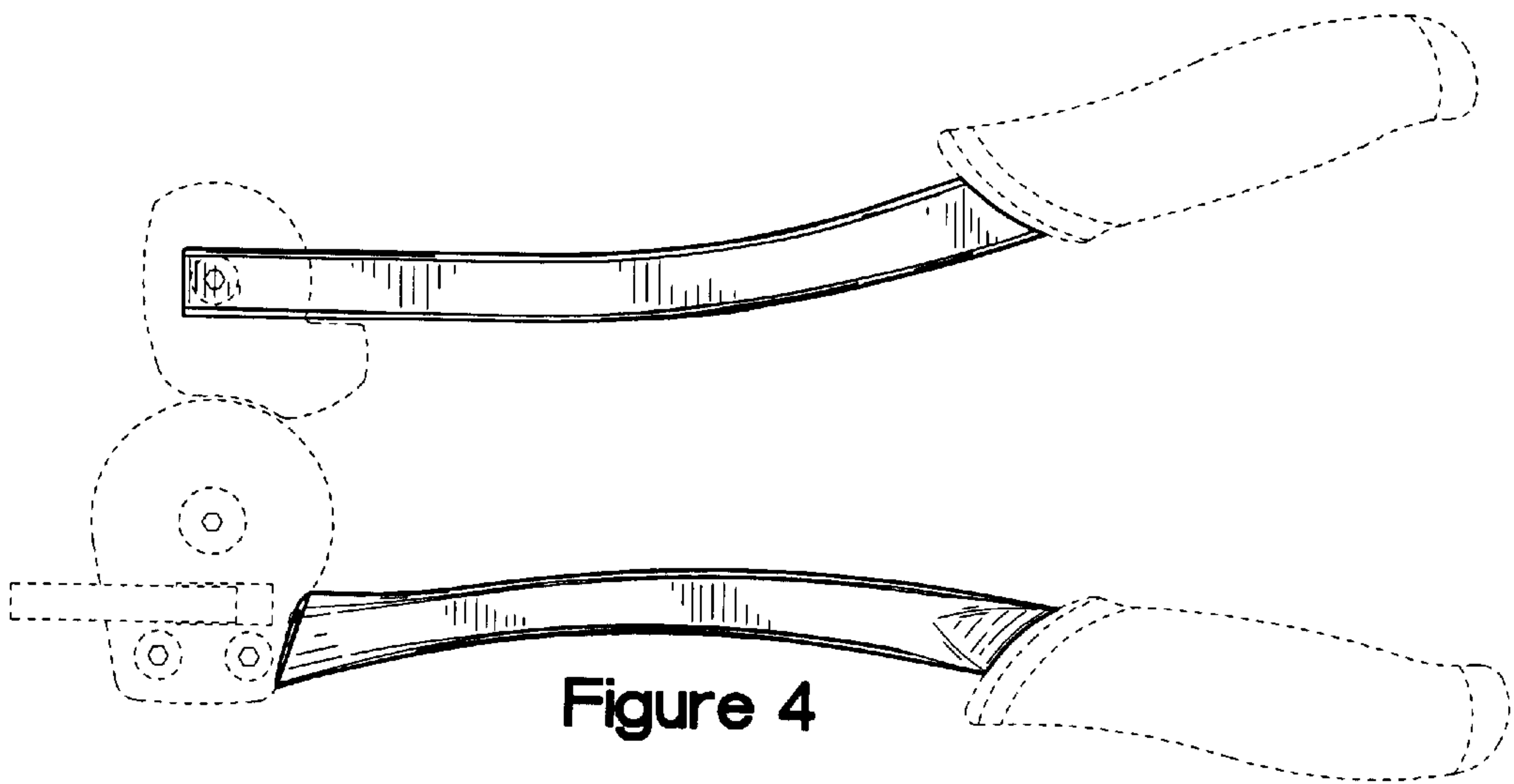

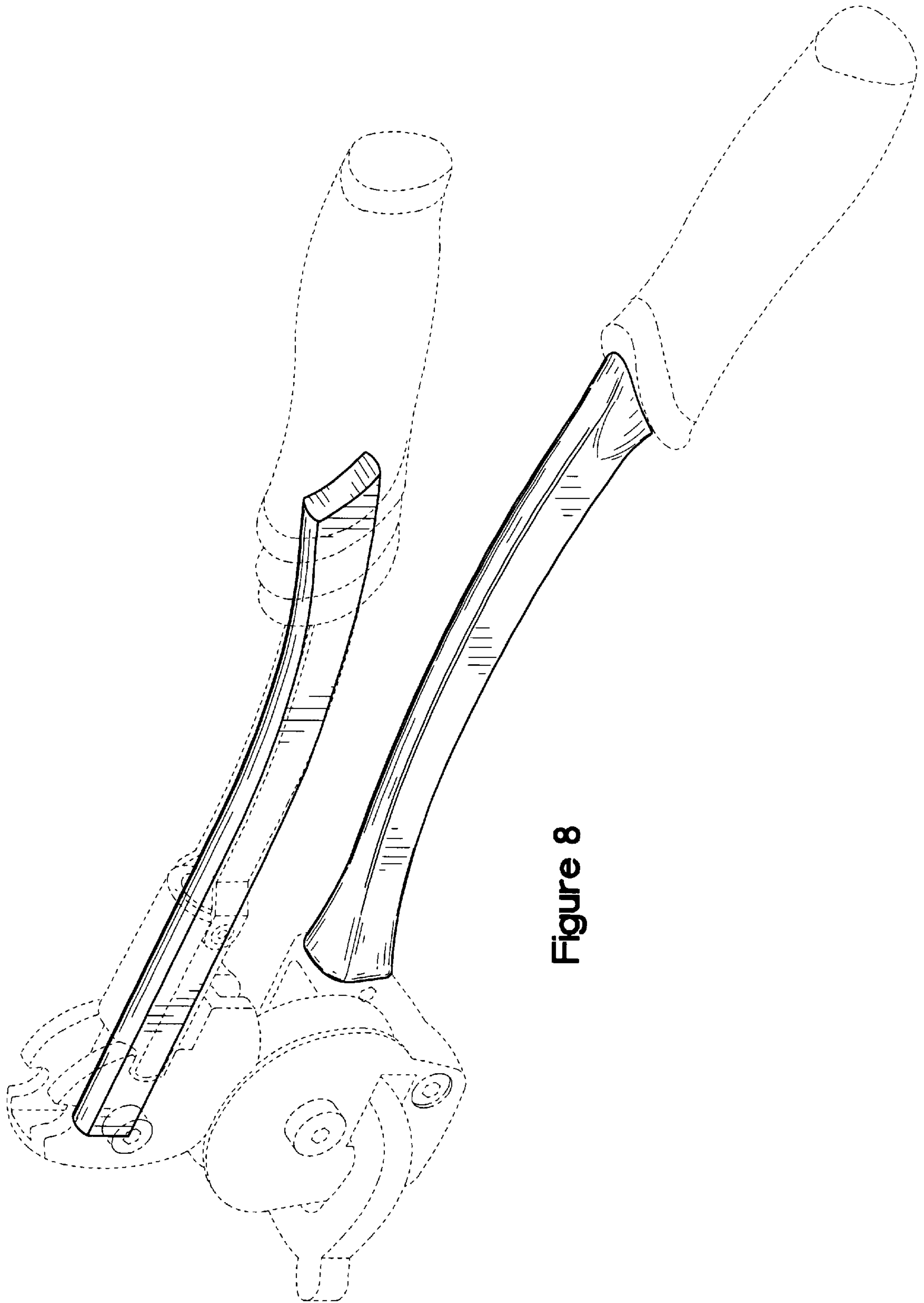
