(57) **CLAIM**

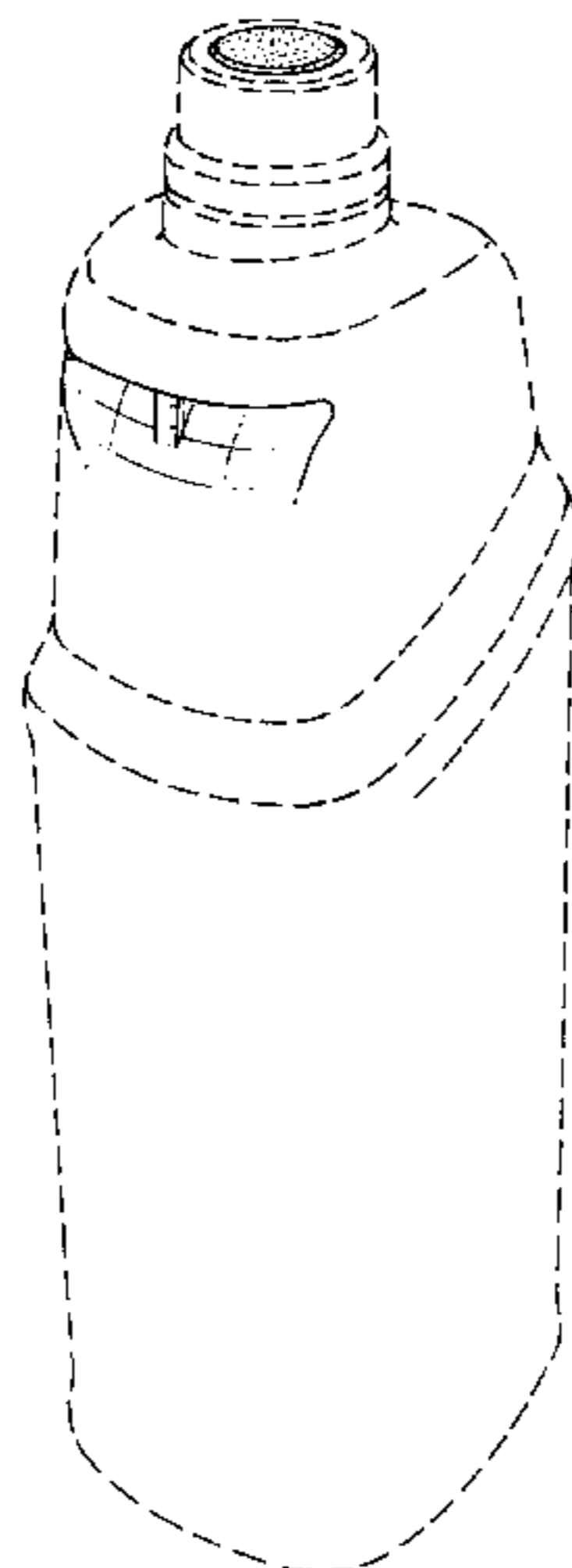
The ornamental design for an upper portion of a container,

**DESCRIPTION**

- FIG. 1 is a perspective view of an upper portion of a  
container, embodying our new design;
- FIG. 2 is a side elevational view thereof, the opposite side  
elevational view being the same;
- FIG. 3 is a top view thereof;
- FIG. 4 is a bottom view thereof;
- FIG. 5 is a front view thereof; and,
- FIG. 6 is a rear view thereof.

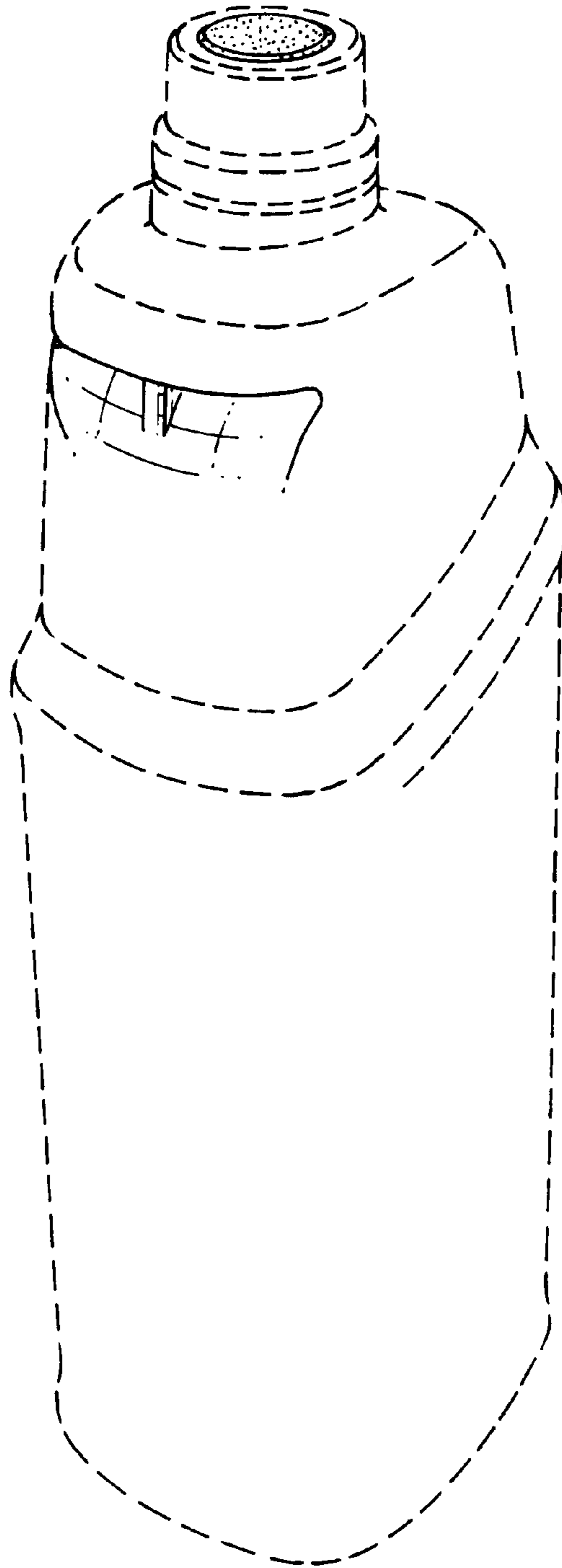

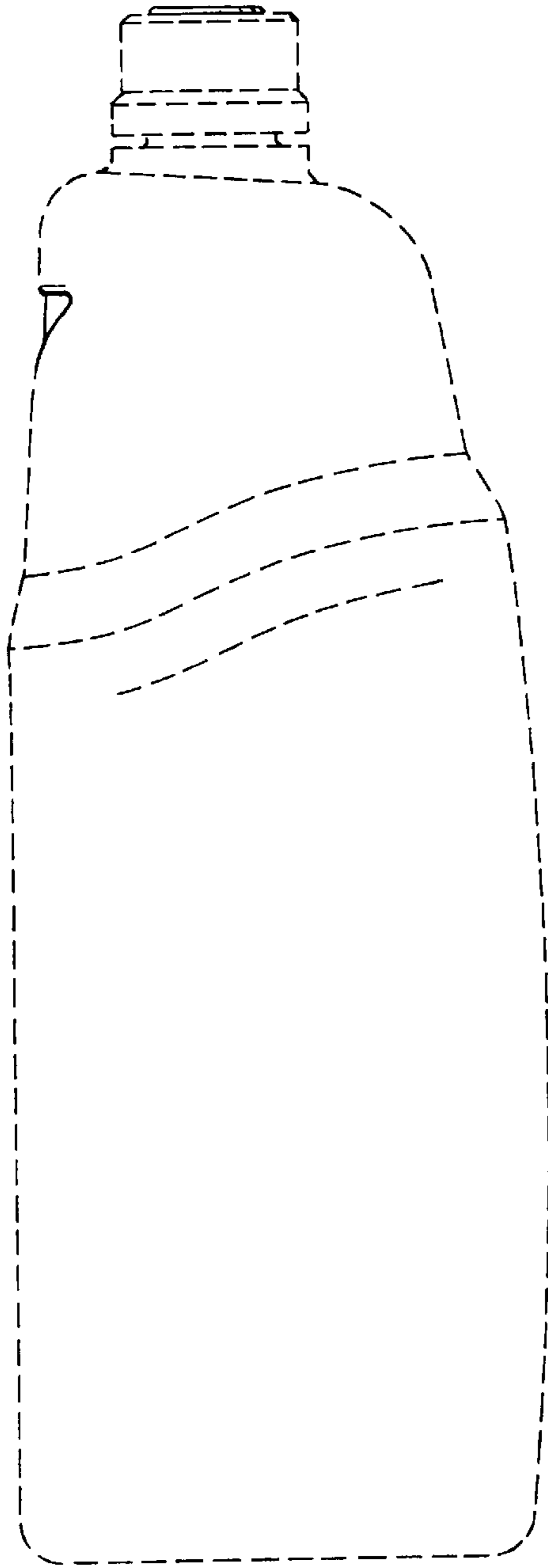

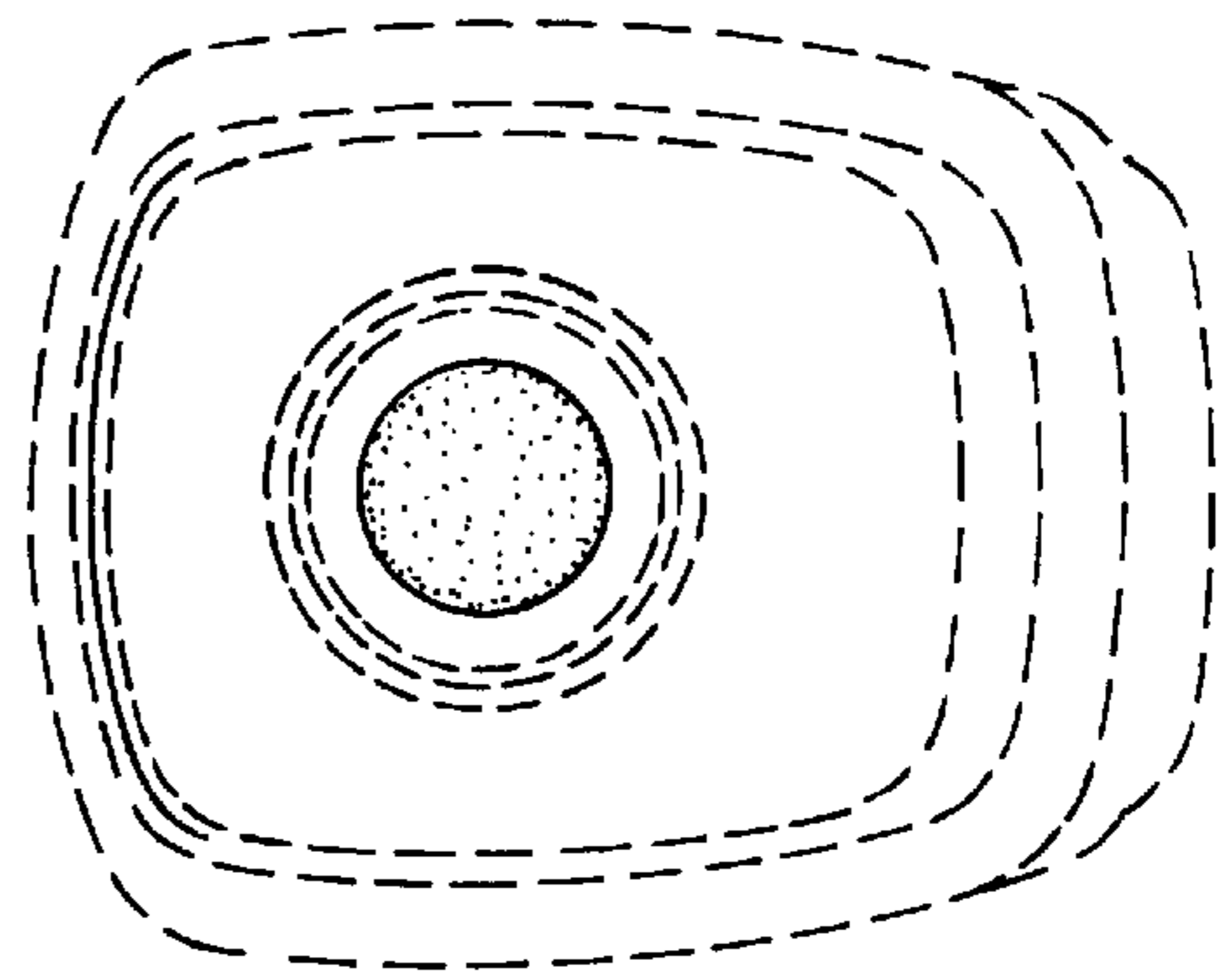

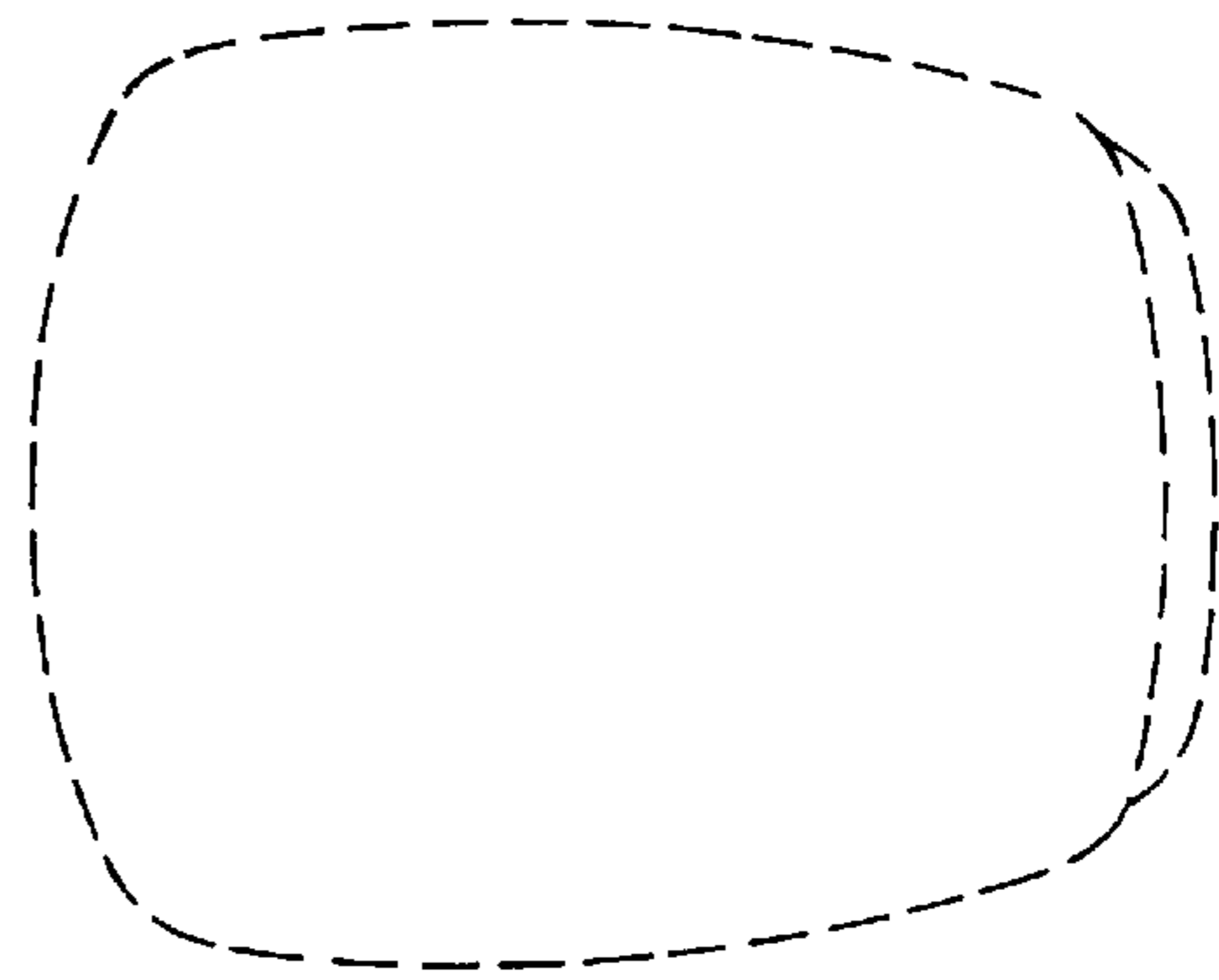

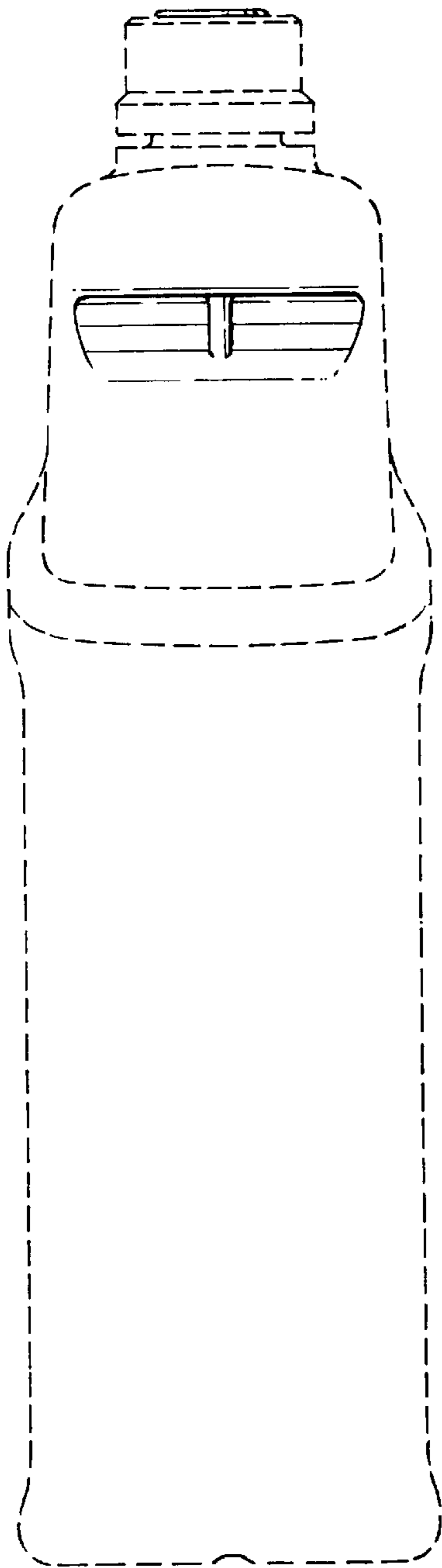

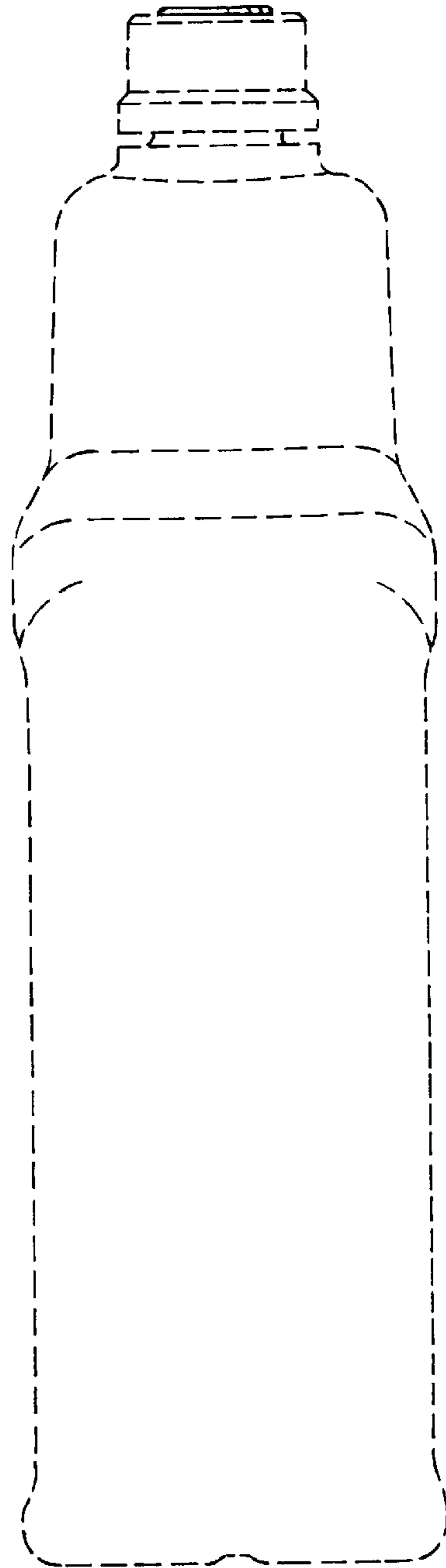
