FIG. 2 is a left side view of the cosmetics bottle of the present invention, the right side view being a mirror image thereof;

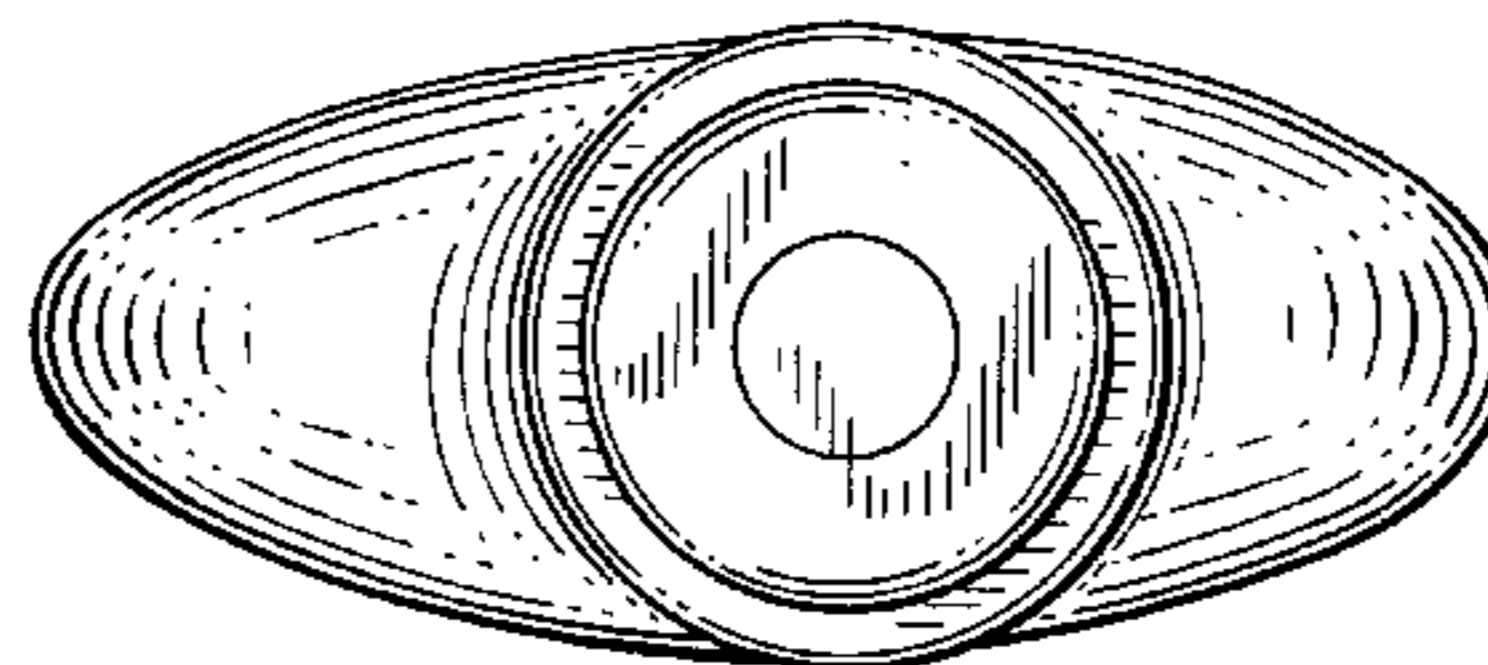
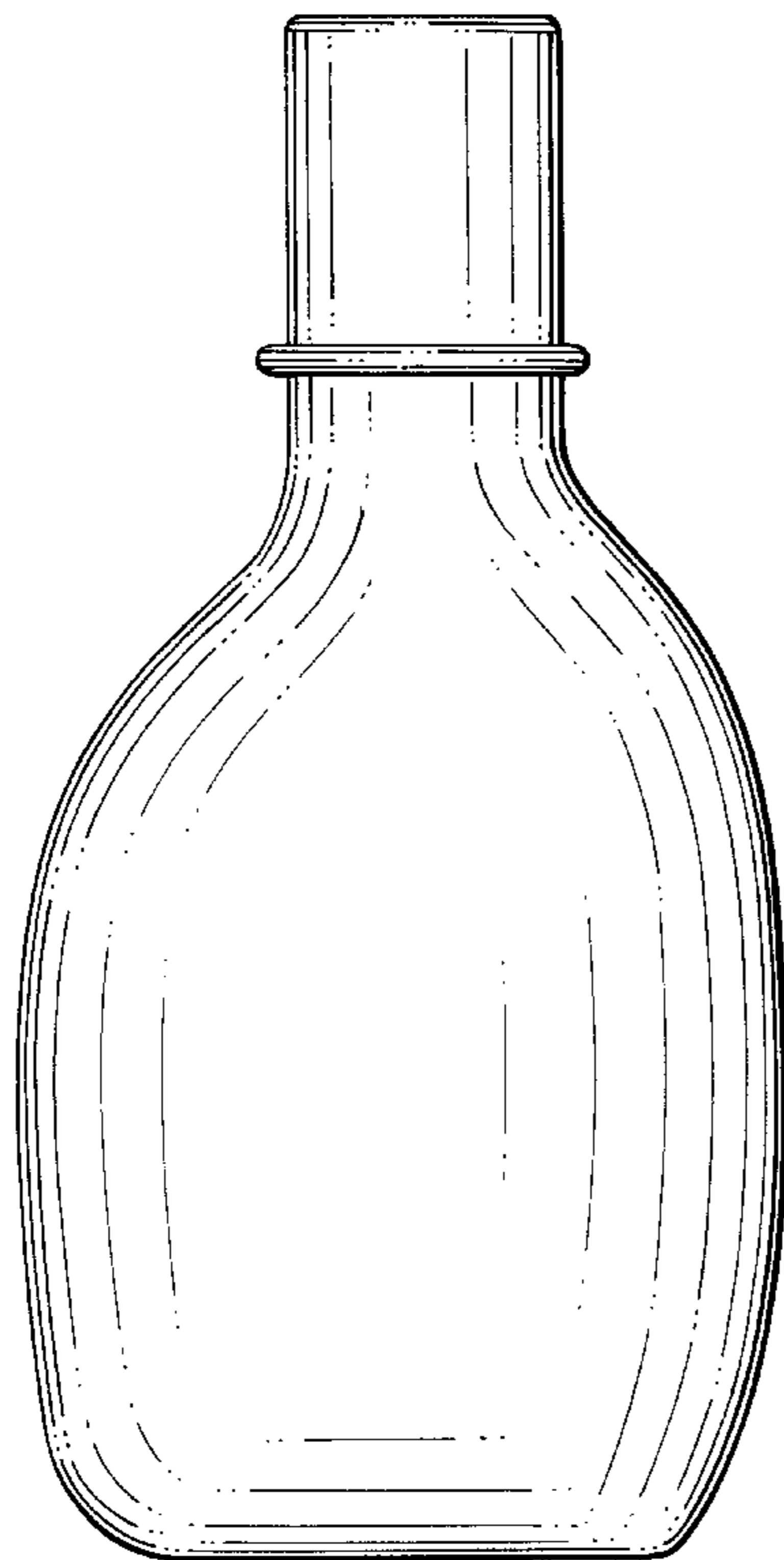
FIG. 3 is a top plan view of the cosmetics bottle of the present invention;

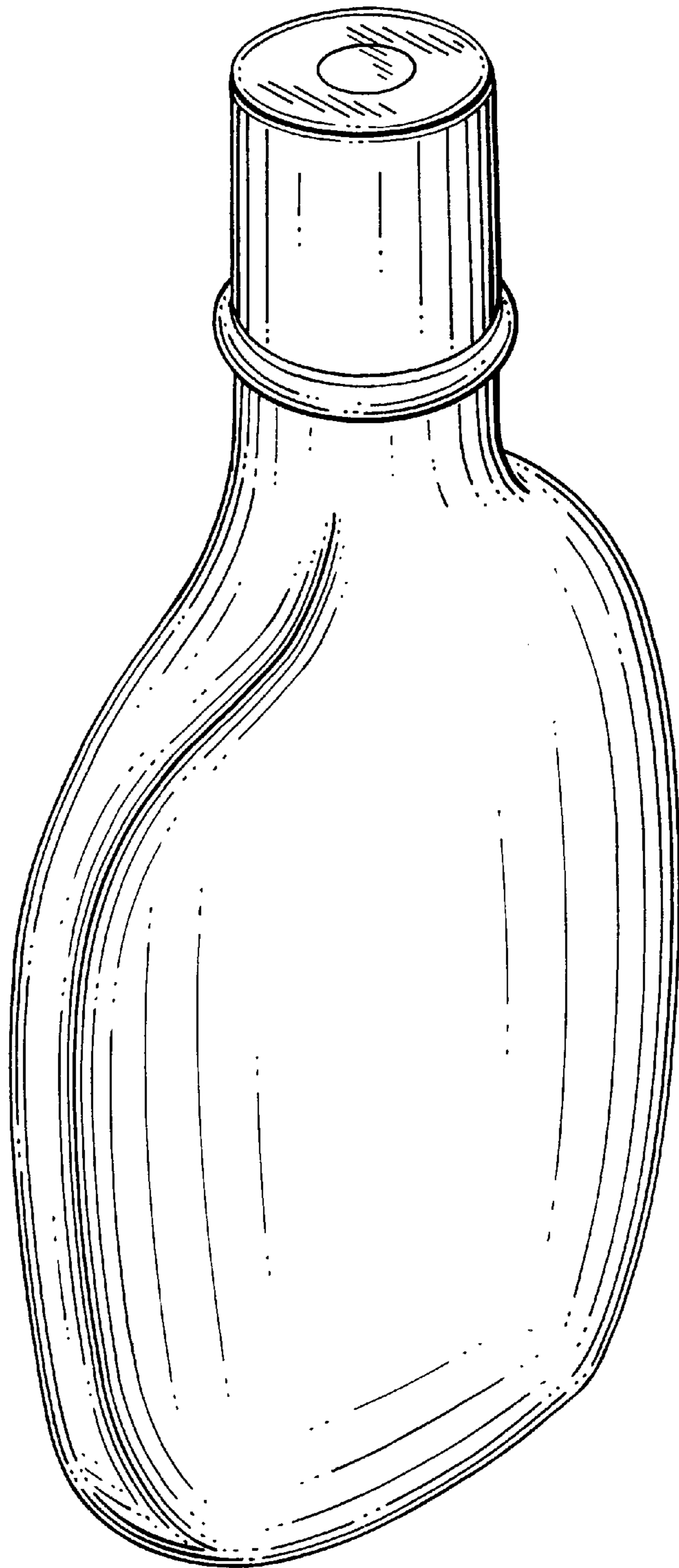

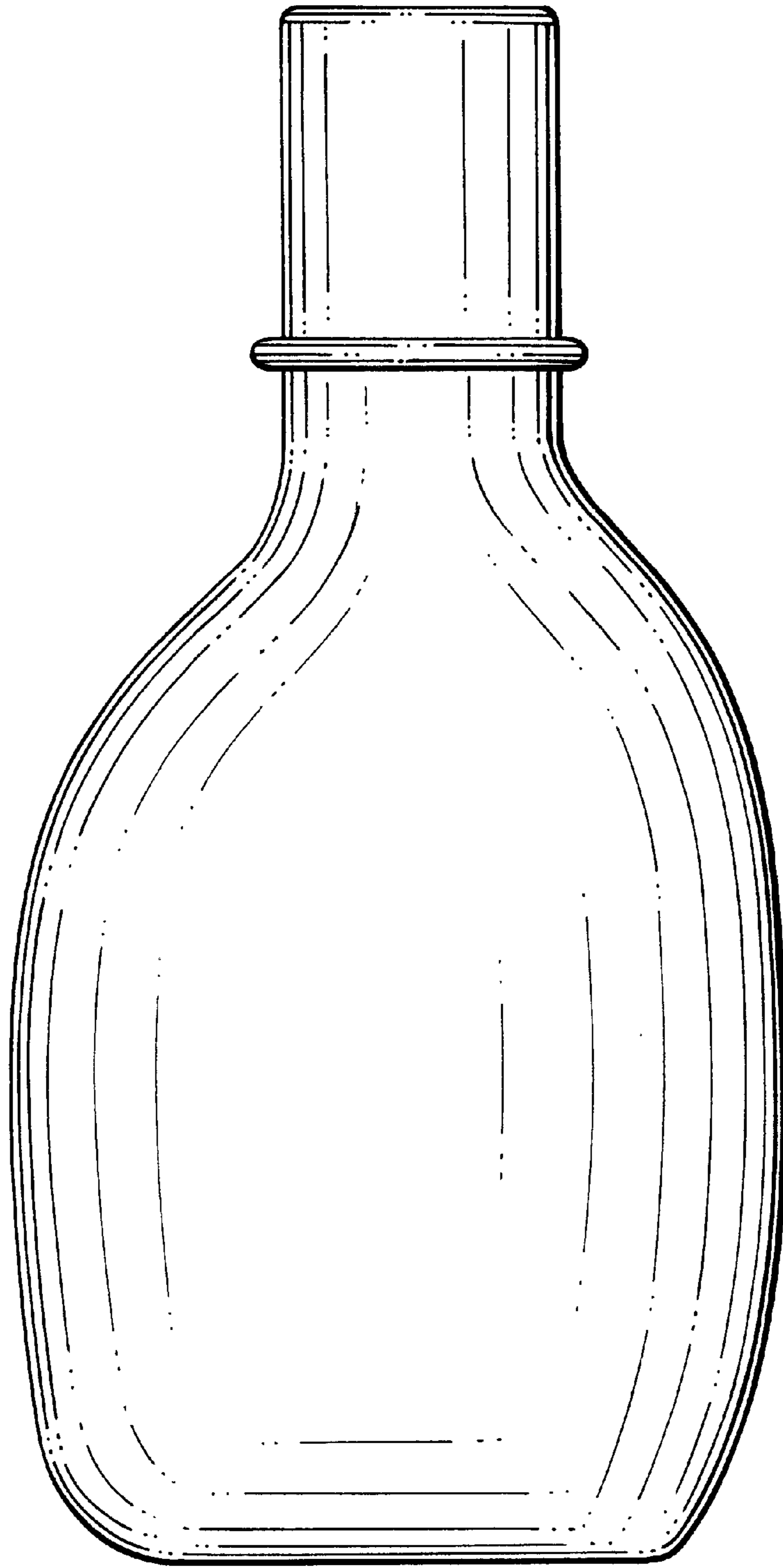

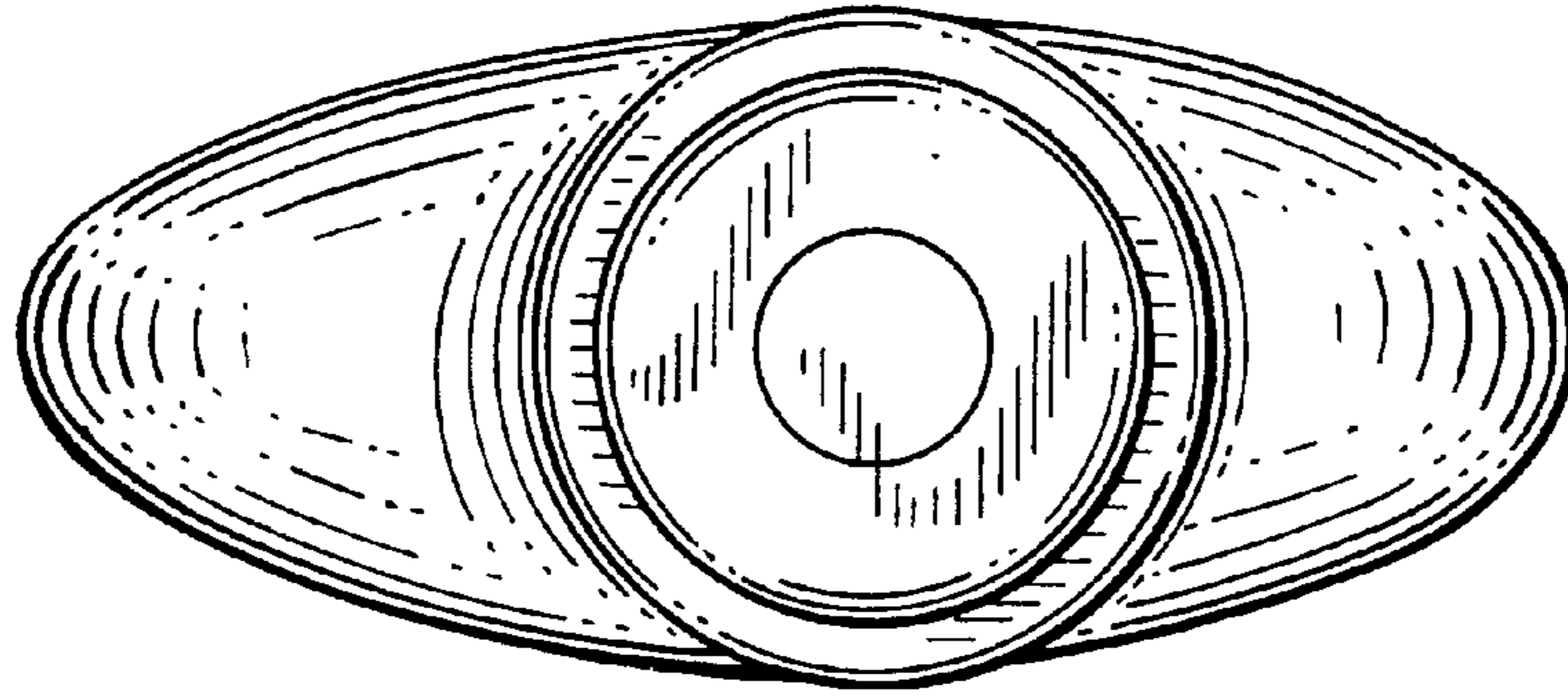

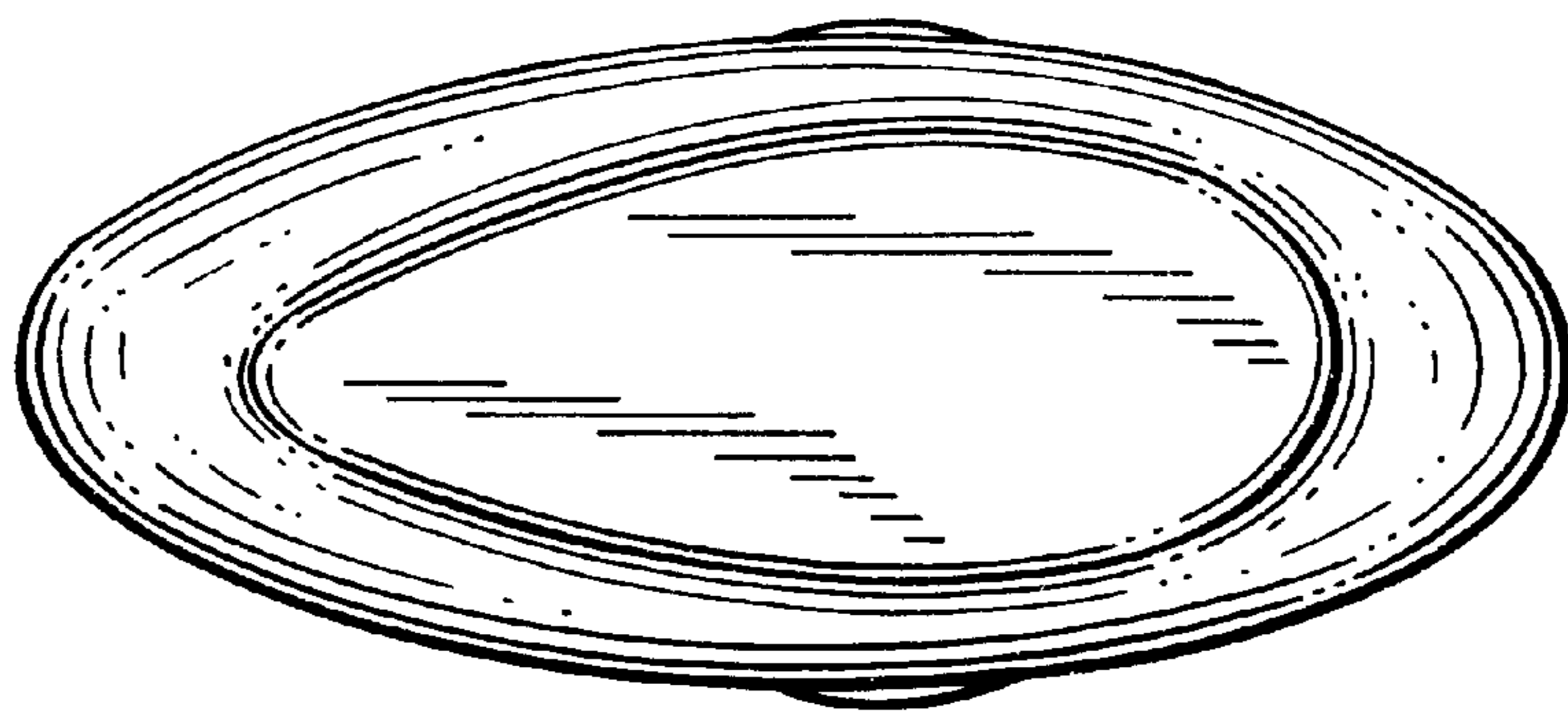

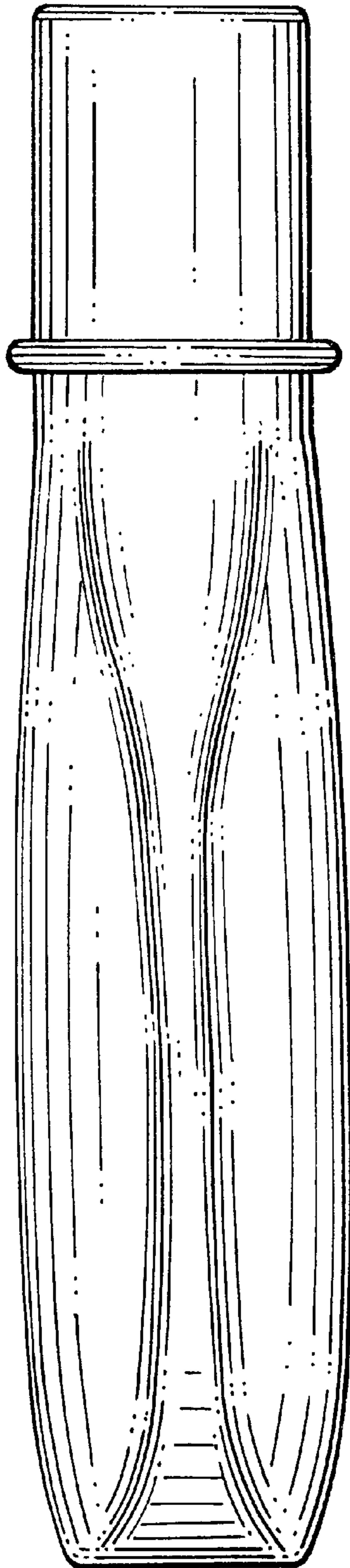

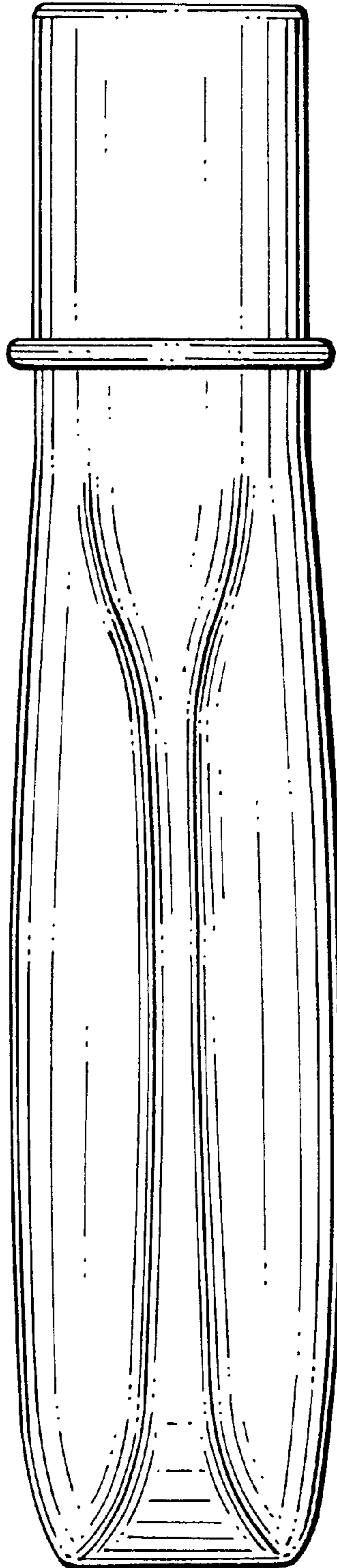
