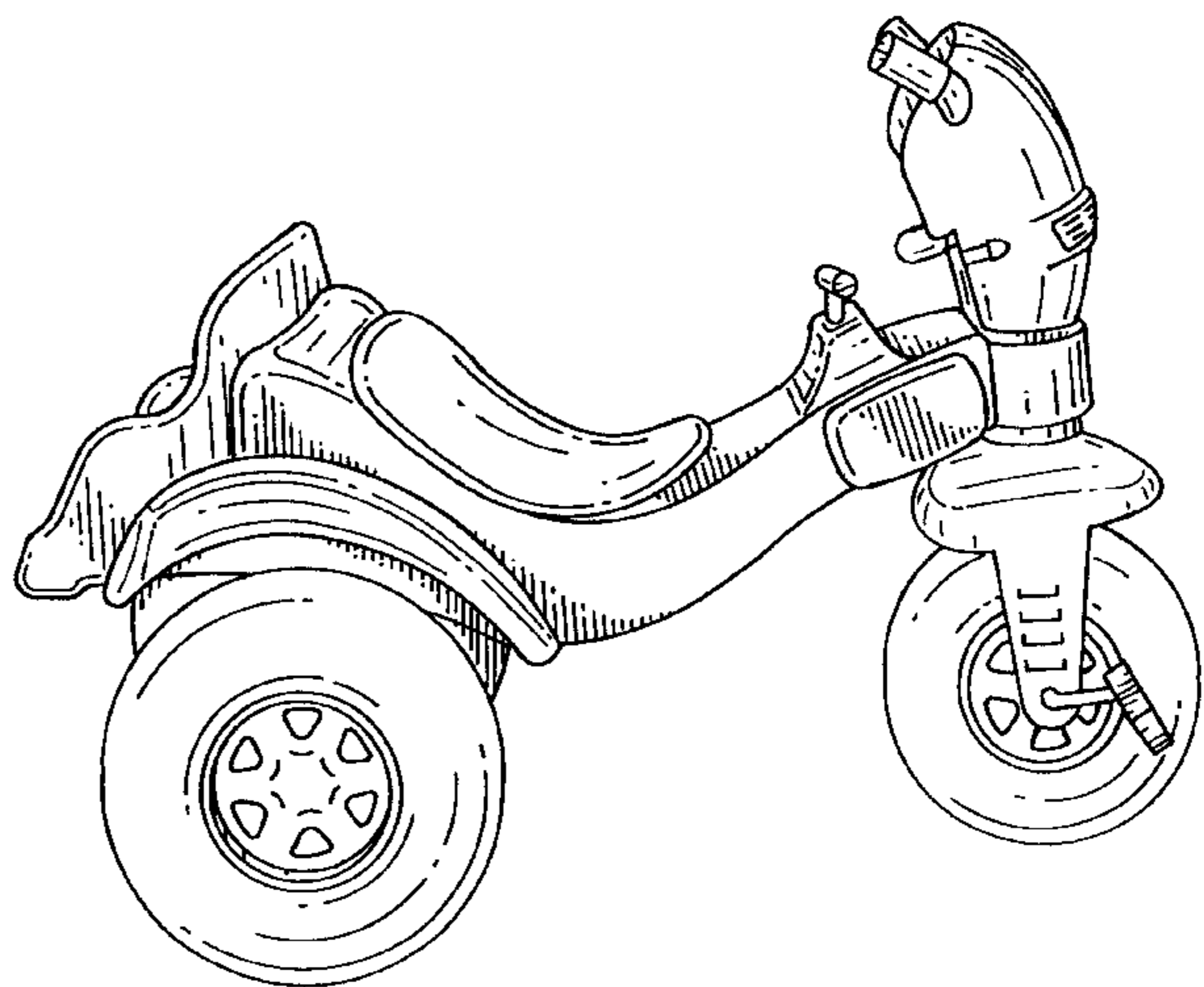
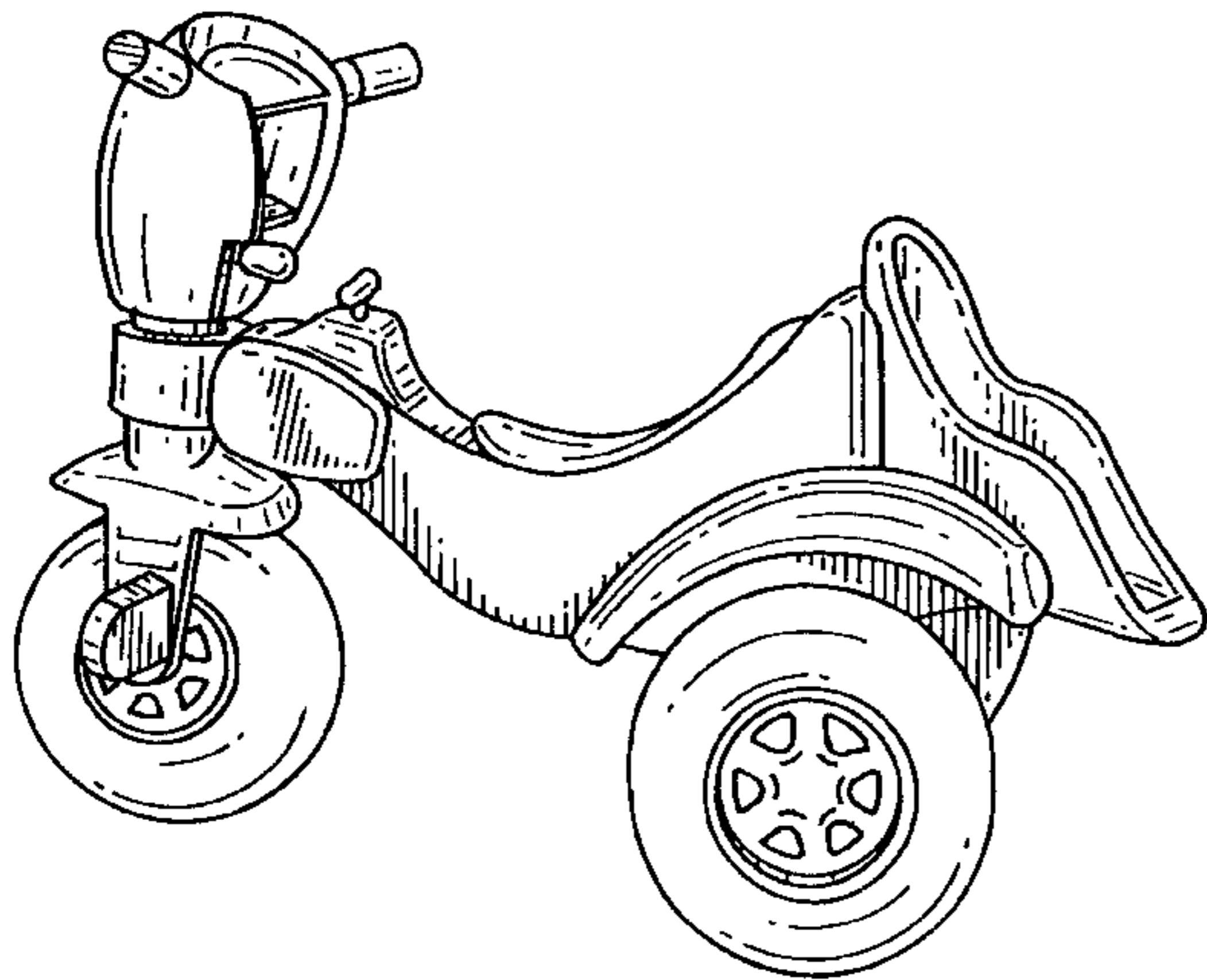
(57) **CLAIM**

The ornamental design for a tricycle with an additional rear seat, substantially as shown and described.

DESCRIPTION

FIG. 1 is a partial perspective view of the tricycle of the present invention;
 FIG. 2 is a left side view of the tricycle of the present invention;
 FIG. 3 is a full perspective view of the tricycle of the present invention from a left rear perspective;
 FIG. 4 is a rear view of the tricycle of the present invention;
 FIG. 5 is a full perspective view of the tricycle of the present invention from a right rear perspective;
 FIG. 6 is a right side view of the tricycle of the present invention;
 FIG. 7 is a full perspective view of the tricycle of the present invention from a right, front perspective;
 FIG. 8 is a front view of the tricycle of the present invention from an elevated, front elevation;
 FIG. 9 is a full perspective view of the tricycle of the present invention from a left, front perspective;
 FIG. 10 is a right side view of the tricycle of the present invention containing a tiltable rear bucket seat;
 FIG. 11 is a perspective view of the tricycle of the present invention taken from a right front elevation;
 FIG. 12 is a perspective view of the tricycle of the present invention taken from a left rear elevation;
 FIGS. 13 and 14 show rear elevational views of the tricycle of the present invention showing the tiltable rear bucket seat in different positions; and,
 FIGS. 15 and 16 show respective side elevational views of FIGS. 13 and 14, of the tricycle of the present invention.

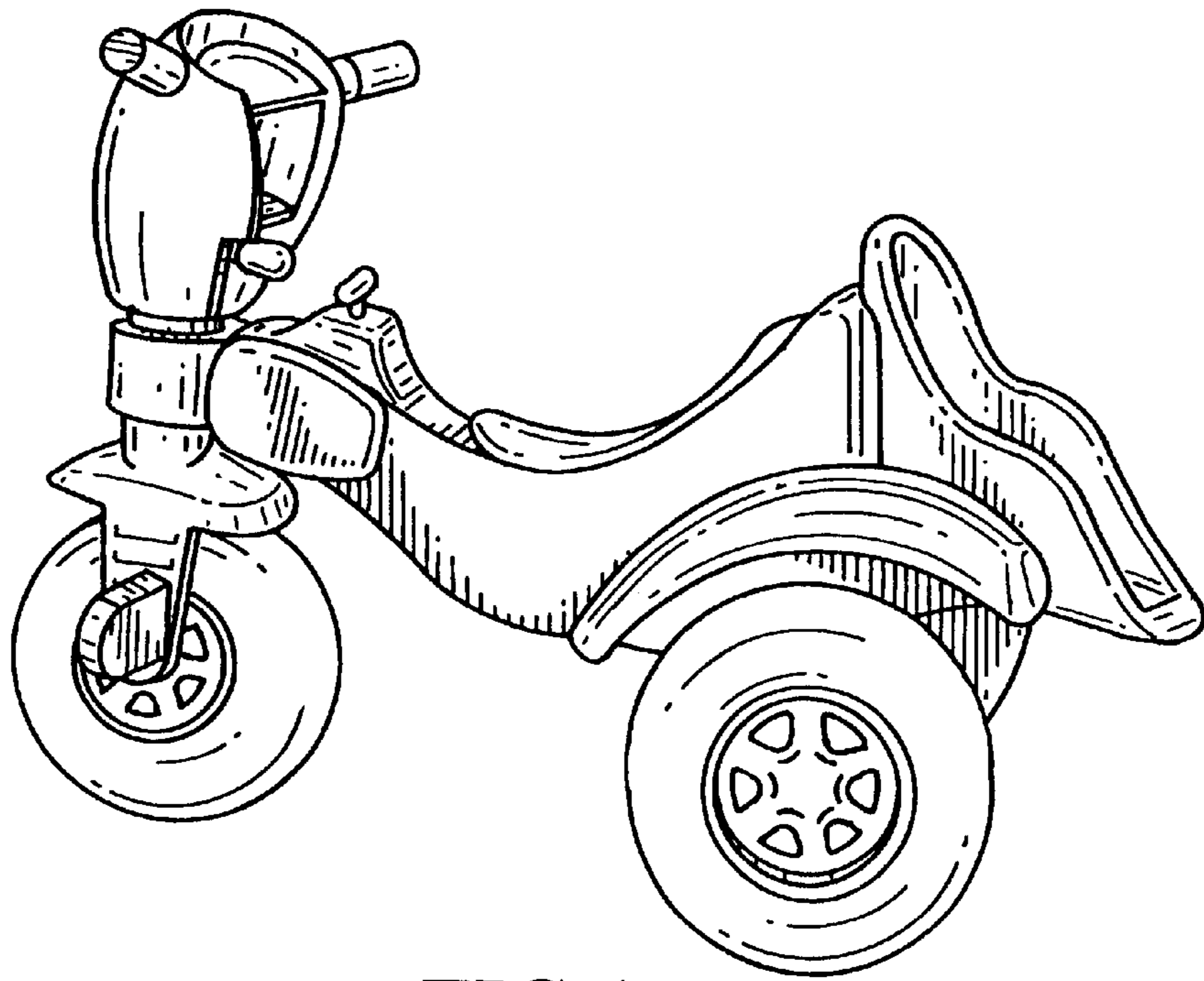

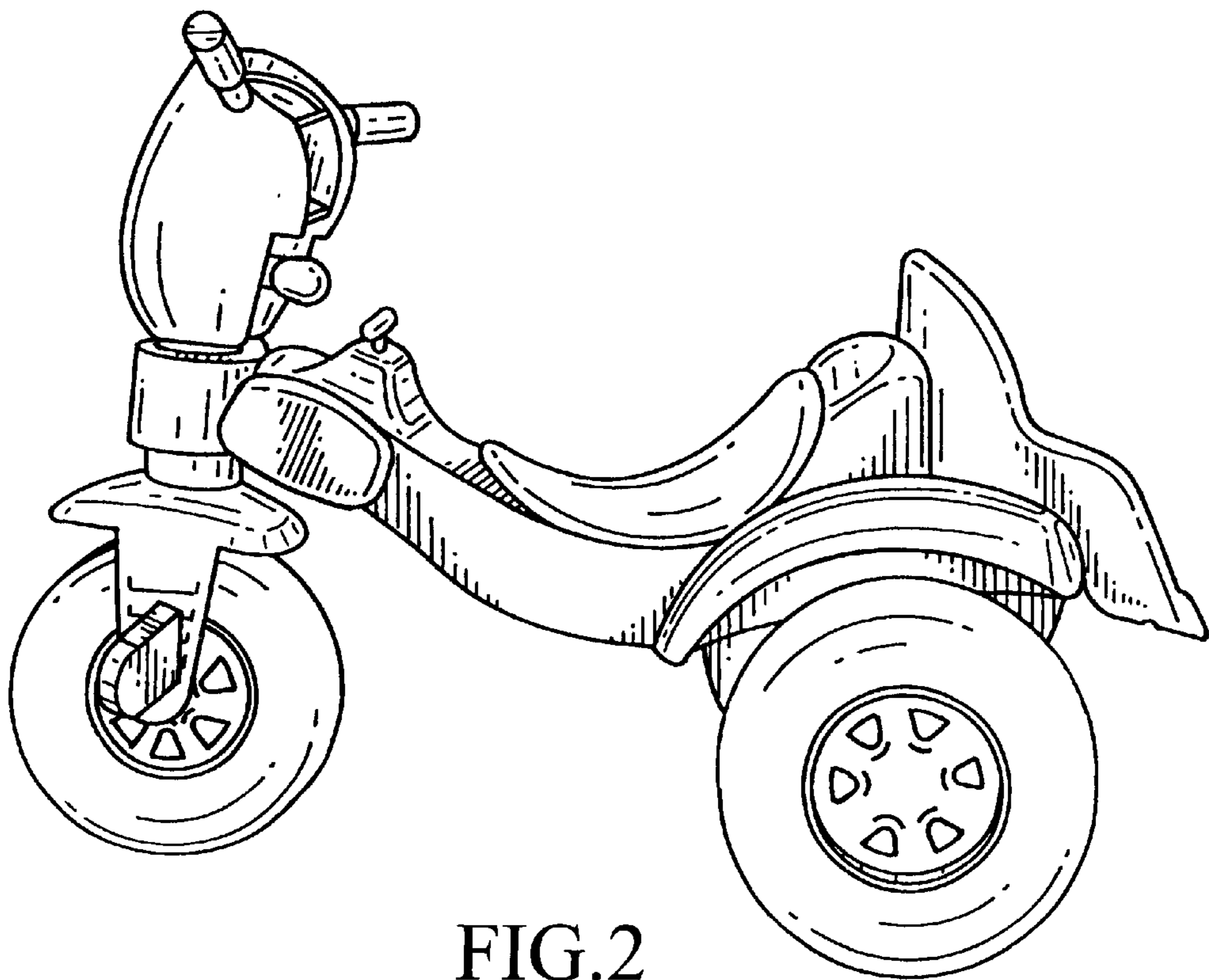

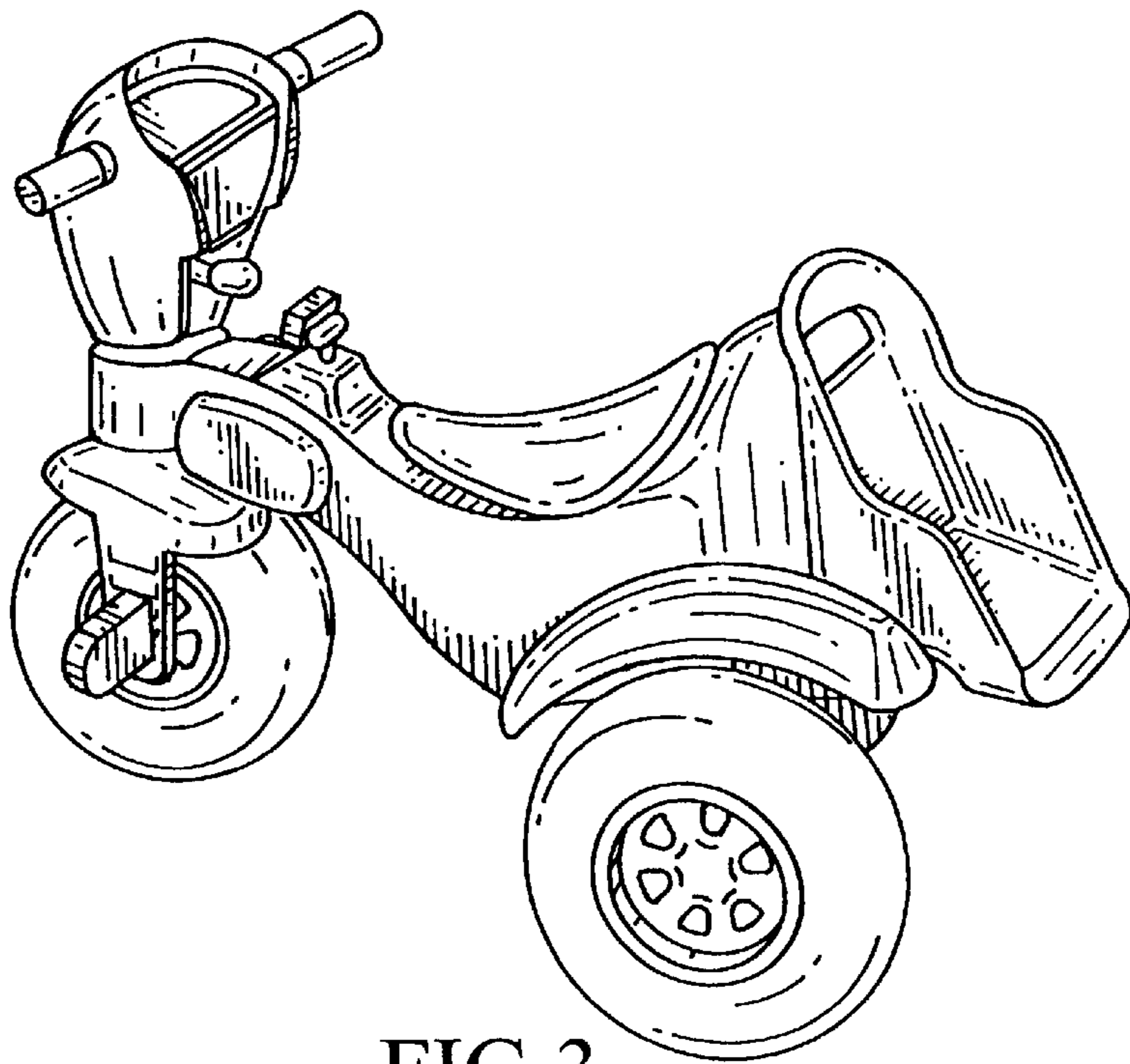

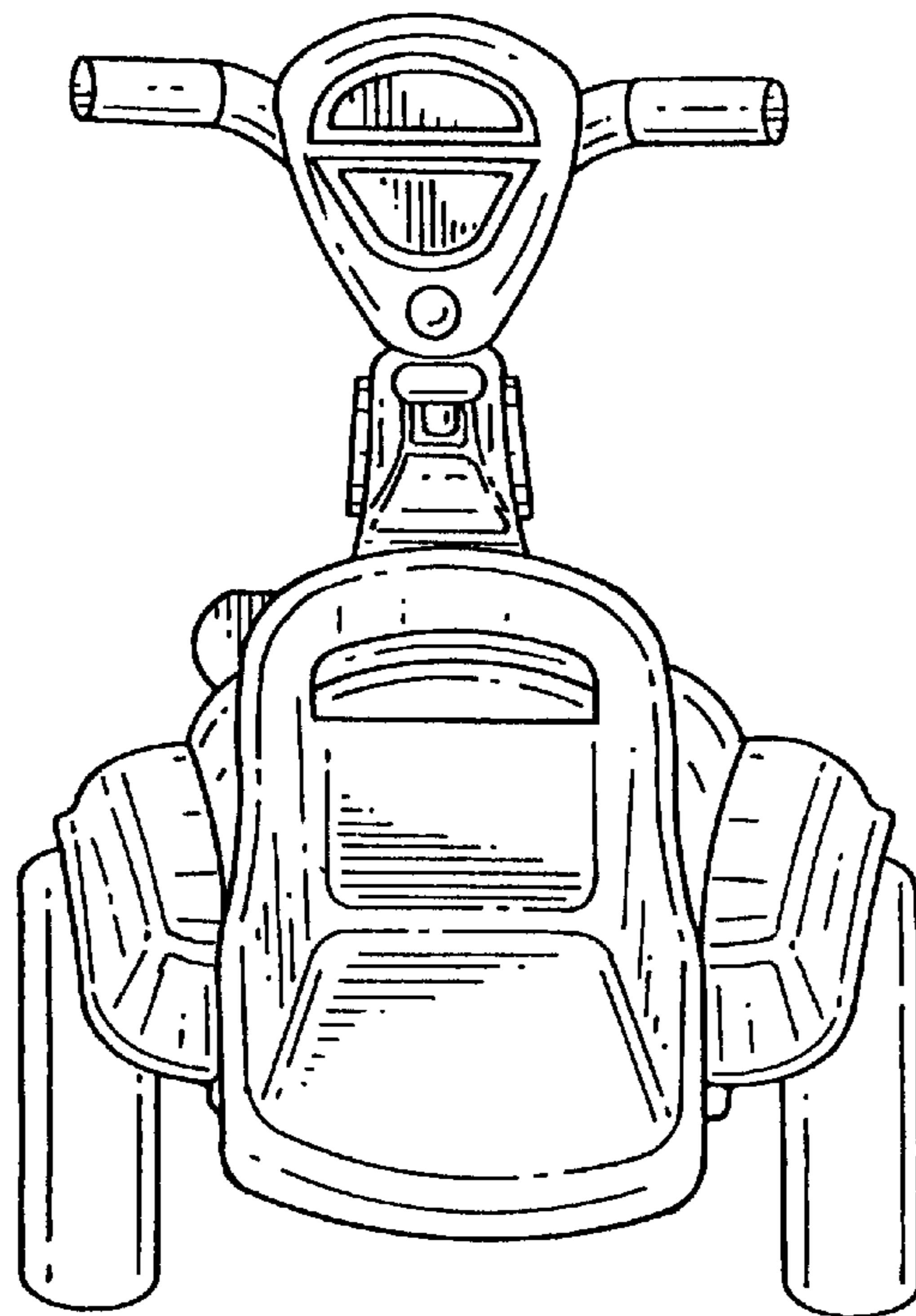

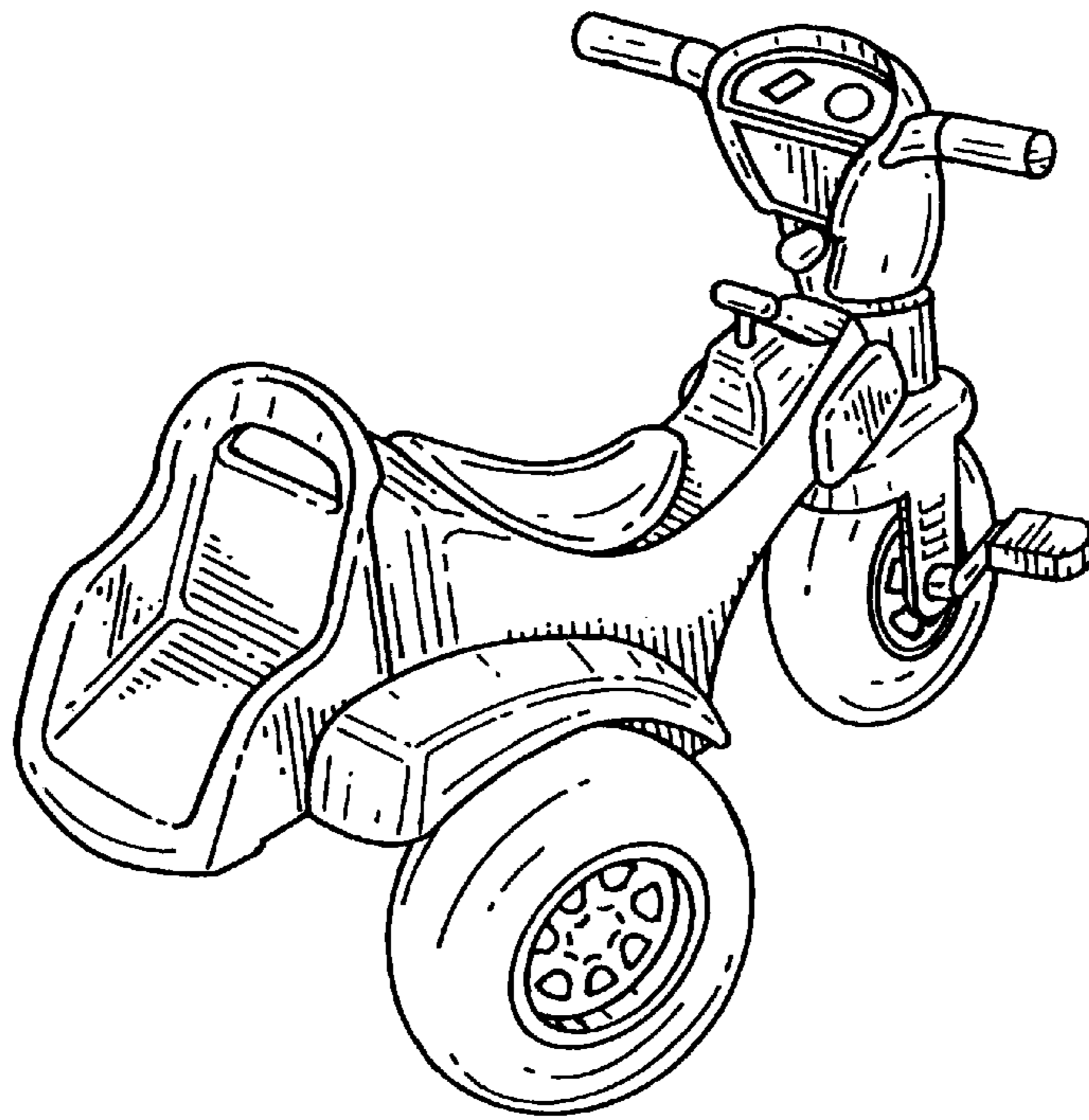

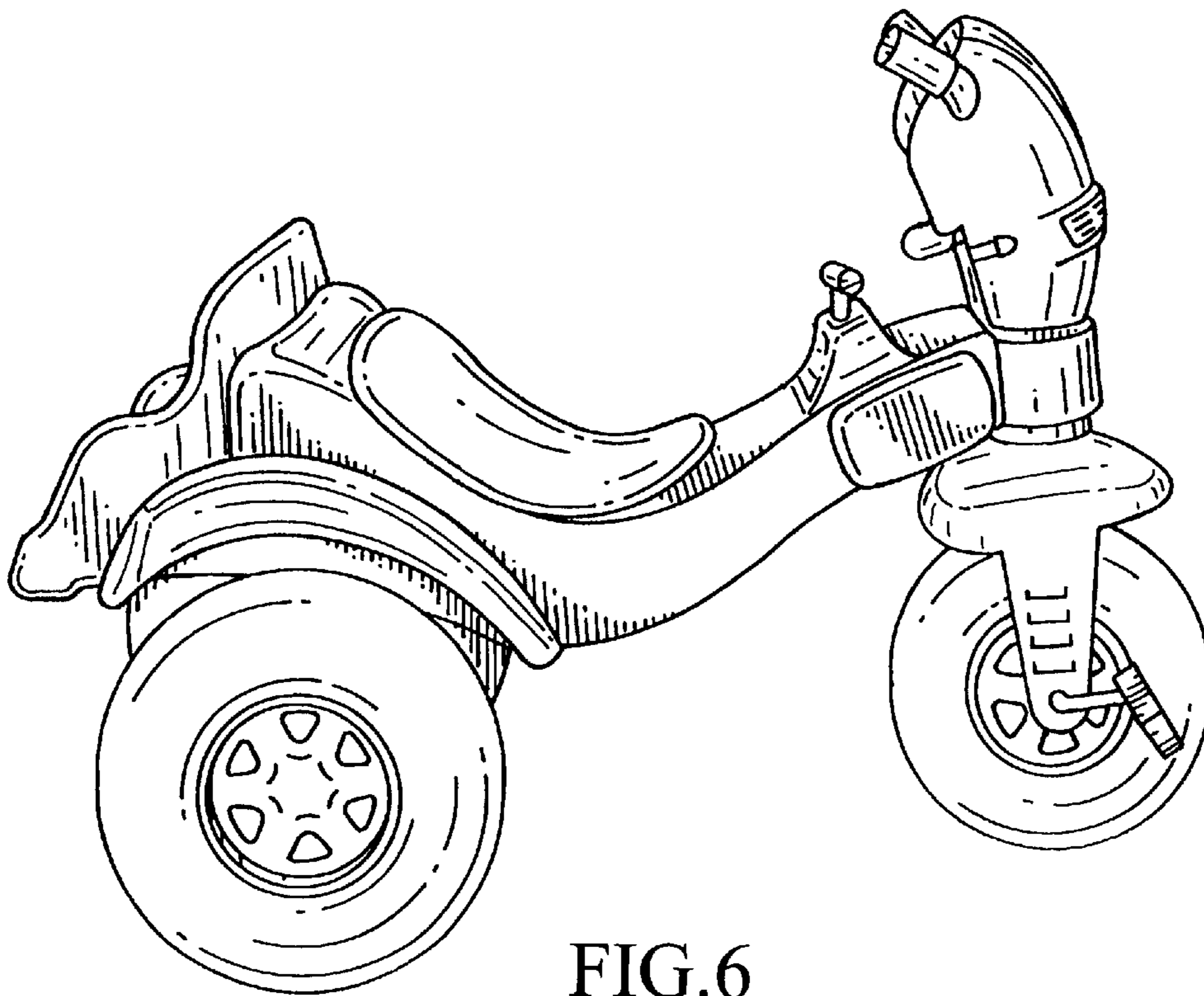

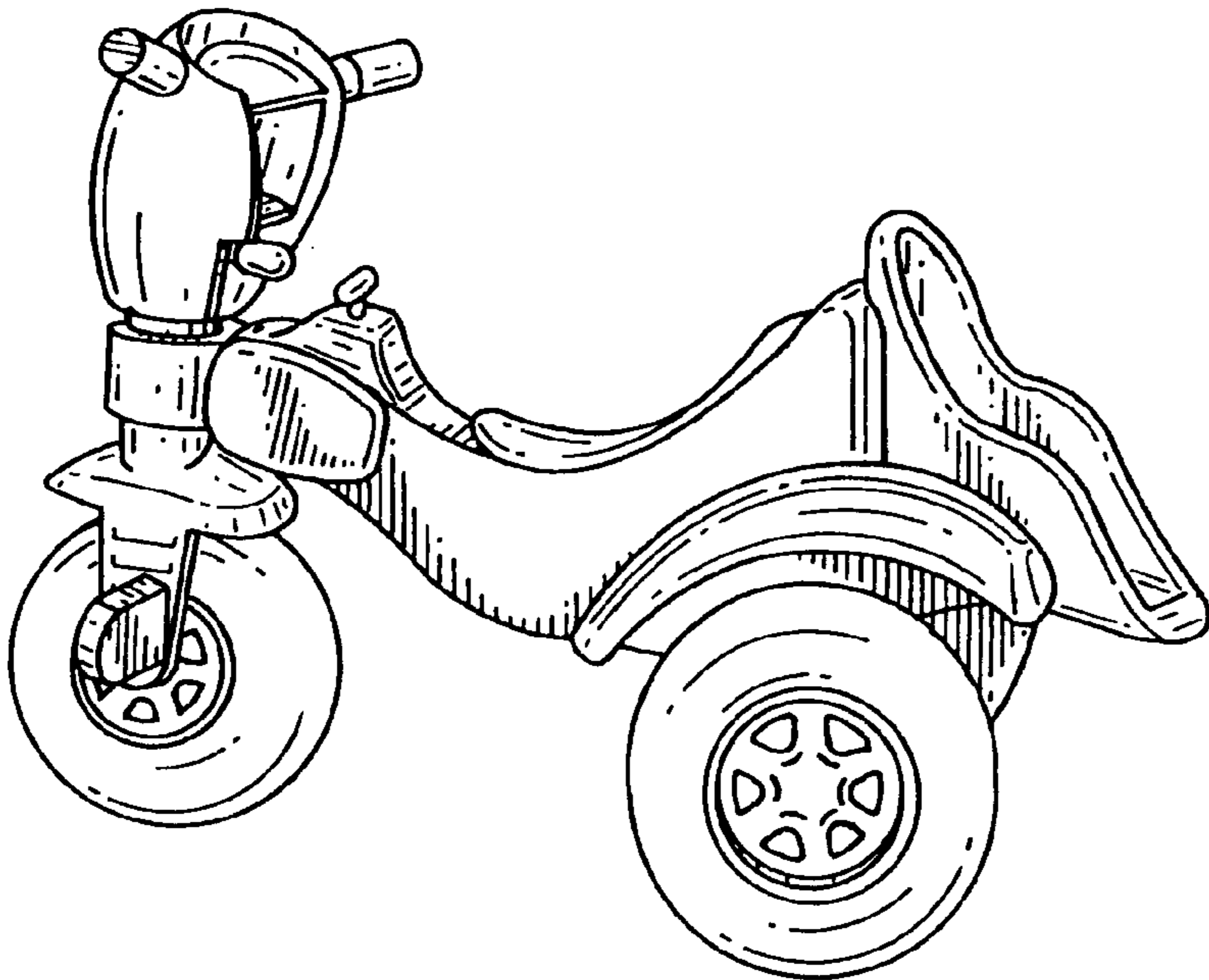

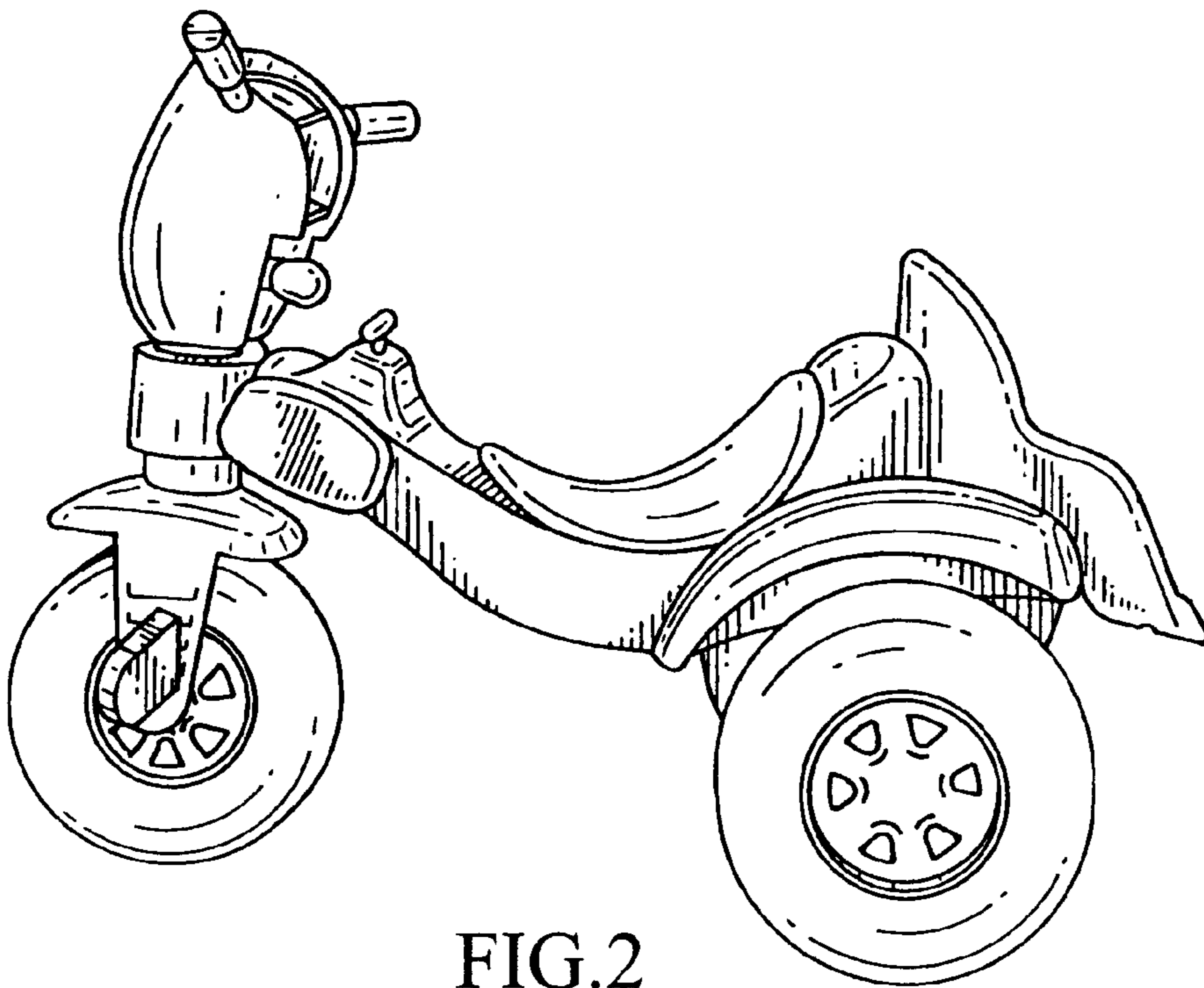

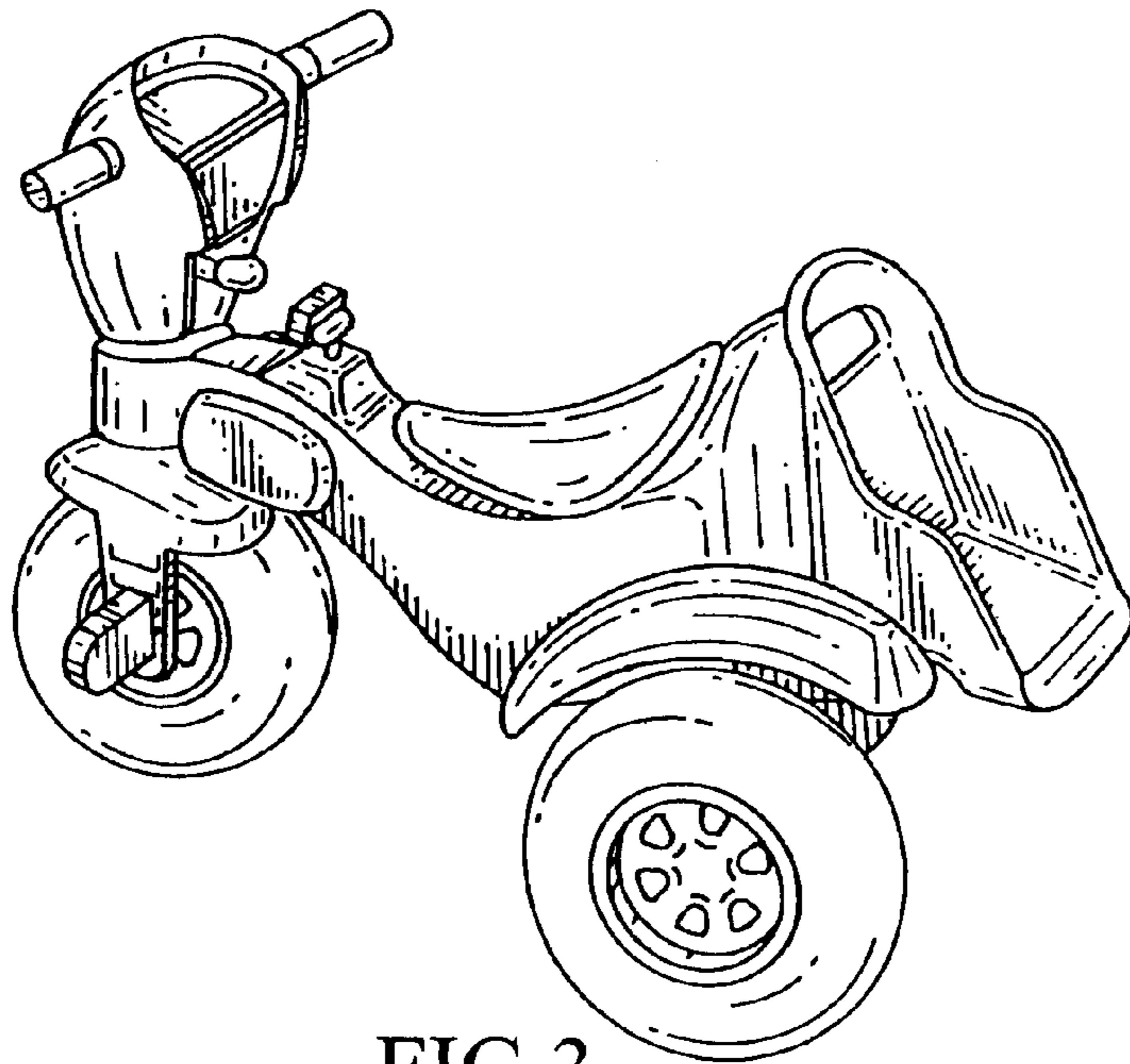

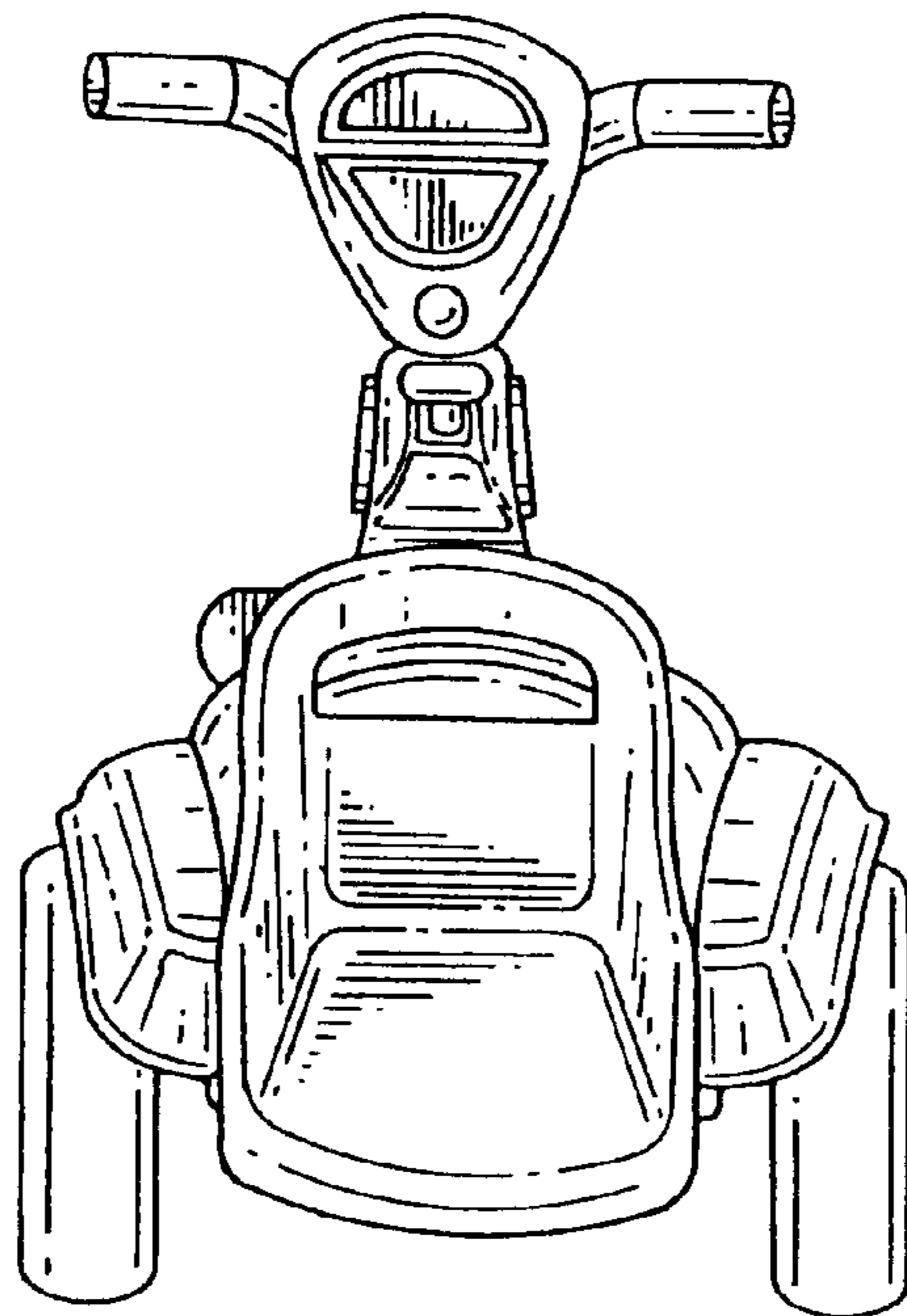

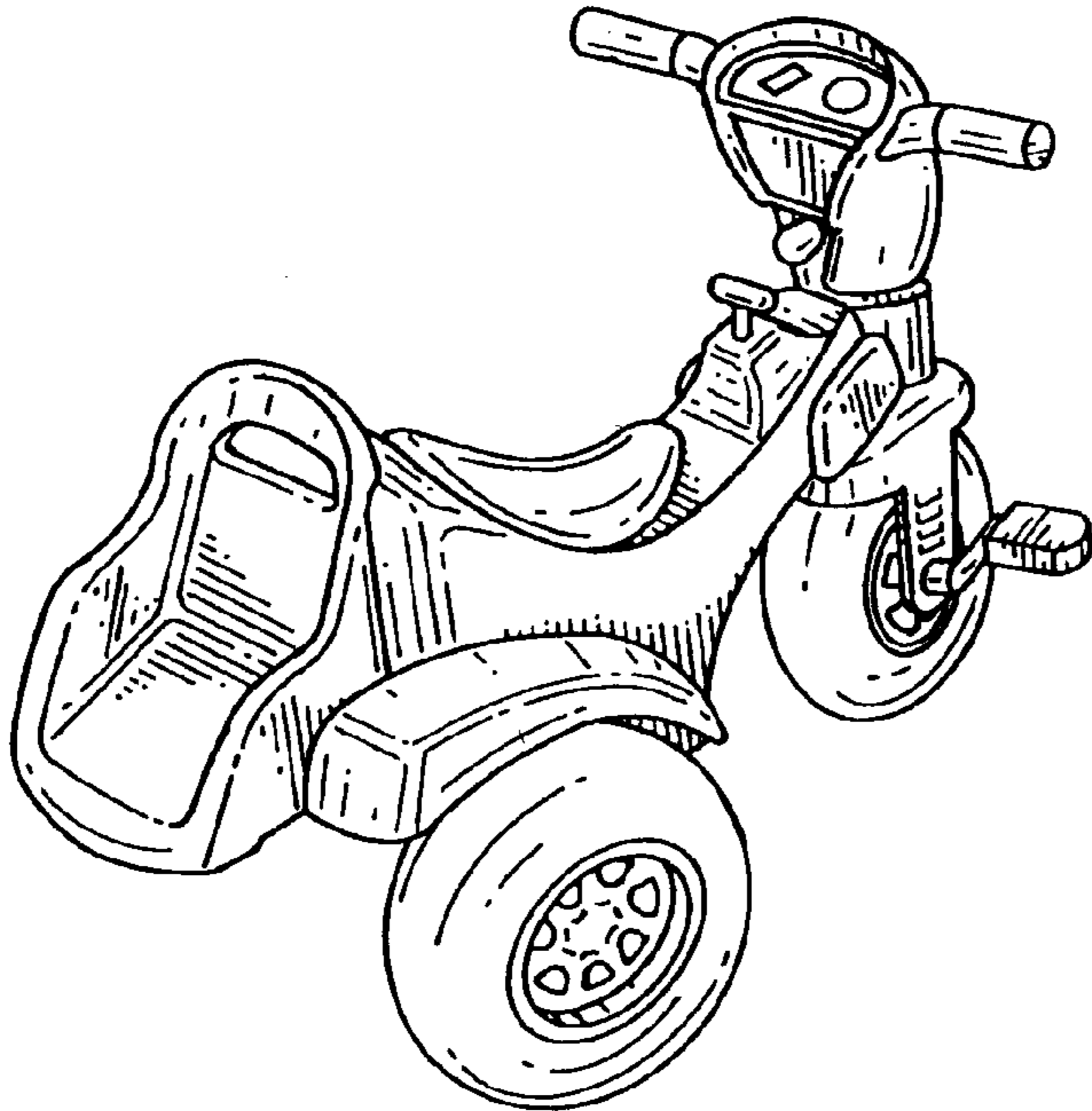

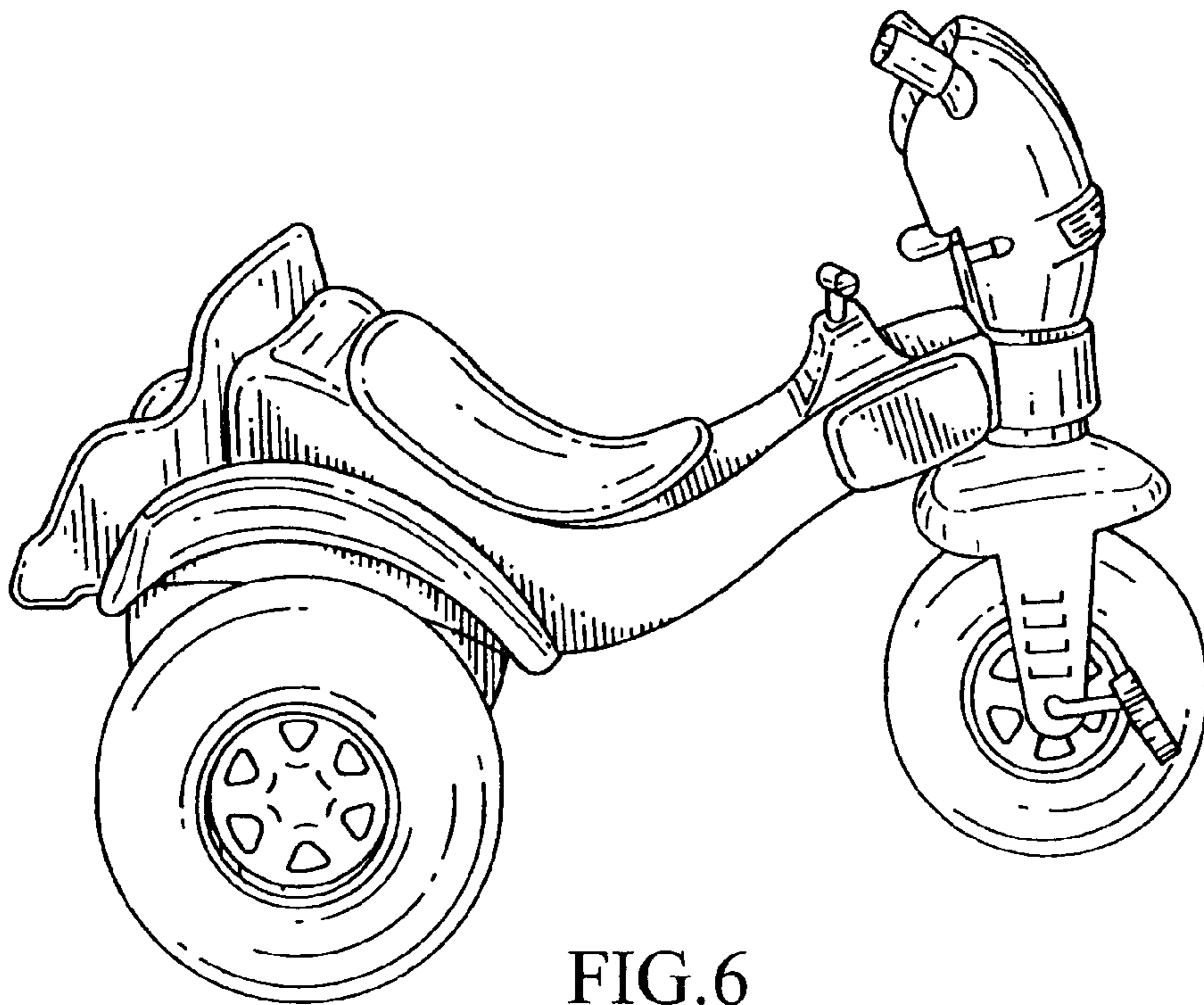

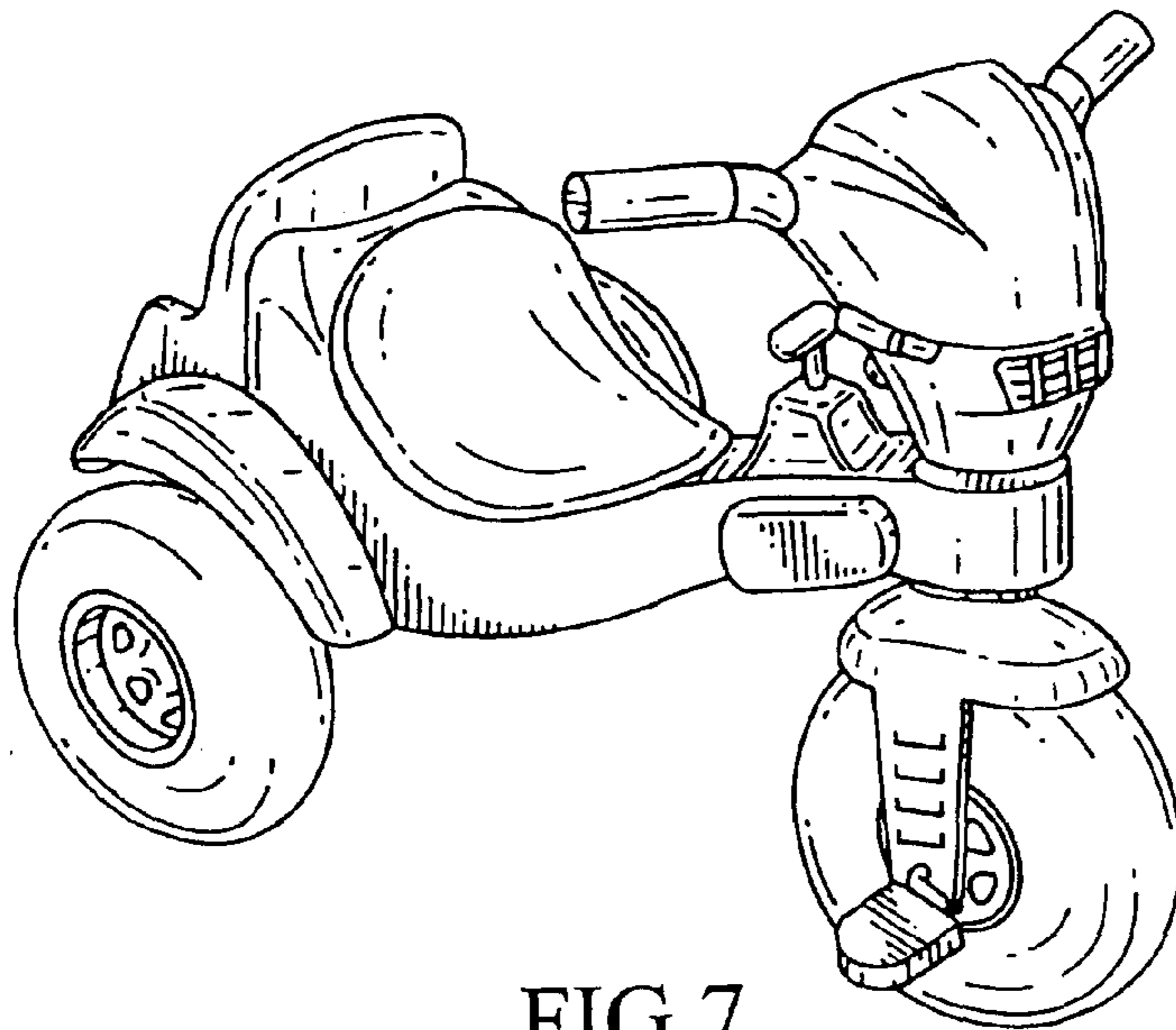

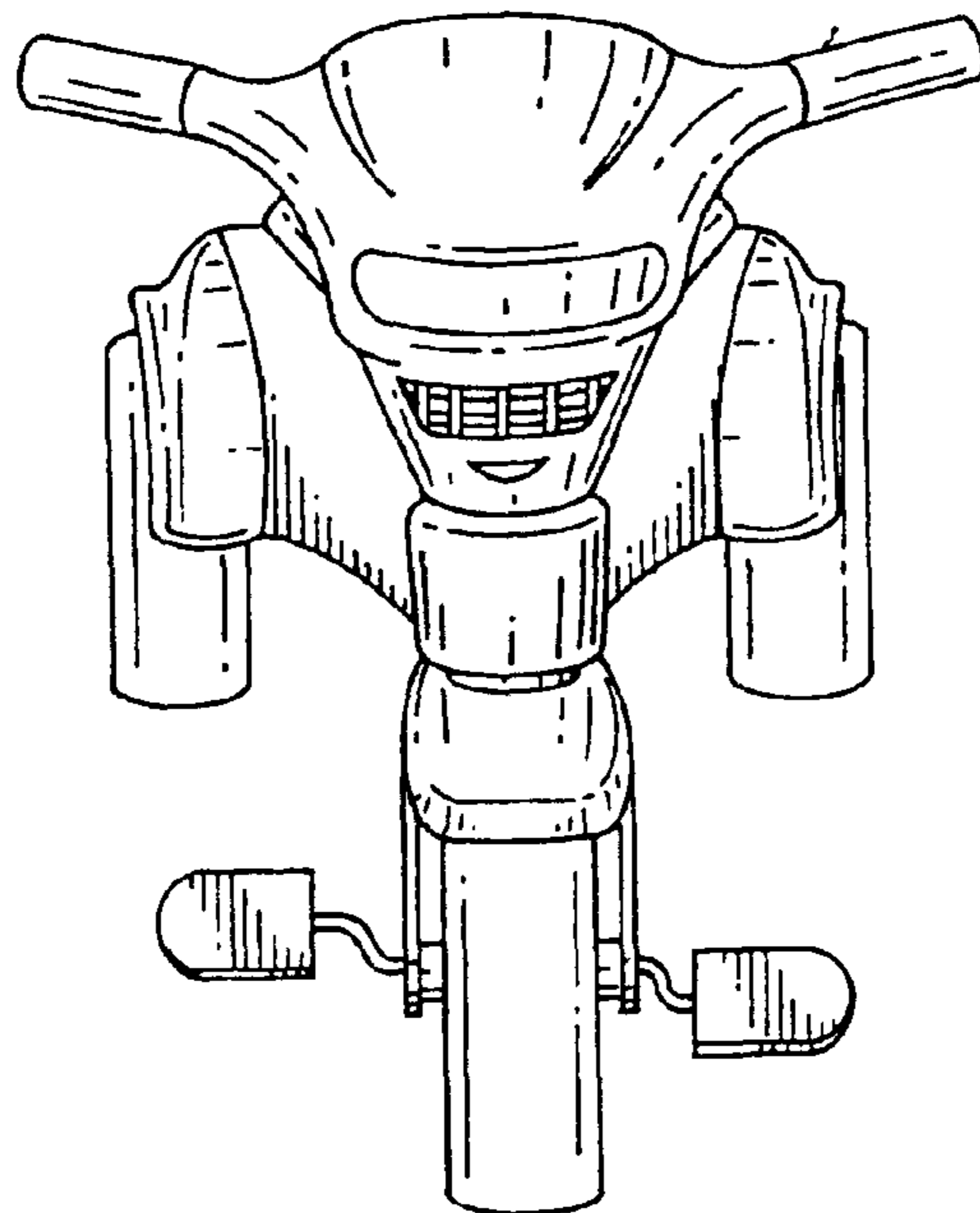

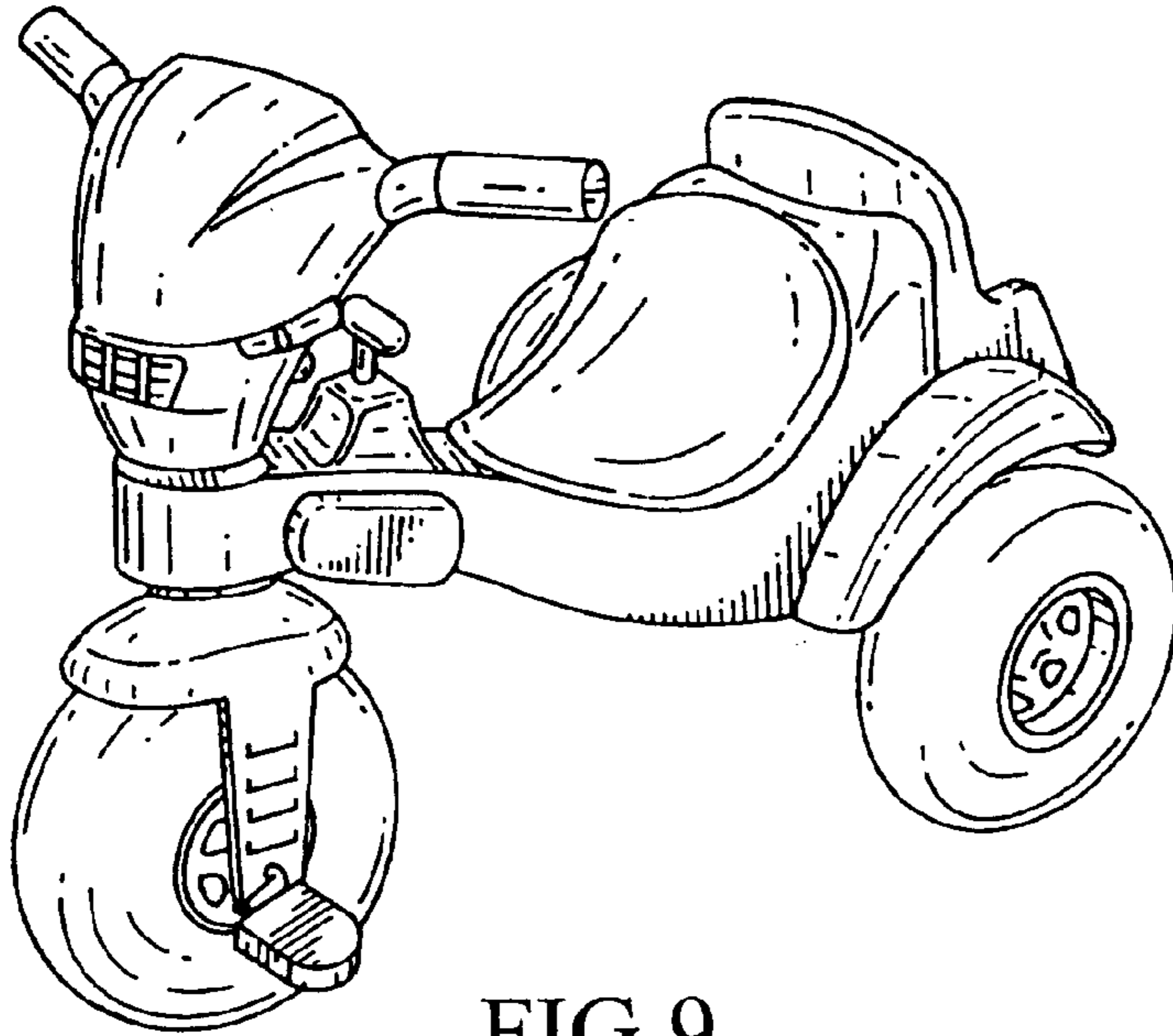

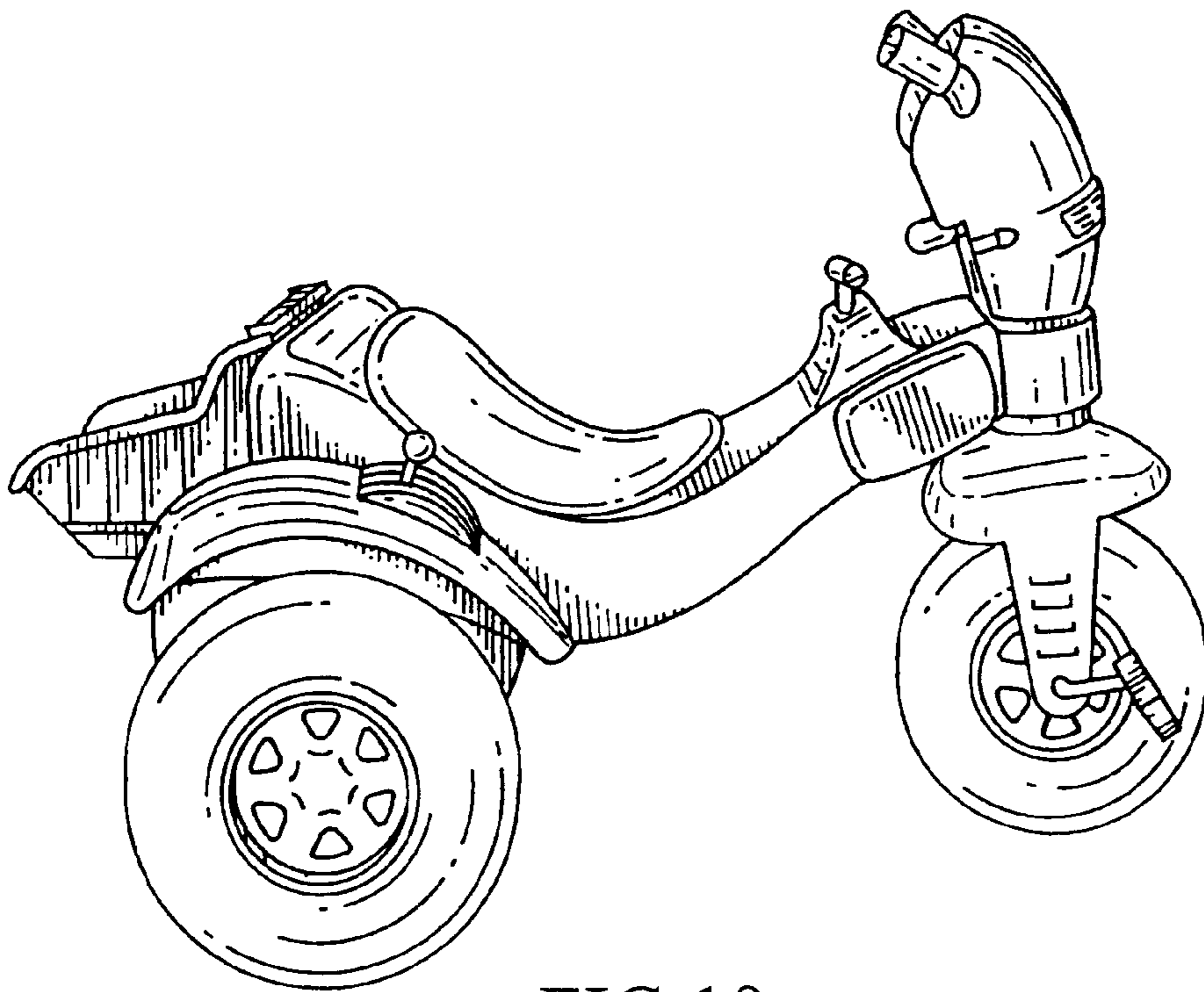

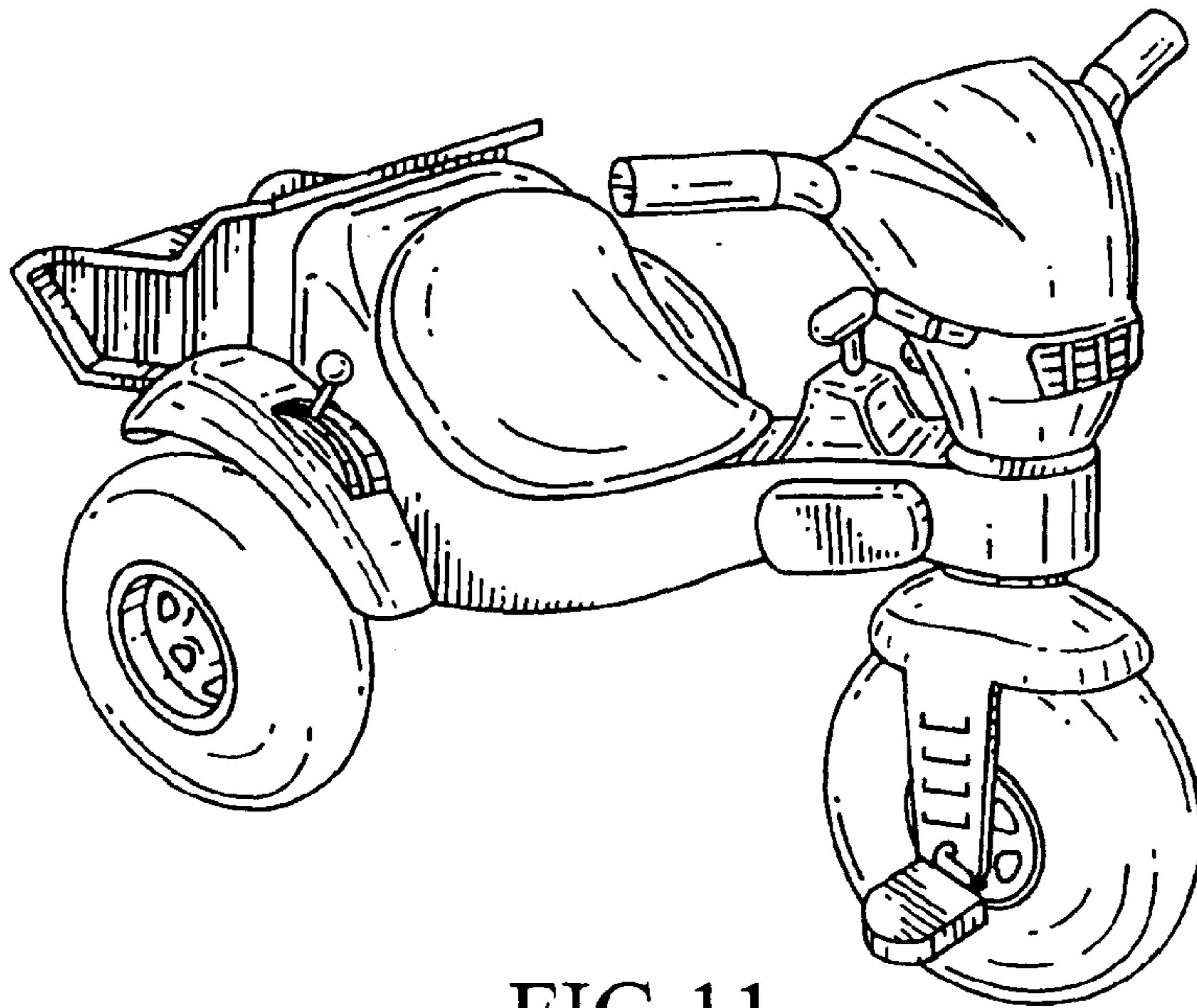

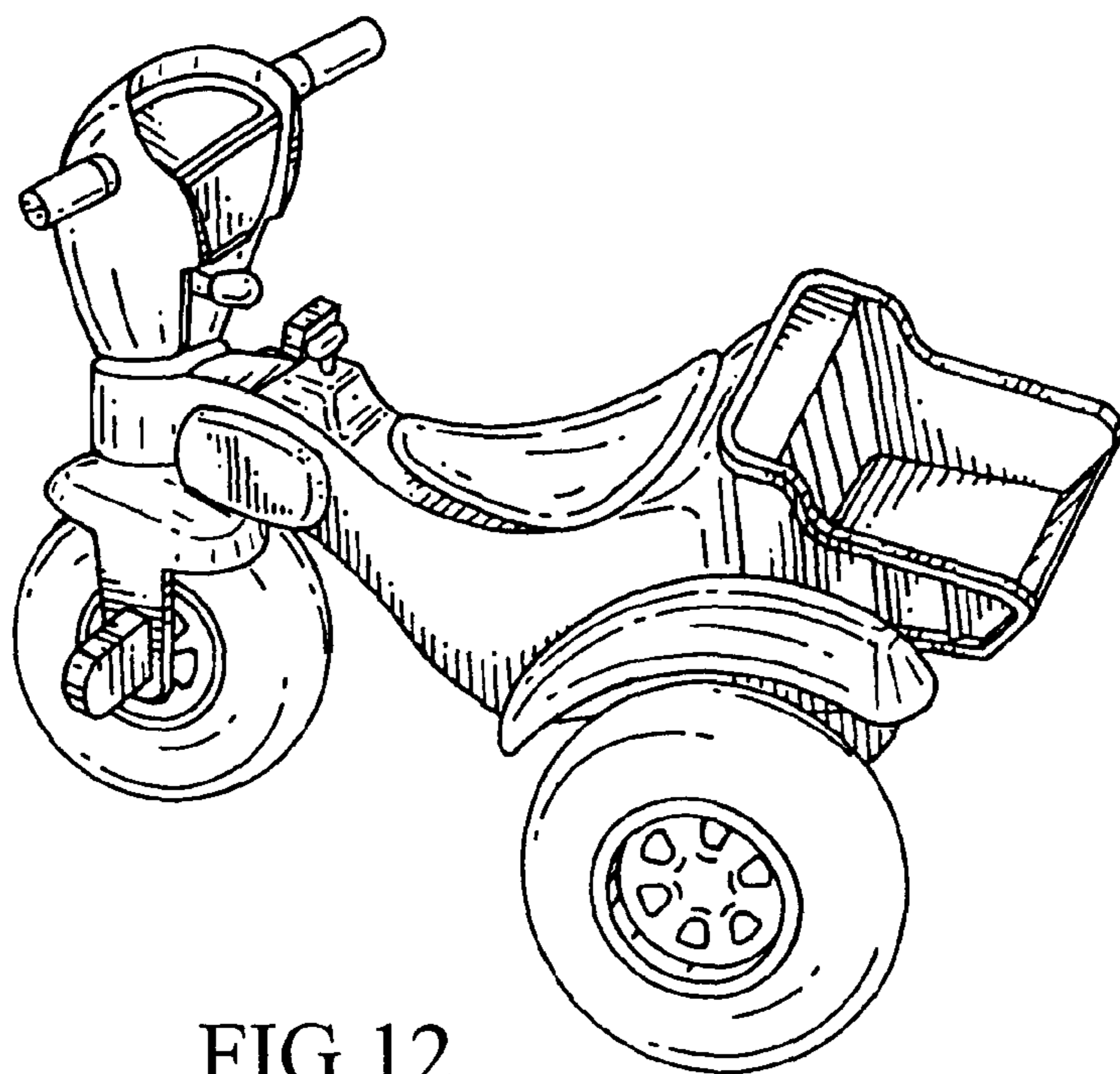

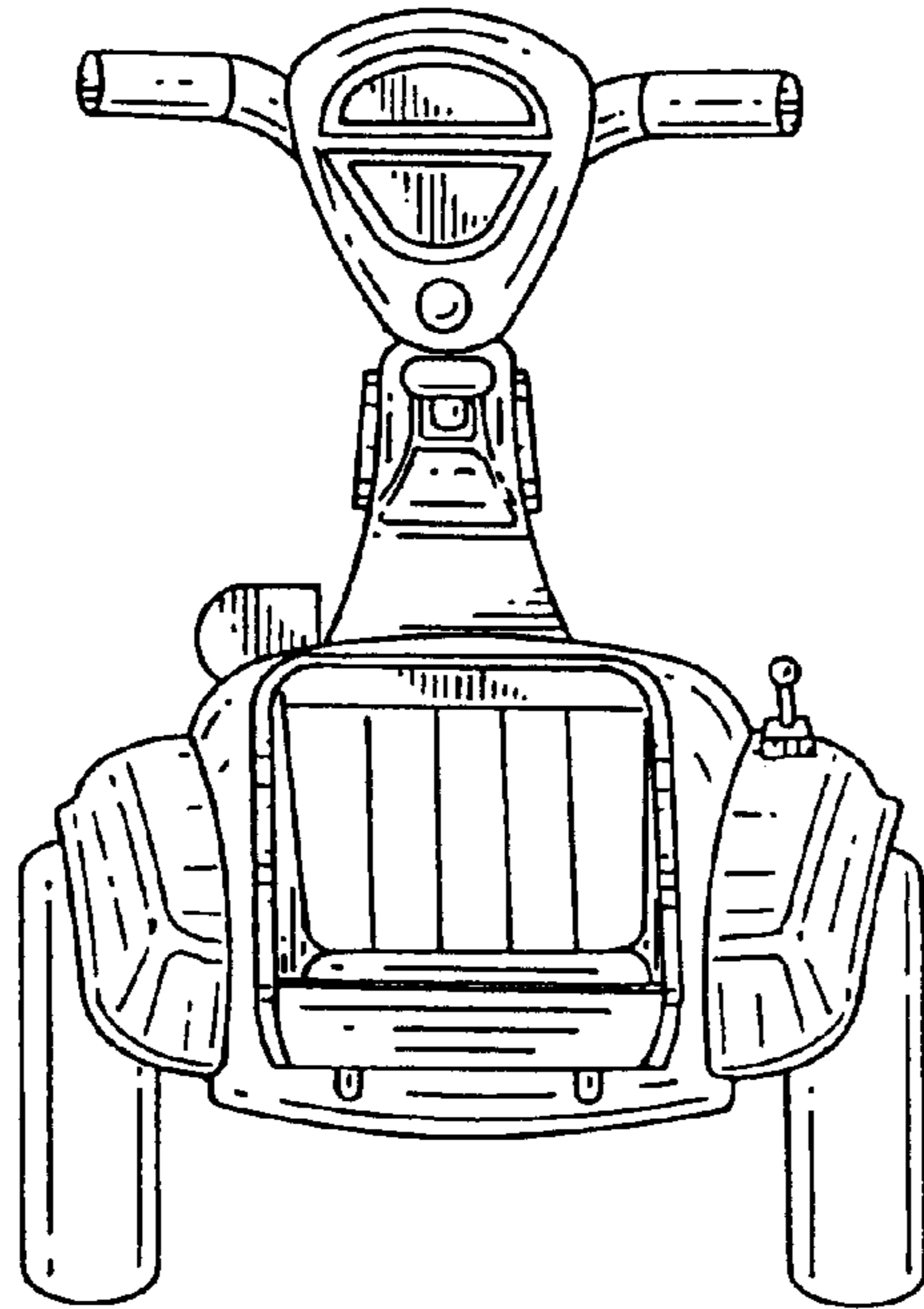

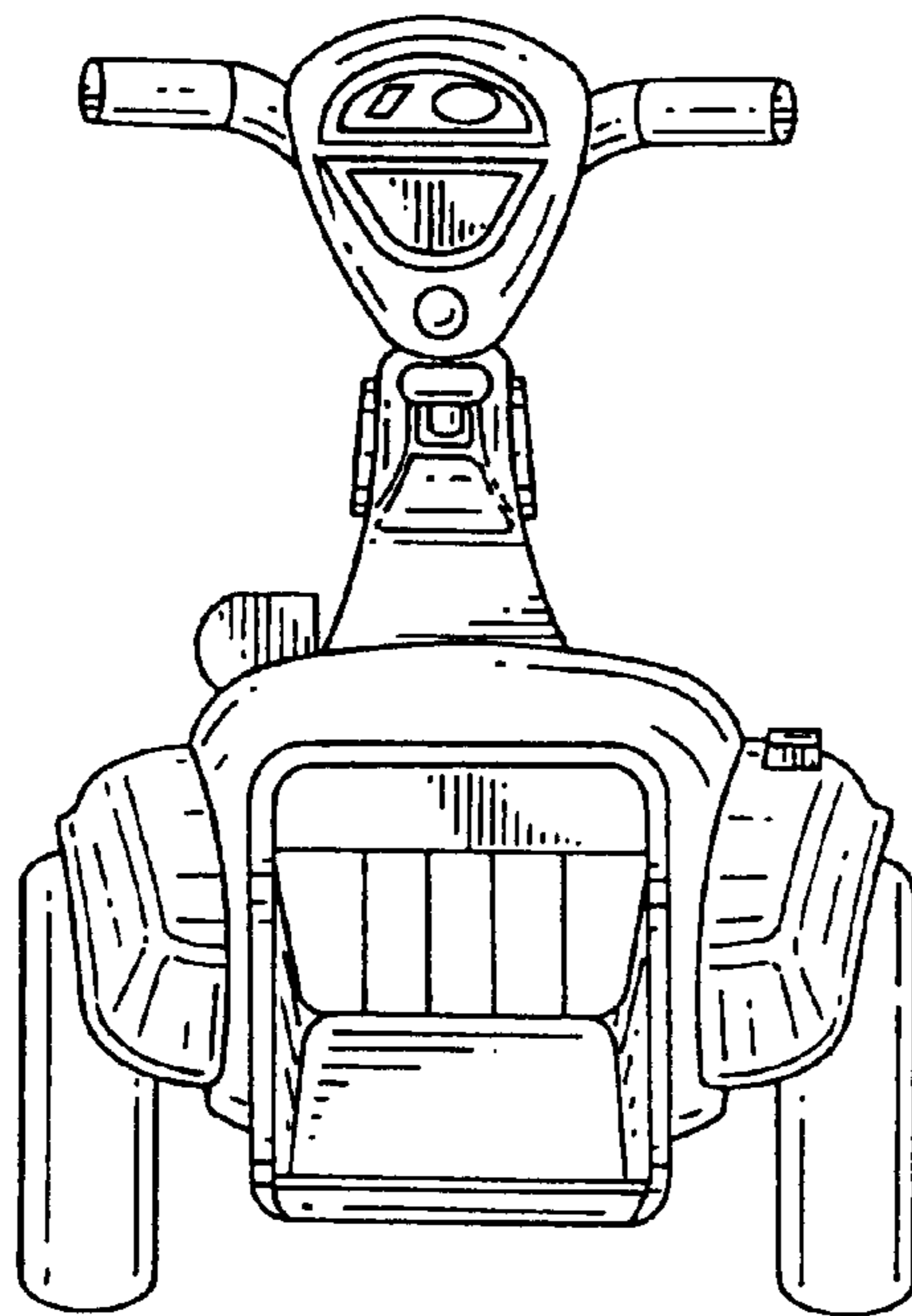

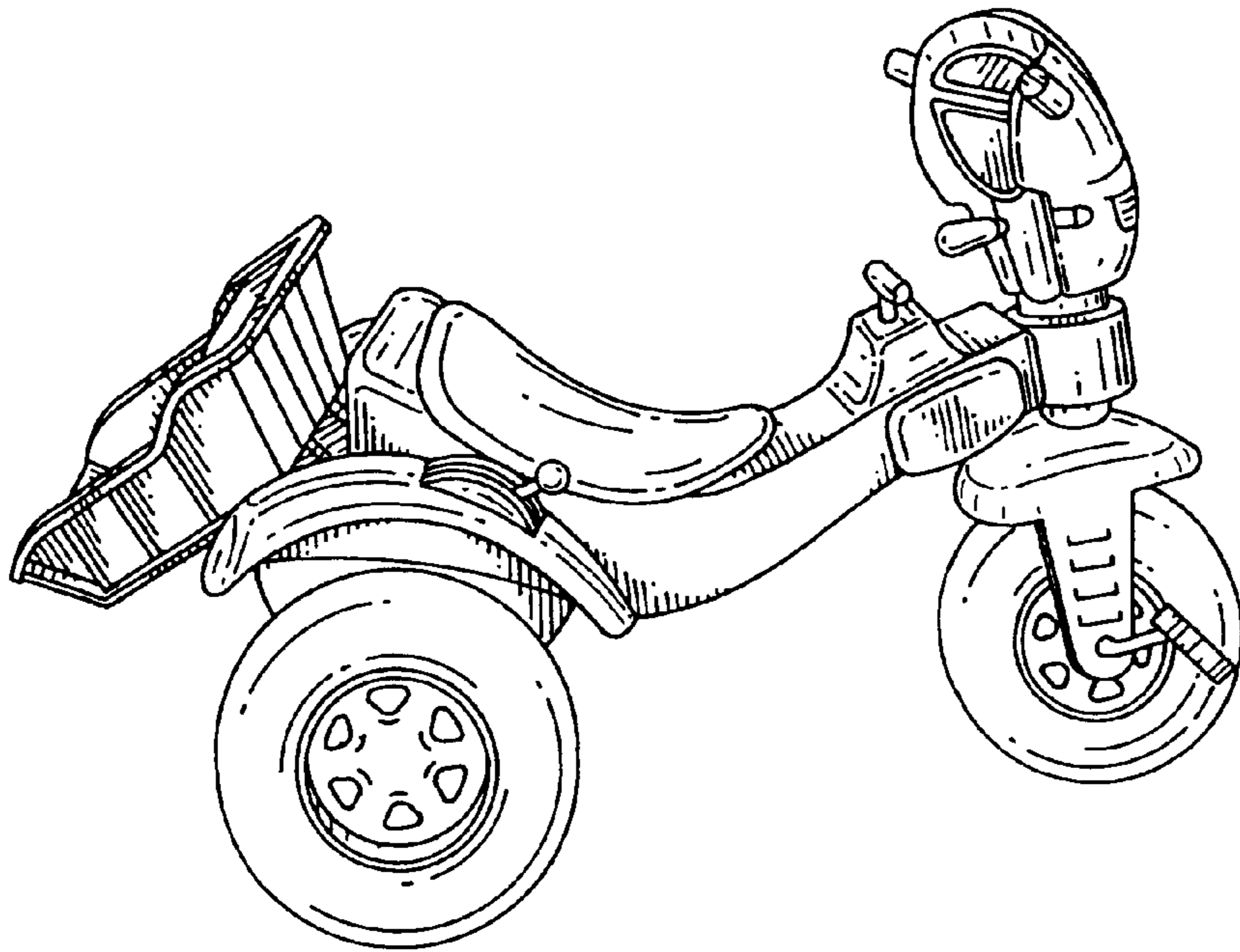

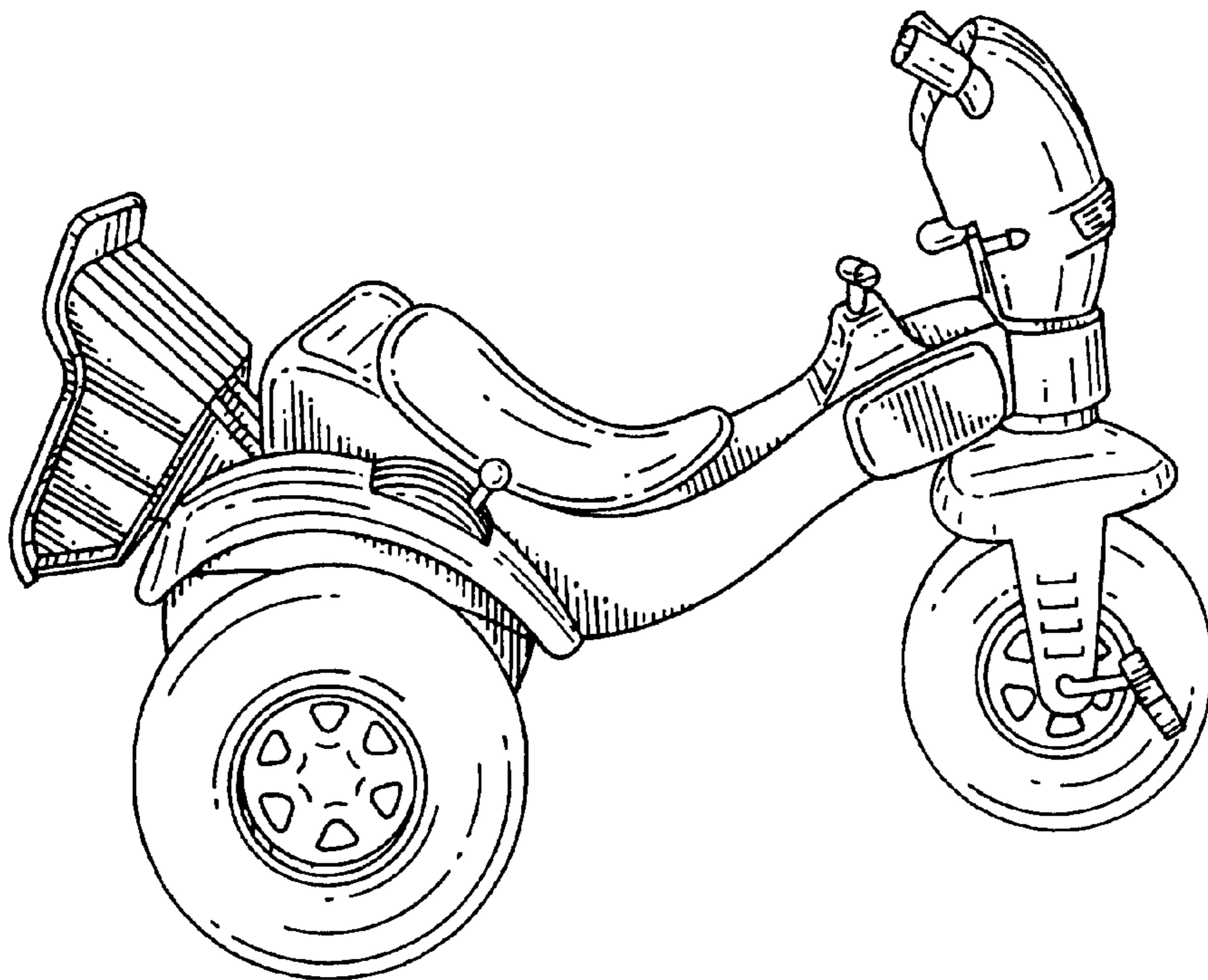
