(57) **CLAIM**

We claim the ornamental design for a clip for a writing instrument, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a clip for a writing instrument showing our new design;

FIG. 3 is a rear elevational view thereof;

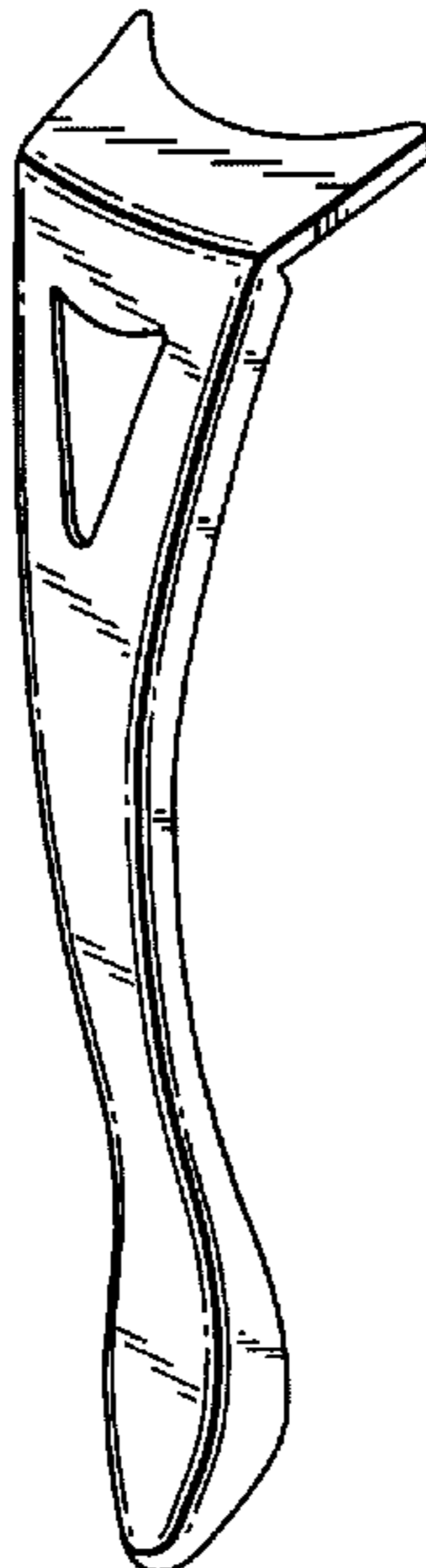
FIG. 4 is a right side elevational view, the left side being a mirror image thereof;

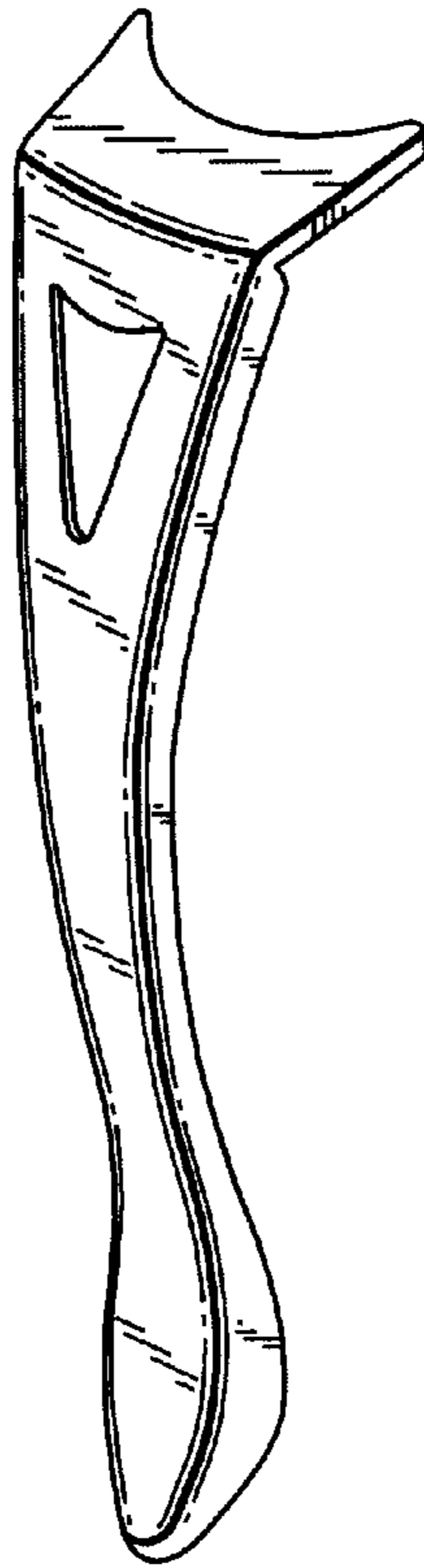
FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof; and,

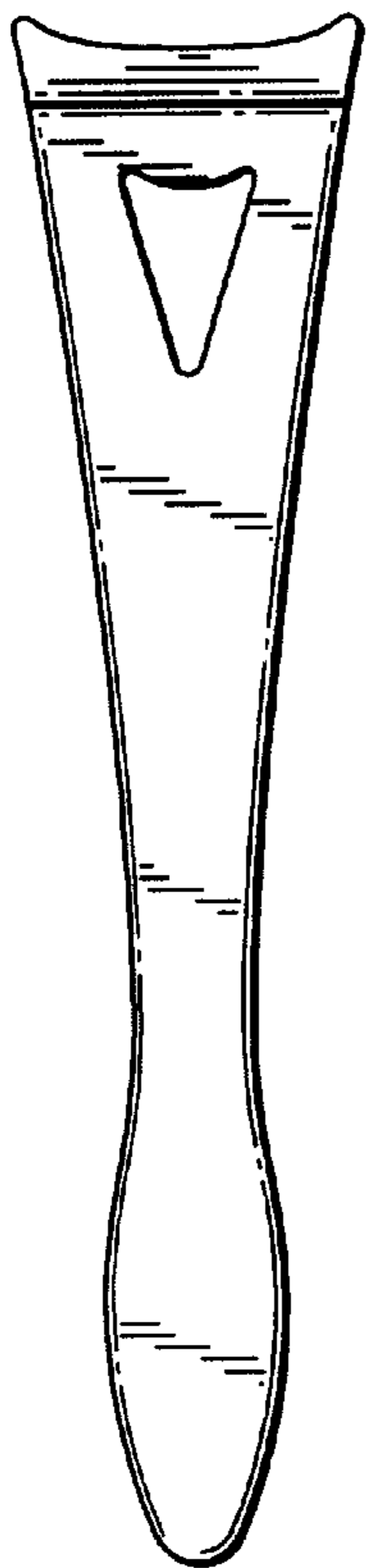
FIG. 7 is a second perspective view thereof, the writing instrument depicted by means of broken lines being shown for illustrative purposes only and forming no part of the claimed design.

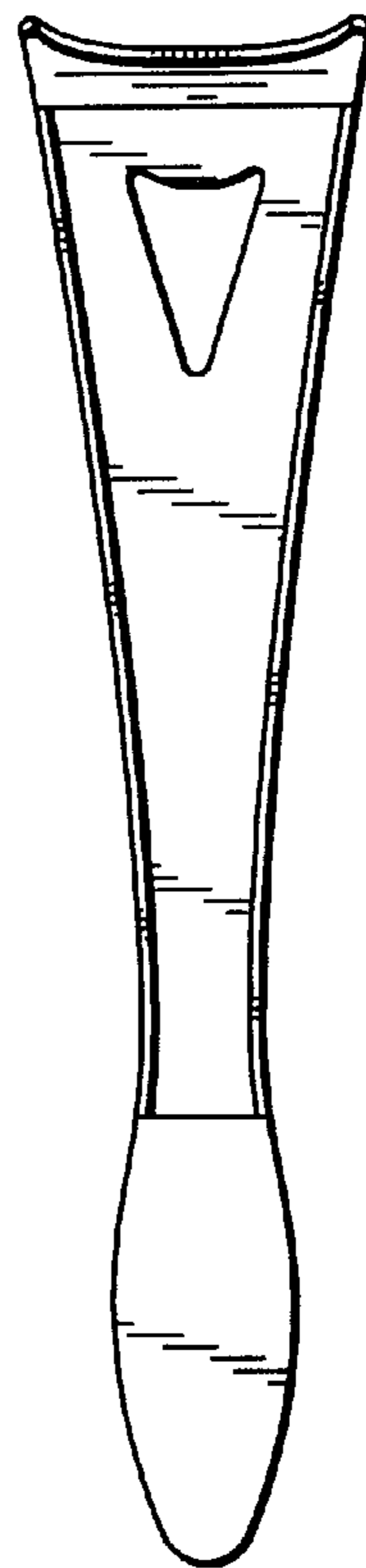




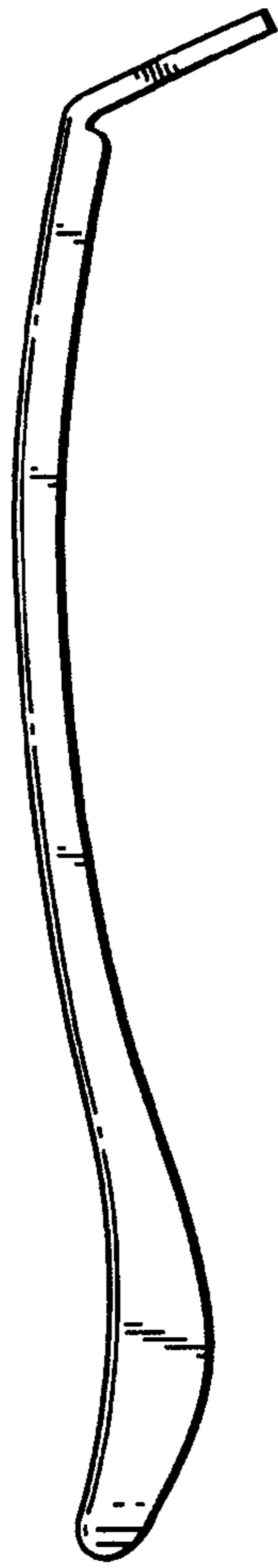

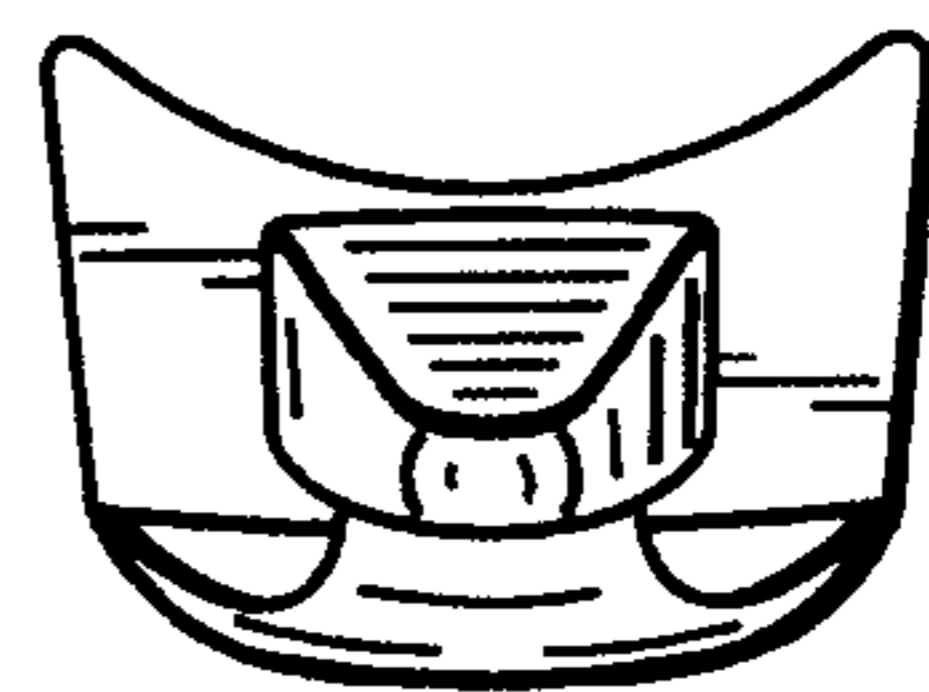

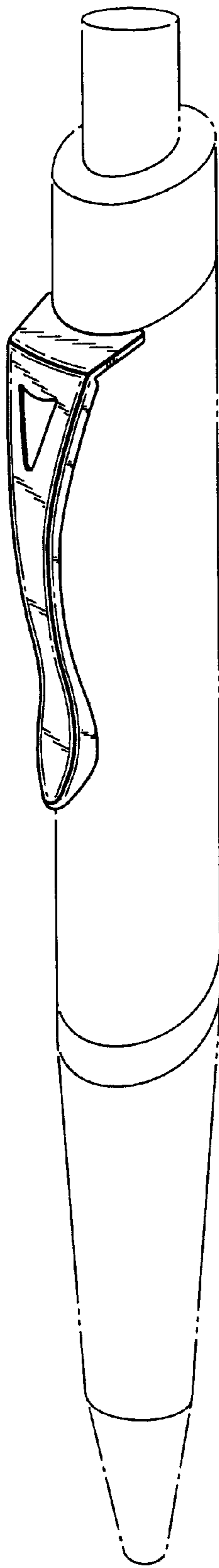
