(57) **CLAIM**

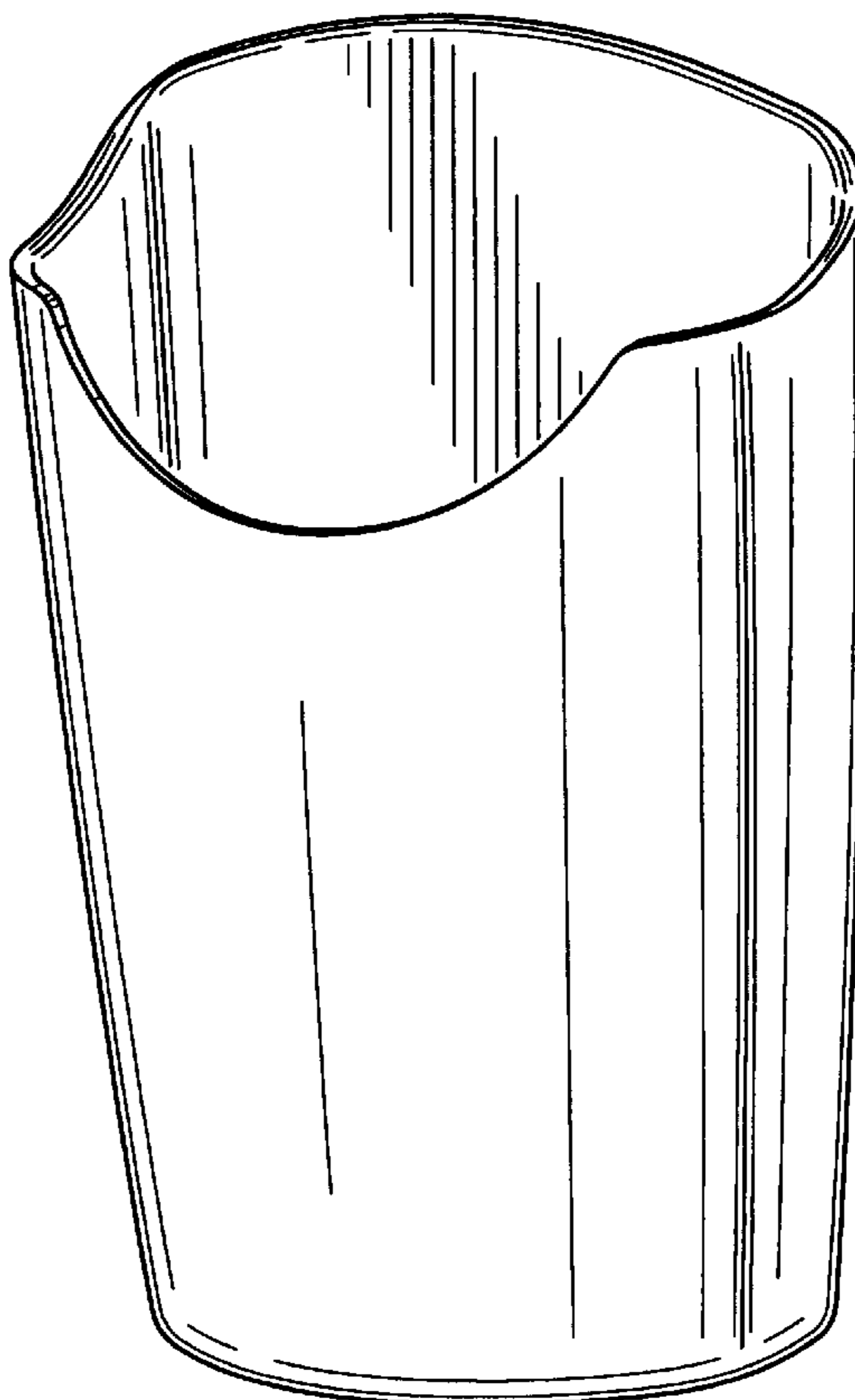
The ornamental design for a holder for elongated articles, such as pens and pencils, for attachment to a wall, such as a cubicle wall, as shown and described.

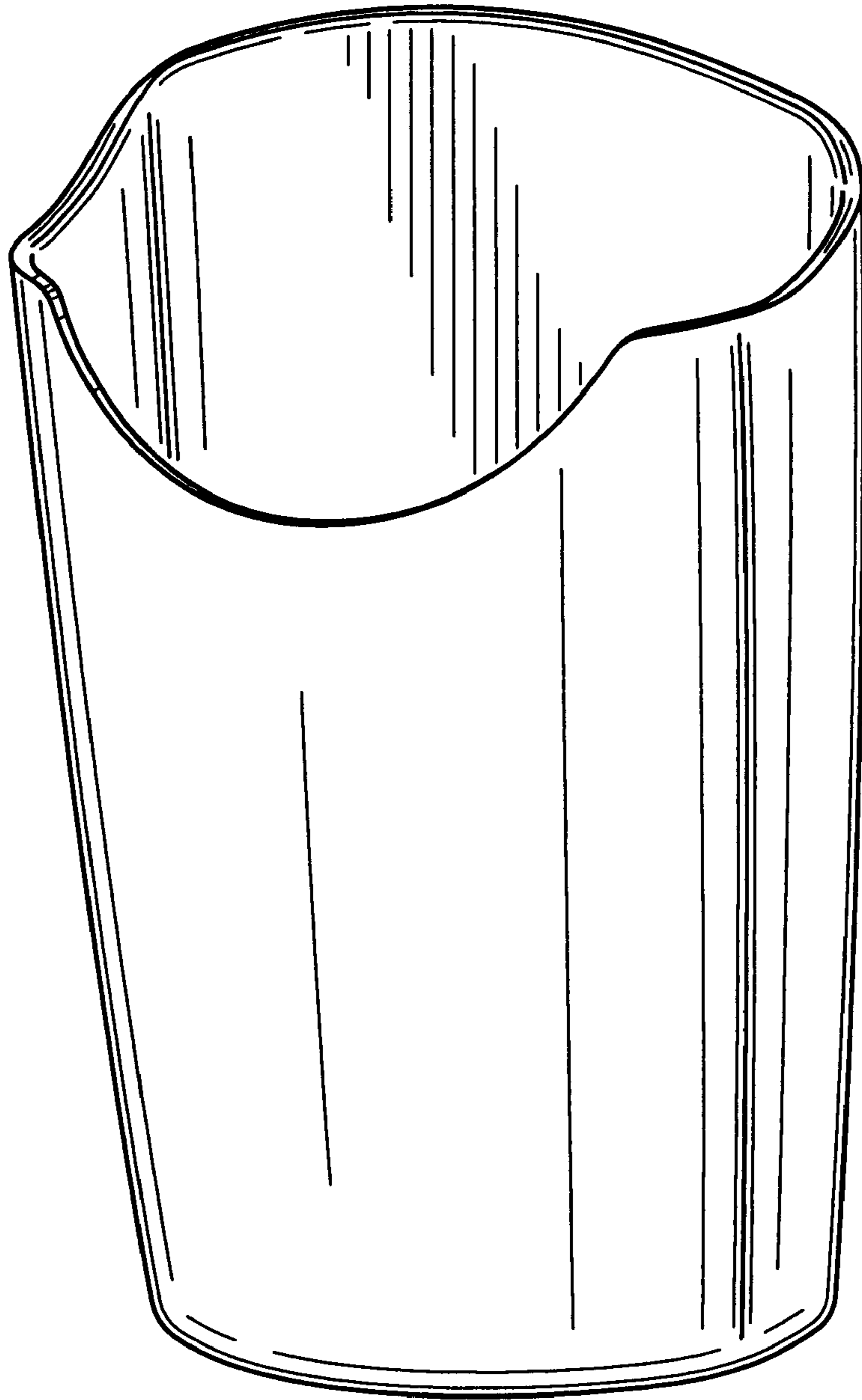

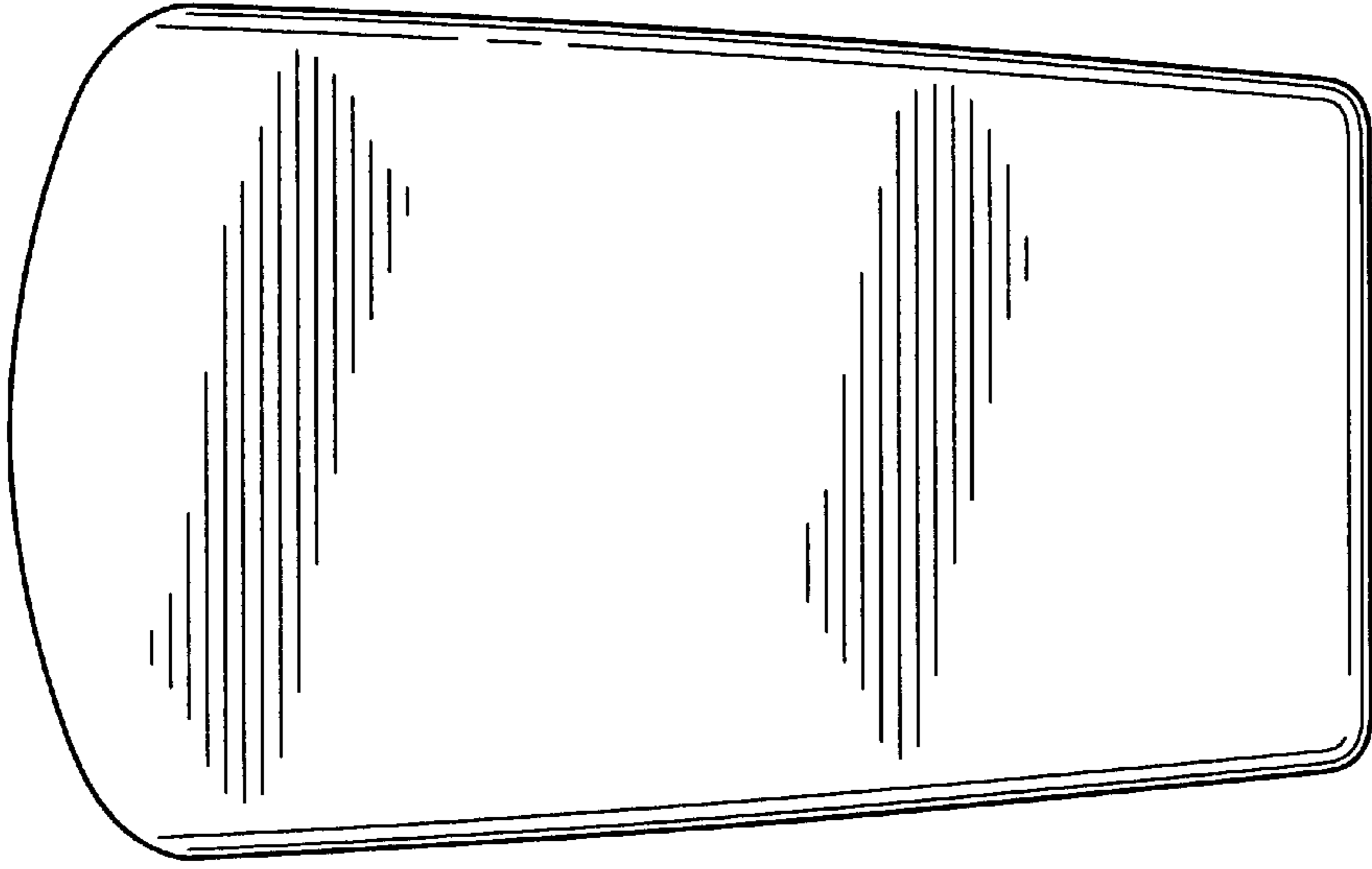

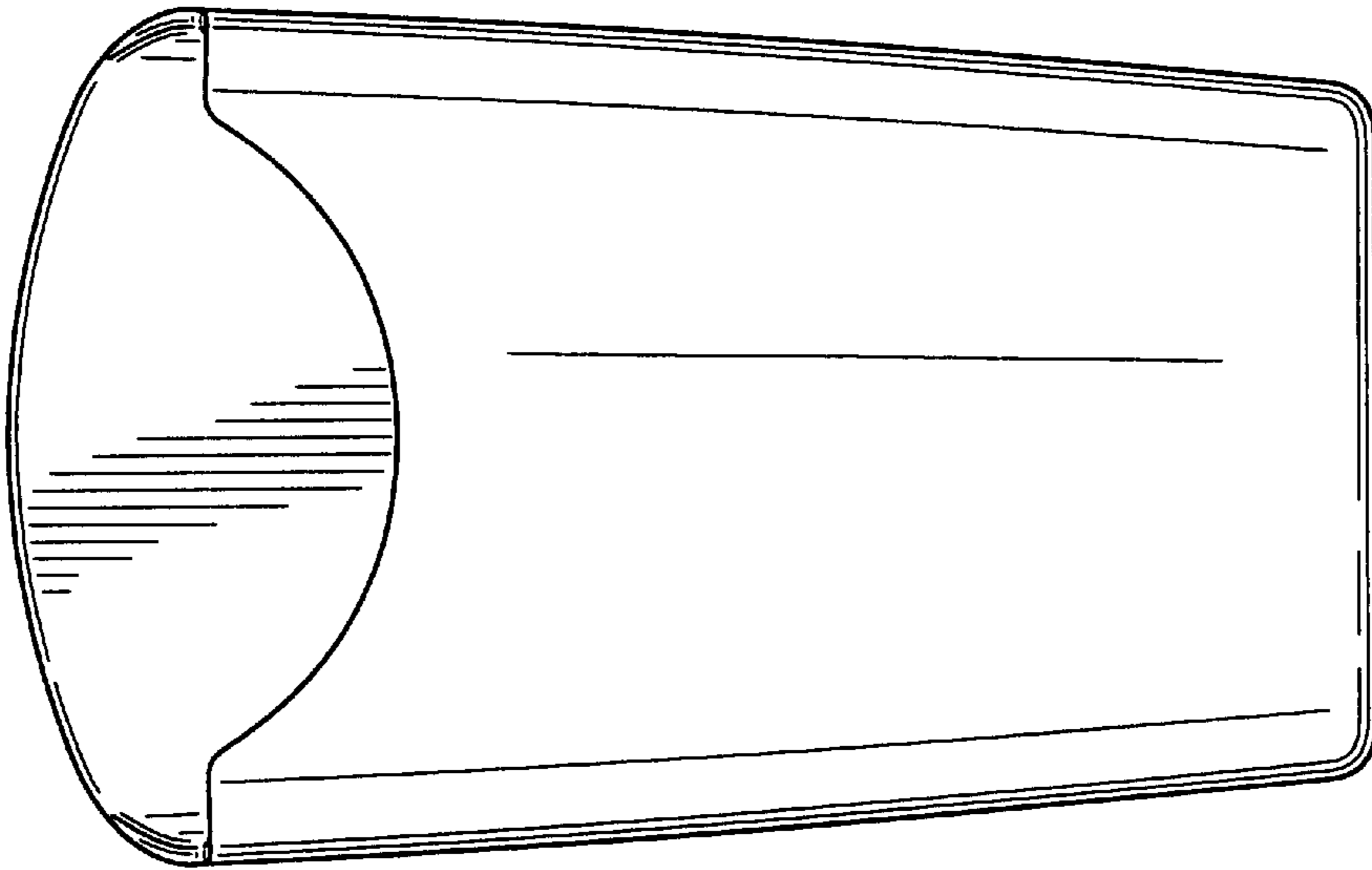

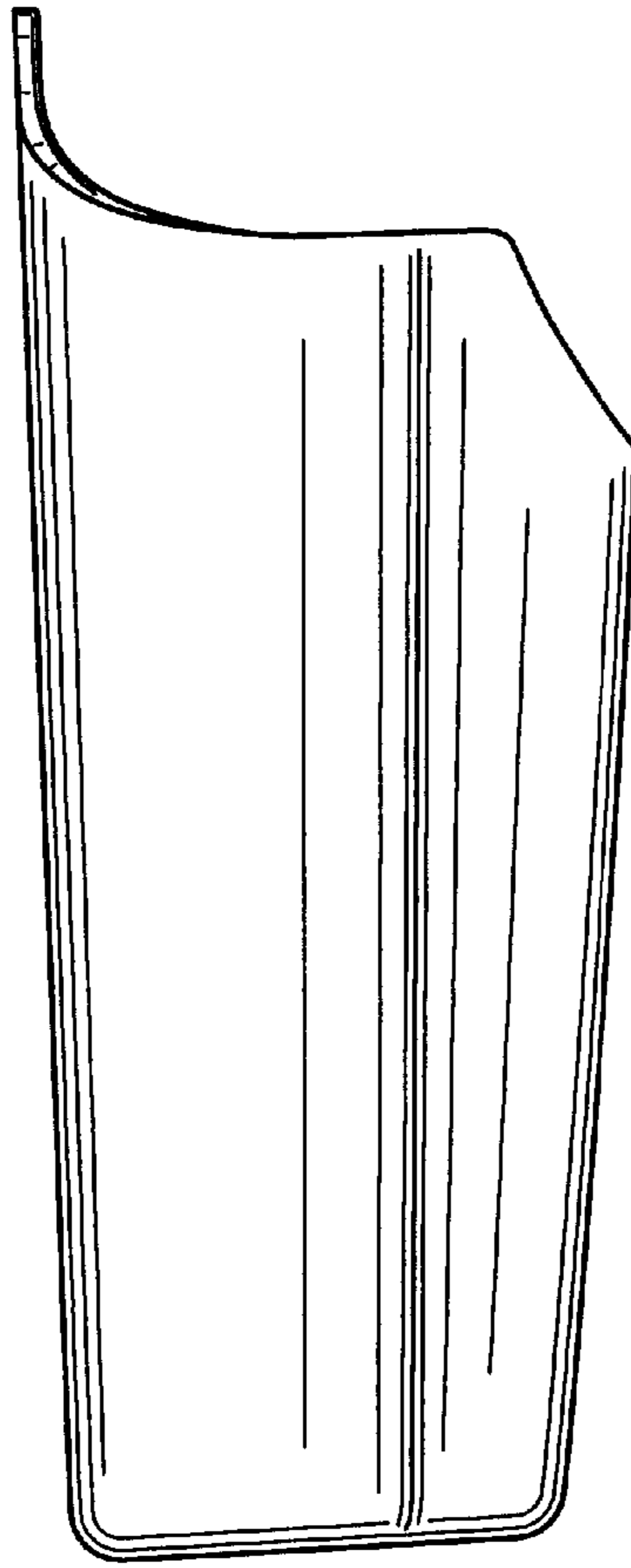

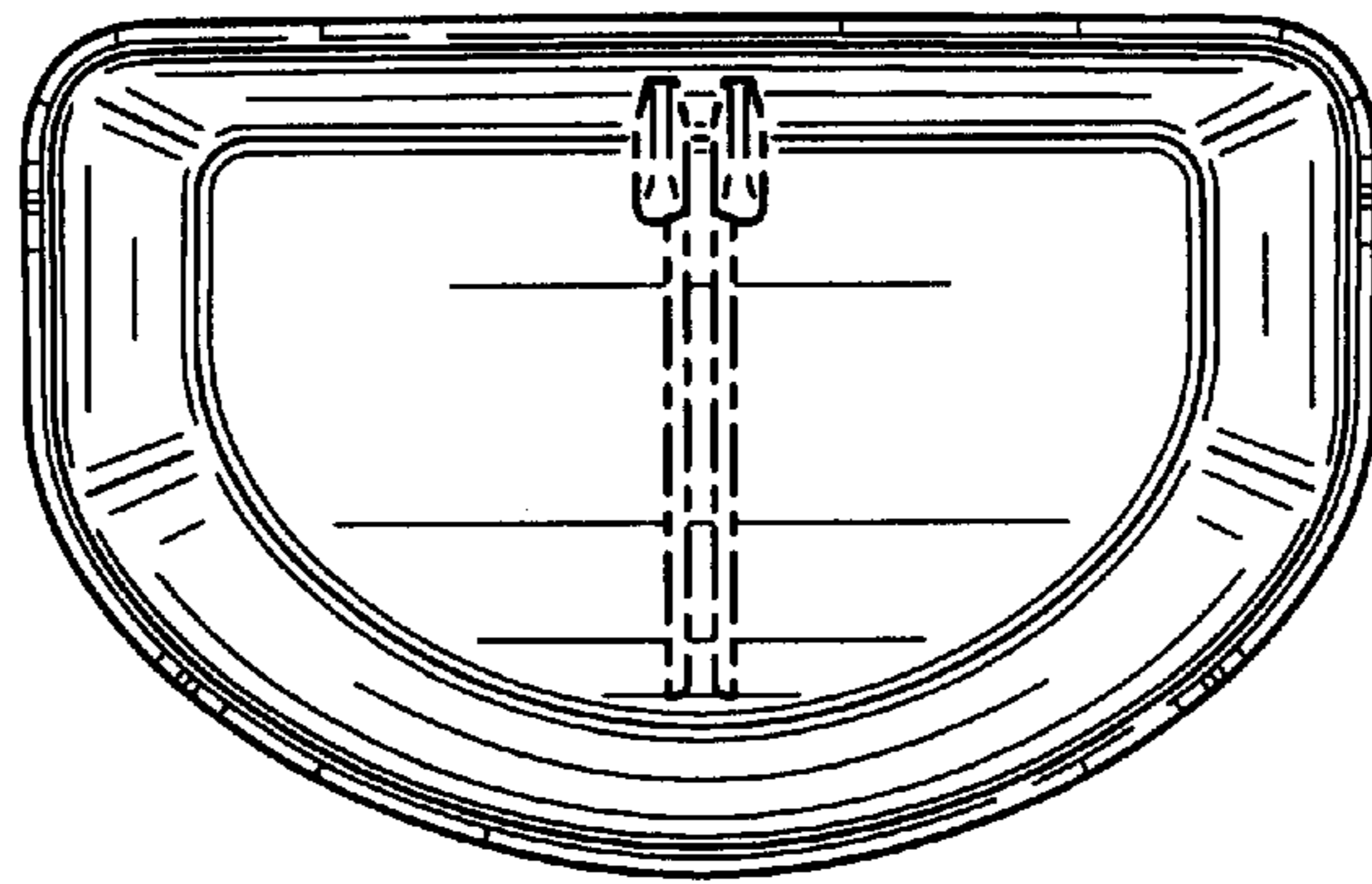
