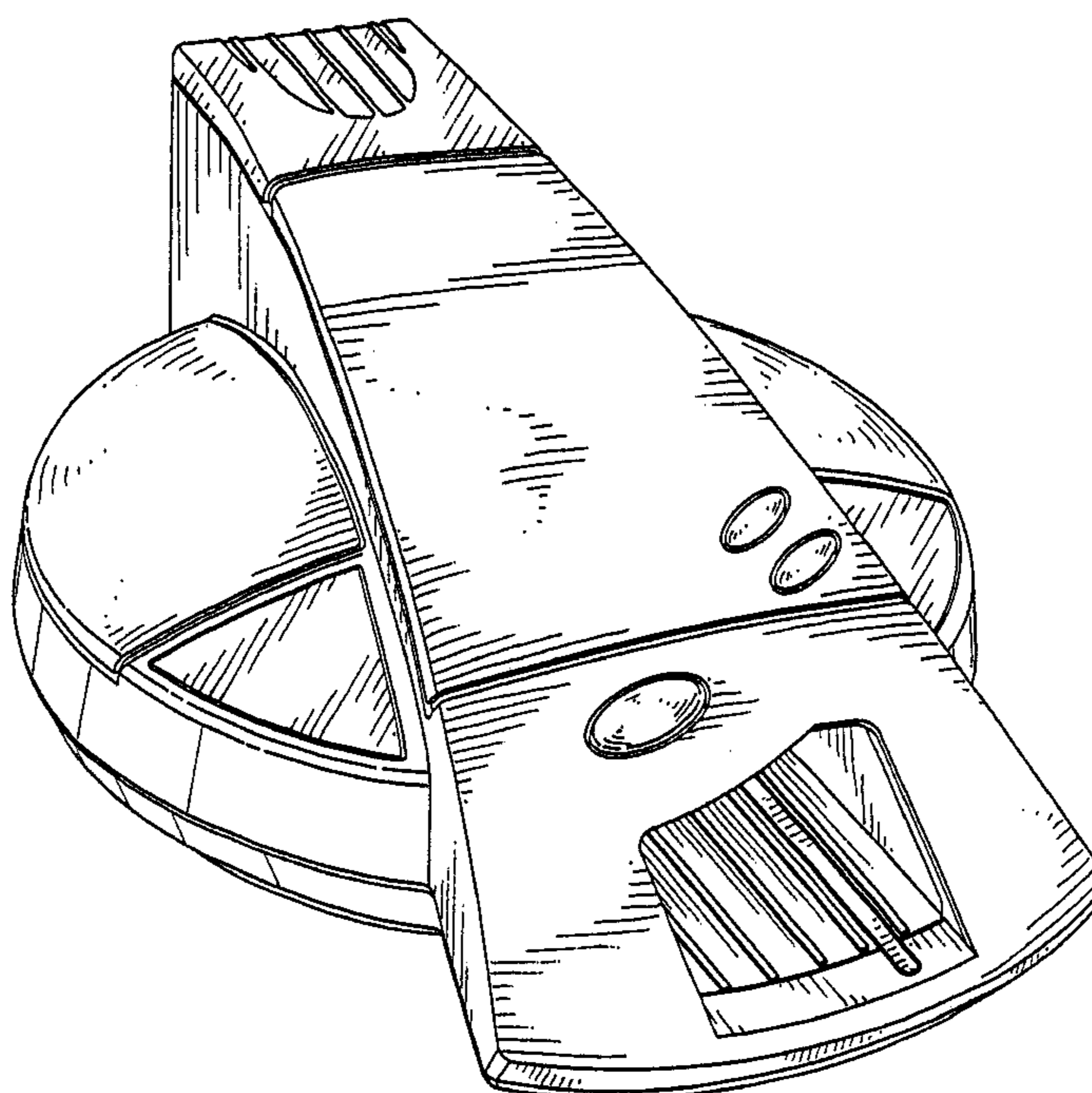
(57) **CLAIM**

The ornamental design for an automatic game apparatus for dealing playing cards, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of the automatic game apparatus for dealing playing cards of the instant invention; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a rear elevational view thereof; FIG. 6 is a left side elevational view thereof; and, FIG. 7 is a right side elevational view thereof.

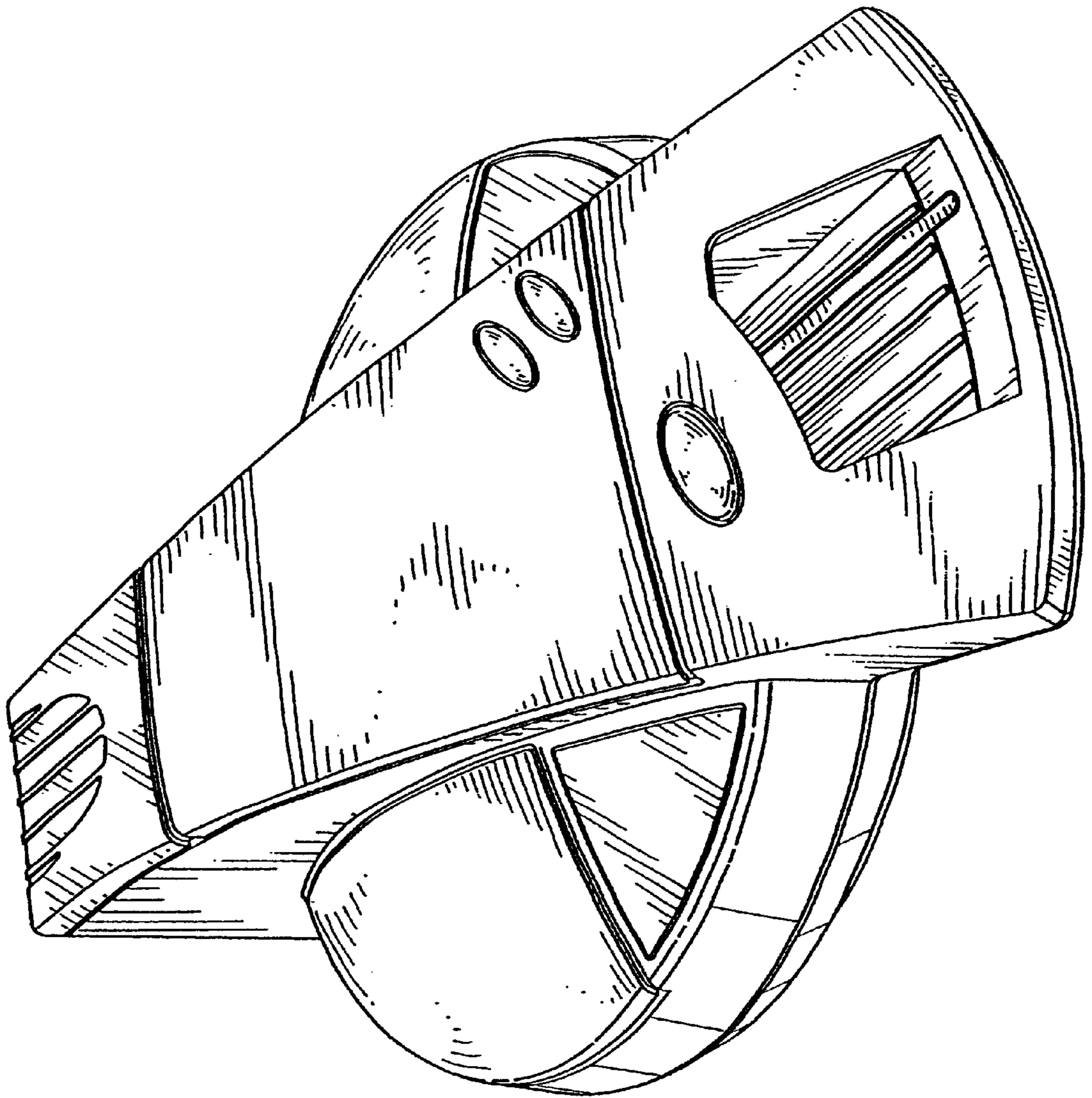

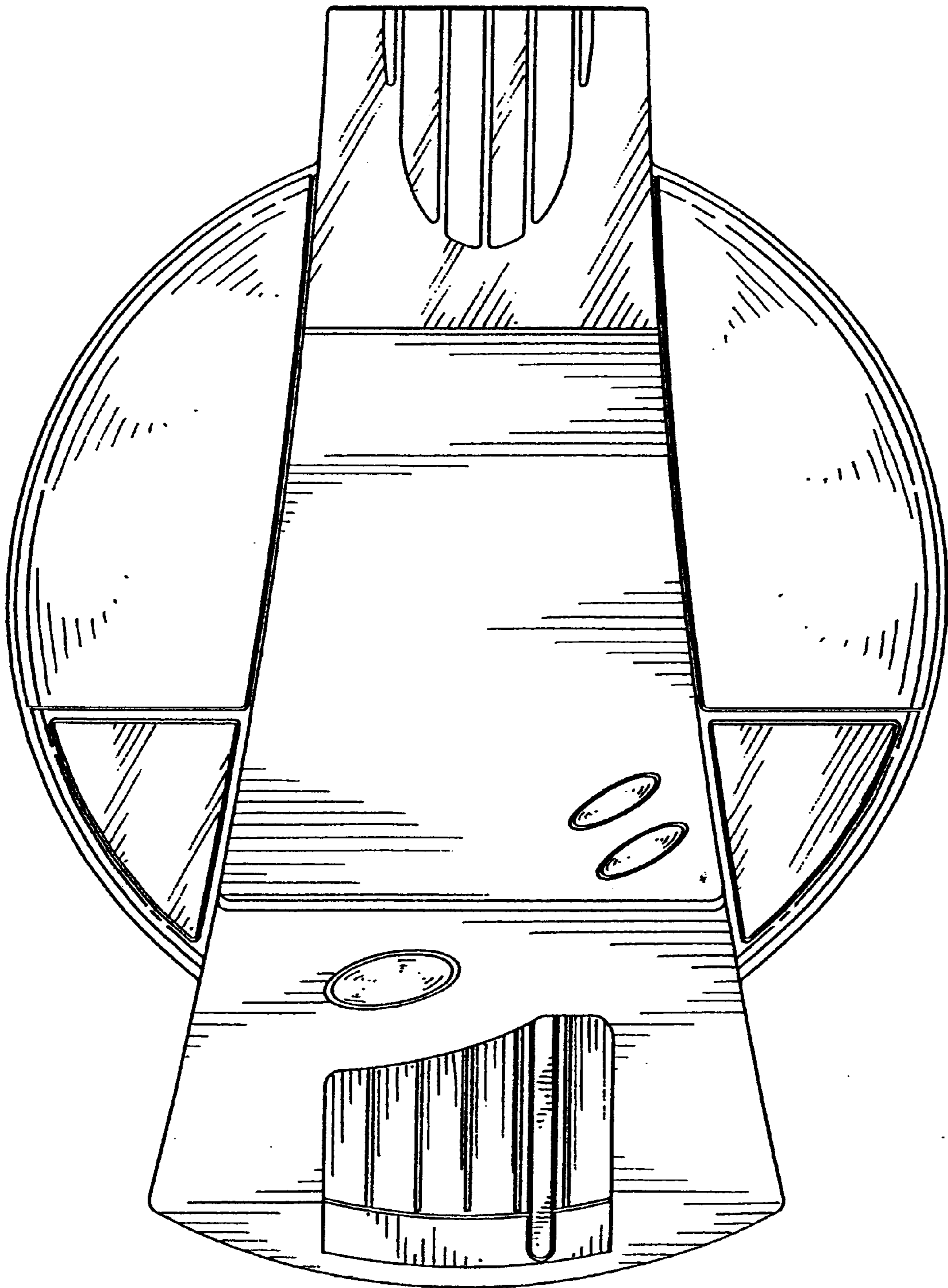

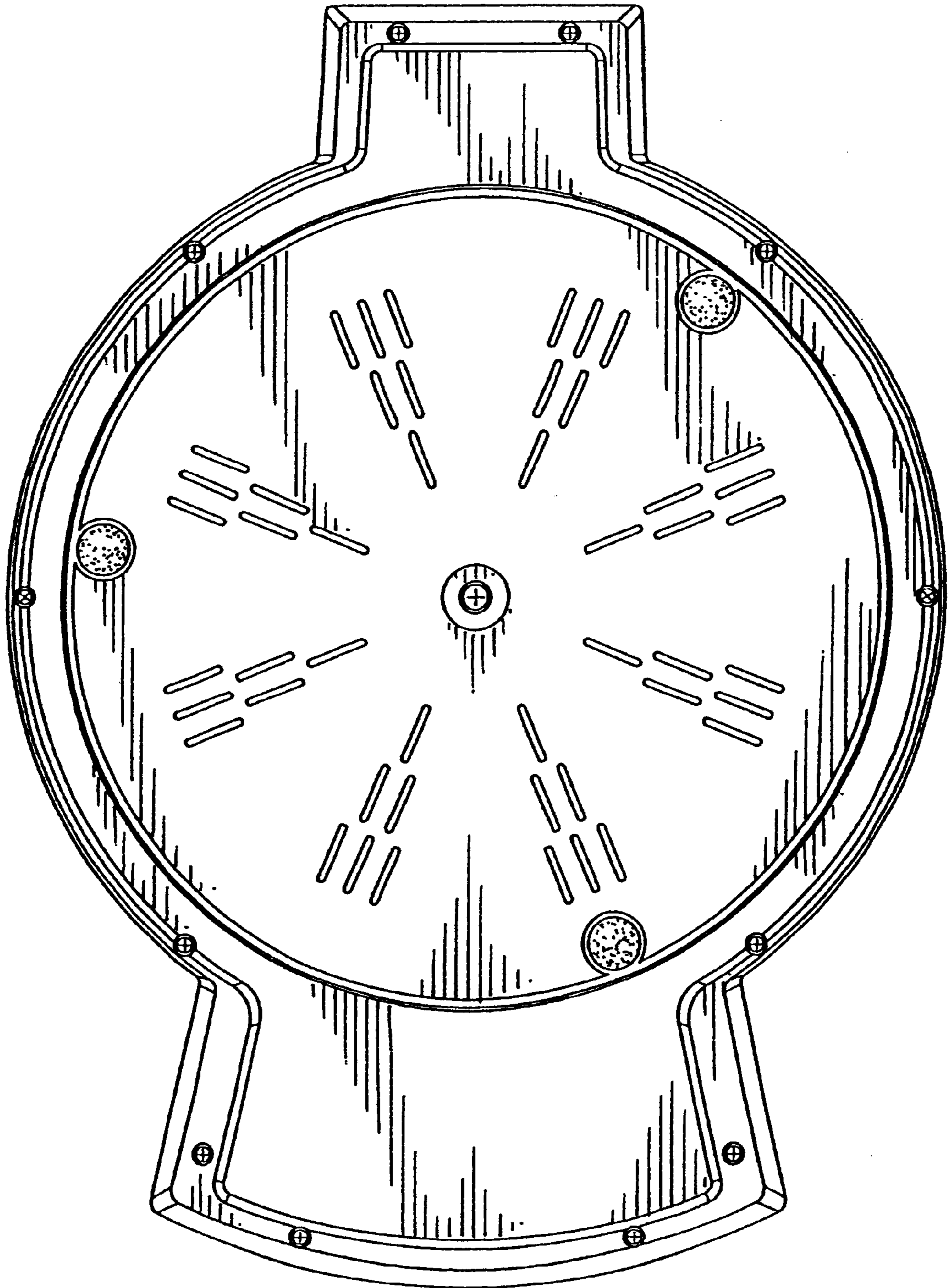

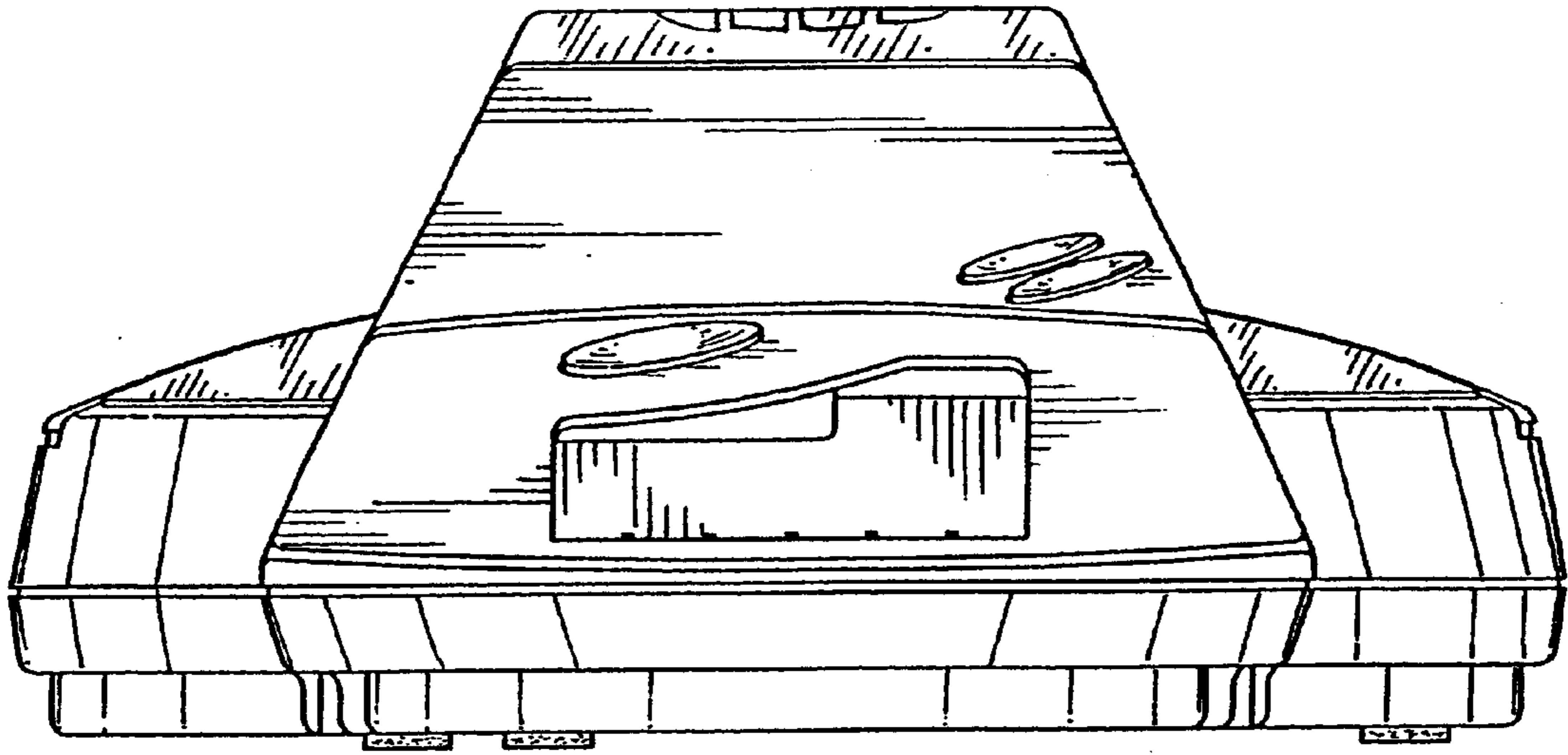

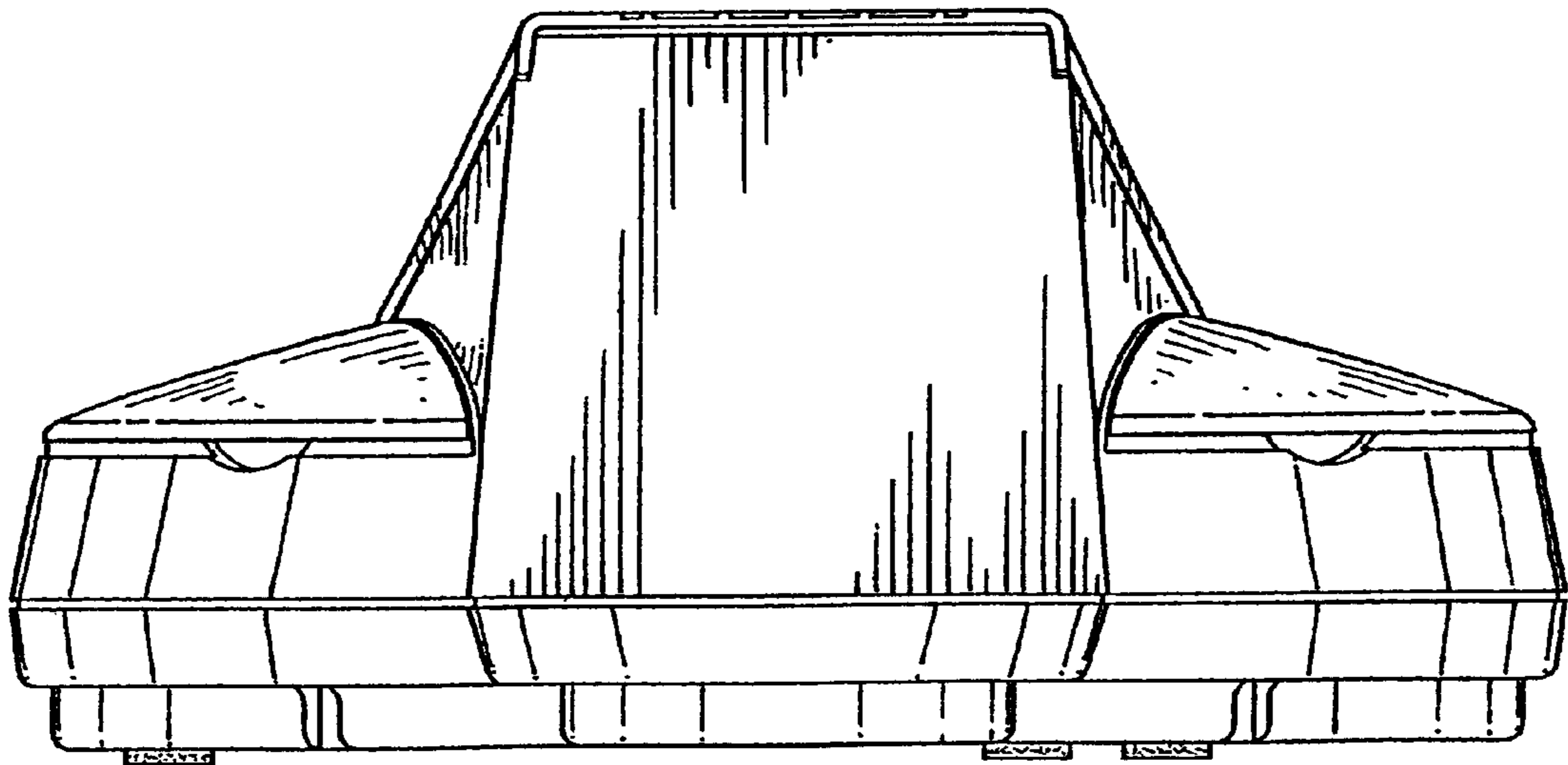

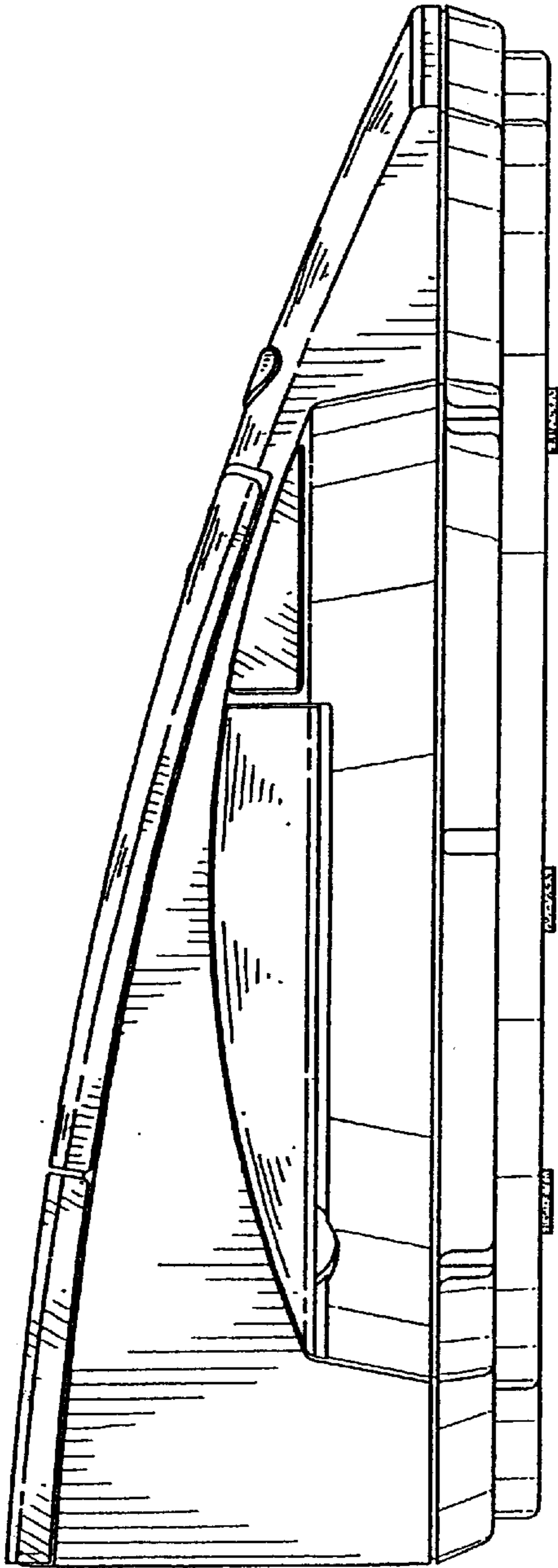

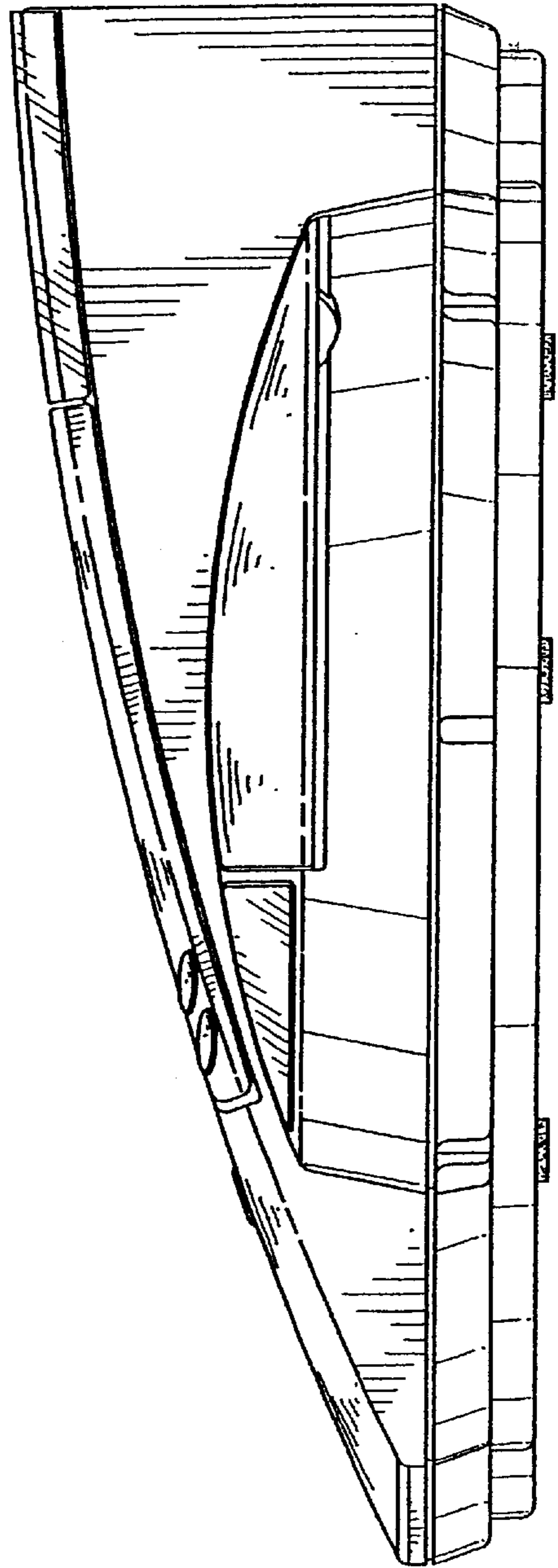
