the design of the present invention.

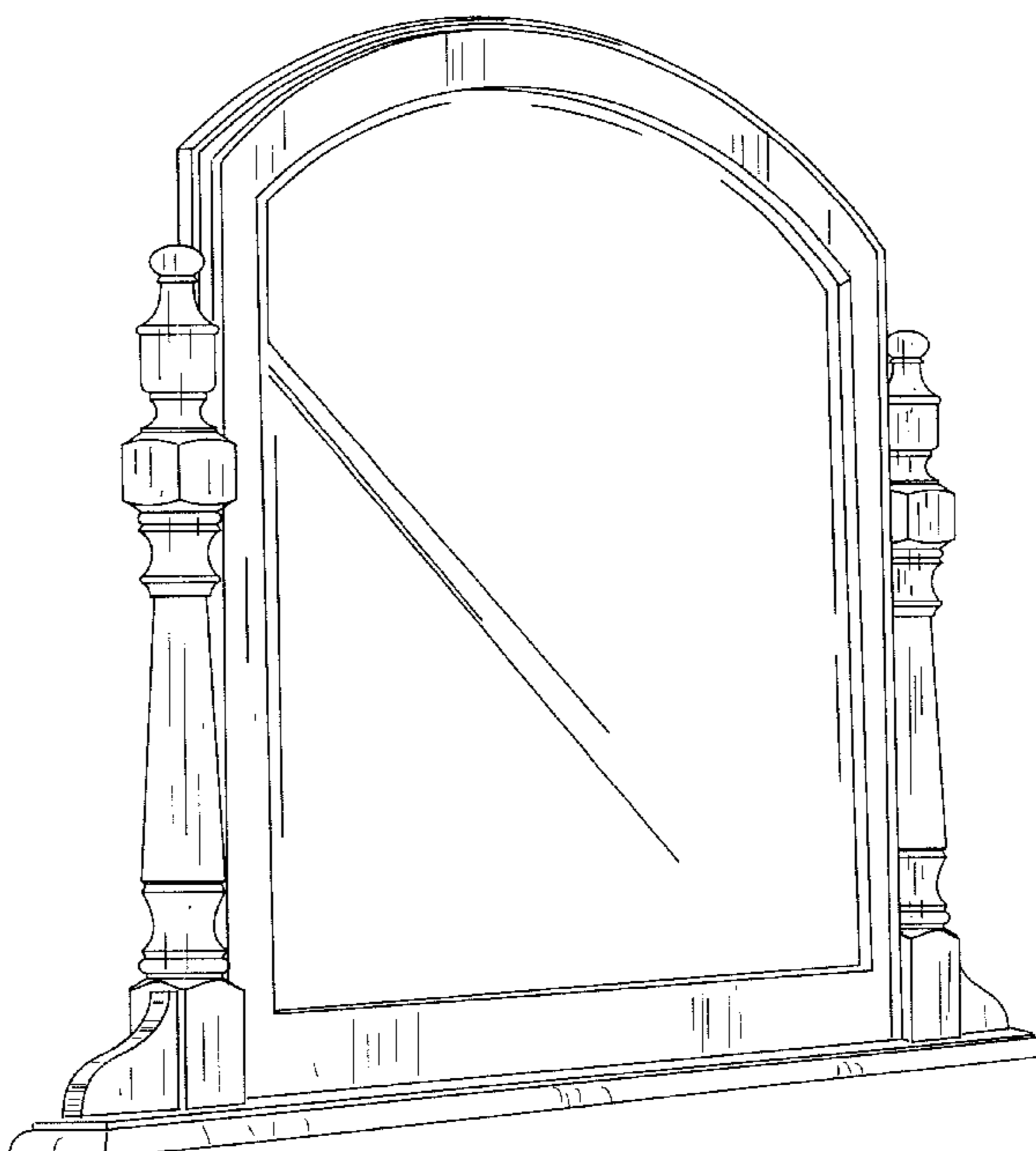
FIG. 2 is a top view of a mirror showing the design of the

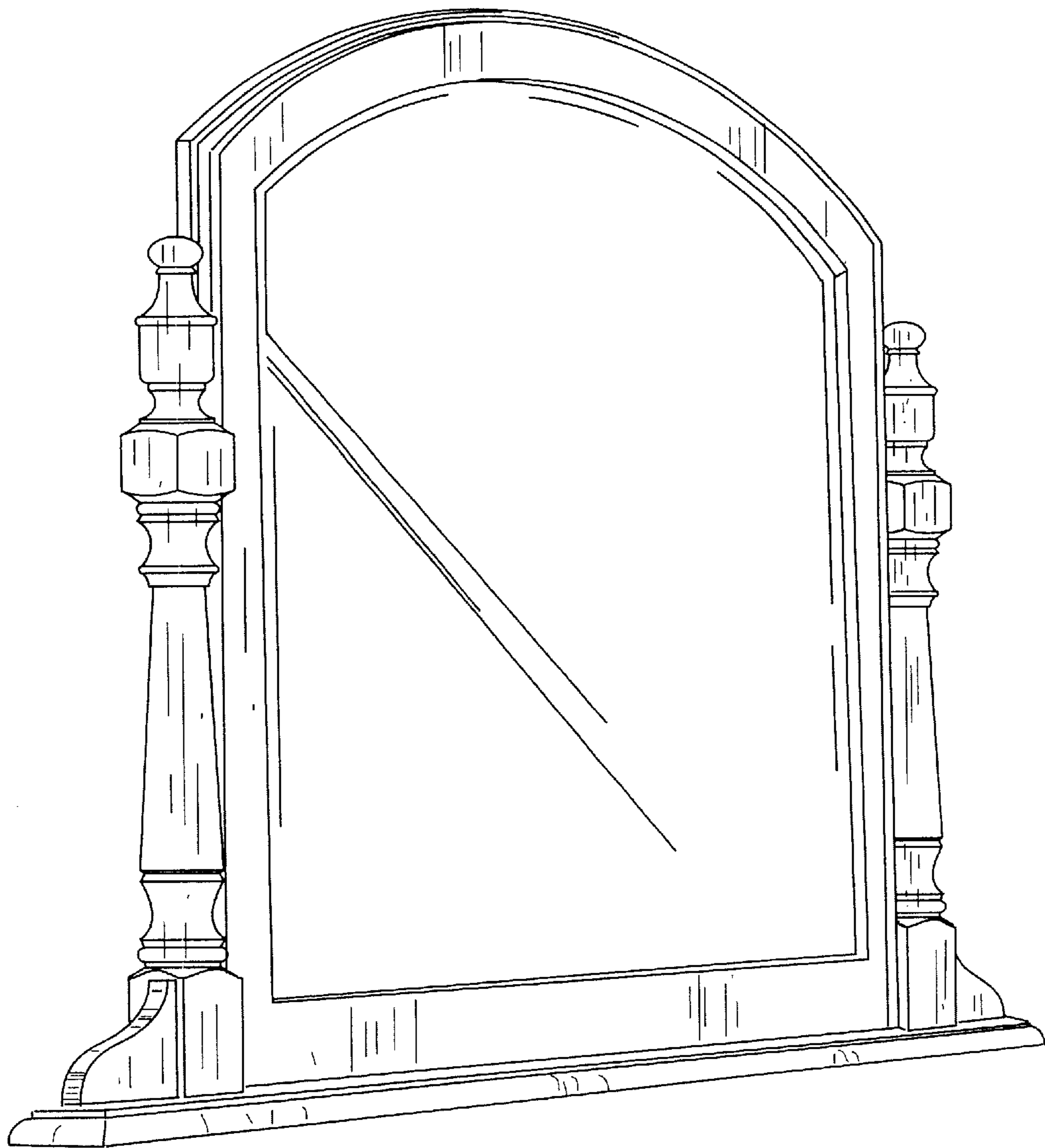

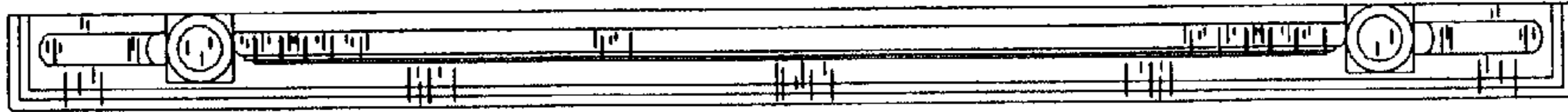

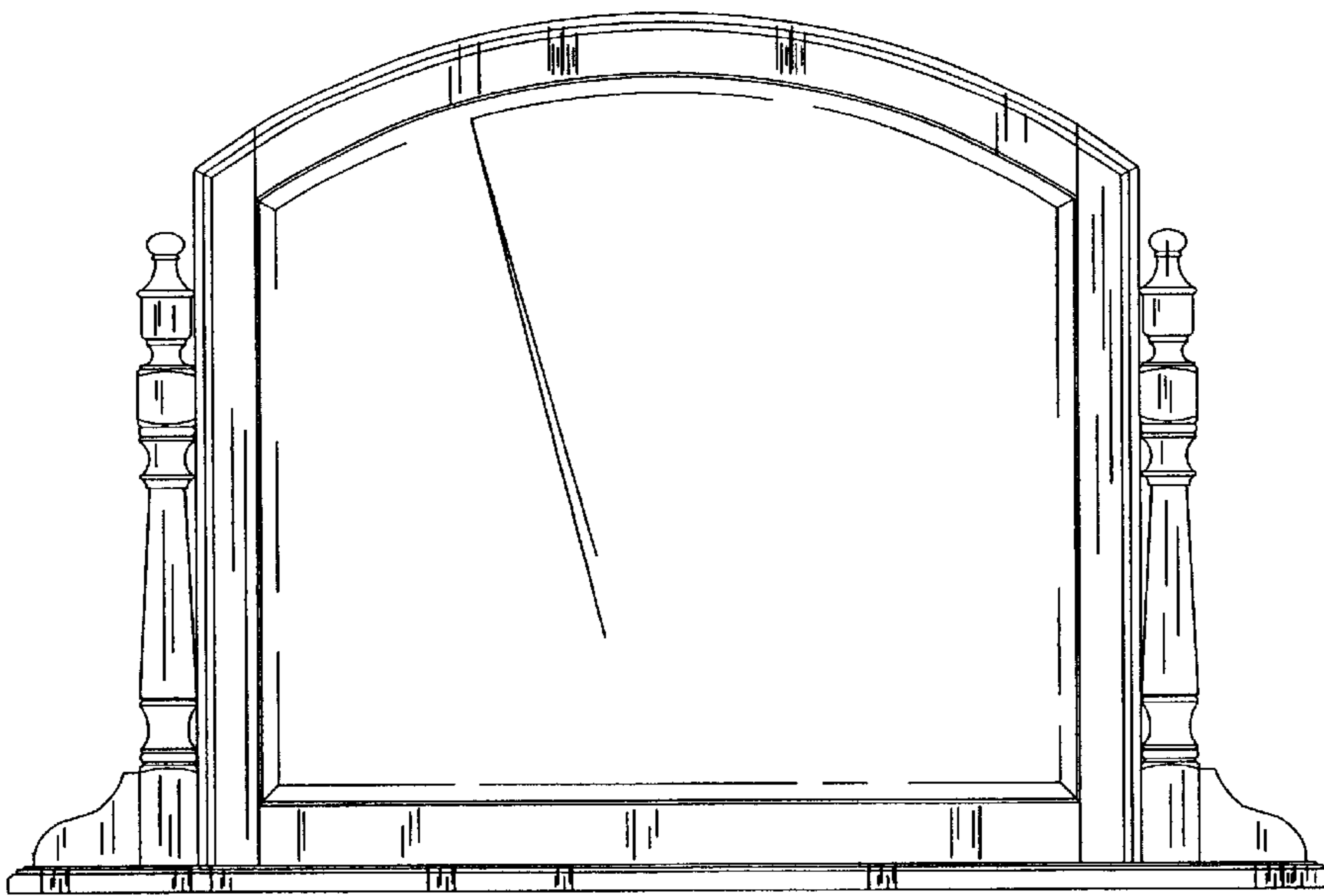

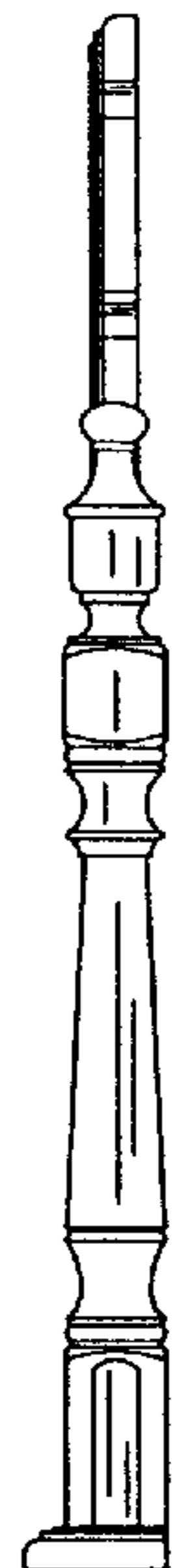
