(57) **CLAIM**

The ornamental design for a coffee tools set, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, left isometric perspective view of a coffee tools set showing my new design.

FIG. 2 is a front elevational view thereof.

FIG. 3 is a rear elevational view thereof.

FIG. 4 is a right side elevational view thereof.

FIG. 5 is a left side elevational view thereof.

FIG. 6 is a top plan view thereof.

FIG. 7 is a bottom plan view thereof.

FIG. 8 is a front, right isometric perspective view of a Frothing Pitcher of the coffee tools set showing my new design.

FIG. 9 is a front elevational view of the Frothing Pitcher of FIG. 8.

FIG. 10 is a rear elevational view of the Frothing Pitcher of FIG. 8.

FIG. 11 is a right side elevational view of the Frothing Pitcher of FIG. 8, the left side being a mirror image thereof.

FIG. 12 is a top plan view of the Frothing Pitcher of FIG. 8.

FIG. 13 is a bottom plan view of the Frothing Pitcher of FIG. 8.

FIG. 14 is a front, right isometric perspective view of a Shot Glass of the coffee tools set showing my new design.

FIG. 24 is a front, right perspective view of a Scoop of the coffee tools set showing my new design.

FIG. 25 is a front elevational view of the Scoop of FIG. 24.

FIG. 26 is a rear elevational view of the Scoop of FIG. 24.

FIG. 27 is a right side elevational view of the Scoop of FIG. 24, the left side being a mirror image thereof.

FIG. 28 is a top plan view of the Scoop of FIG. 24.

FIG. 29 is a bottom plan view of the Scoop of FIG. 24.

FIG. 30 is a front, right isometric perspective view of a Thermometer of the coffee tools set showing my new design.

FIG. 31 is a front elevational view of the Thermometer of FIG. 30, the rear elevational view being a mirror image thereof.

FIG. 32 is a right side elevational view of the Thermometer of FIG. 30, the left side being a mirror image thereof.

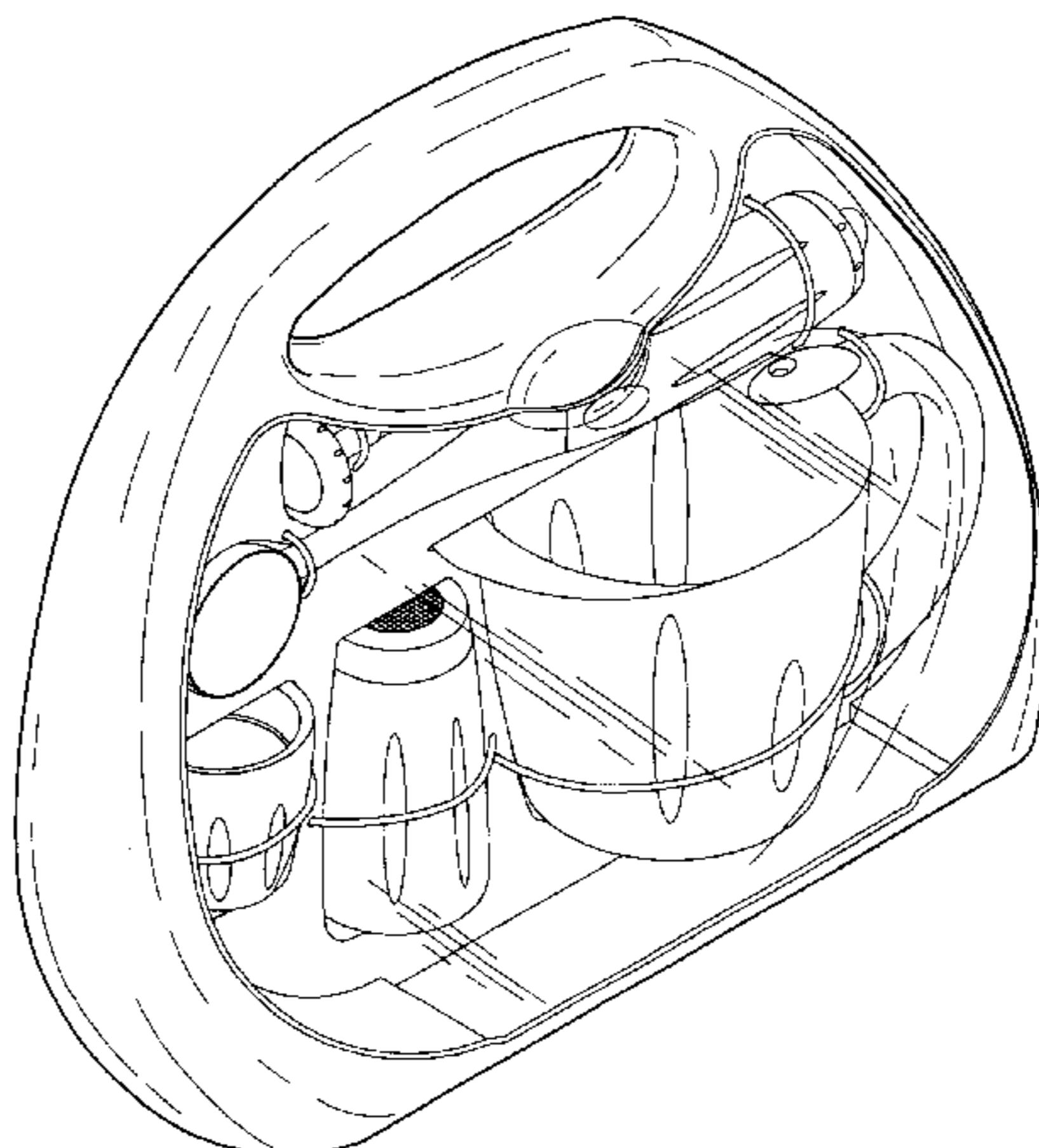
FIG. 33 is a top plan view of the Thermometer of FIG. 30;

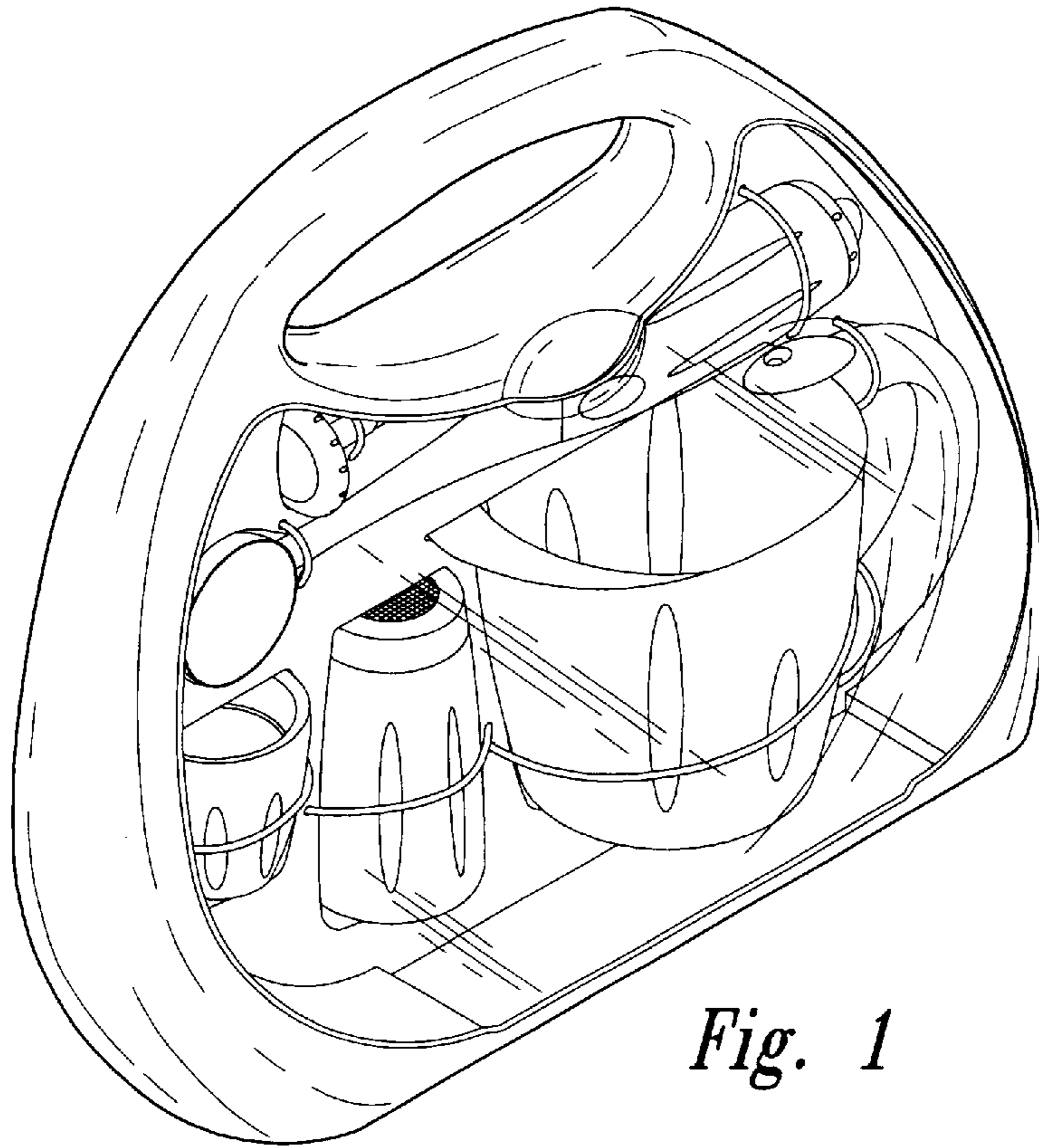

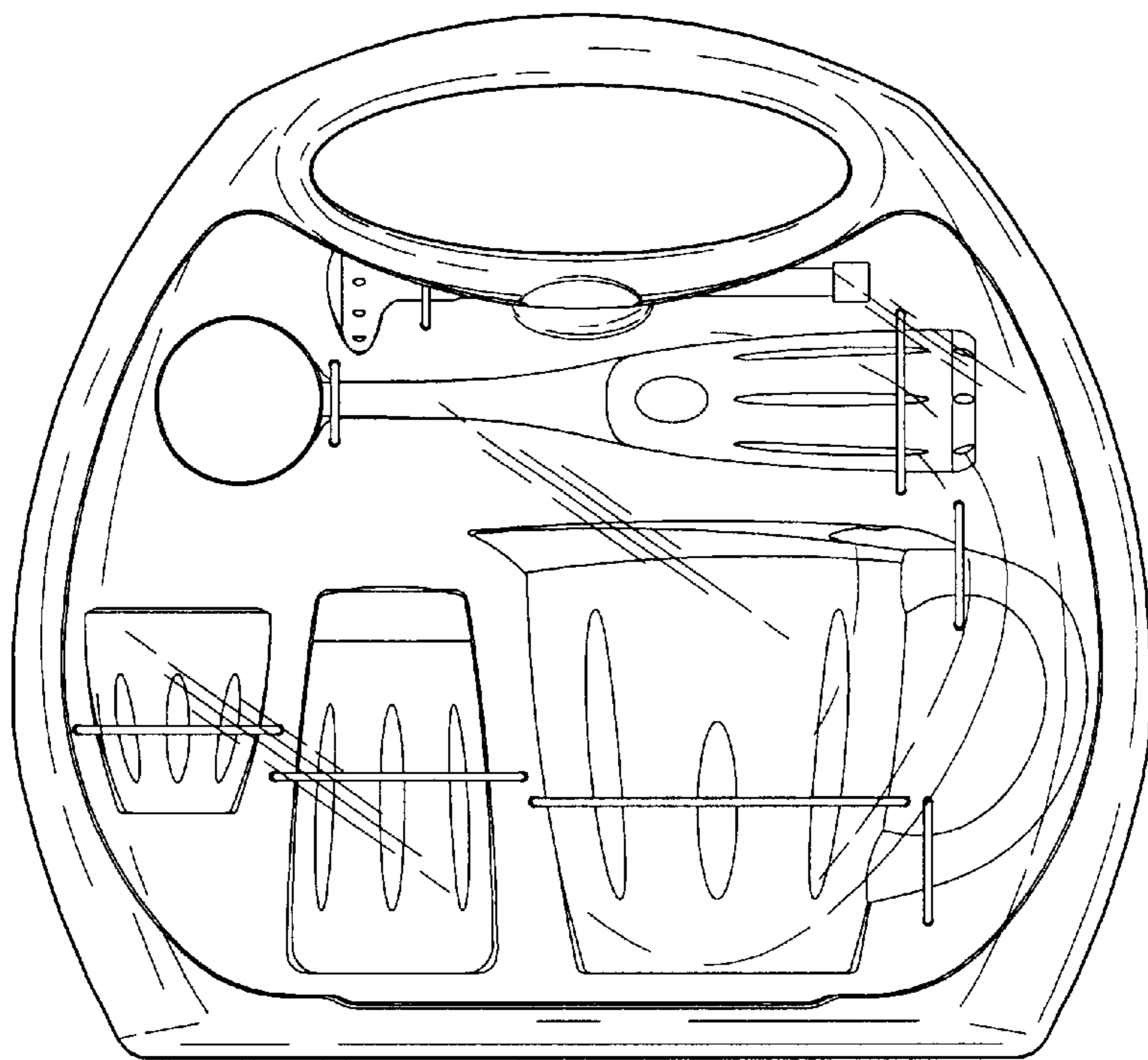

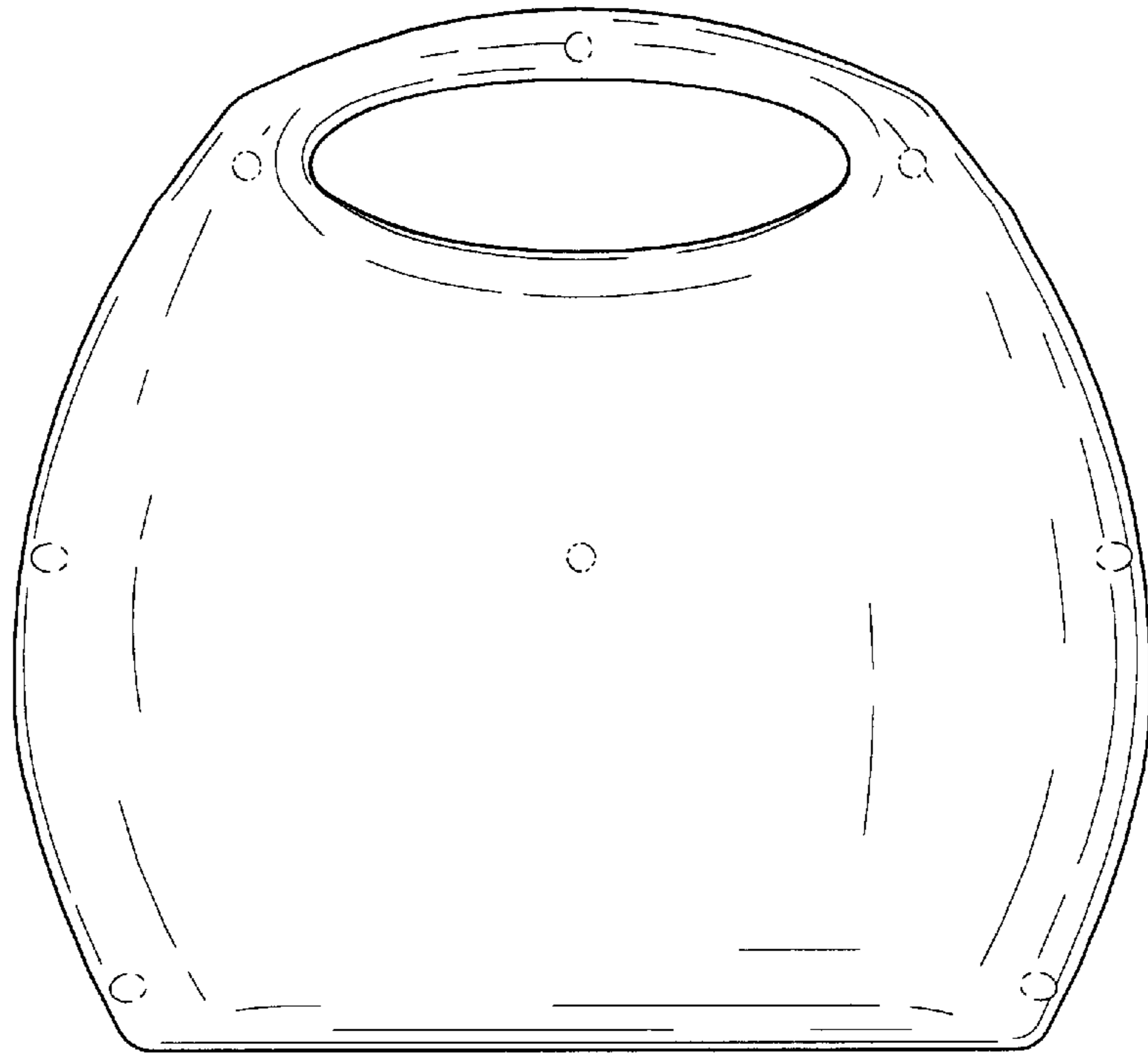

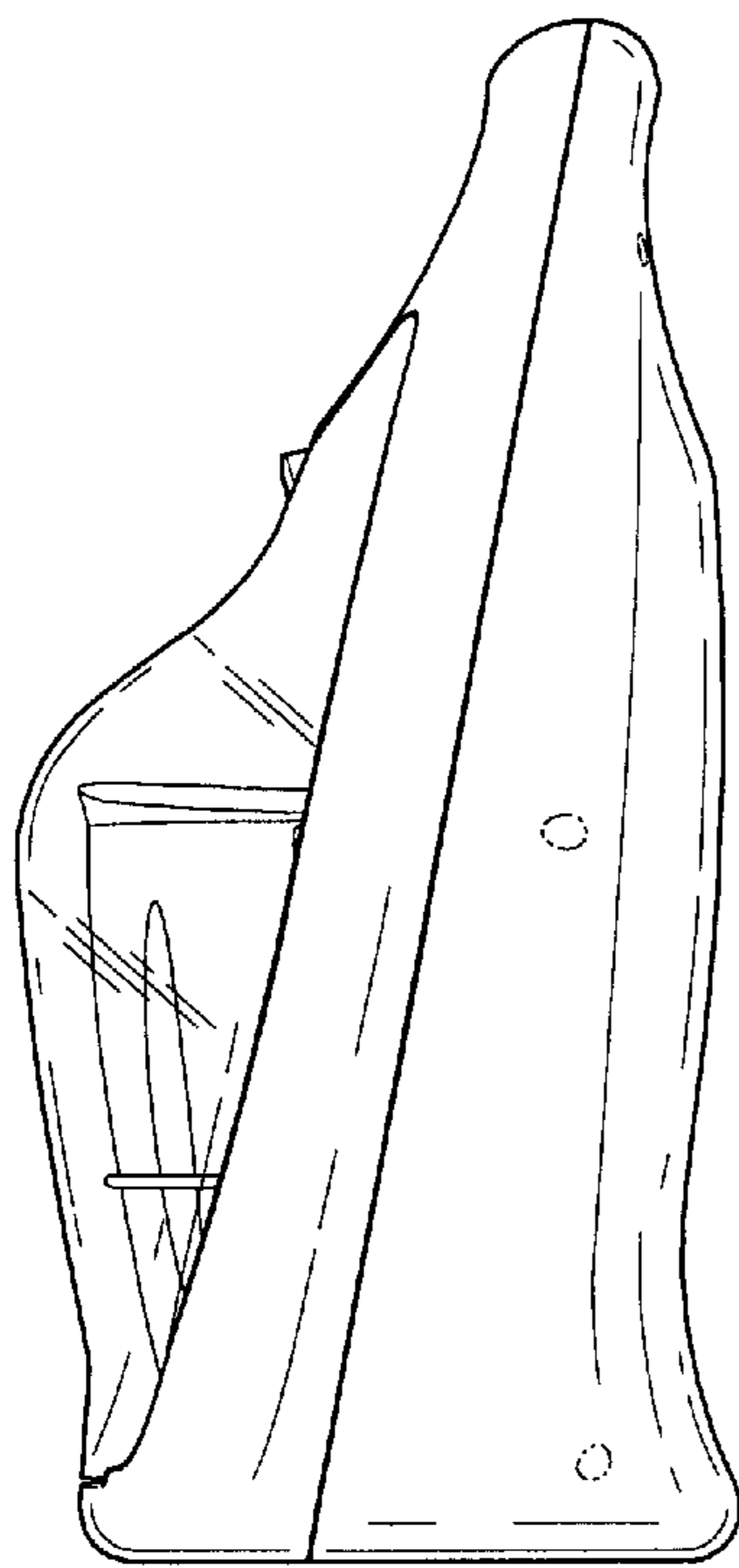

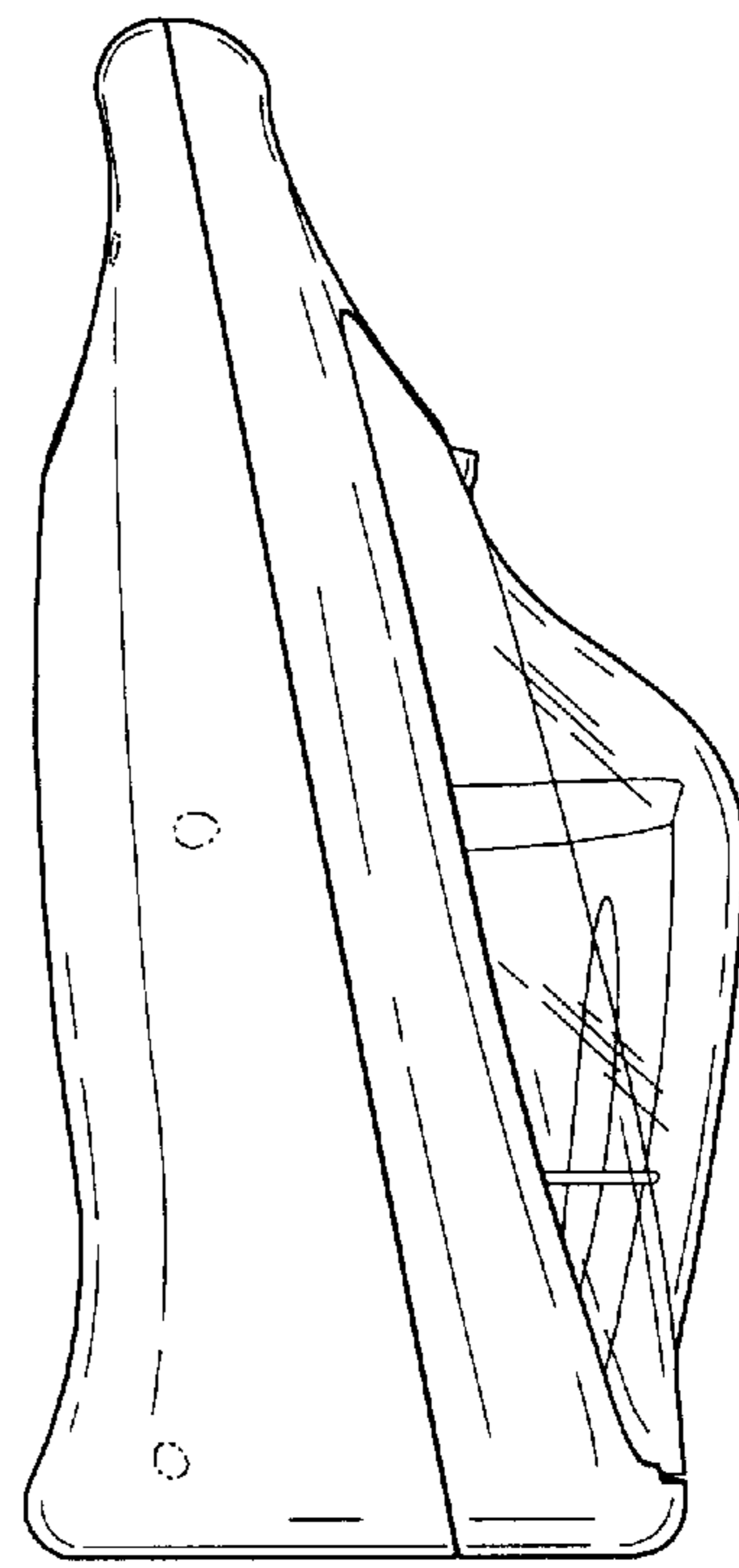

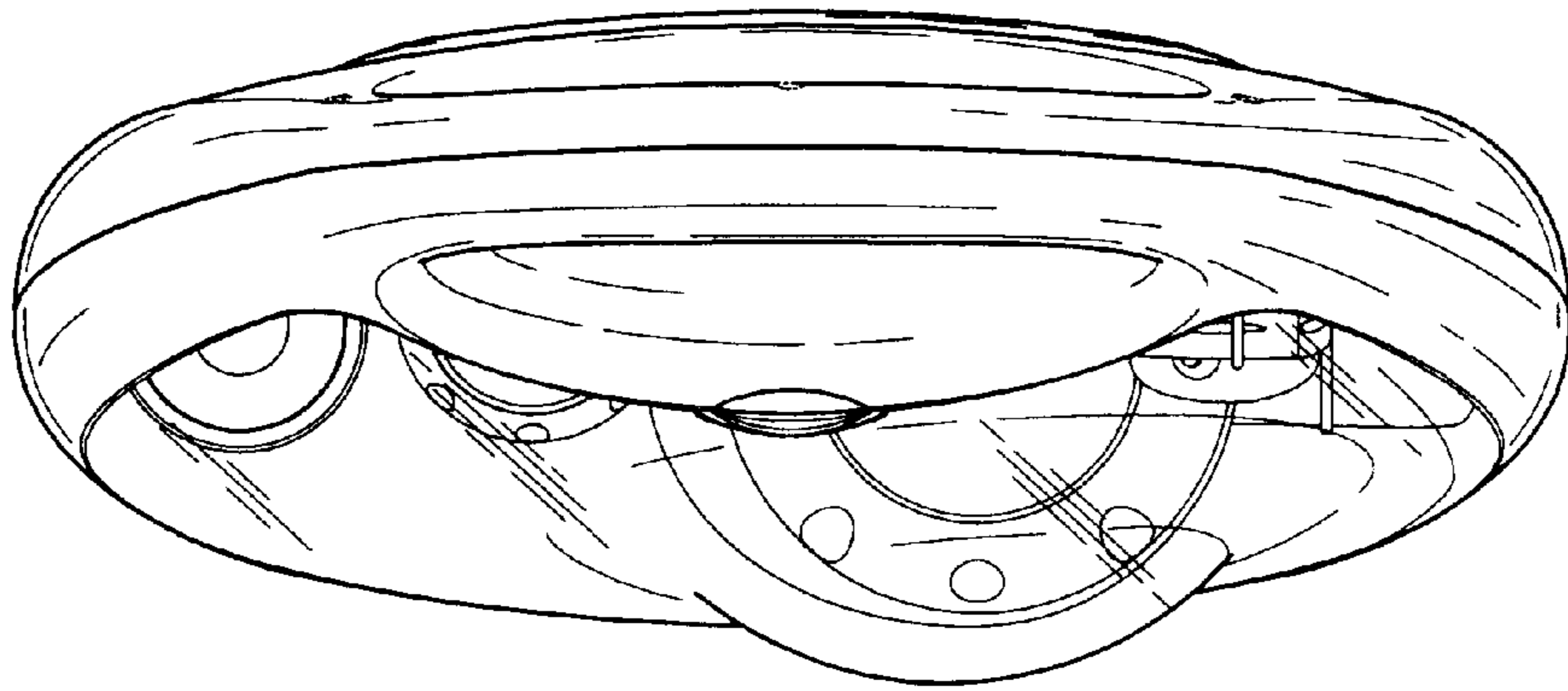

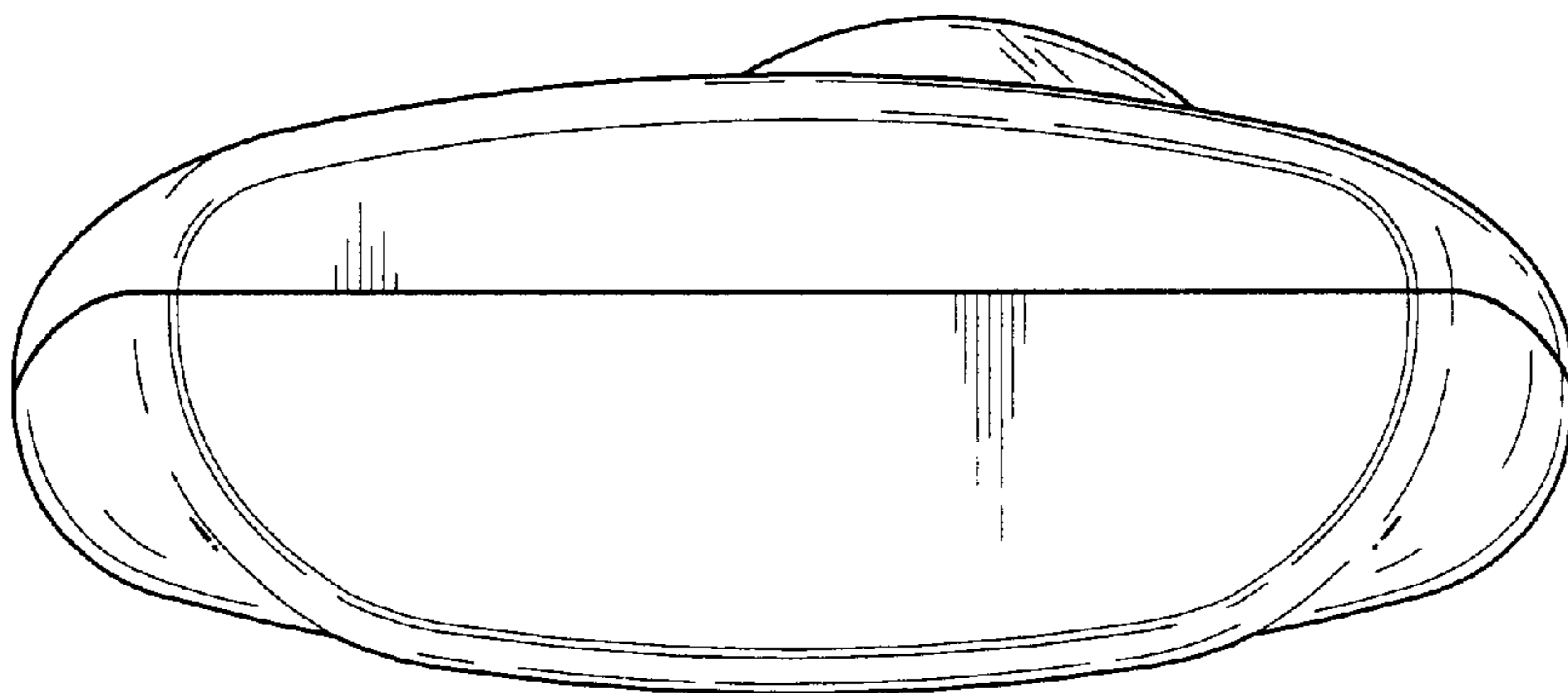

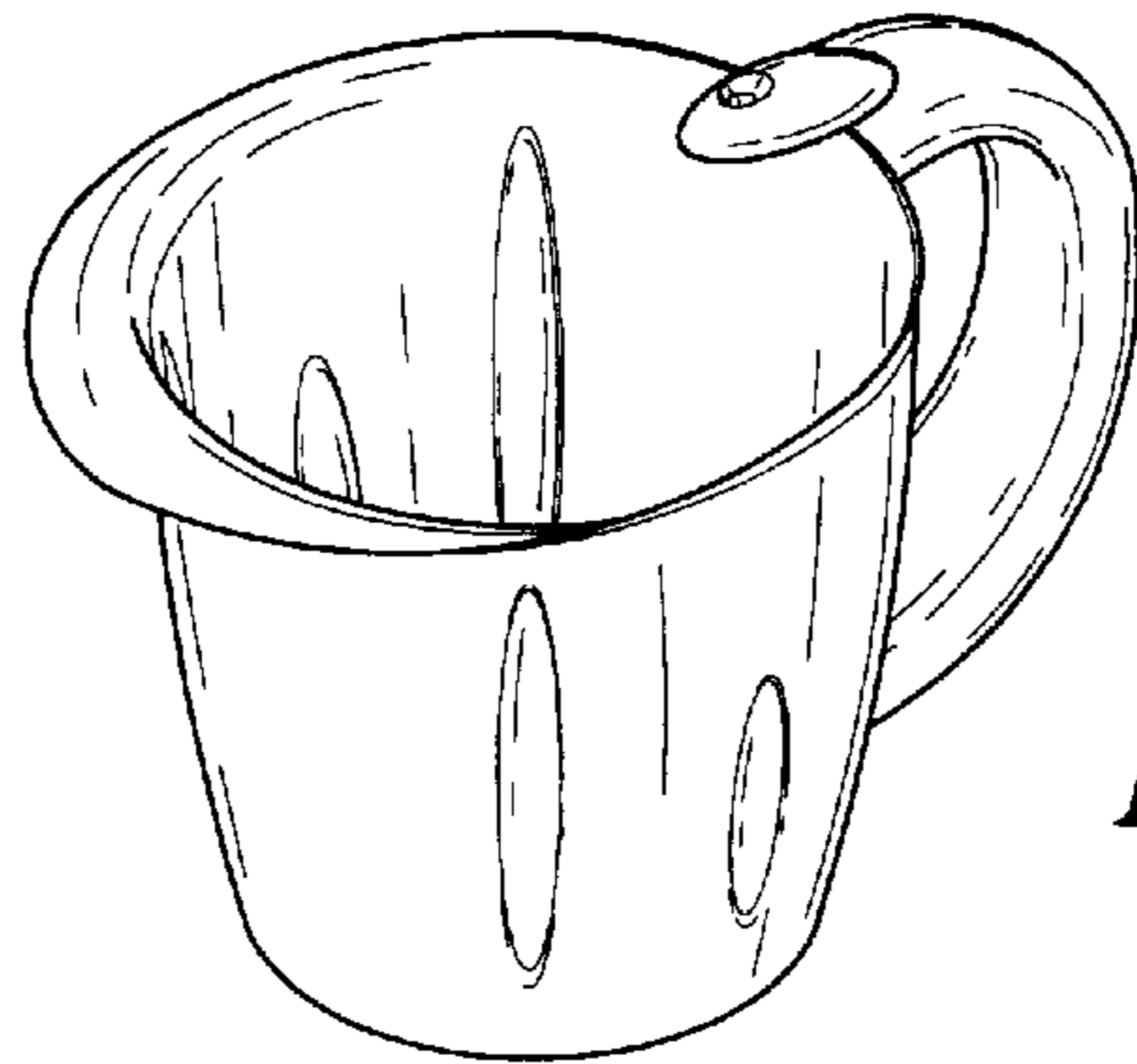

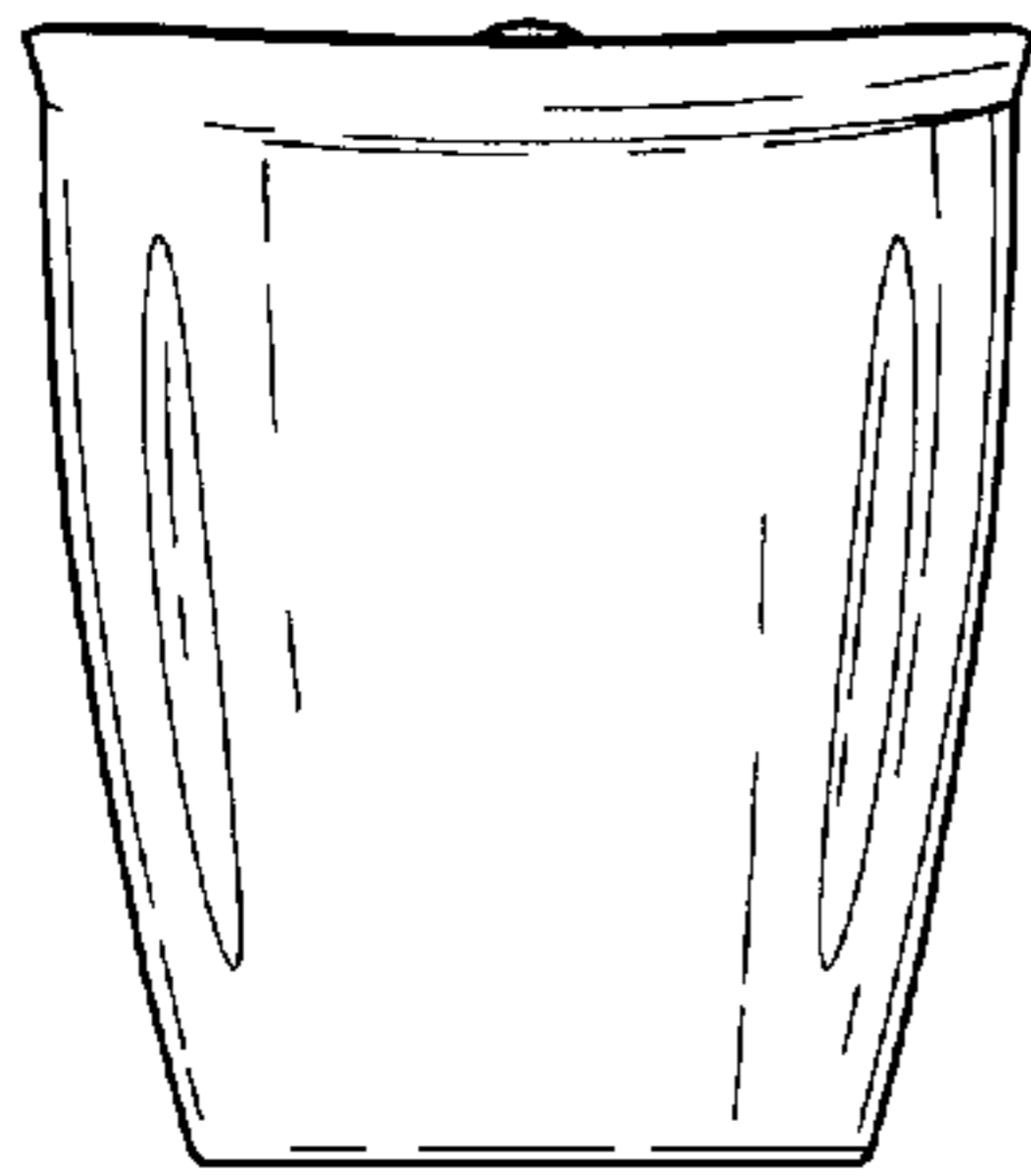

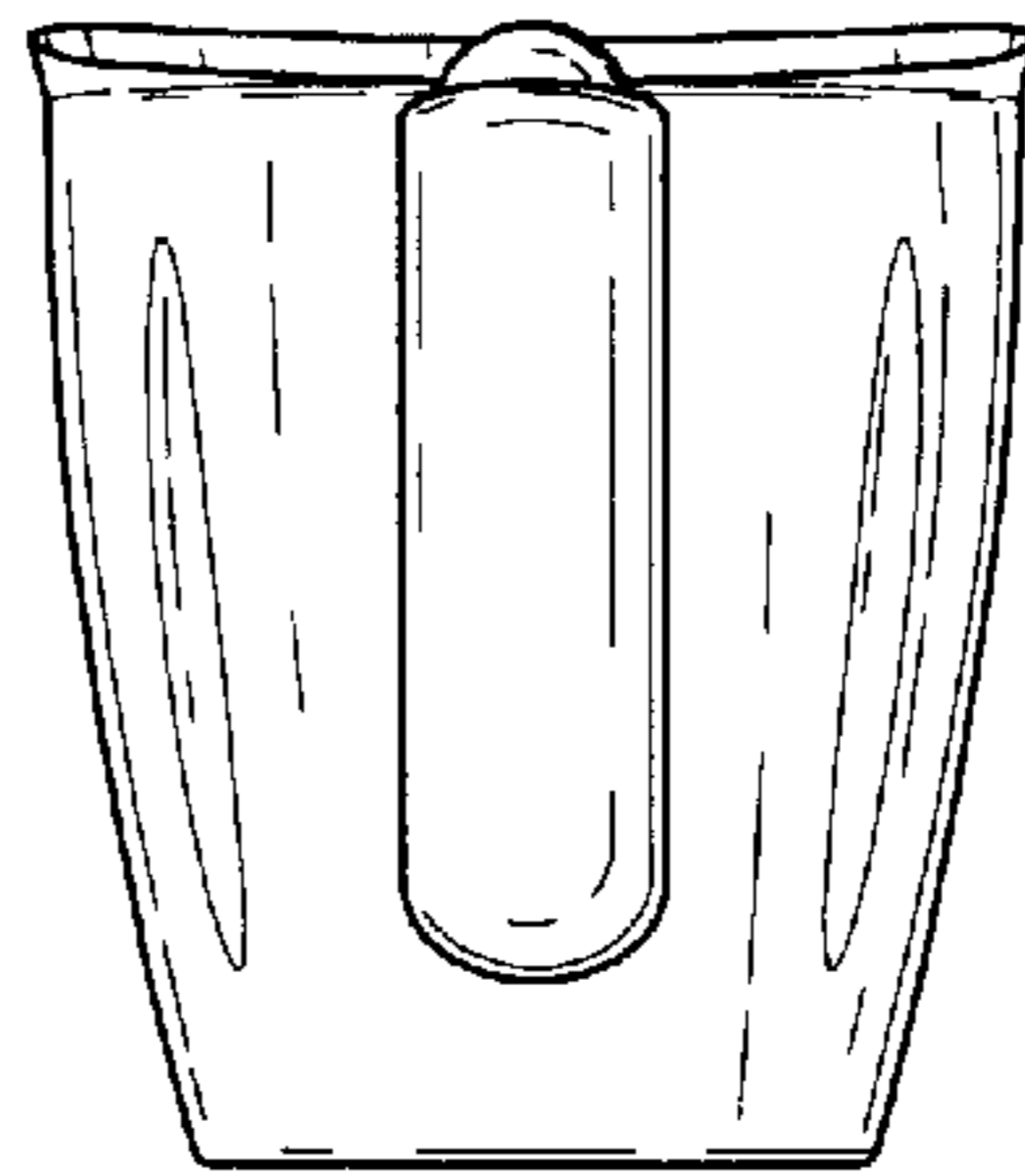

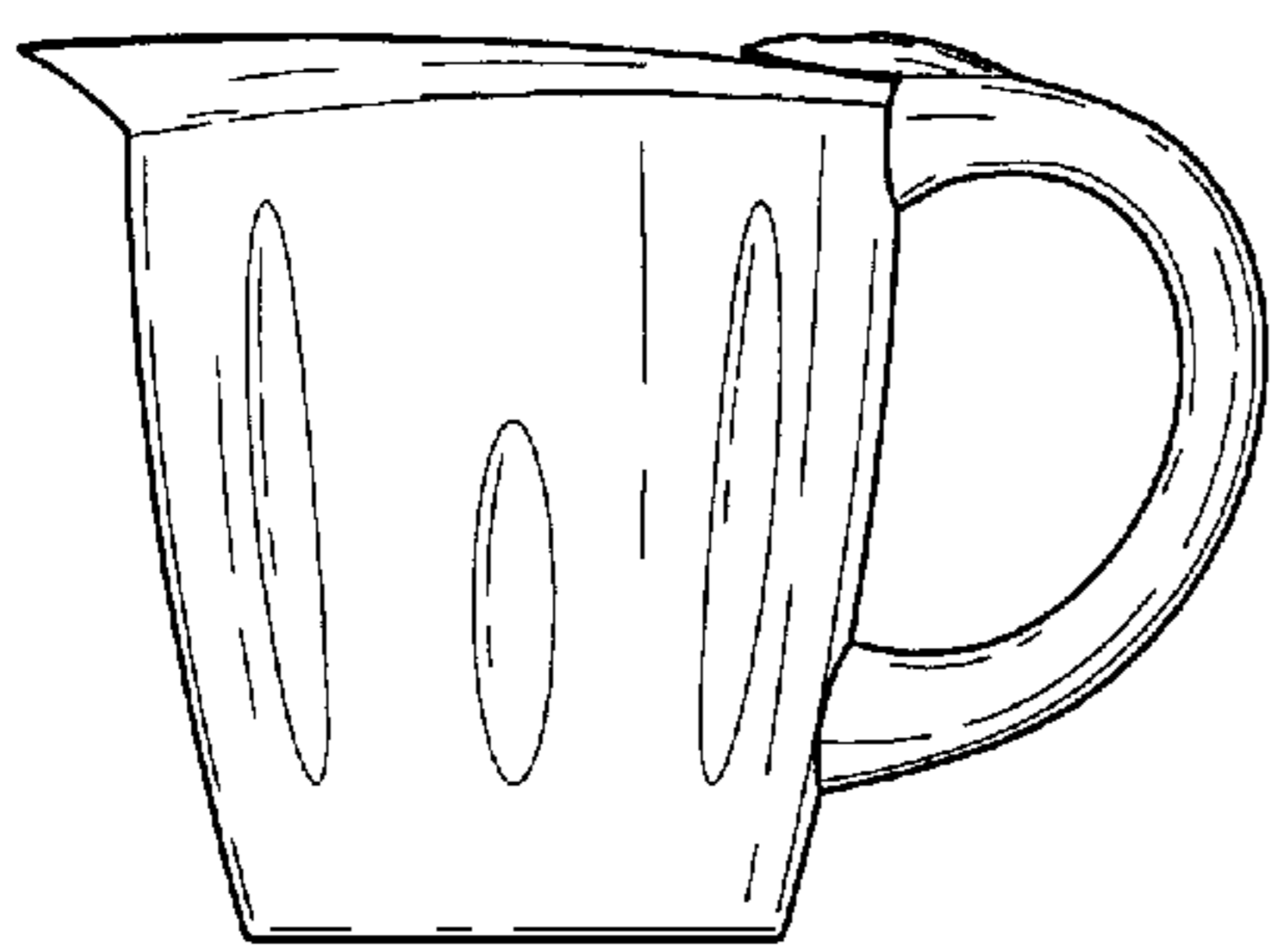

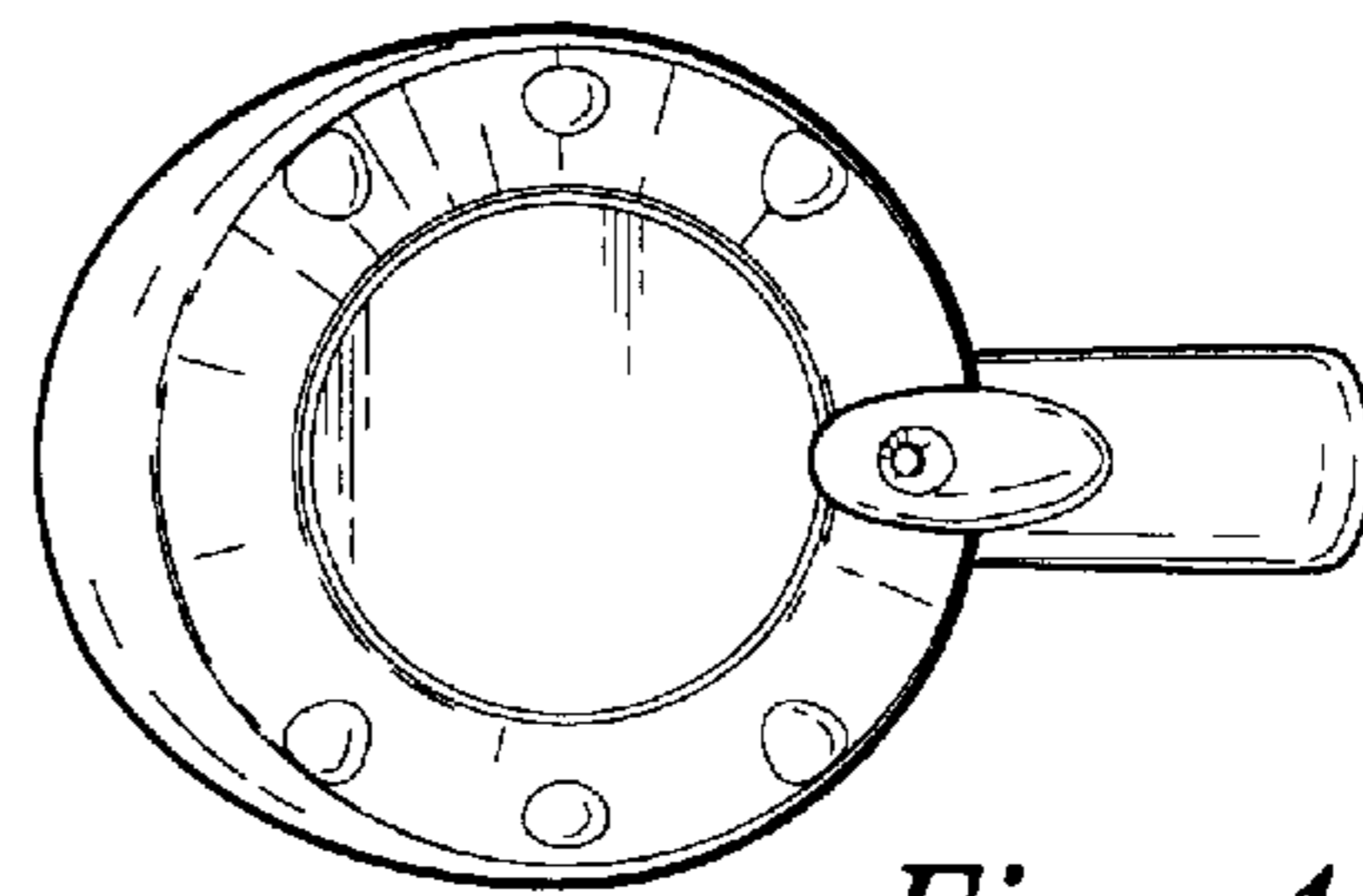

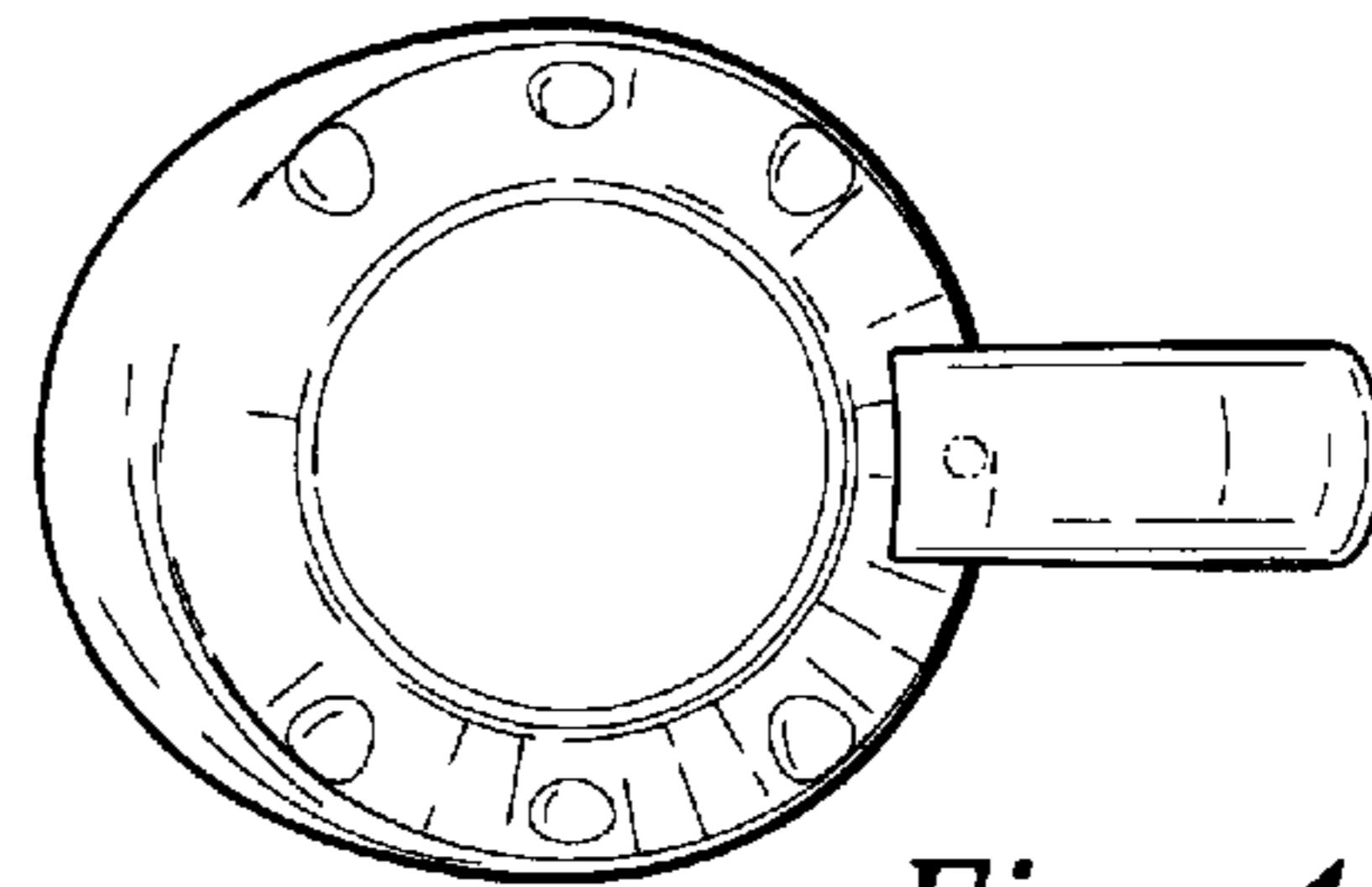

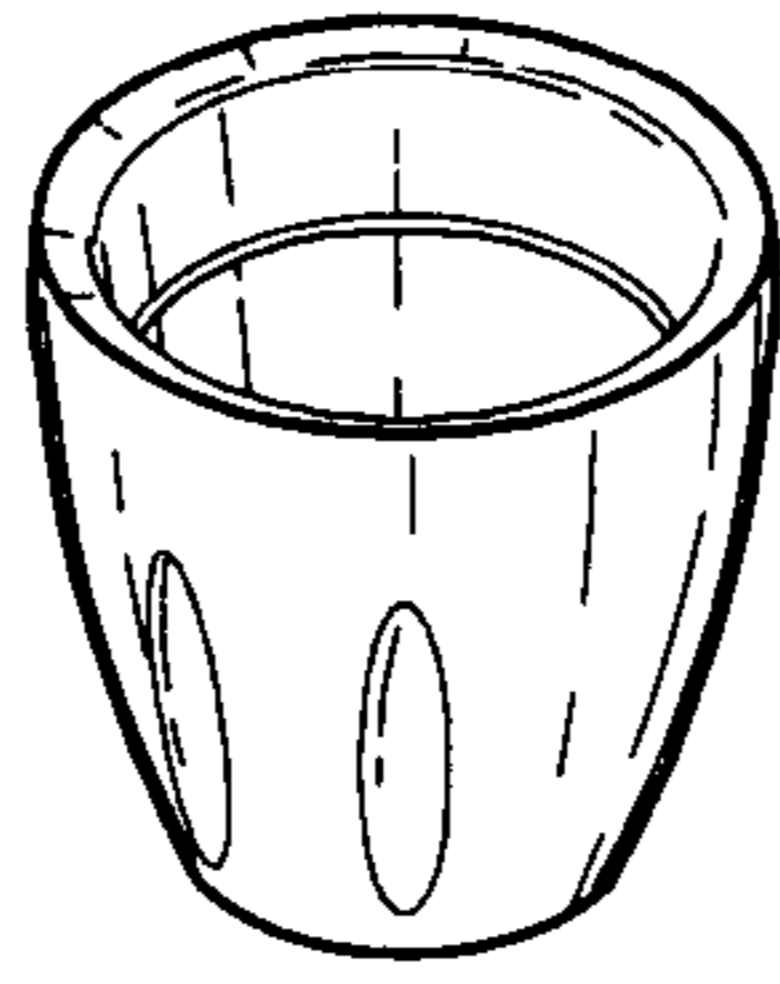

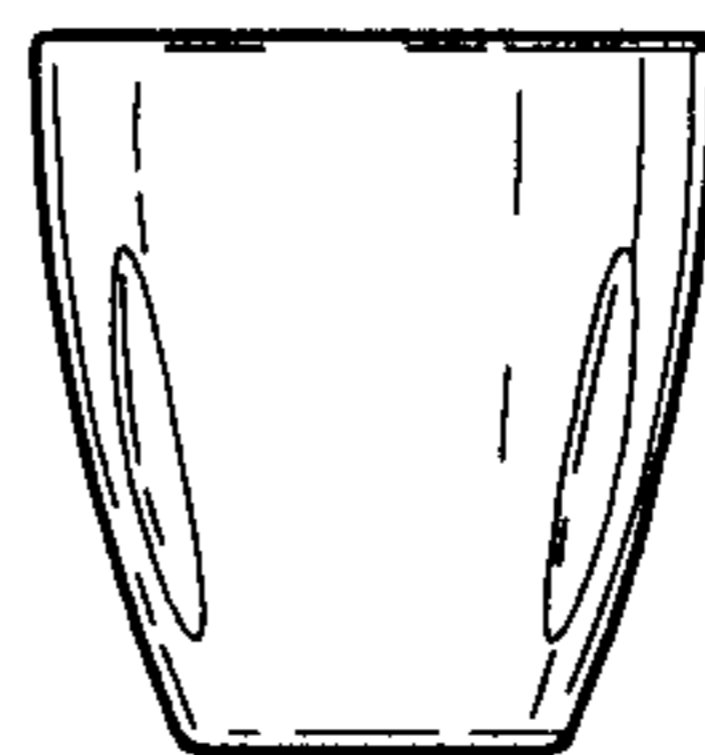

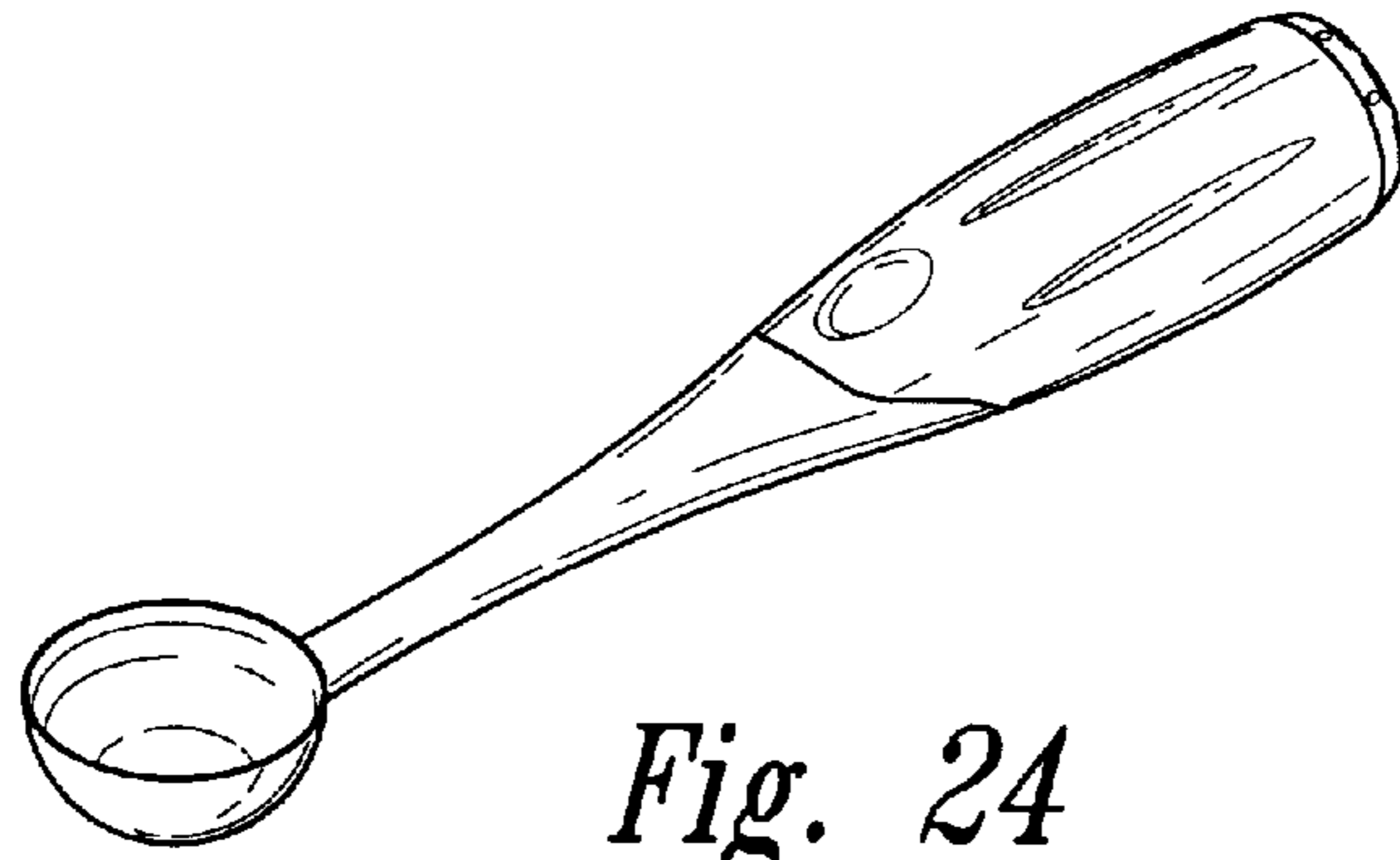

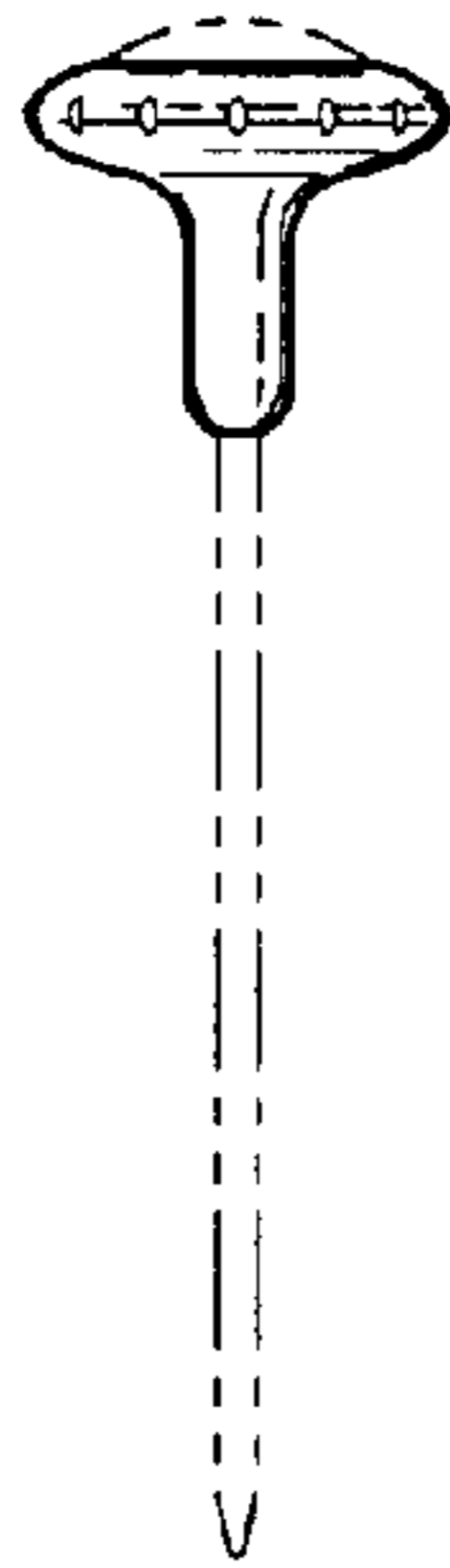

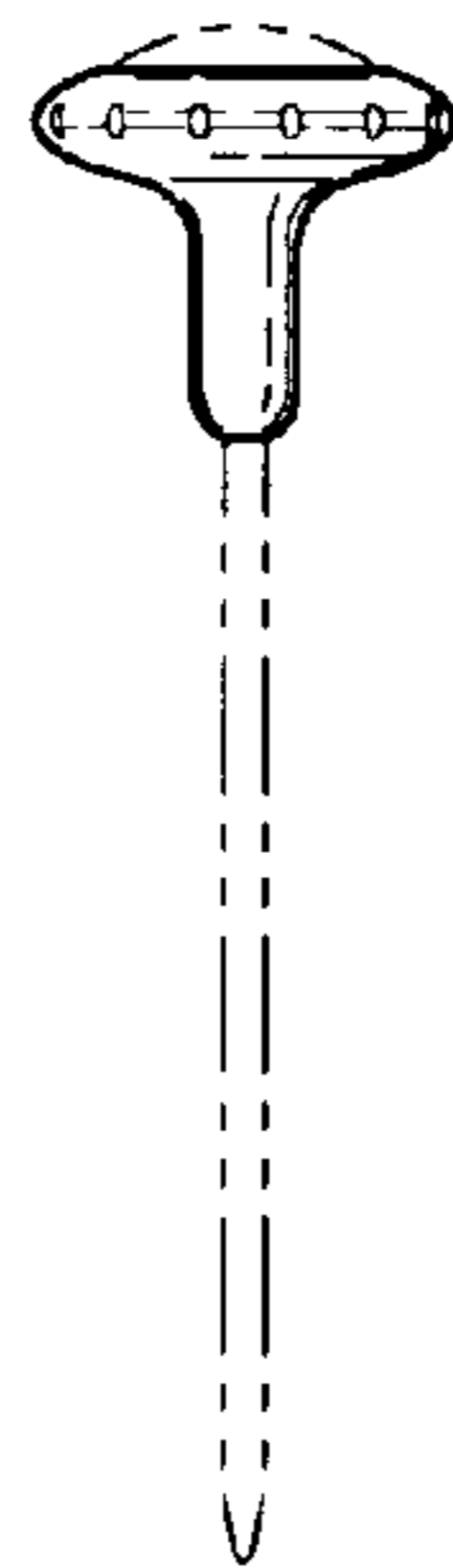

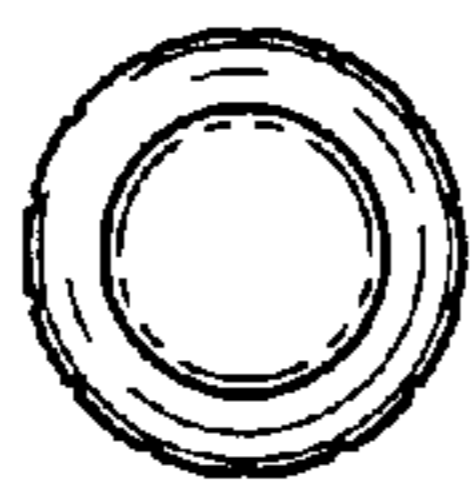

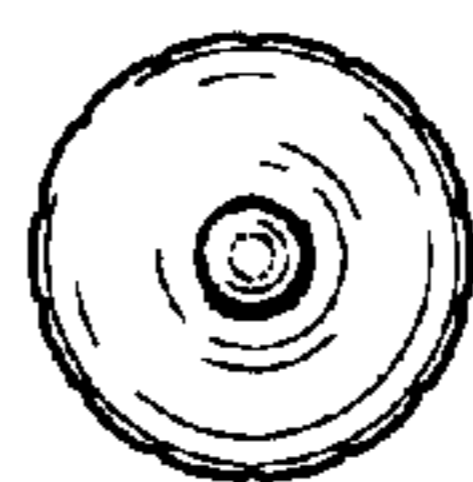
