**DESCRIPTION**

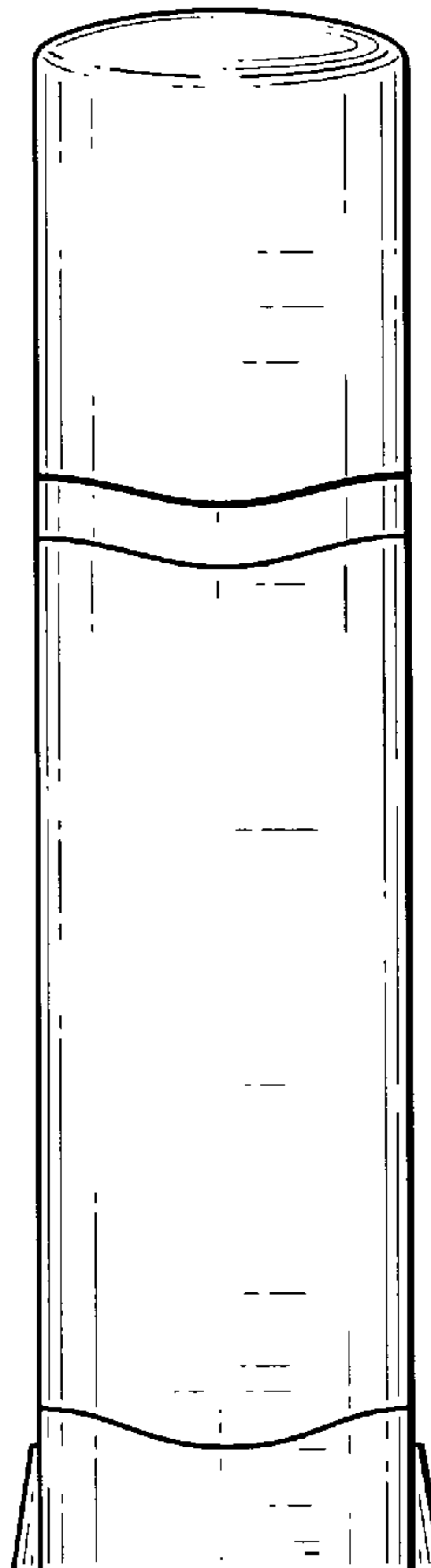
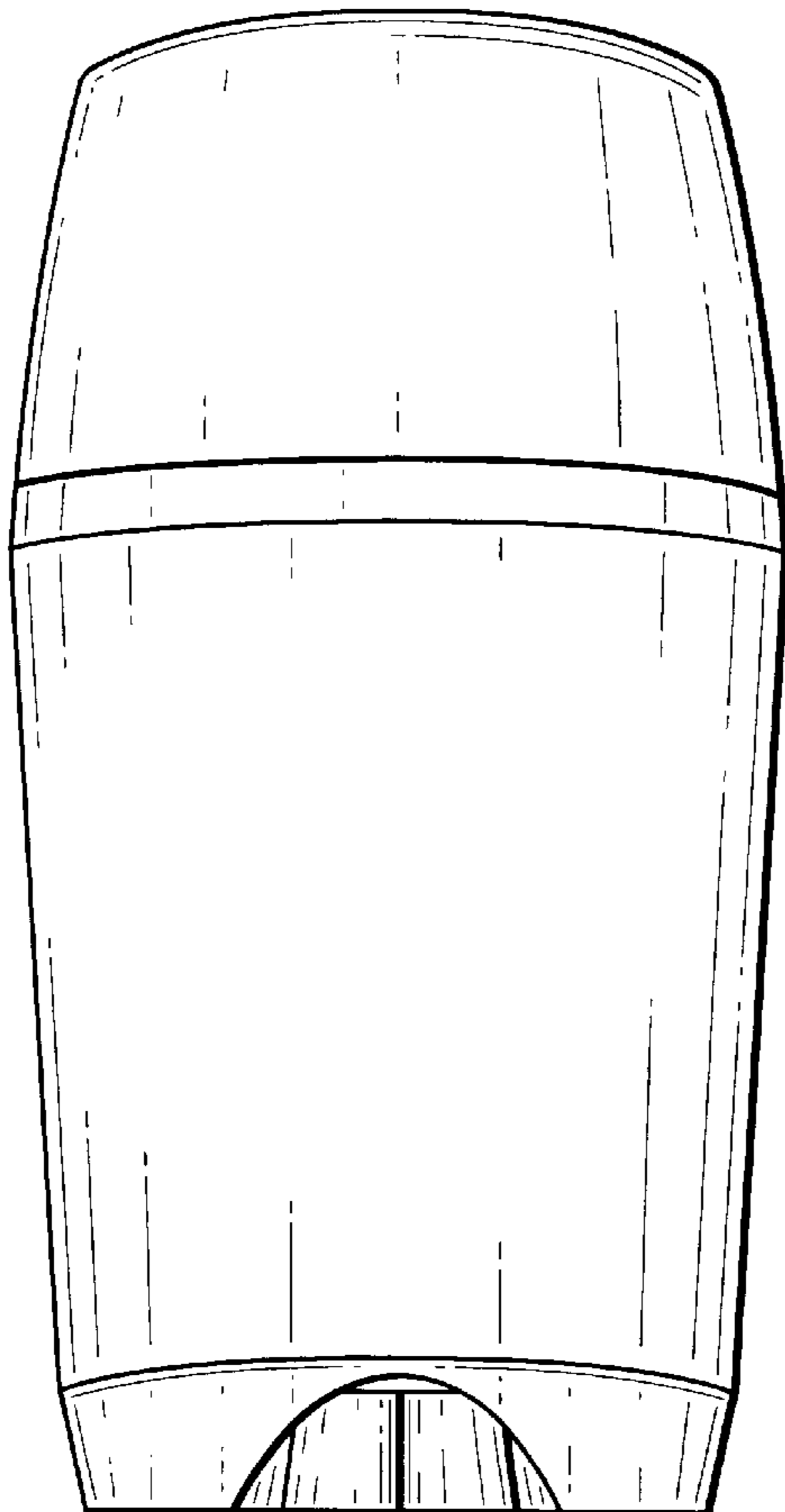
FIG. 1 is a front elevation view of my design for a dispenser, the rear elevation view being a mirror image thereof.

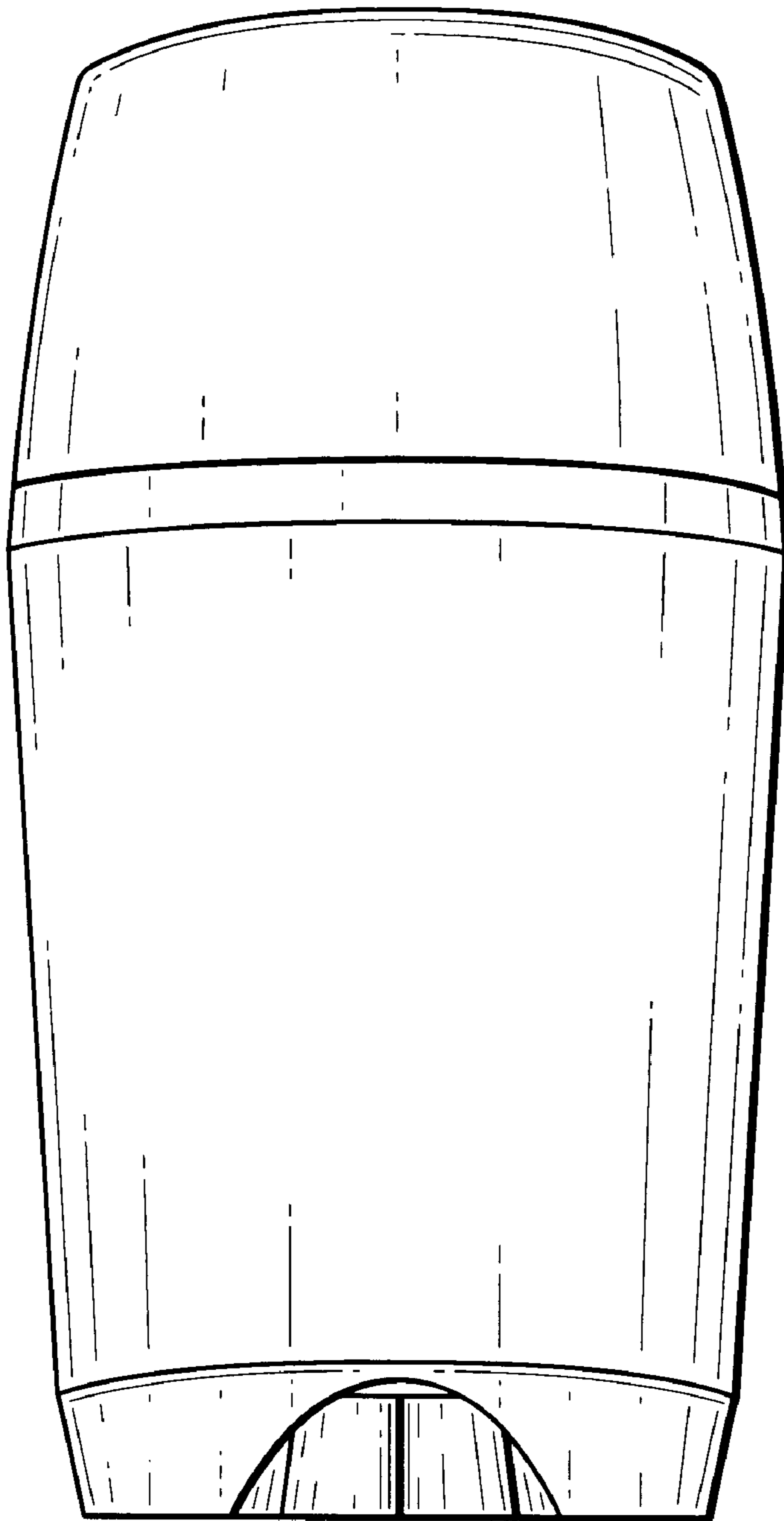

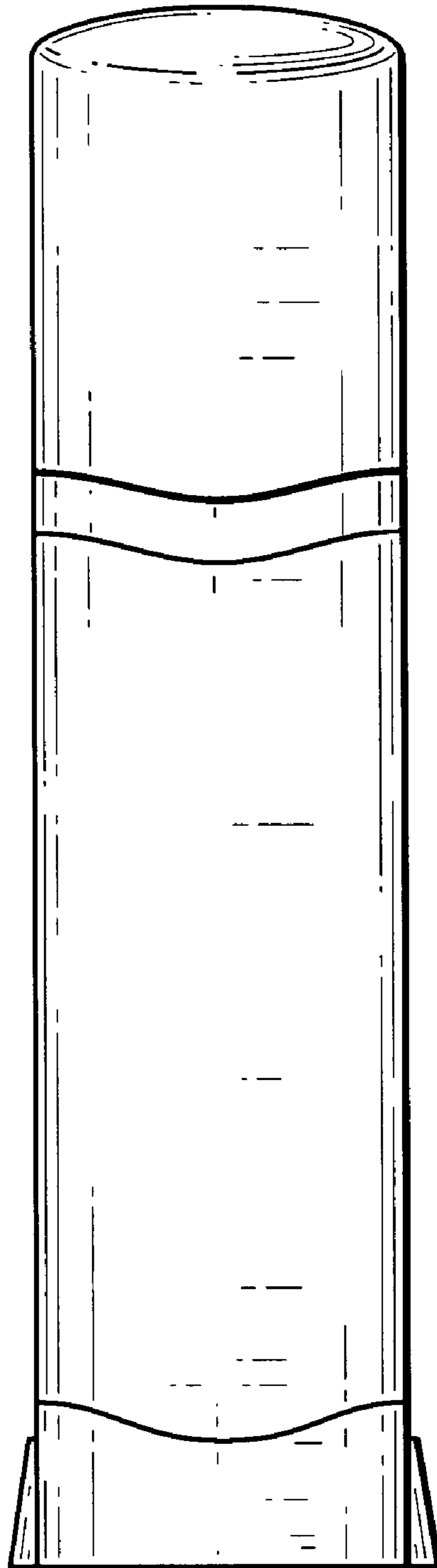

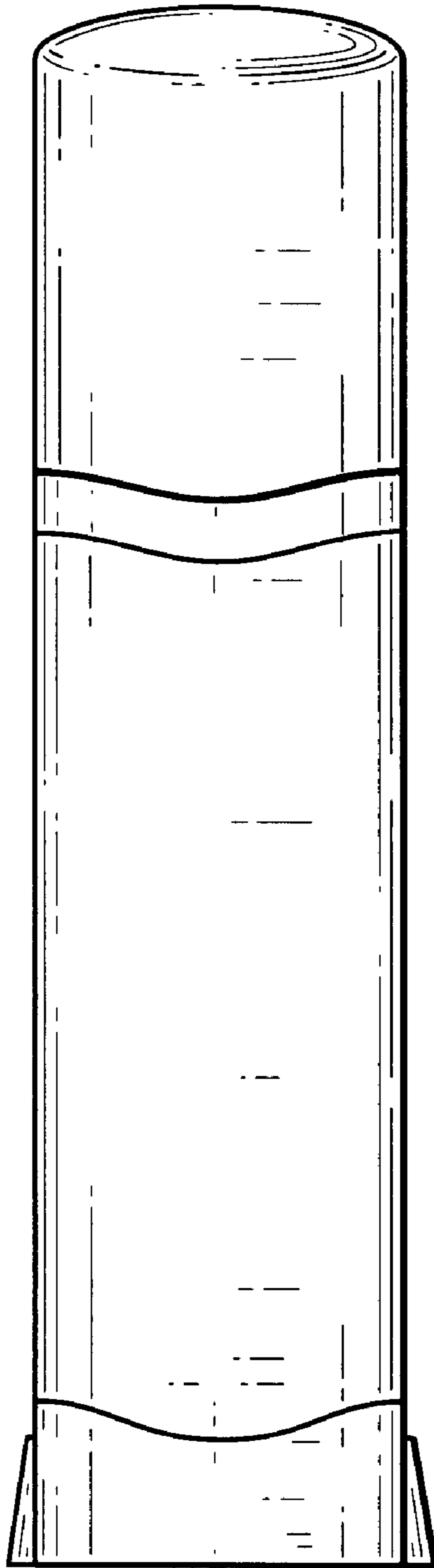

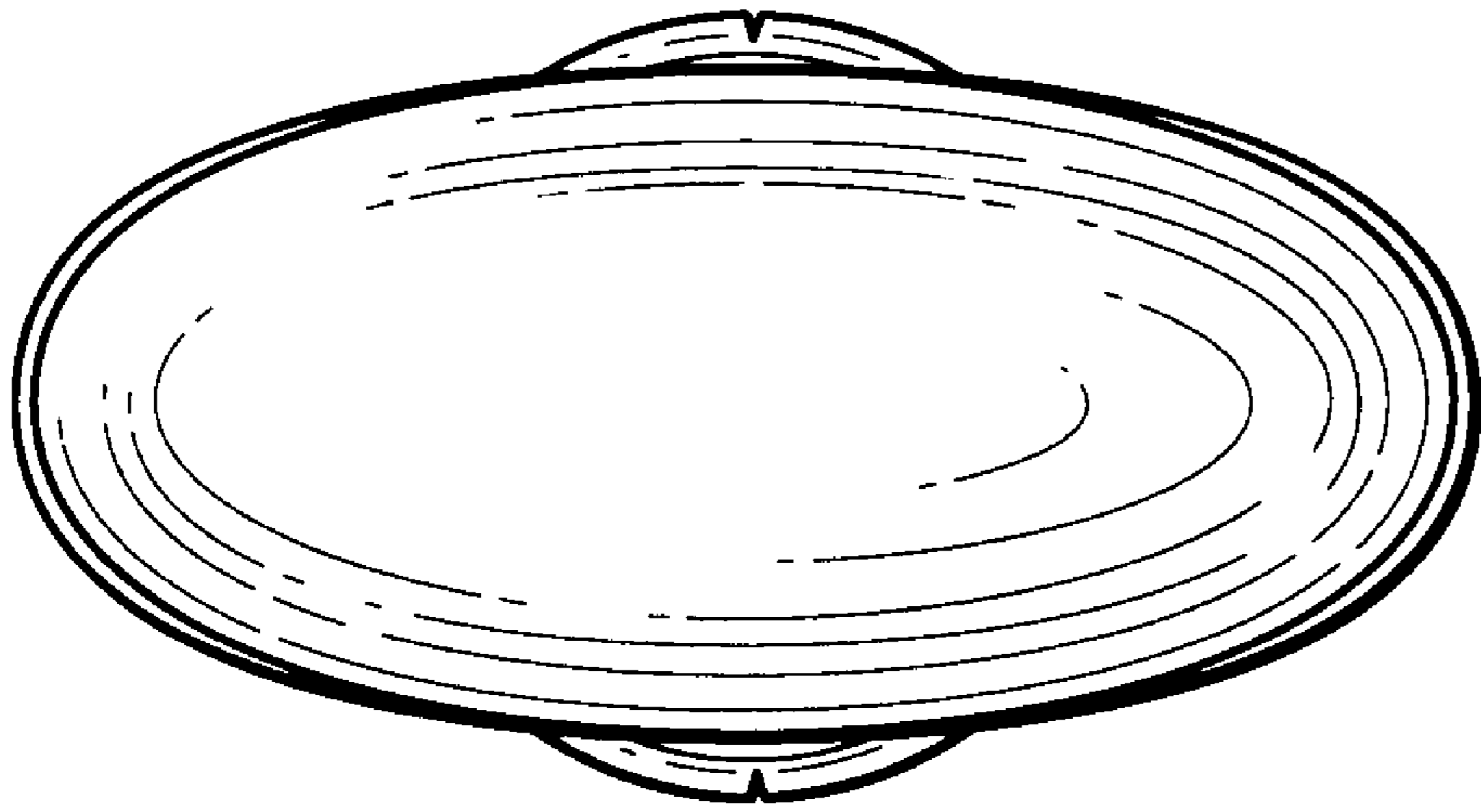
