(57) **CLAIM**

The ornamental design for a digital video disk player with display, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a digital video disk player with display showing my new design,

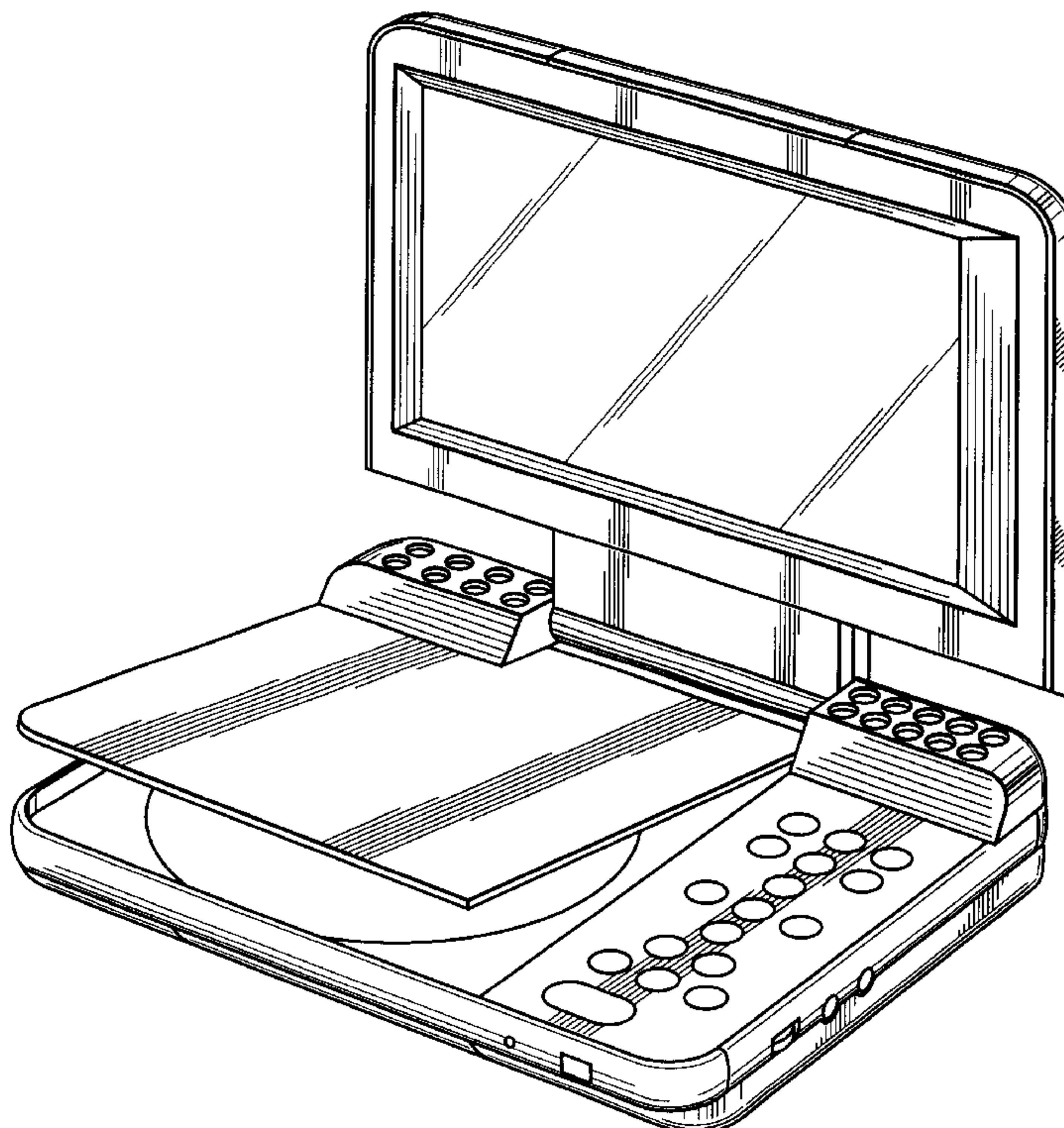

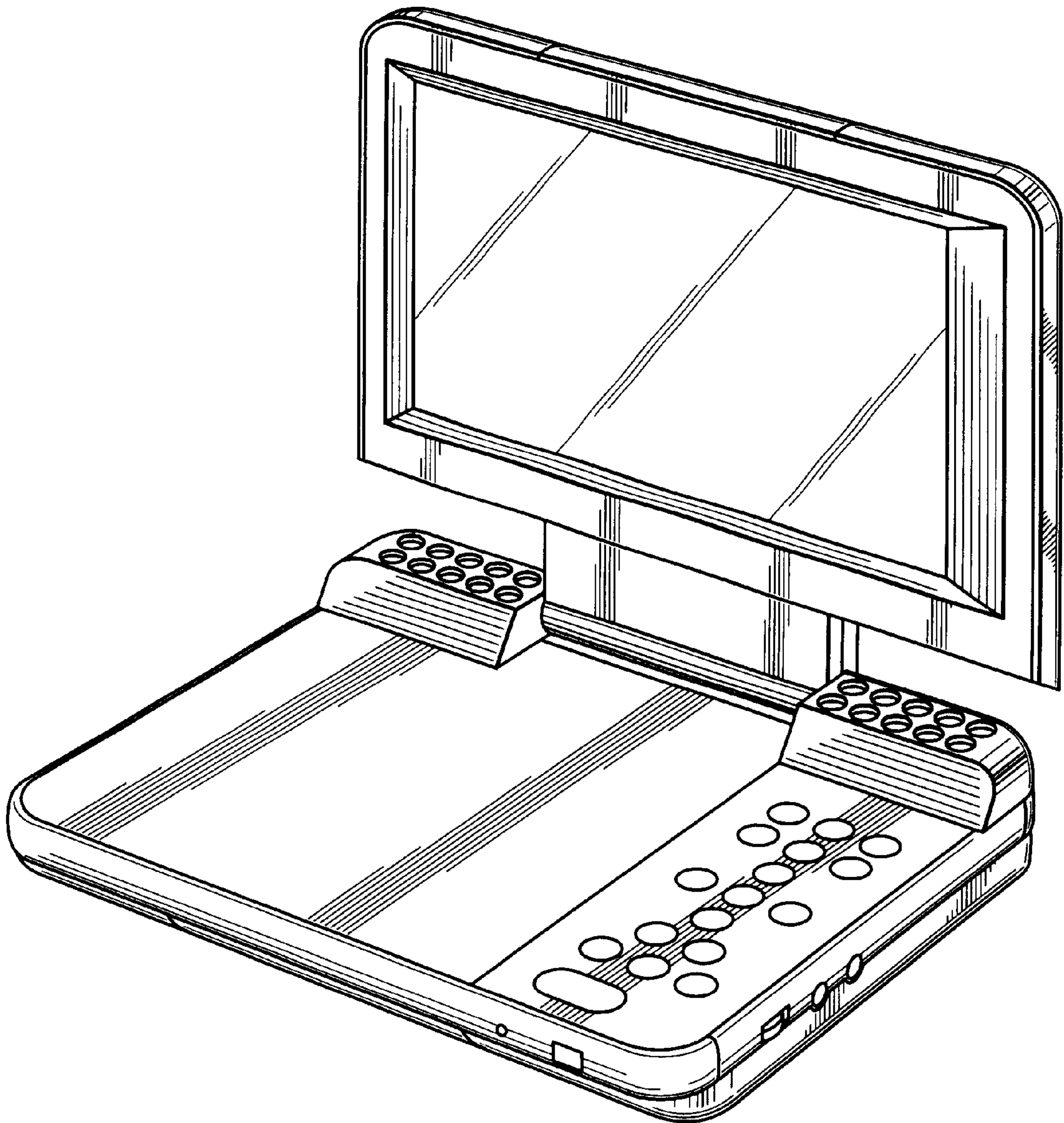

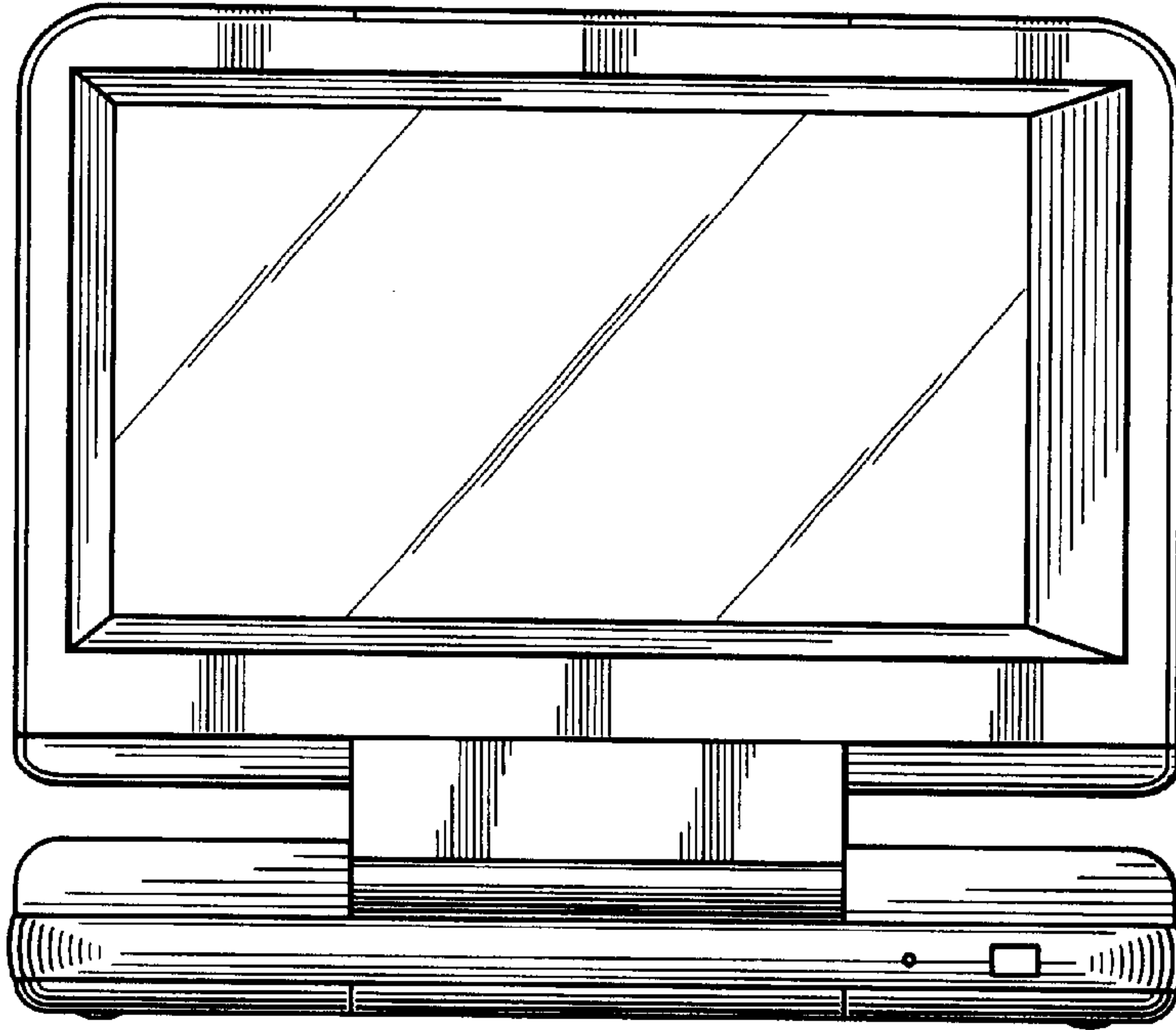

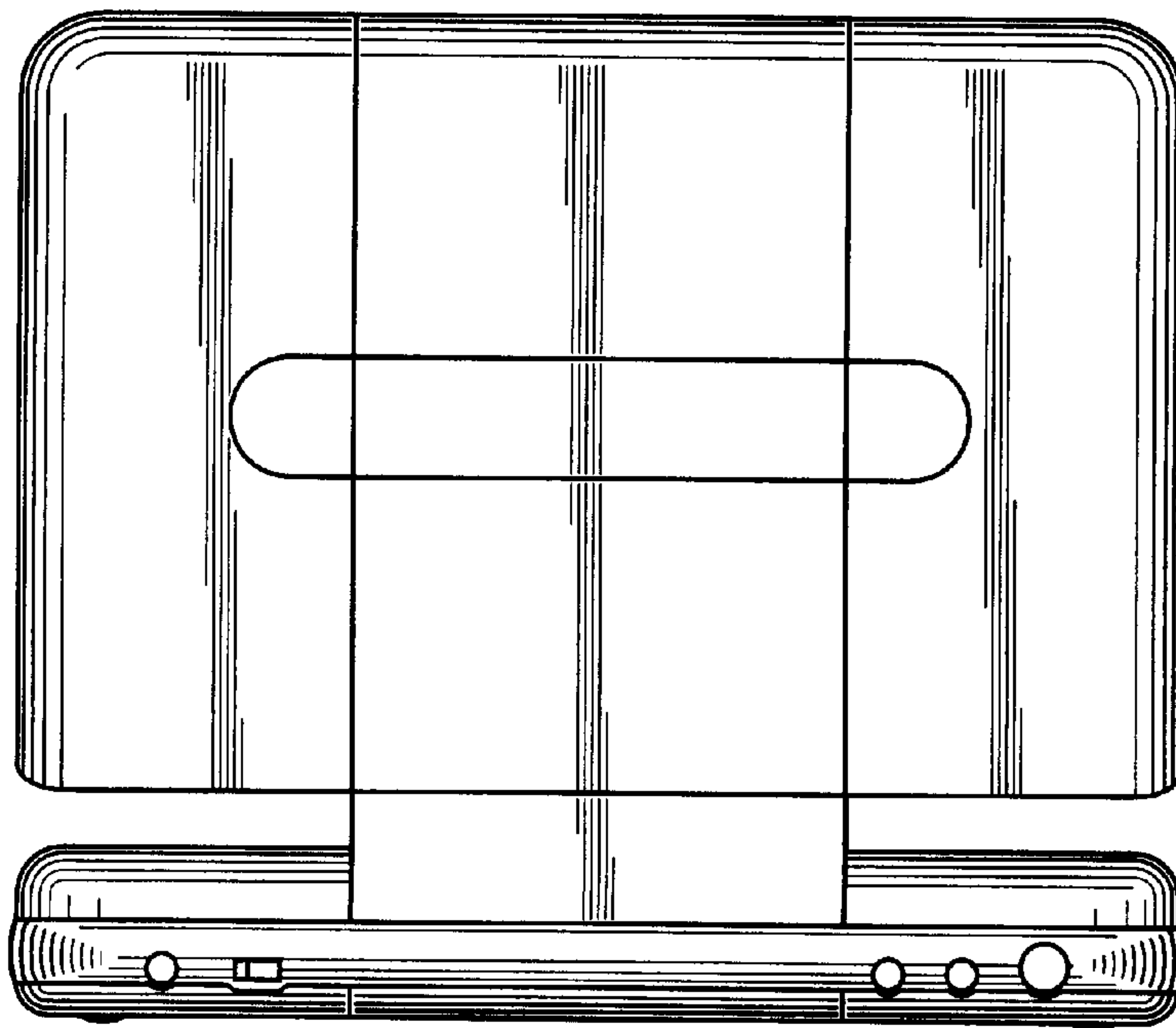

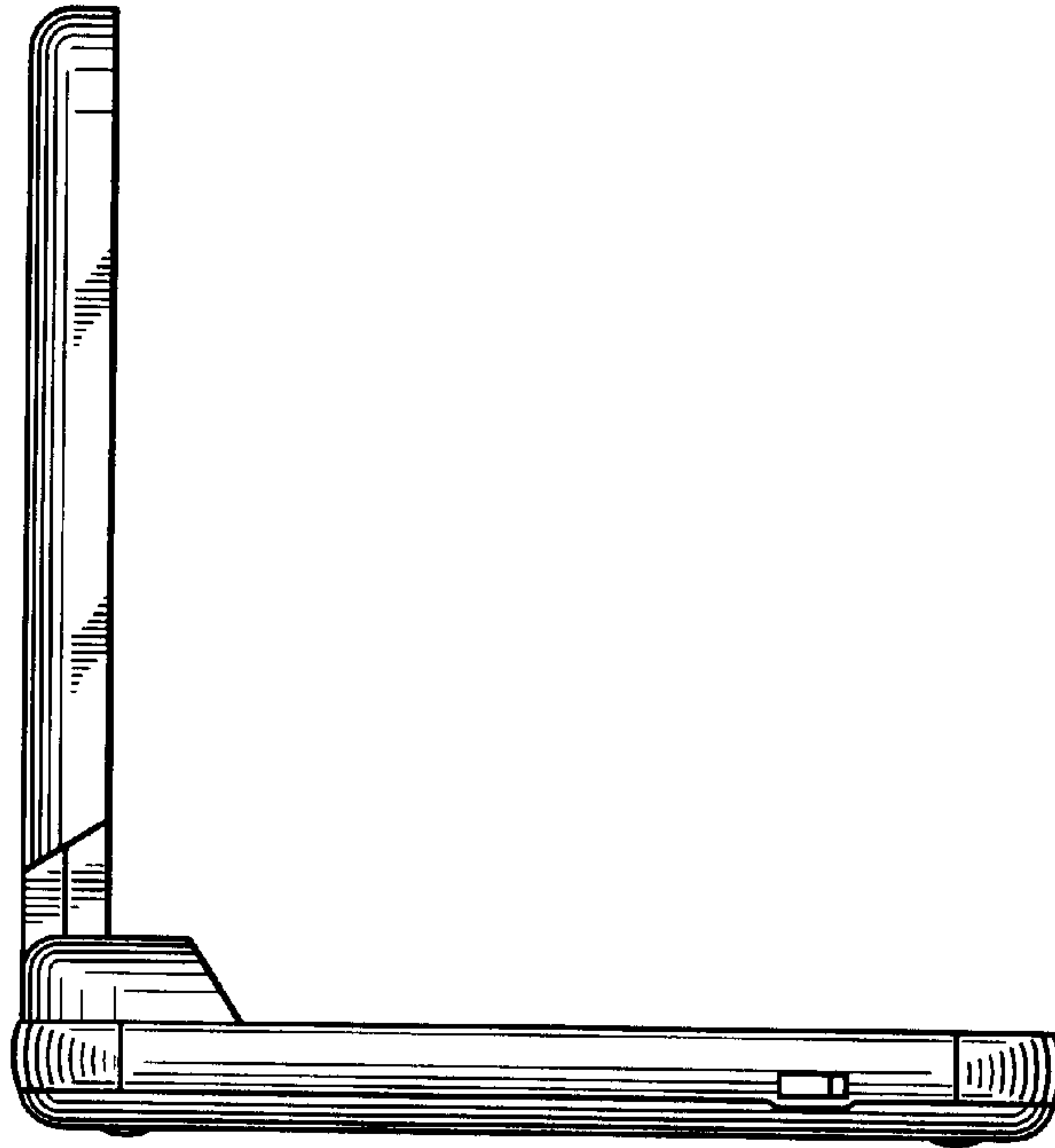

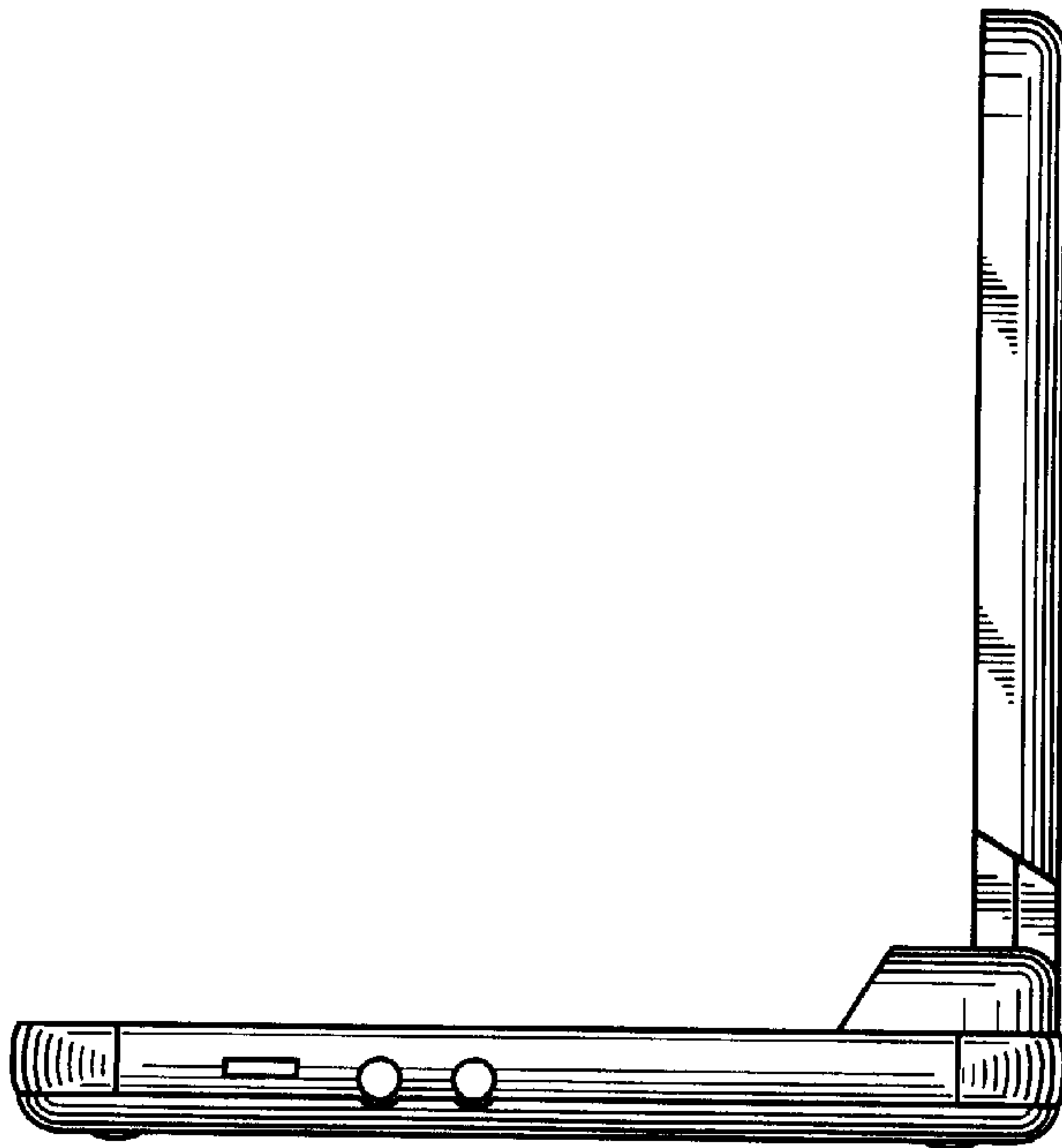

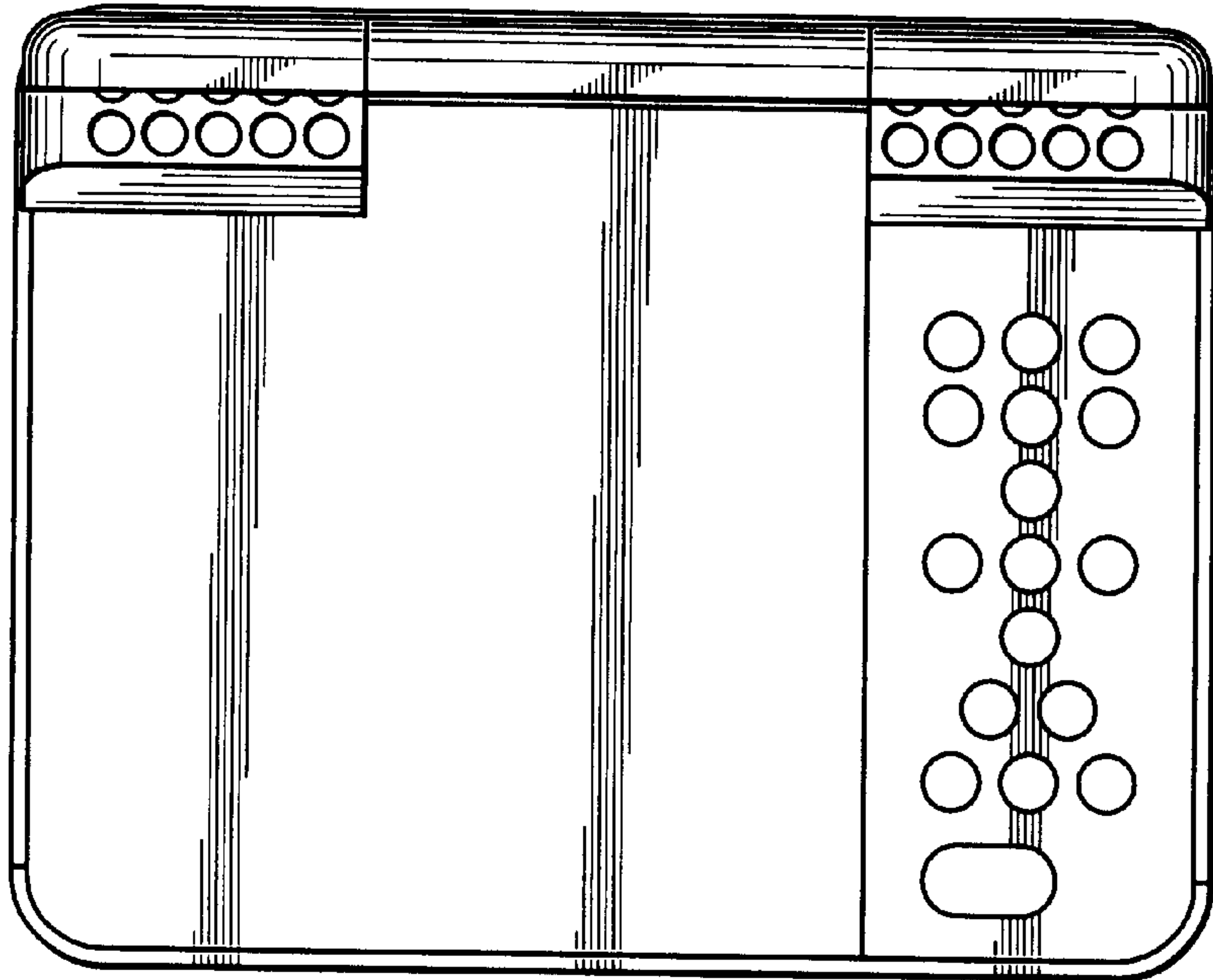

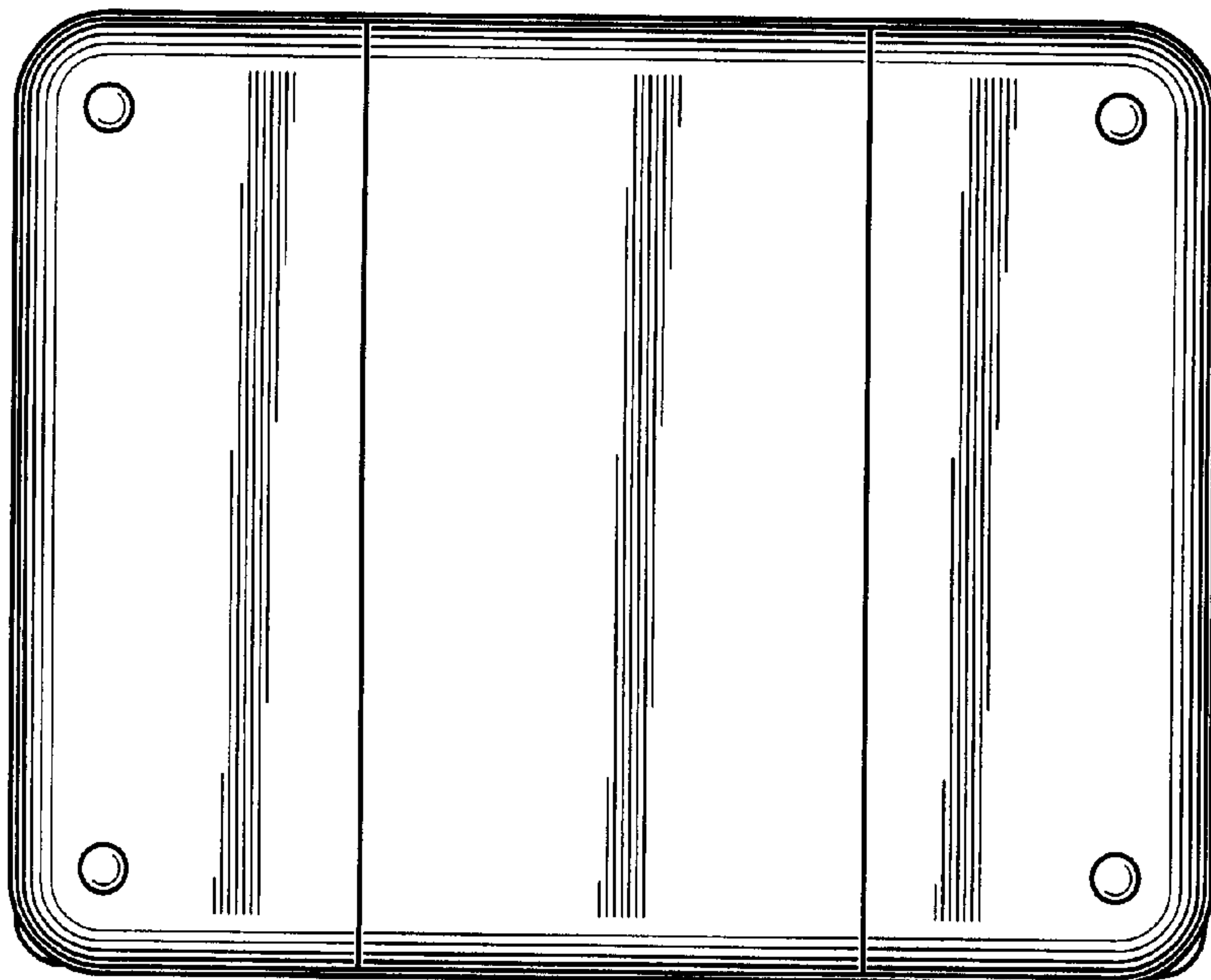

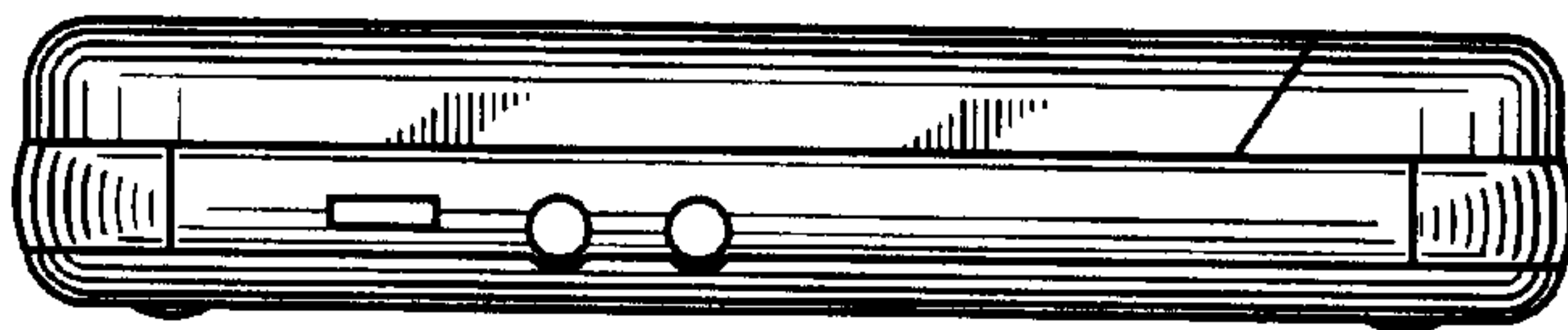

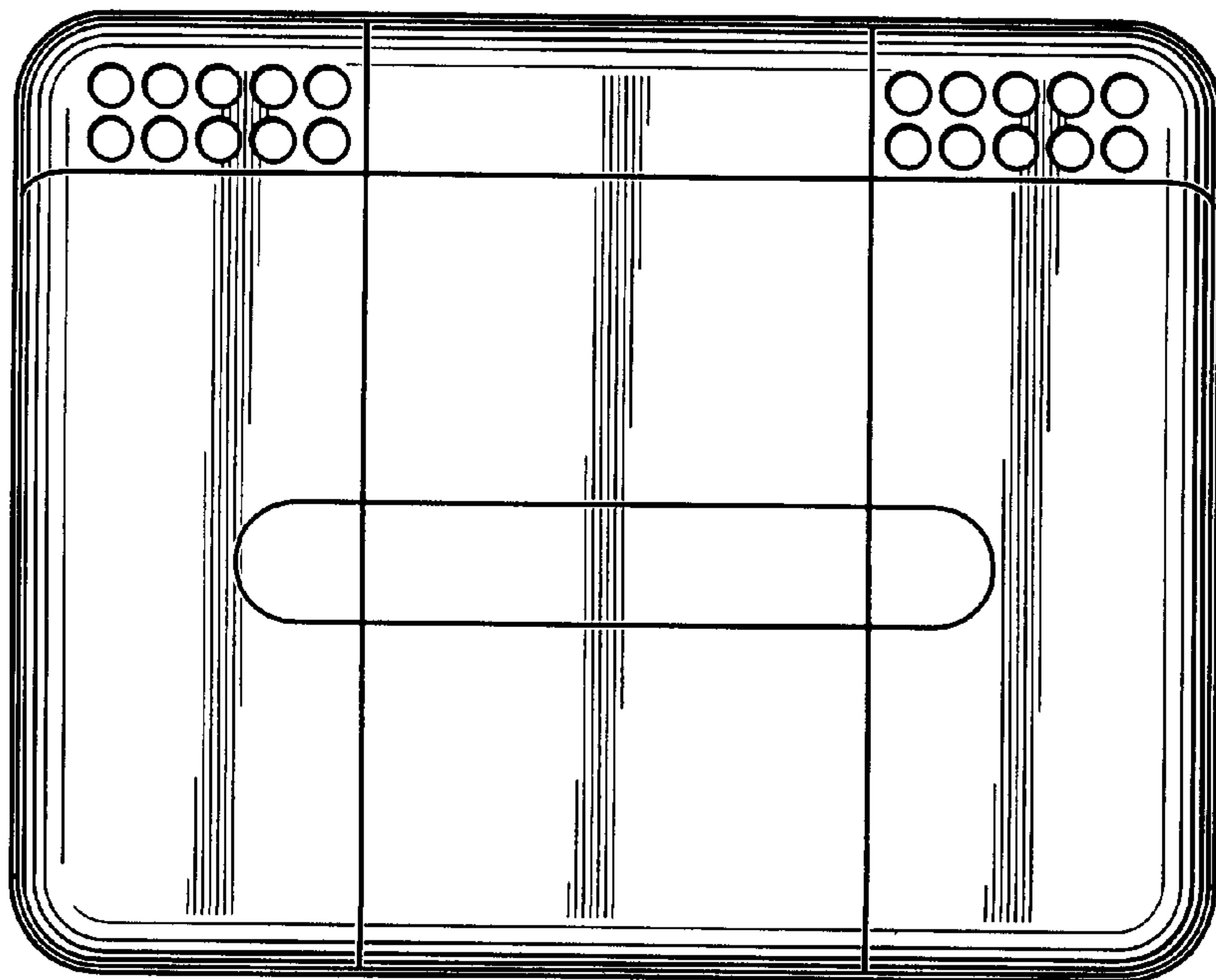
