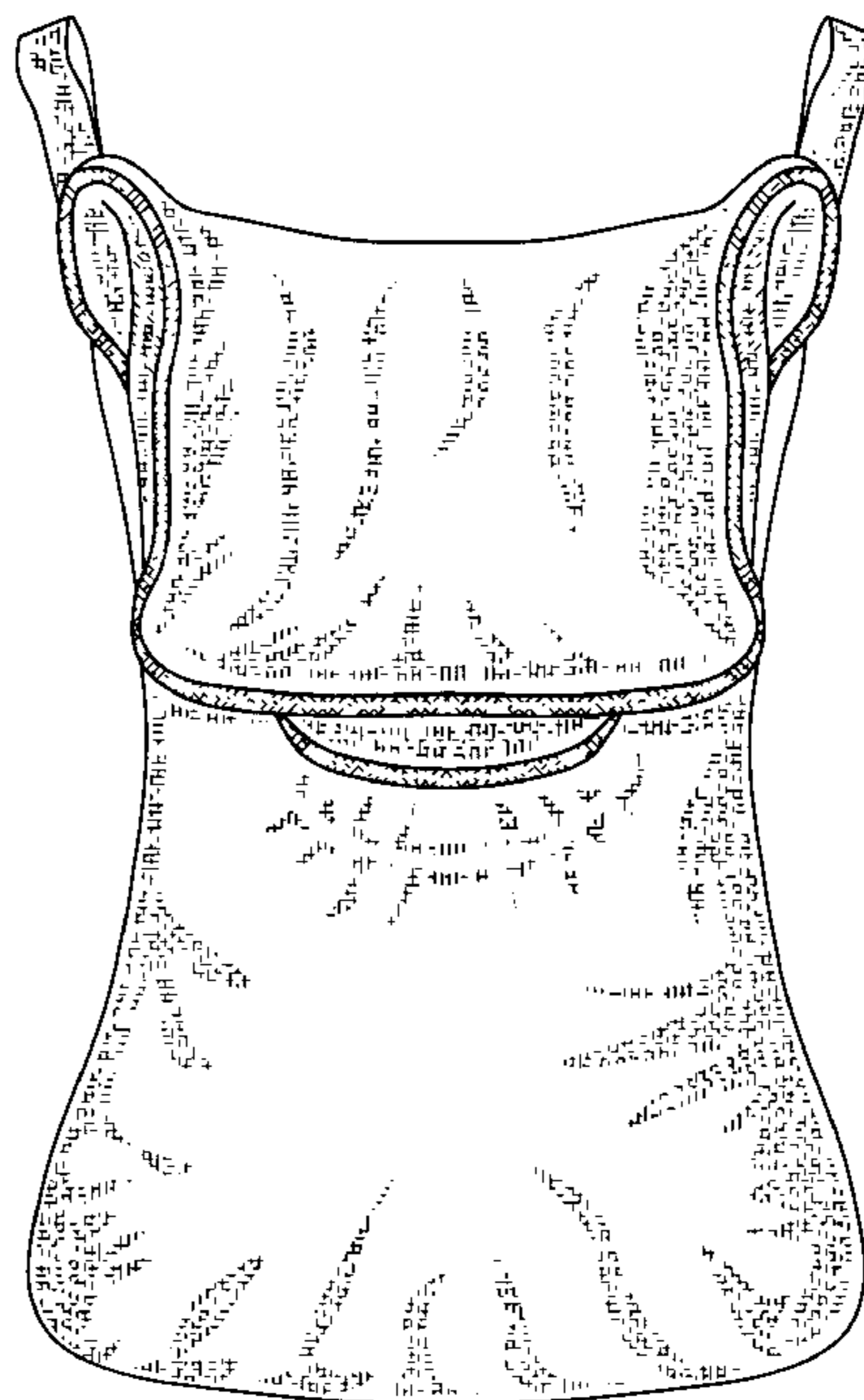
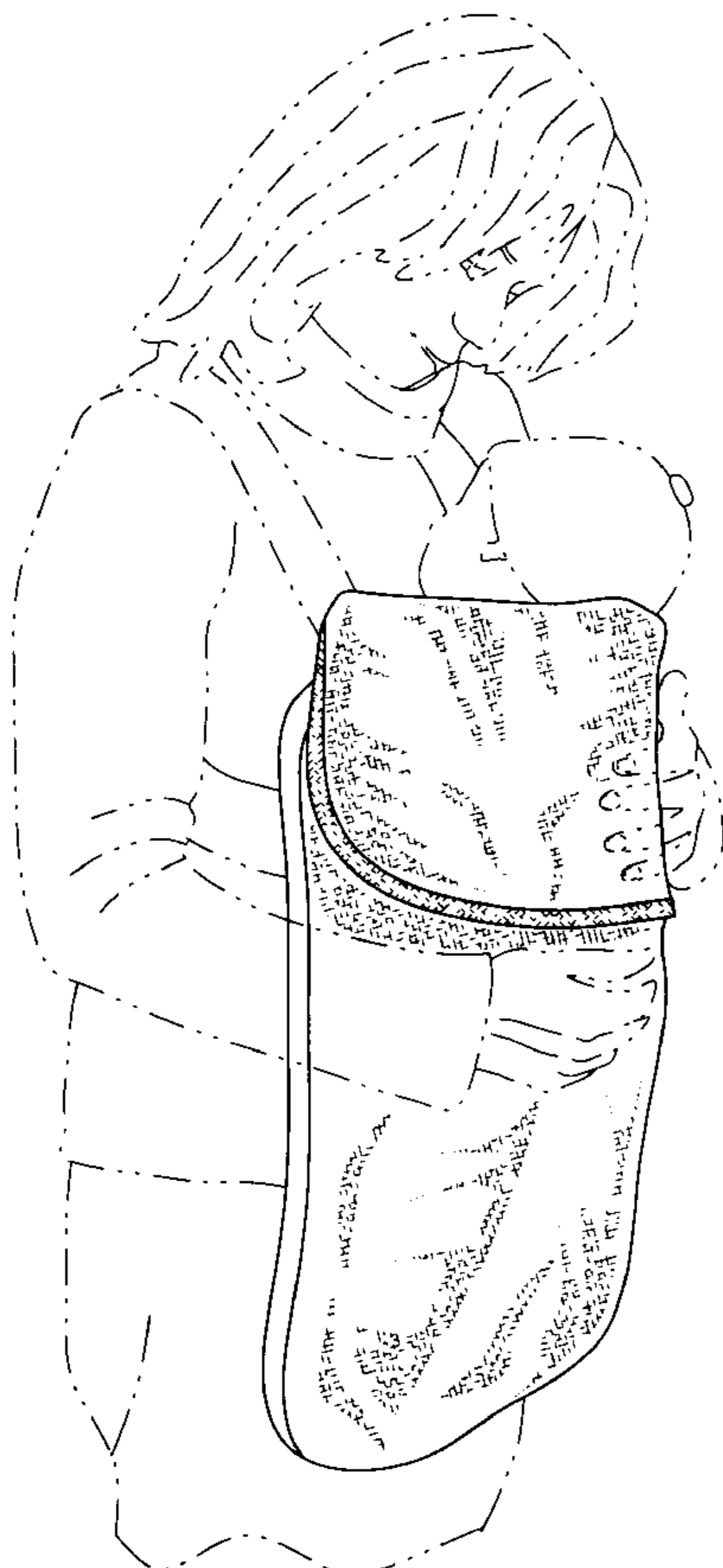
(57) **CLAIM**

The ornamental design for baby cover for use with front-pack carrier, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of baby cover for use with front-pack carrier showing my design; the broken lines showing a mother and child represent the environment in which the design resides, and form no part of the claim; FIG. 2 is a front elevation view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a left side elevation view thereof, the right side elevation view thereof being a mirror image; FIG. 5 is a rear elevation view thereof; and, FIG. 6 is a bottom view thereof.

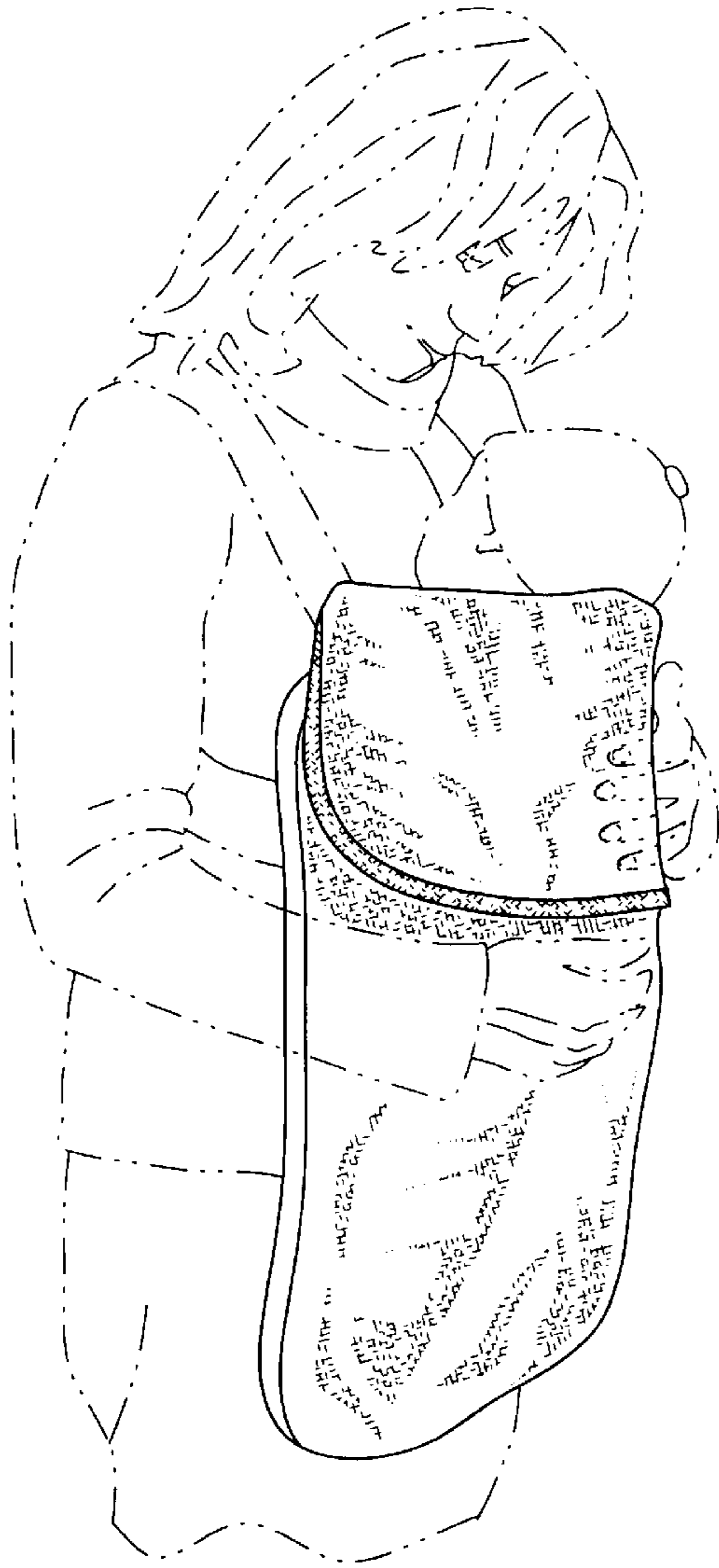

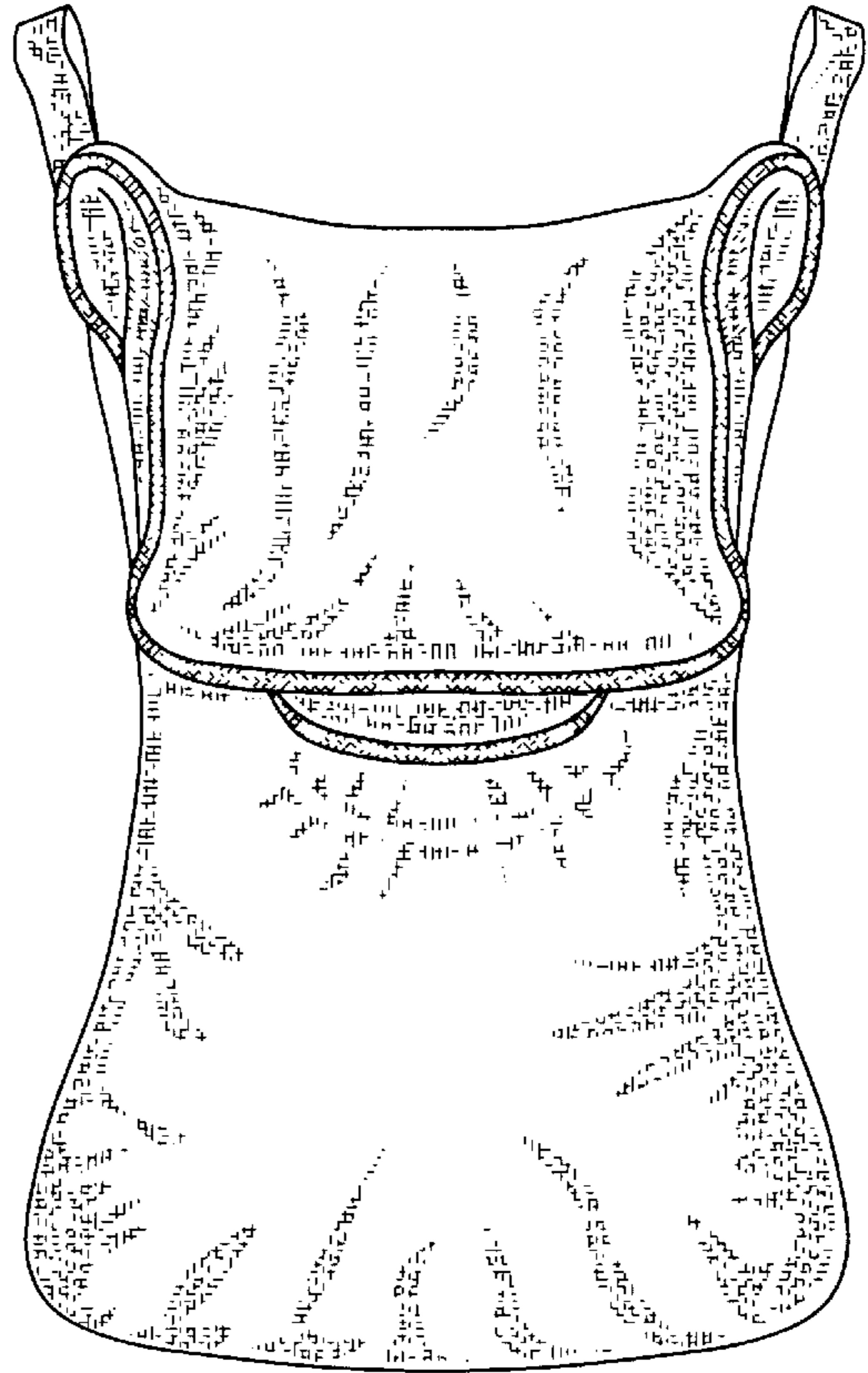

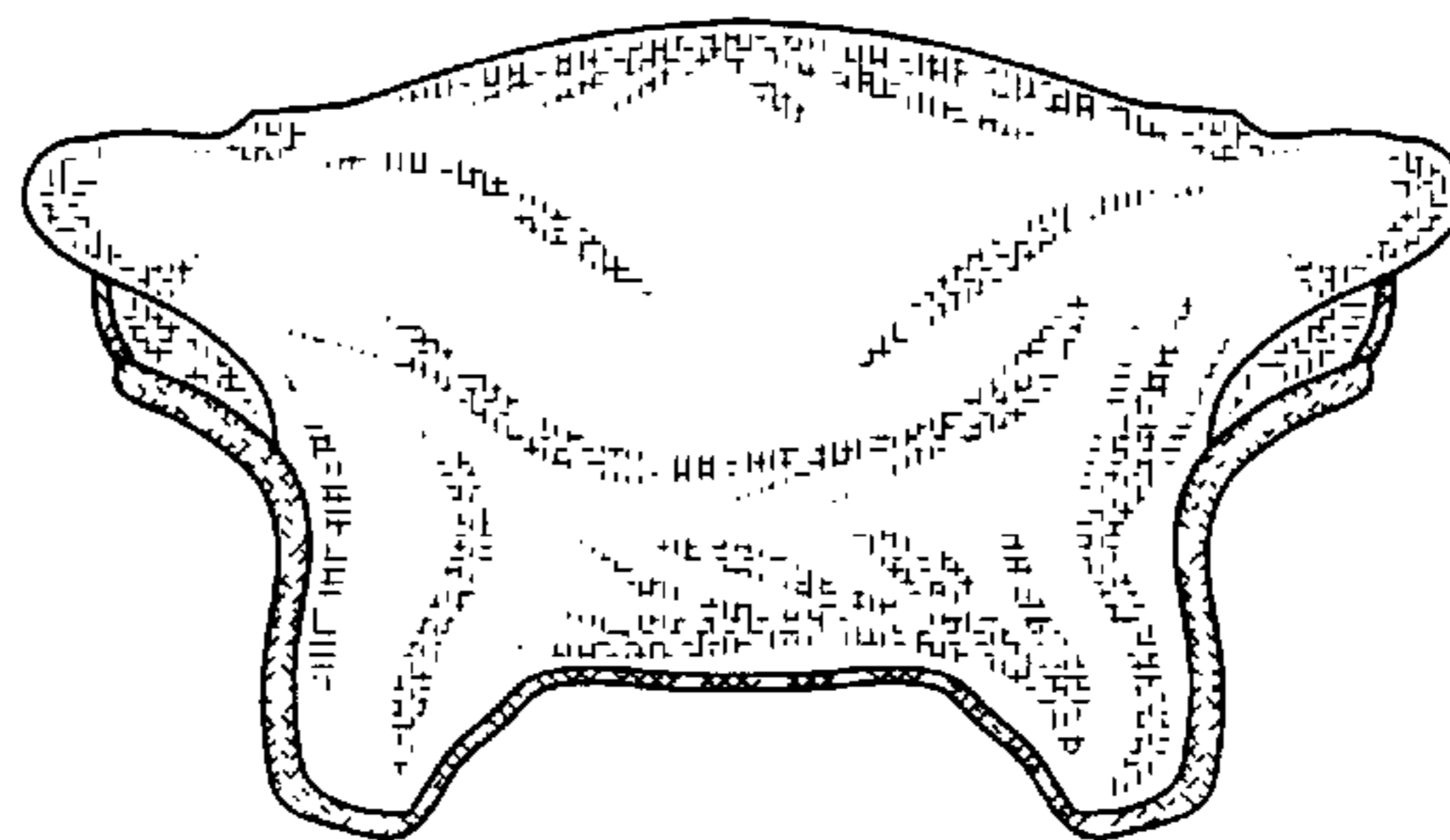

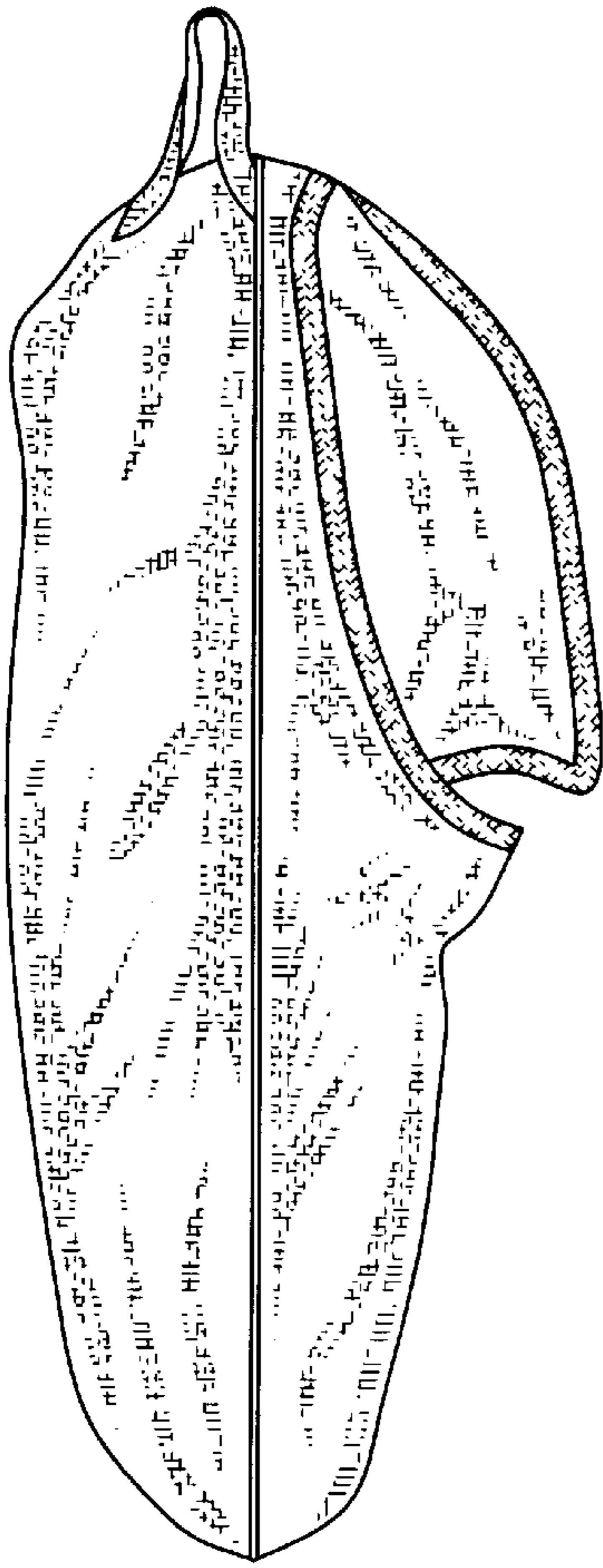

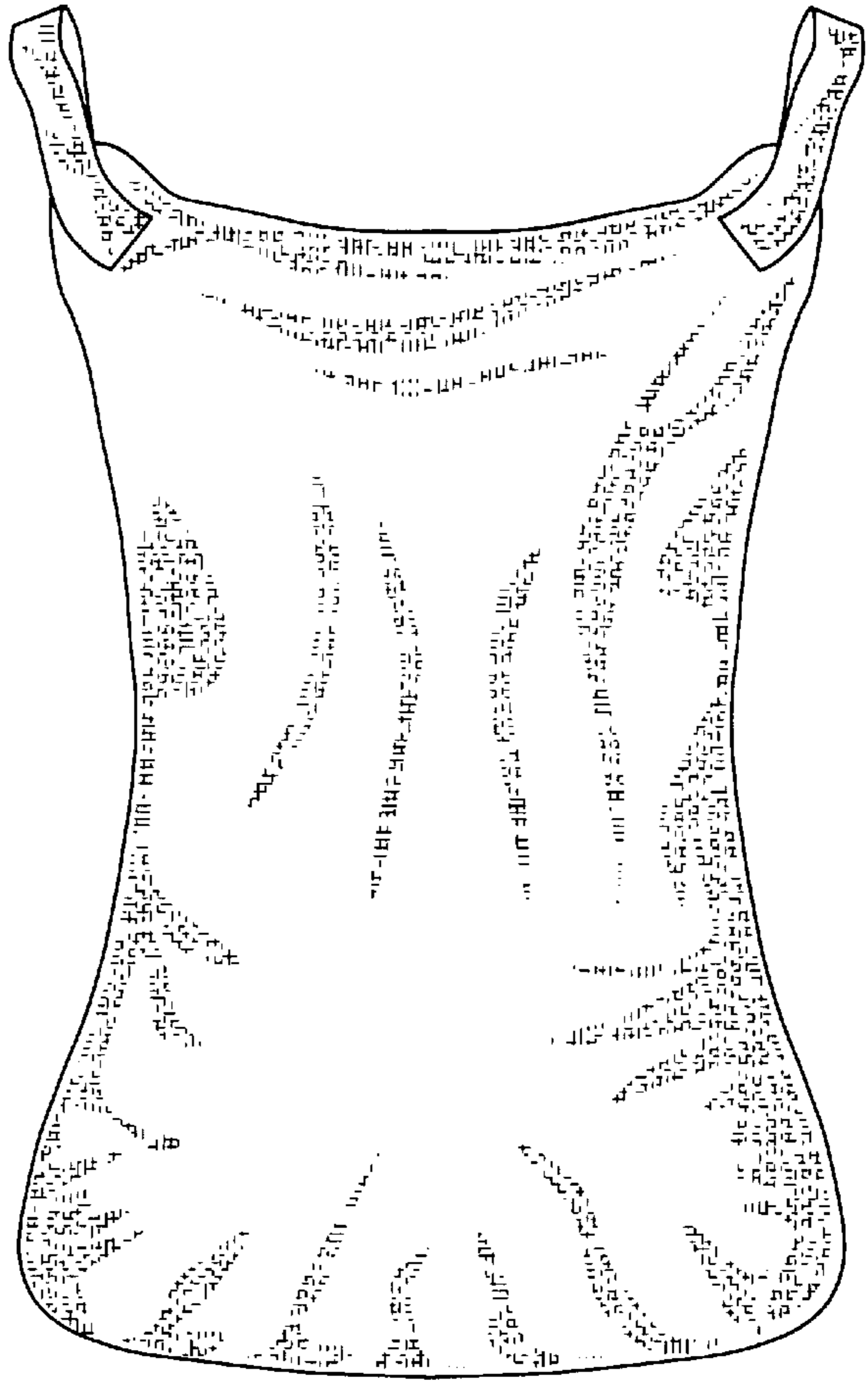

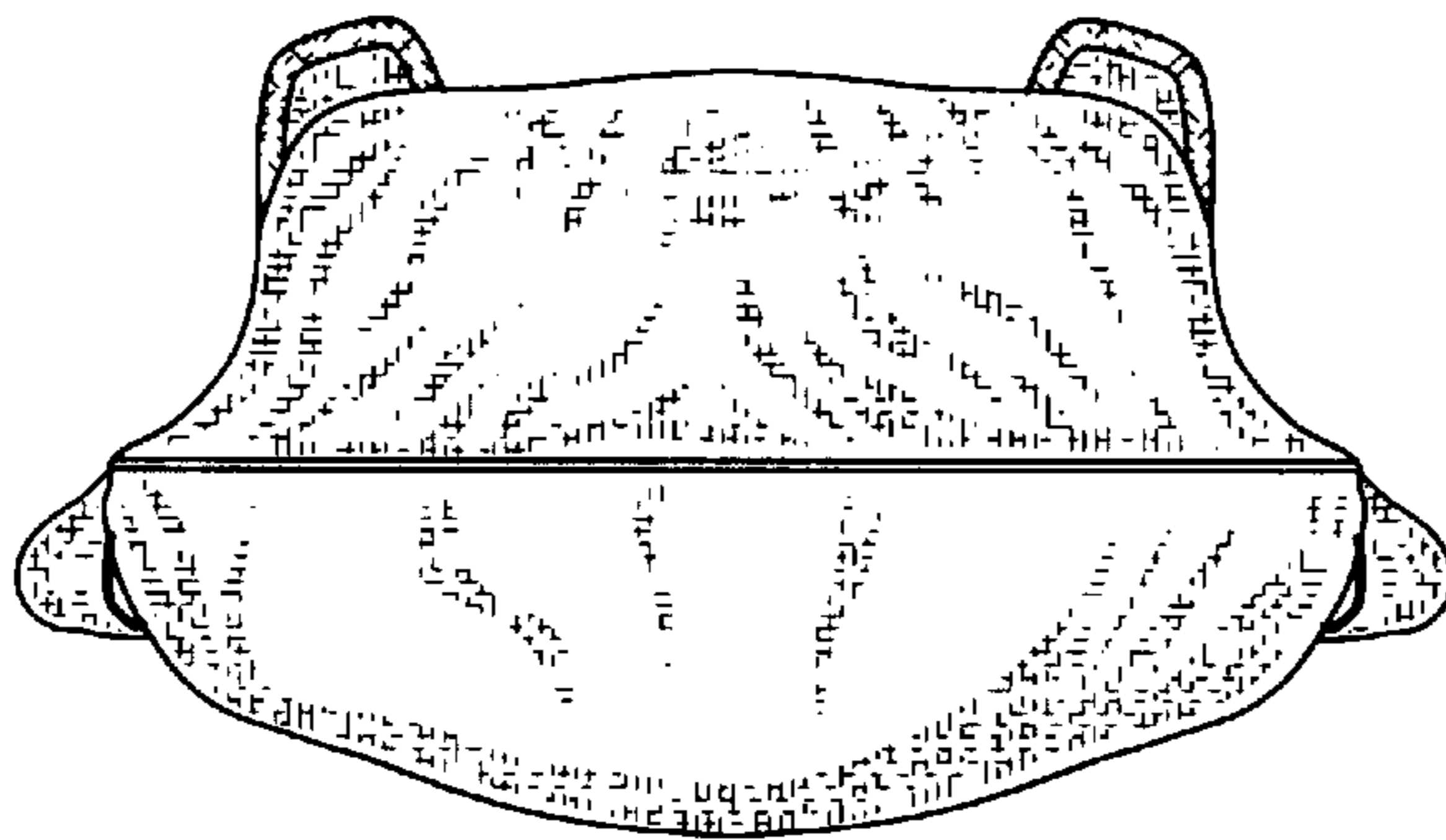
