FIG. 7 is a right side view of the cellular phone carrying case of FIG. 1, but shows a cellular phone in phantom being carried therein; and,

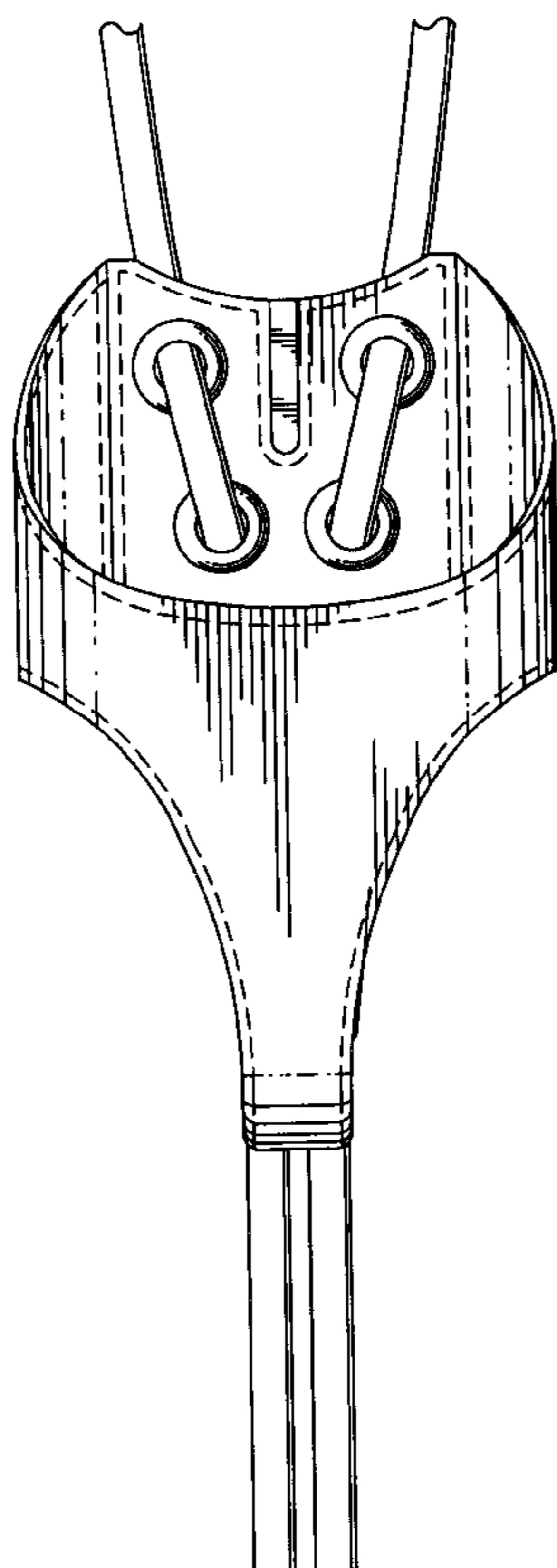
FIG. 8 is a back view of the cellular phone carrying case of FIG. 1, but shows a cellular phone in phantom being carried therein.

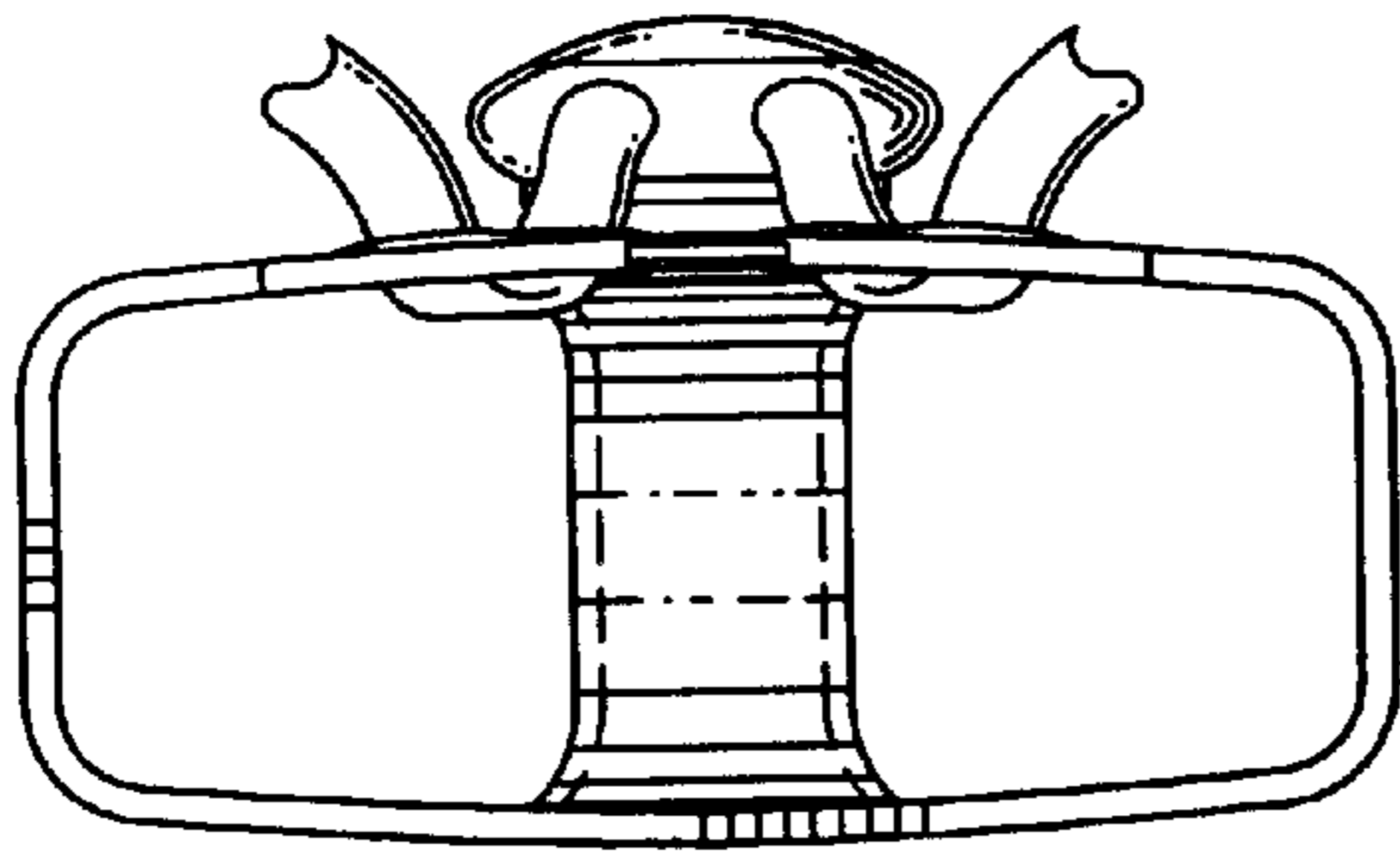

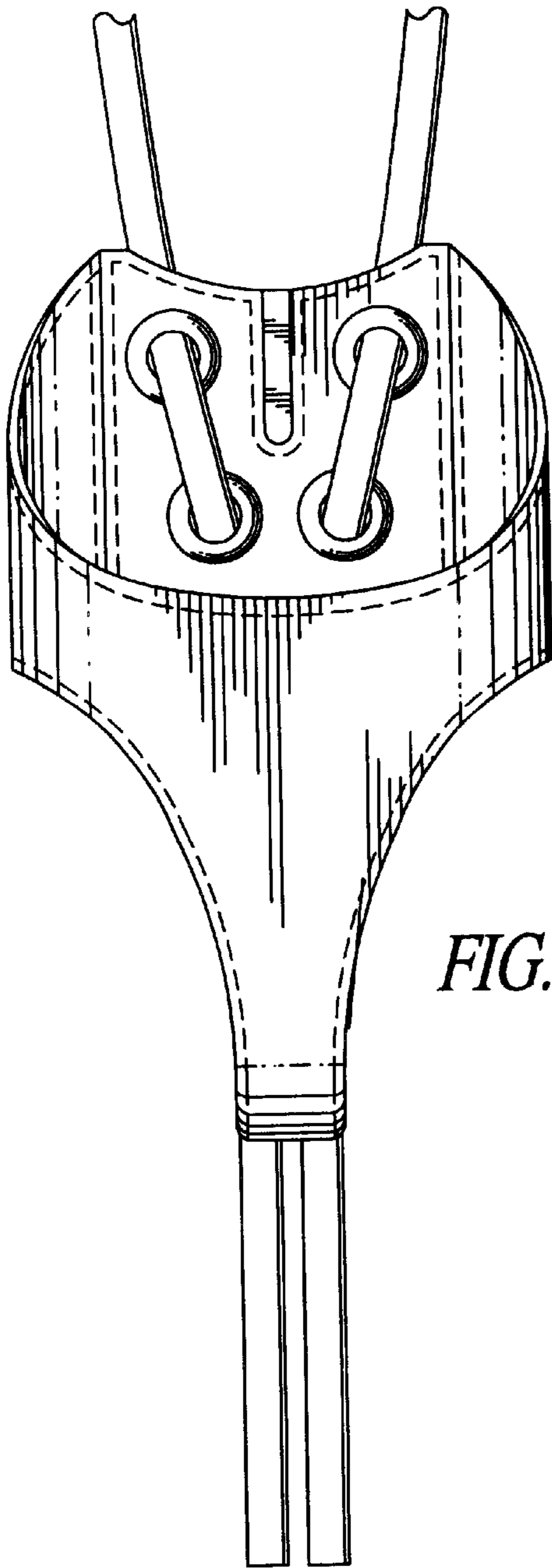

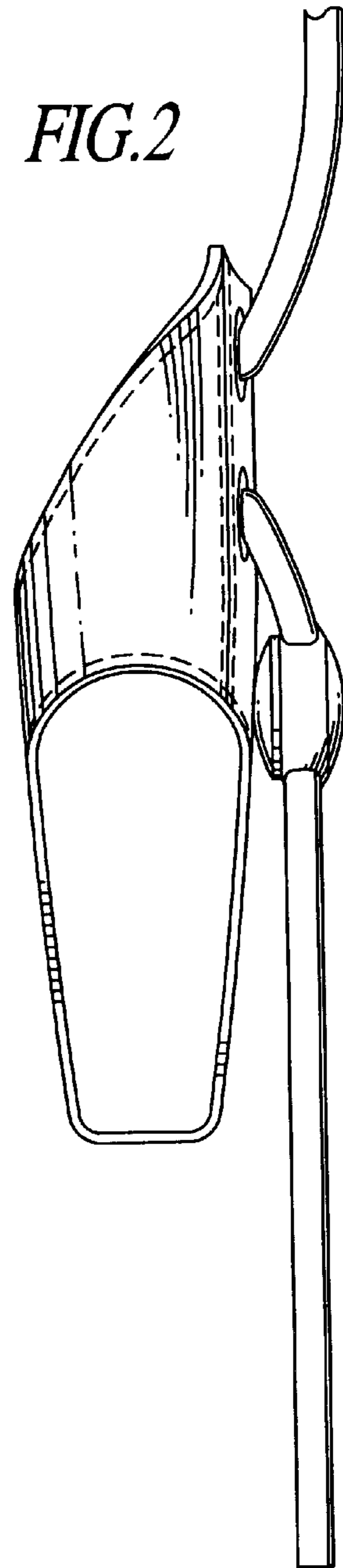
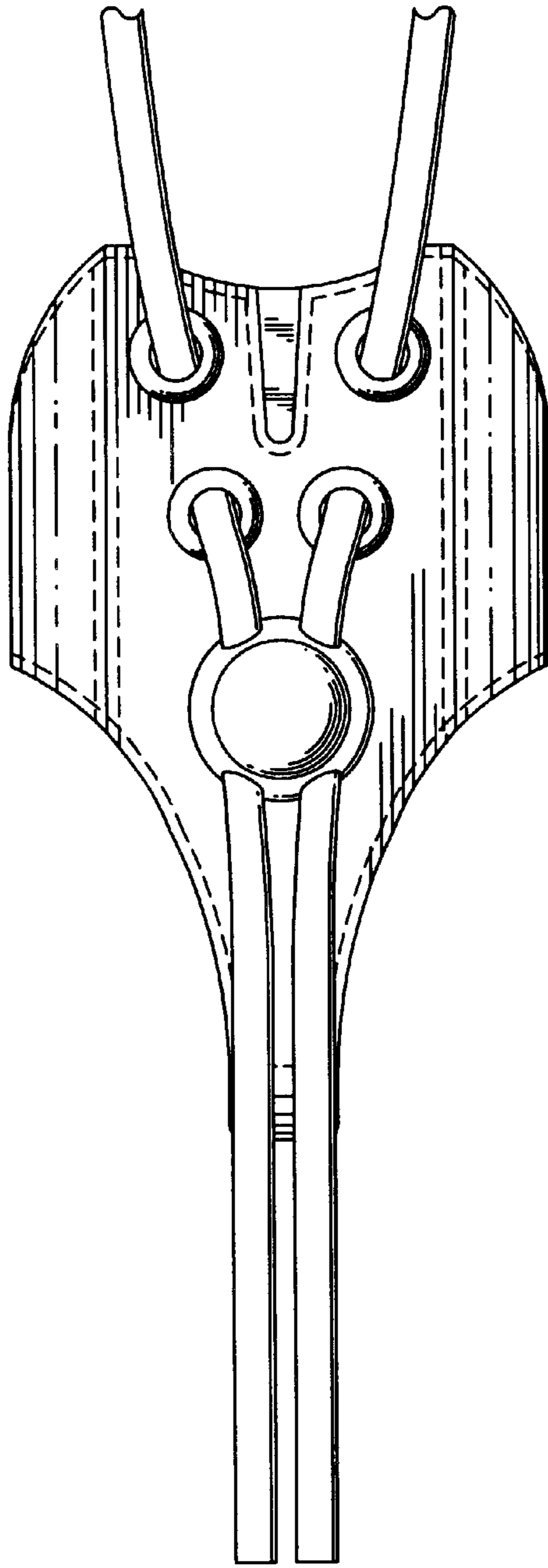
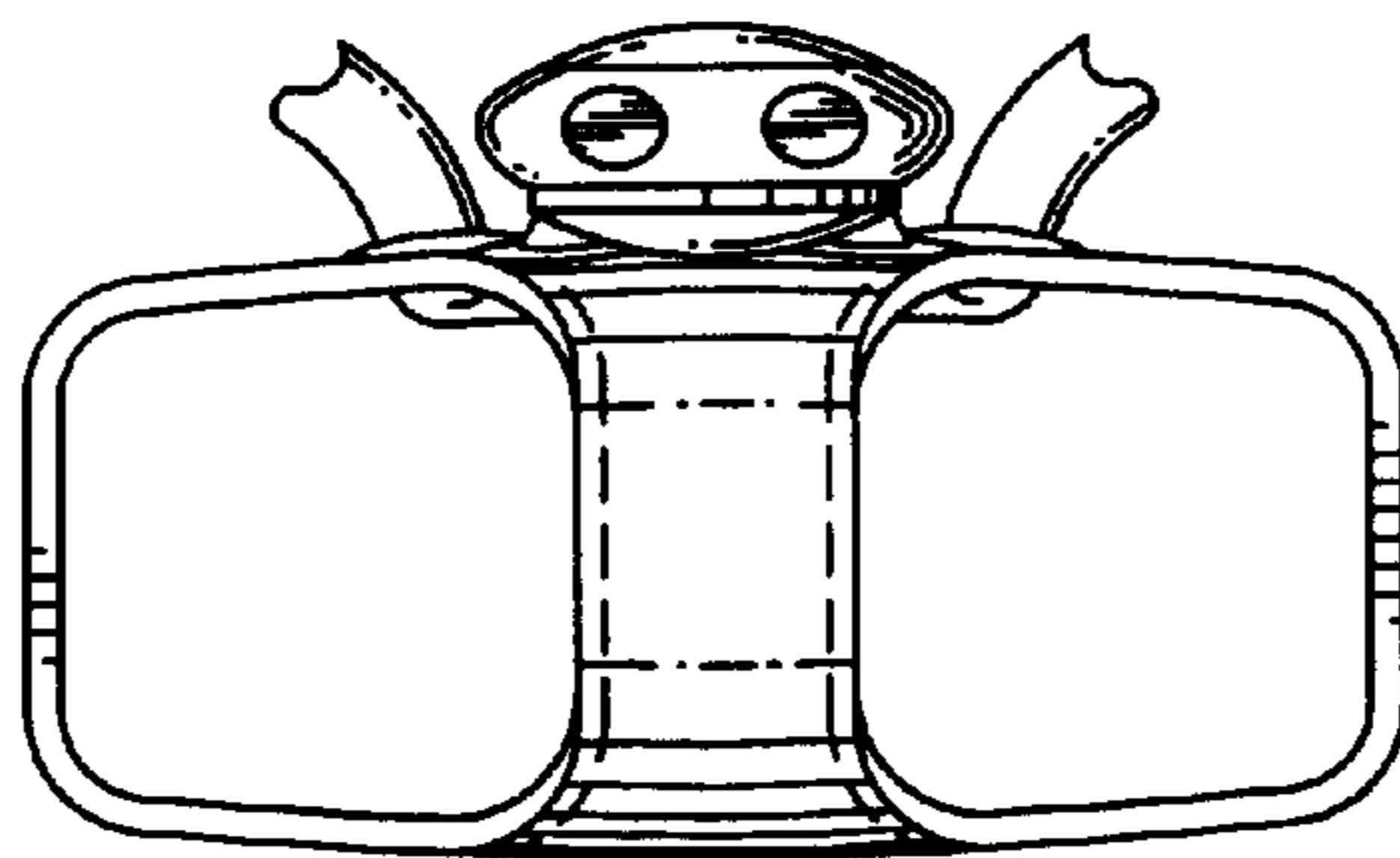

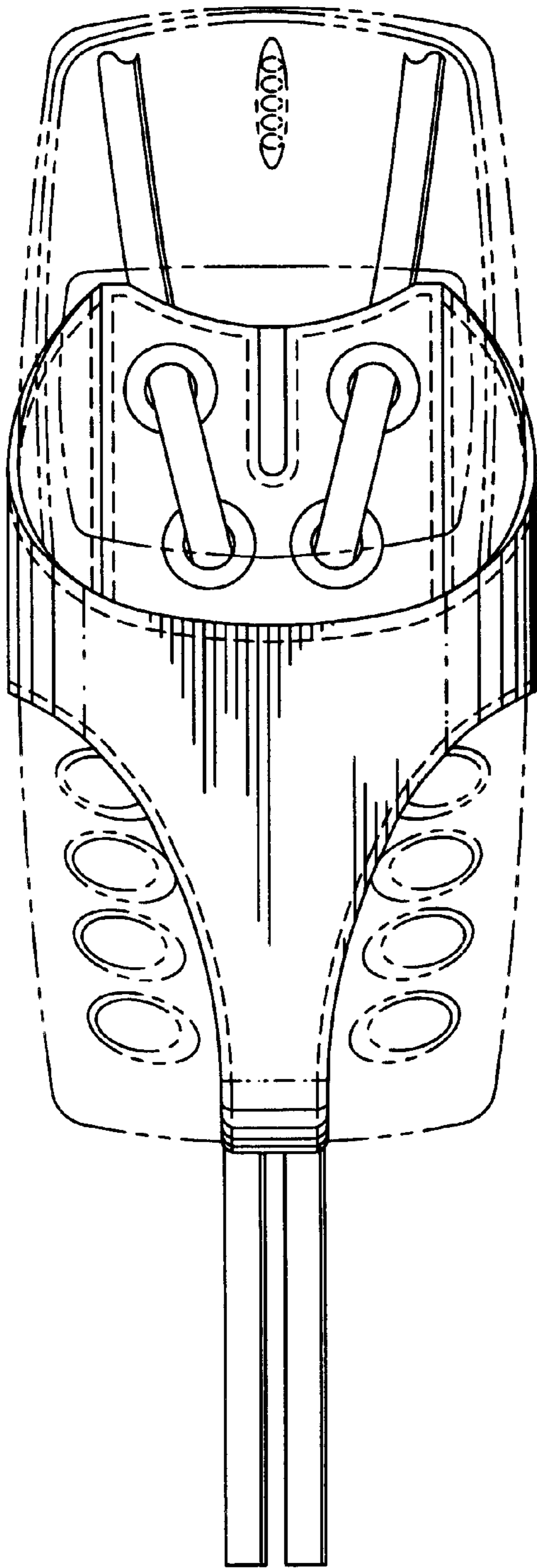

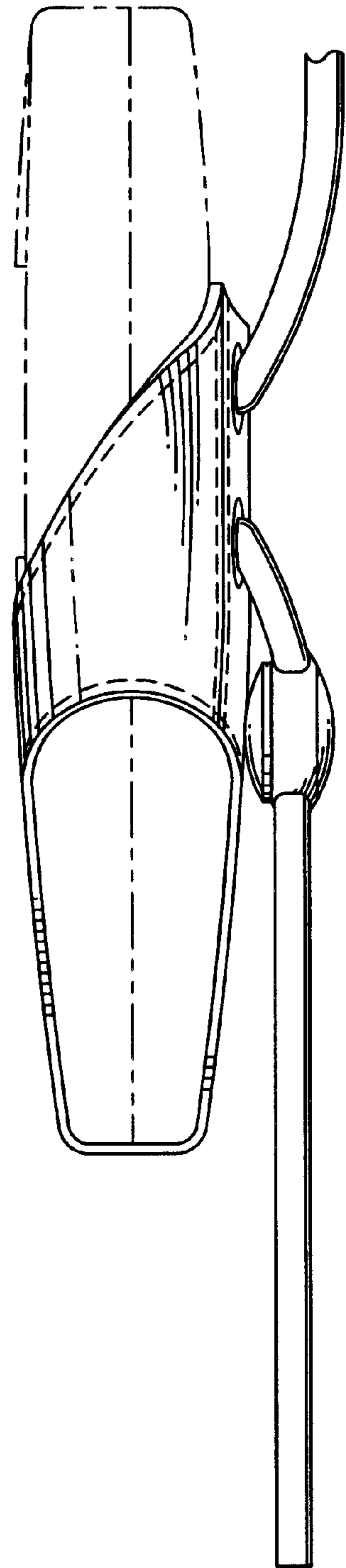
