FIG. 1 is a top view of a DVD holder showing my new design;

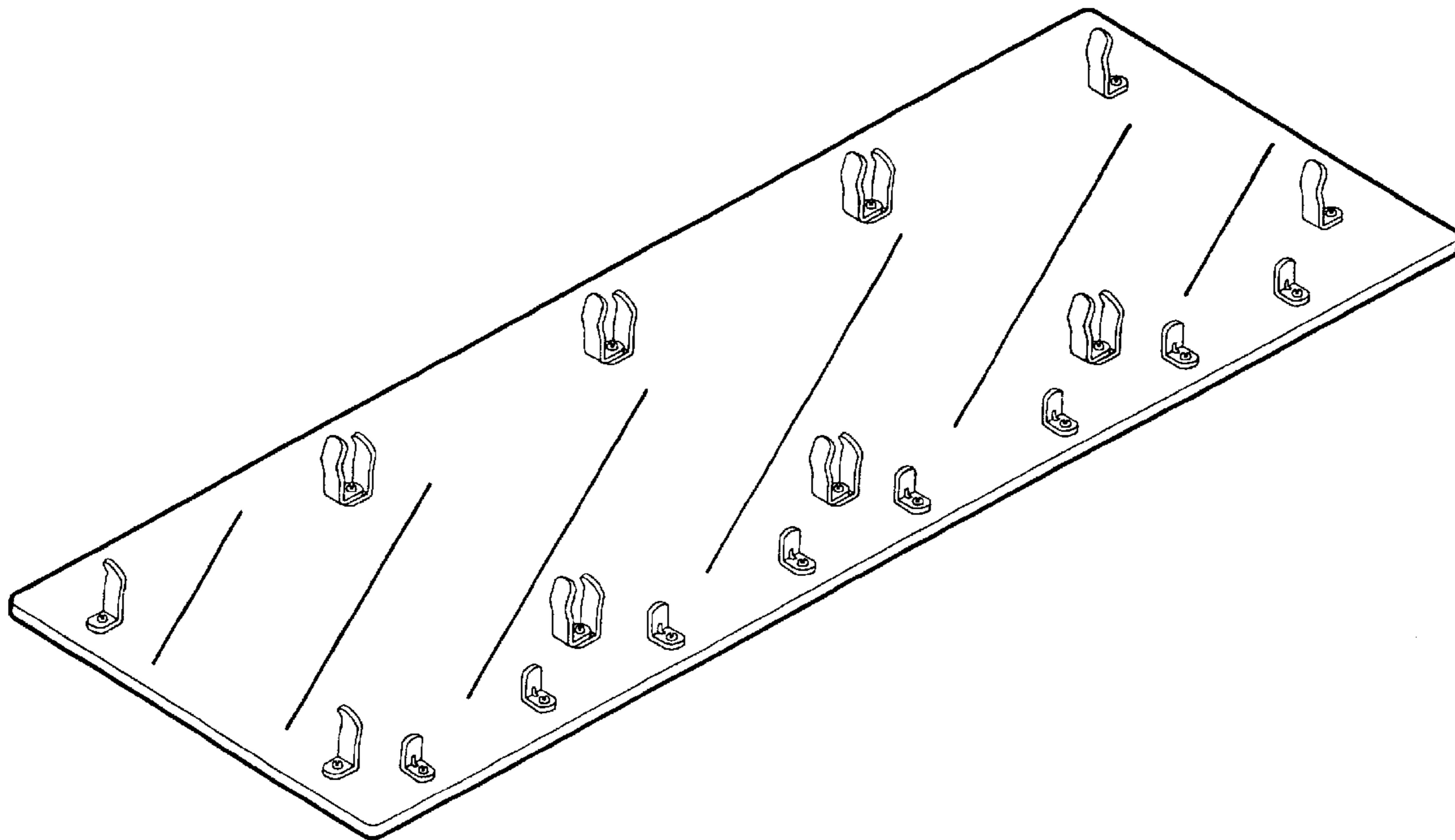
FIG. 2 is an end elevation view thereof, the opposite end view being a mirror image thereof;

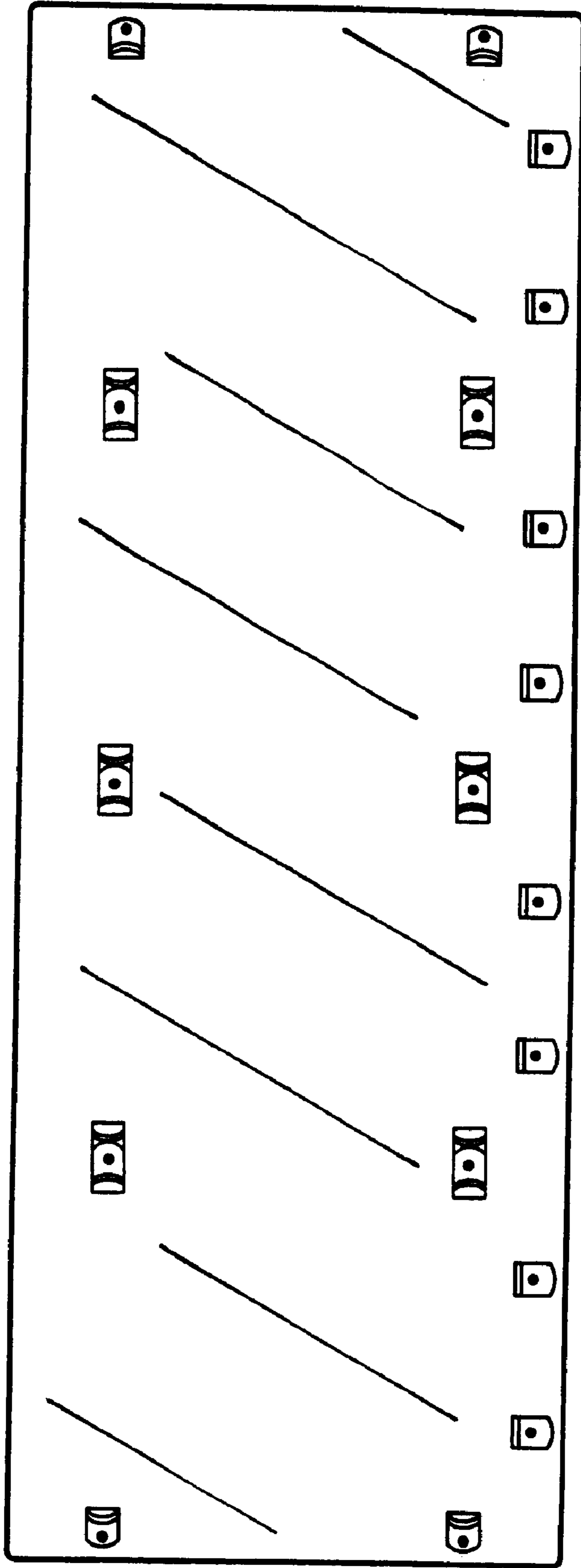

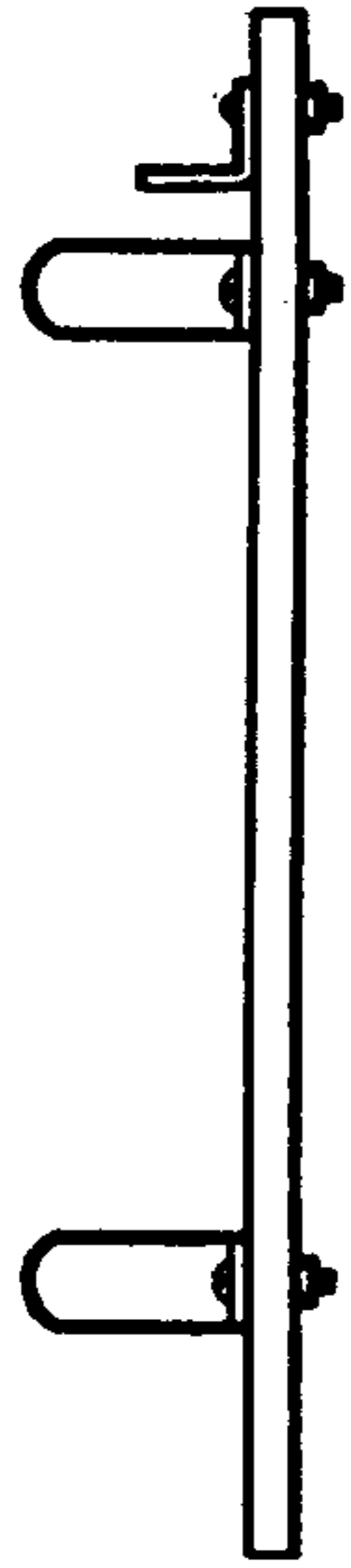

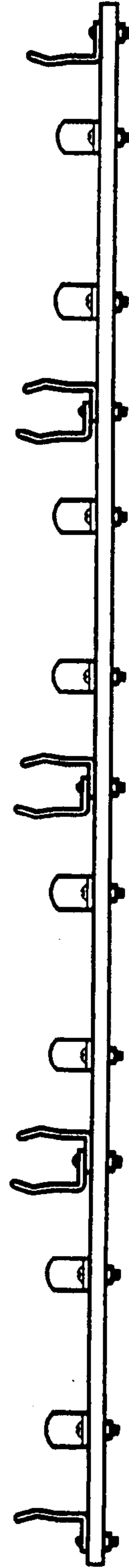

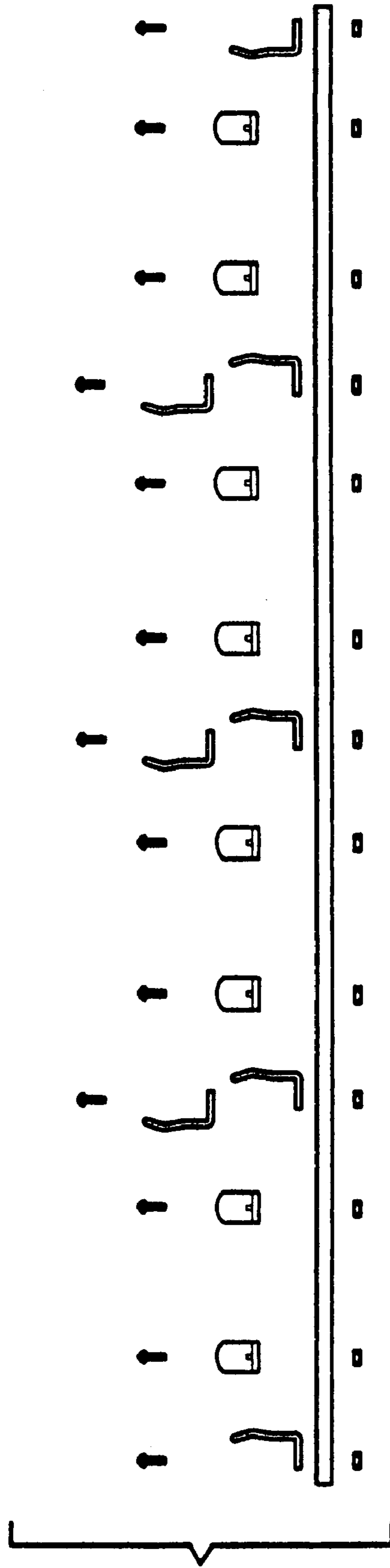

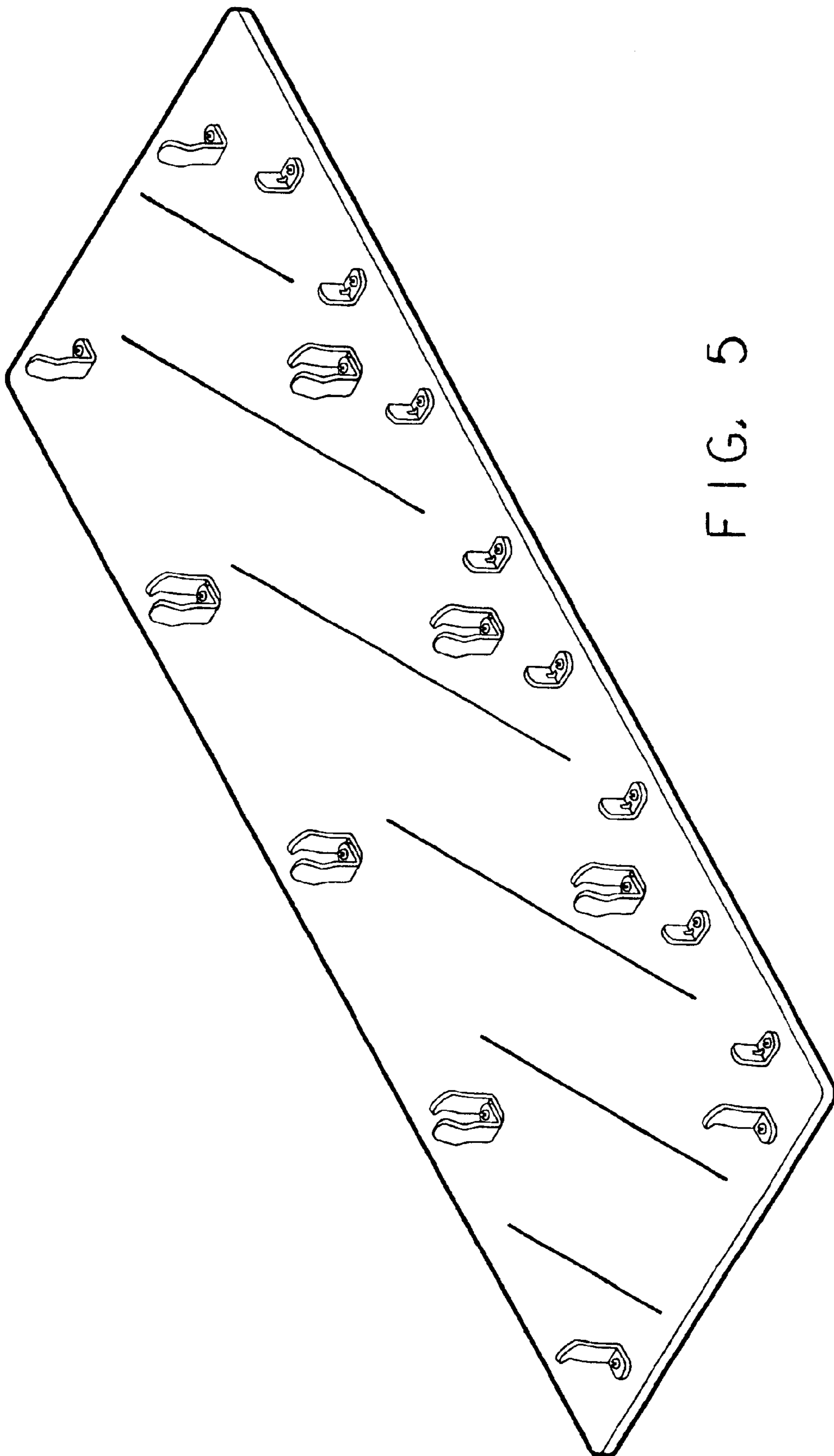
