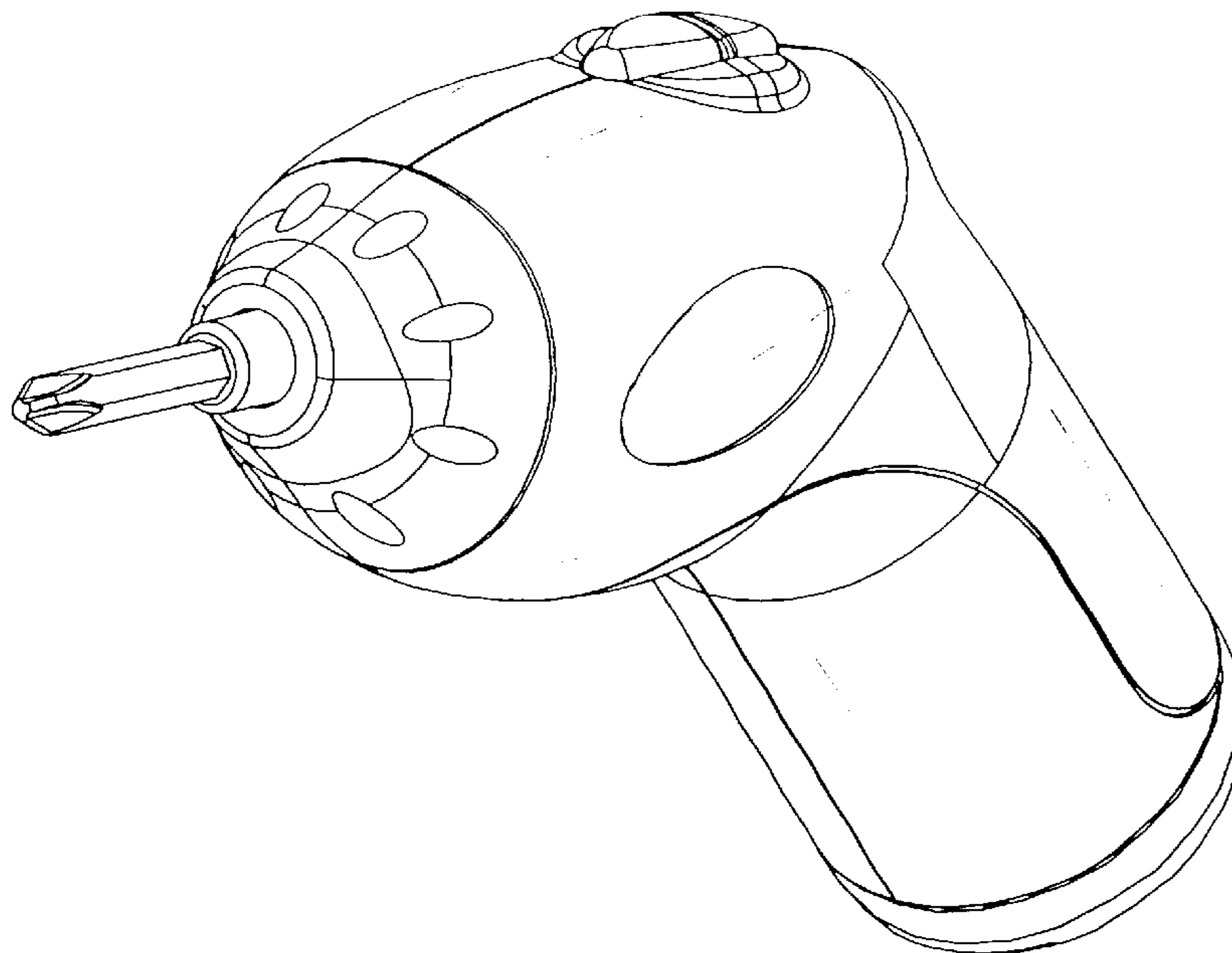
(57) **CLAIM**

The ornamental design for a battery powered screwdriver, as shown and described.

DESCRIPTION

FIG. 1 is a right side isometric view of a battery powered screwdriver showing our new design; FIG. 2 is a left side isometric view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a right side elevational view thereof, the left side being a mirror image; FIG. 5 is a bottom plan view thereof; FIG. 6 is a front elevational view thereof; and, FIG. 7 is a rear elevational view thereof.

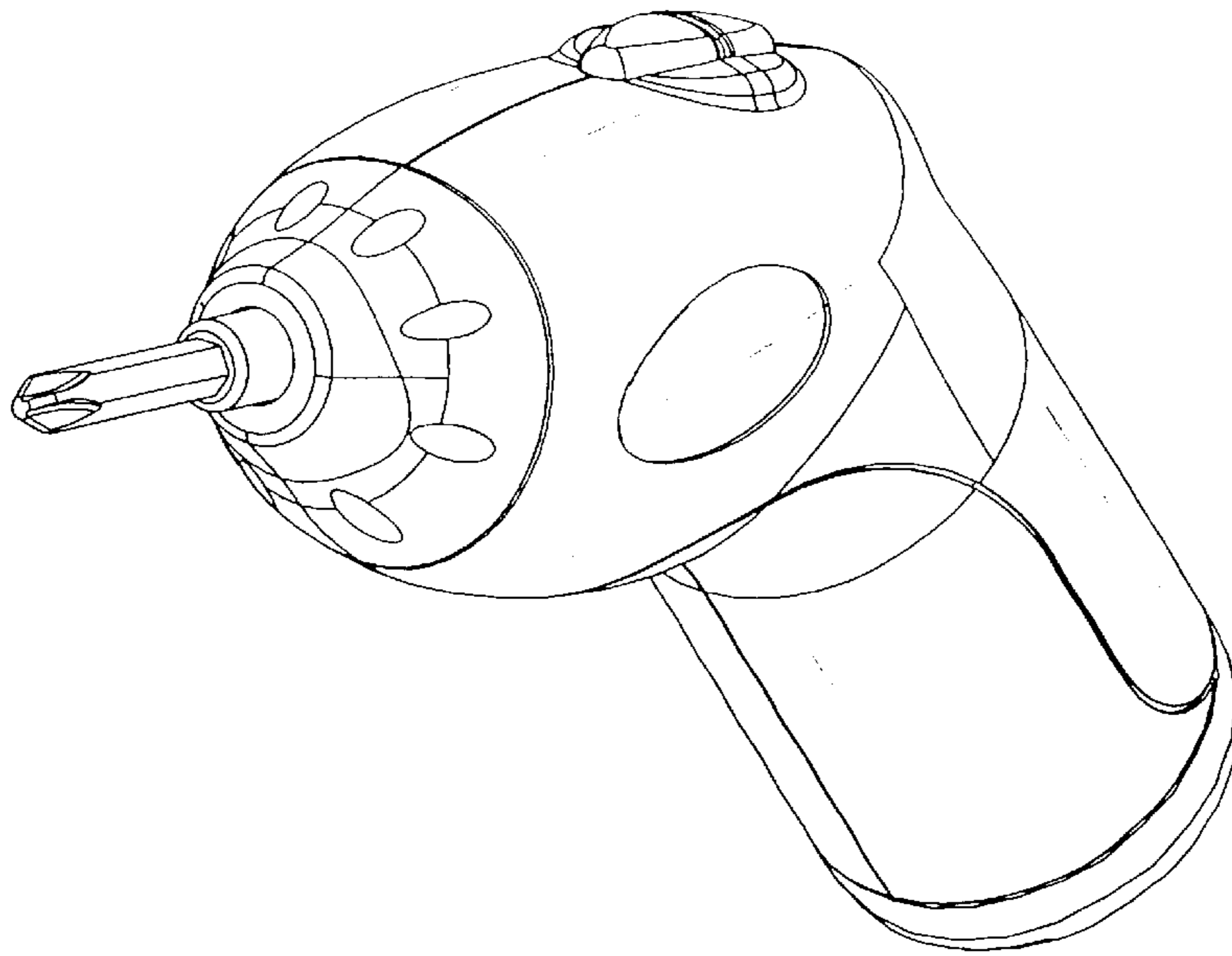

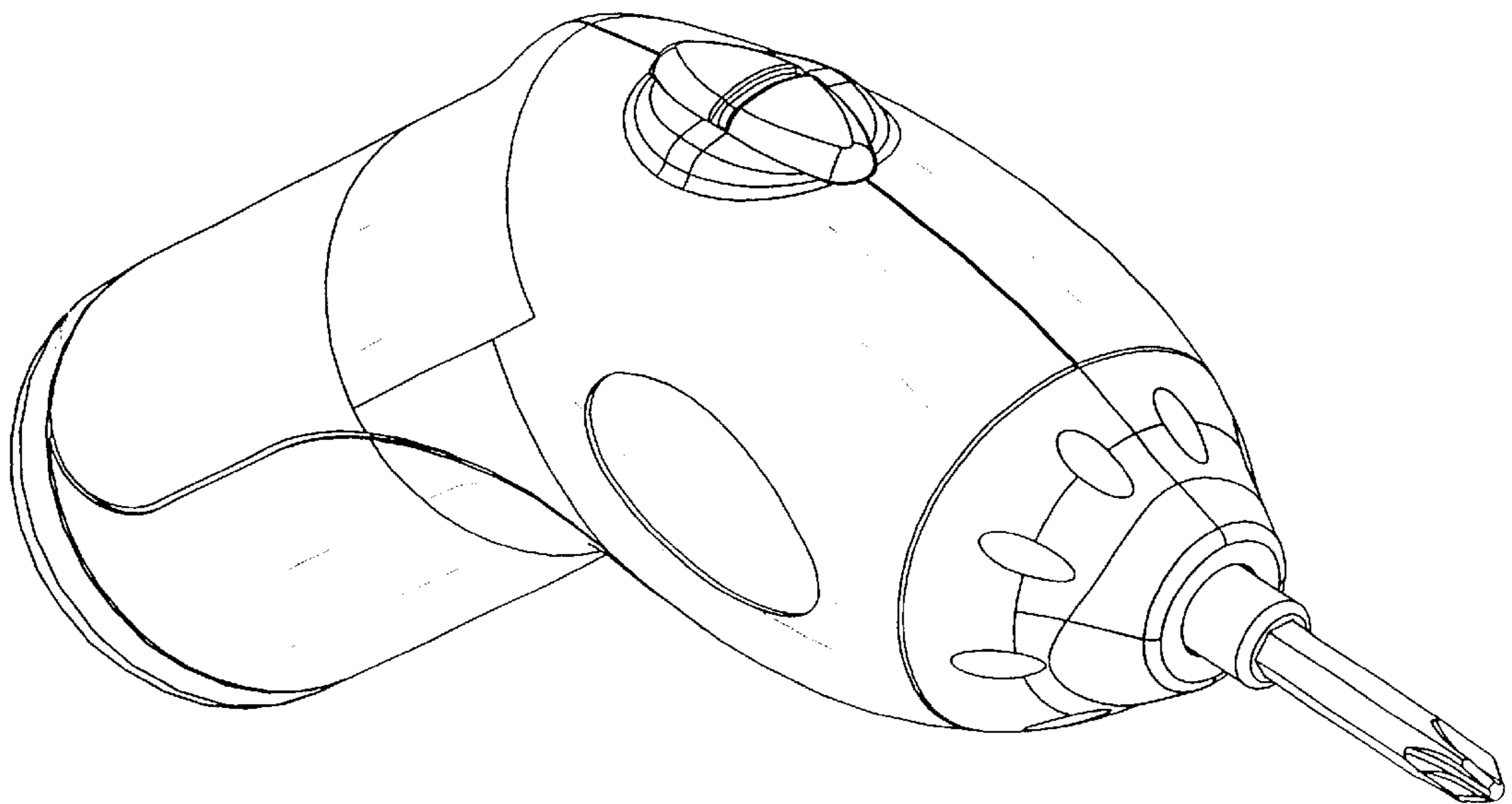

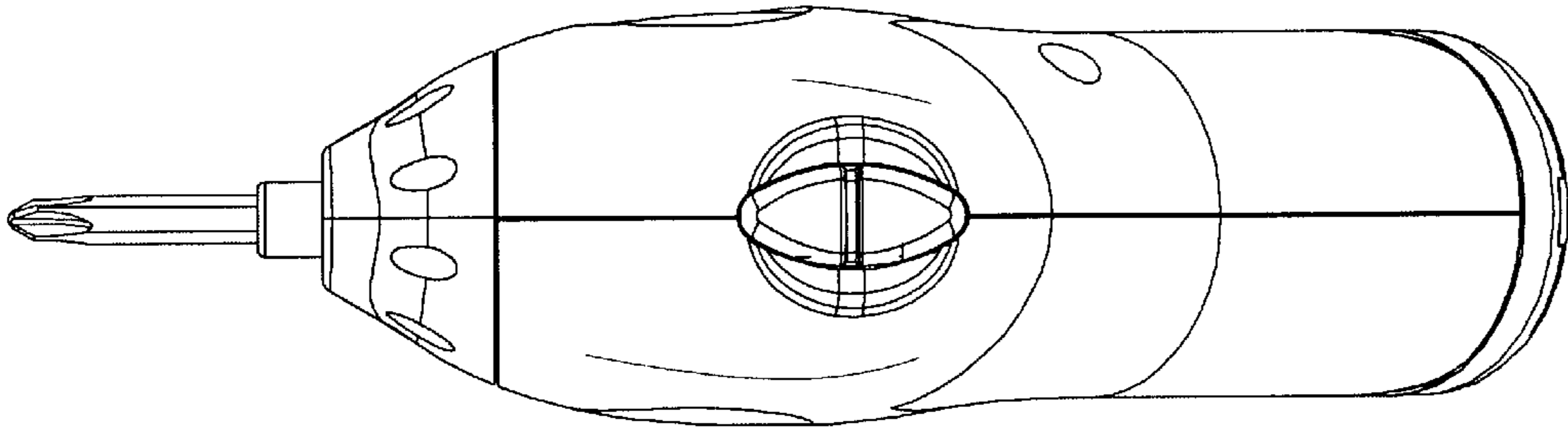

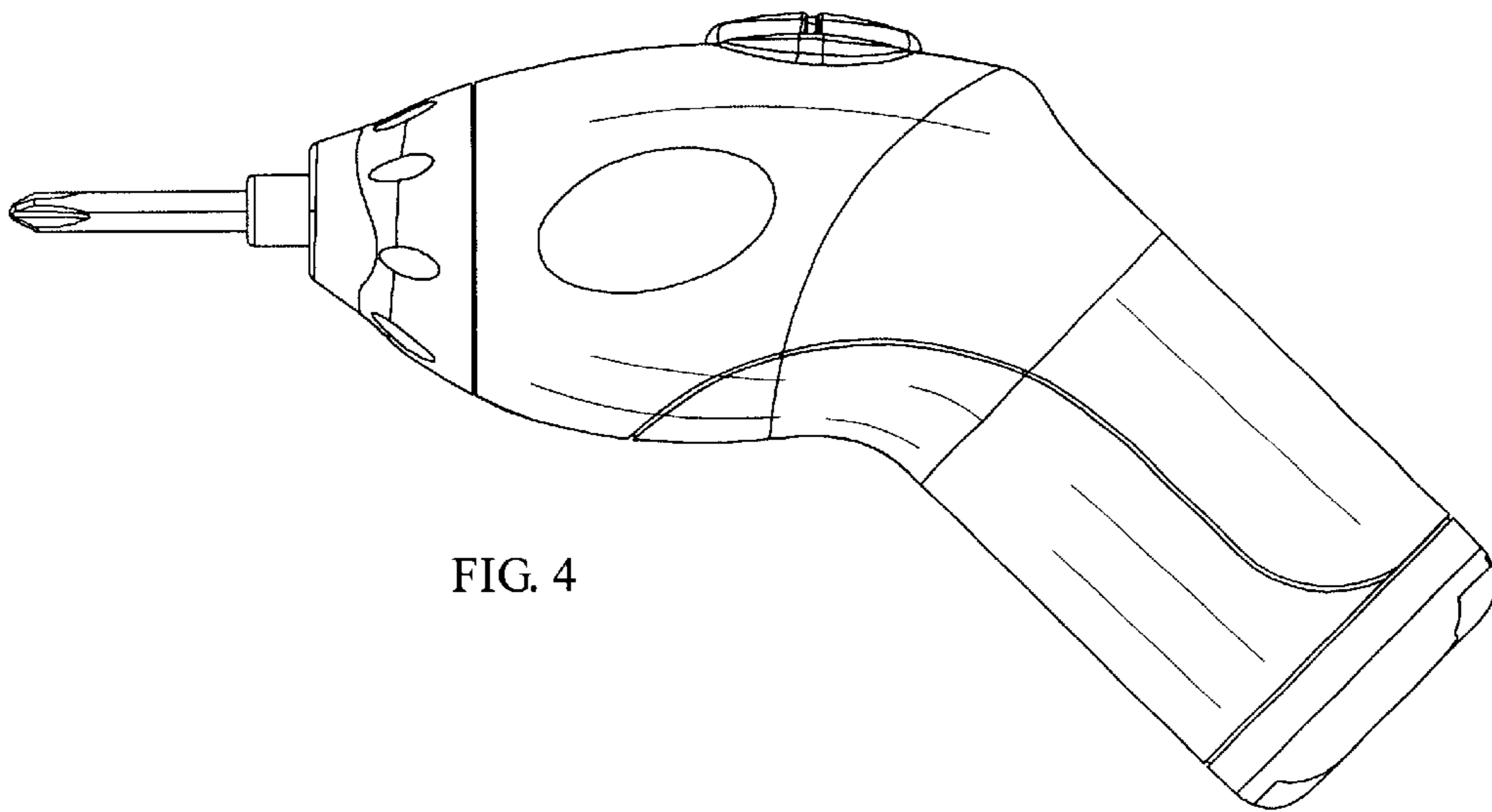
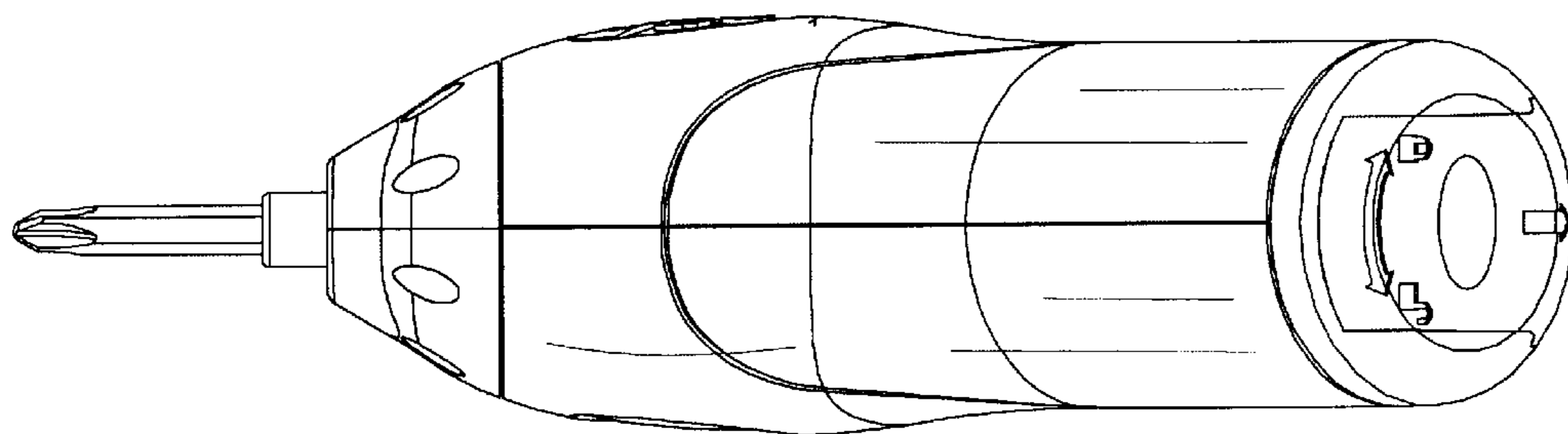

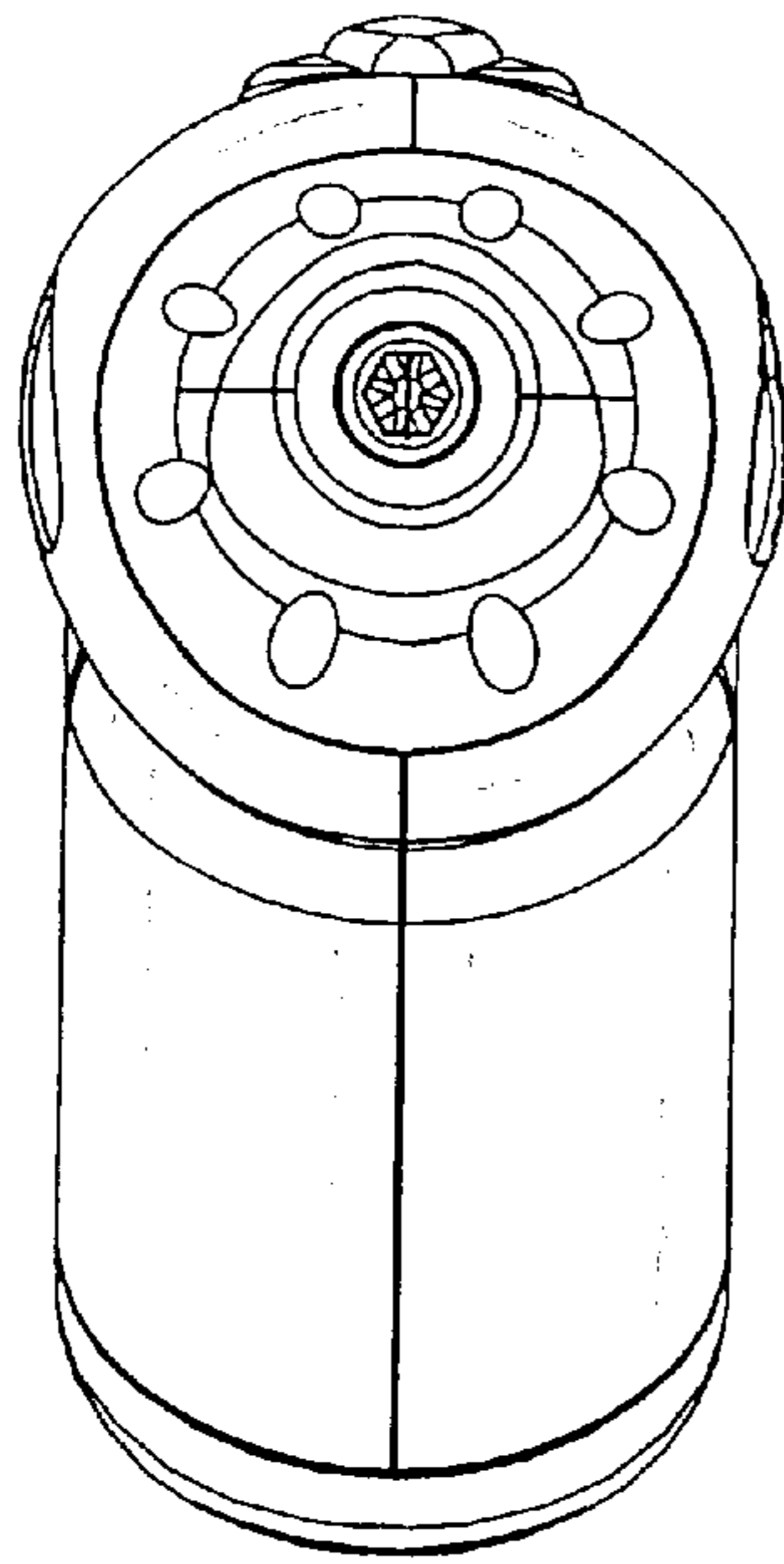

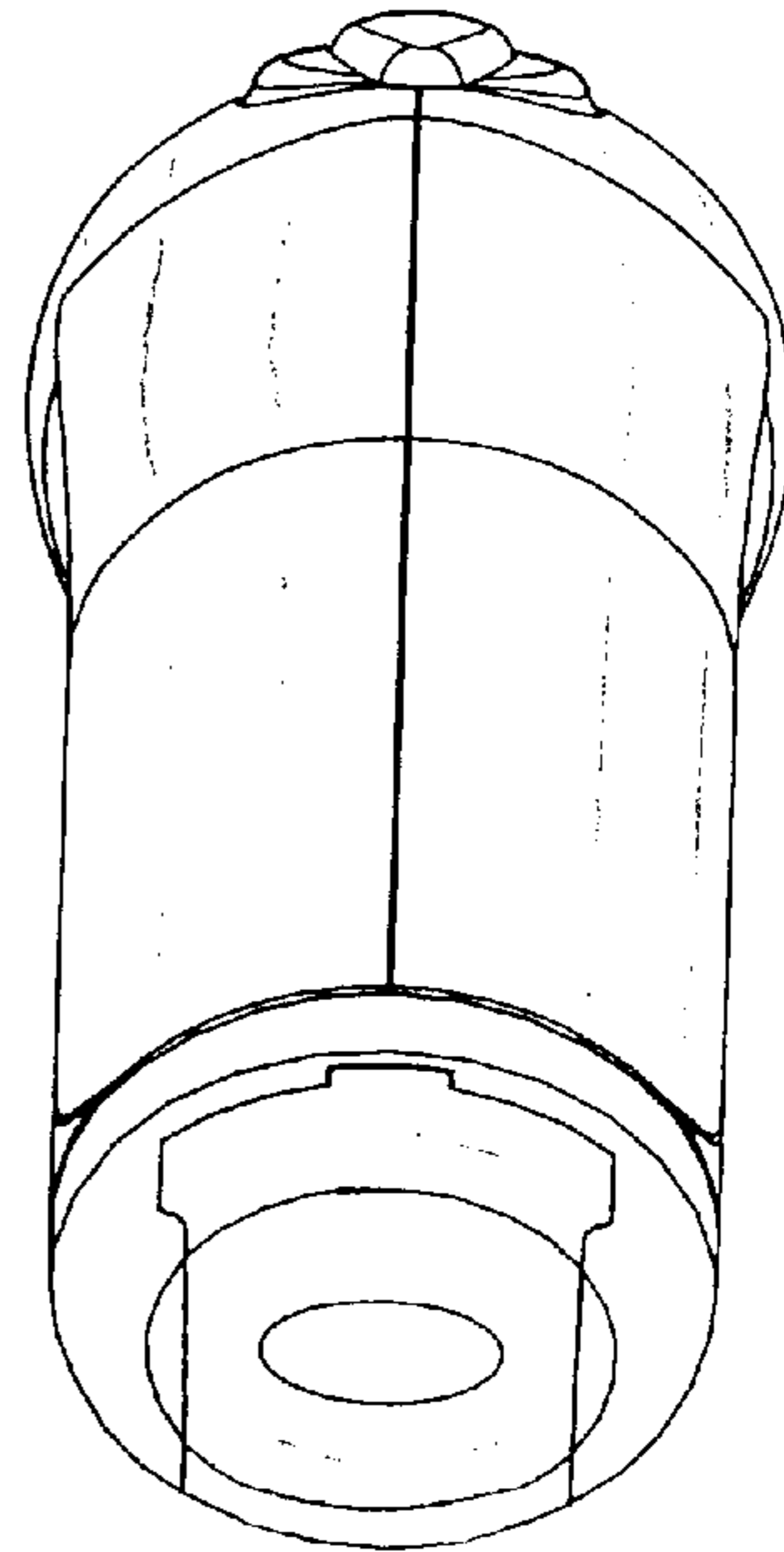
