**DESCRIPTION**

FIG. 1 is a perspective view of a speaker box showing my new design;

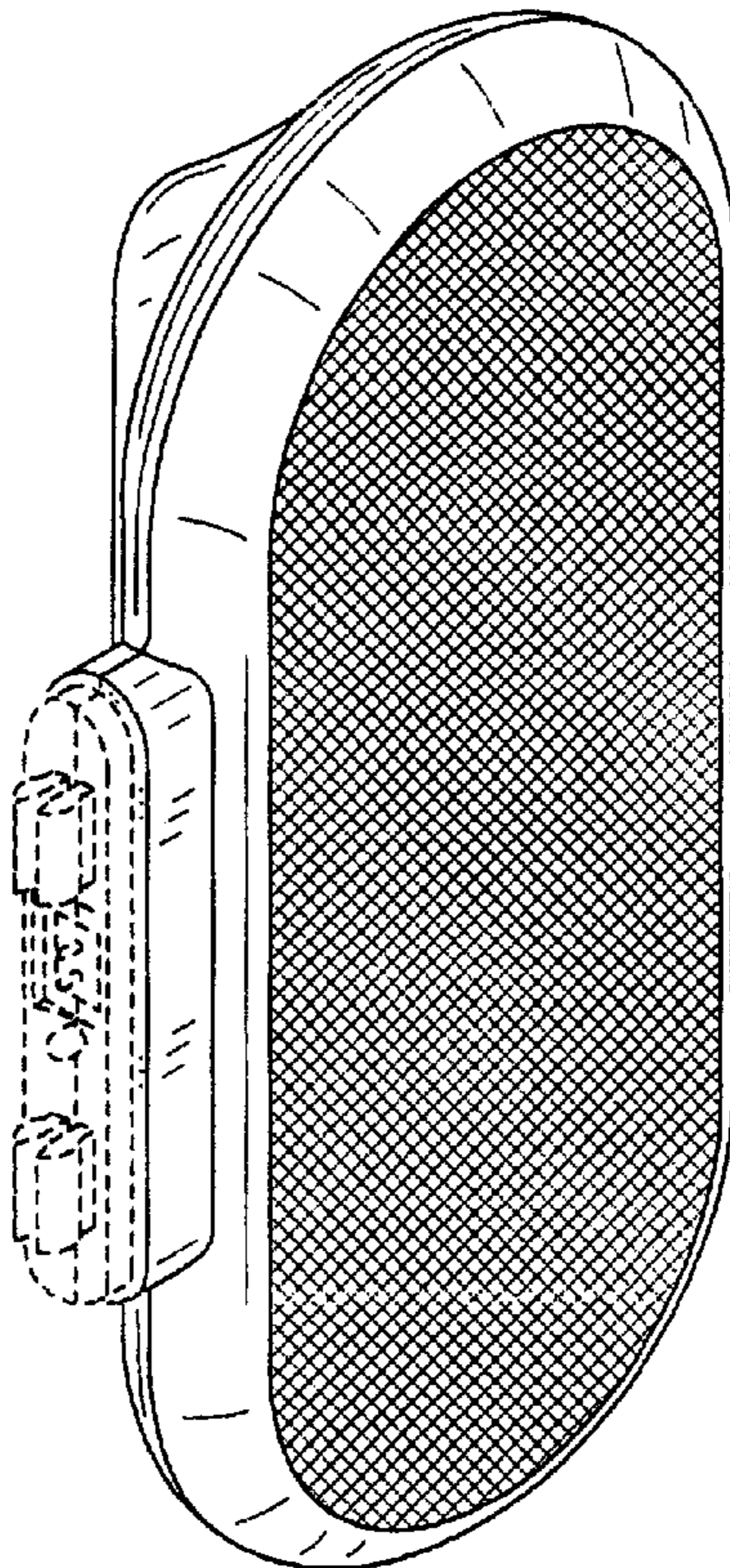

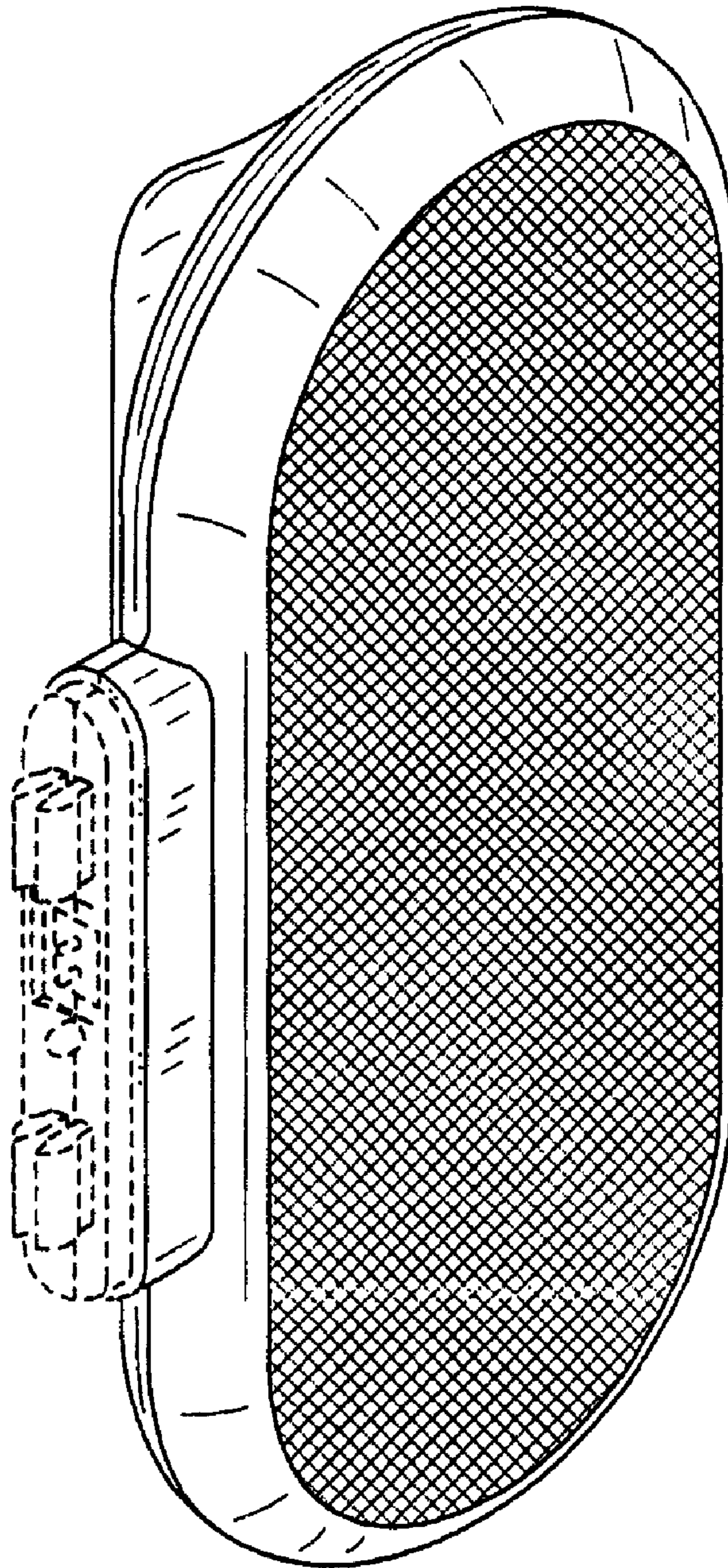

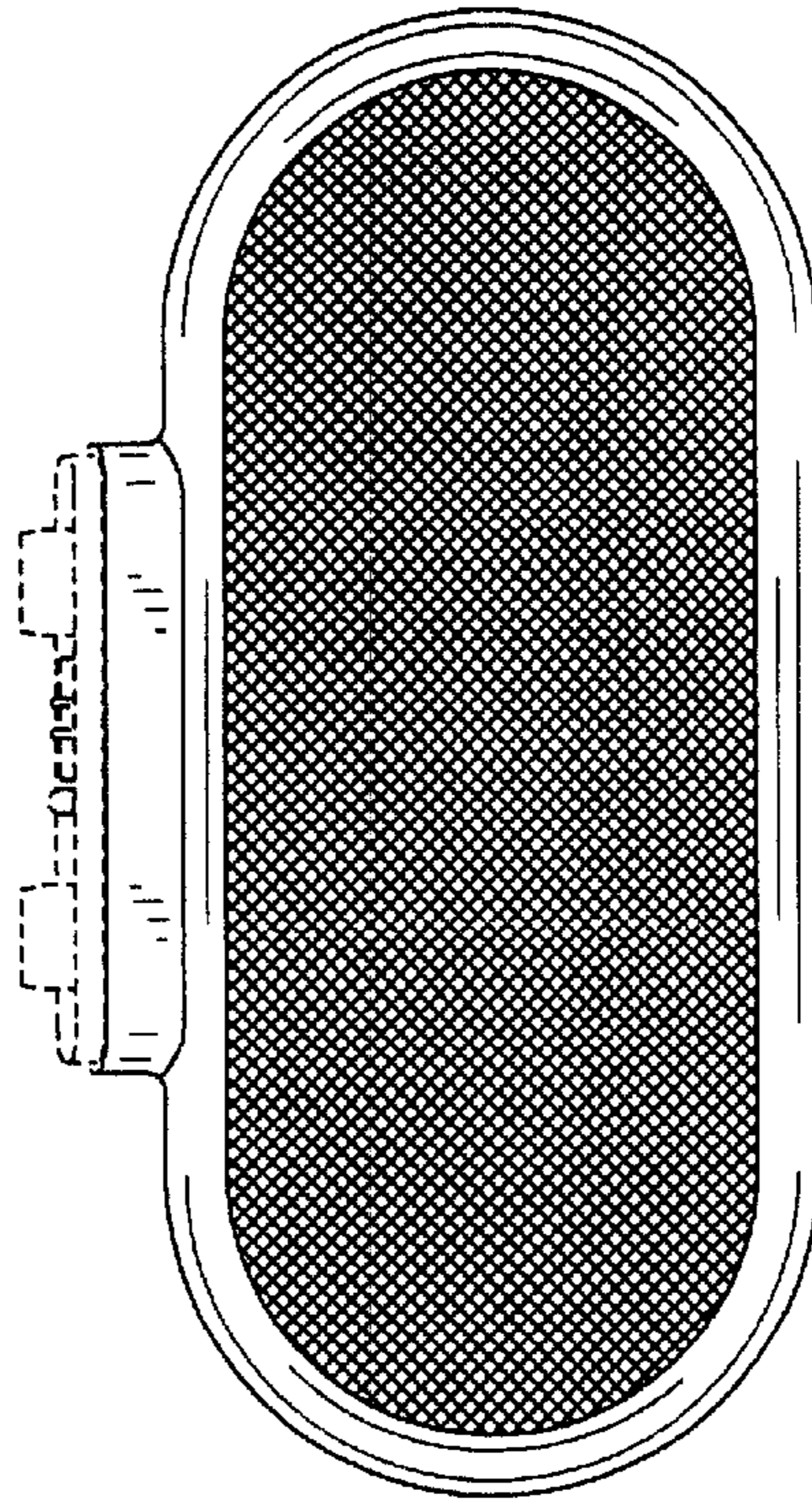

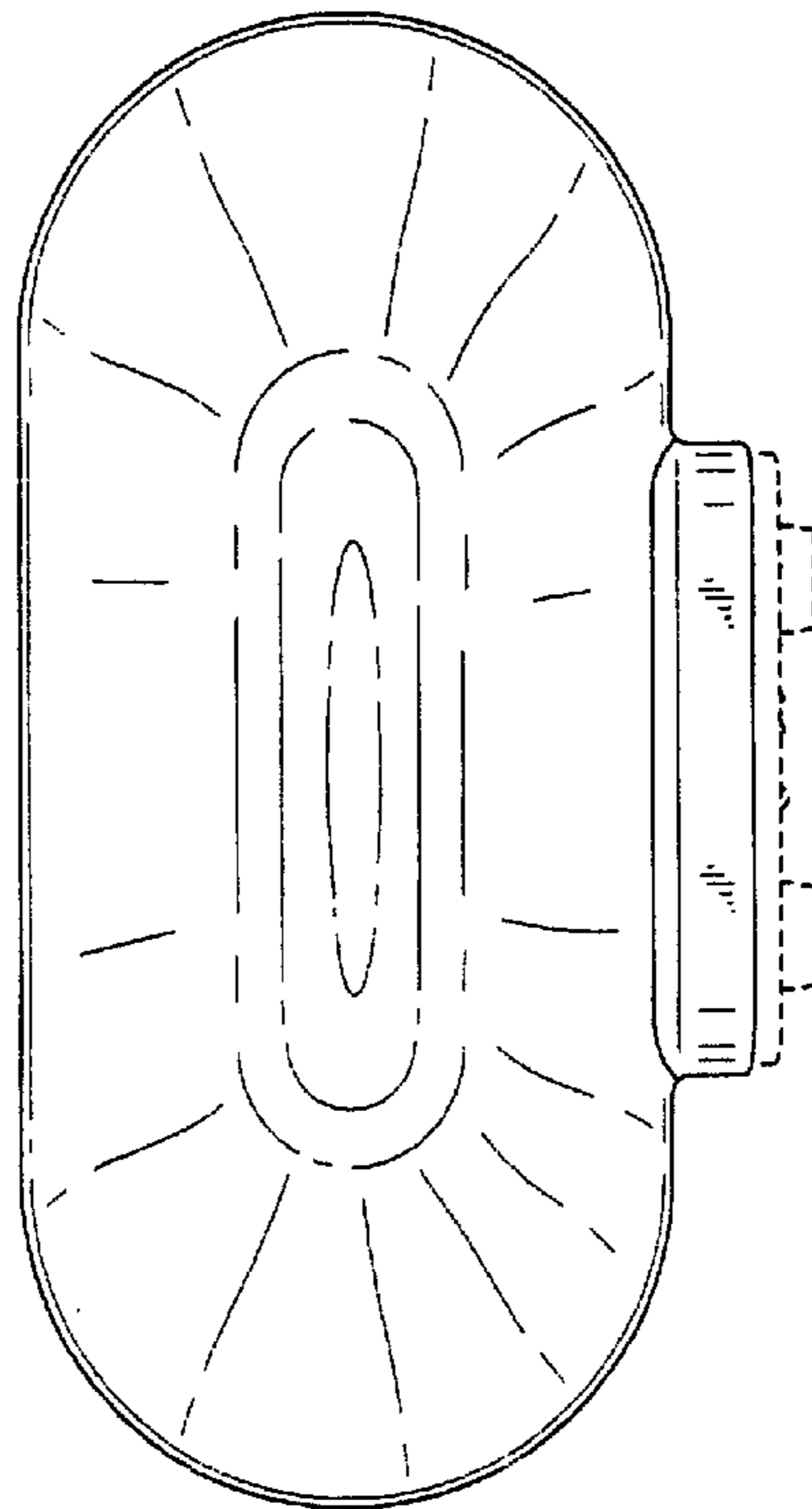

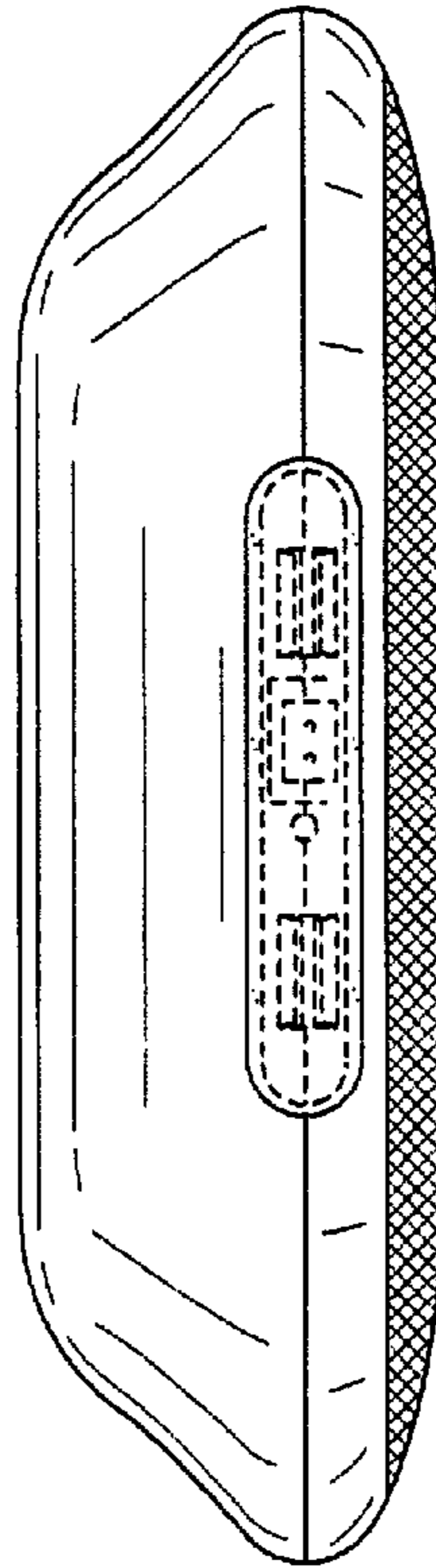

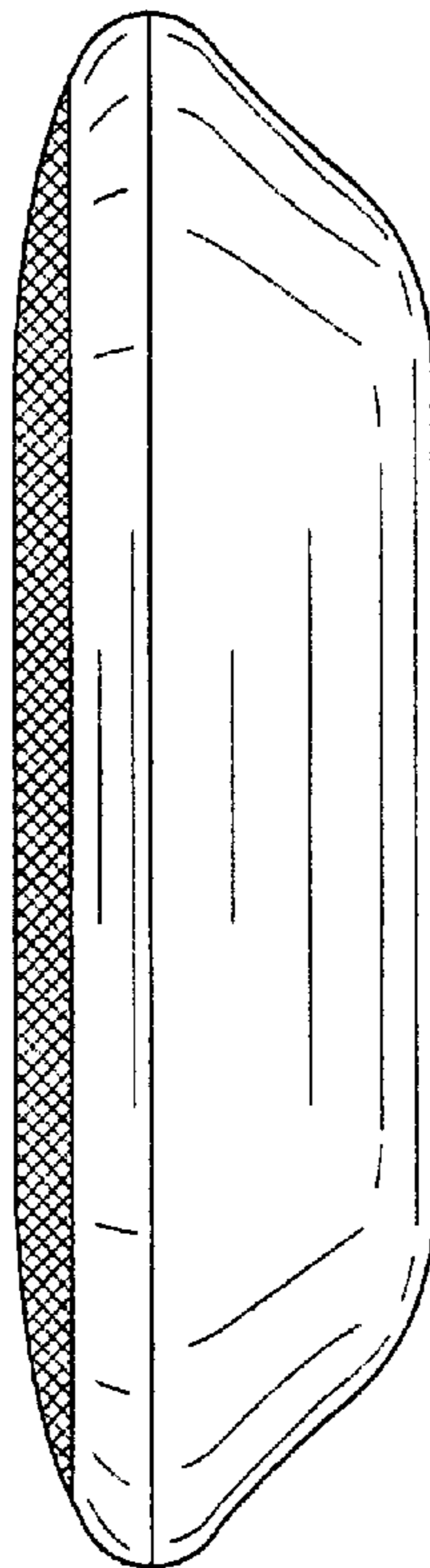

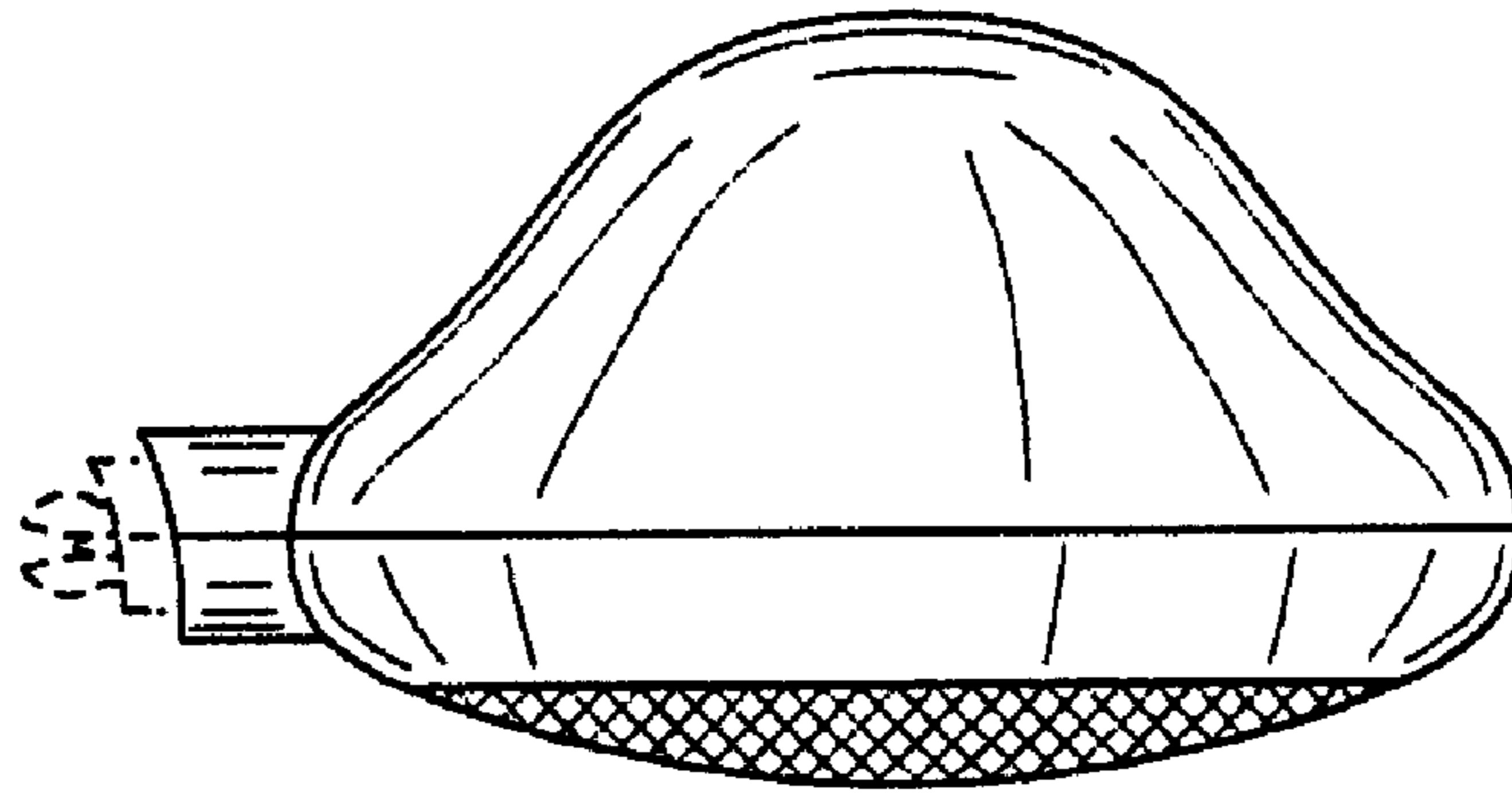
