The ornamental design for a portion of a golf club head, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a portion of a club head for a putter showing my new design;

FIG. 2 is a top view thereof;

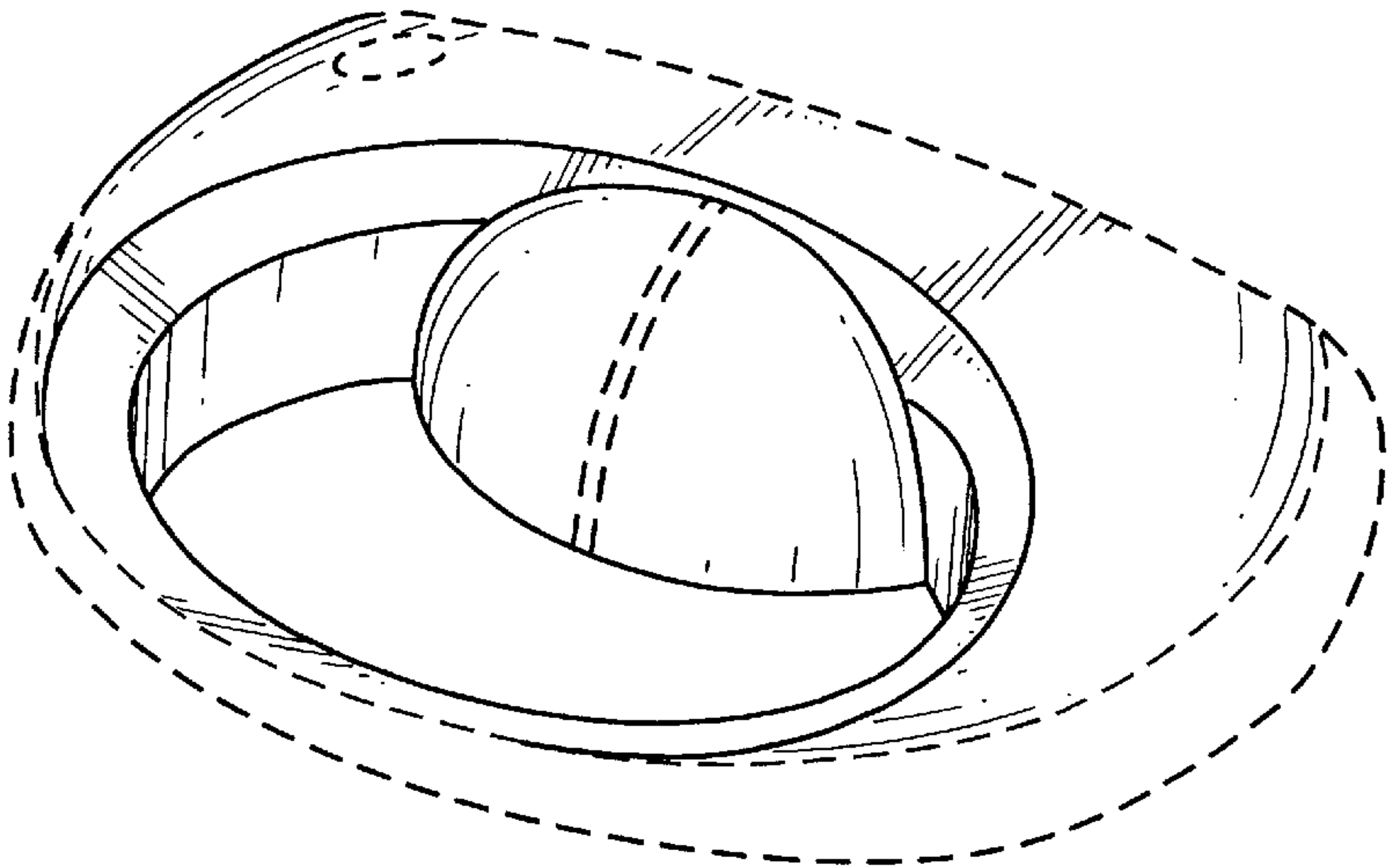
FIG. 3 is a heel side view thereof;

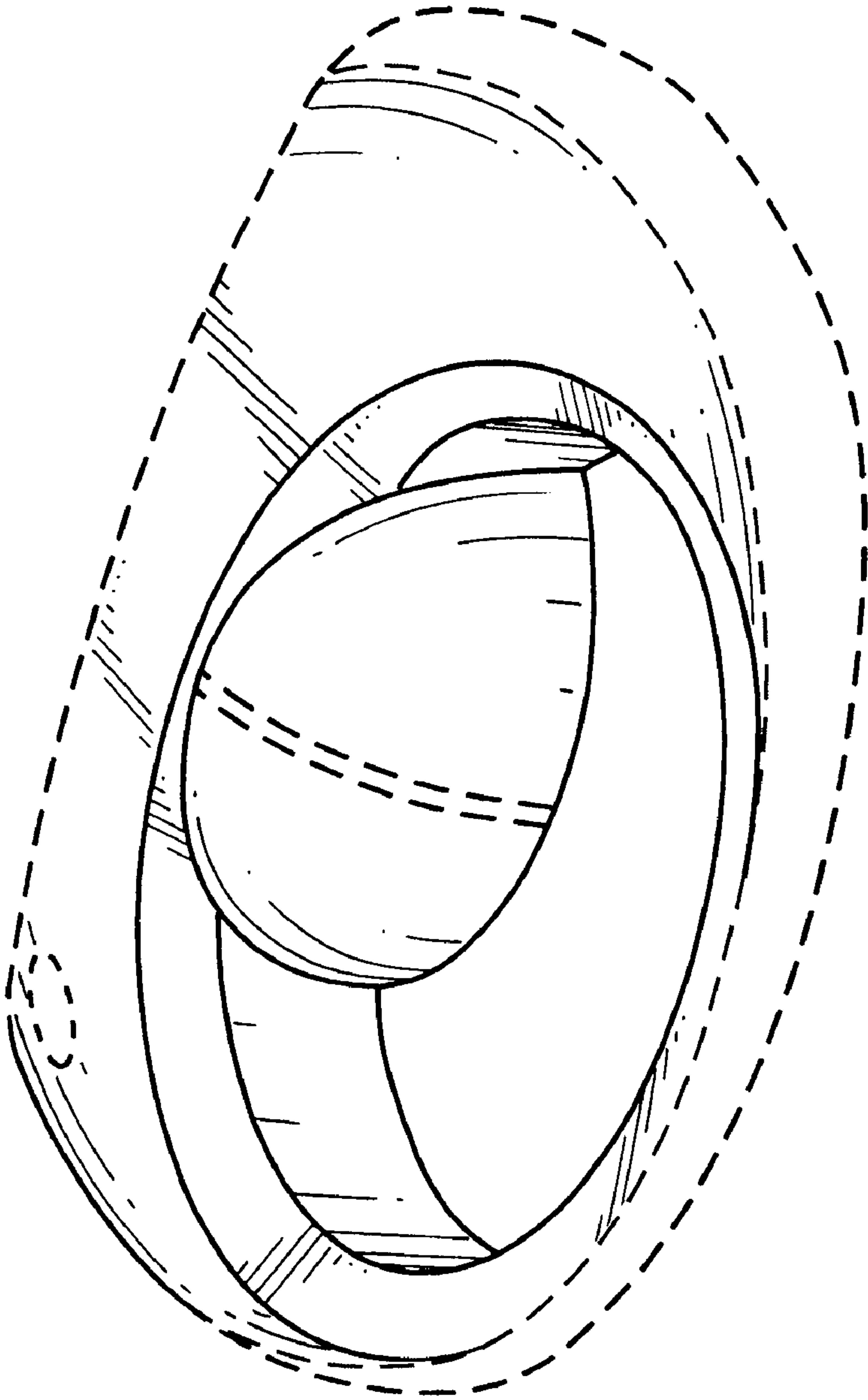

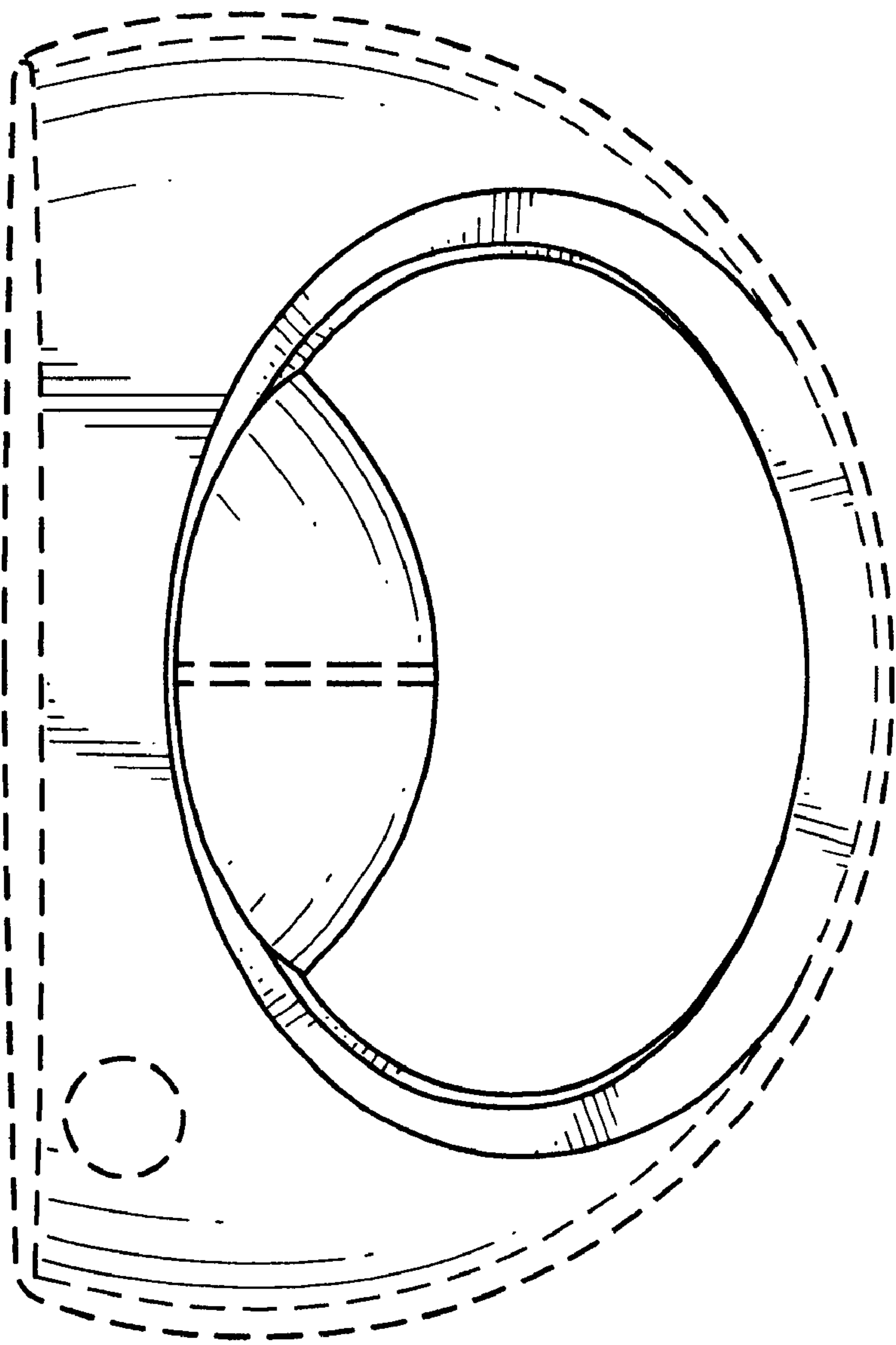

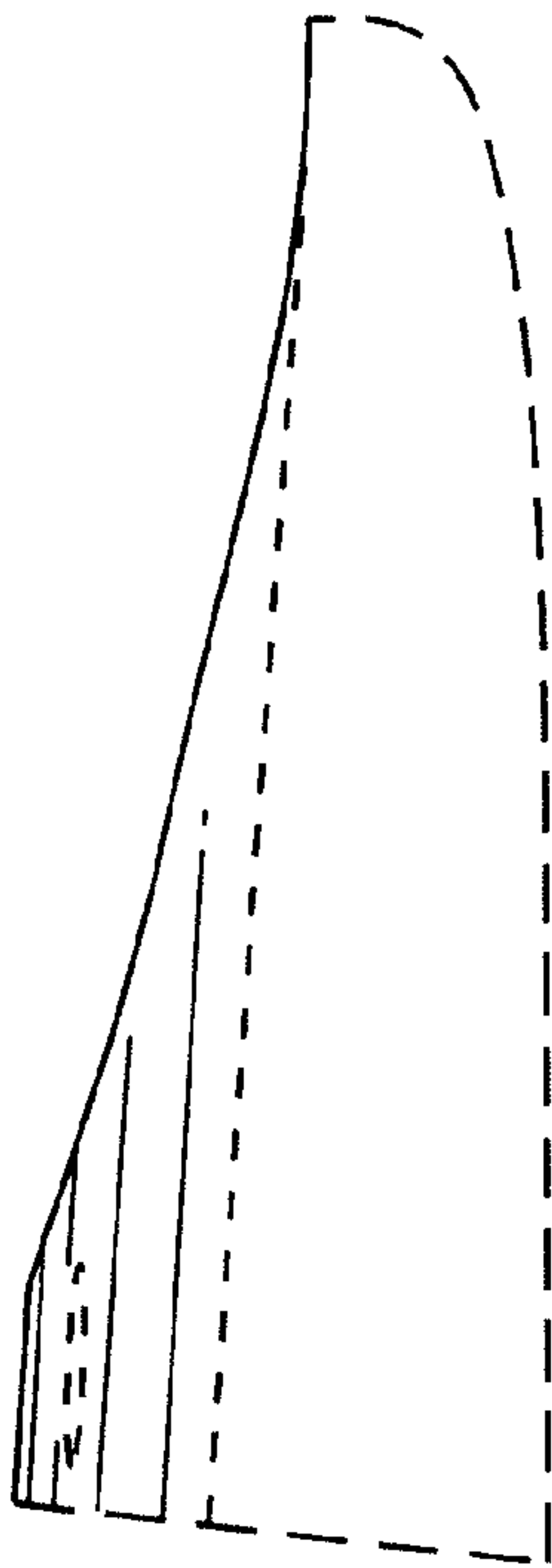

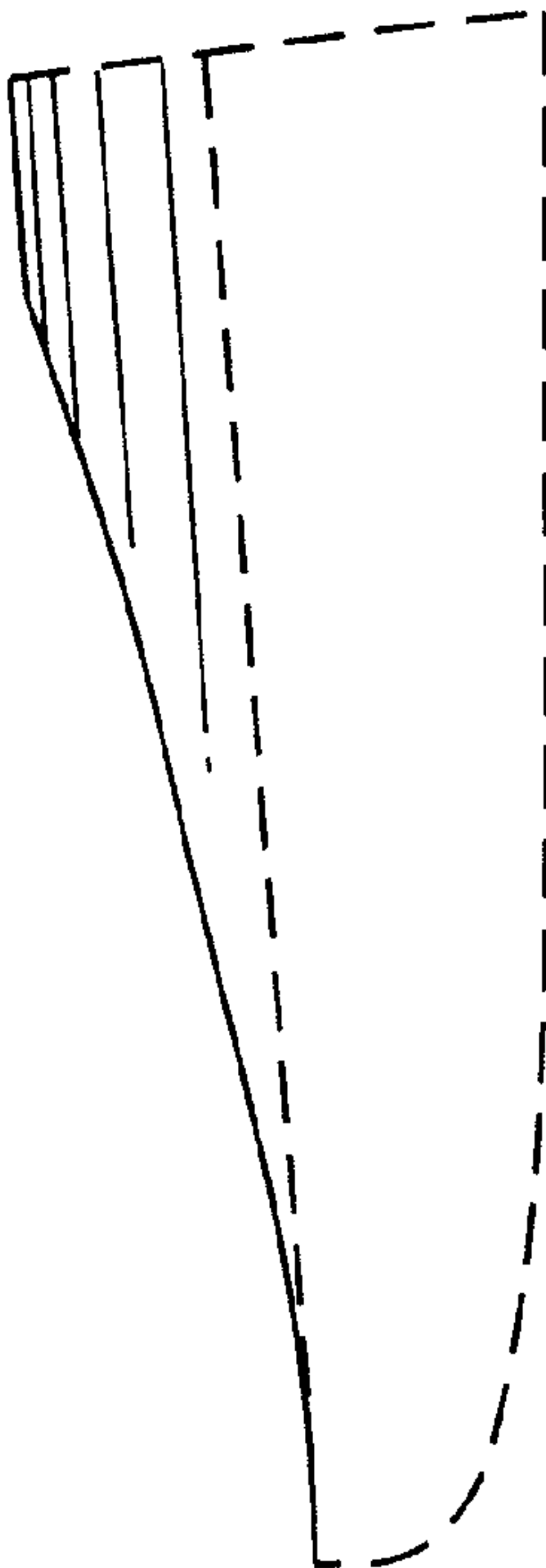

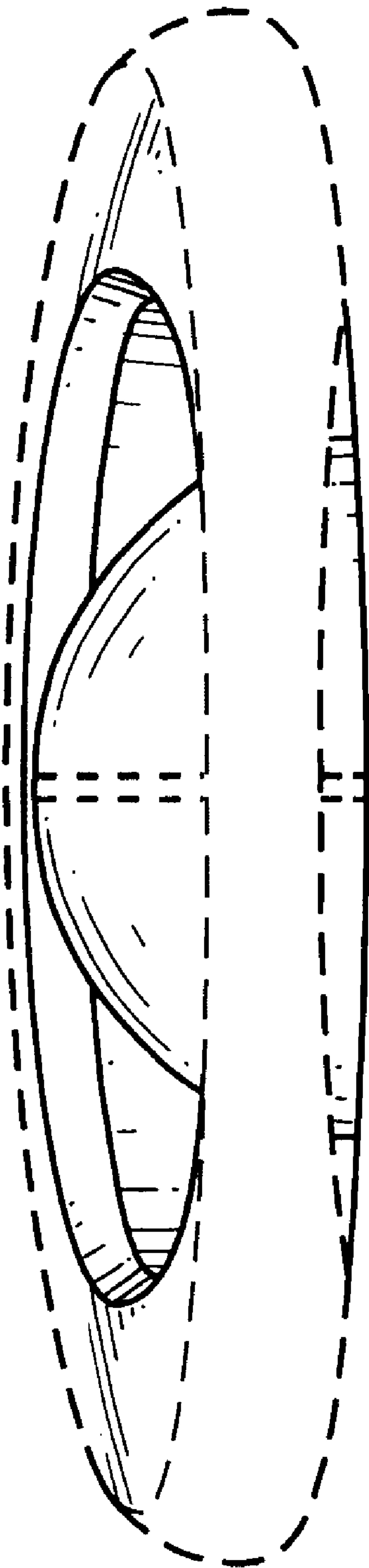
