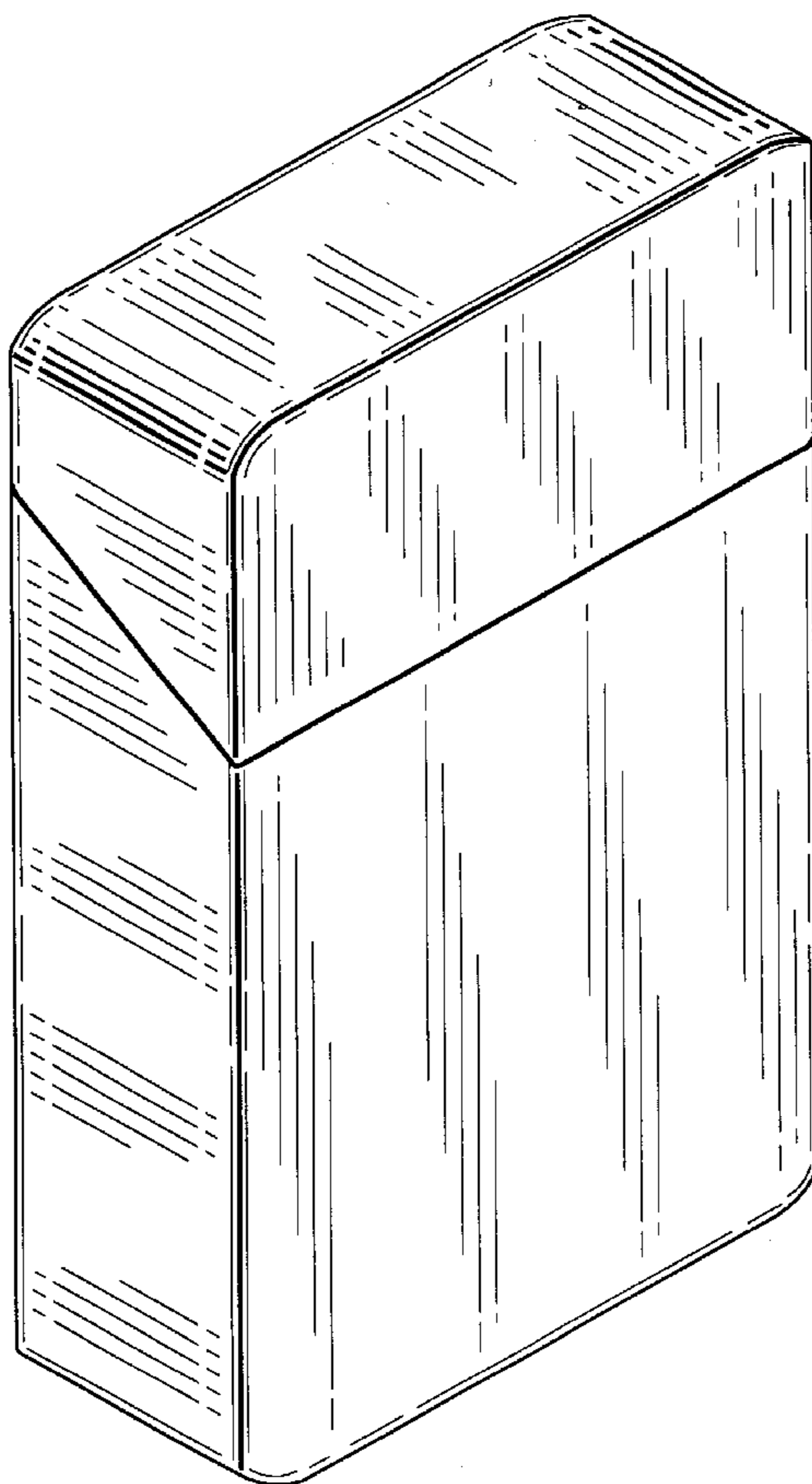
(57) **CLAIM**

The ornamental design for a rigid, hinged-lid container for tobacco articles, substantially as shown.

DESCRIPTION

FIG. 1 is a front view in perspective of a rigid, hinged-lid container for tobacco articles showing our new design; FIG. 2 is a front view of the FIG. 1 container; FIG. 3 is a side view of the FIG. 1 container; FIG. 4 is a bottom view of the FIG. 1 container; and, FIG. 5 is a rear view of the FIG. 1 container.

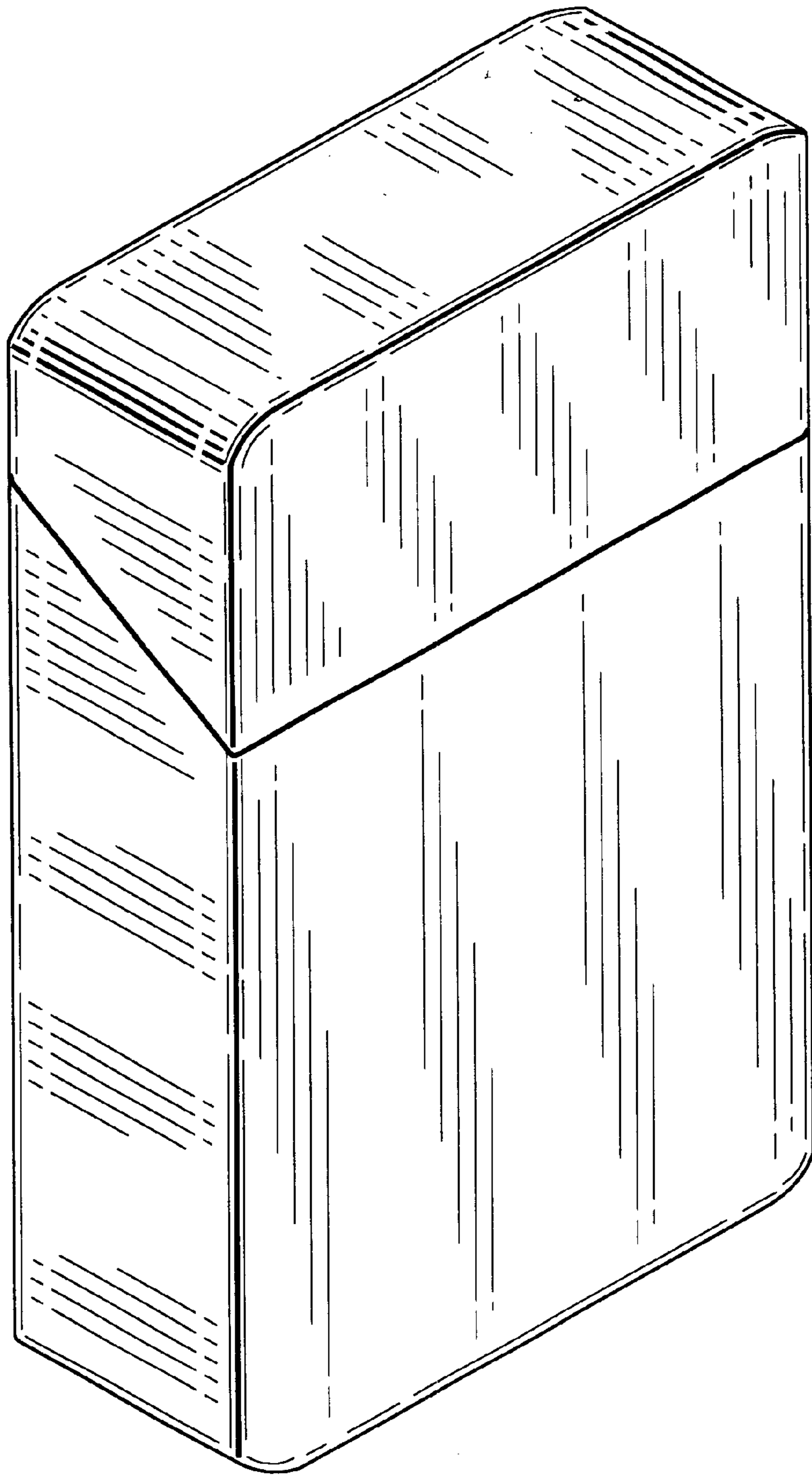

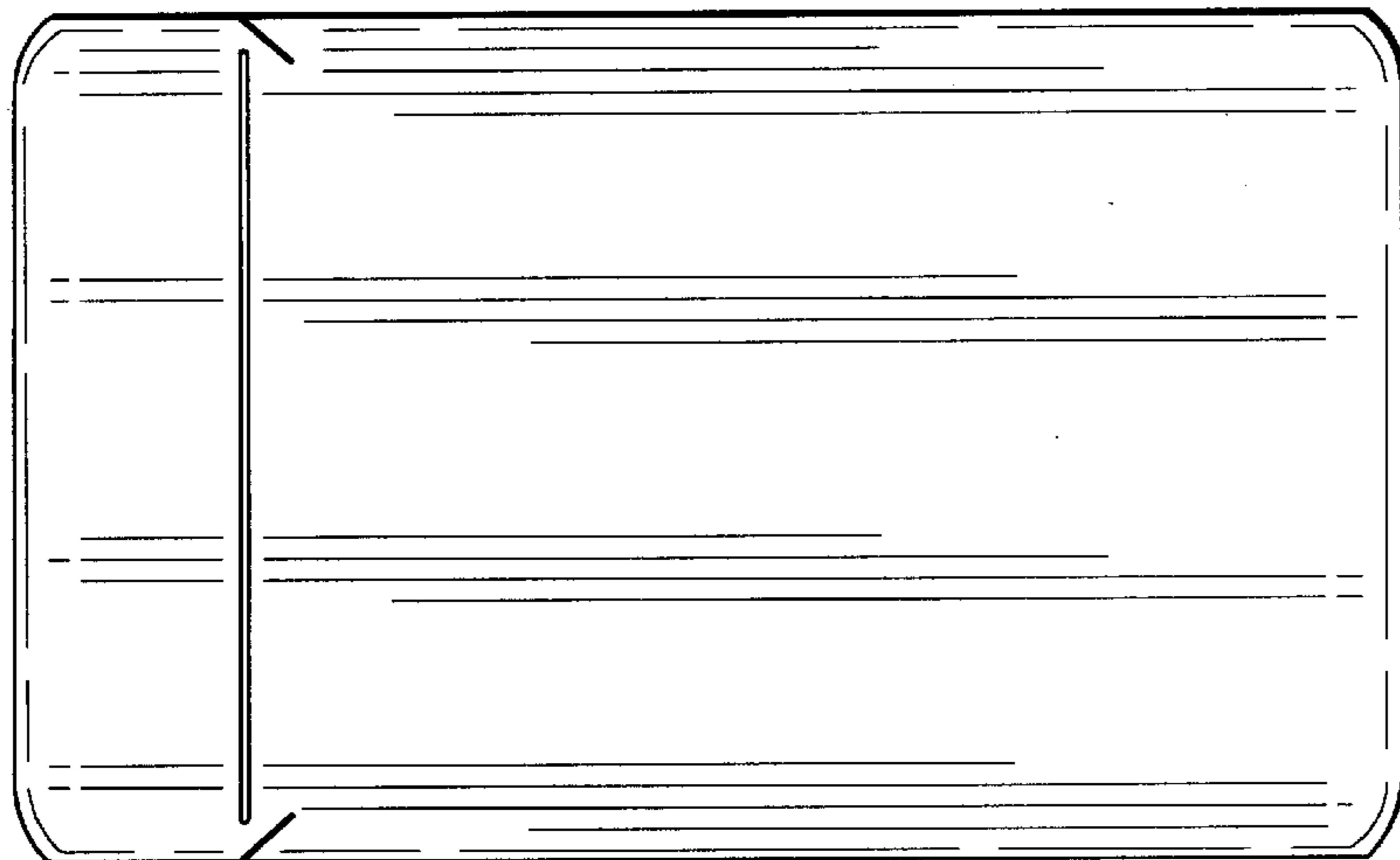

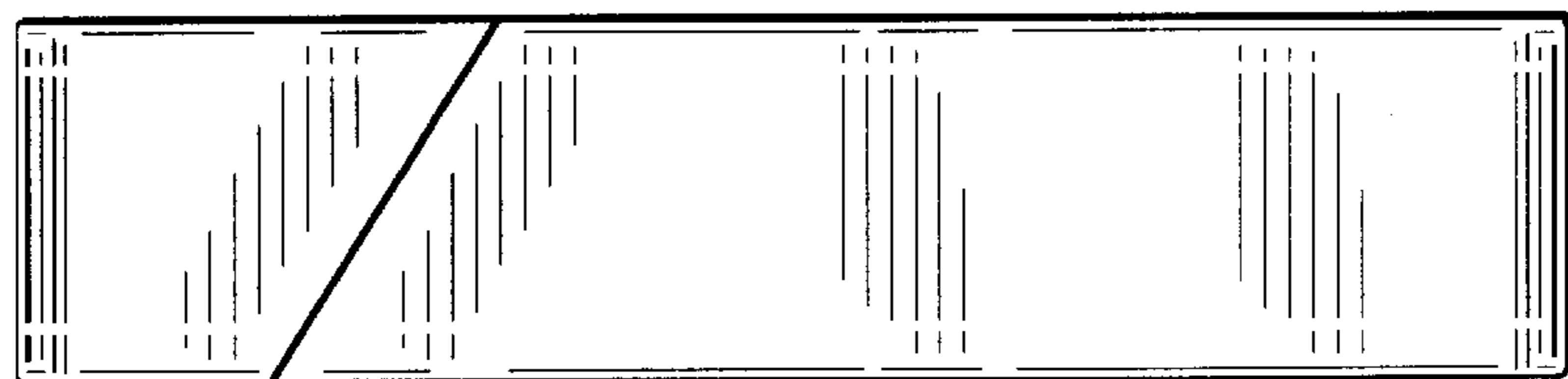

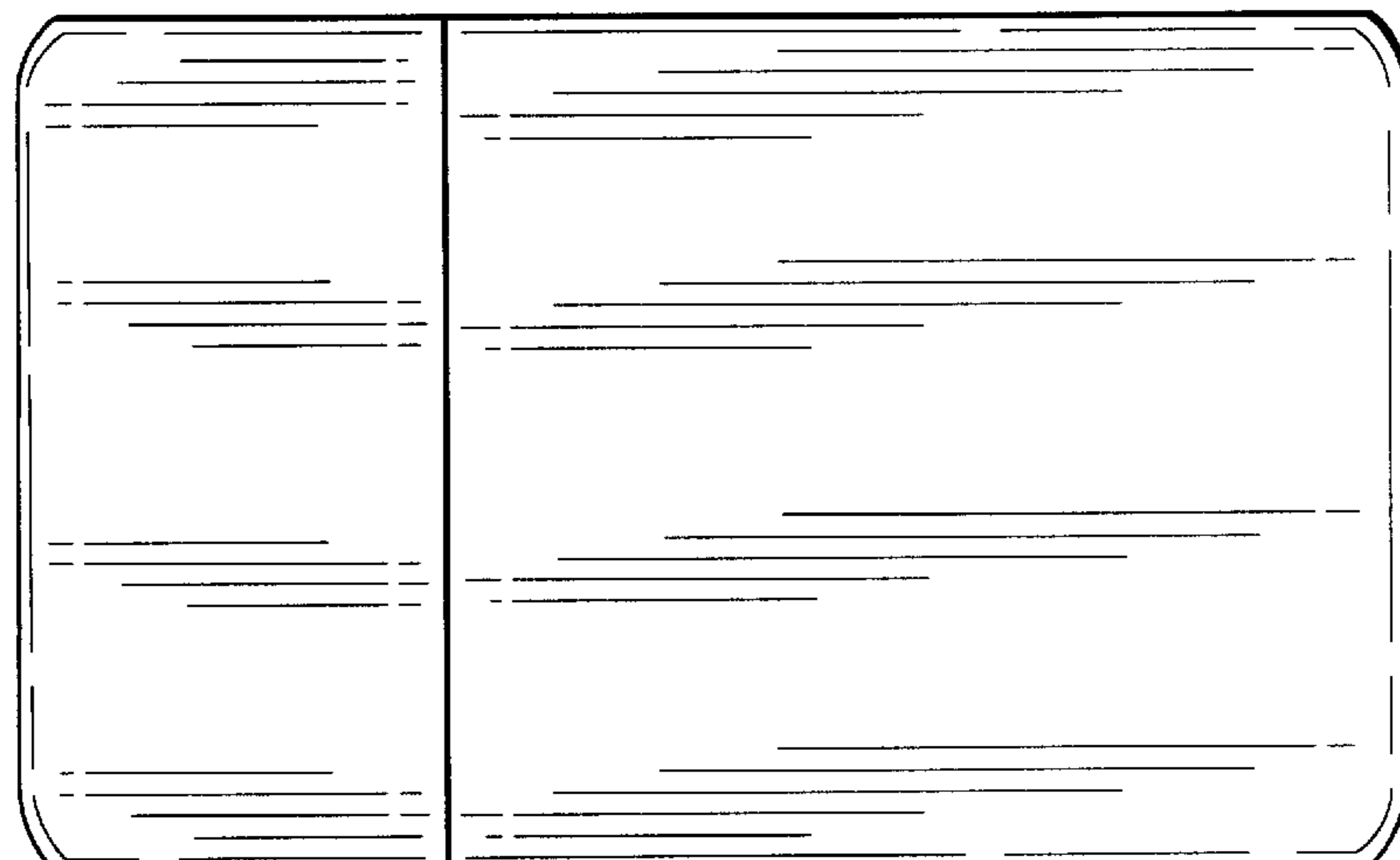

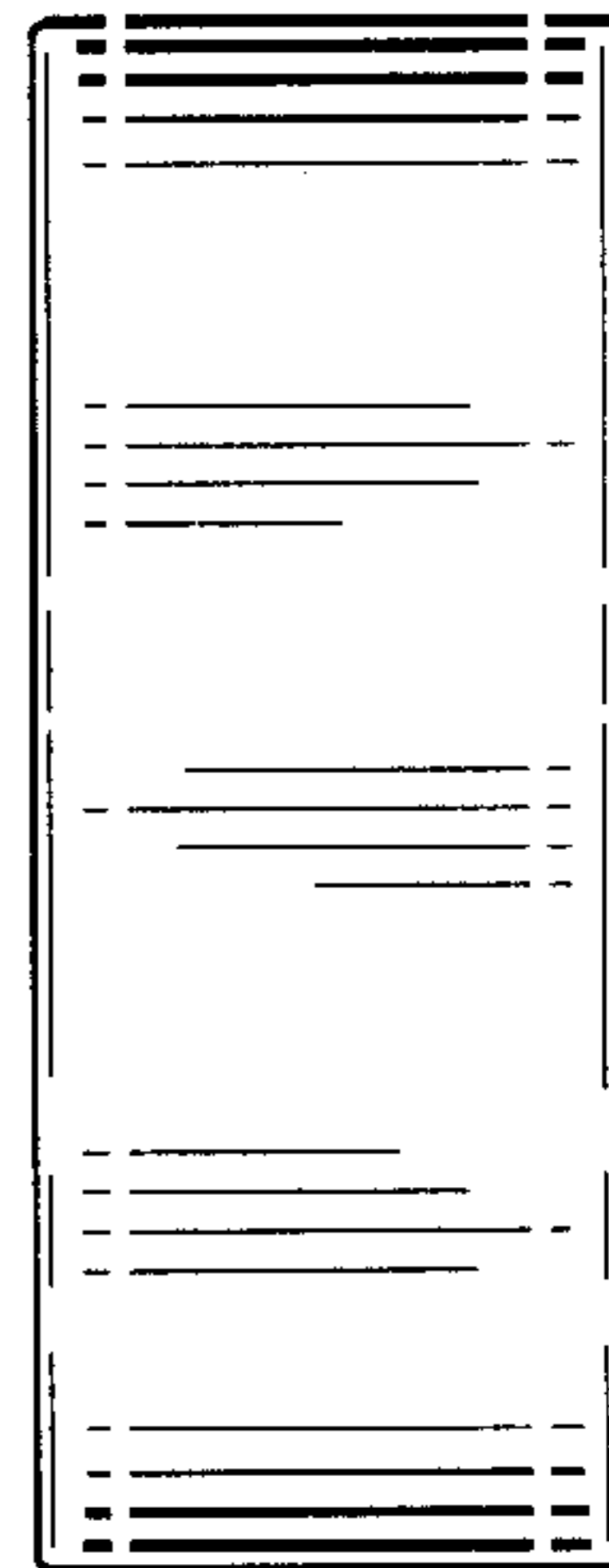
