FIG. 2 is a right-side view thereof, the left-side view being identical;

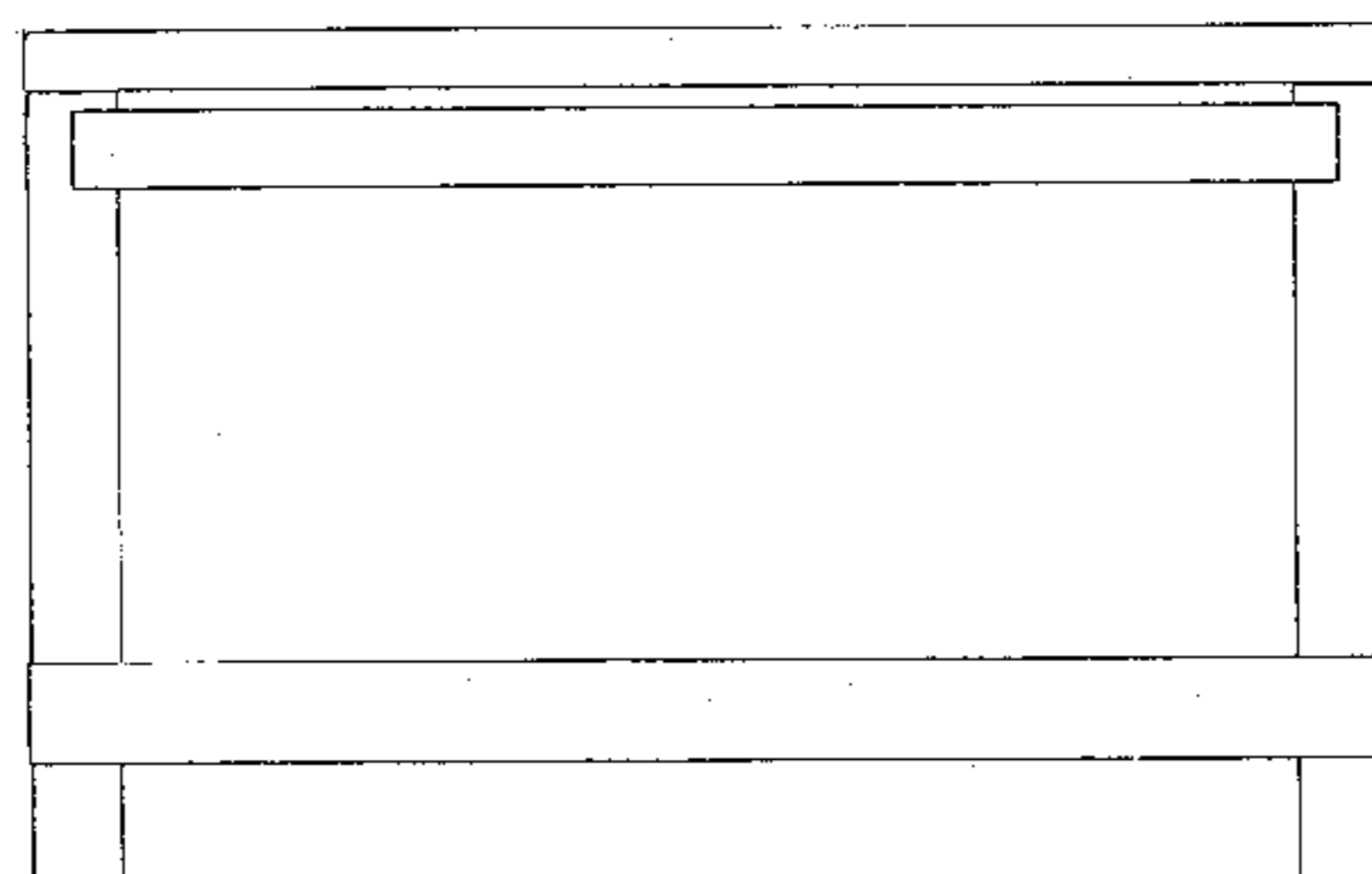
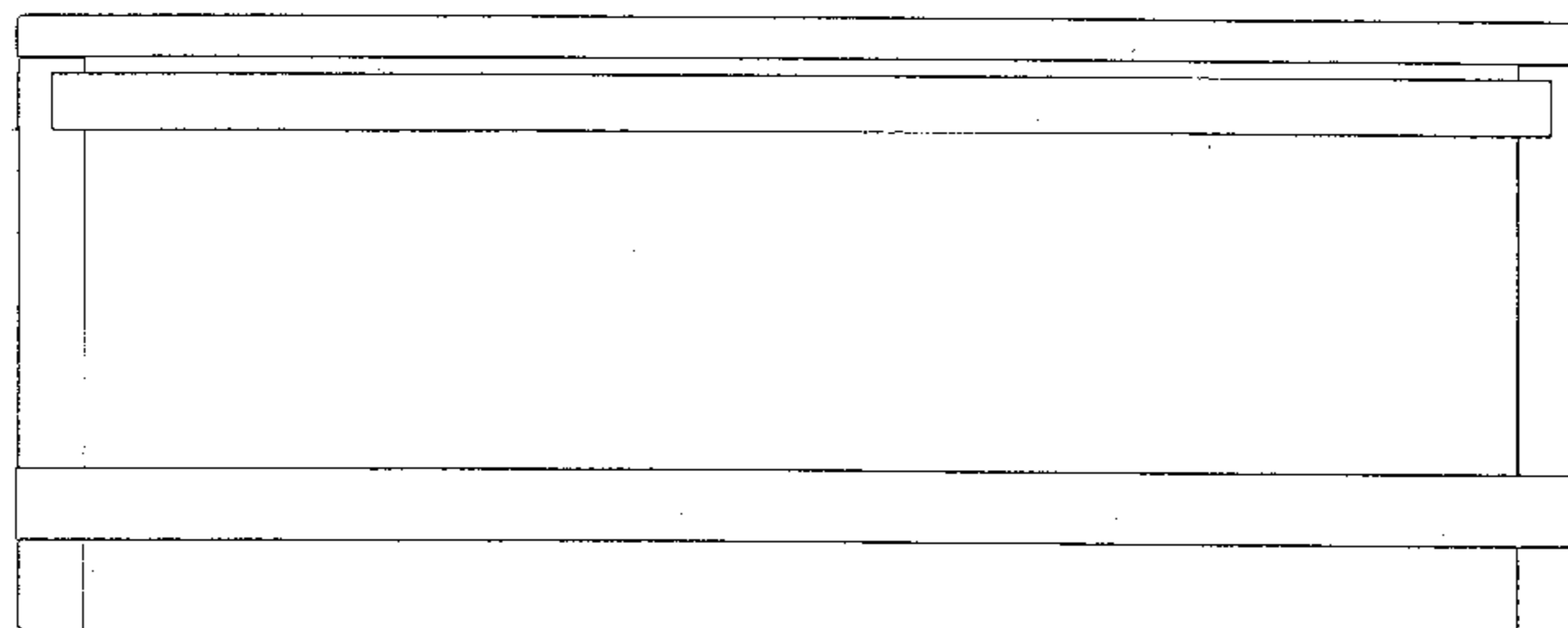
FIG. 3 is a top view thereof;

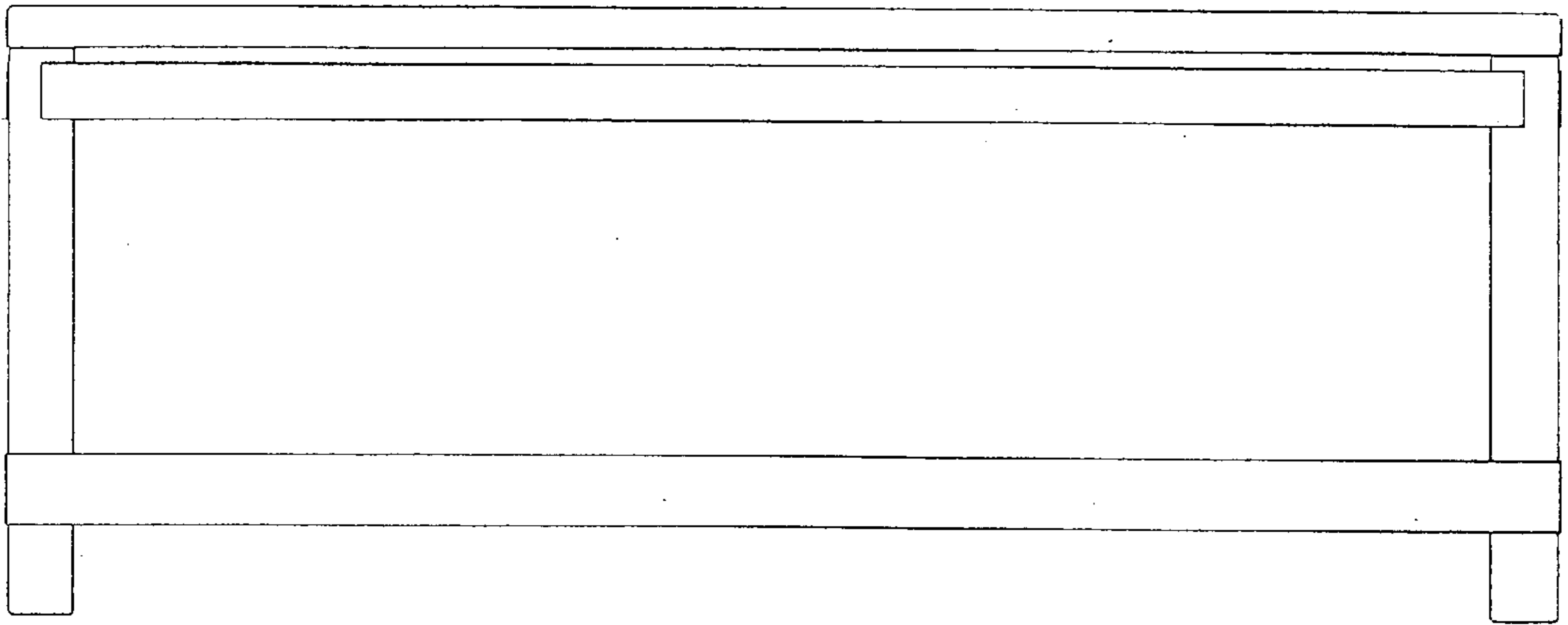
FIG. 4 is a front view of a second embodiment thereof, the rear view being identical;

FIG. 5 is a right-side view thereof, the left-side view being identical; and,

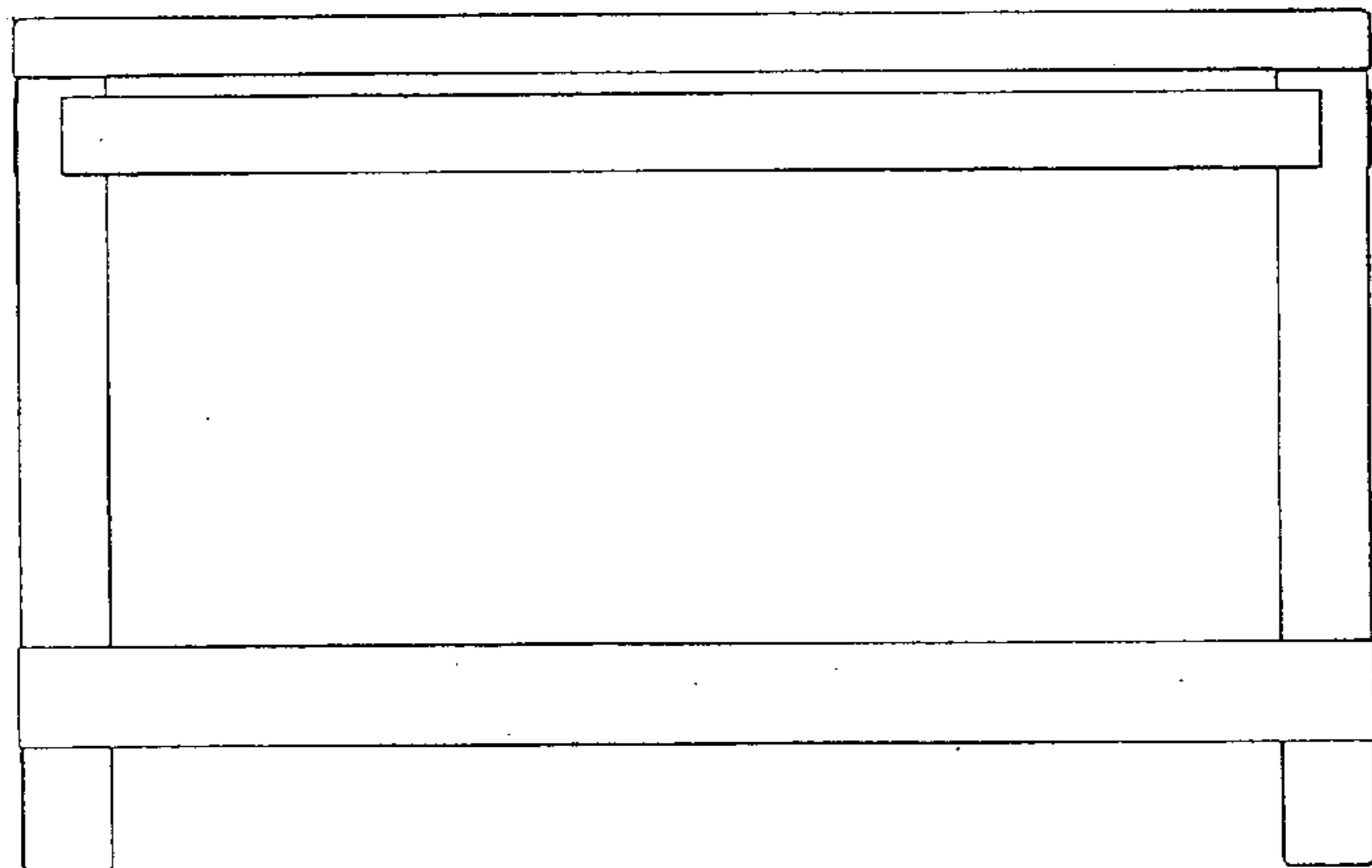
FIG. 6 is a top view thereof.

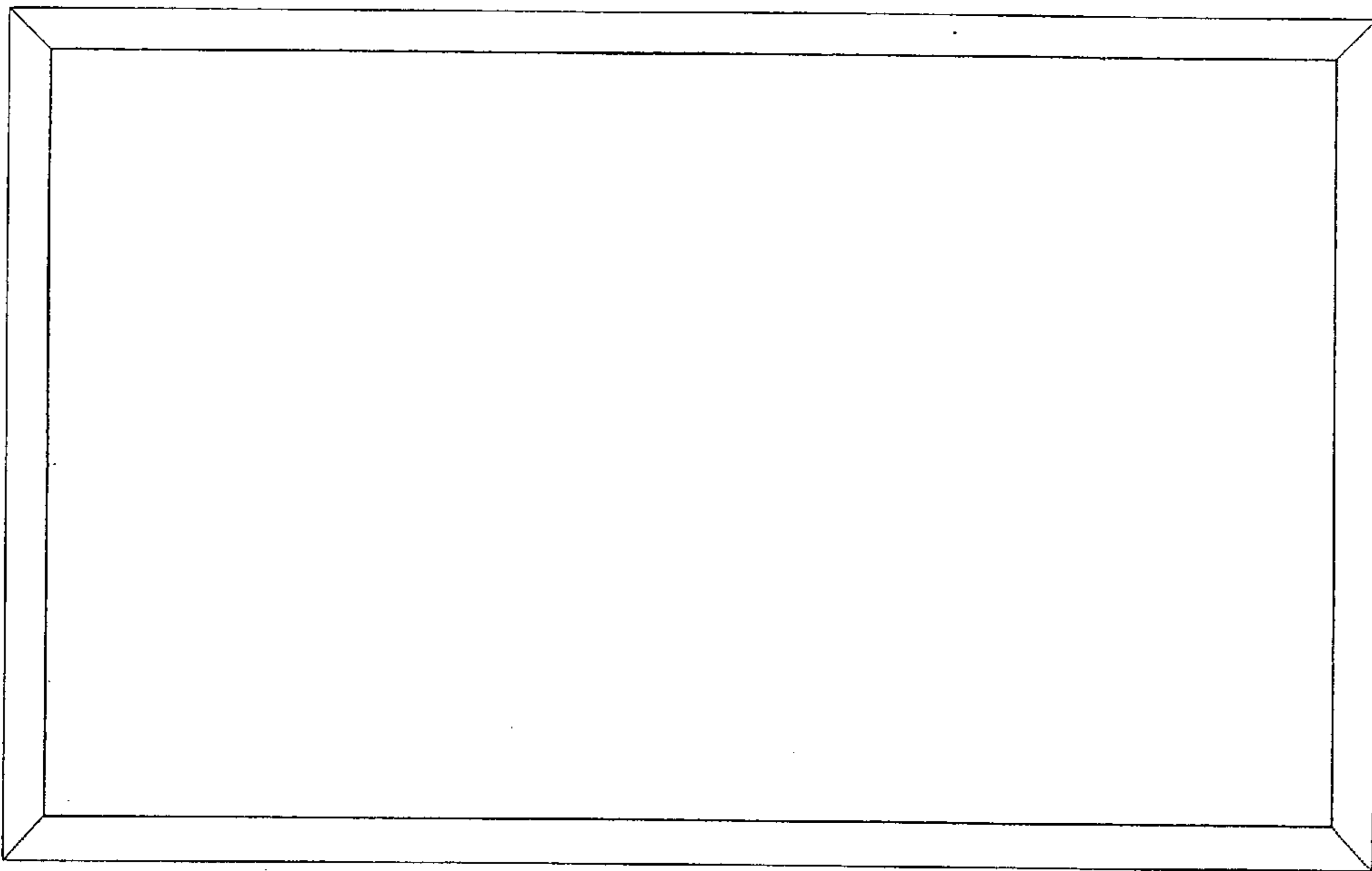

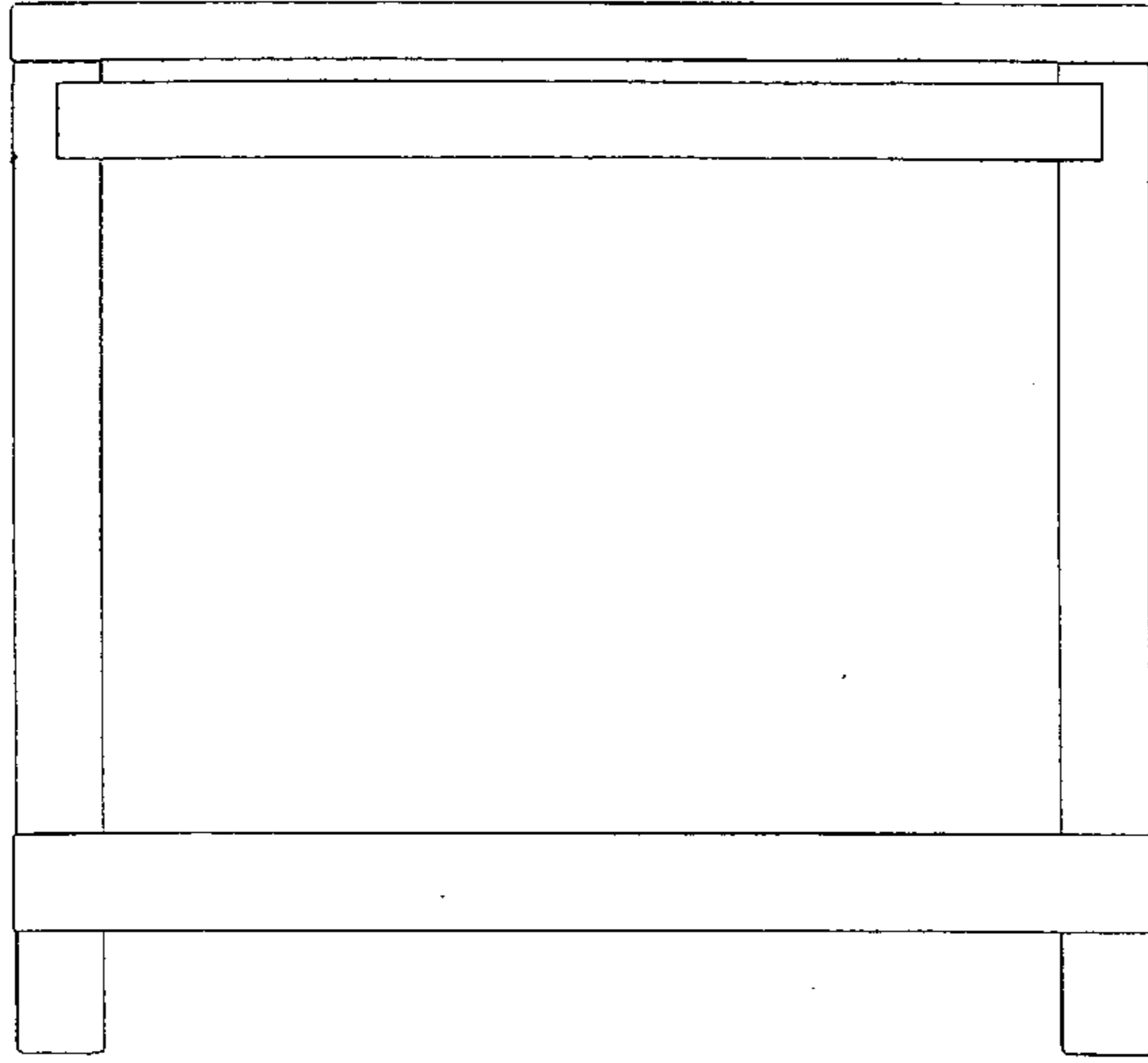

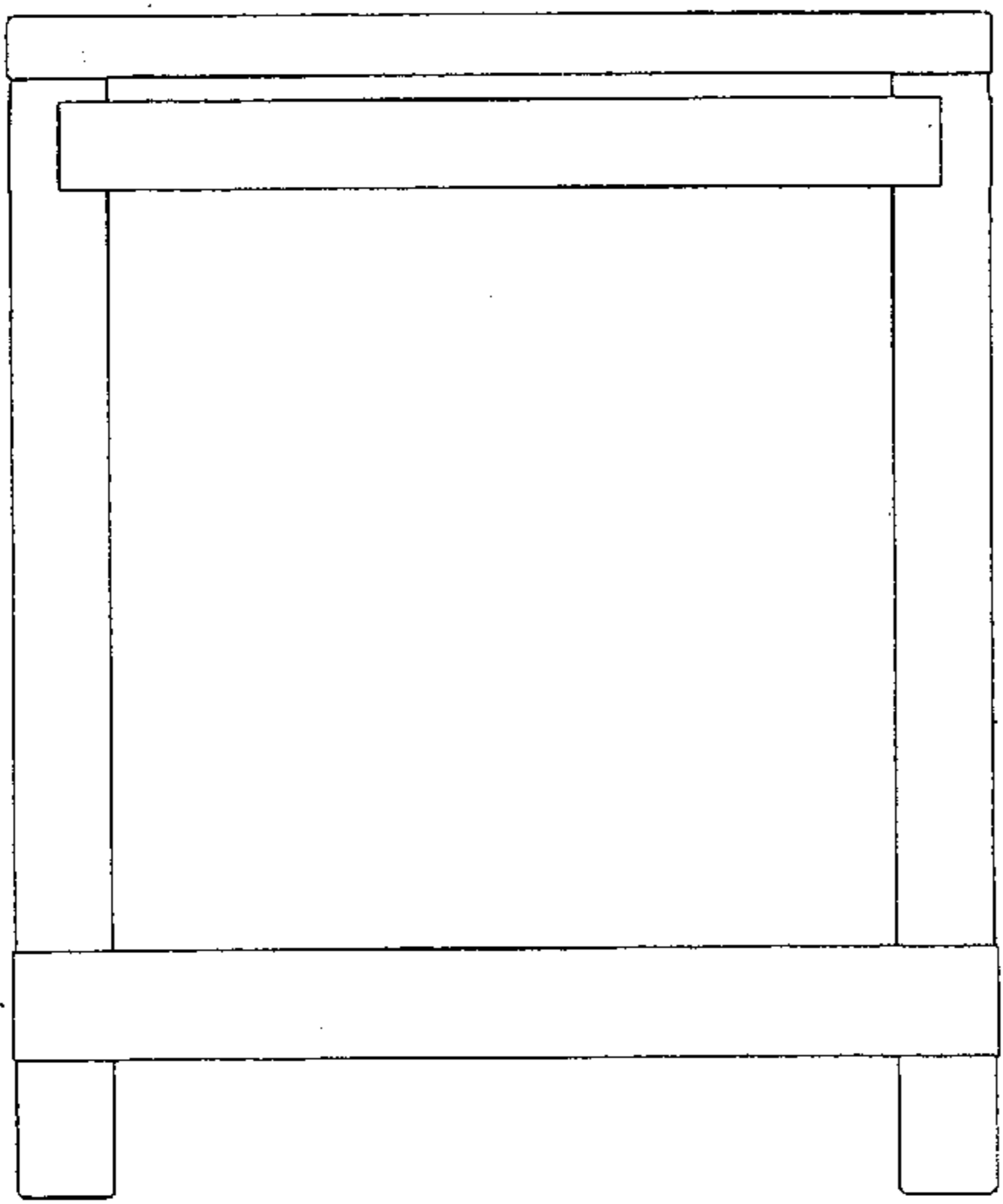

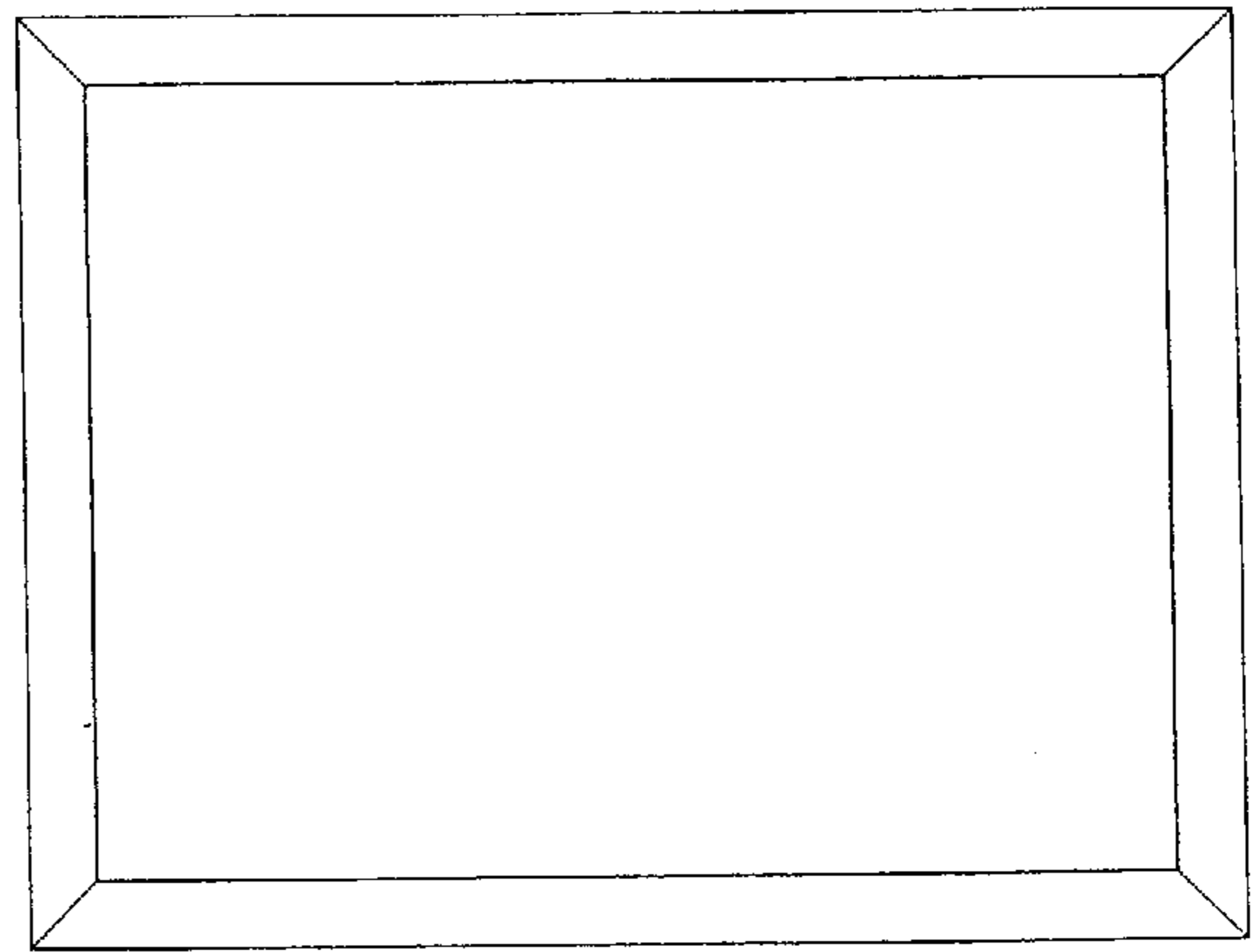
