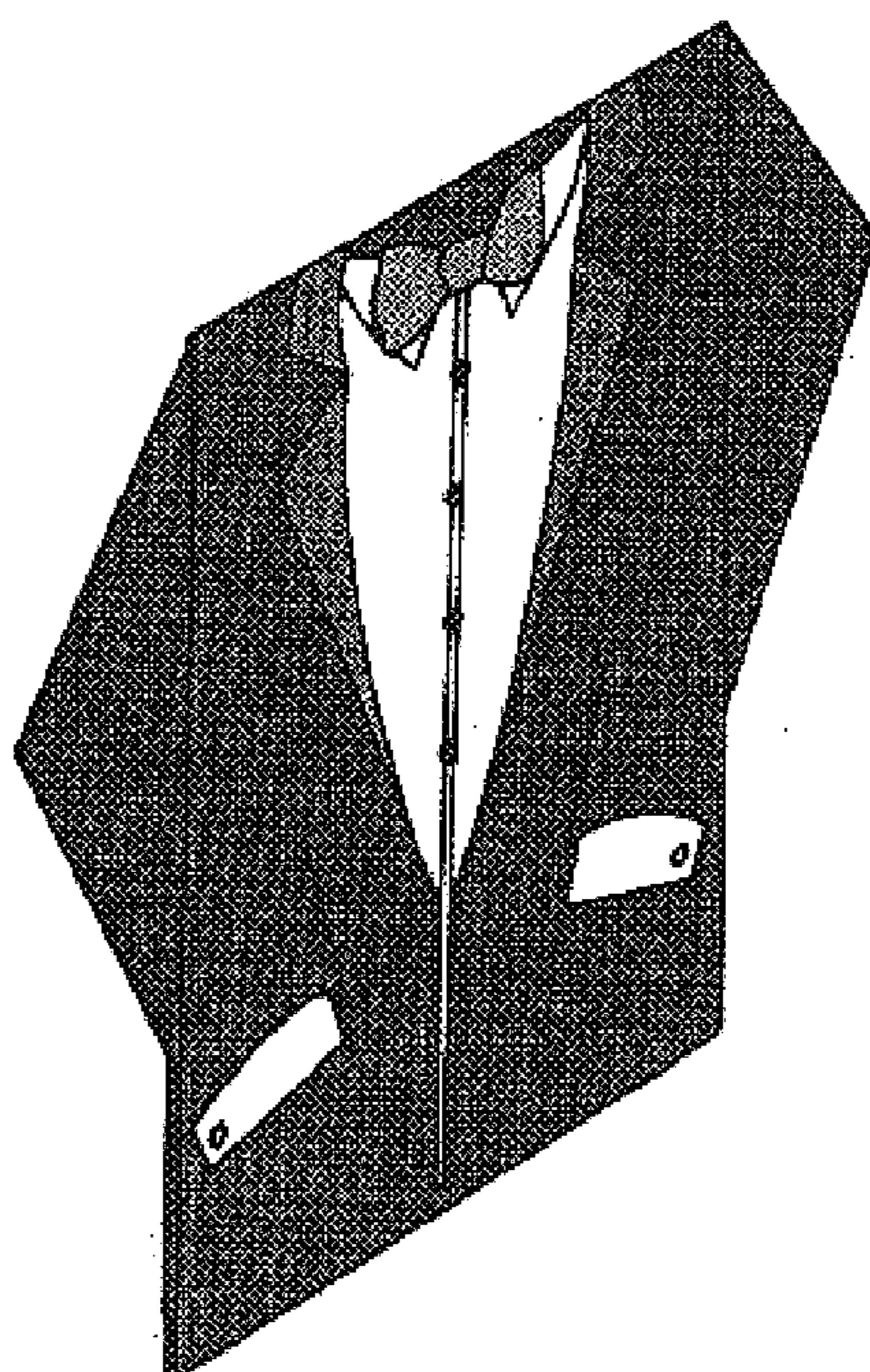
(57) **CLAIM**

The ornamental design for a napkin: sleeved-black, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a napkin: sleeved-black having a unique configuration of the present design; FIG. 2 is a rear view of the napkin: sleeved-black; FIG. 3 is a right side view of the napkin: sleeved-black; FIG. 4 is a front view of the napkin: sleeved-black; FIG. 5 is a left side view of the napkin: sleeved-black; FIG. 6 is a top view of the napkin: sleeved-black; and, FIG. 7 is a bottom view of the napkin: sleeved-black.

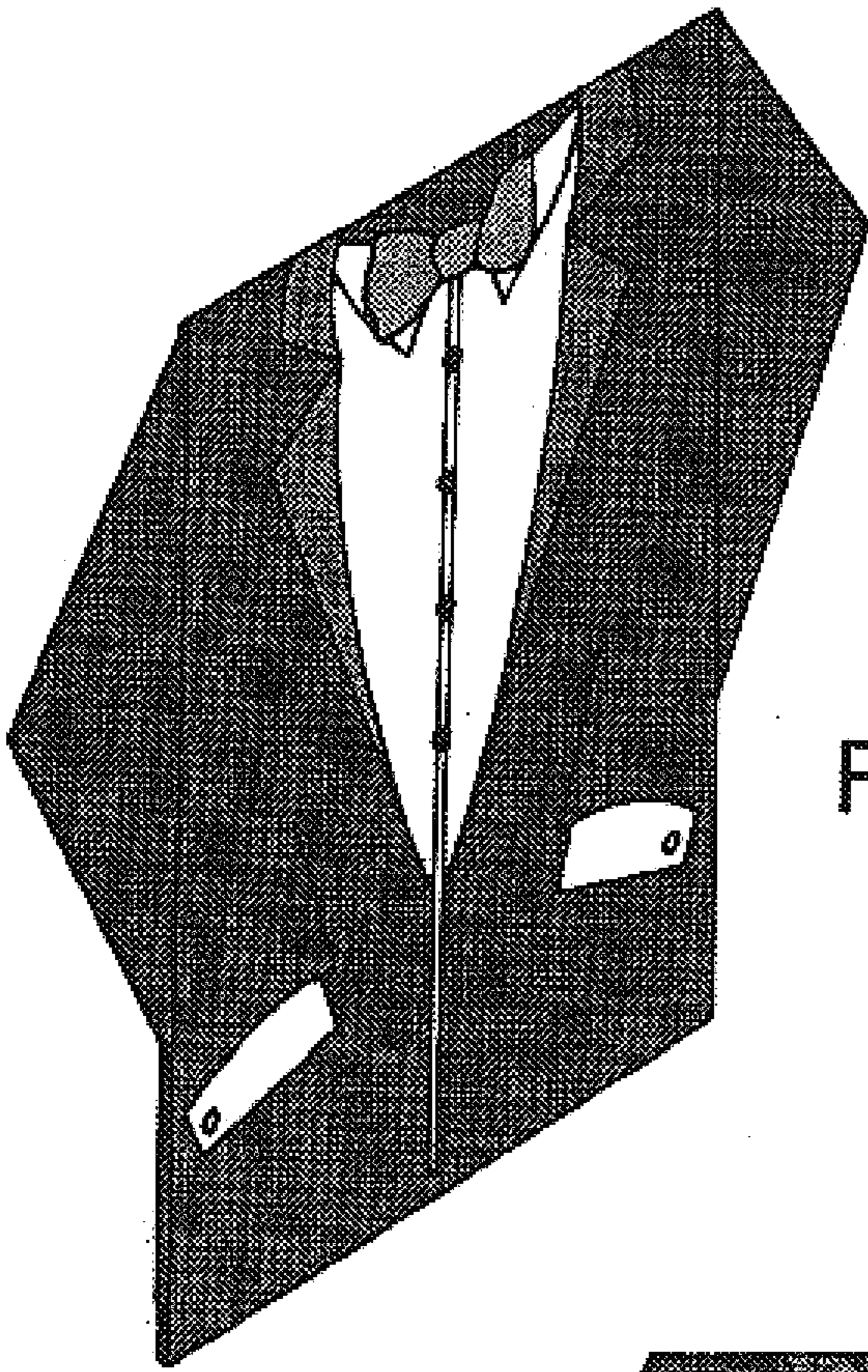

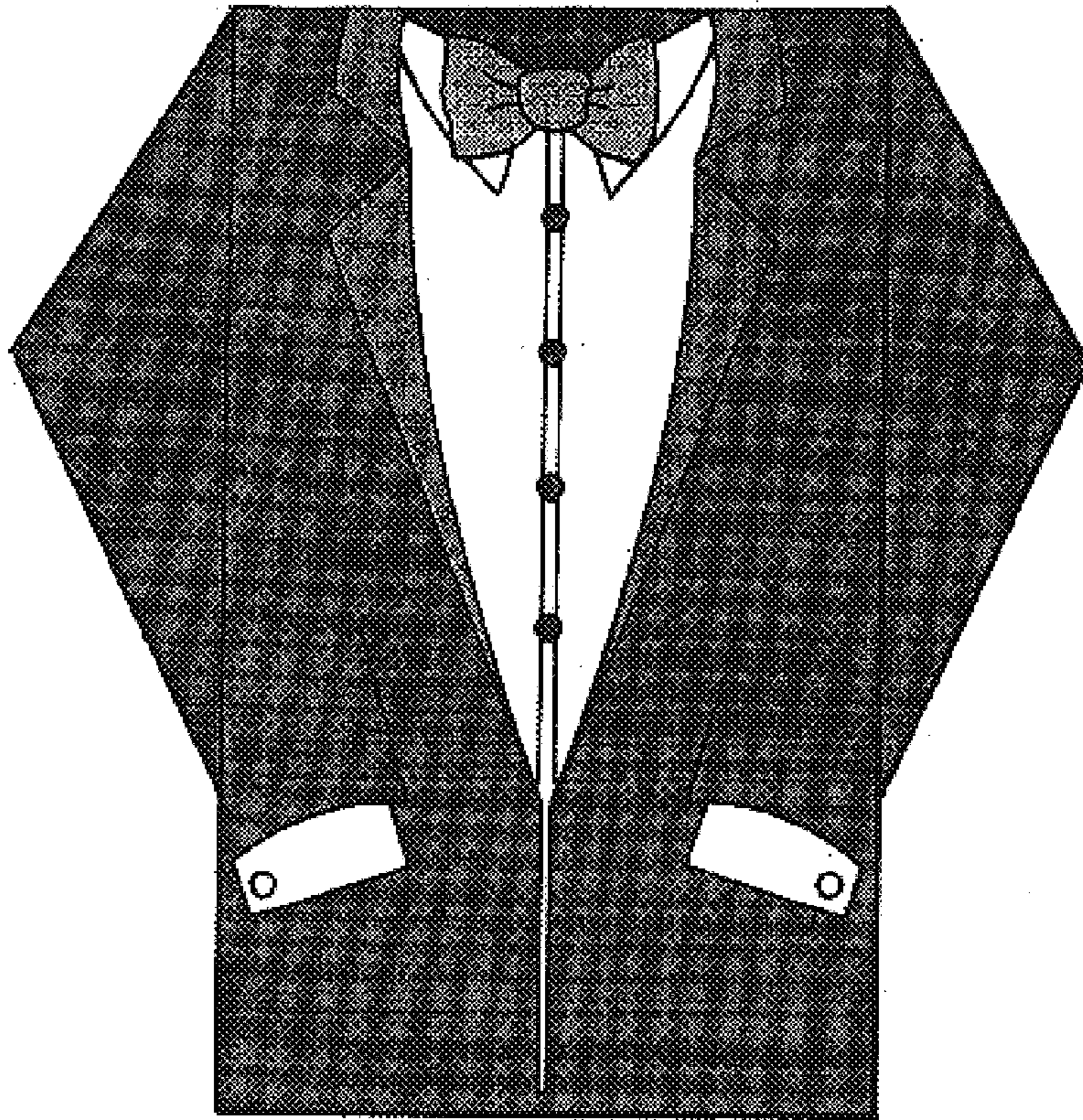
