(57) **CLAIM**

The ornamental design for a handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the handle showing my new design looking downwardly at a front and left side thereof, and showing a tool attachment head in broken lines attached to the handle;

FIG. 2 is a right elevation view of the handle, and showing a tool attachment head in broken lines attached to the handle;

FIG. 3 is a left elevation view of the handle, and showing a tool attachment head in broken lines attached to the handle;

FIG. 4 is a top plan view of the handle, and showing a tool attachment head in broken lines attached to the handle;

FIG. 5 is a front elevation view of the handle, and showing a tool attachment head in broken lines attached to the handle; and,

FIG. 6 is a rear elevation view of the tool handle, and showing a tool attachment head in broken lines attached to the handle.

The broken lines showing the tool attachment head are for illustrative purposes only and form no part of the claimed design. A bottom view of the saw handle is a mirror image of the top plan view.

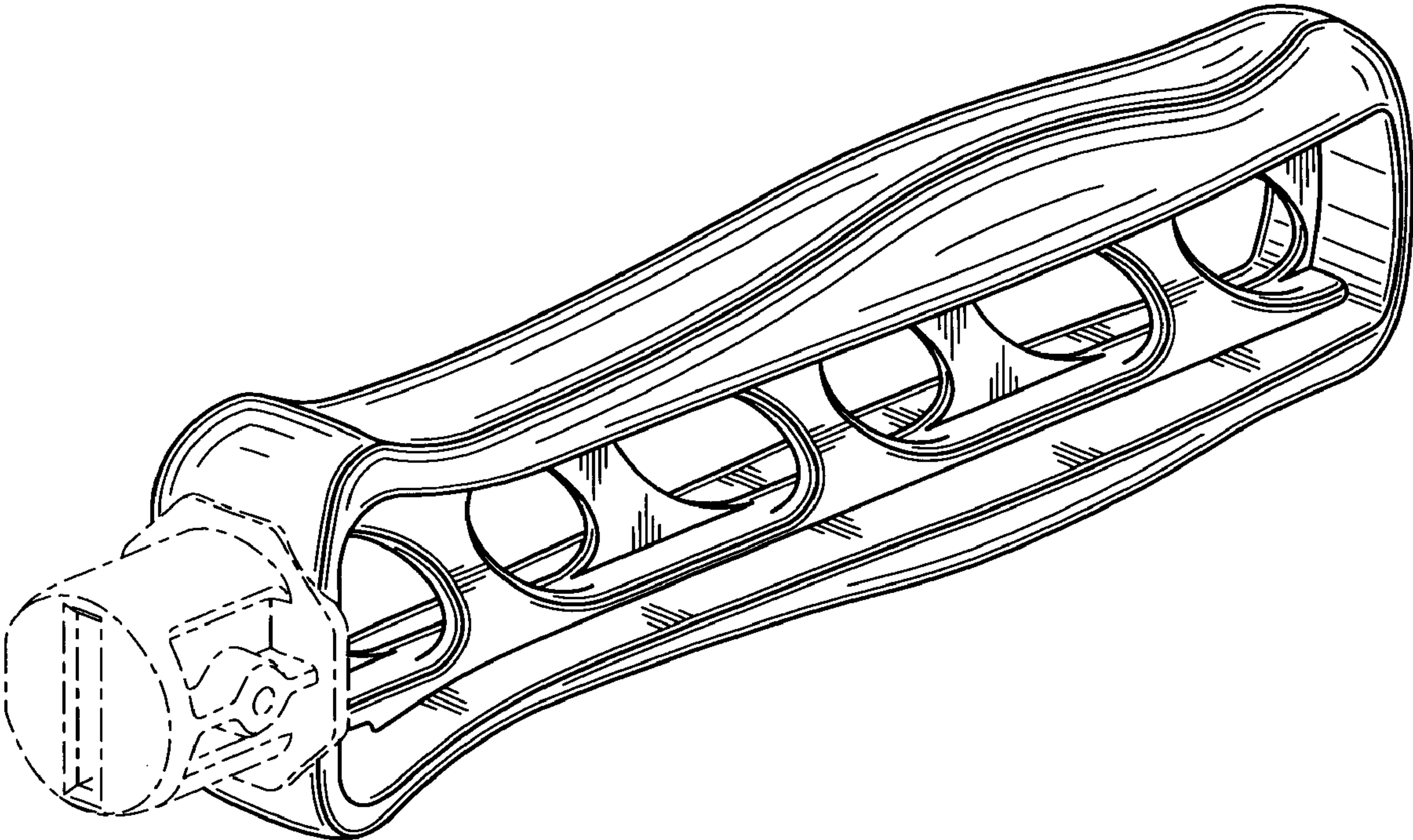

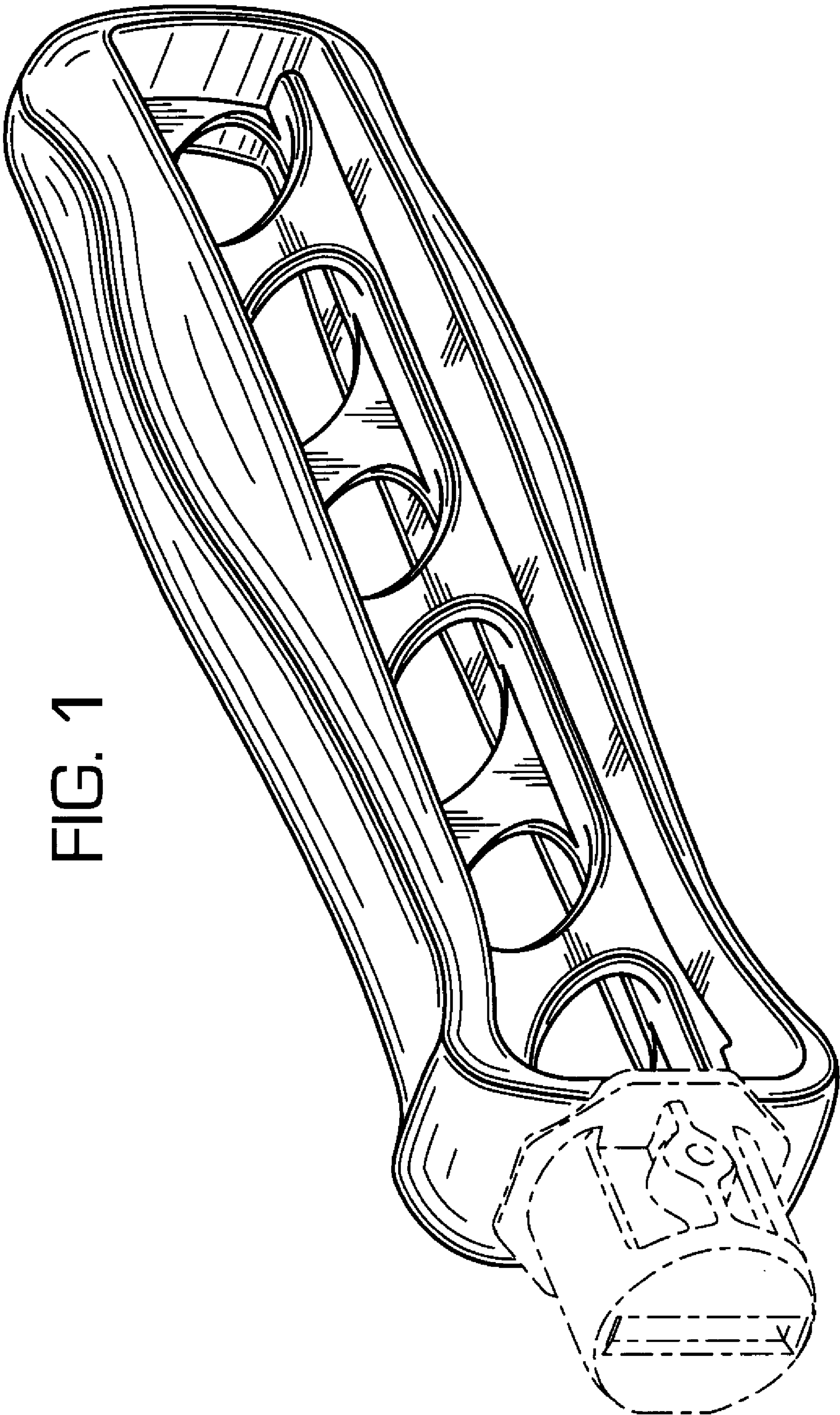

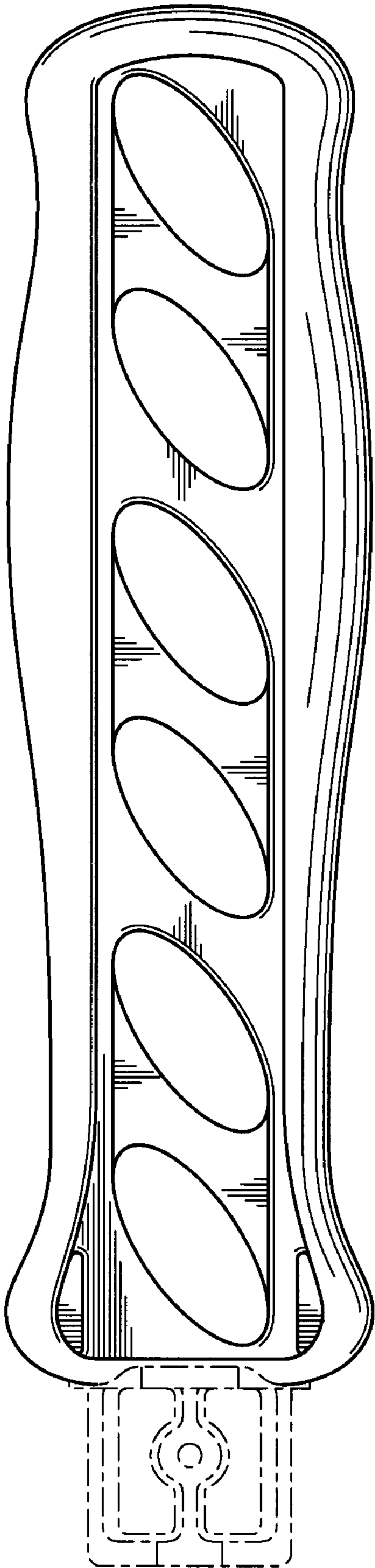
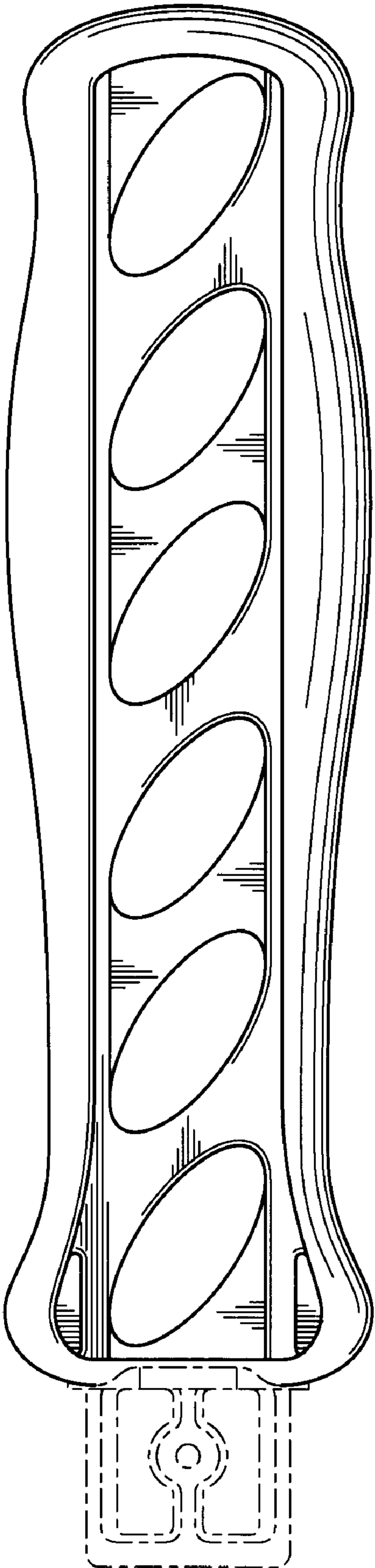

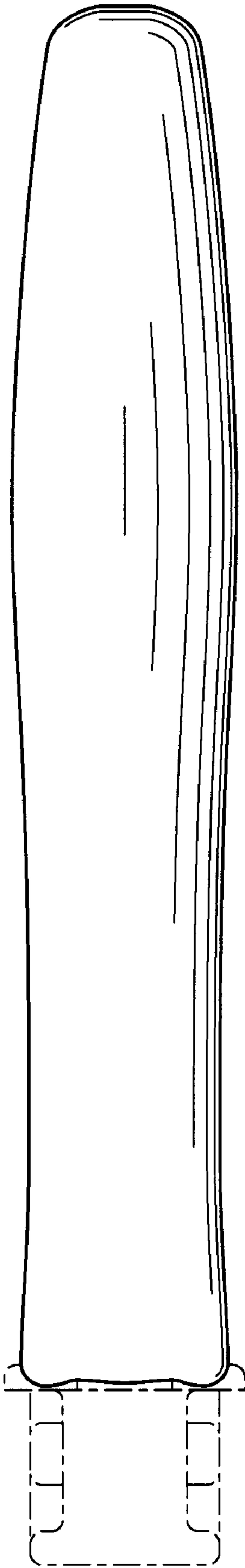

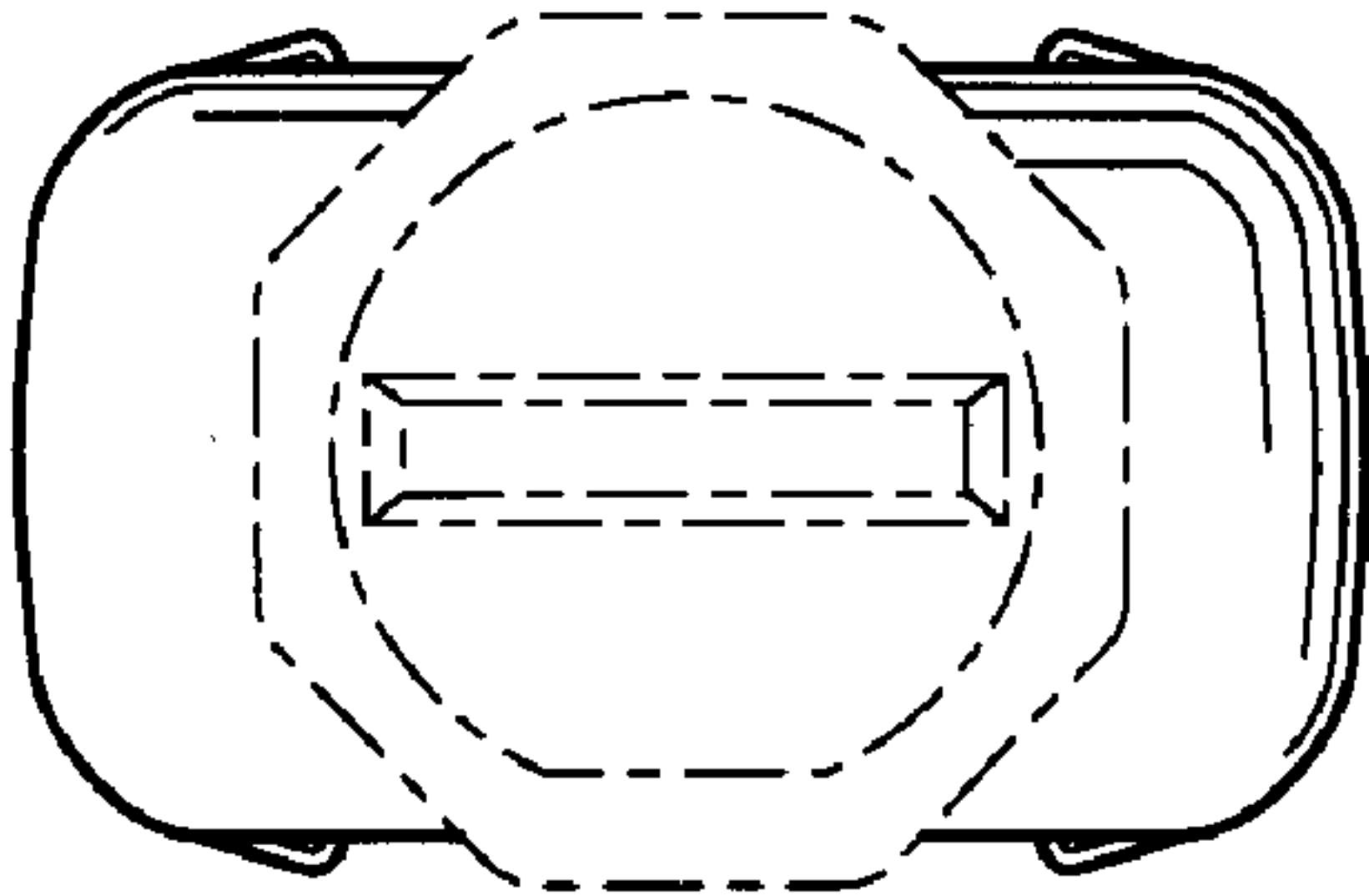

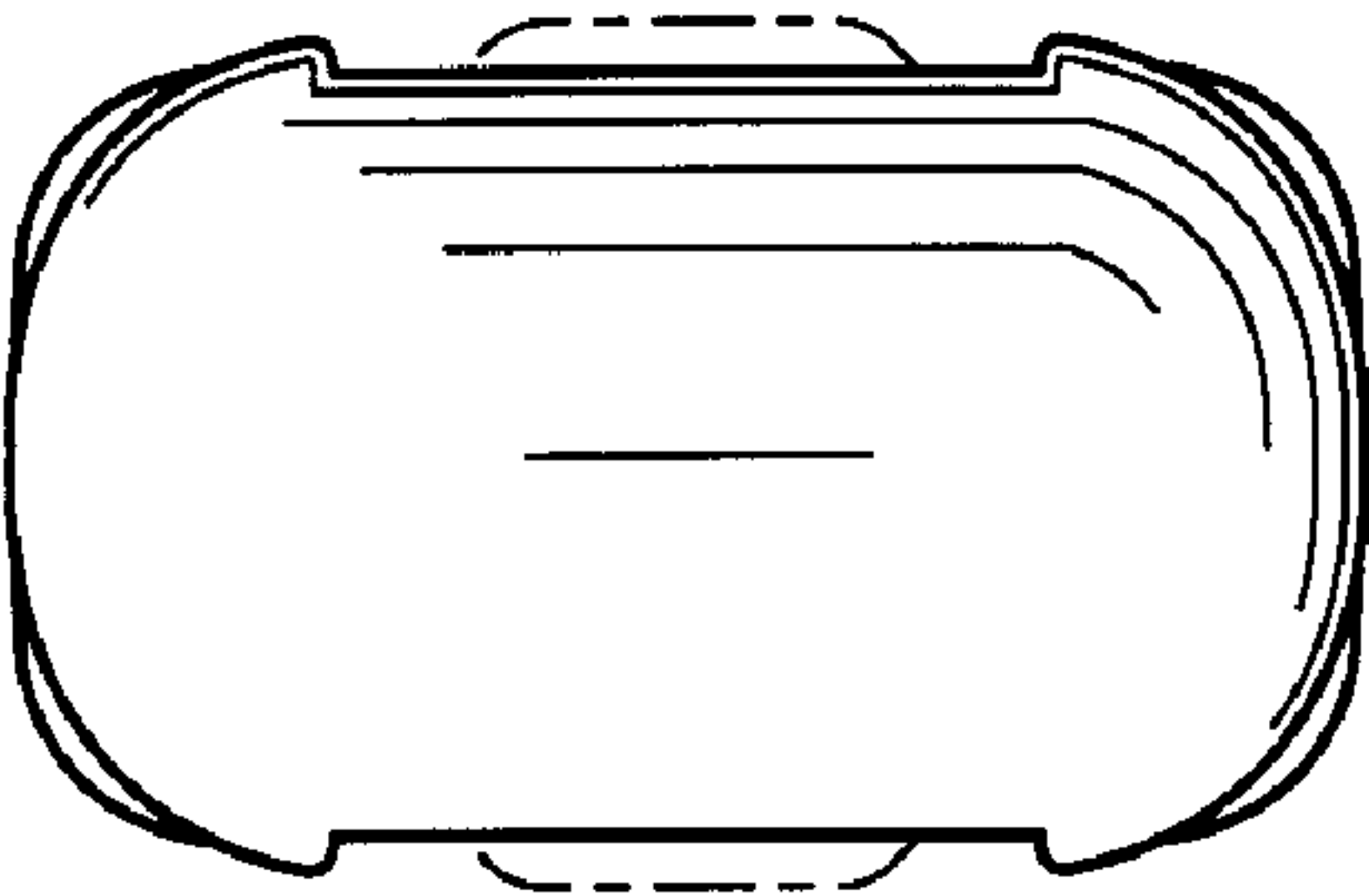
