(57) **CLAIM**

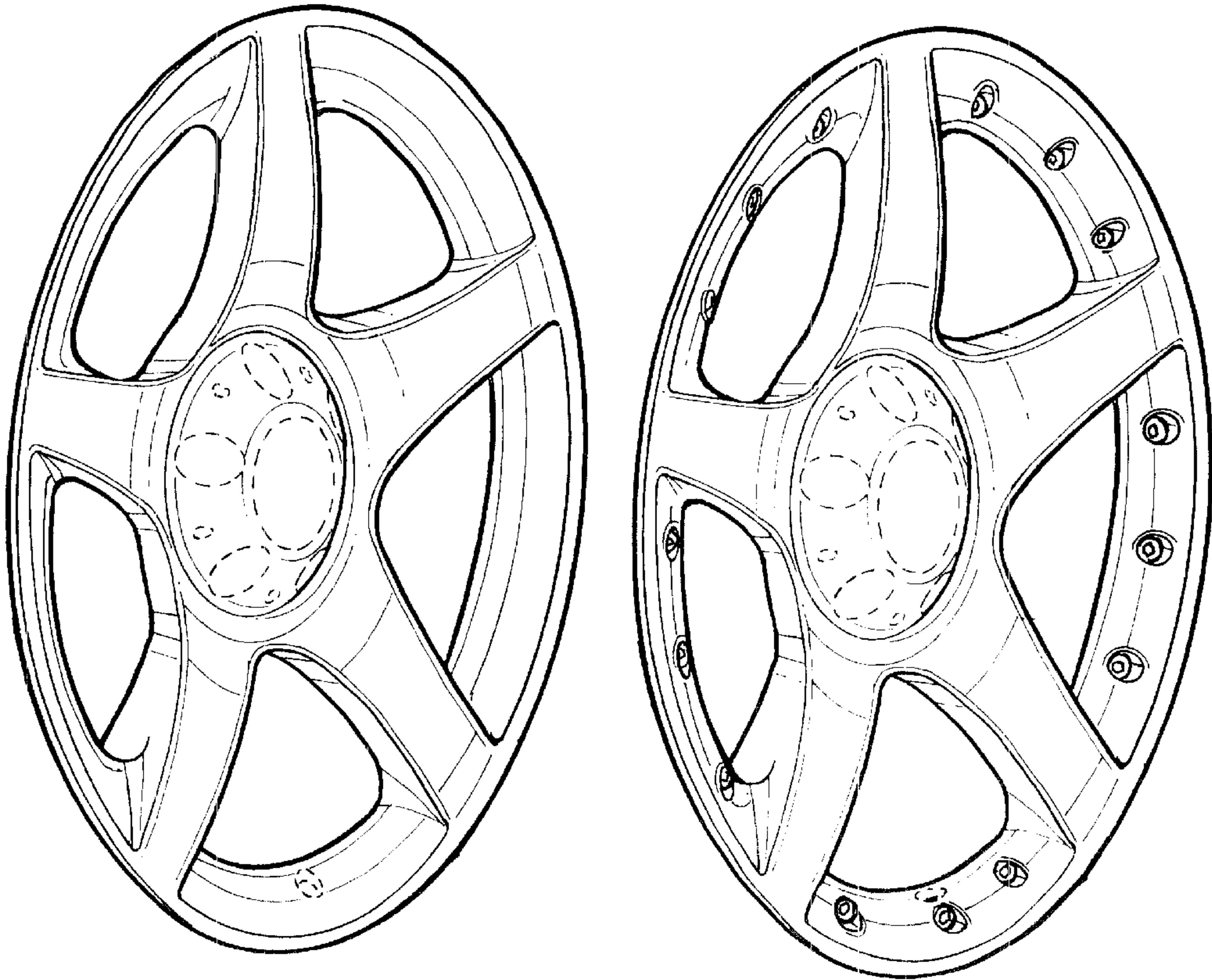
The ornamental design for a front face of a vehicle wheel, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first embodiment of a front face of a vehicle wheel according to my novel design; FIG. 2 is a perspective view of the first embodiment of the front face of a vehicle wheel according to my novel design; FIG. 3 is a front view of a second embodiment of the front face of a vehicle wheel according to my novel design; and, FIG. 4 is a perspective view of the second embodiment of the front face of a vehicle wheel according to my novel design.

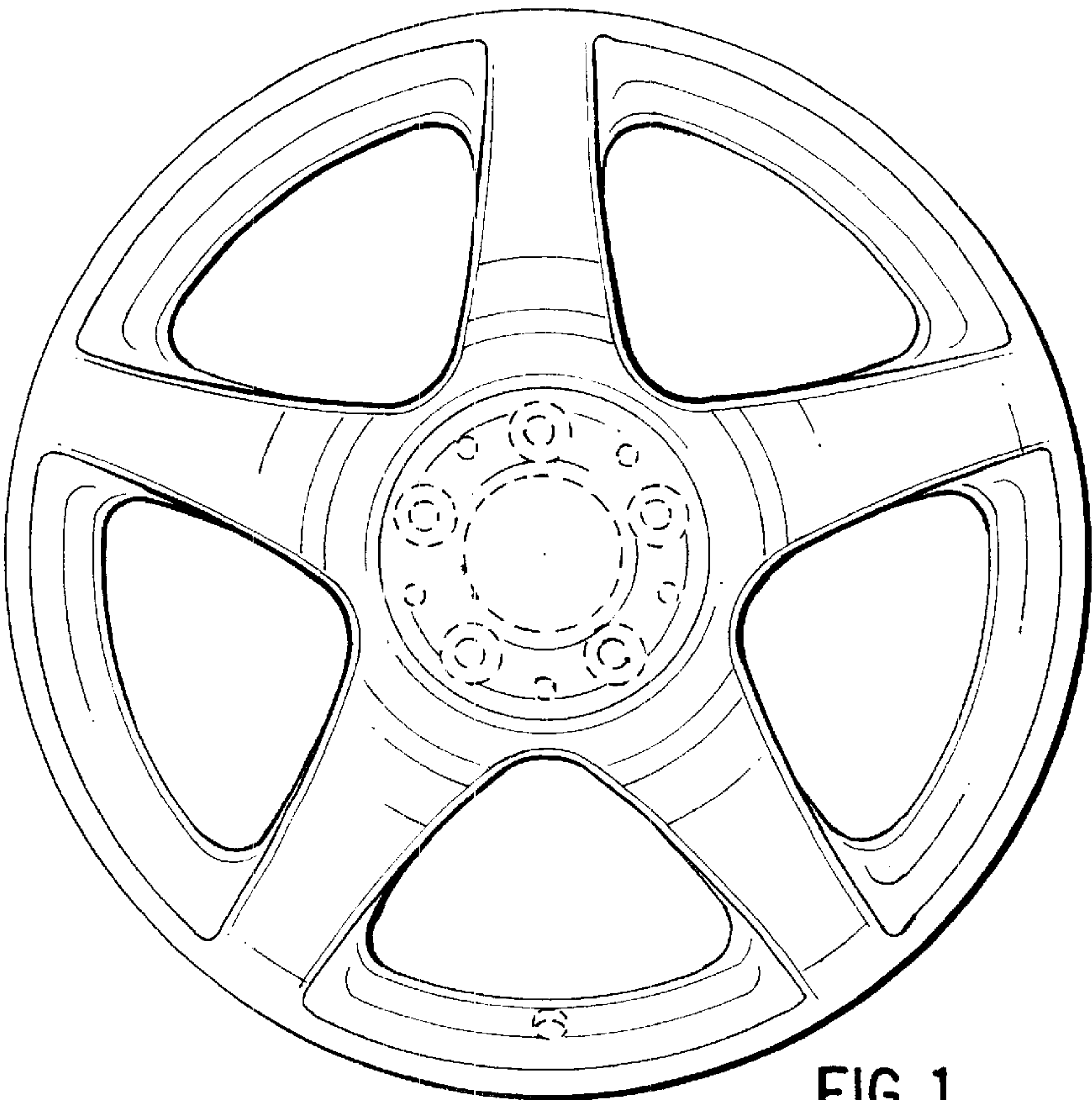

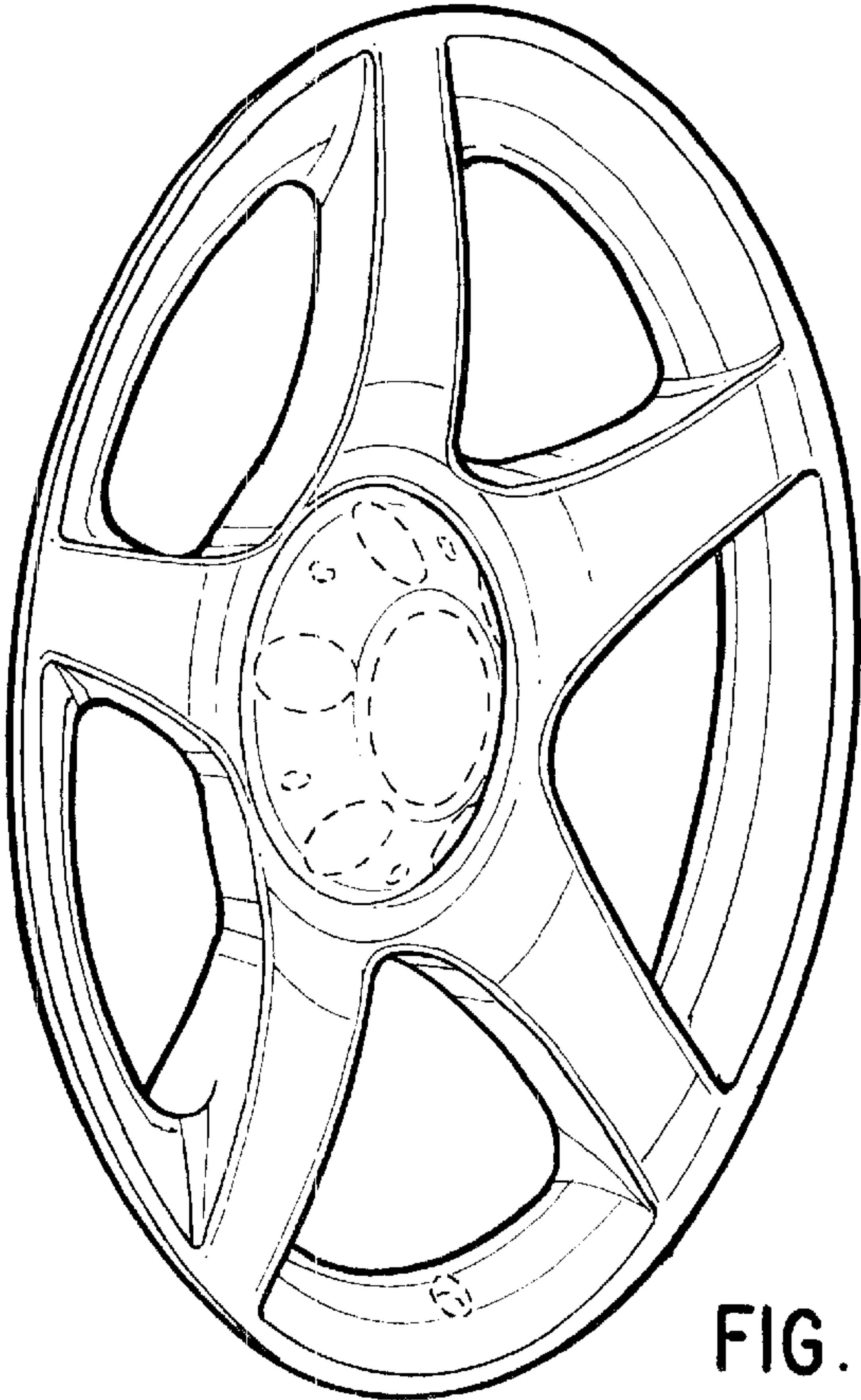

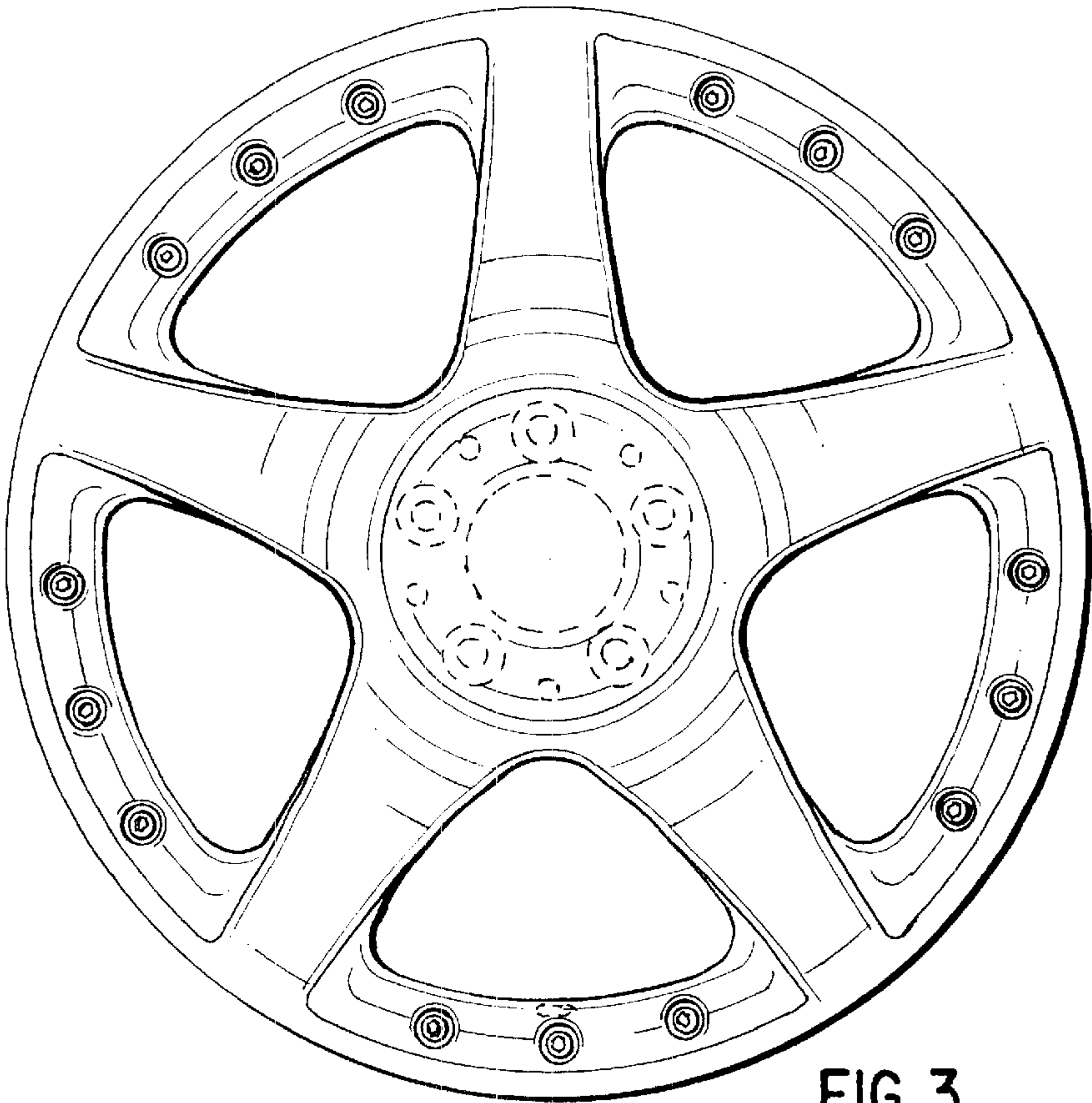

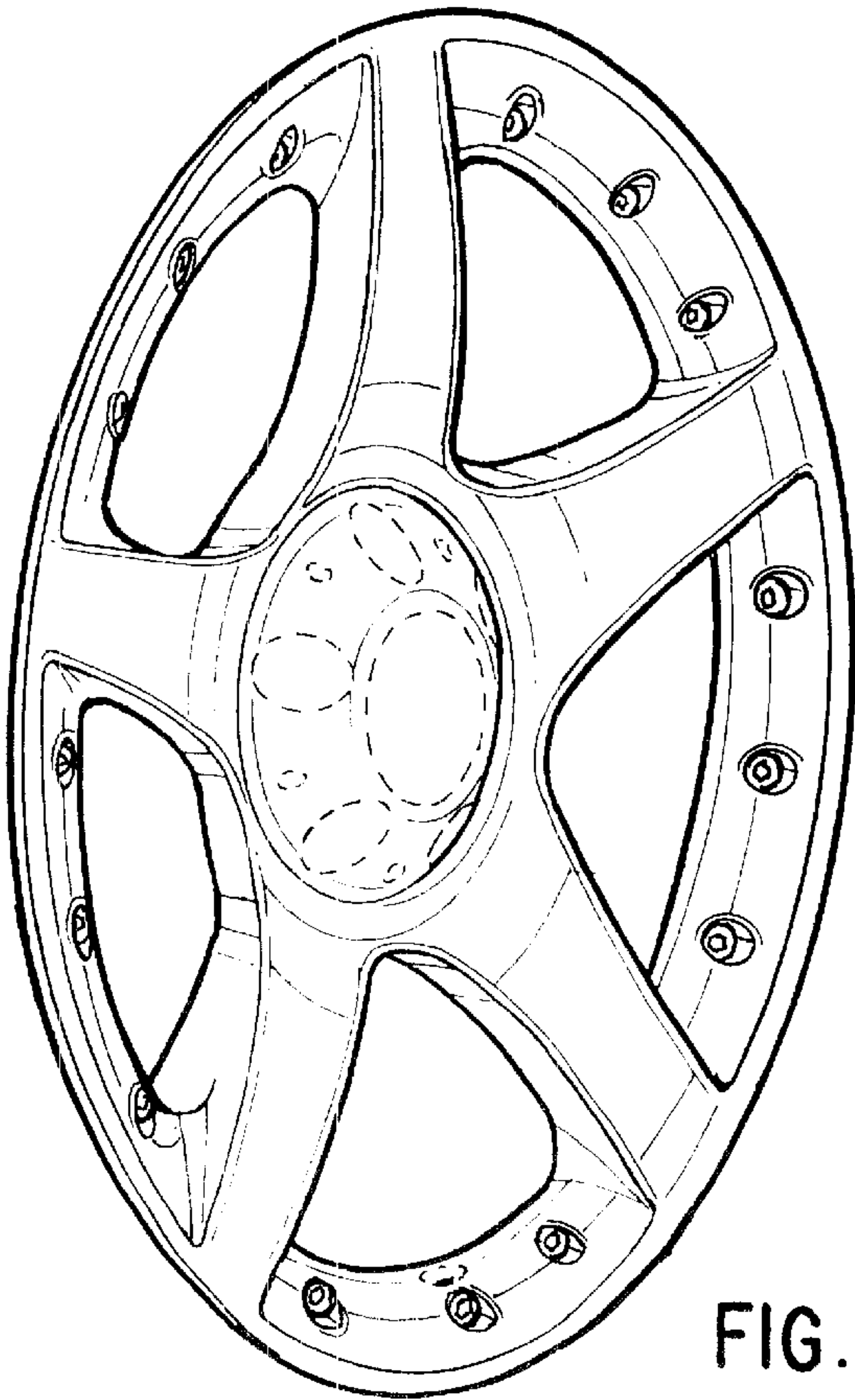
