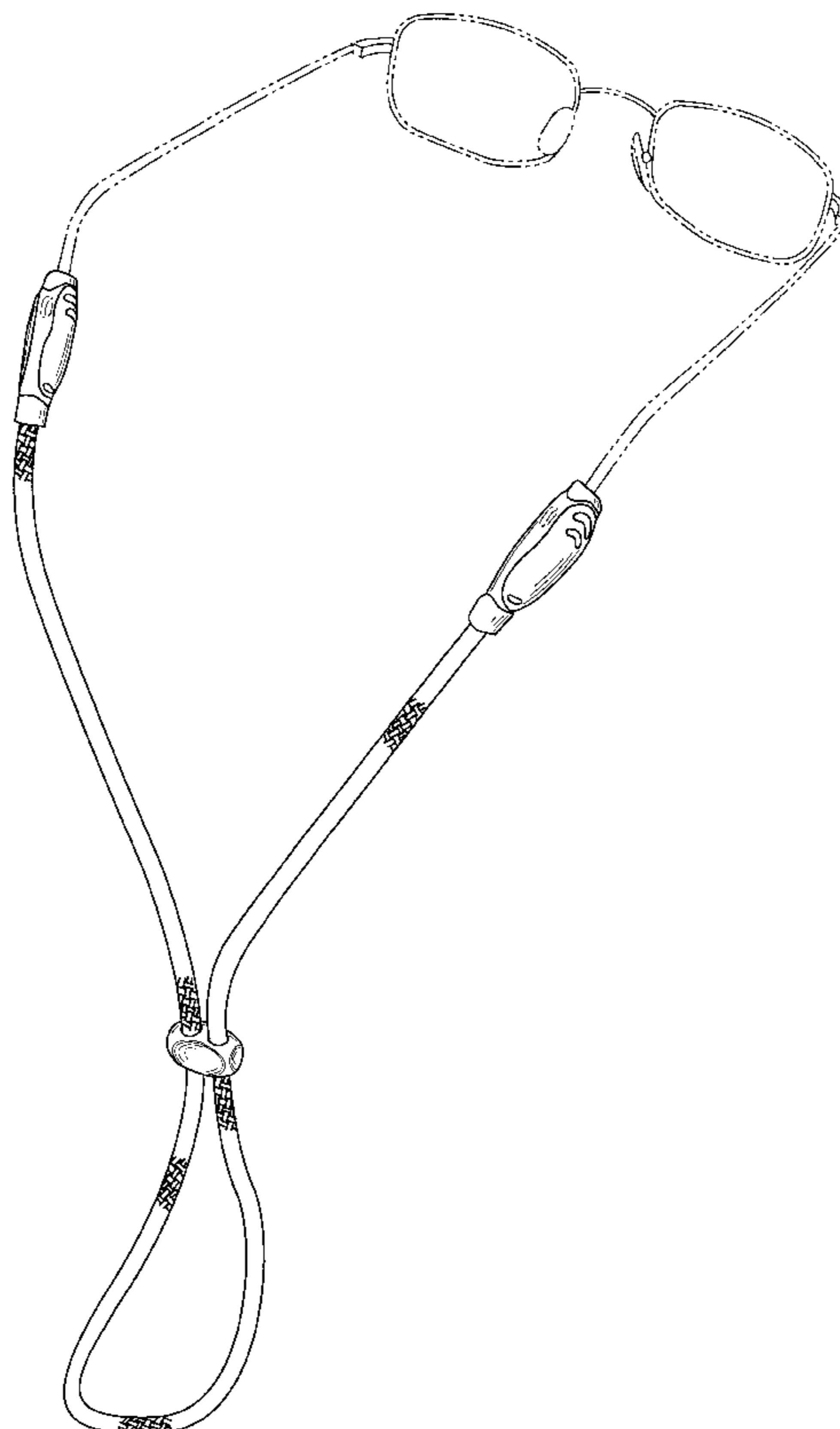
(57) **CLAIM**

The ornamental design for an eyeglass retainer, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the present invention with portions not of the invention being shown in phantom line; FIG. 2 is a view in elevation of the present invention; FIG. 3 is a side elevation view of the invention illustrated in FIG. 2; FIG. 4 is a view of the present invention shown in FIG. 1 looking down from the top of the retainer; and, FIG. 5 is a view of the present invention shown in FIG. 1 looking up from the bottom of the retainer.

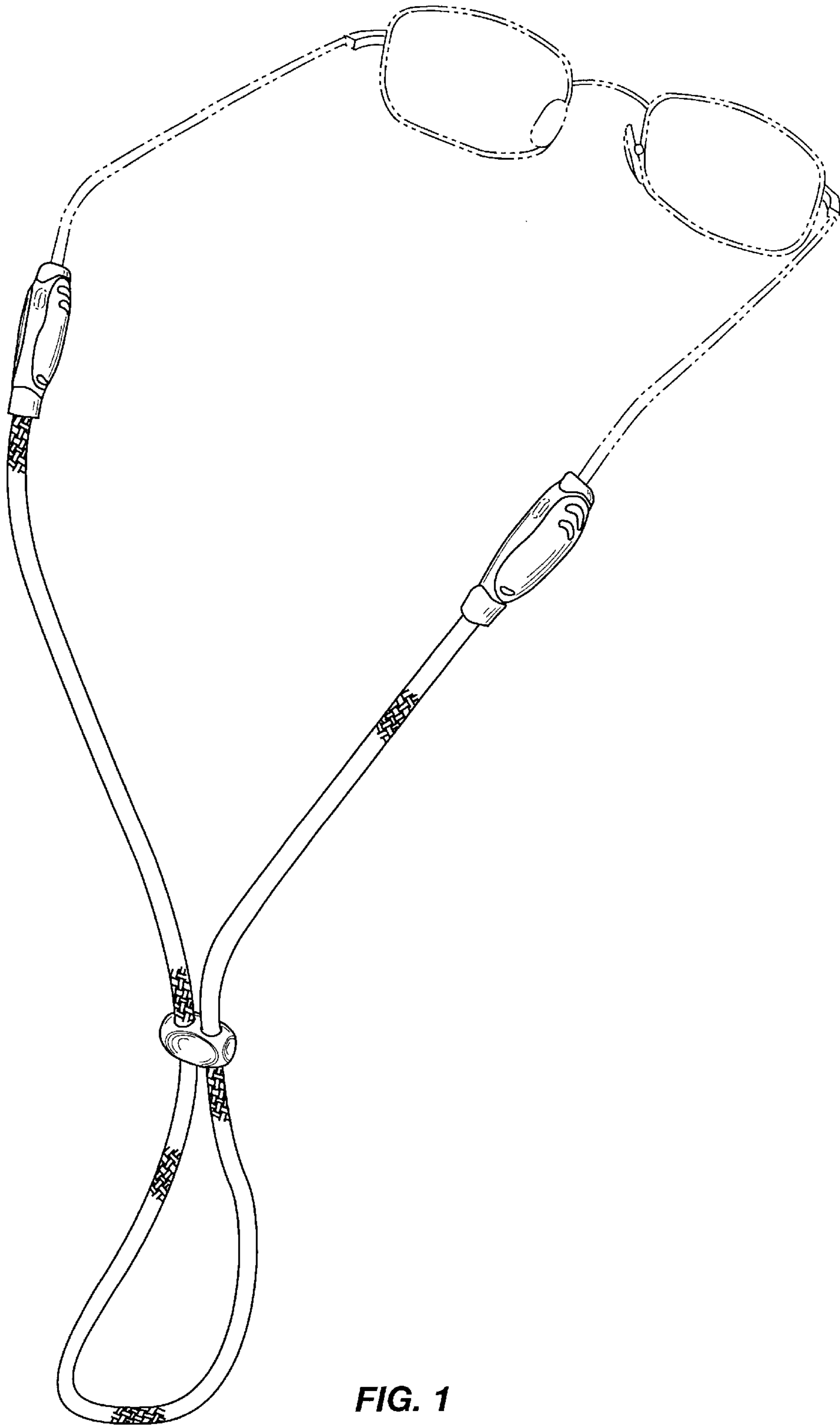

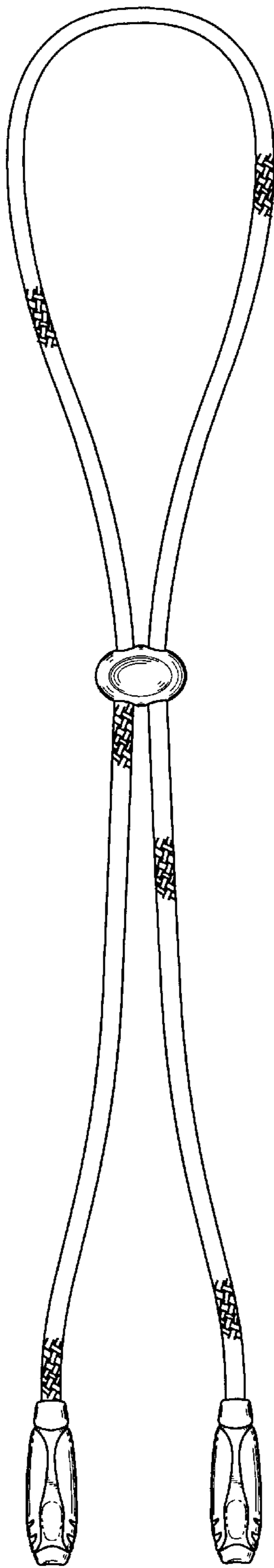
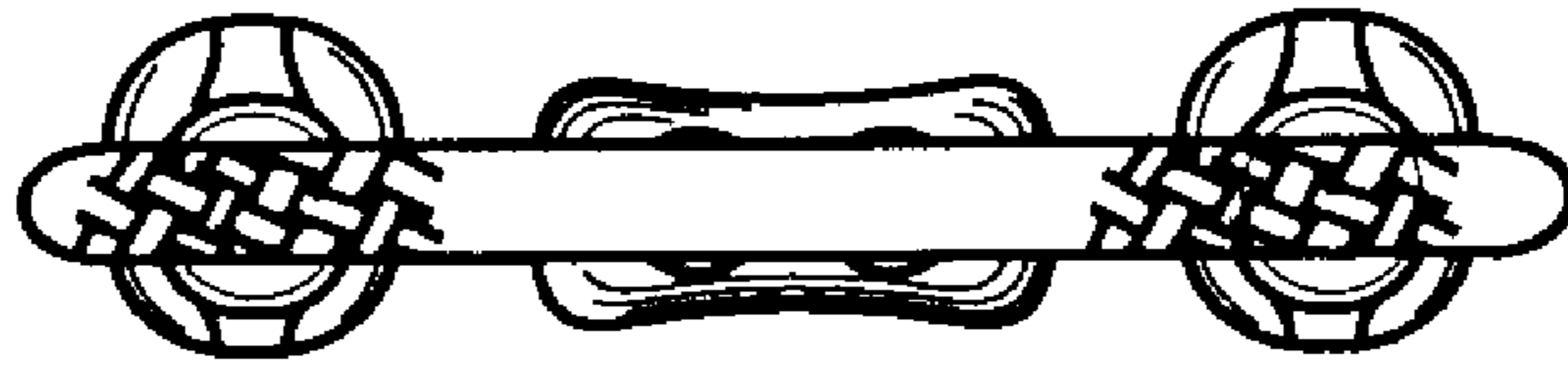


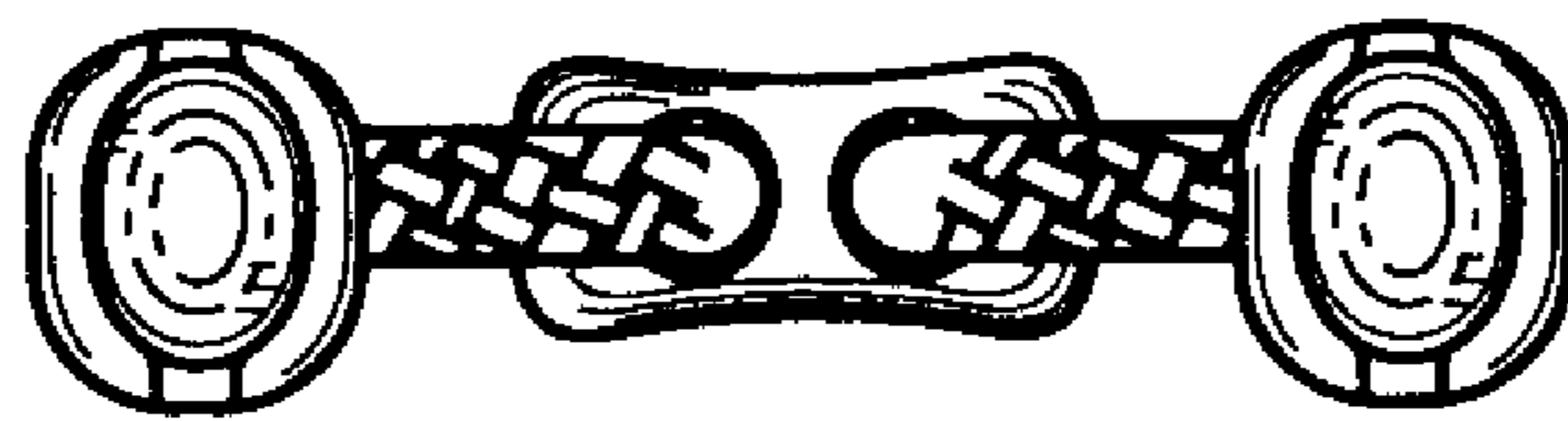
