FIG. 12 is a left side closed view thereof;

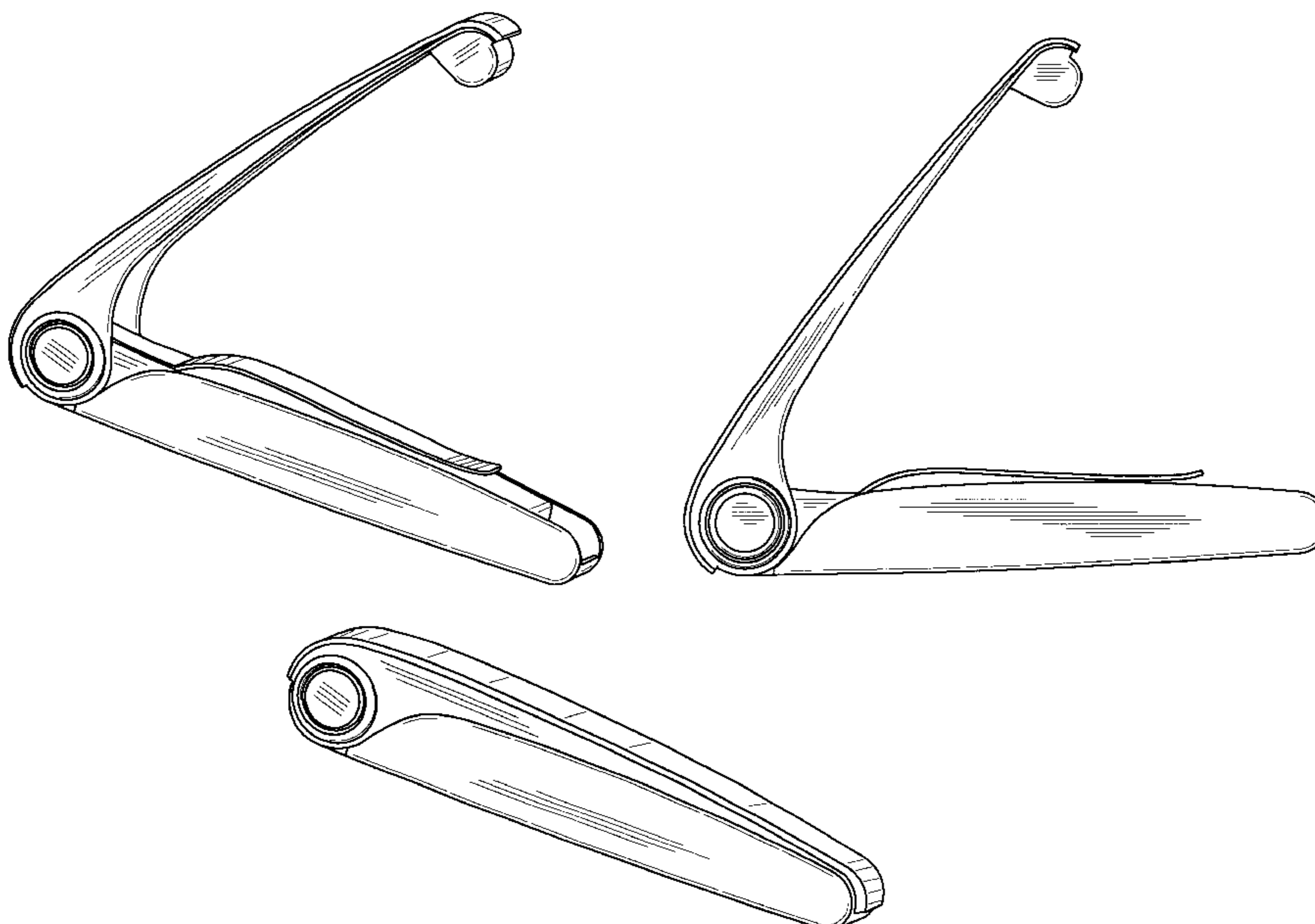
FIG. 13 is a rear closed view thereof;

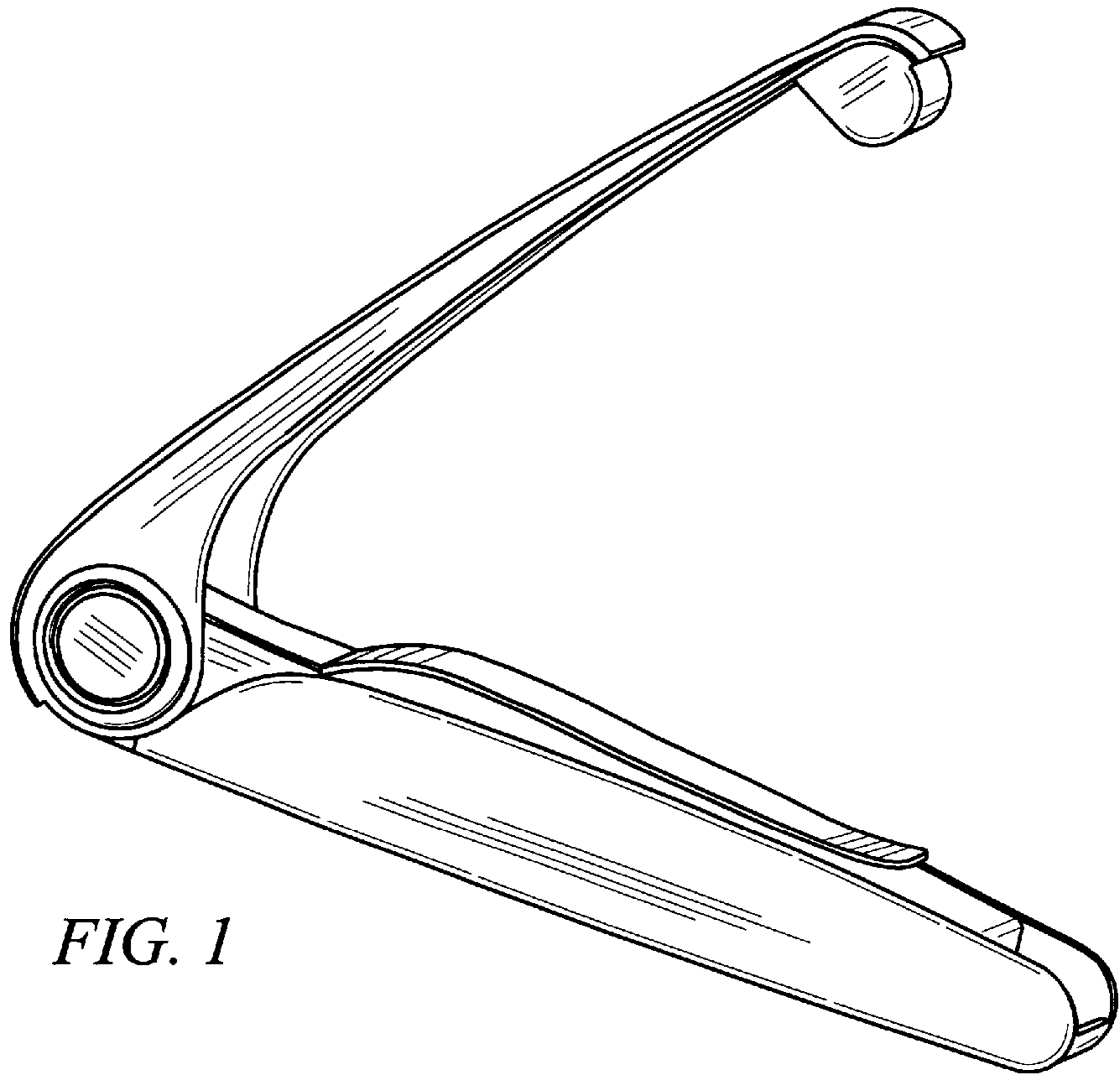

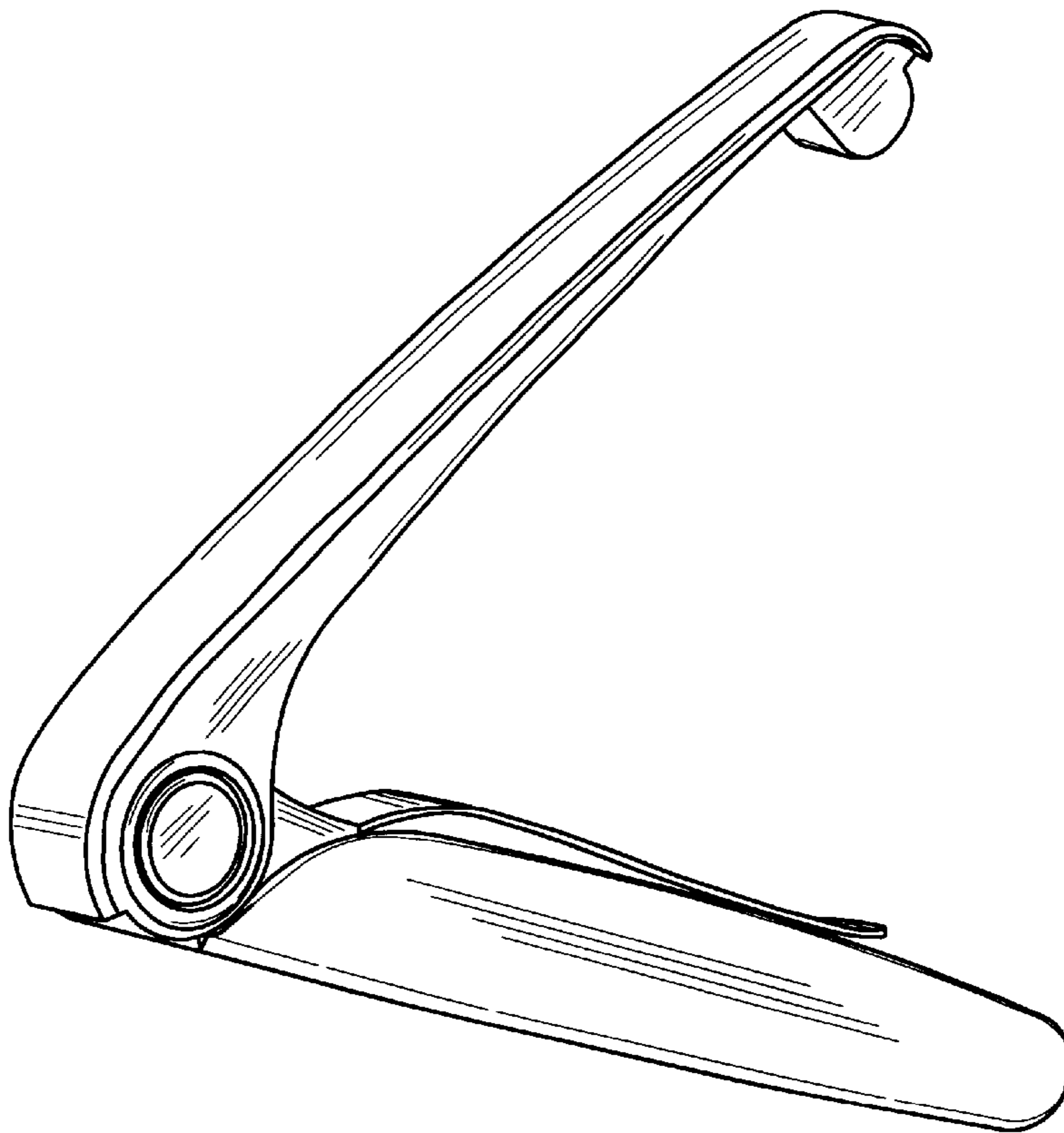

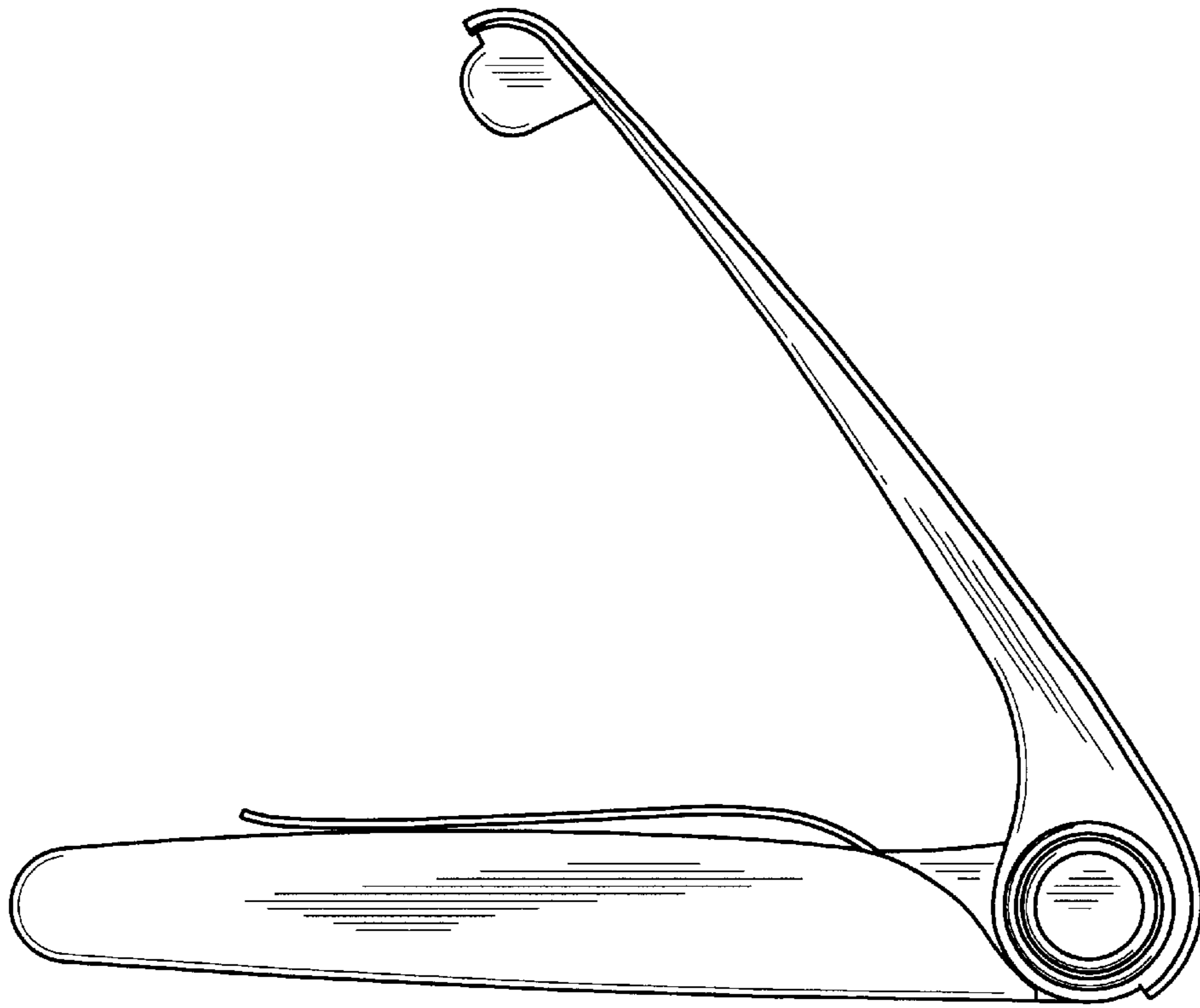

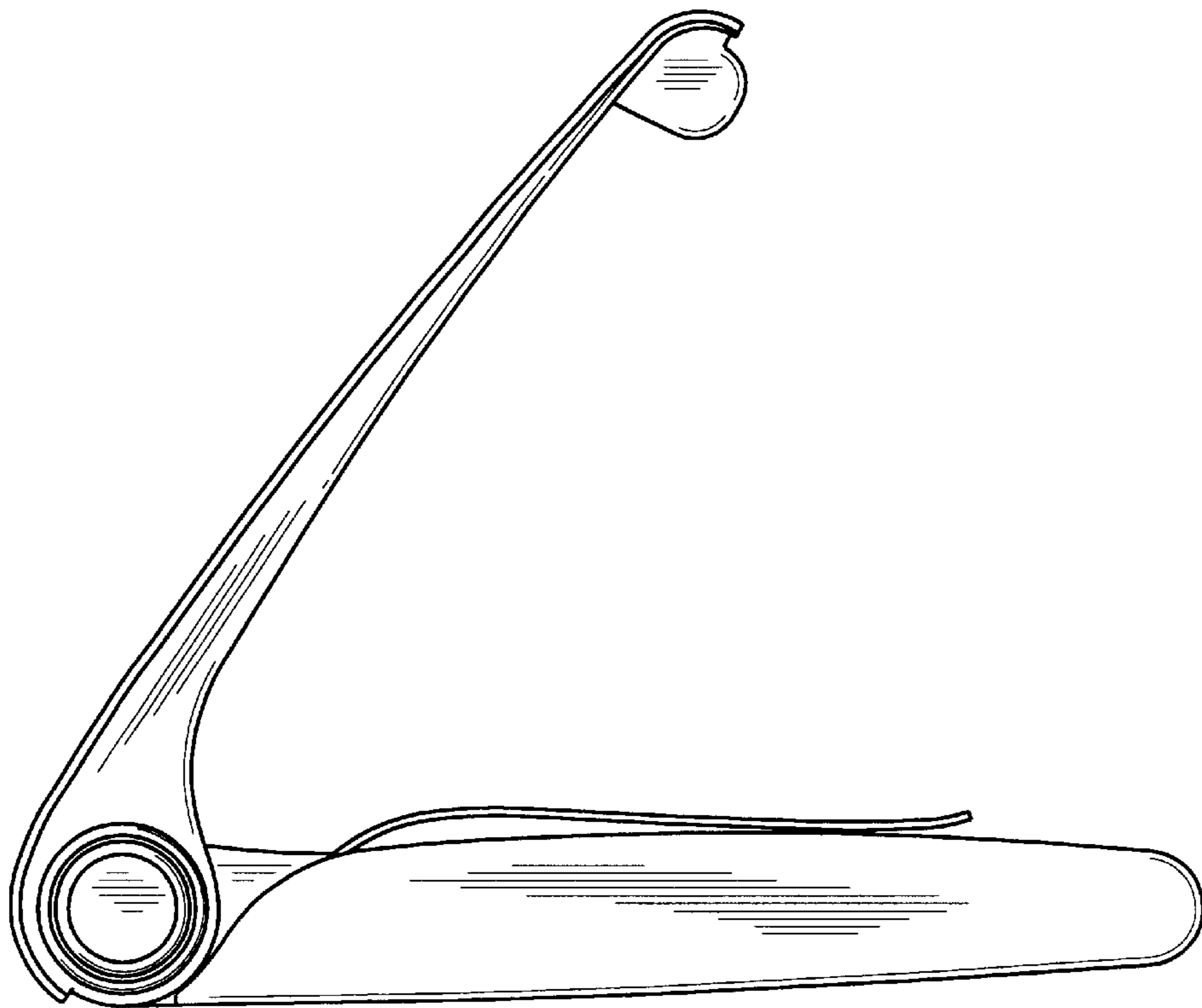

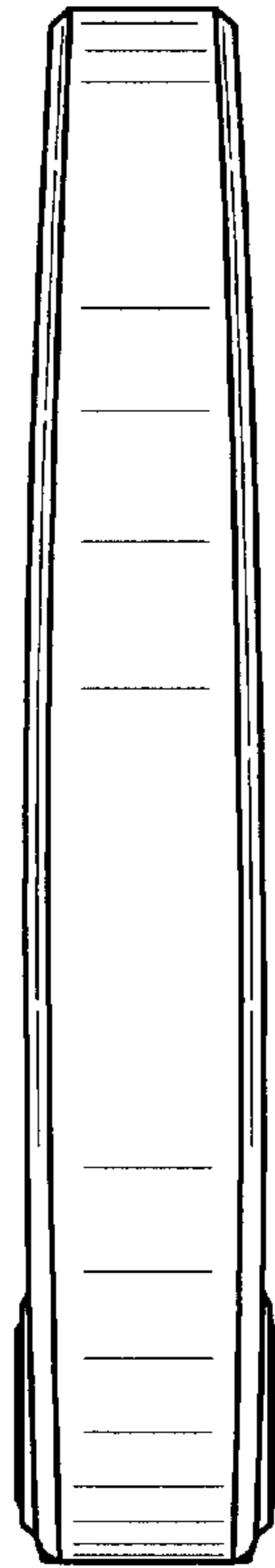

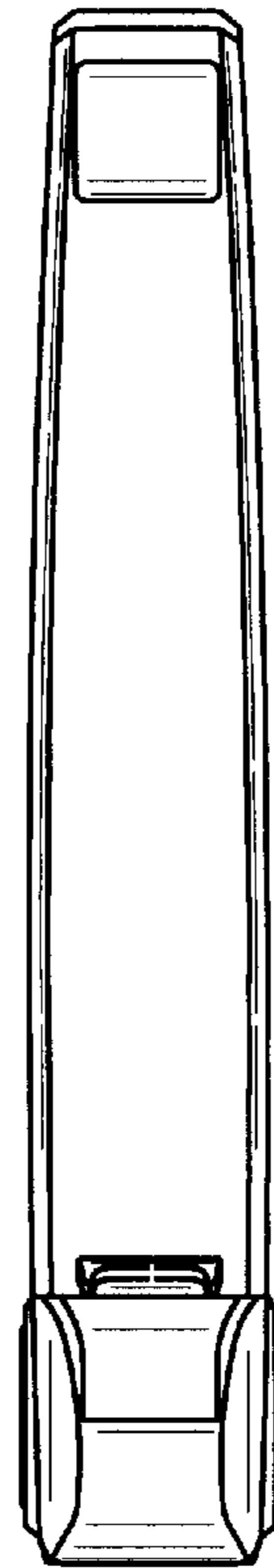

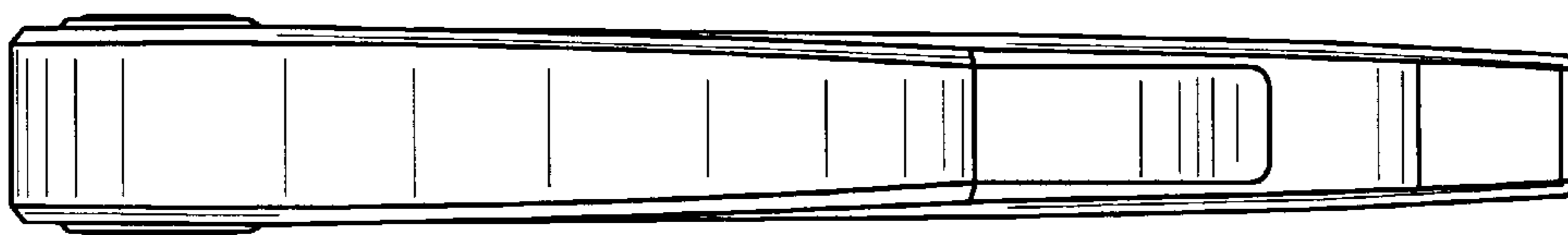

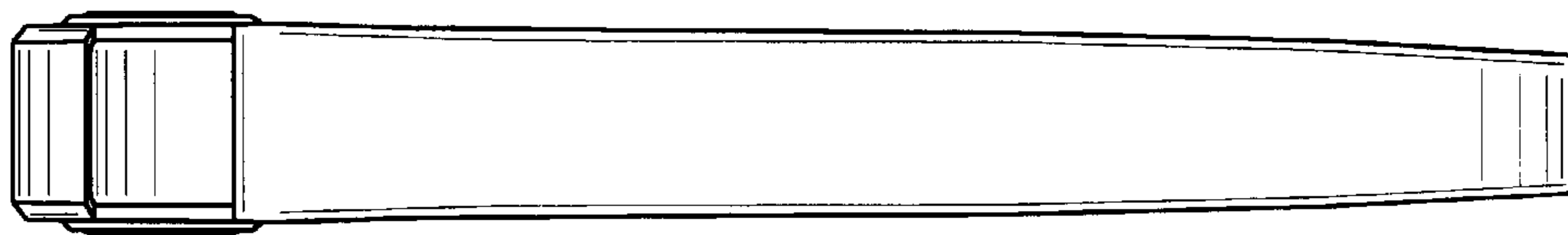

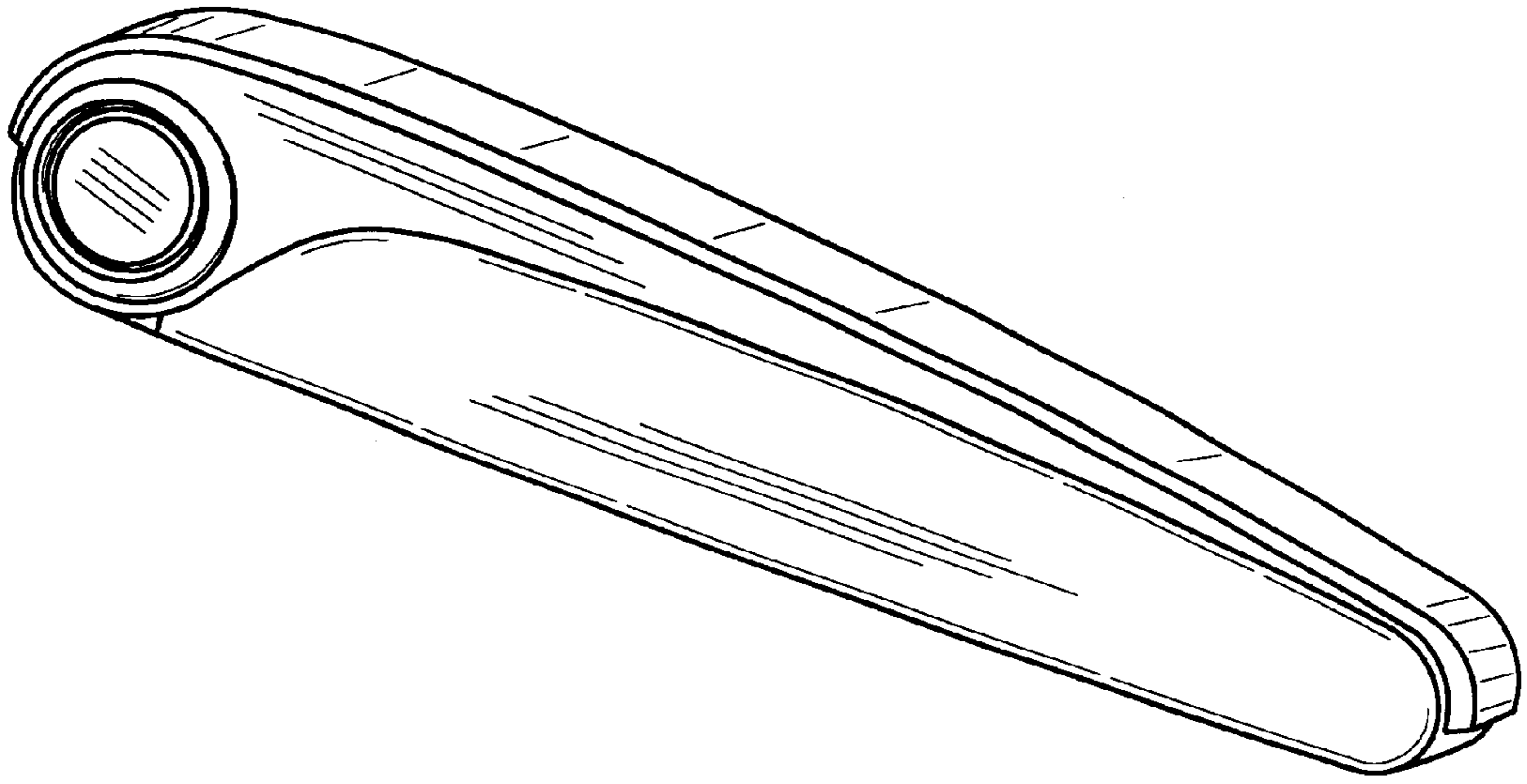

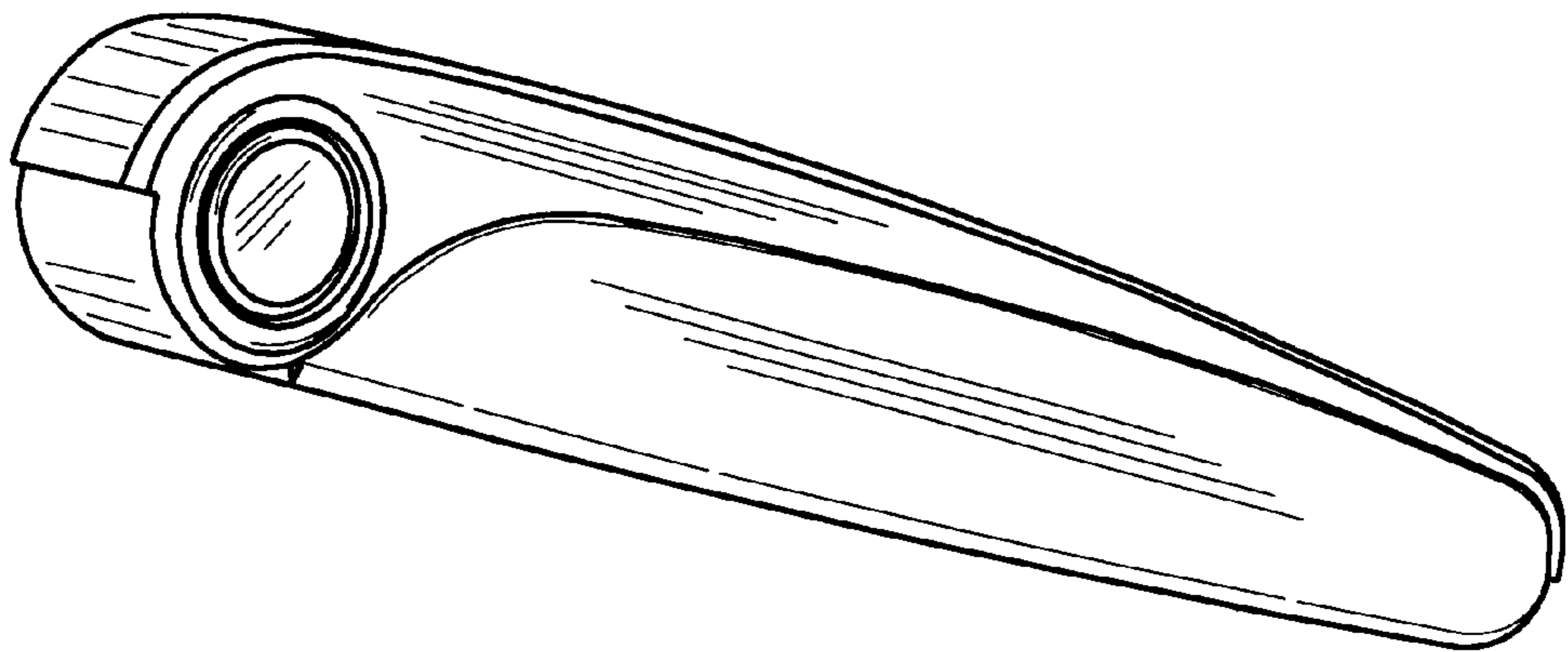

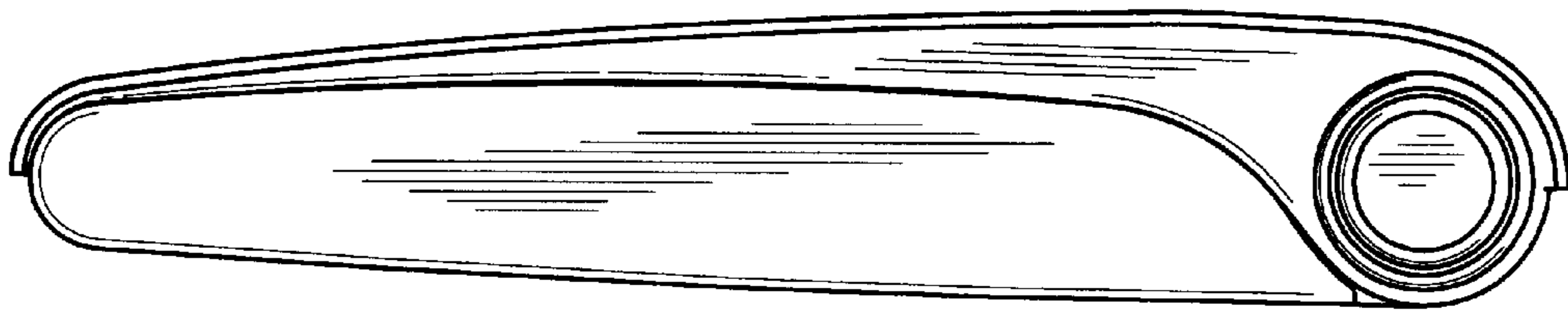

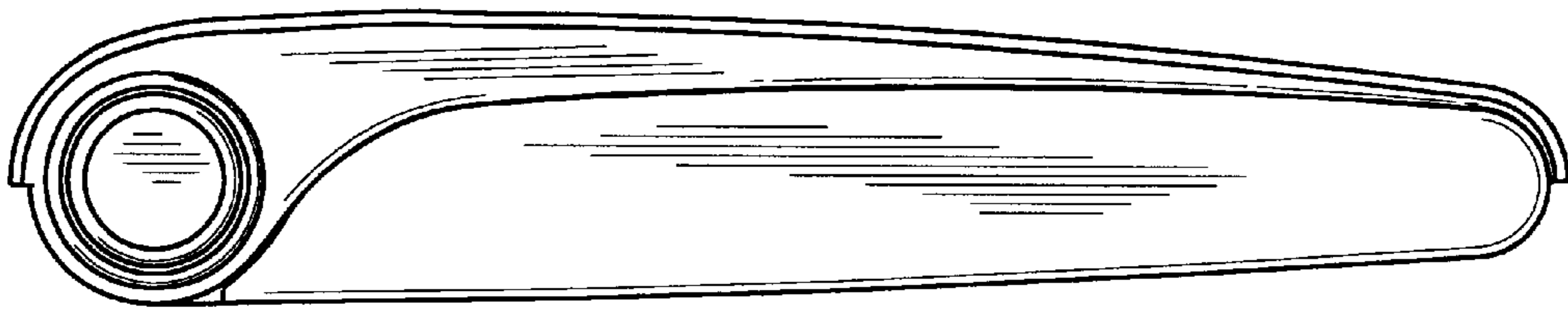

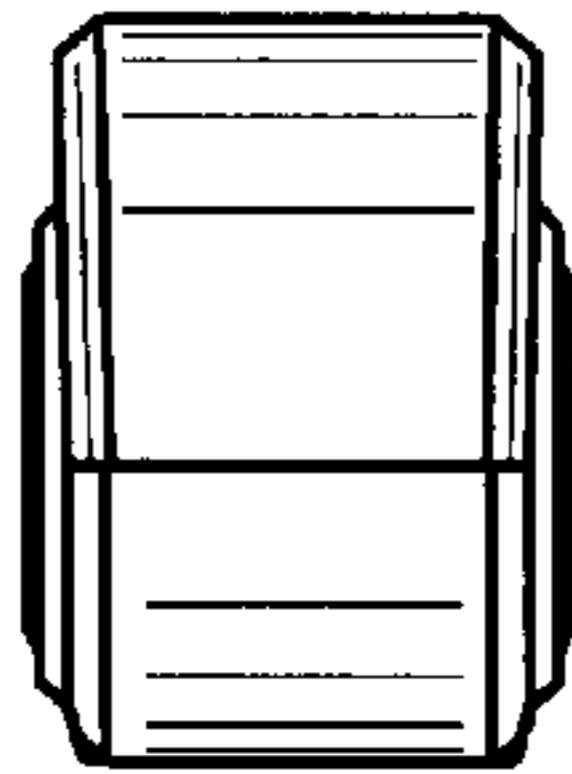

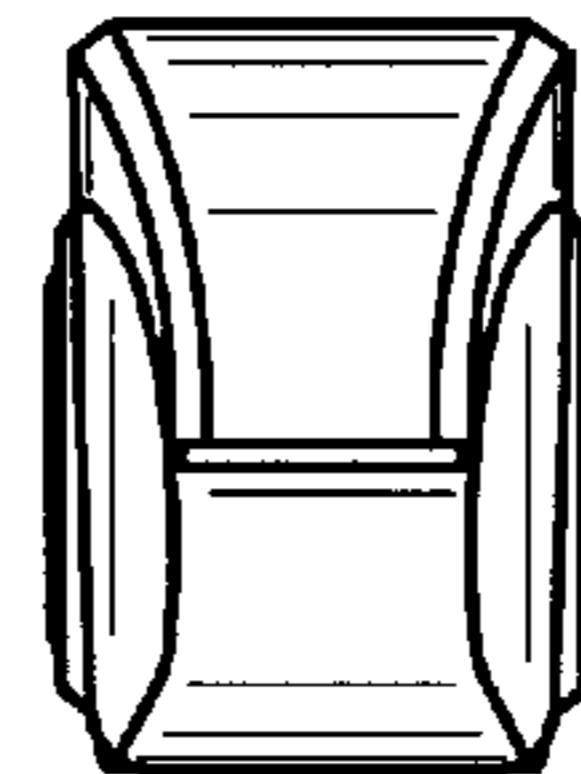

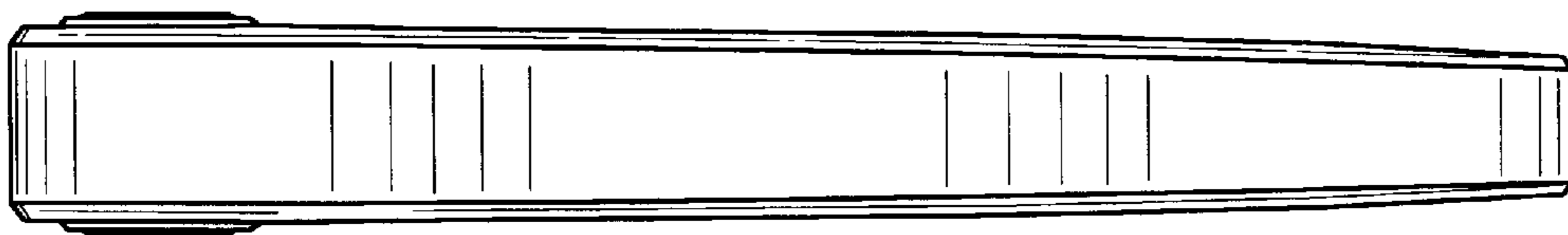

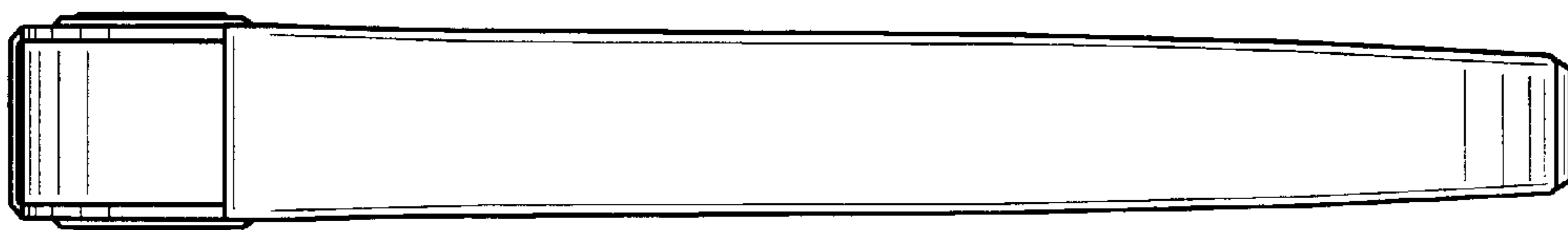
