FIG. 4 is a bottom plan view showing the horseshoe of FIG. 1;

FIG. 5 is a right side view showing the horseshoe of FIG. 1, the left side view being a mirror image of the right side view;

FIG. 6 is a front perspective view showing the horseshoe of FIG. 1; and,

FIG. 7 is a rear perspective view showing the horseshoe of FIG. 1.

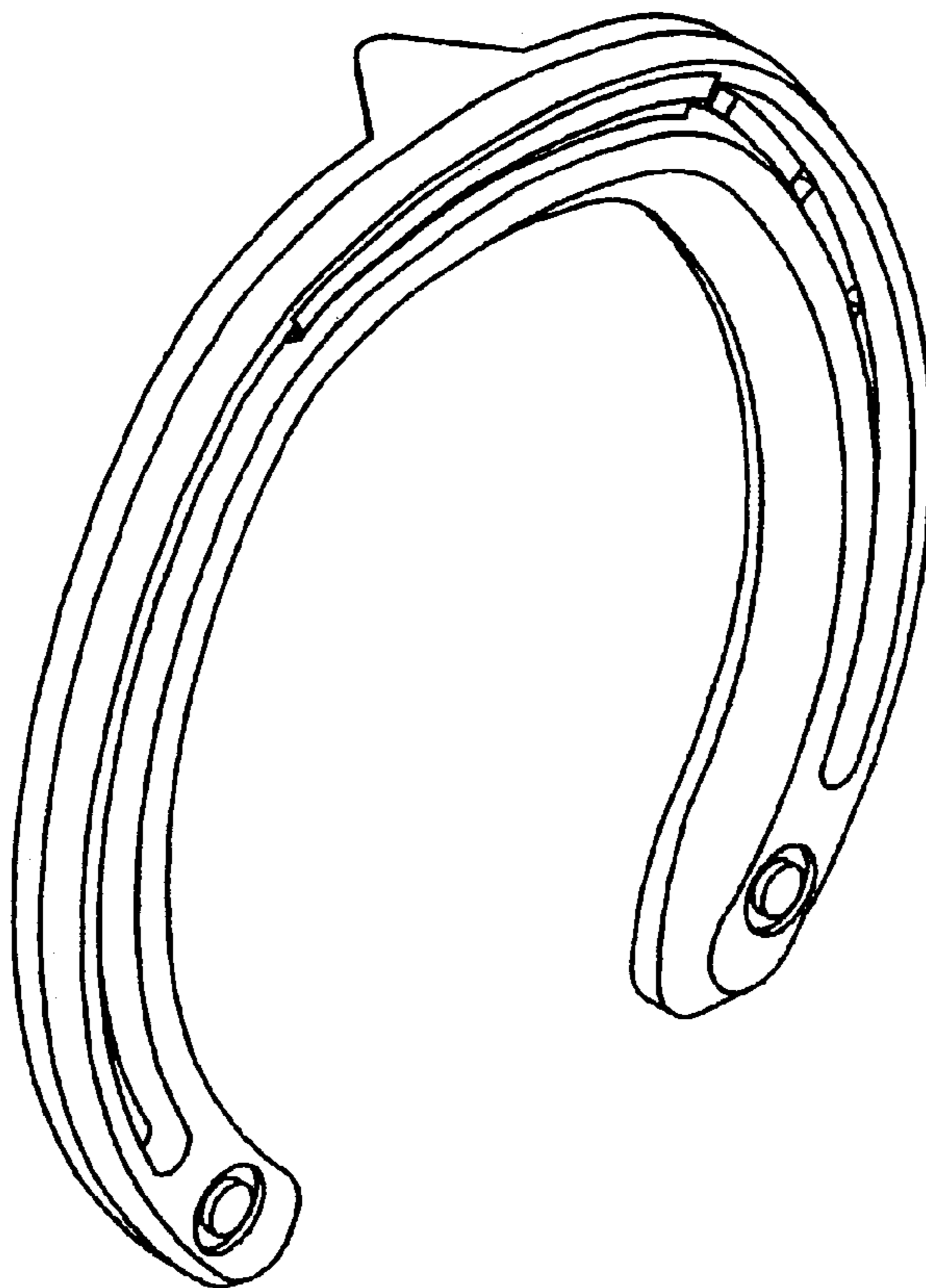

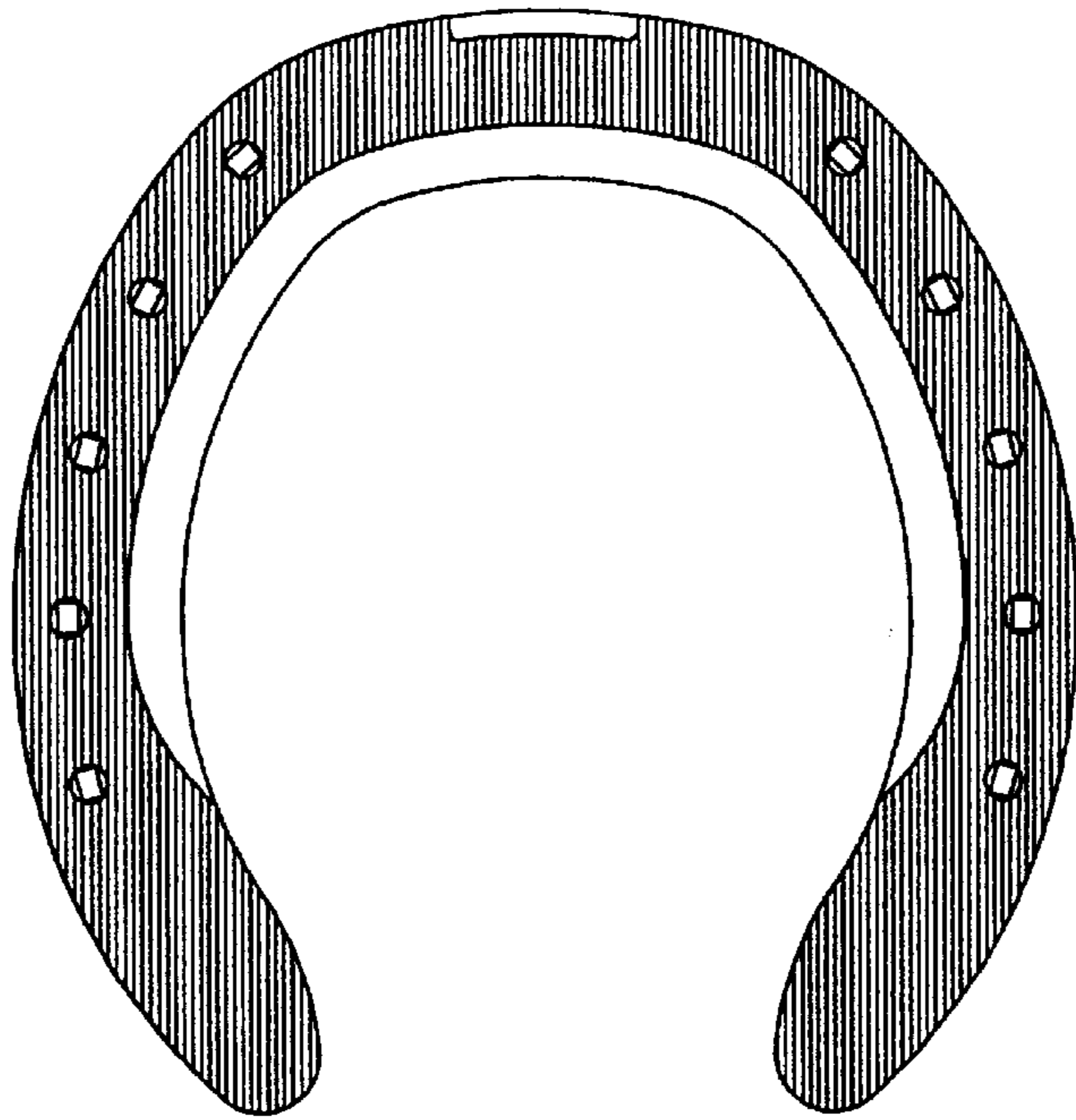

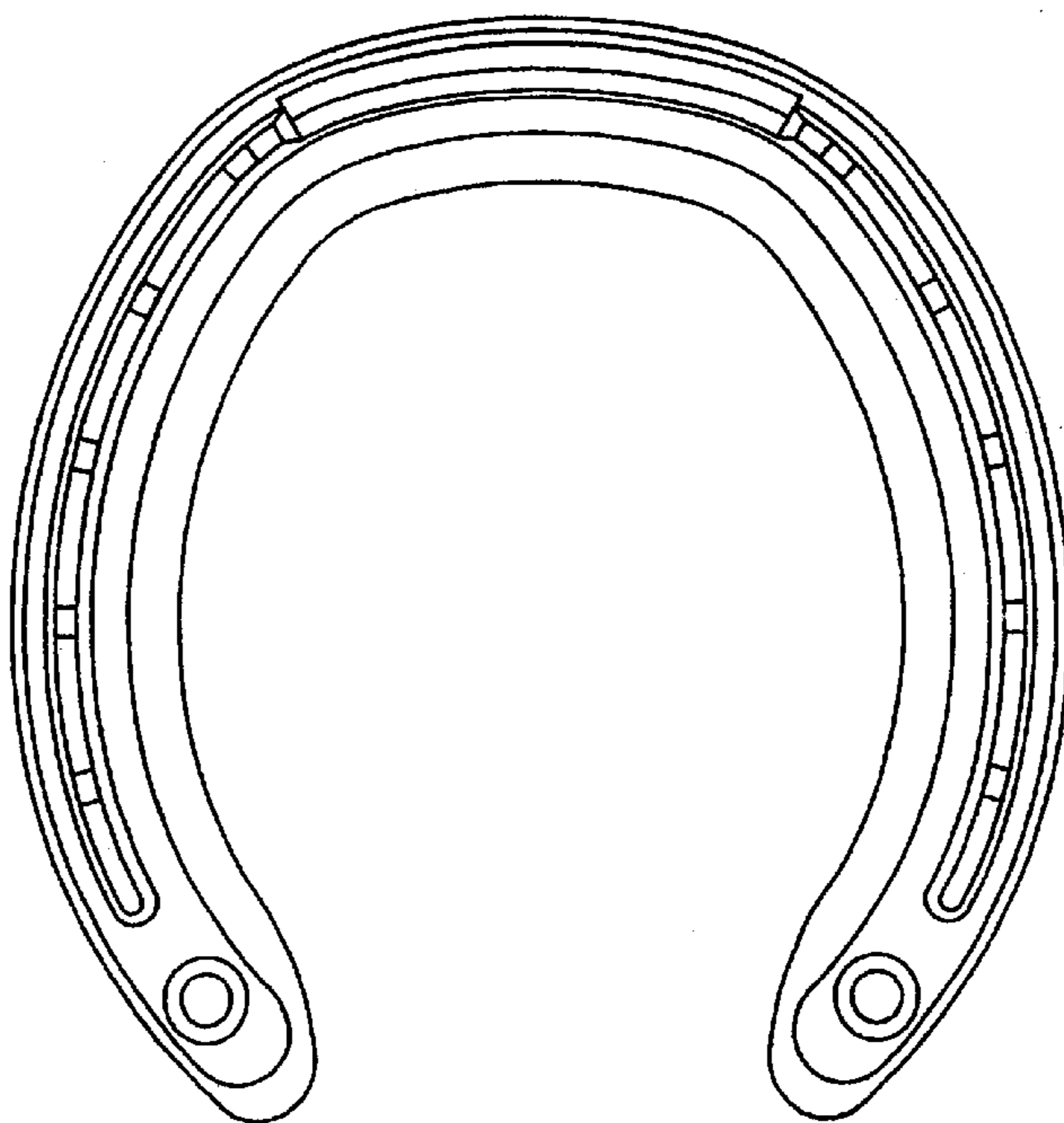

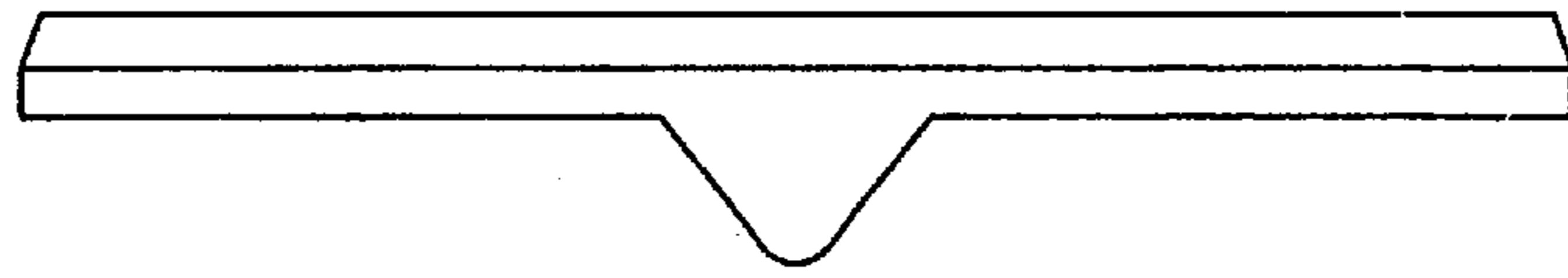

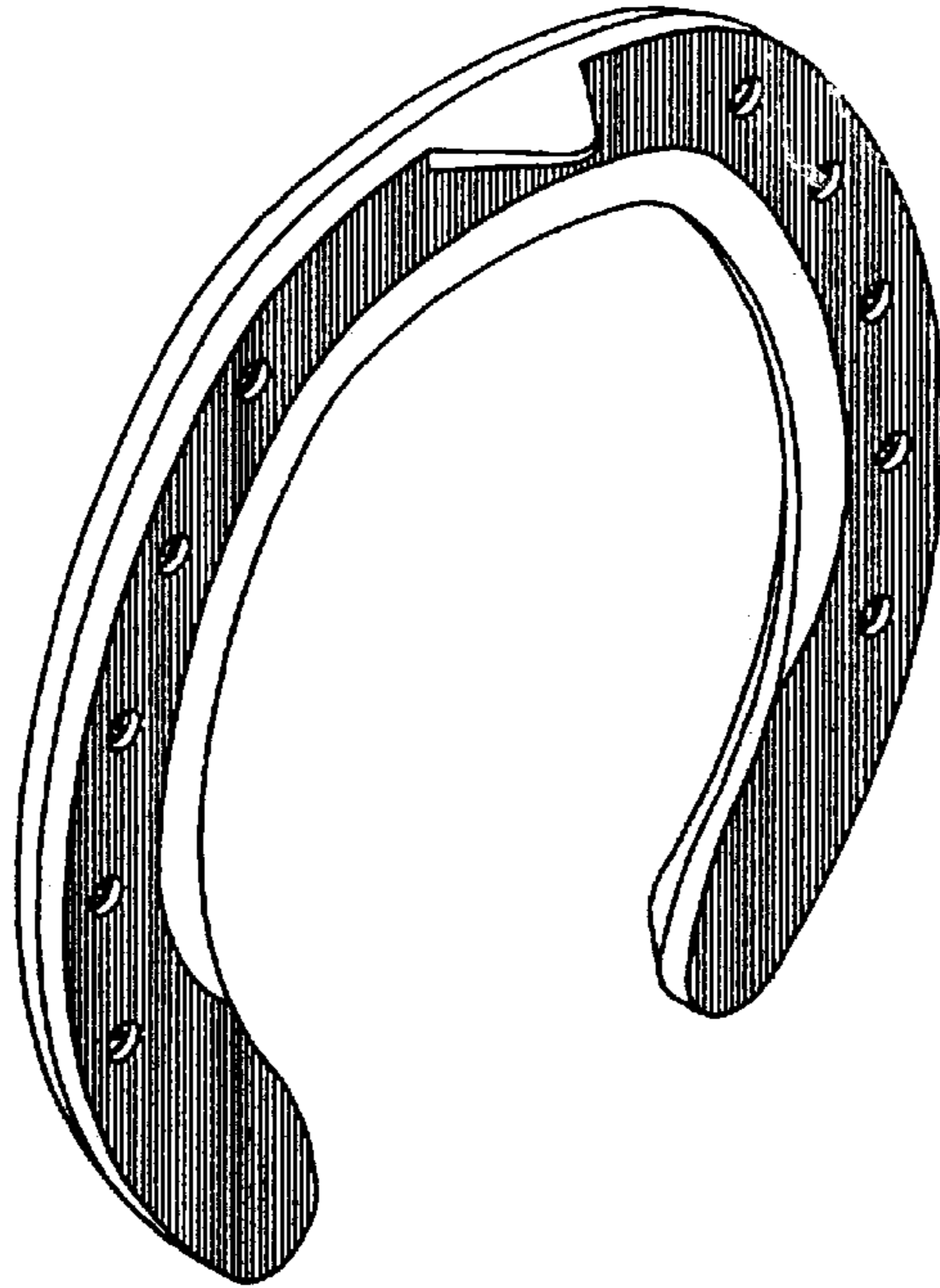
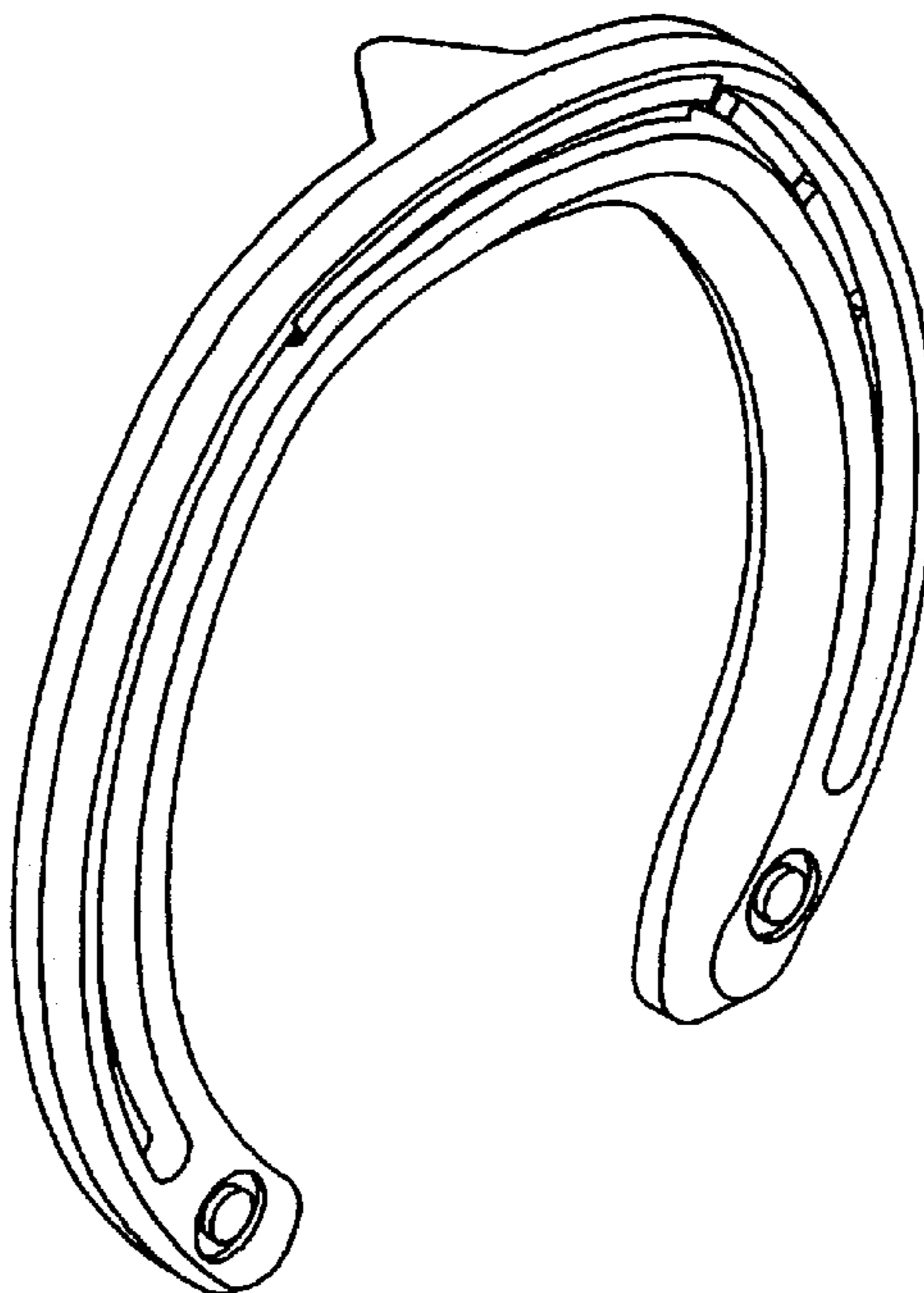
