**DESCRIPTION**

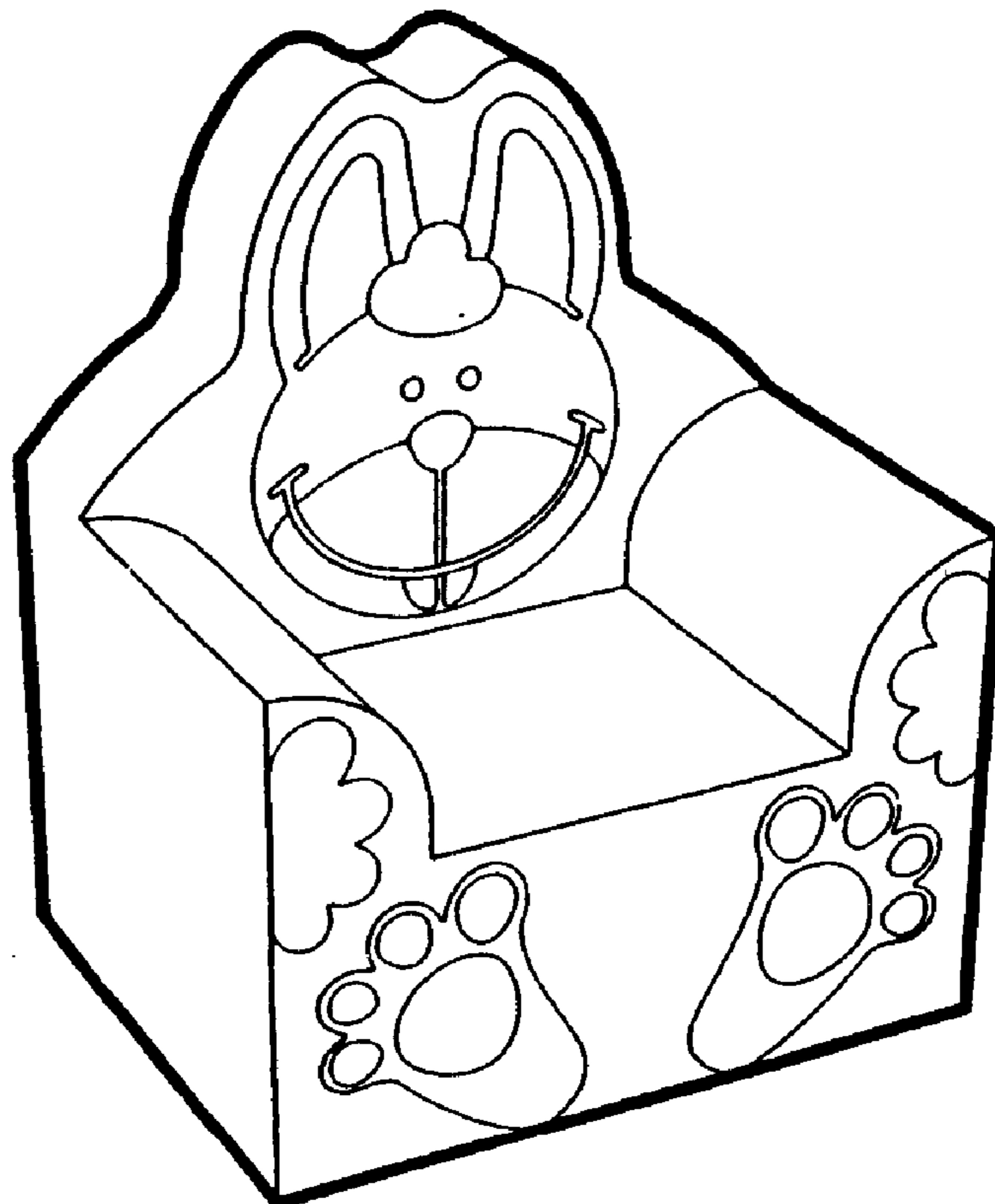
FIG. 1 is a left side view of a rabbit armchair showing my new design;

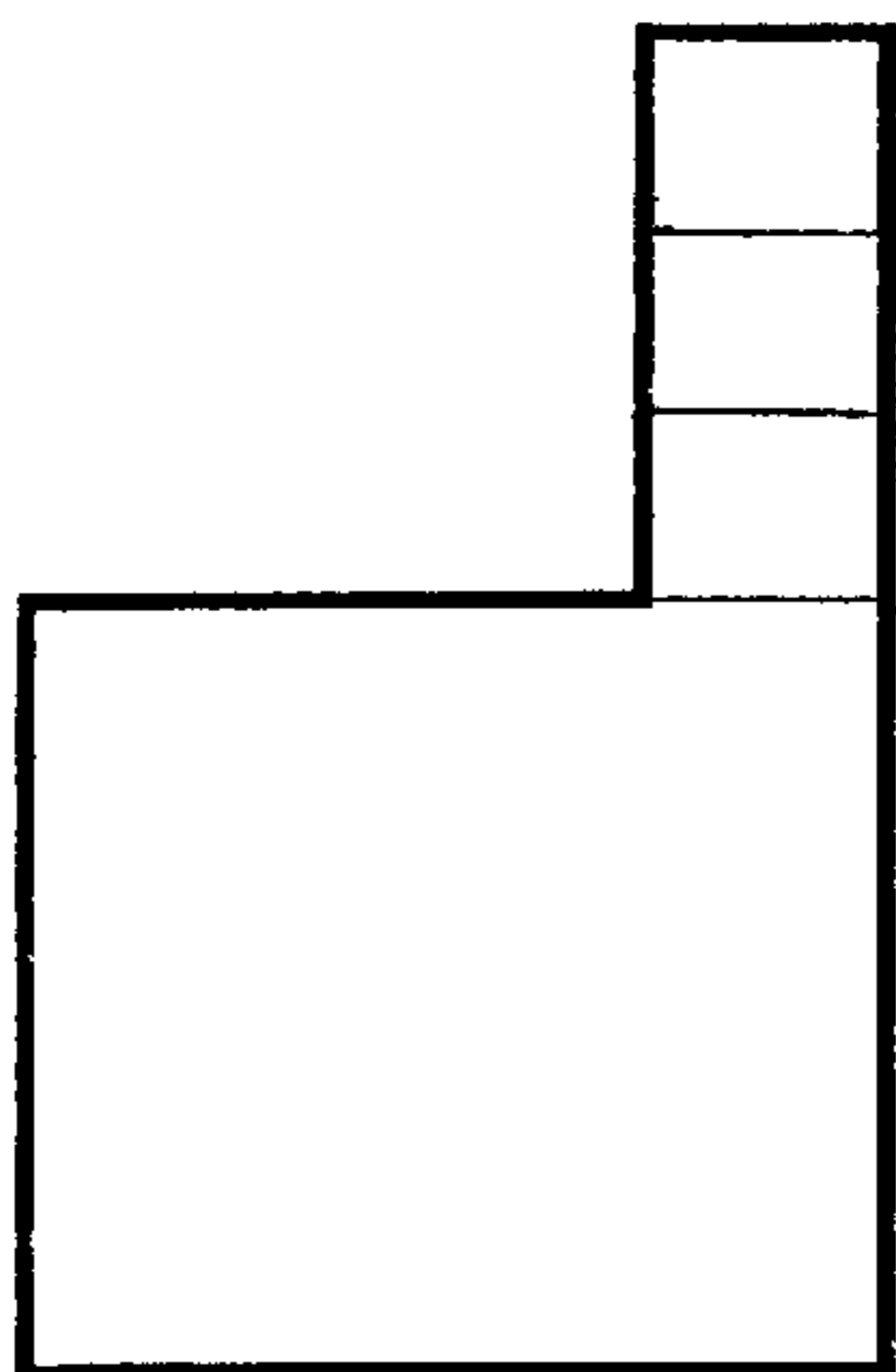

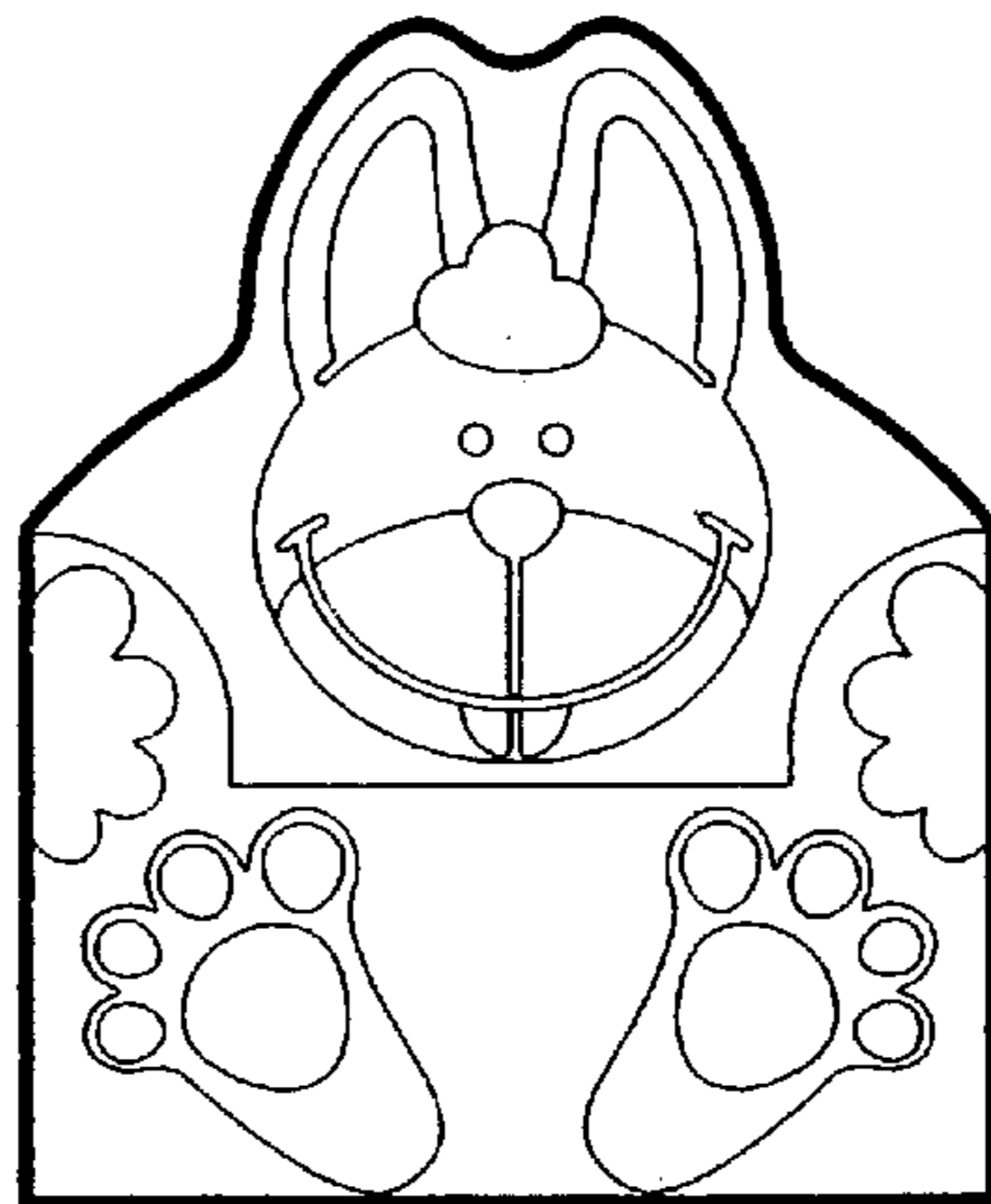

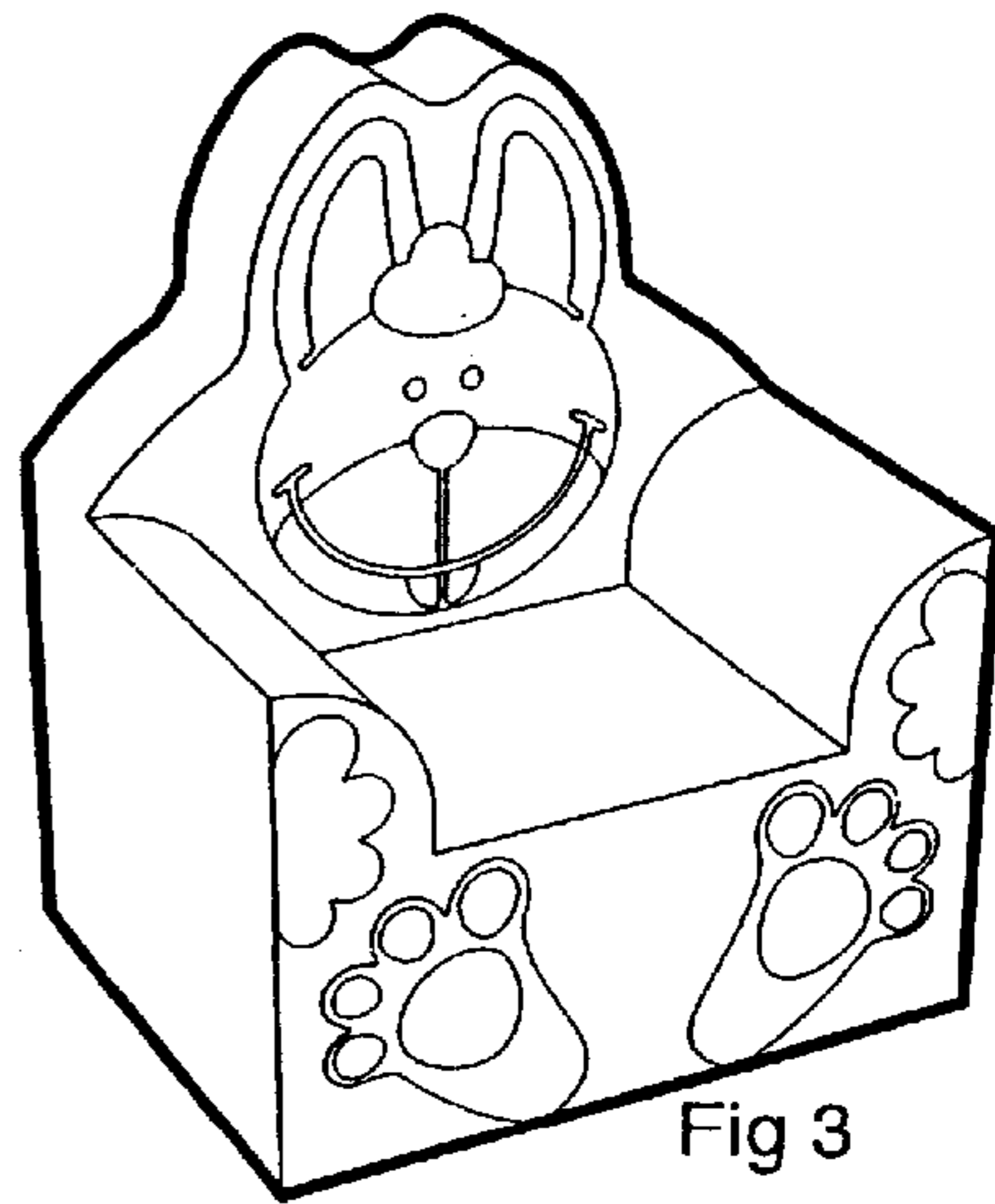
