(57) **CLAIM**

The ornamental design for a translucent cosmetic container with LED illumination means, as shown and described.

DESCRIPTION

FIG. 1 shows a top perspective frontal view of the translucent cosmetic container with LED illumination means, and showing our new design;

FIG. 2 shows a front view thereof;

FIG. 3 shows a bottom perspective frontal view thereof;

FIG. 4 shows a rear view thereof;

FIG. 5 shows a side view thereof, the opposite view being a mirror image;

FIG. 6 shows a top view thereof;

FIG. 7 shows bottom view thereof;

FIG. 8 shows a sectional front view thereof, the section taken along lines 8—8 shown in FIG. 5, and with said section not taken through the cosmetic spray dispenser and its associated battery powered LED illumination means;

FIG. 9 shows a sectional top perspective frontal view thereof, the section taken along lines 9—9 shown in FIG. 1, and with the section not taken through the cosmetic spray dispenser and its associated battery powered LED illumination means;

FIG. 10 shows a second sectional top perspective side view thereof, the section taken along lines 10—10 shown in FIG. 1, and with the section not taken through the cosmetic spray dispenser and its associated battery powered LED illumination means;

FIG. 11 shows a sectional side view thereof, the section taken along lines 11—11 shown in FIG. 2, and with the section not taken through the cosmetic spray dispenser and its associated battery powered LED illumination means;

FIG. 12 shows a sectional front view thereof, the section taken along lines 12—12 shown in FIG. 2, and with the section not taken through the cosmetic spray dispenser and its associated battery powered LED illumination means;

FIG. 13 shows a top perspective frontal view of a modified embodiment of the translucent cosmetic container with LED illumination means, and showing our new design with a parting line shown;

FIG. 14 shows a front view thereof;

FIG. 15 shows a bottom perspective frontal view thereof;

FIG. 16 shows a rear view thereof;

FIG. 17 shows a side view thereof, the opposite view being a mirror image;

FIG. 18 shows a top view thereof;

FIG. 19 shows a bottom view thereof;

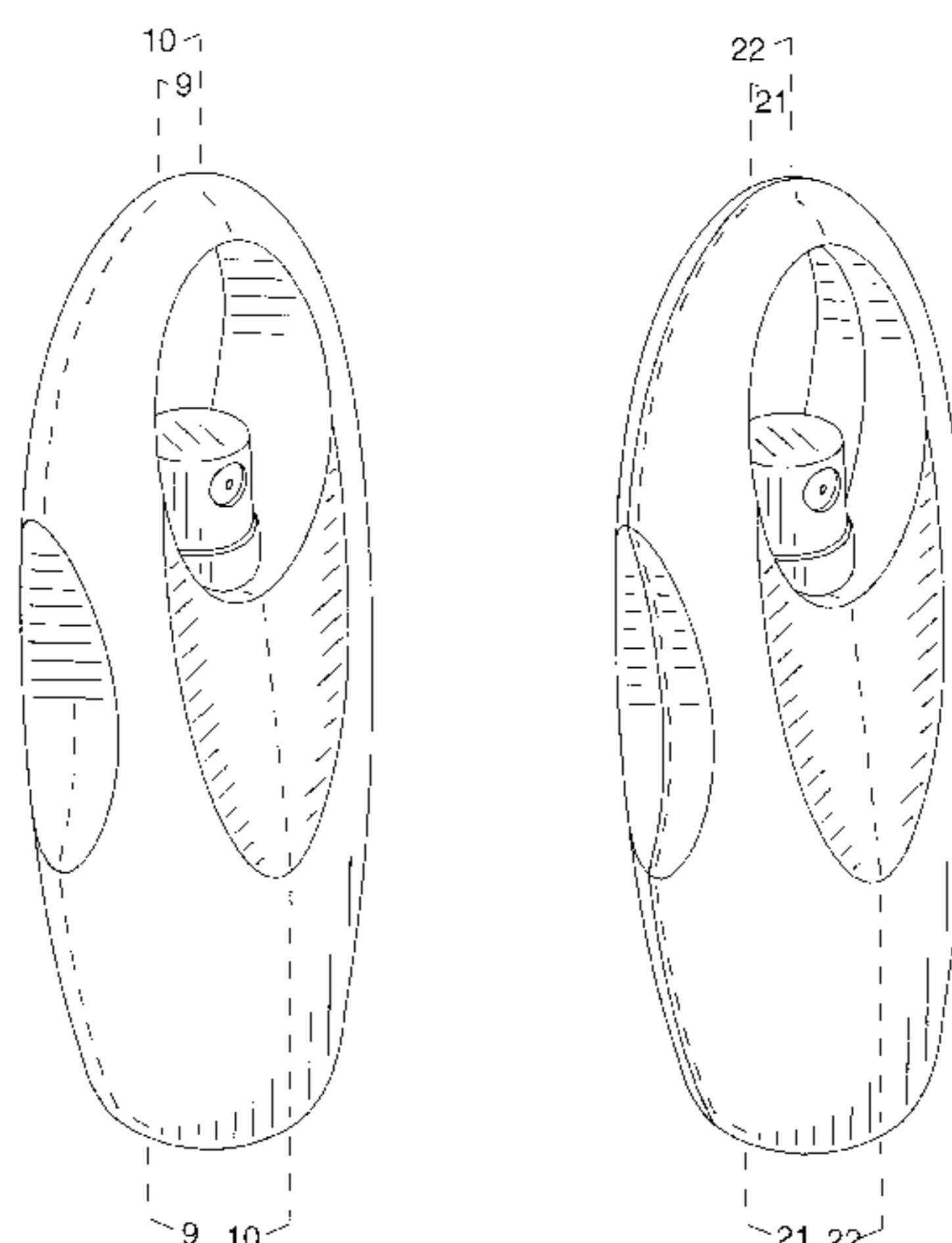

FIG. 23 shows a sectional side view thereof, the section taken along lines 23—23 shown in FIG. 14, and with the section not taken through the cosmetic spray dispenser and its associated battery powered LED illumination means; and,

FIG. 24 shows a sectional front view thereof, the section taken along lines 24—24 shown in FIG. 14, and with the section not taken through the cosmetic spray dispenser and its associated battery powered LED illumination means.

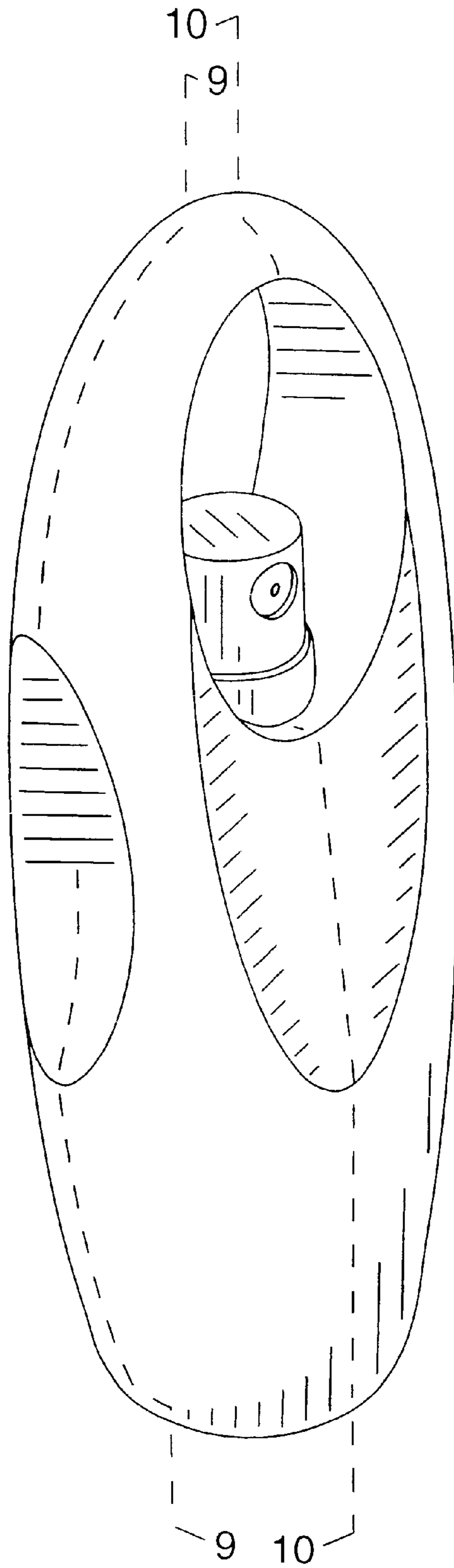

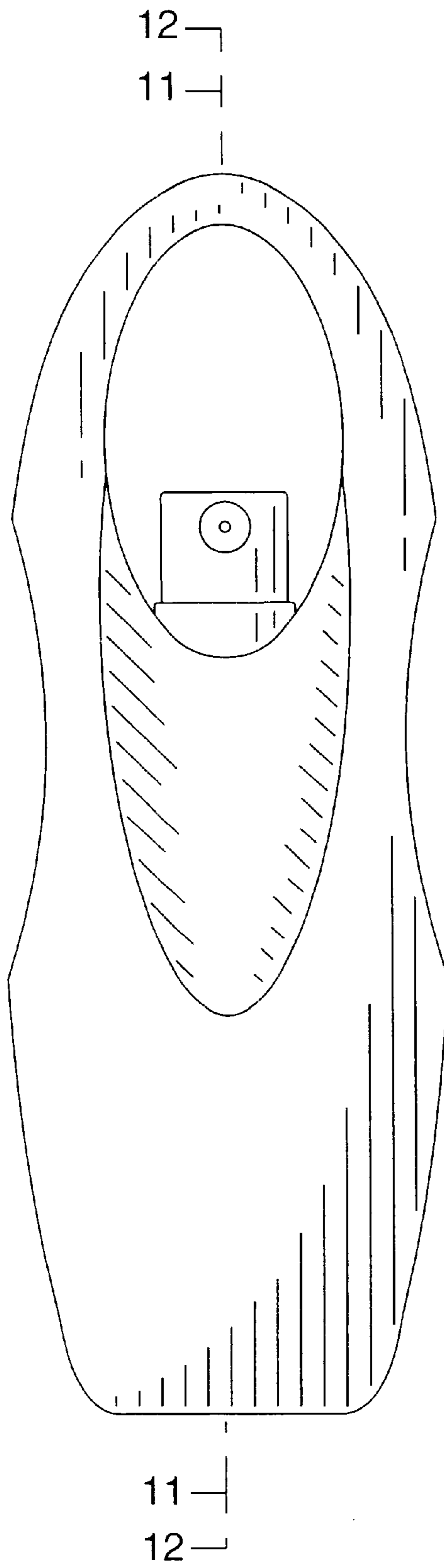

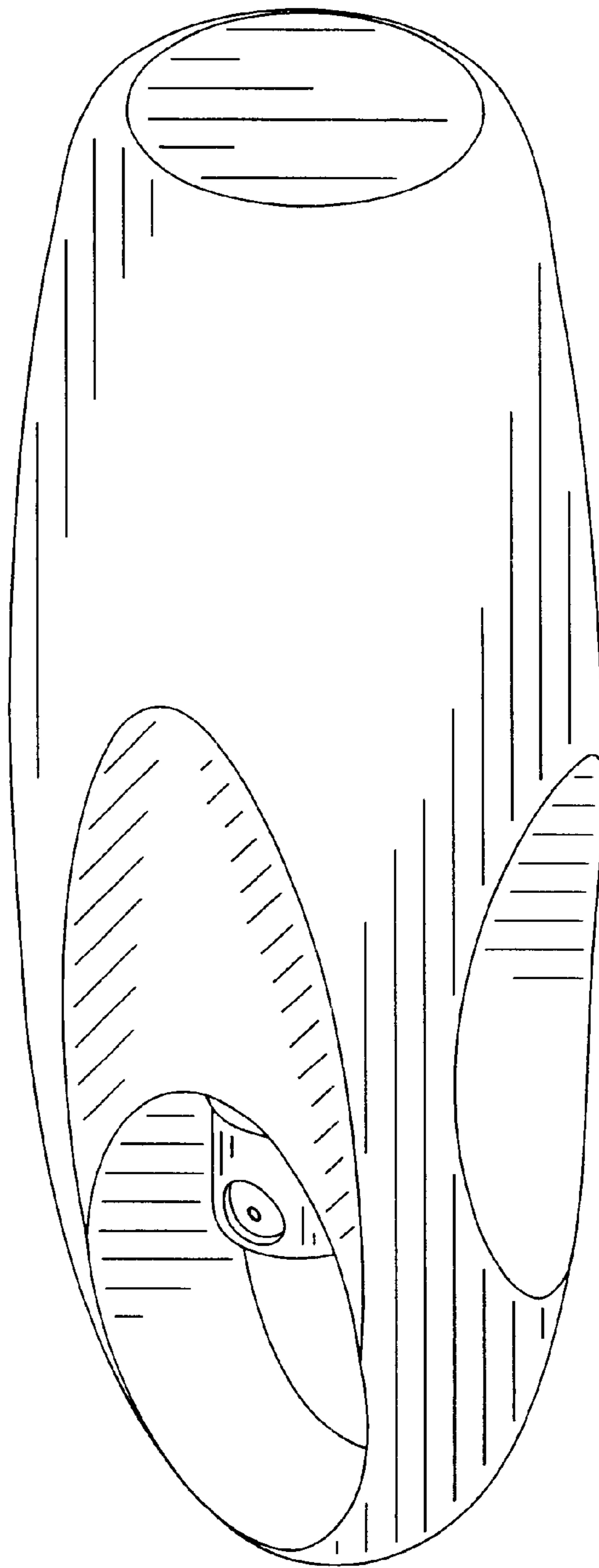

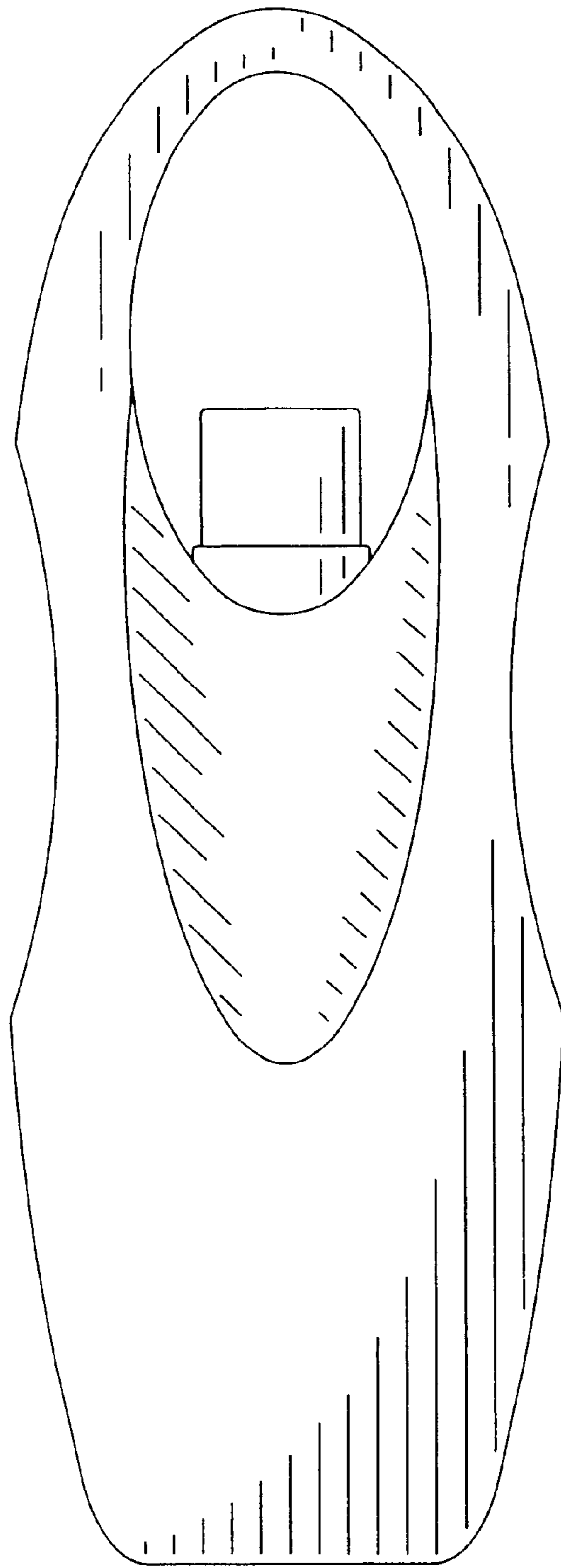

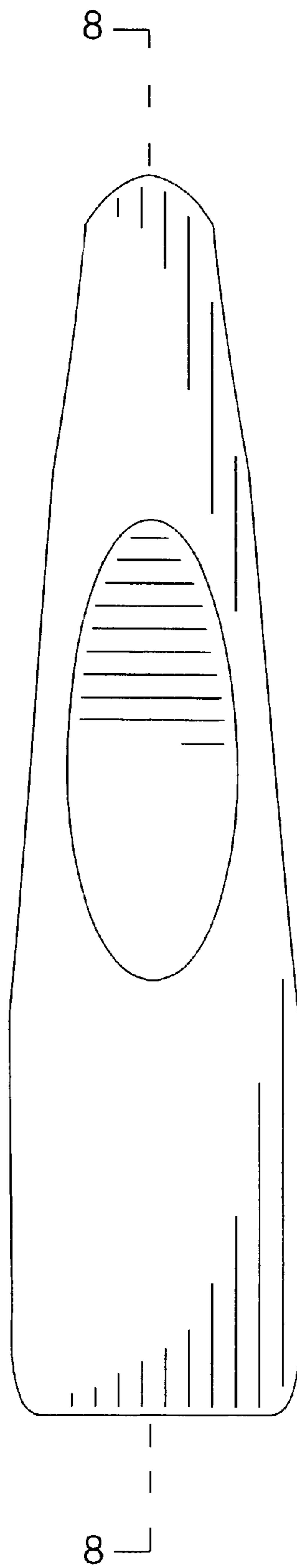

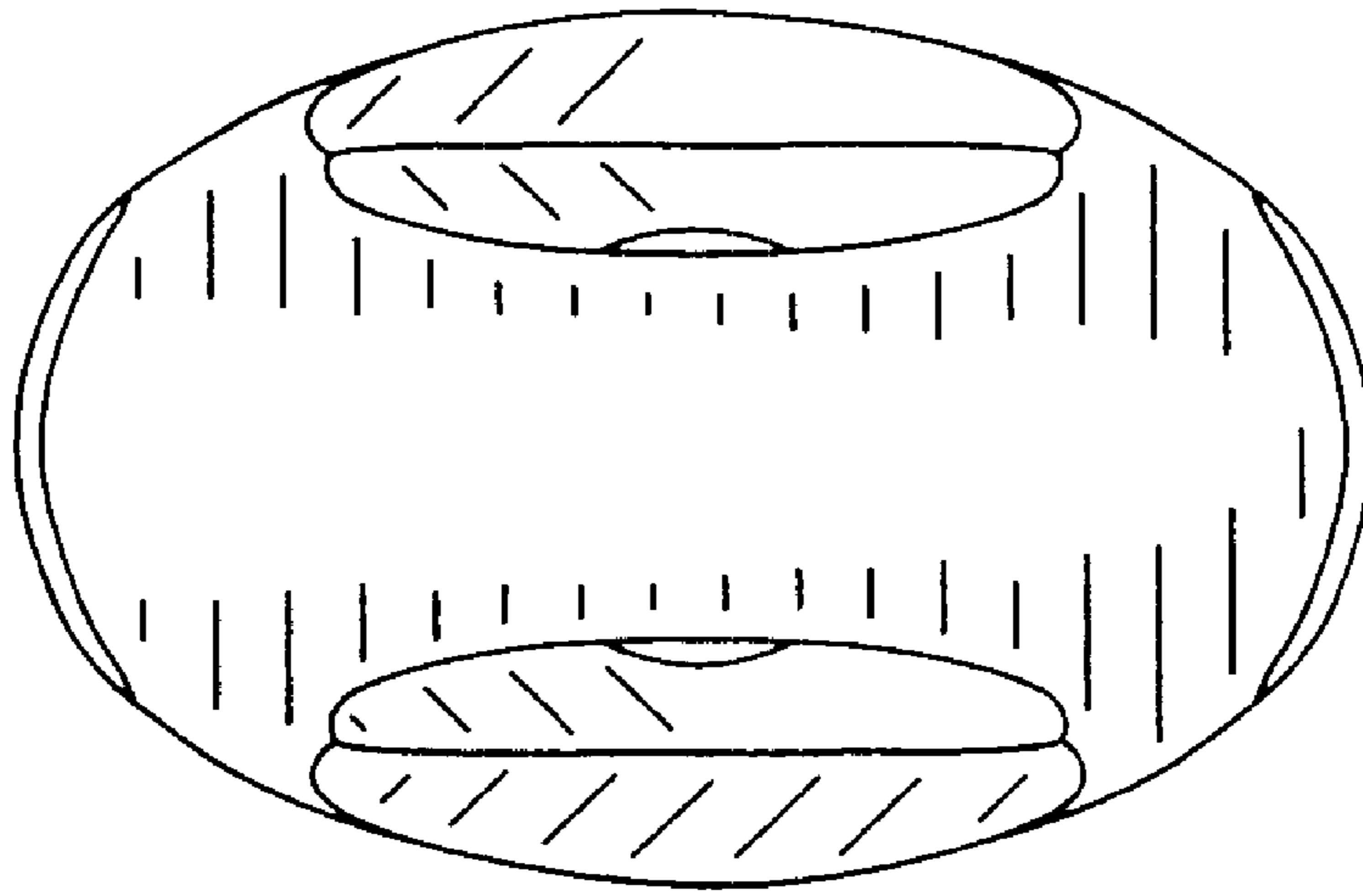

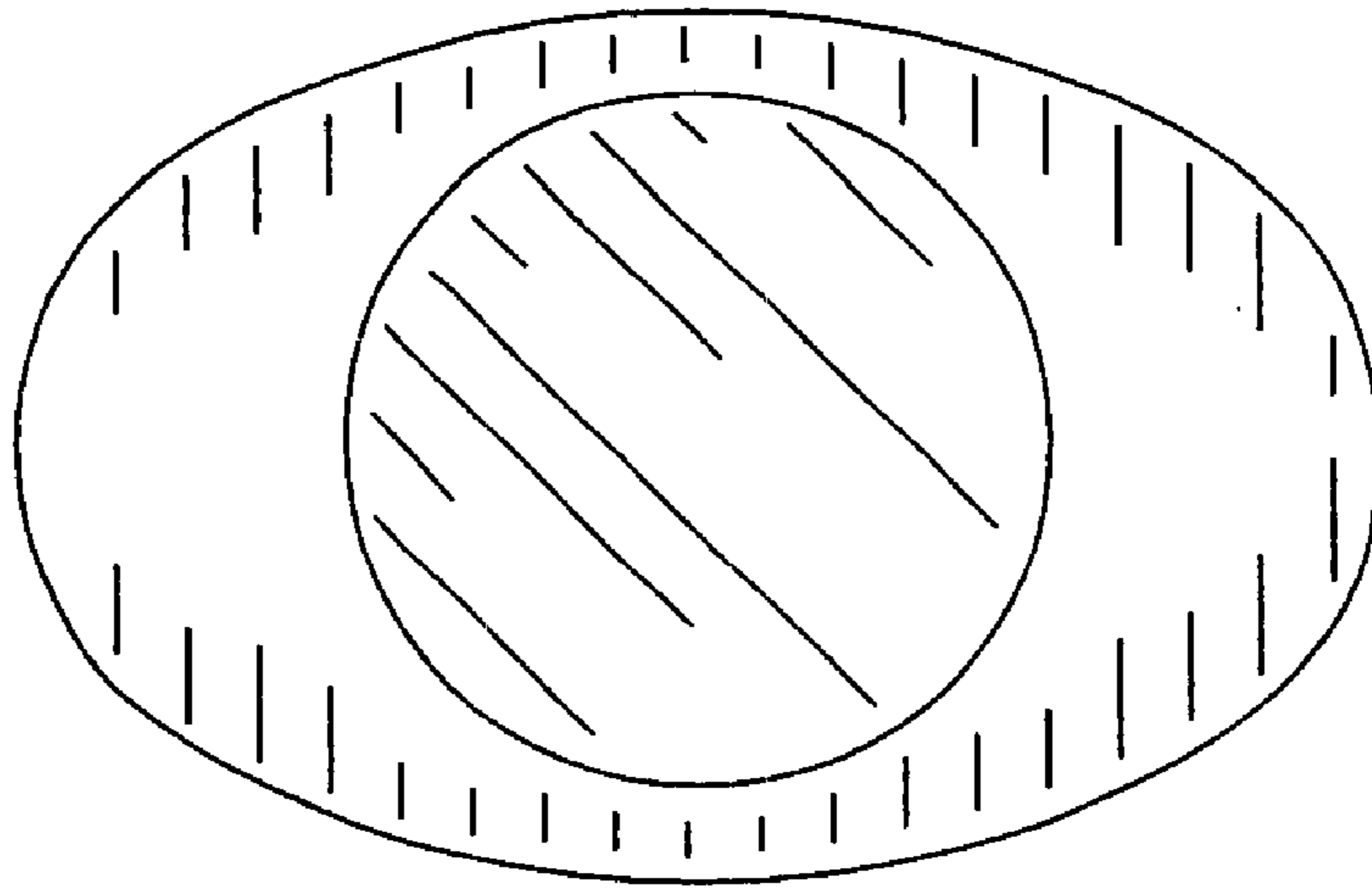

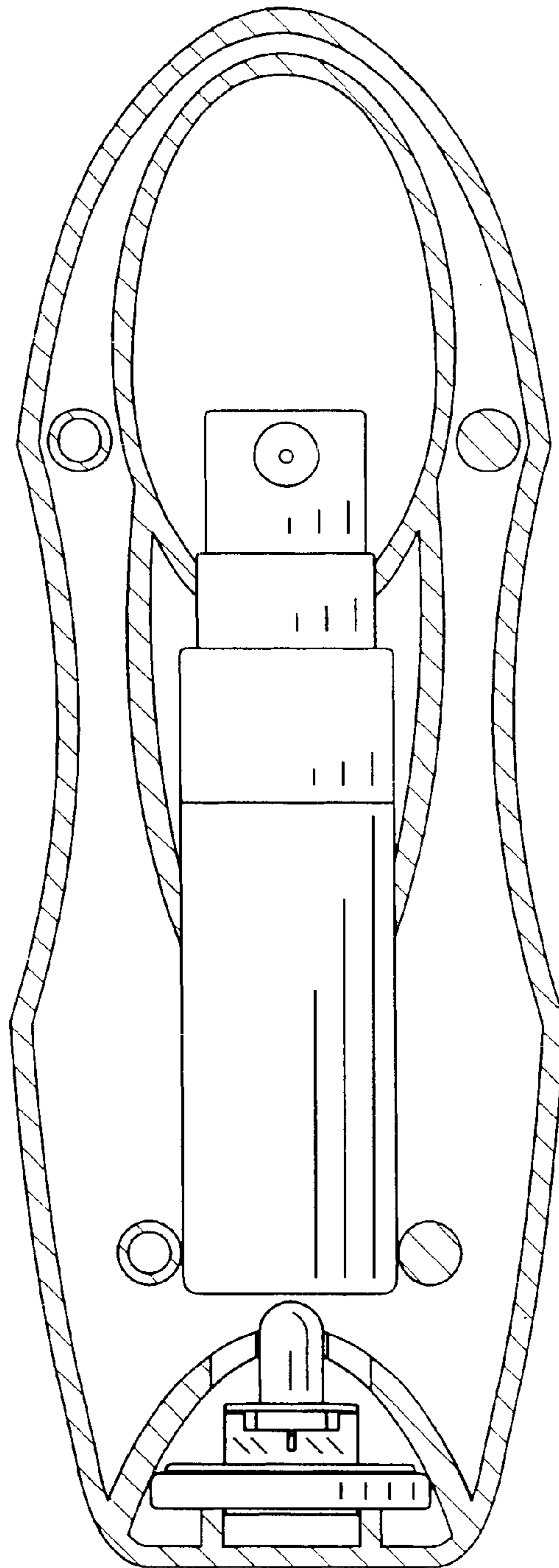

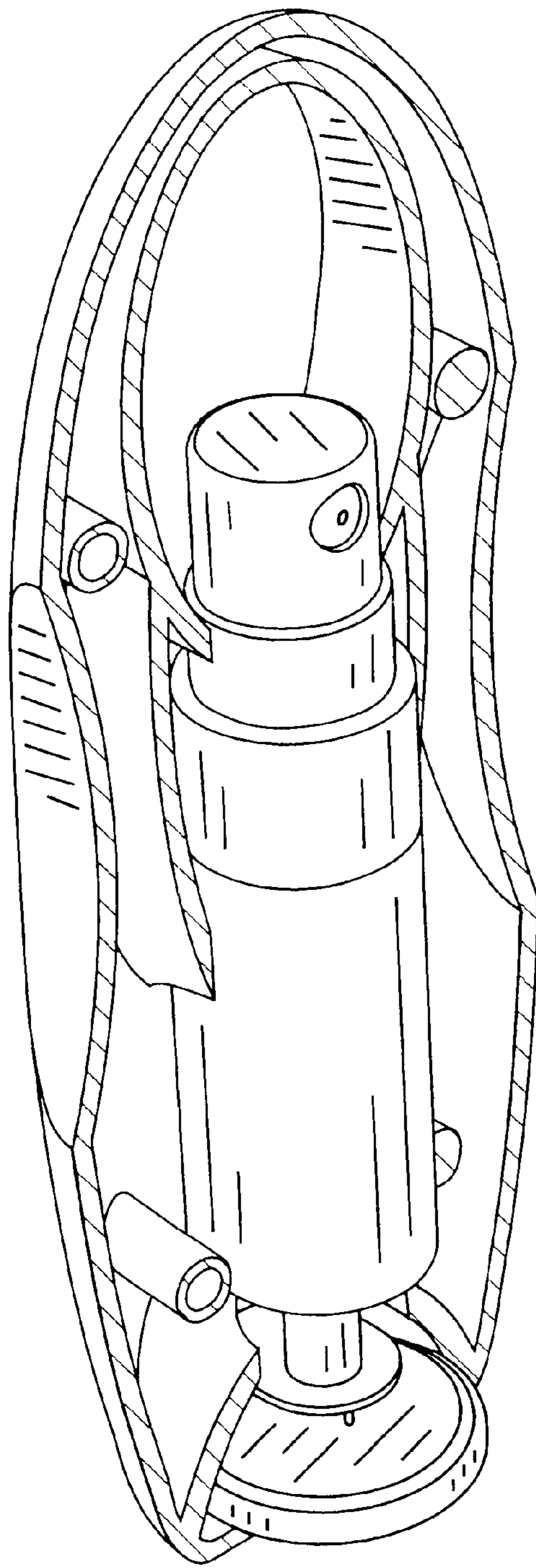

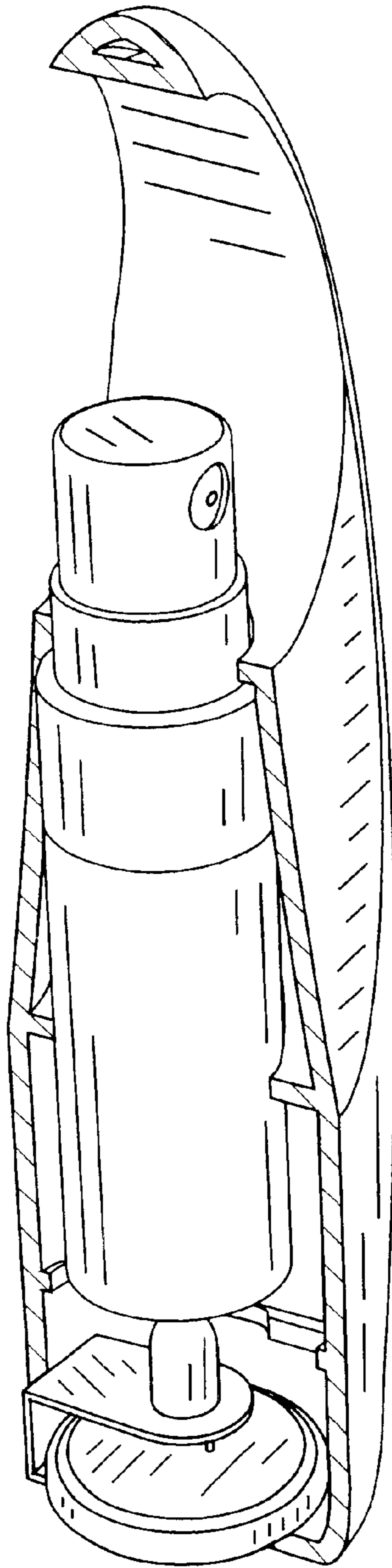

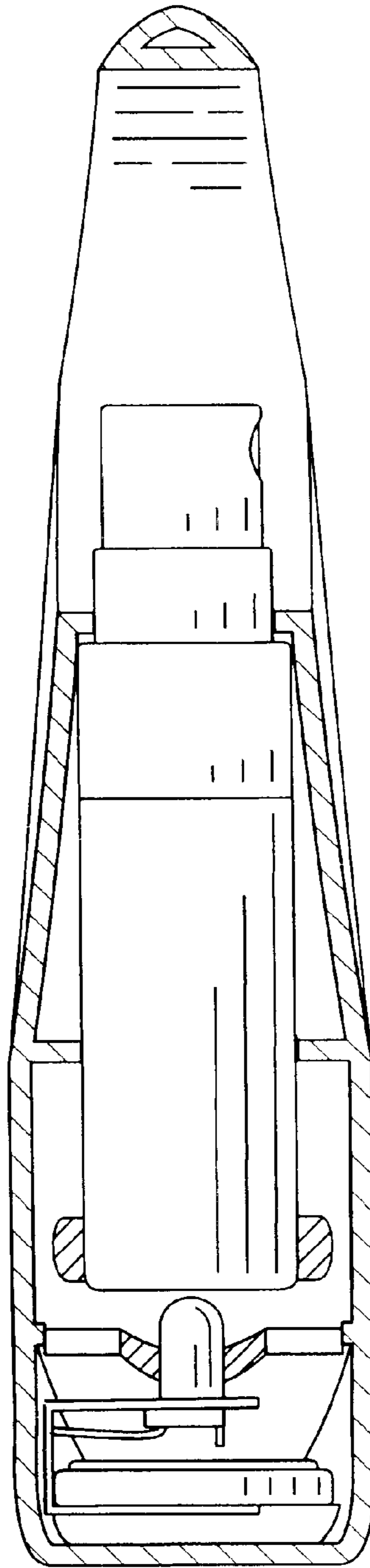

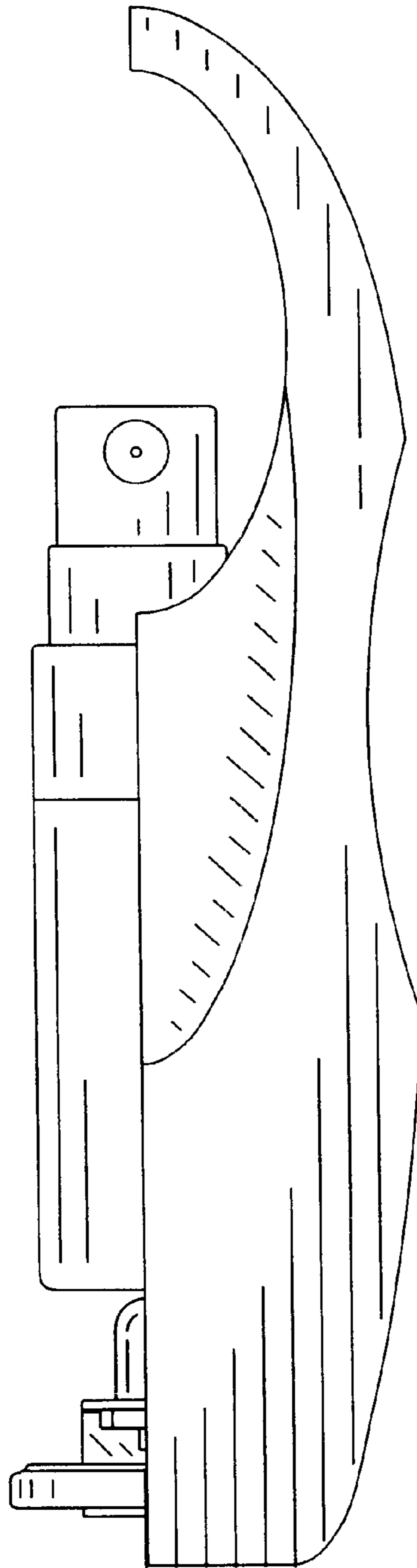

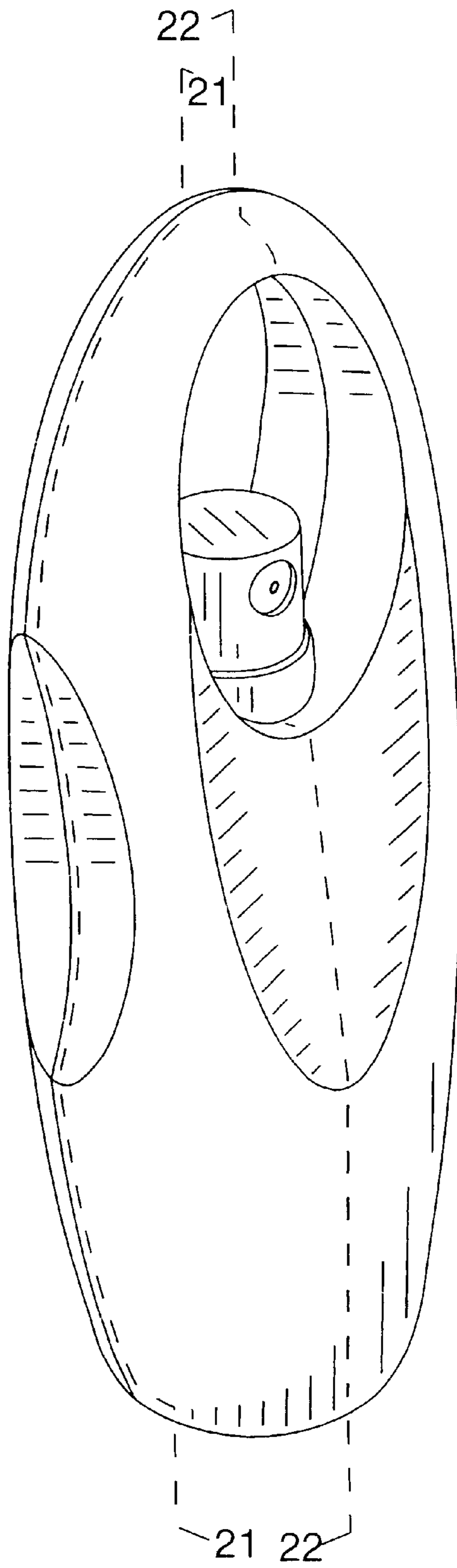

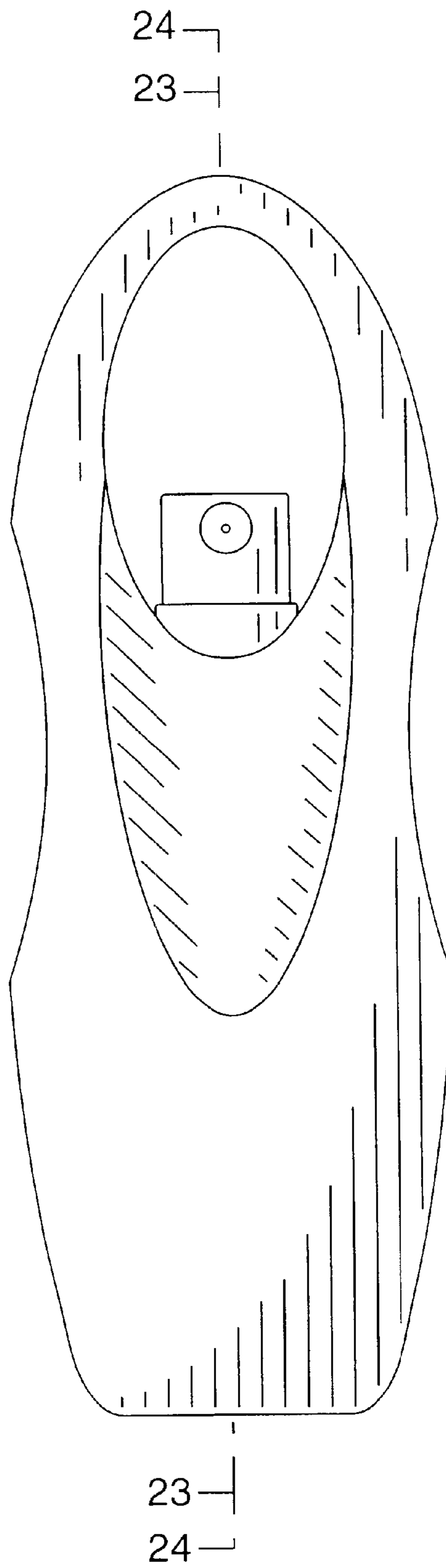

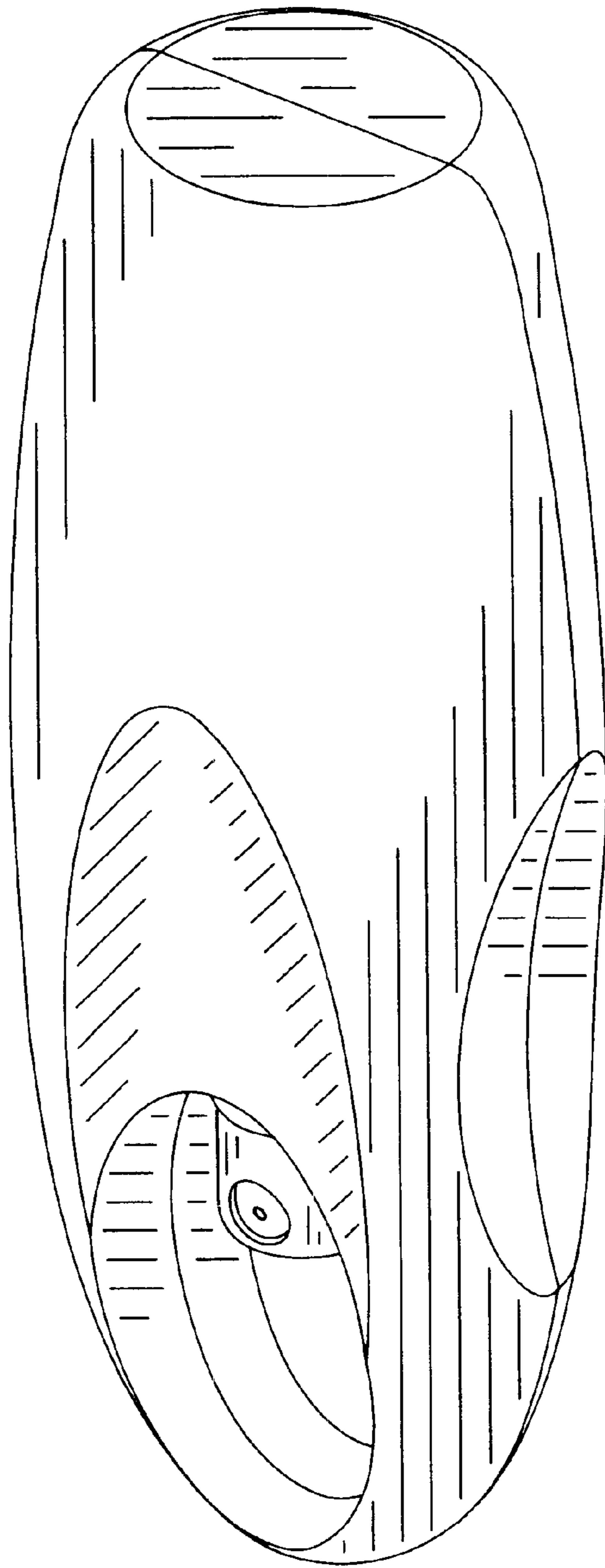

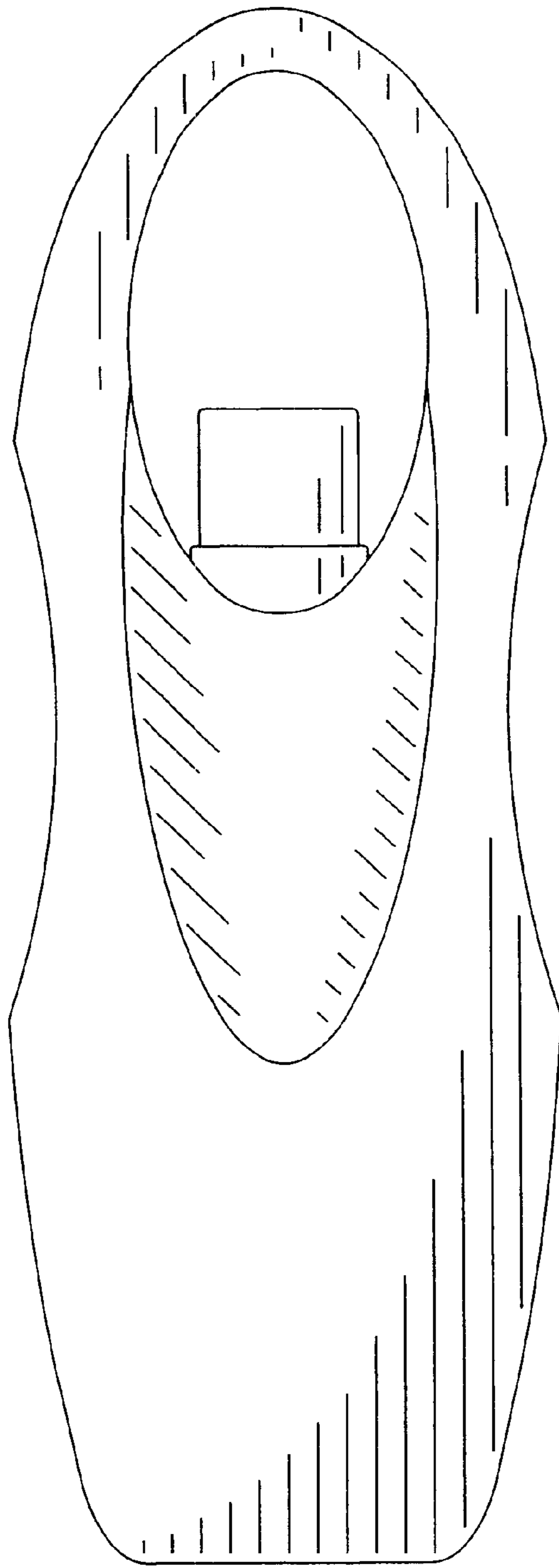

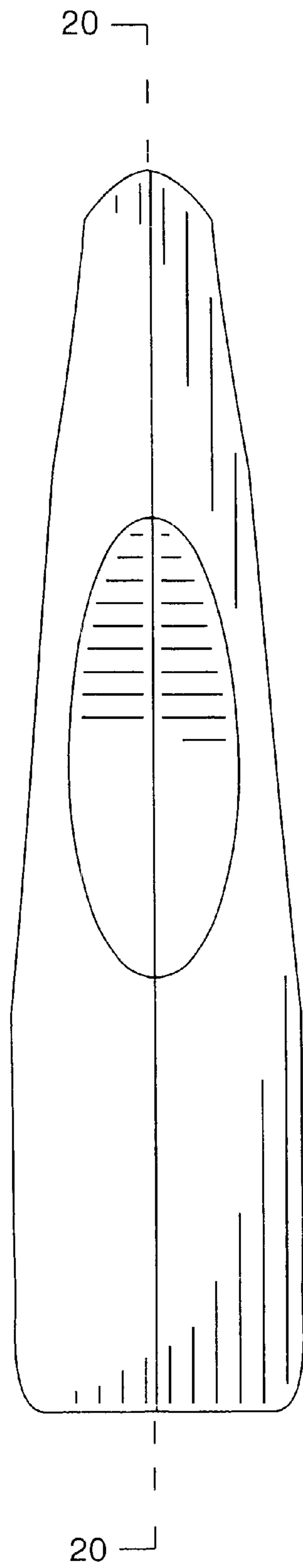

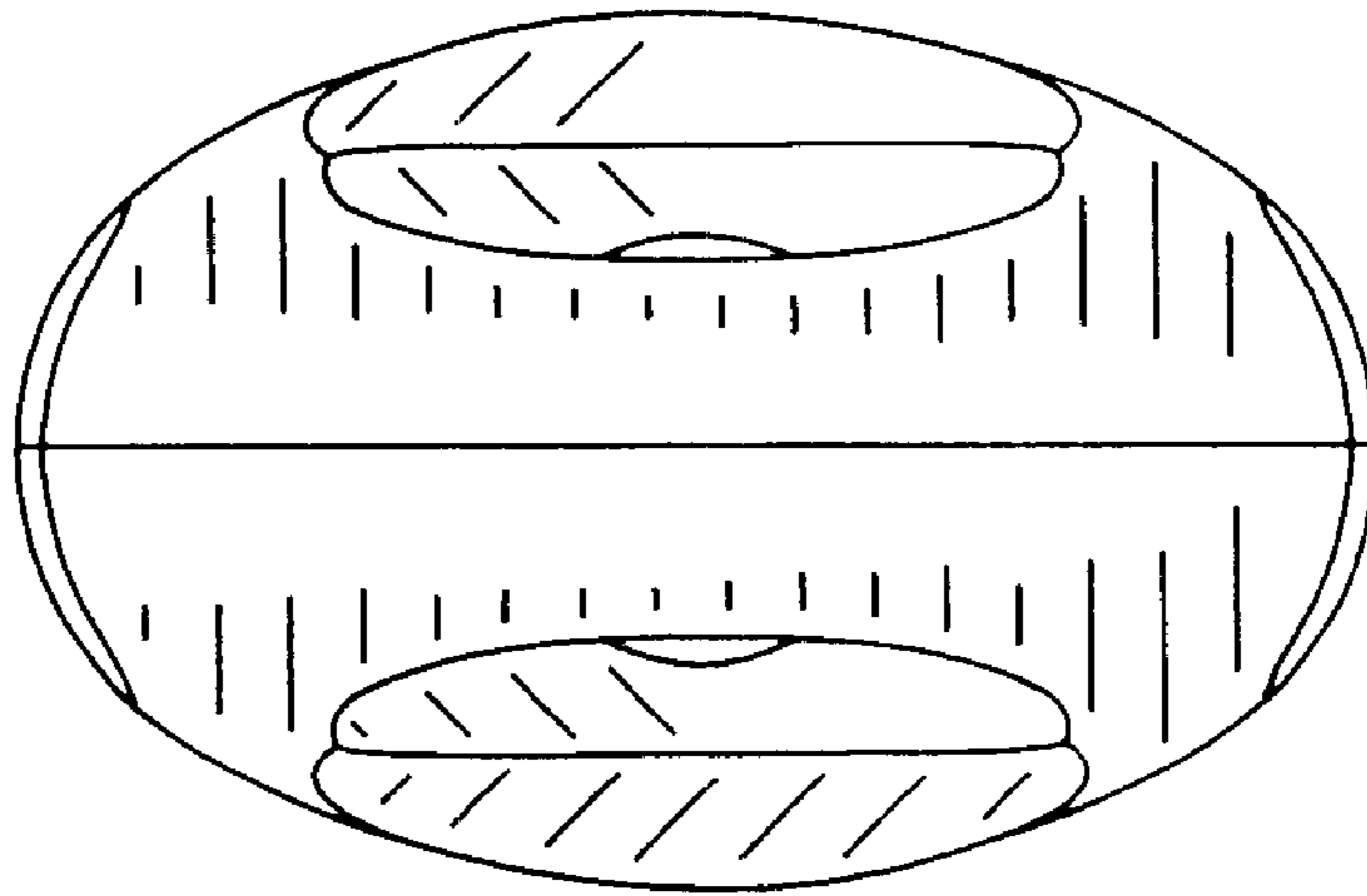

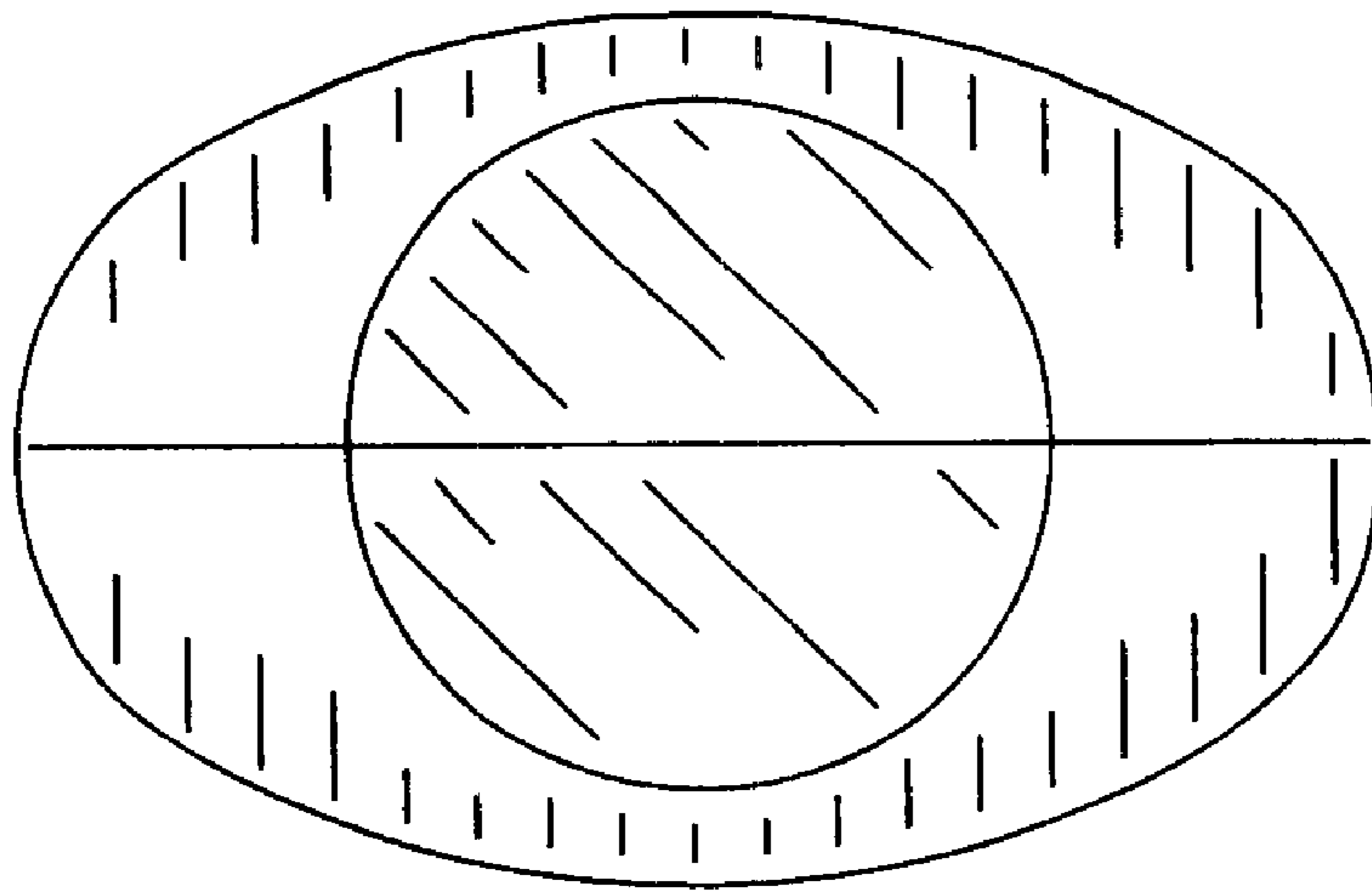

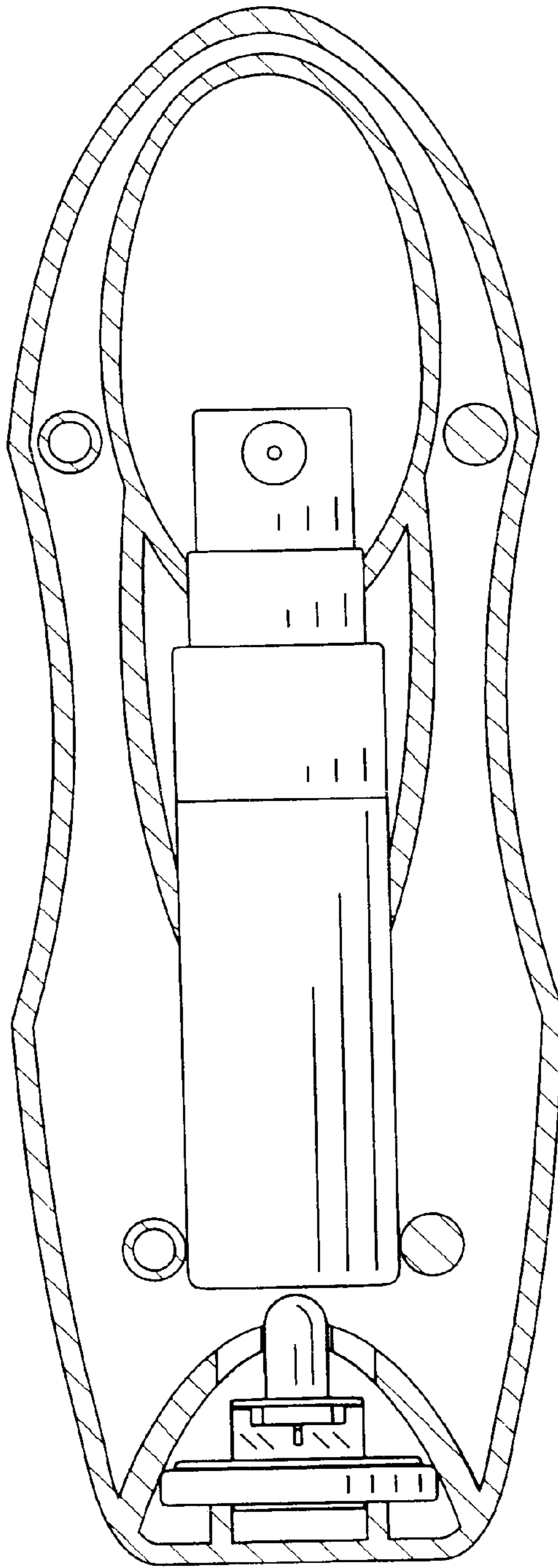

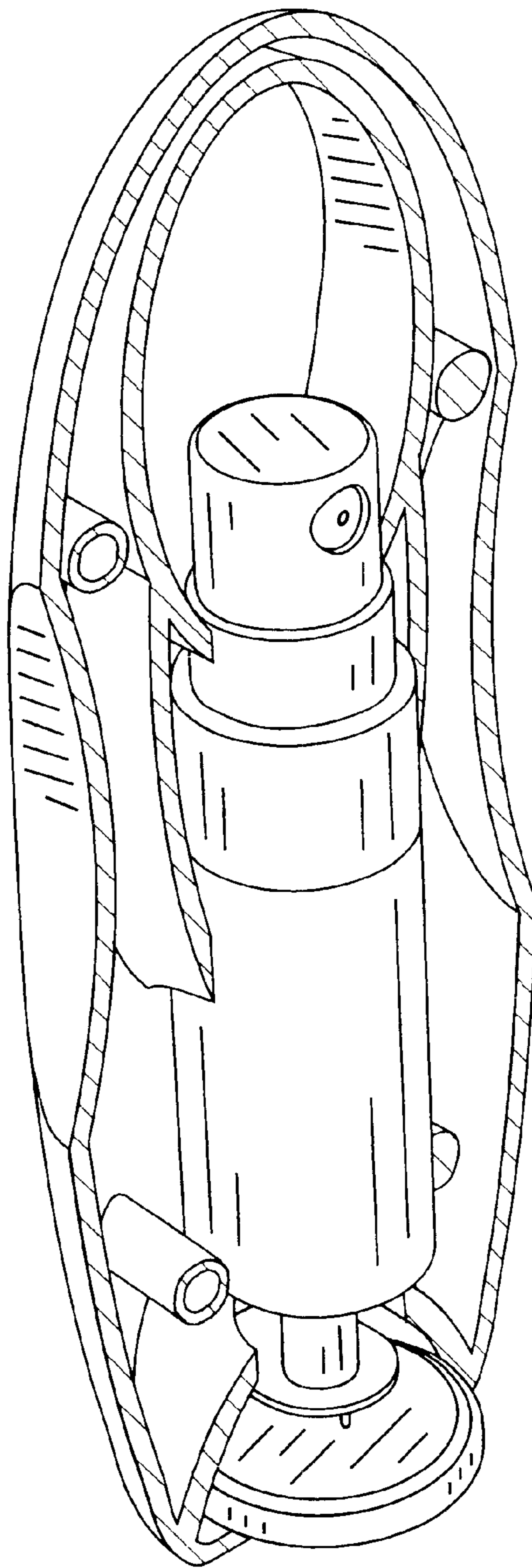

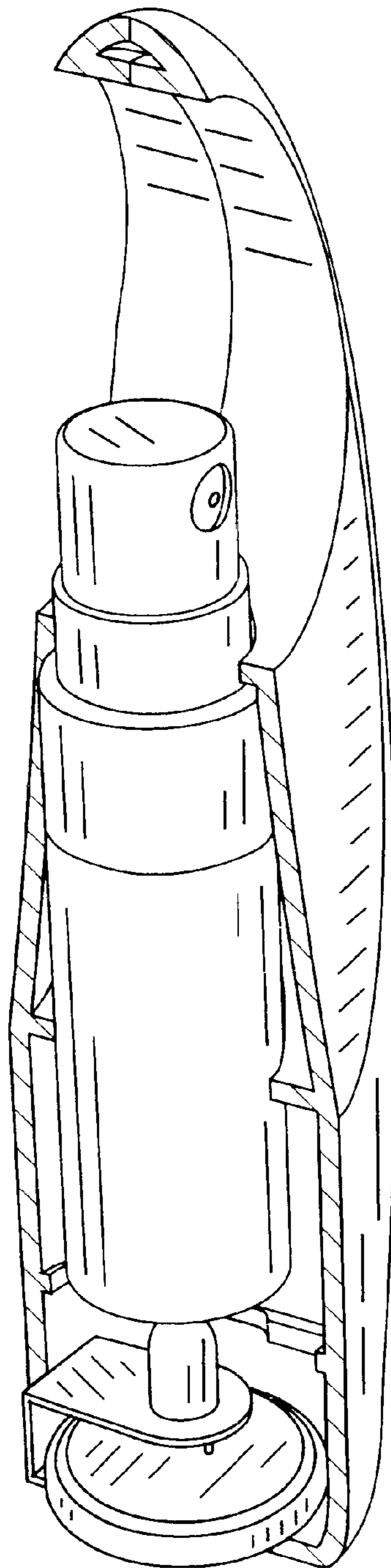

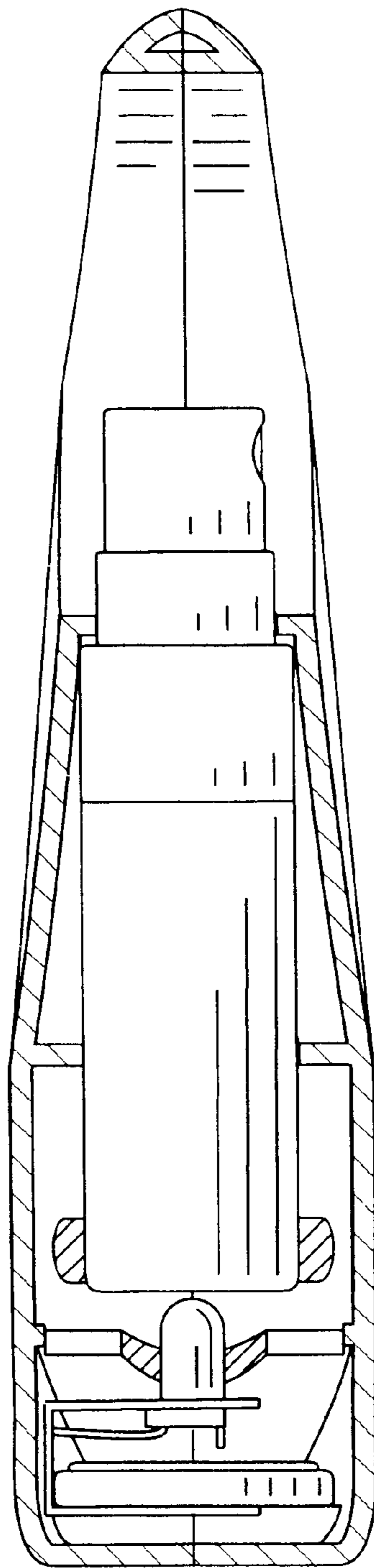

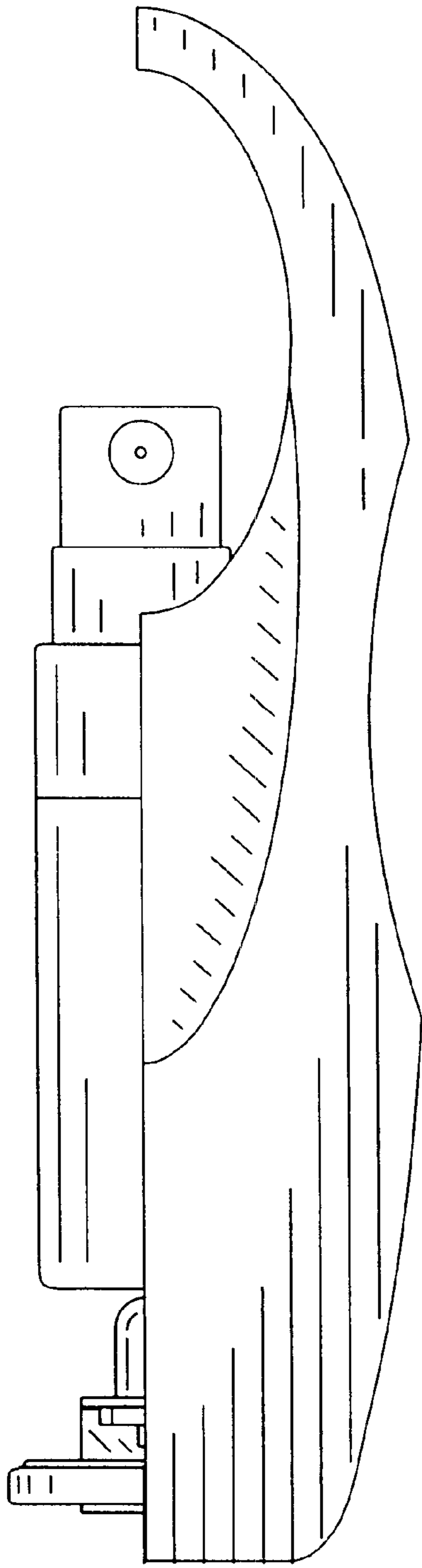
