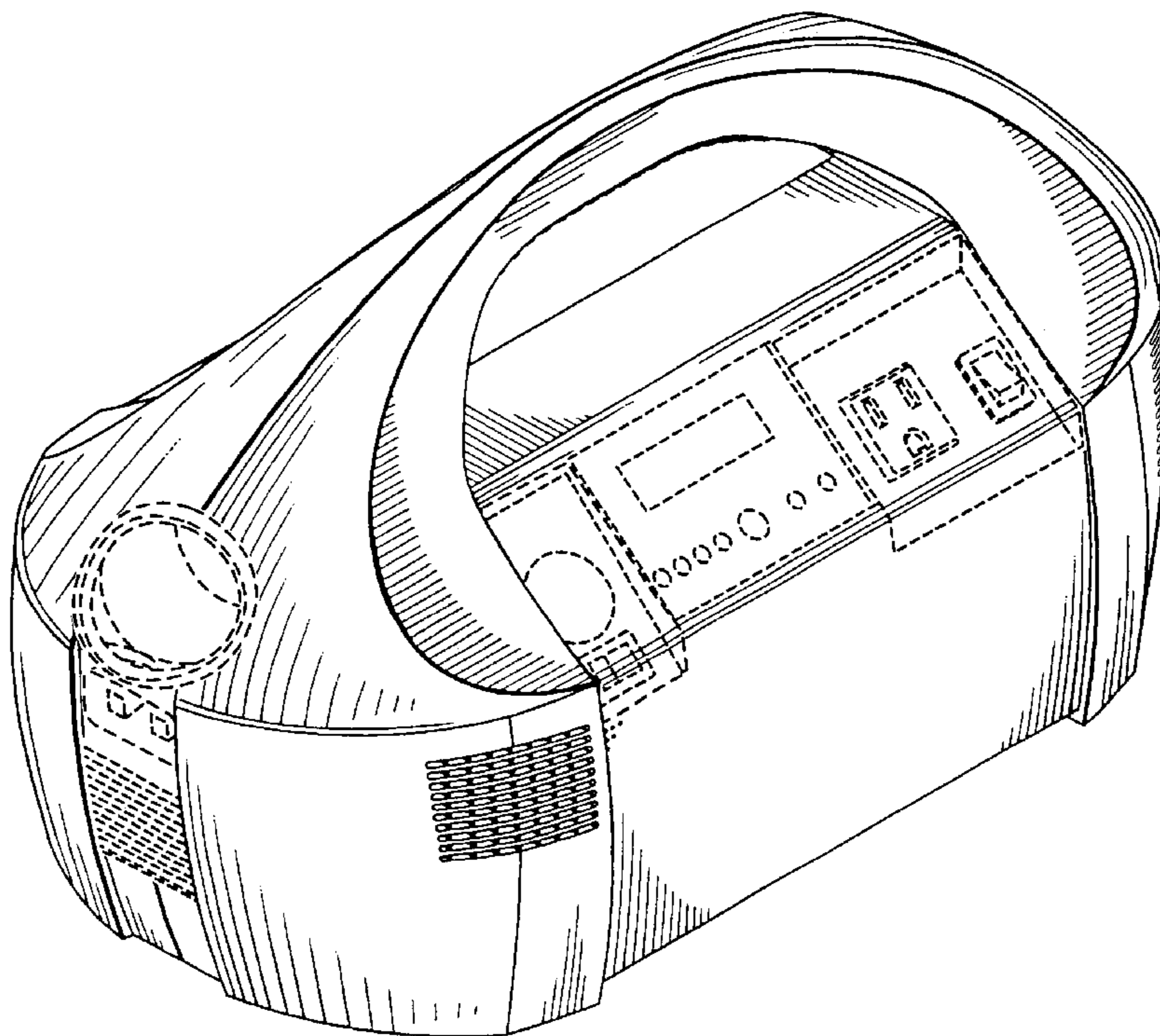

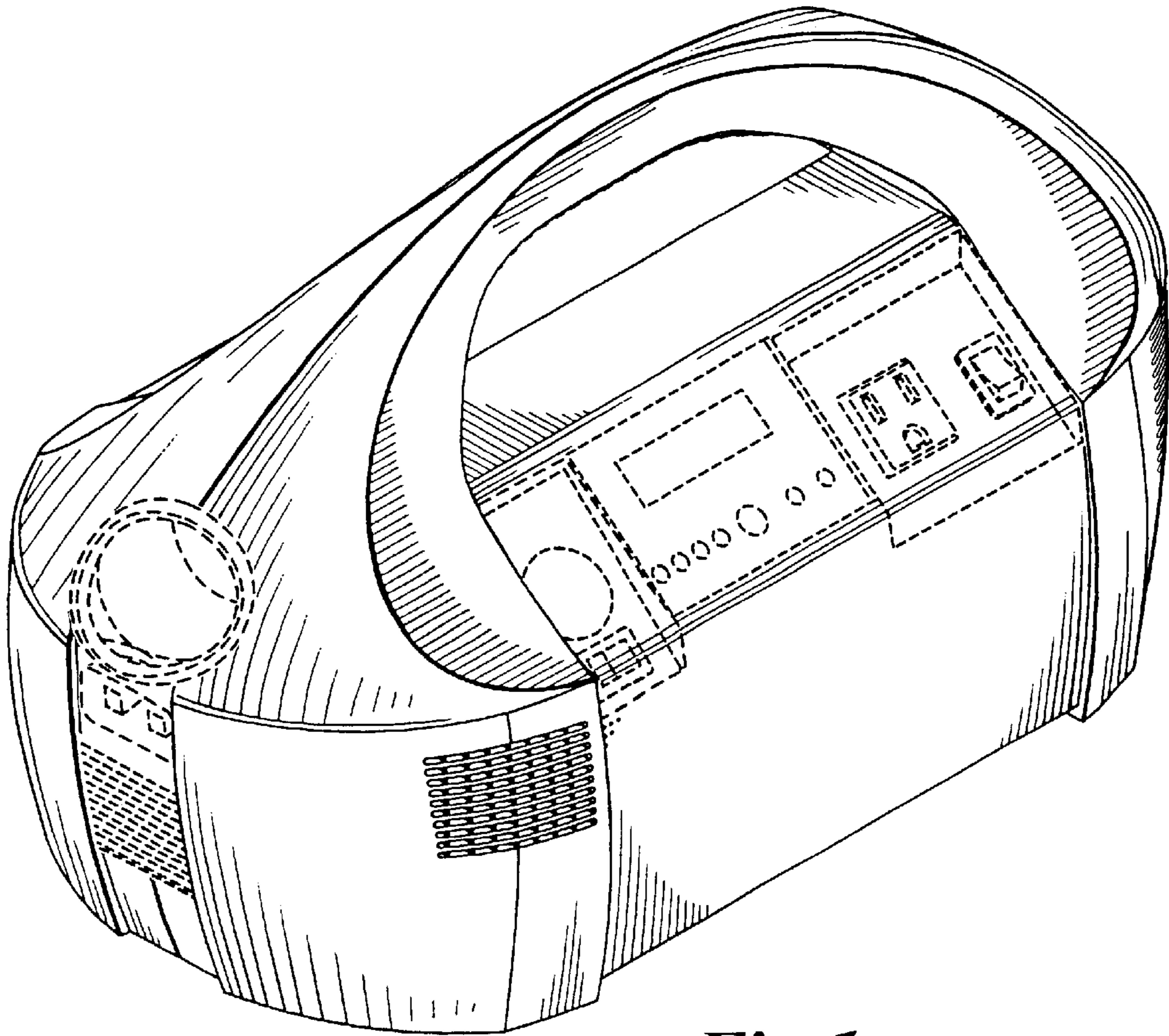
The ornamental design for a portable power supply, as shown and described.

**DESCRIPTION**

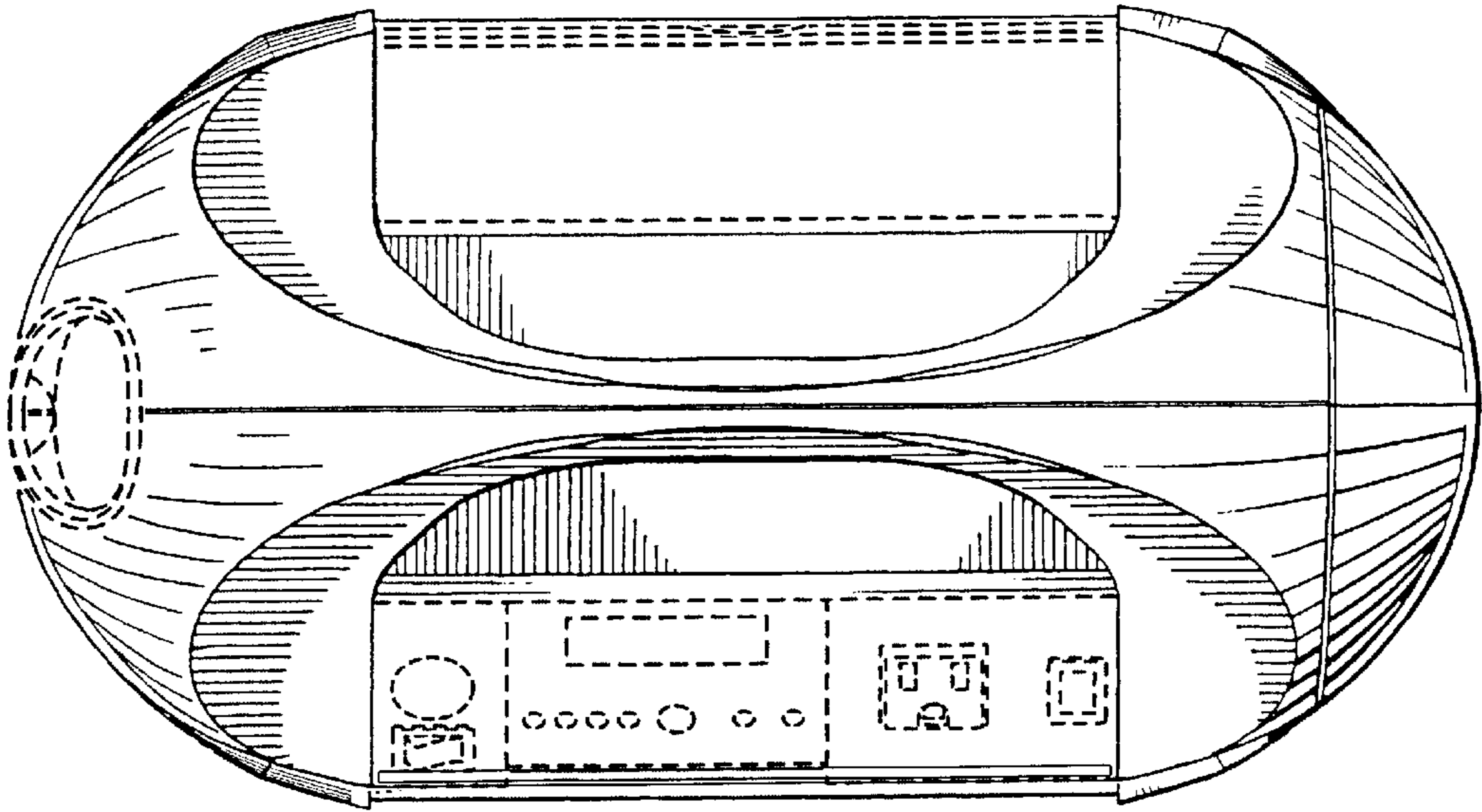
FIG. 1 is a perspective view of a portable power supply showing our new design;

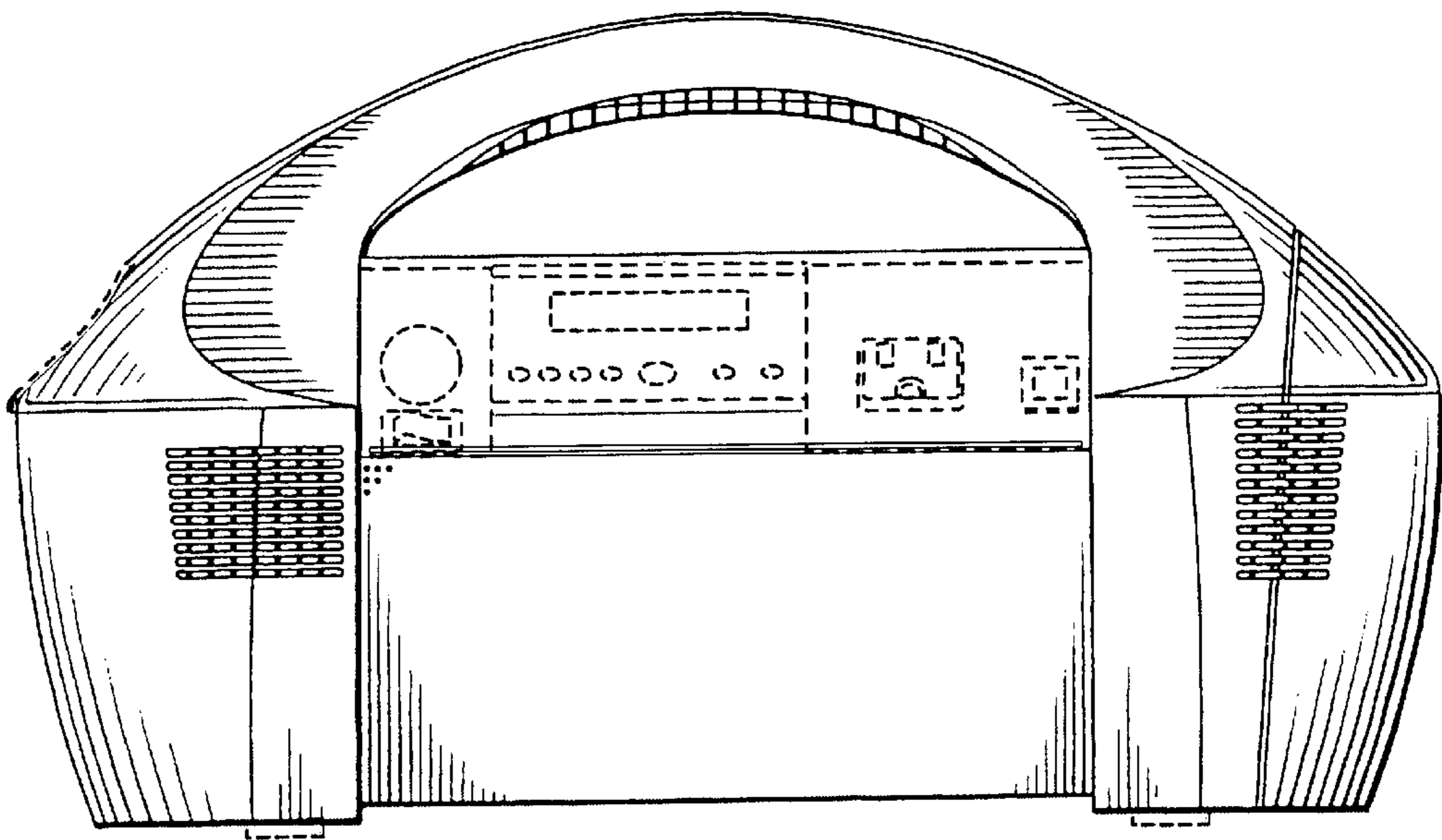




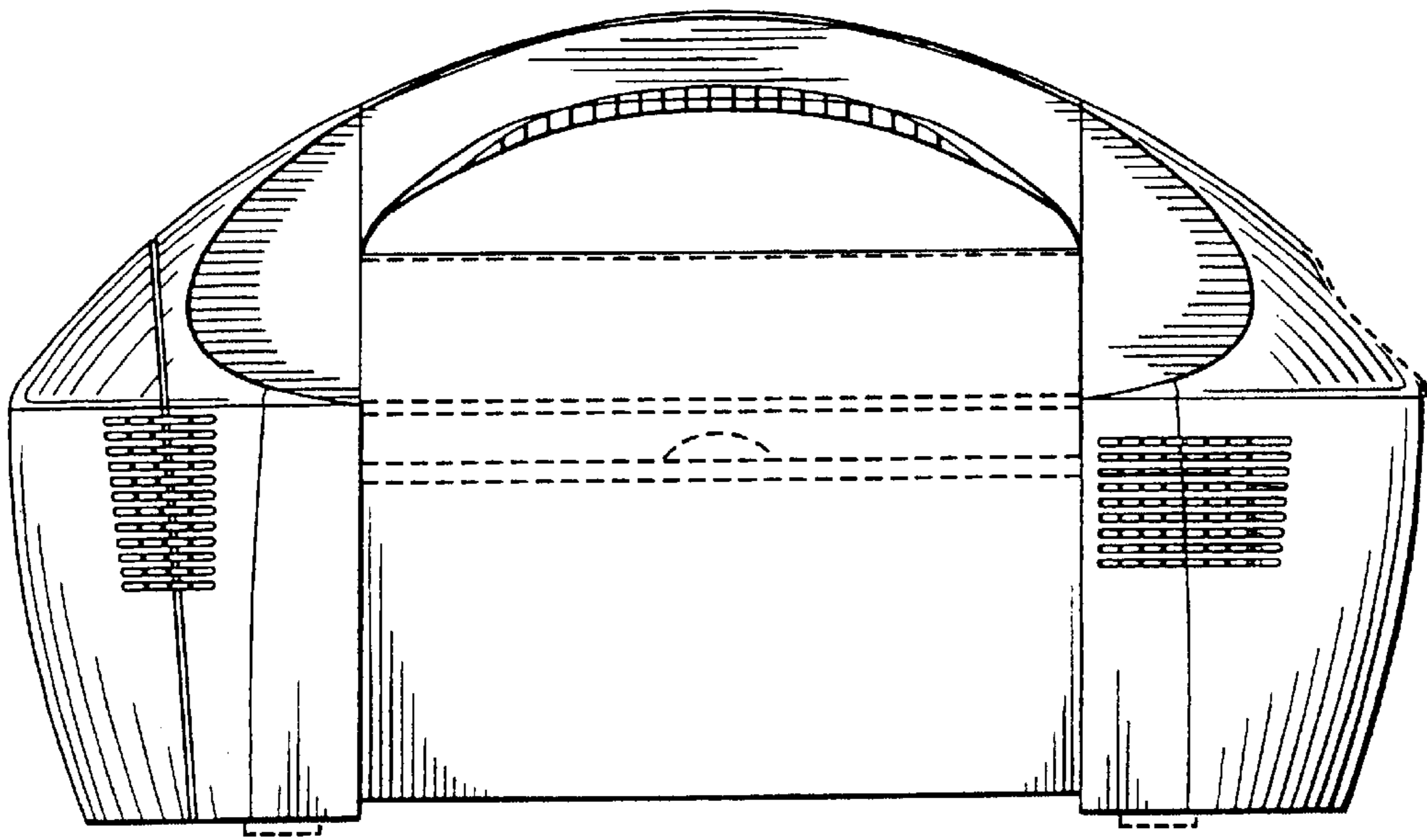

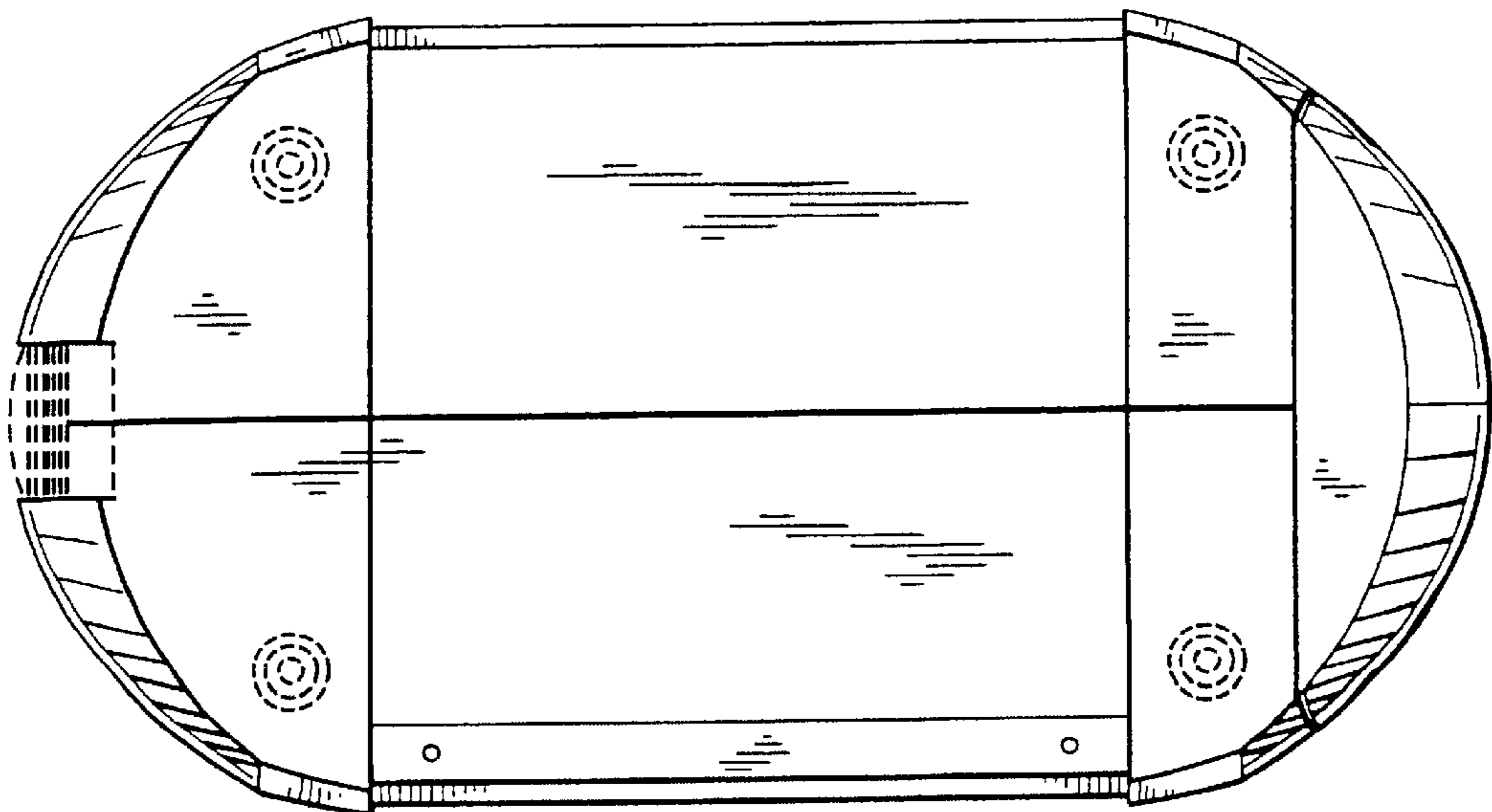

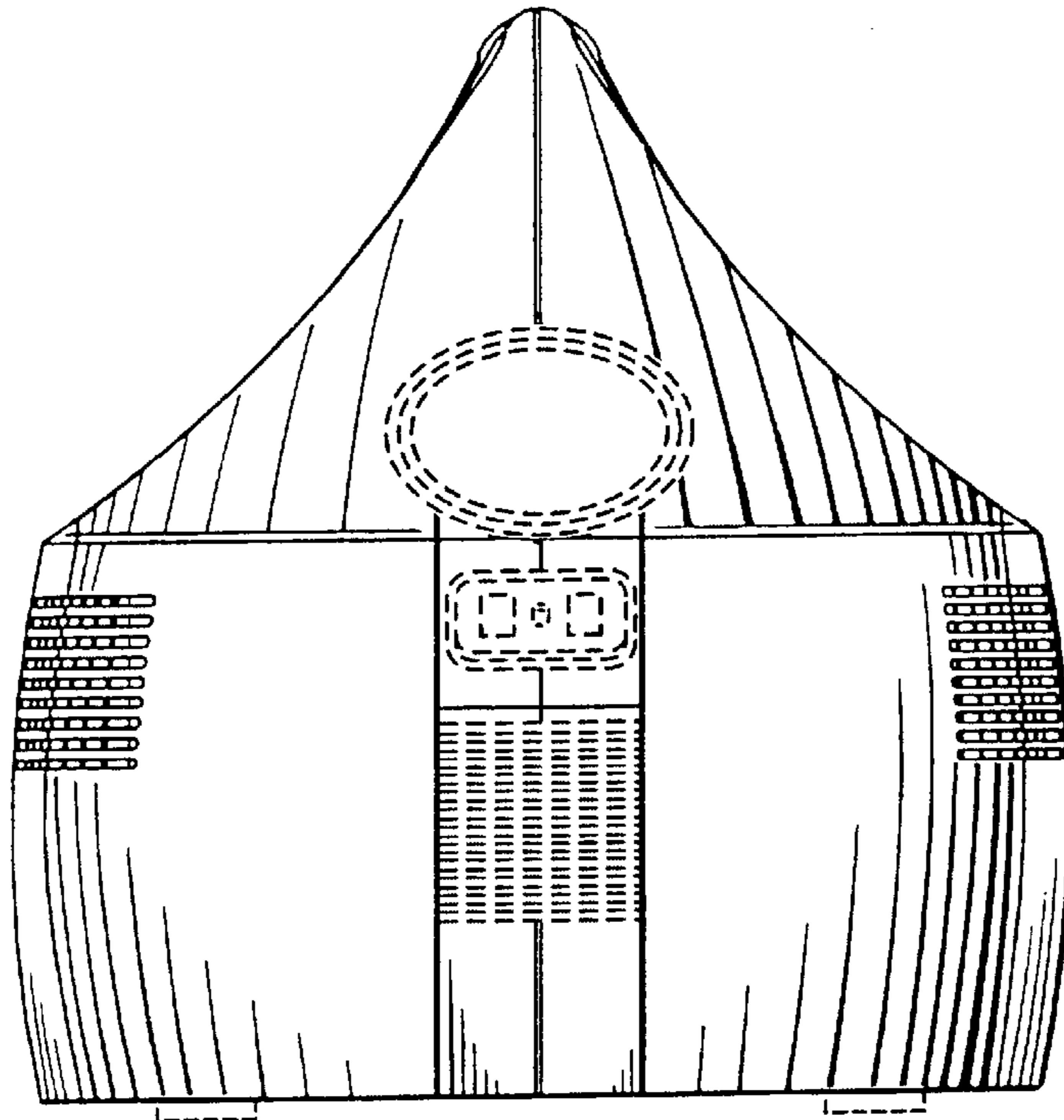

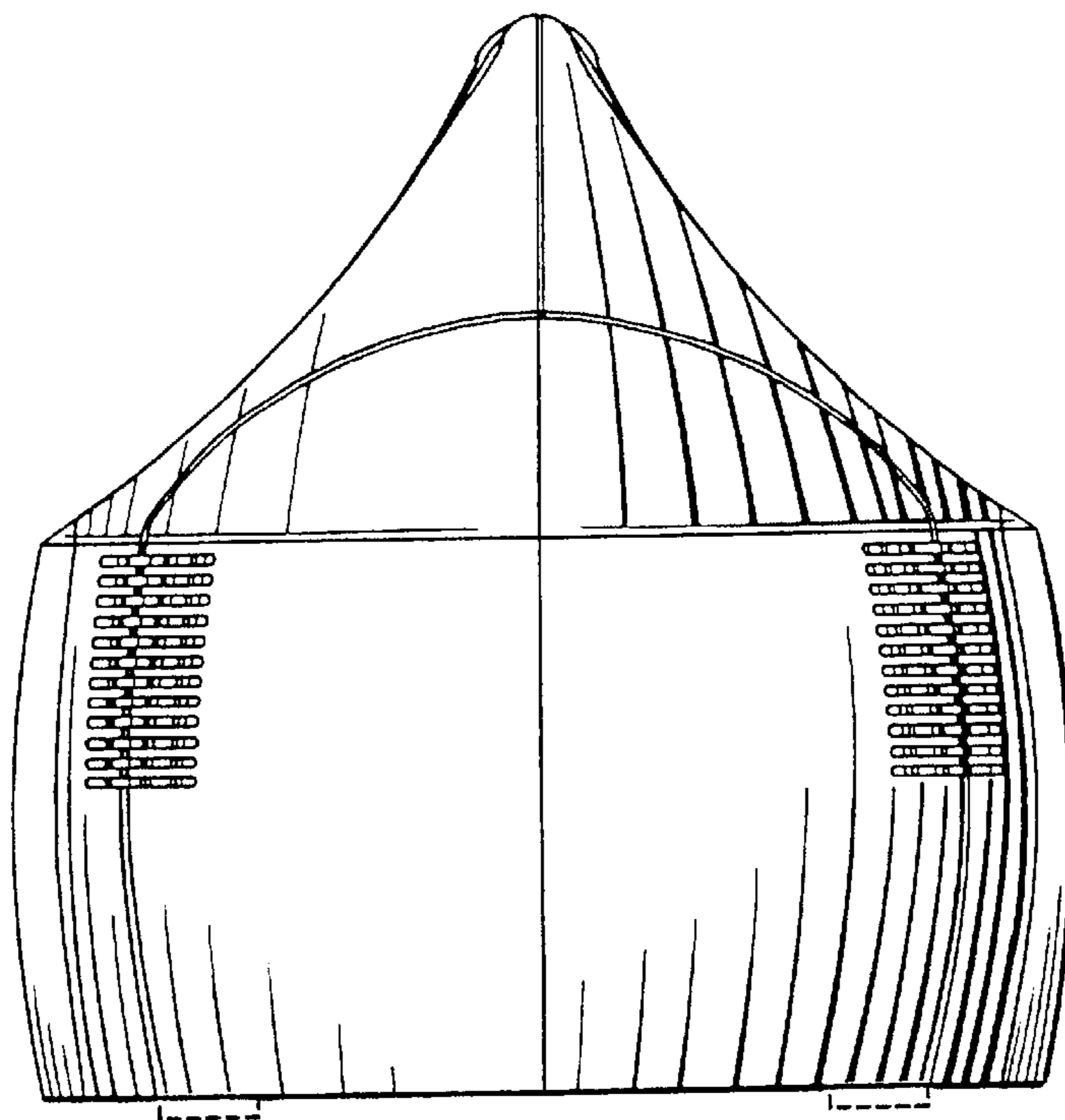
