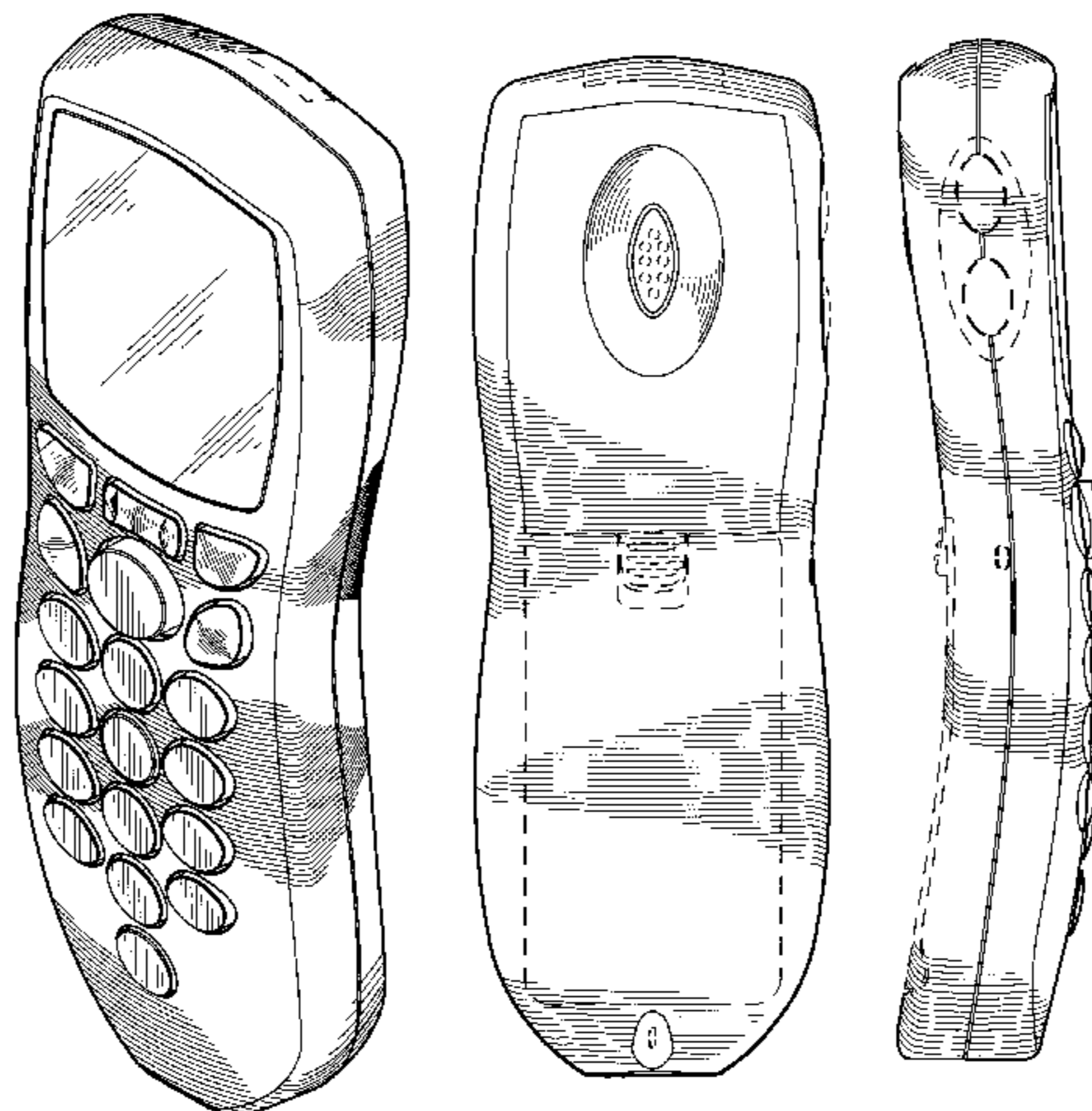
(57) **CLAIM**

The ornamental design for a wireless phone, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the wireless phone; FIG. 2 is a front plan view of the wireless phone; FIG. 3 is a rear plan view of the wireless phone; FIG. 4 is a left plan view of the wireless phone; FIG. 5 is a right plan view of the wireless phone; FIG. 6 is a top plan view wireless phone; and, FIG. 7 is a bottom plan view of the wireless phone. The broken line showings throughout the views are for illustrative purposes only and form no part of the claimed design.

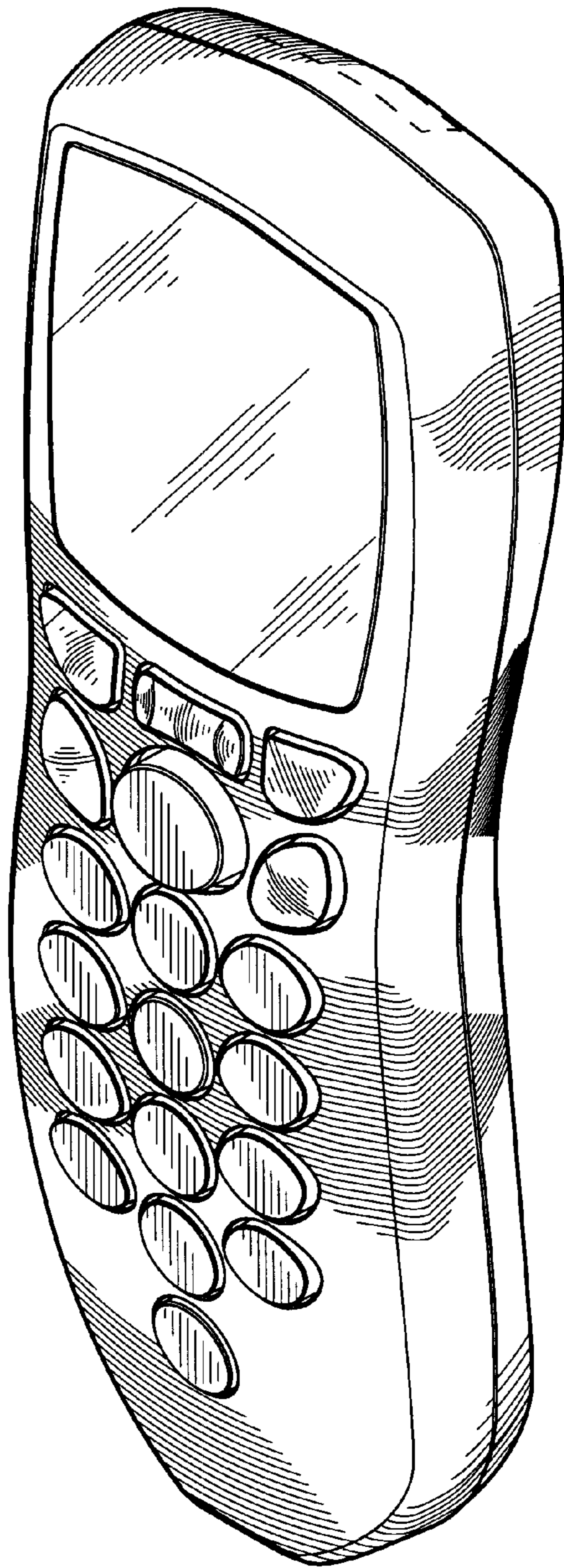

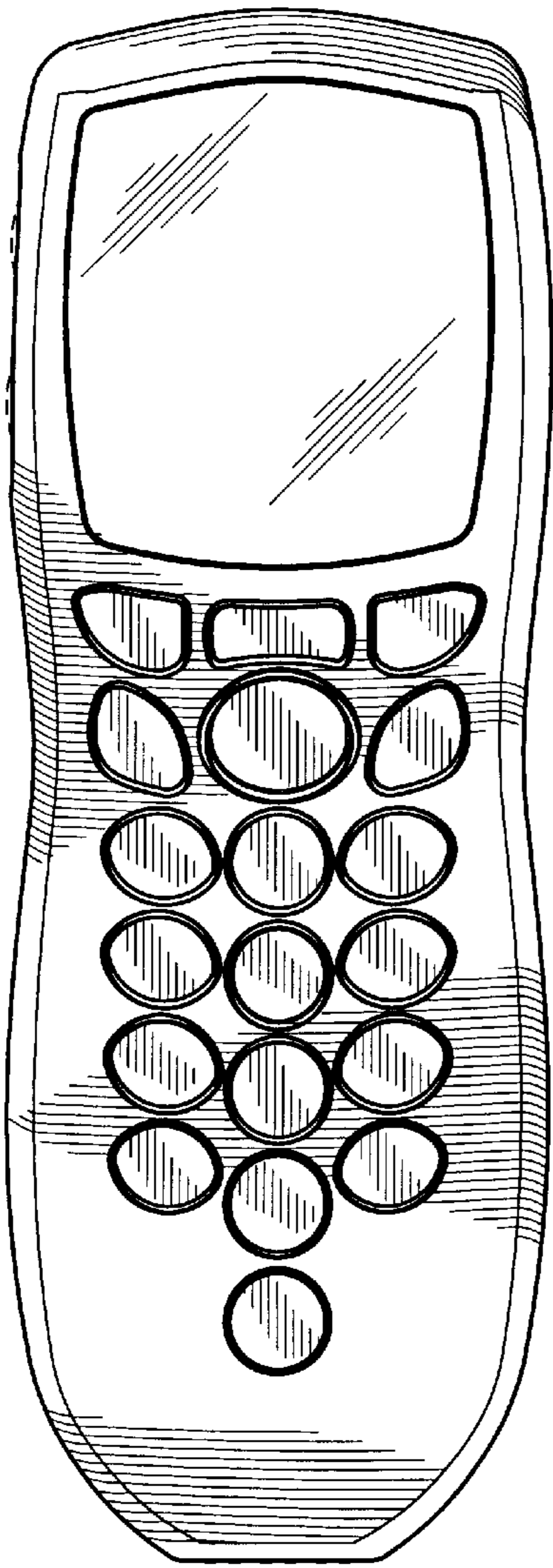

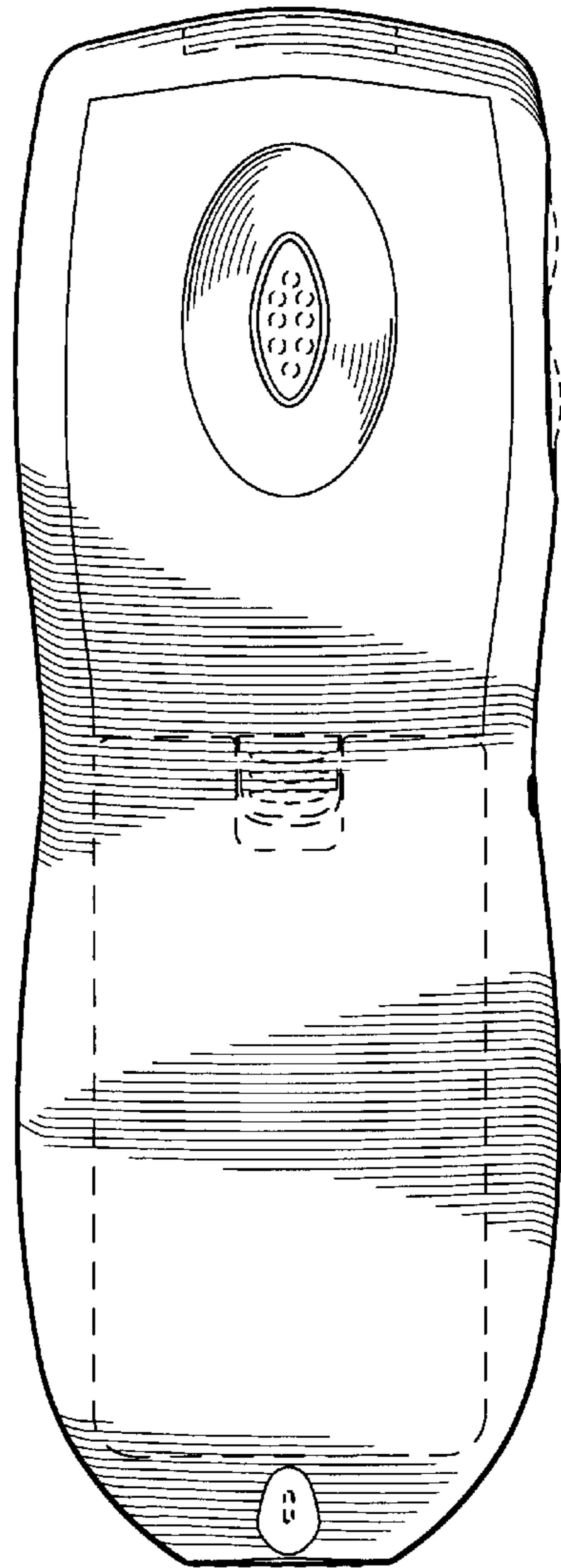

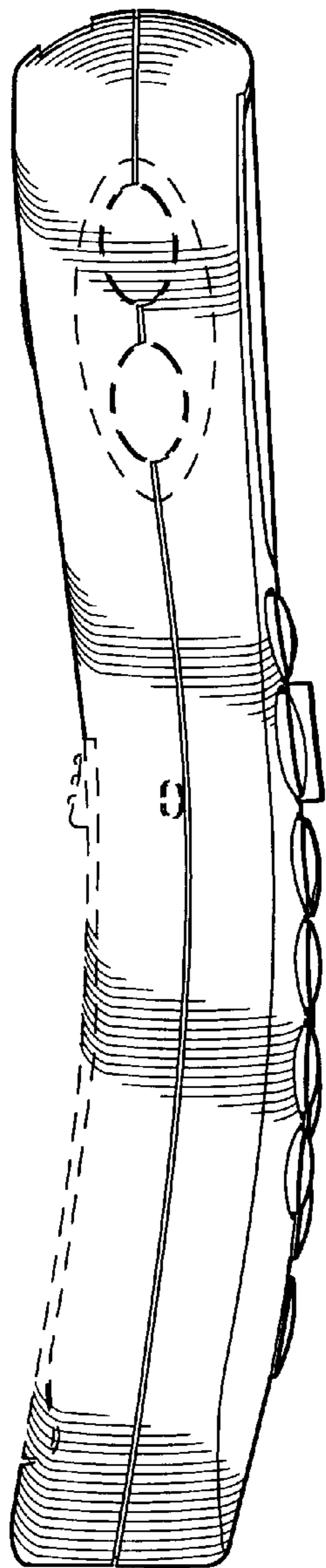

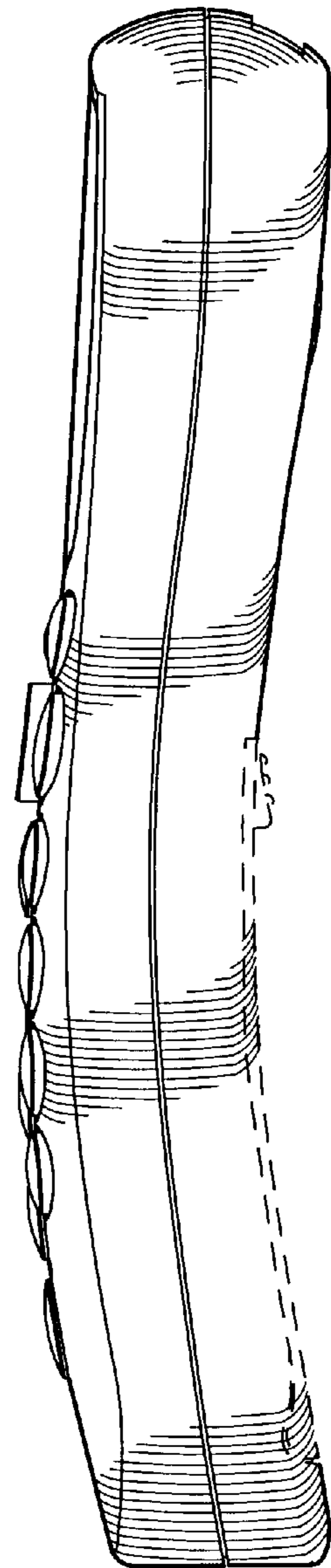

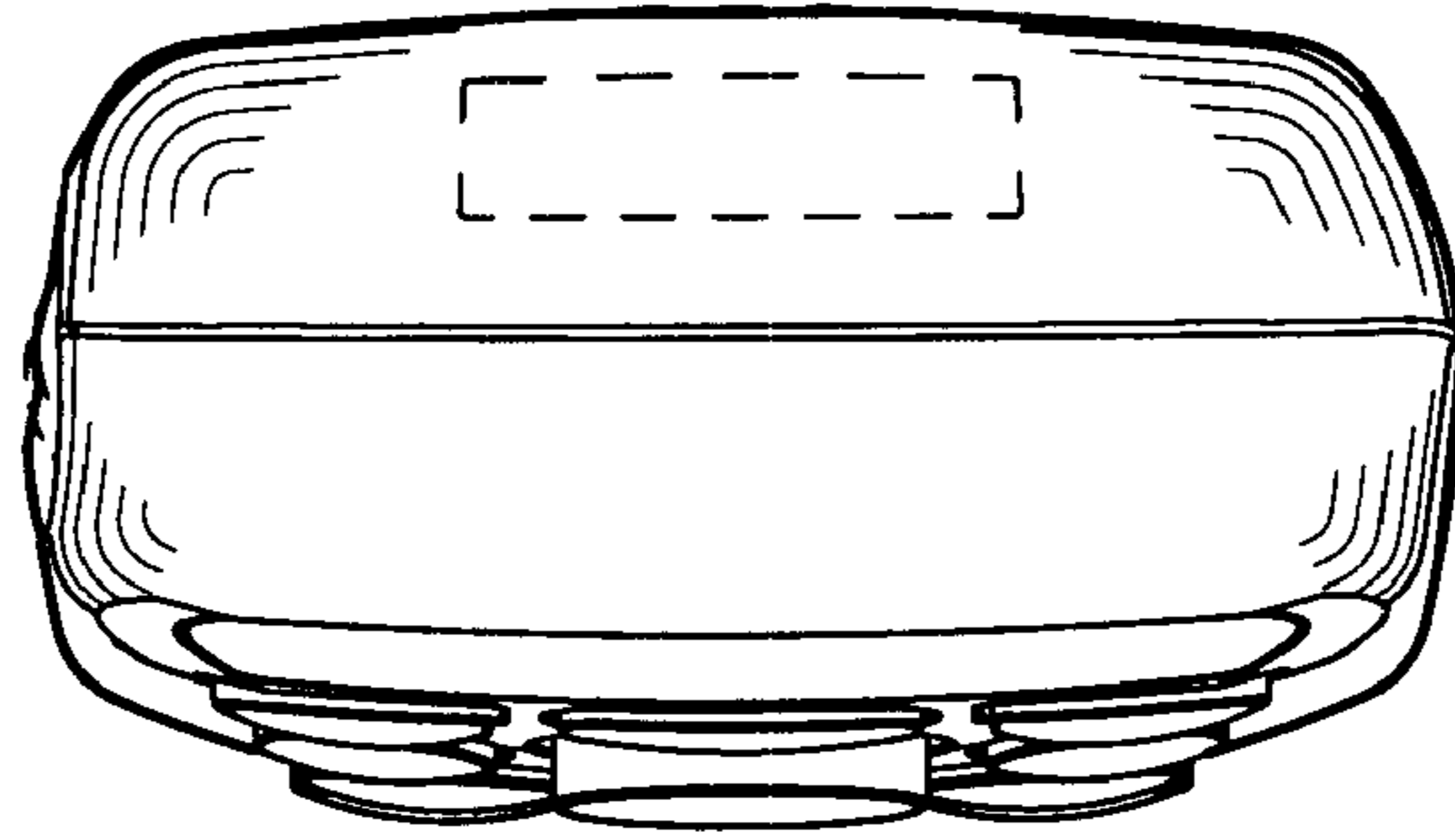

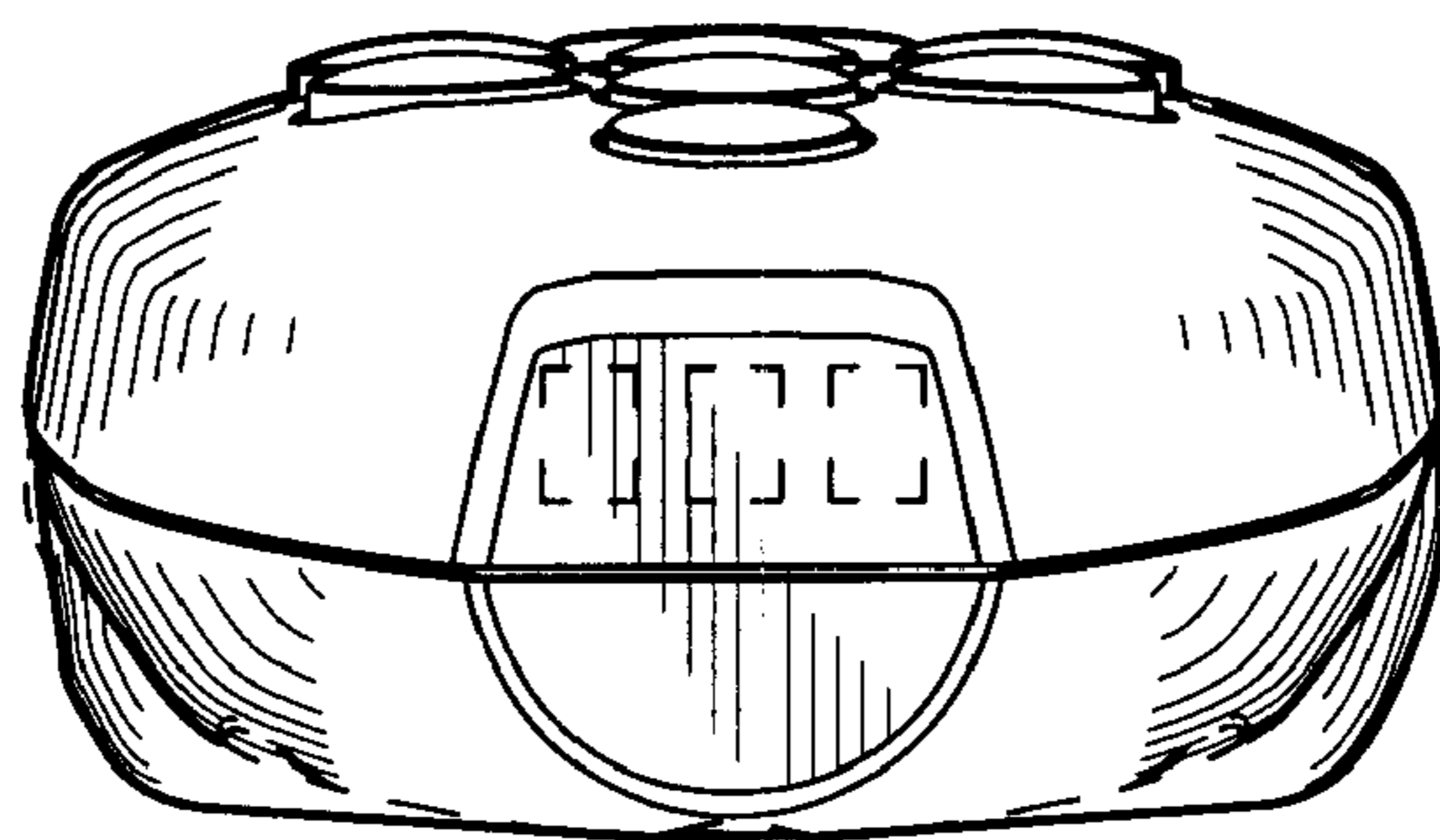
