cover;

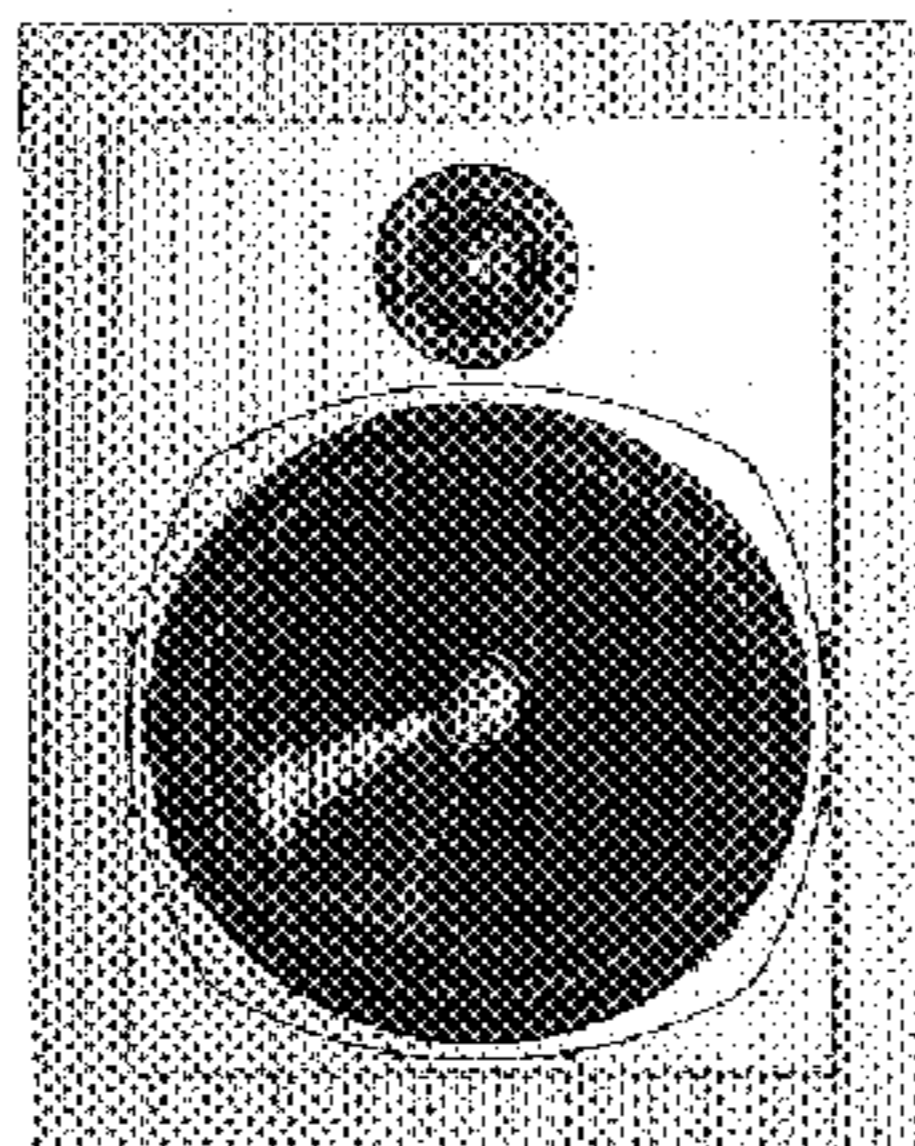
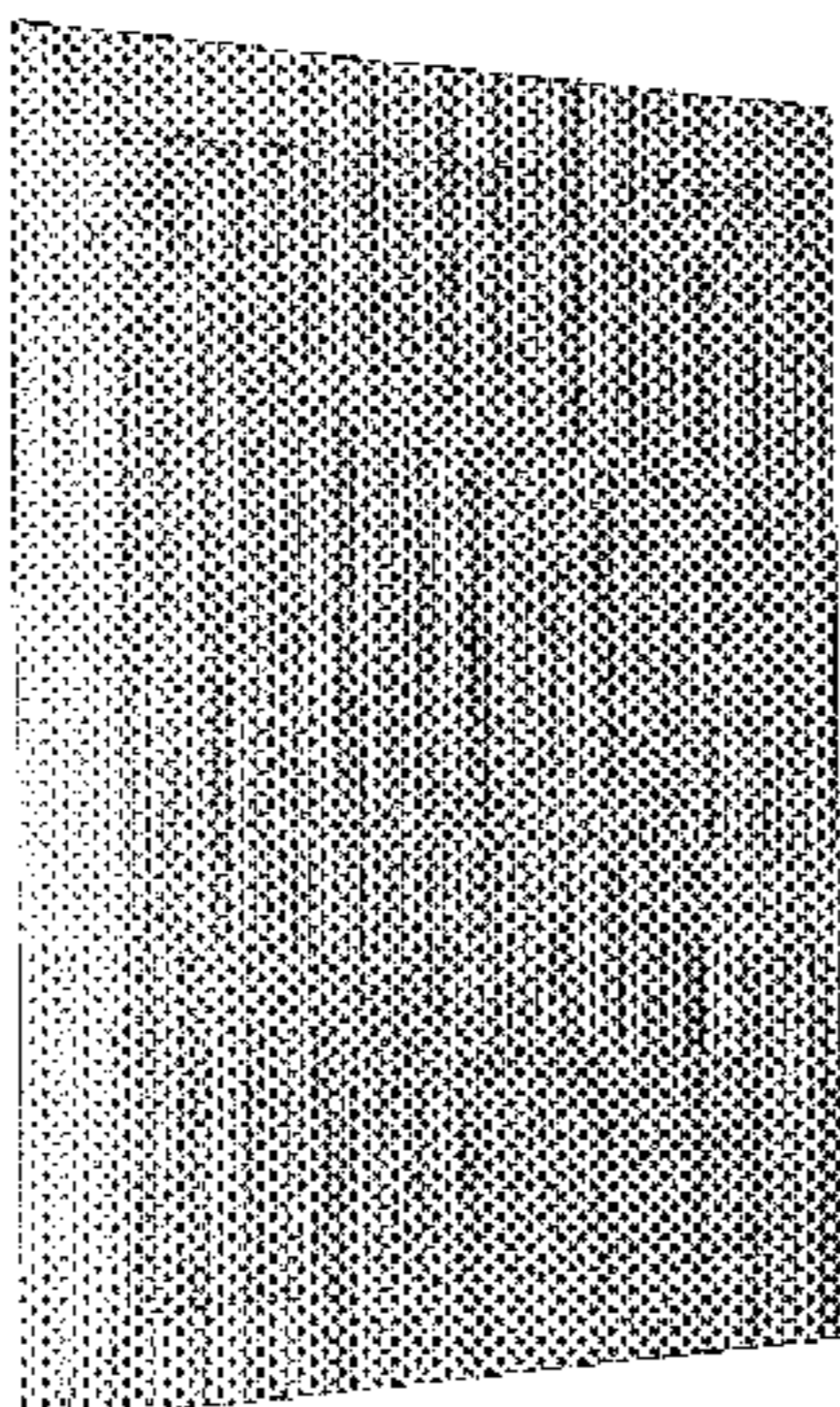
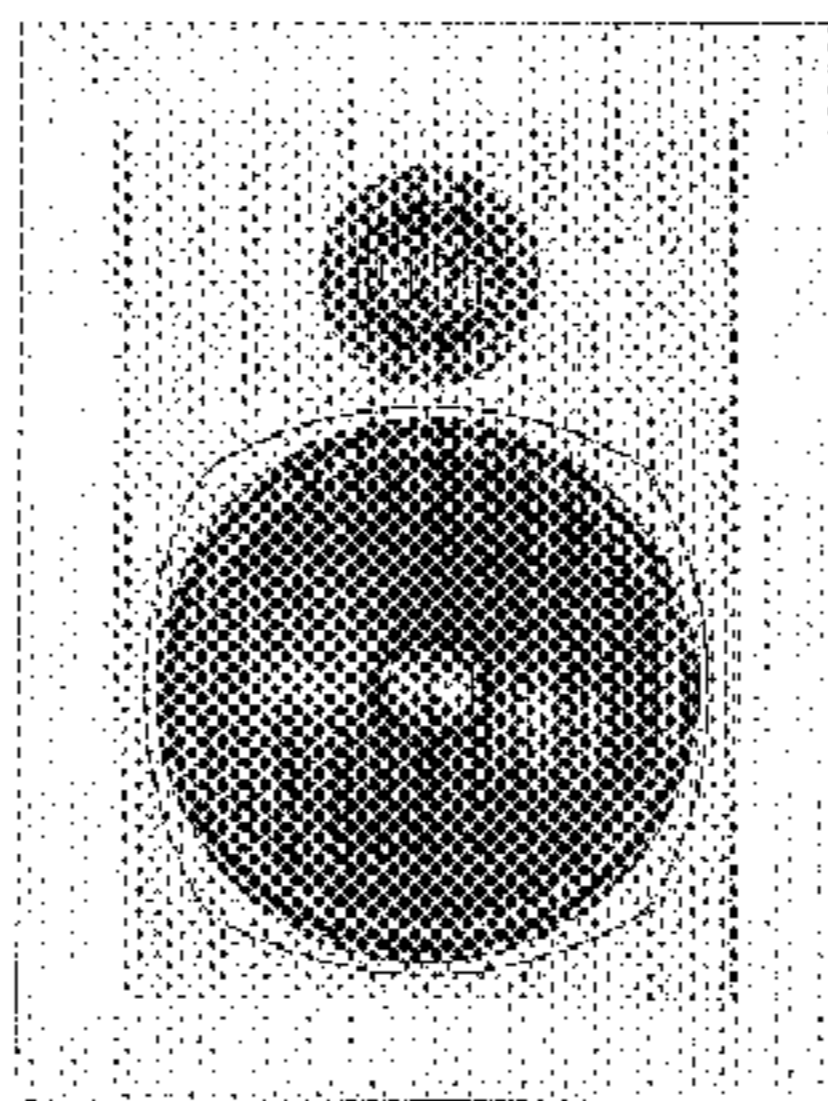
FIG. 7 is a front perspective view of a second embodiment

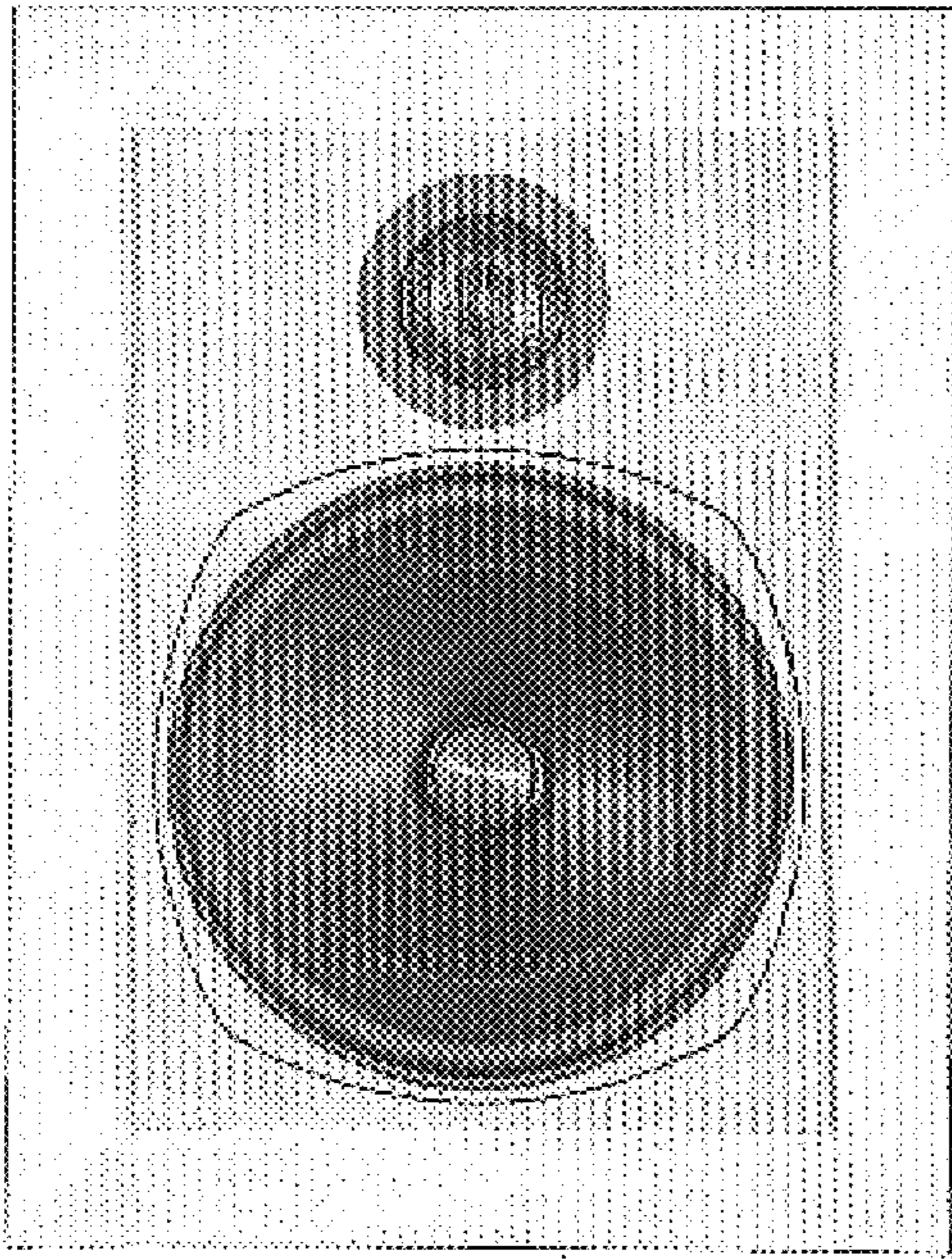

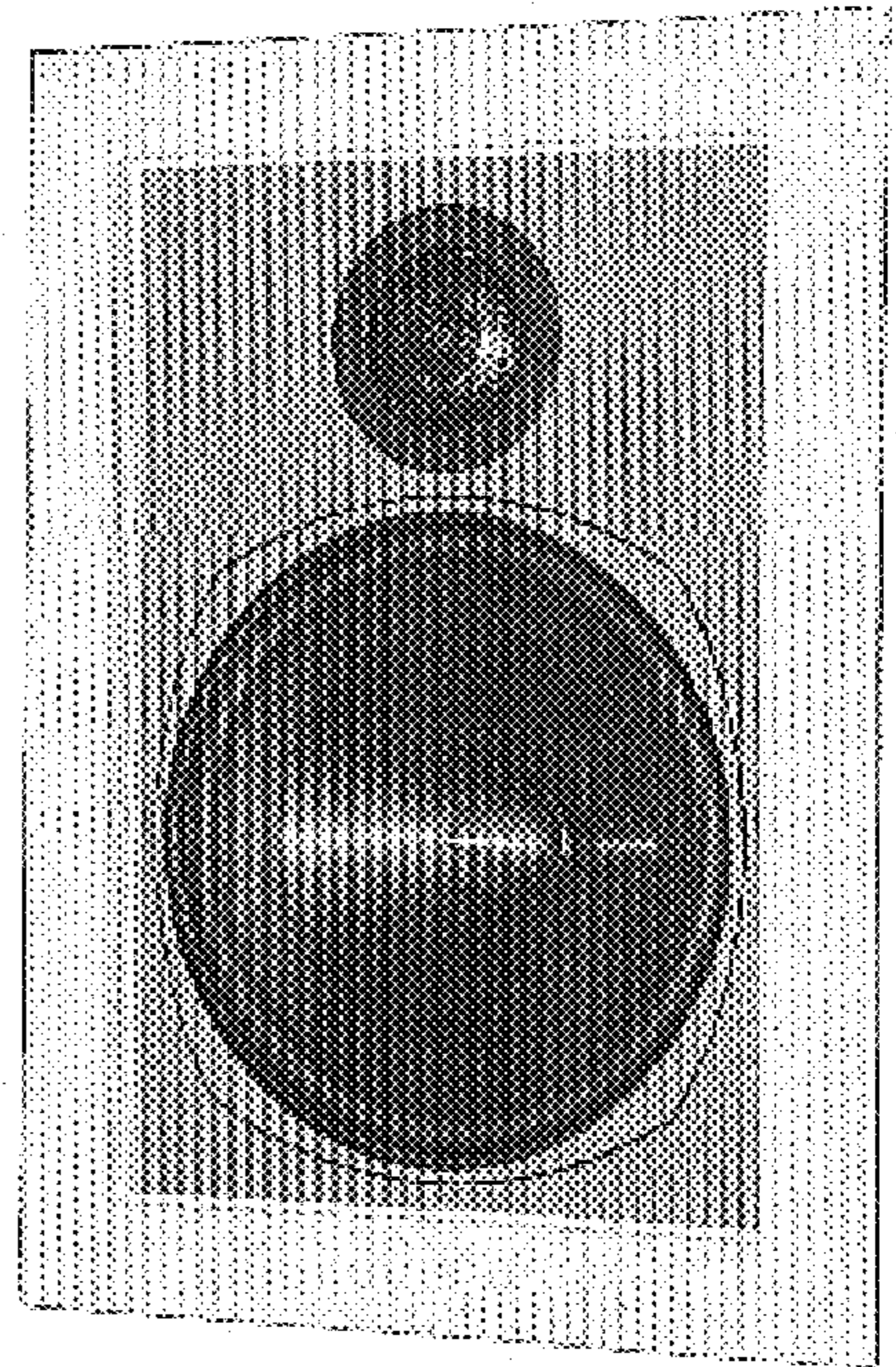

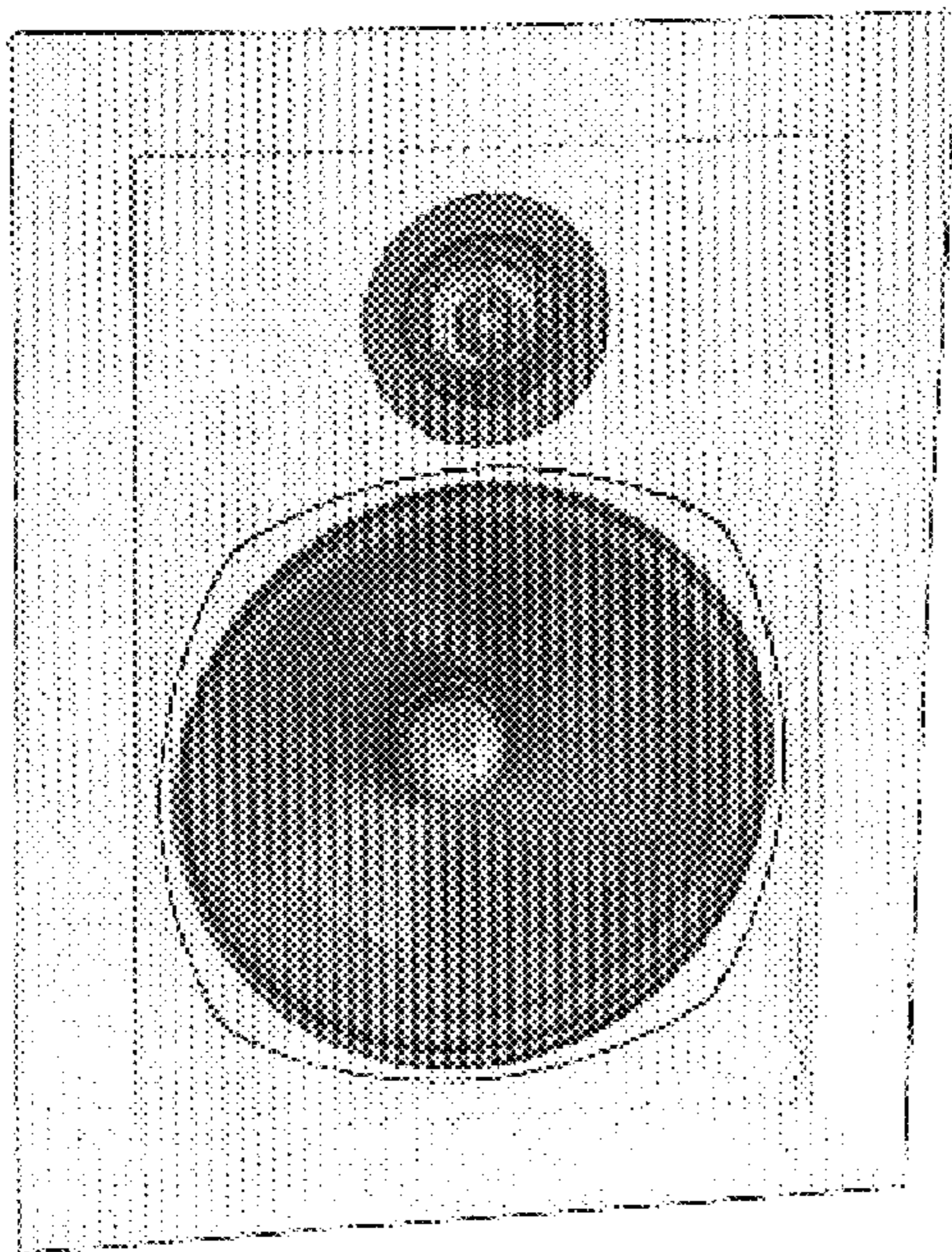

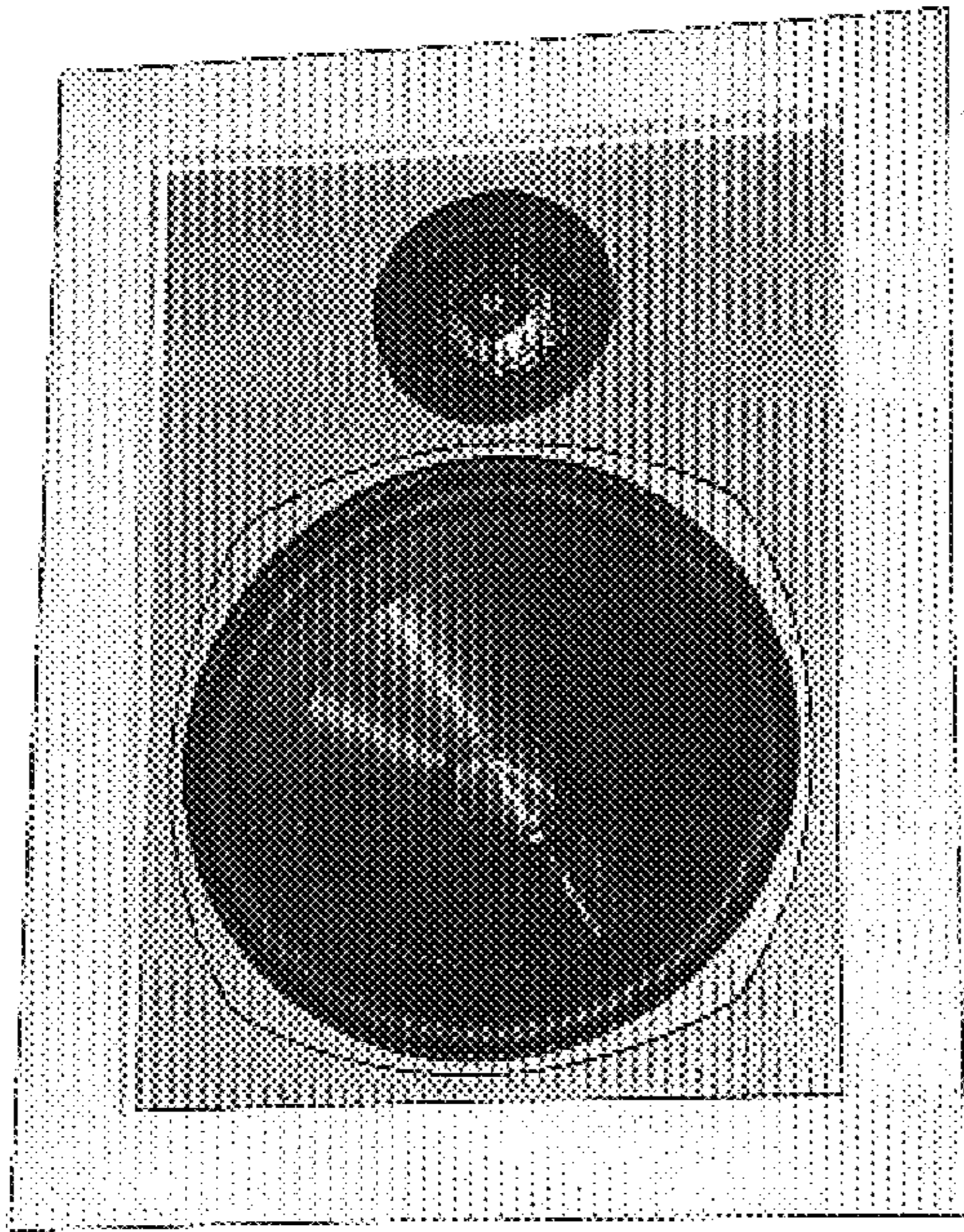

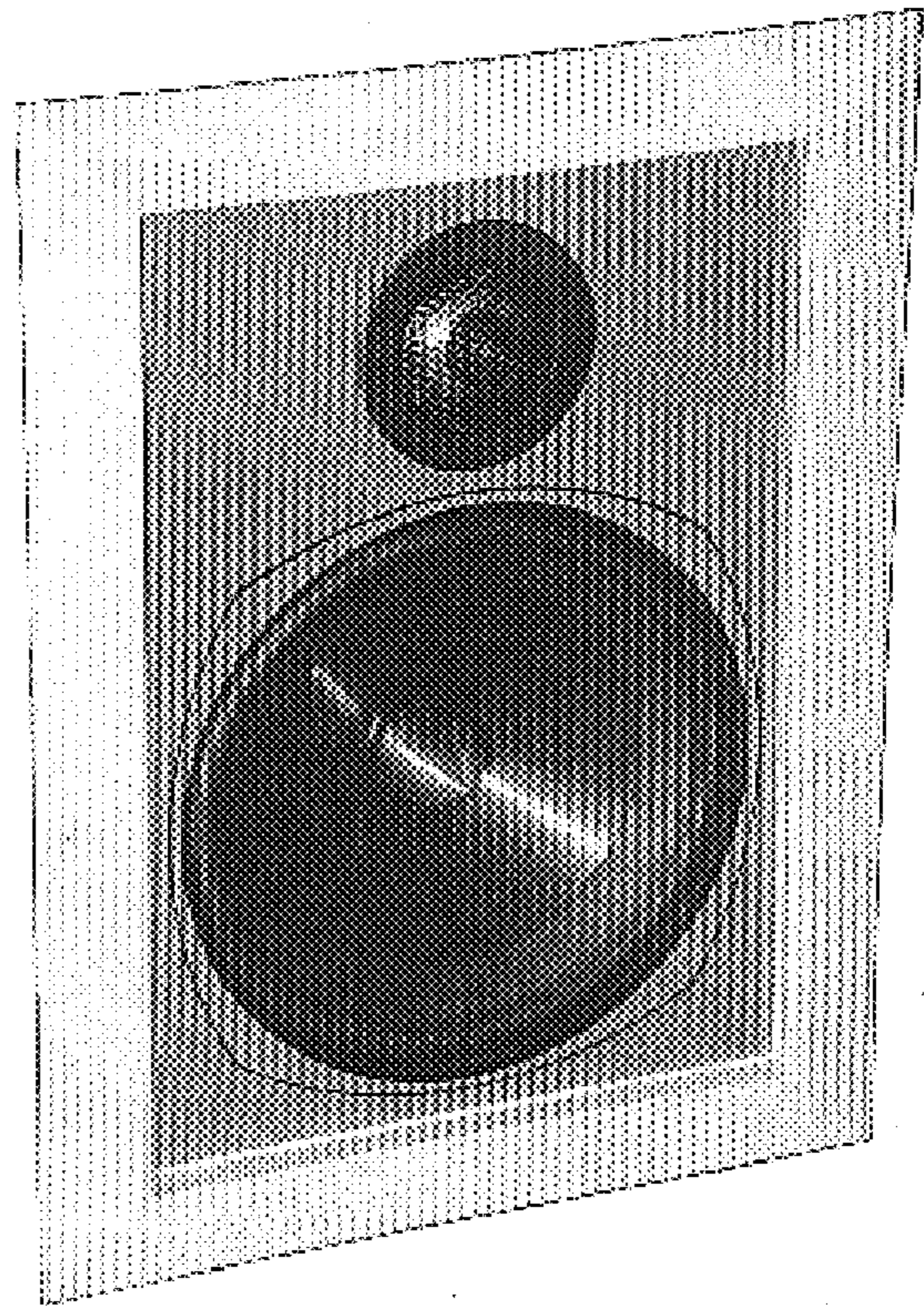

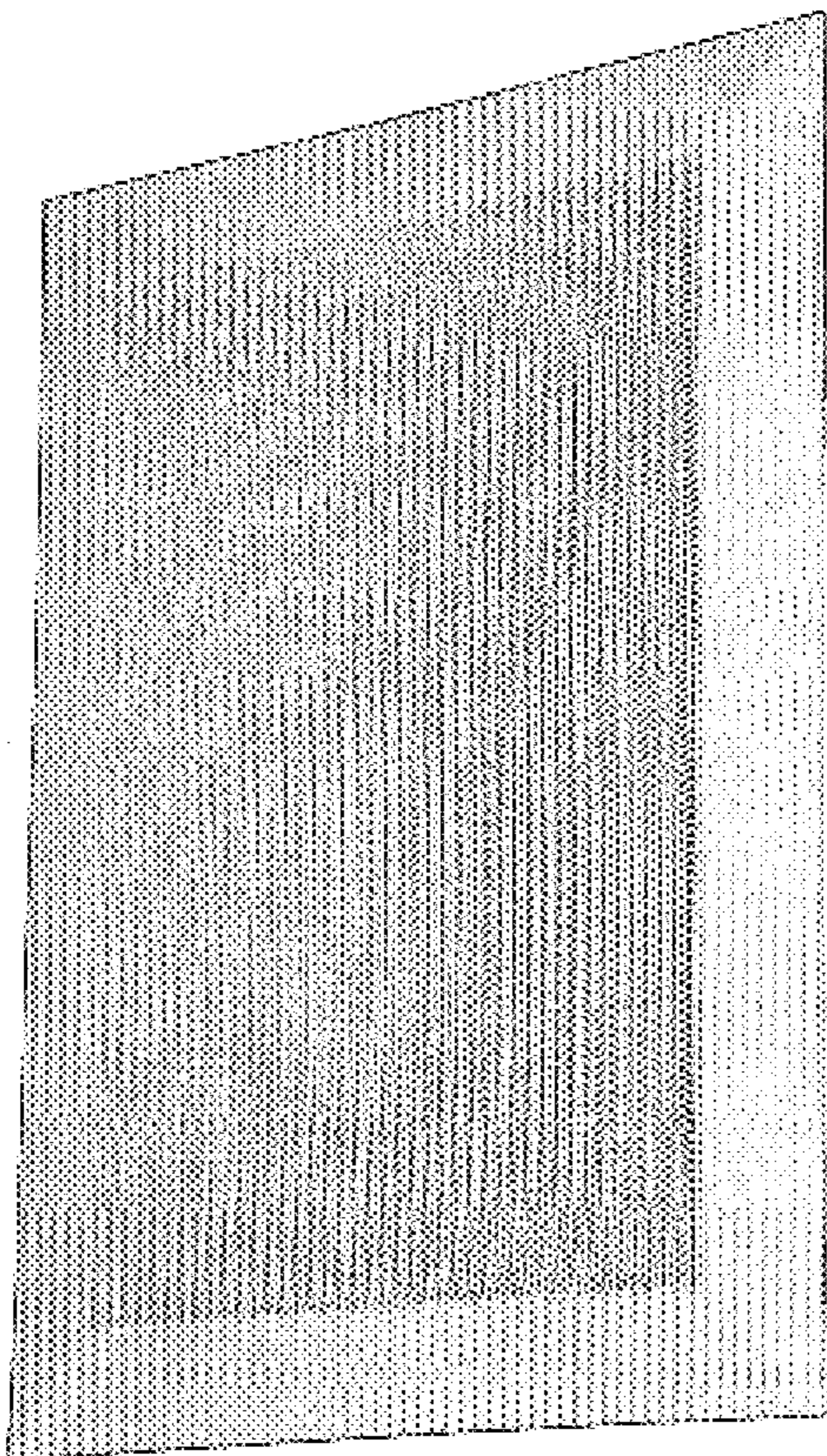

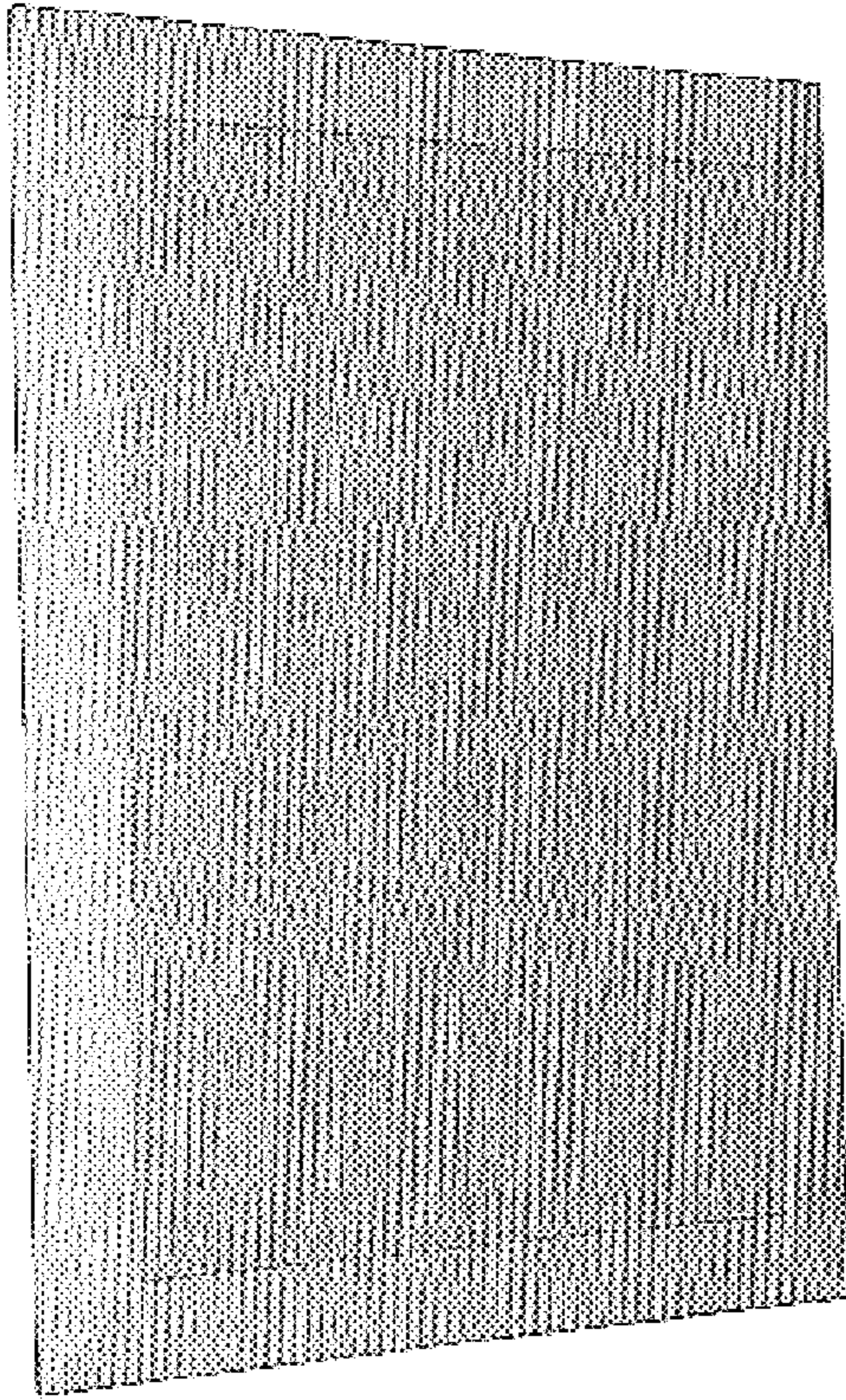

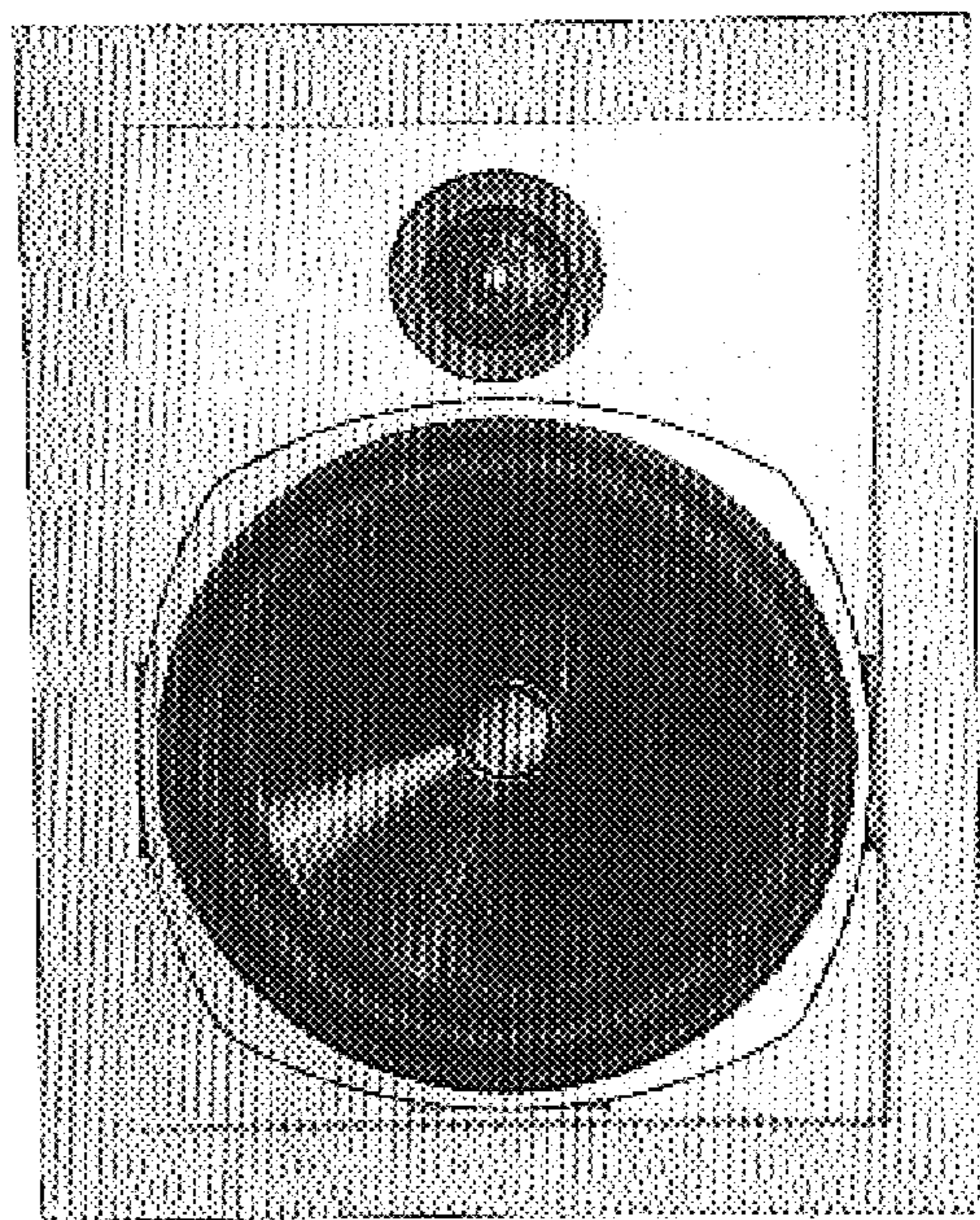

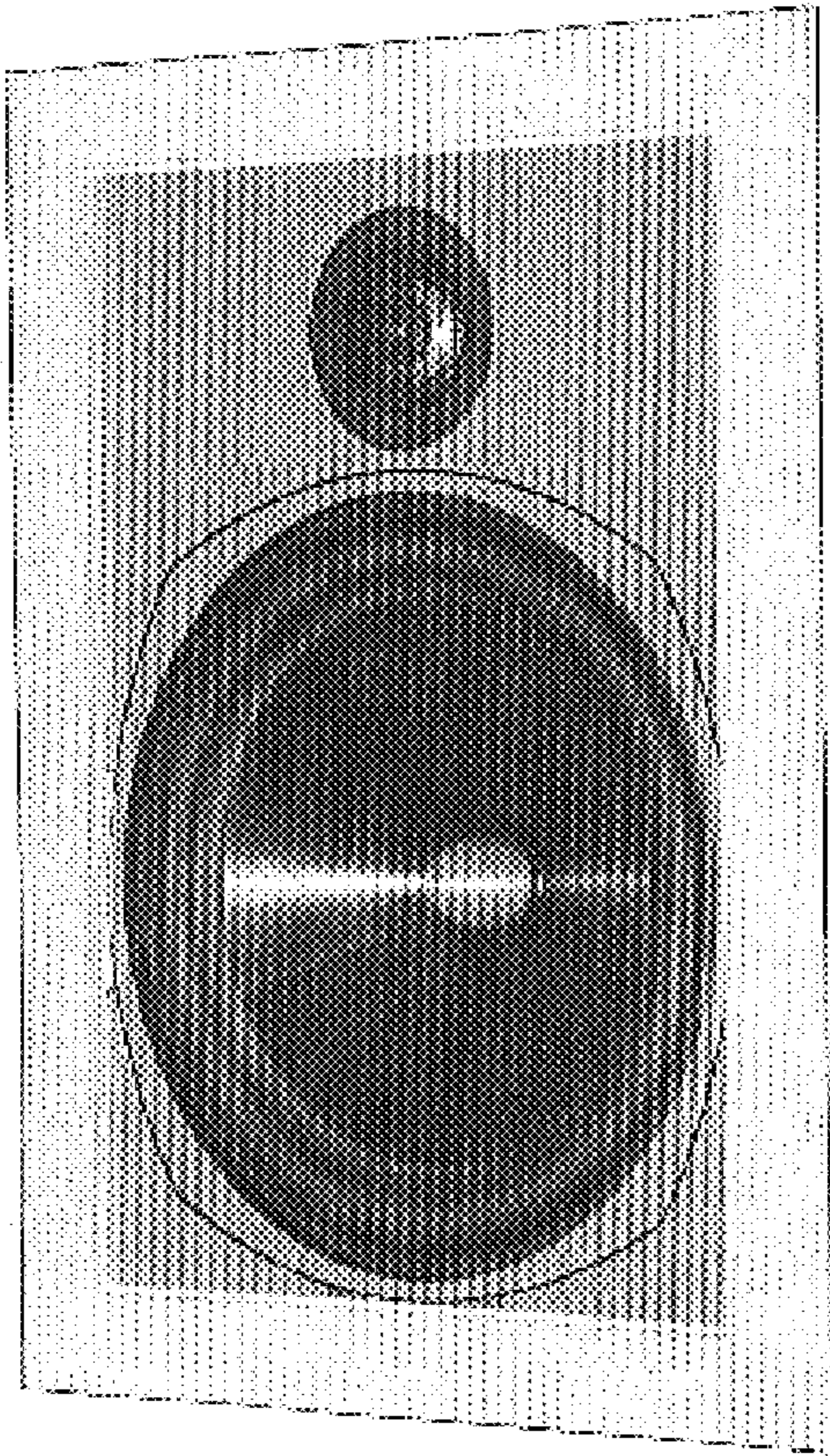

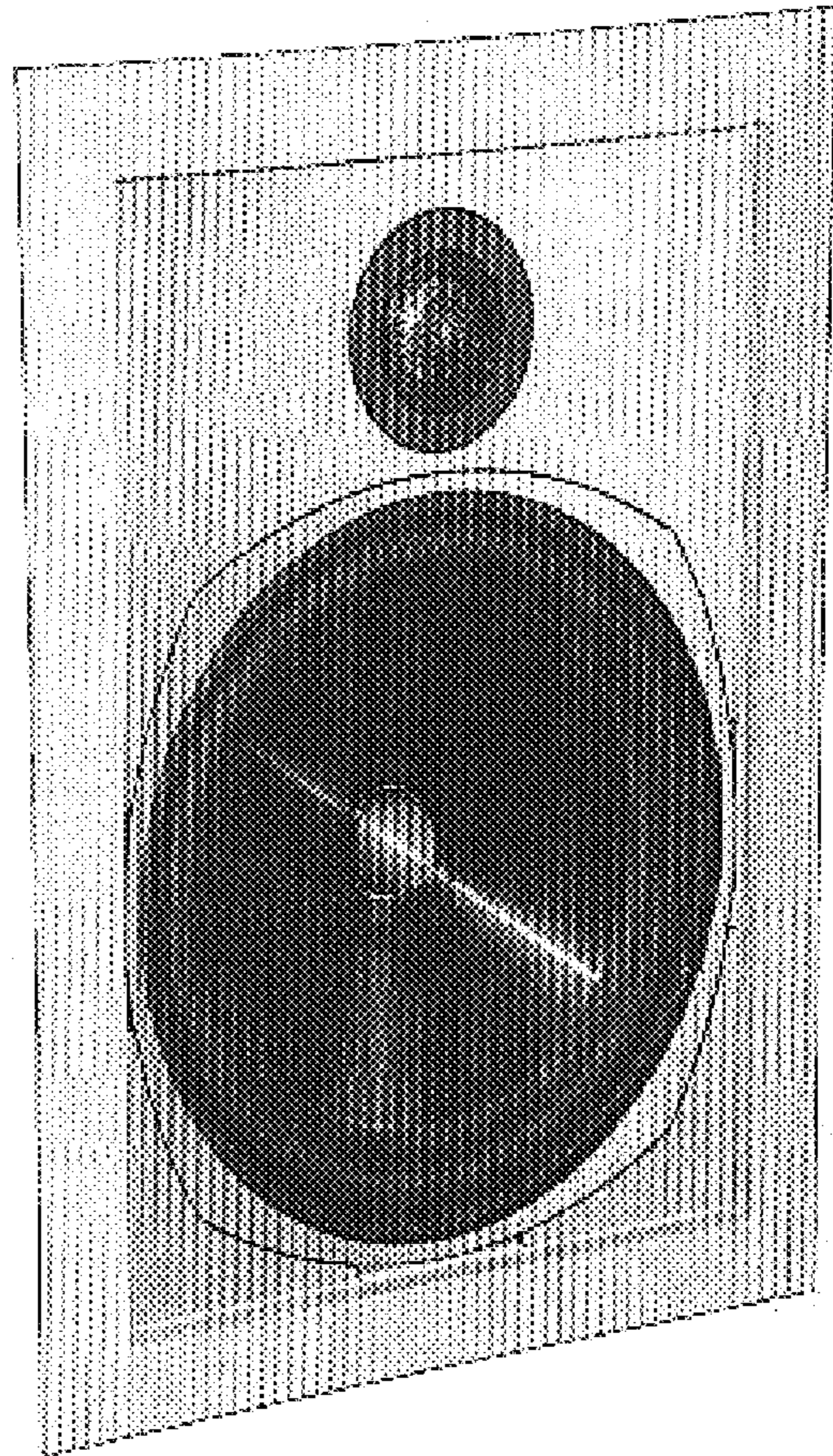
