The ornamental design for a telephone handset, as shown and described.

**DESCRIPTION**

FIG. 9 is a left side view thereof, the right side view being a mirror image thereof;

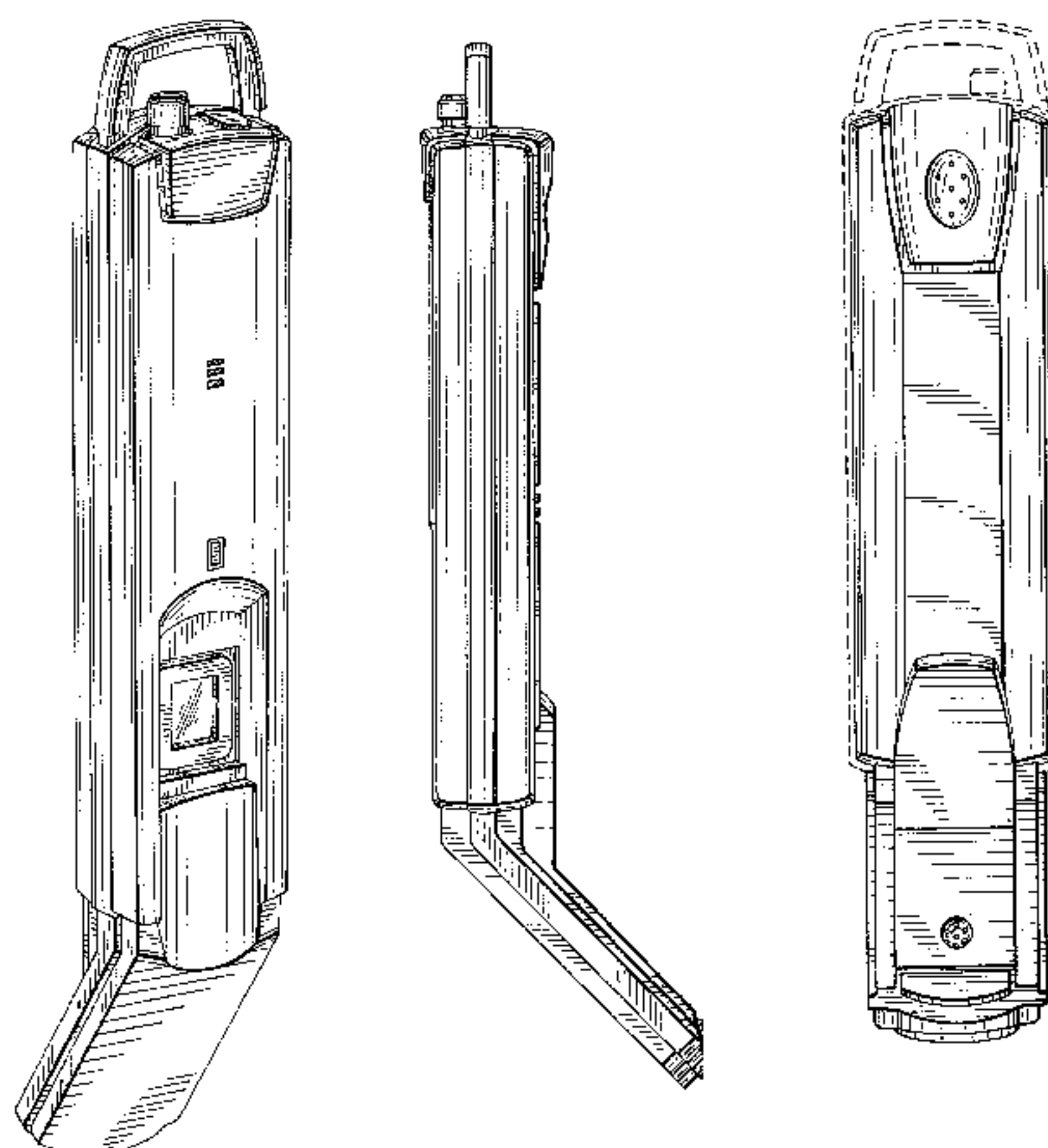
FIG. 10 is a top view thereof;

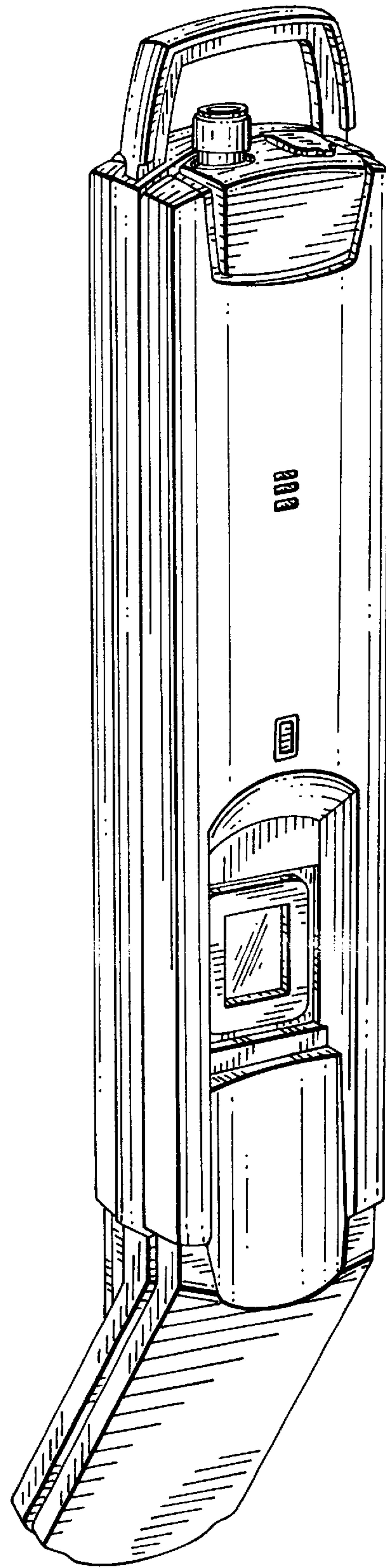

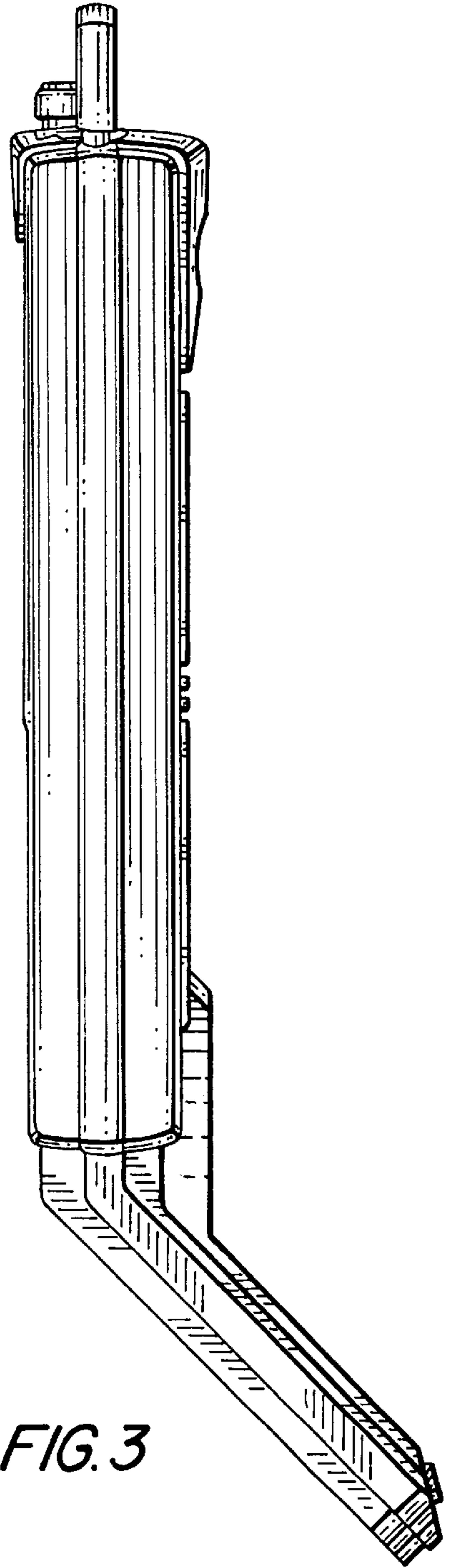
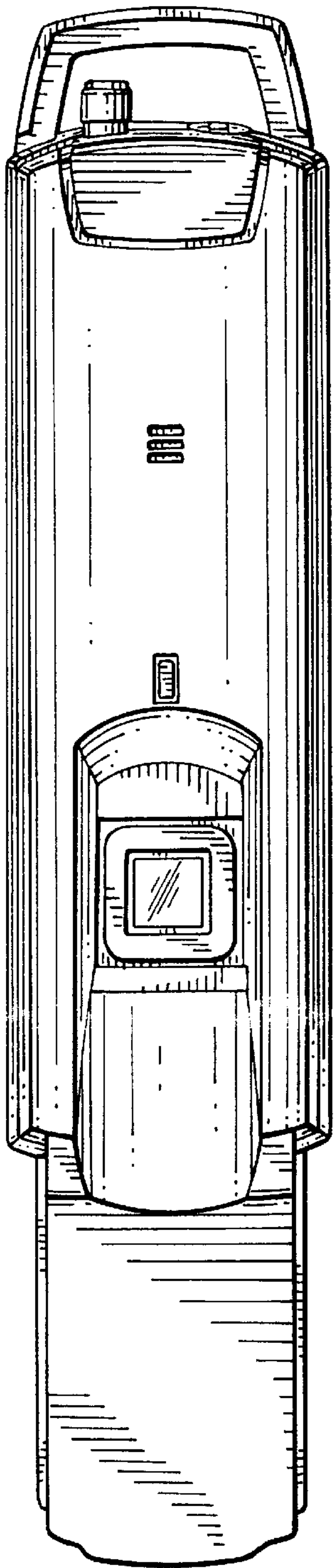
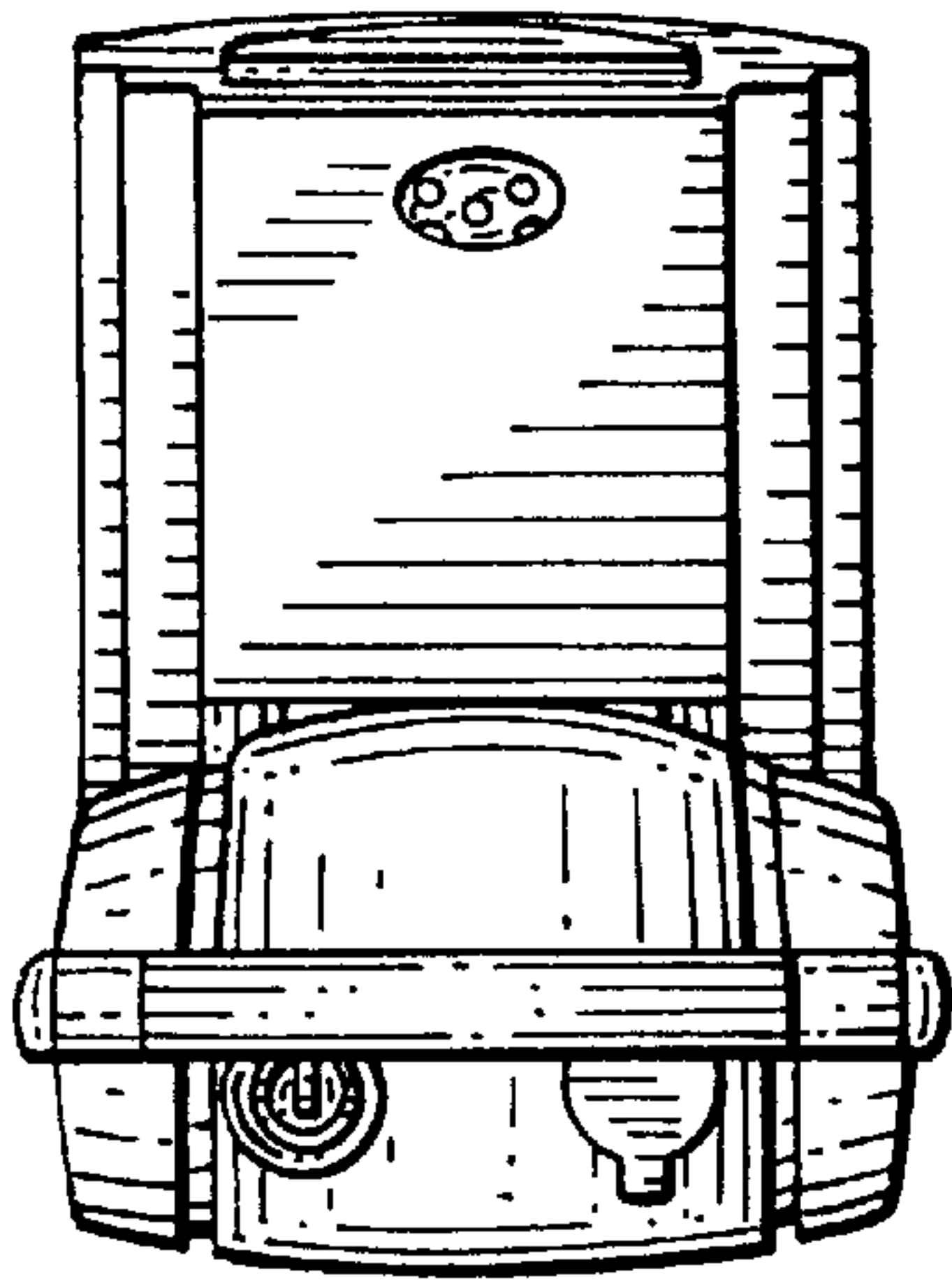


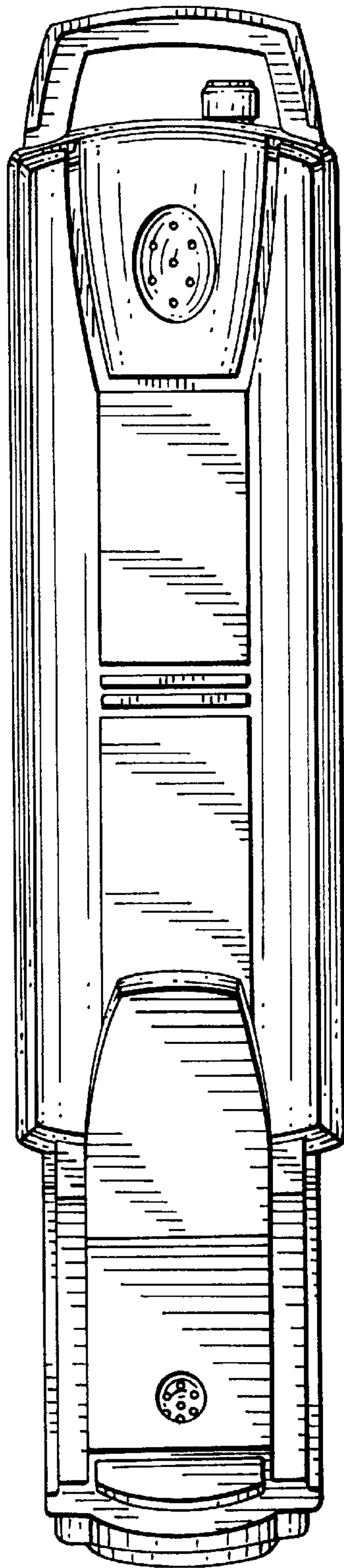

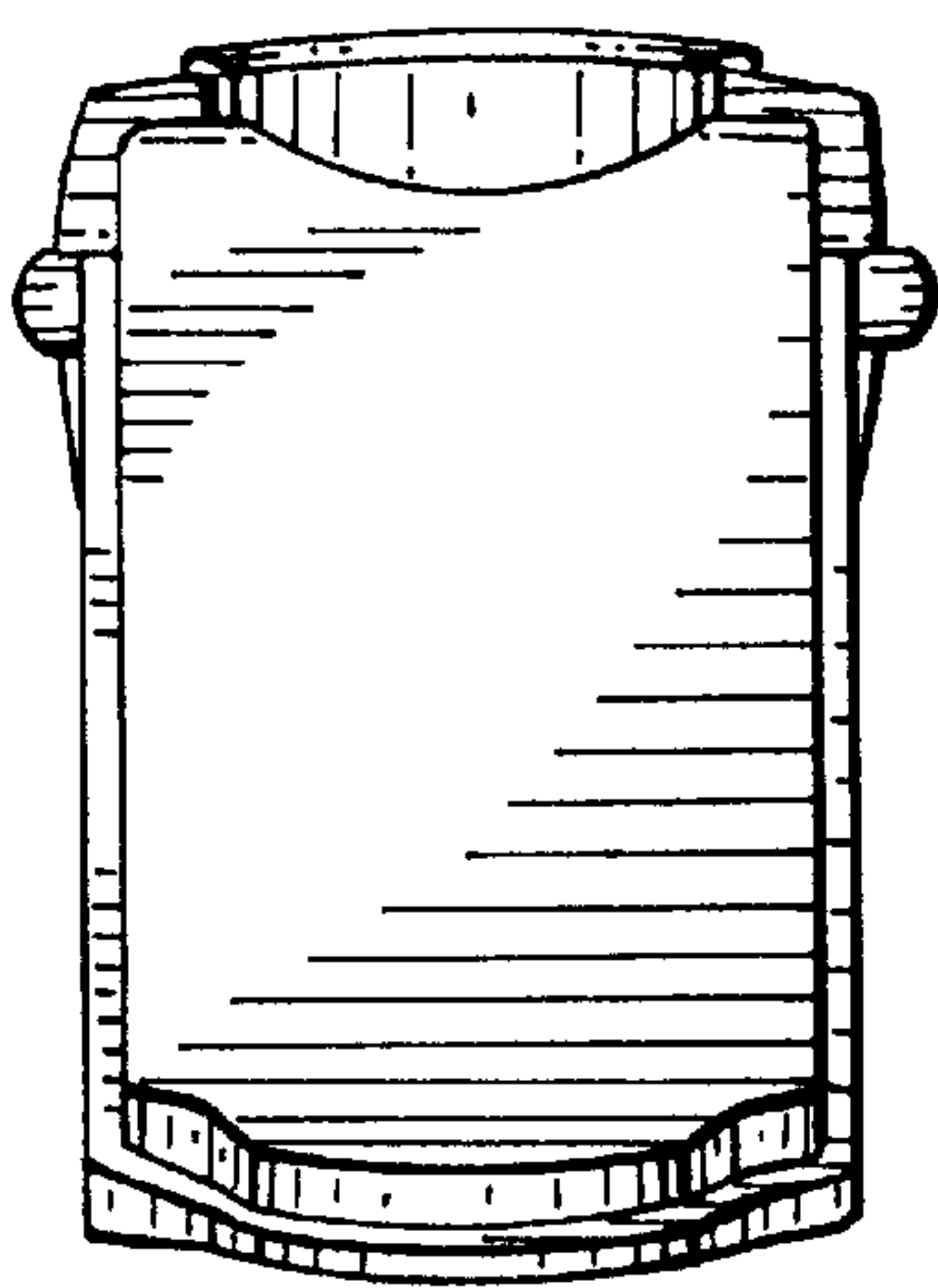

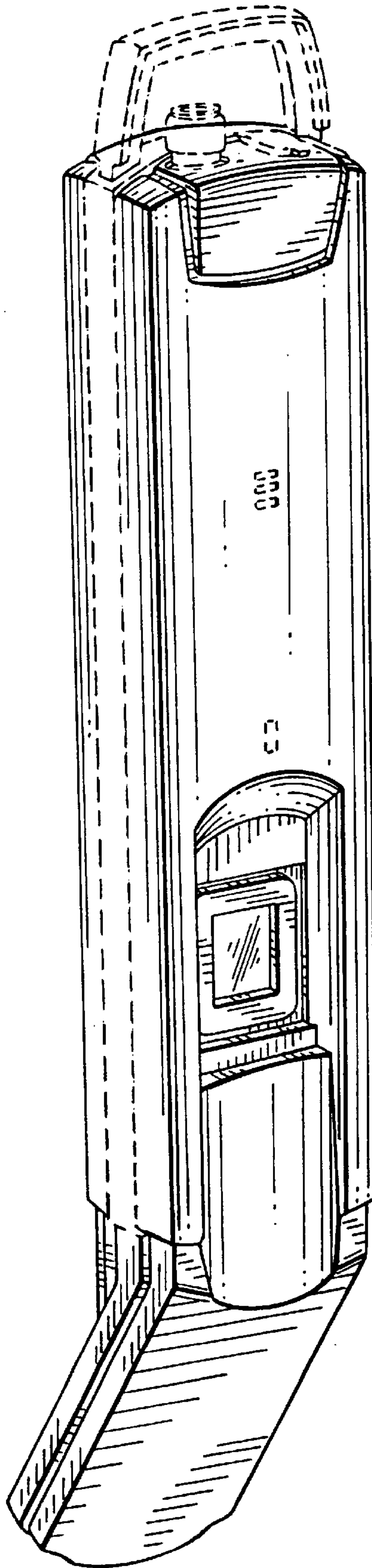

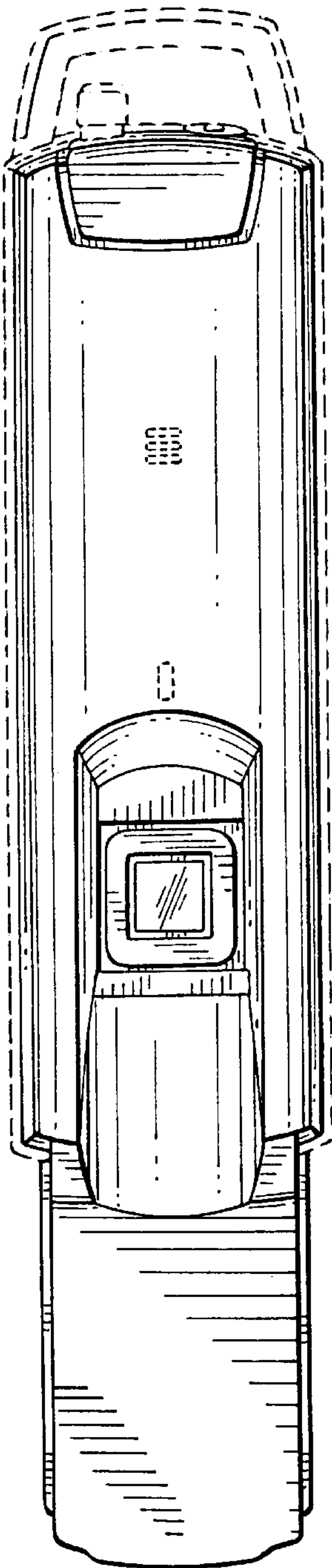

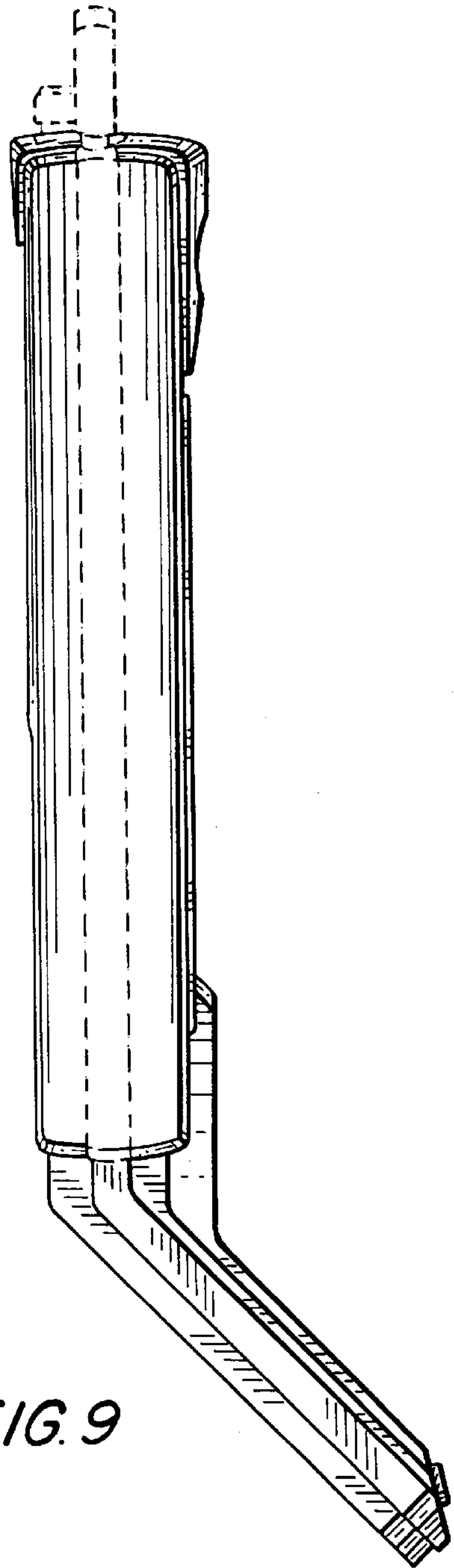

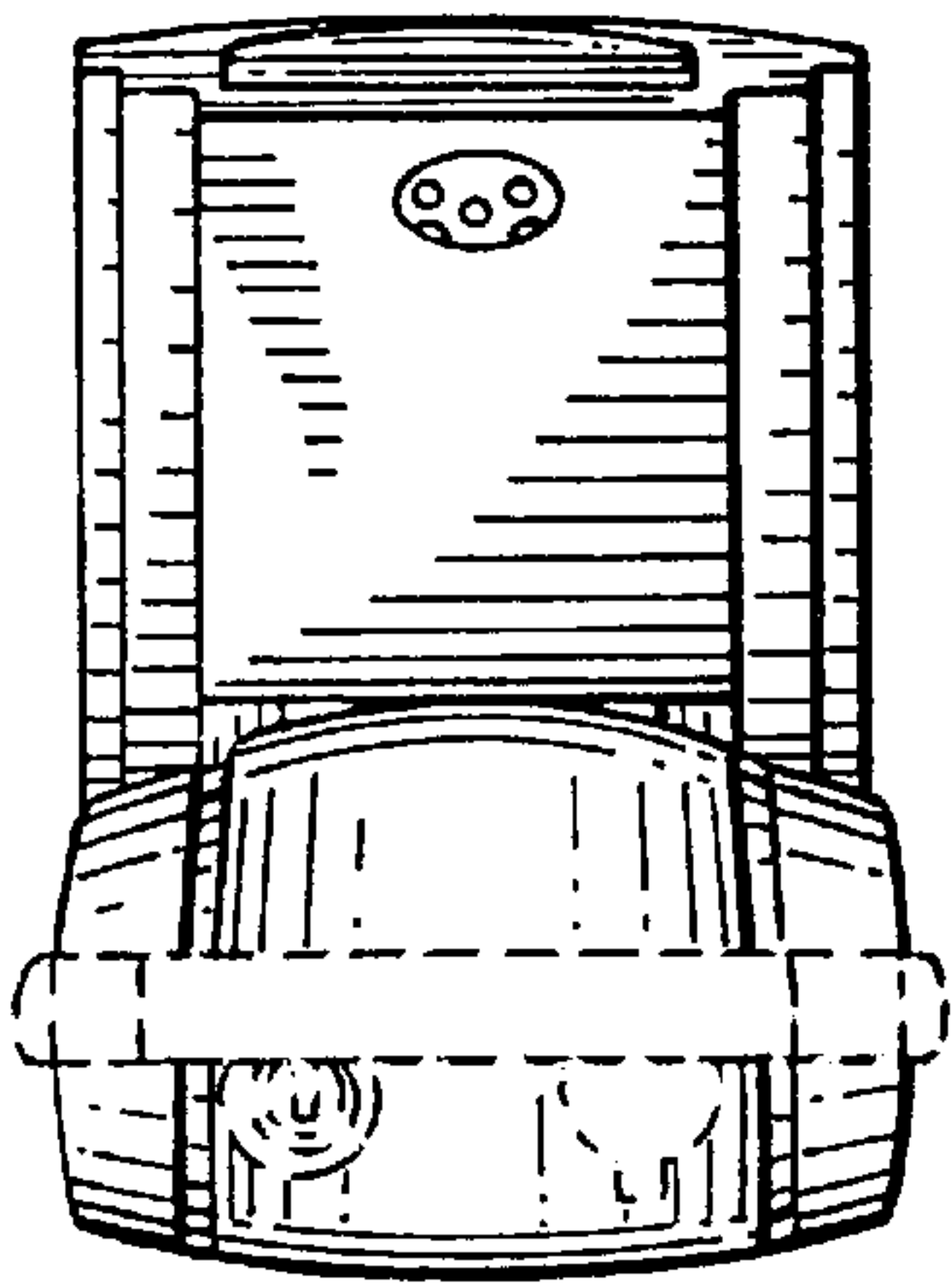

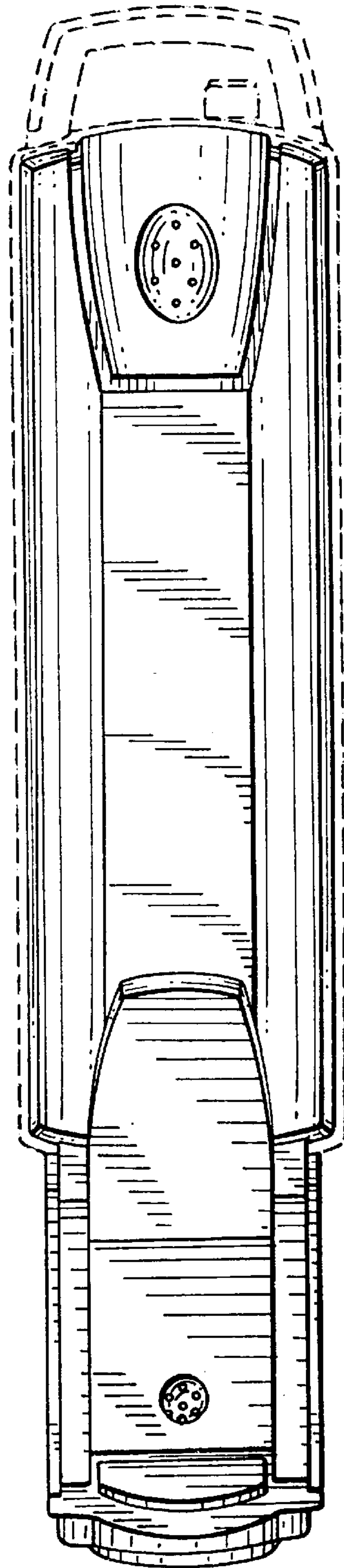
