(57) **CLAIM**

The ornamental design for an organizer cover, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of an organizer cover showing my new design, which includes a left-side flap and top and bottom right-side flaps;

FIG. 2 is a left side elevation view thereof;

FIG. 3 is a right side elevation view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a rear elevation view thereof;

FIG. 7 is a front elevation view thereof, with the right-side flaps swung open;

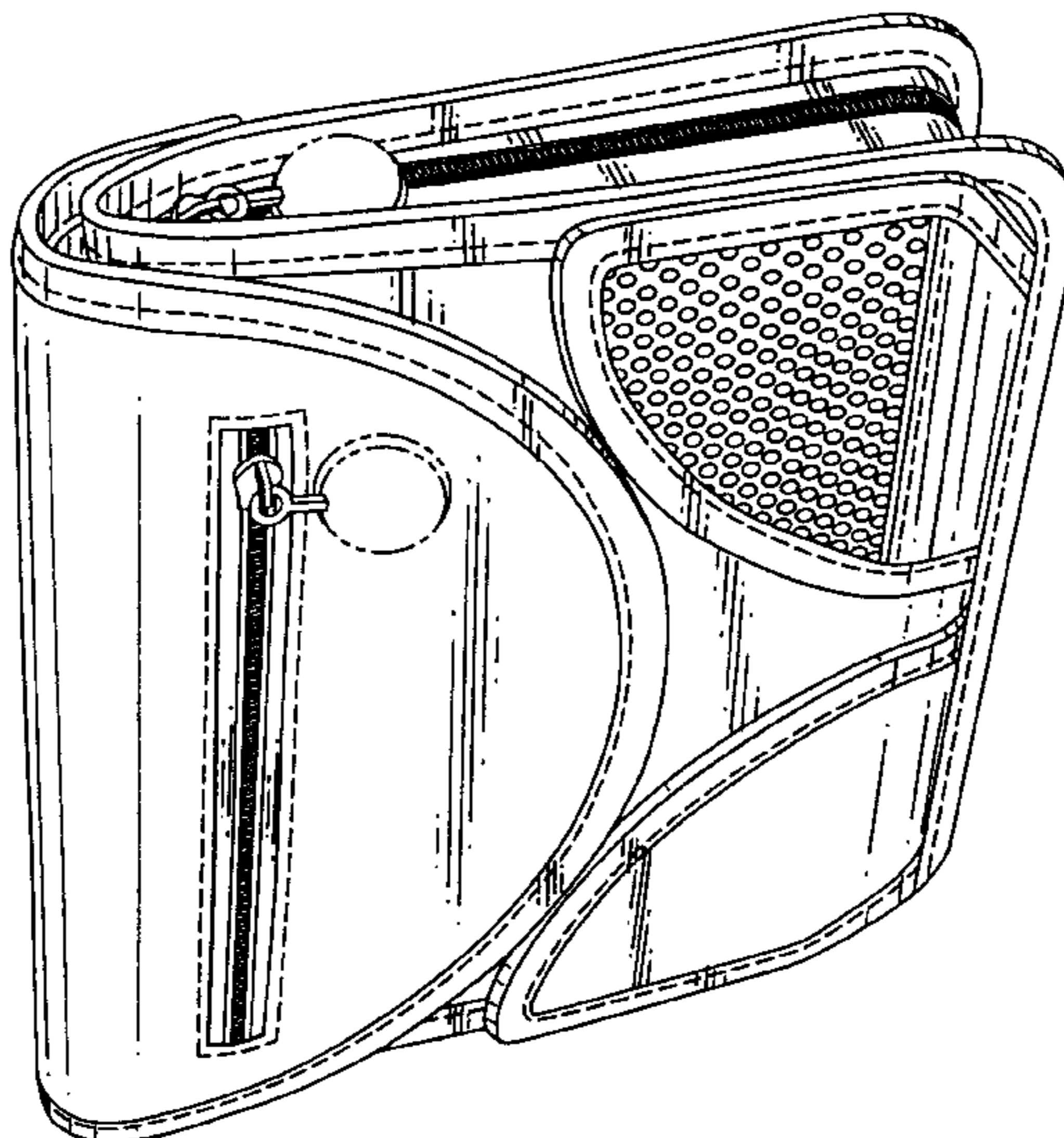
FIG. 8 is a front elevation view thereof, with the left-side flap swung open;

FIG. 9 is a front elevation view thereof, with the left-side and the right-side flaps swung open; and,

FIG. 10 is a perspective view thereof.

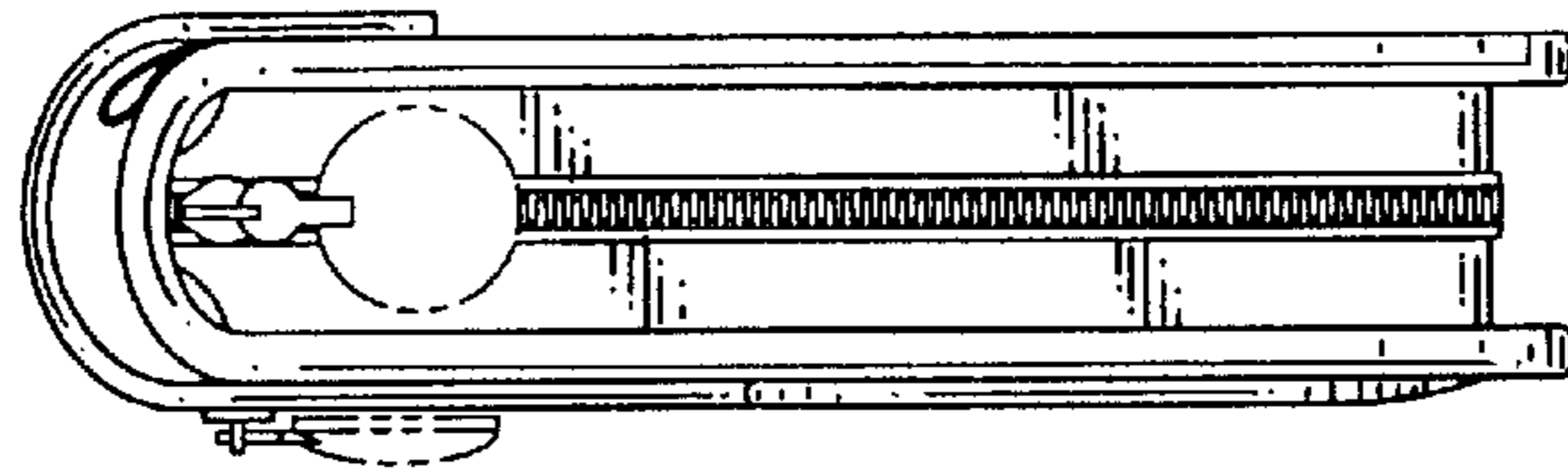

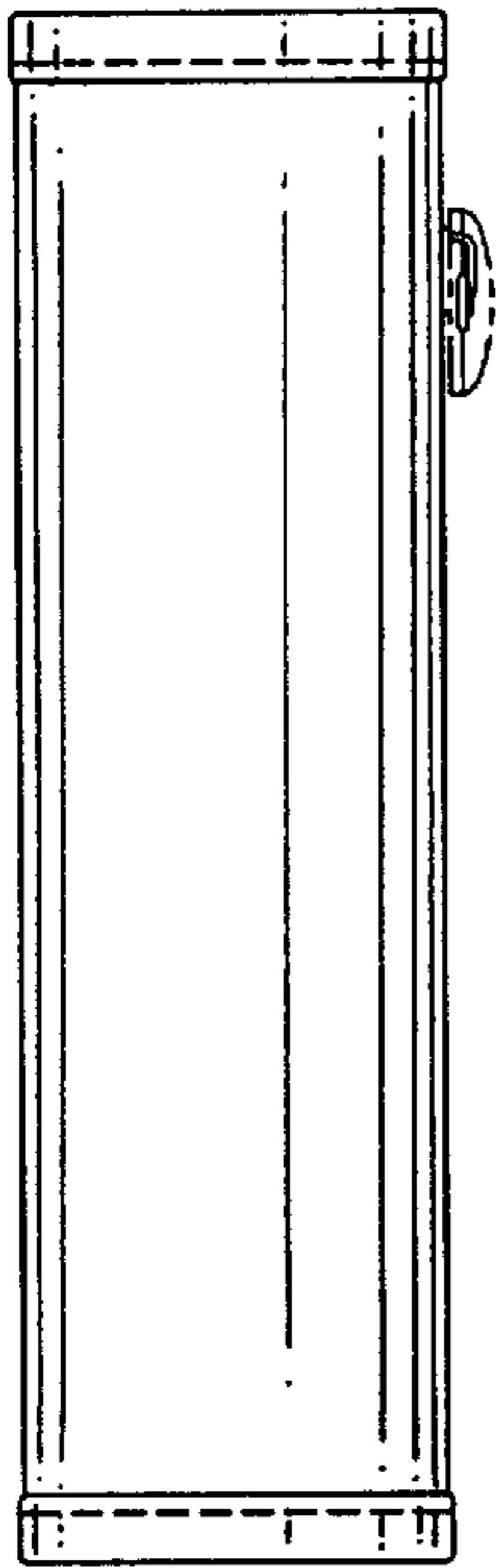

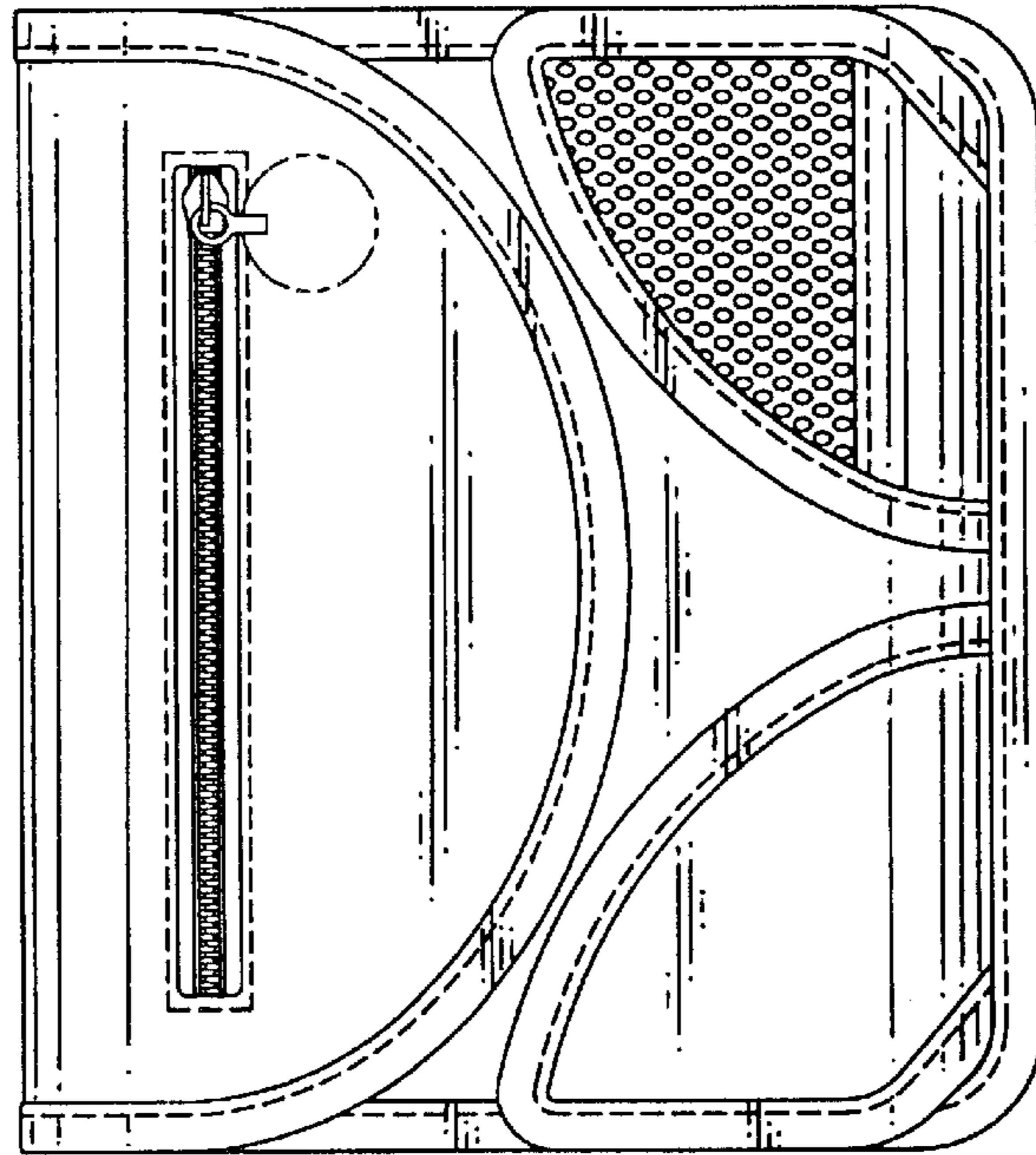

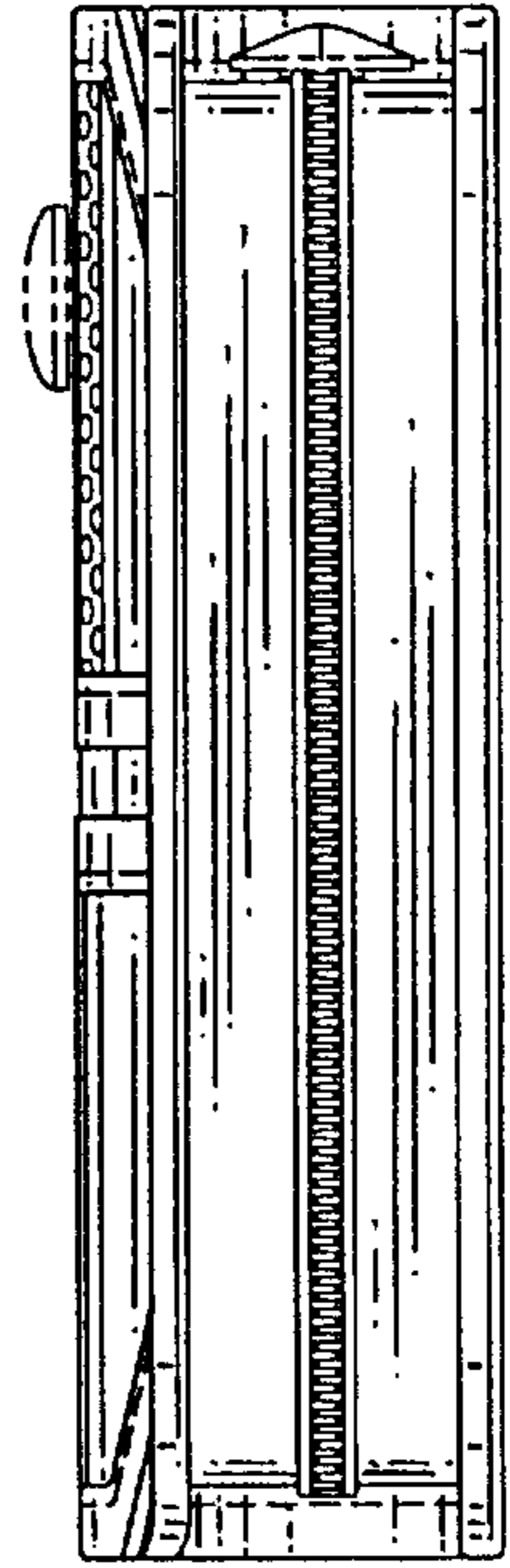

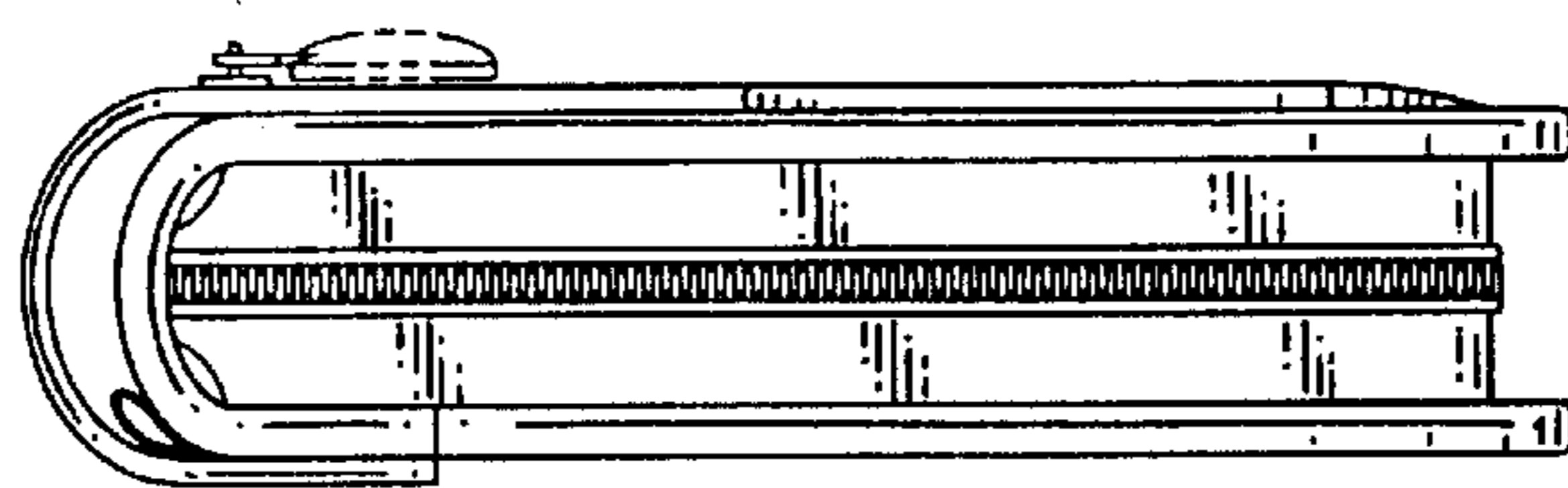

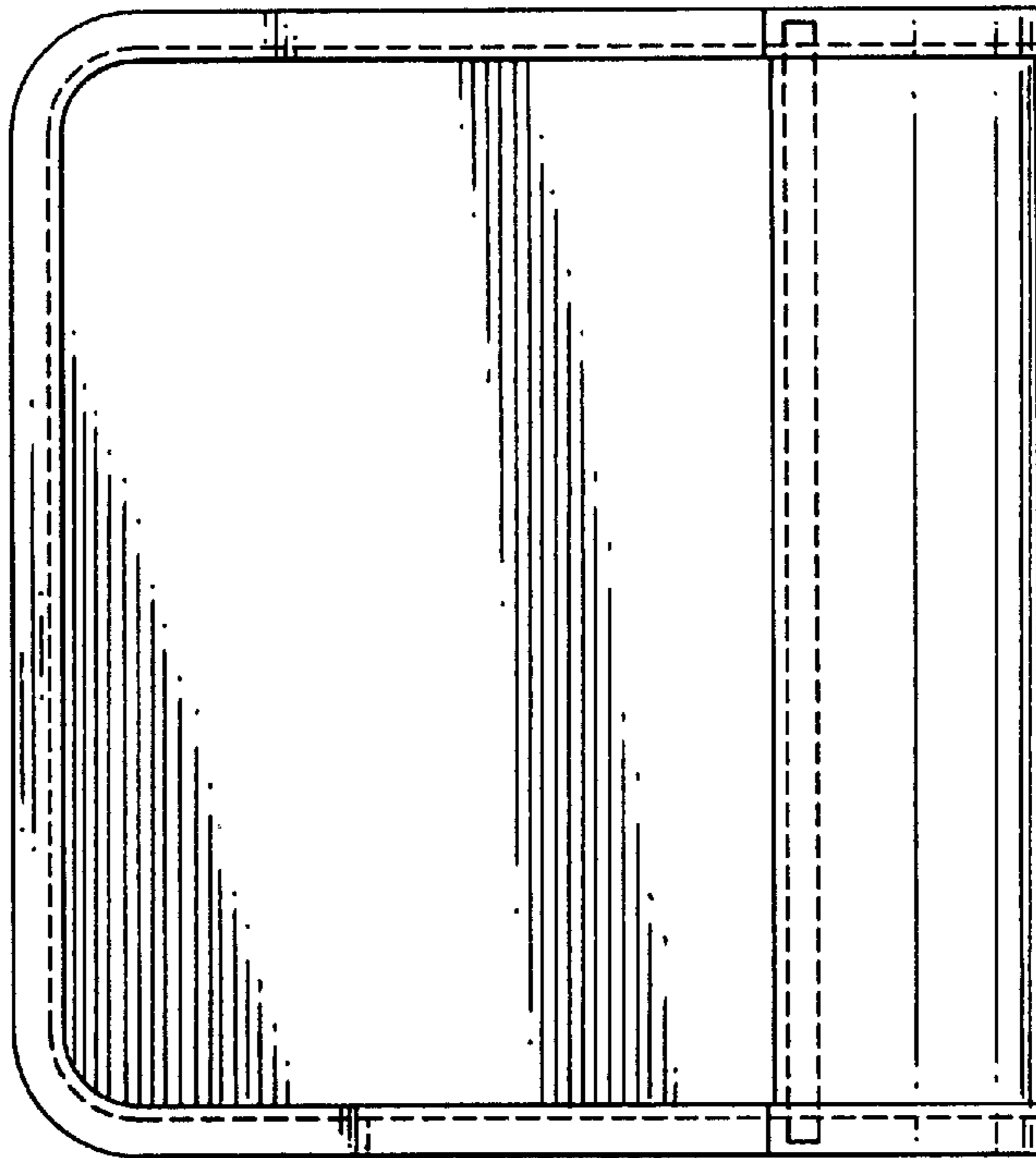
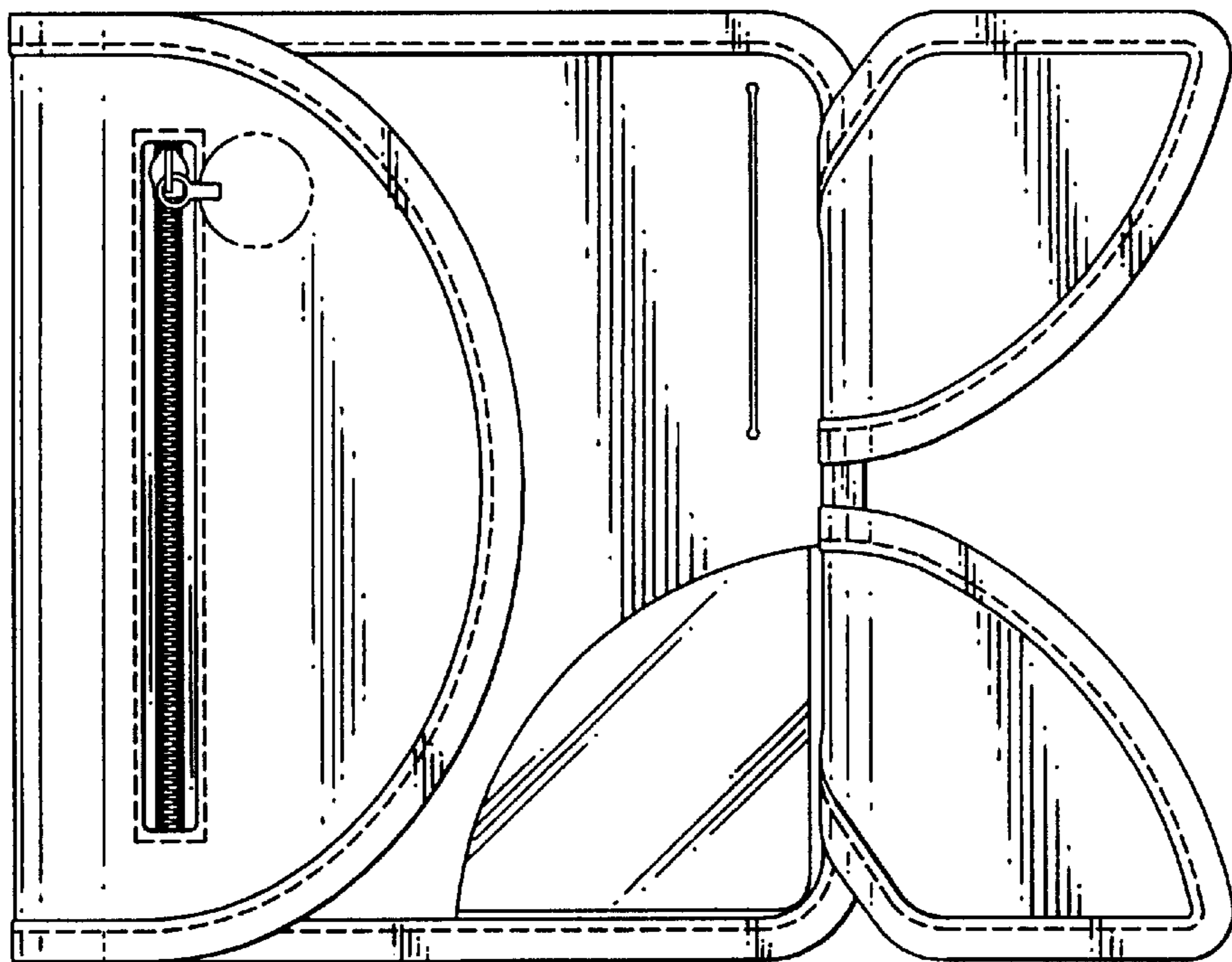

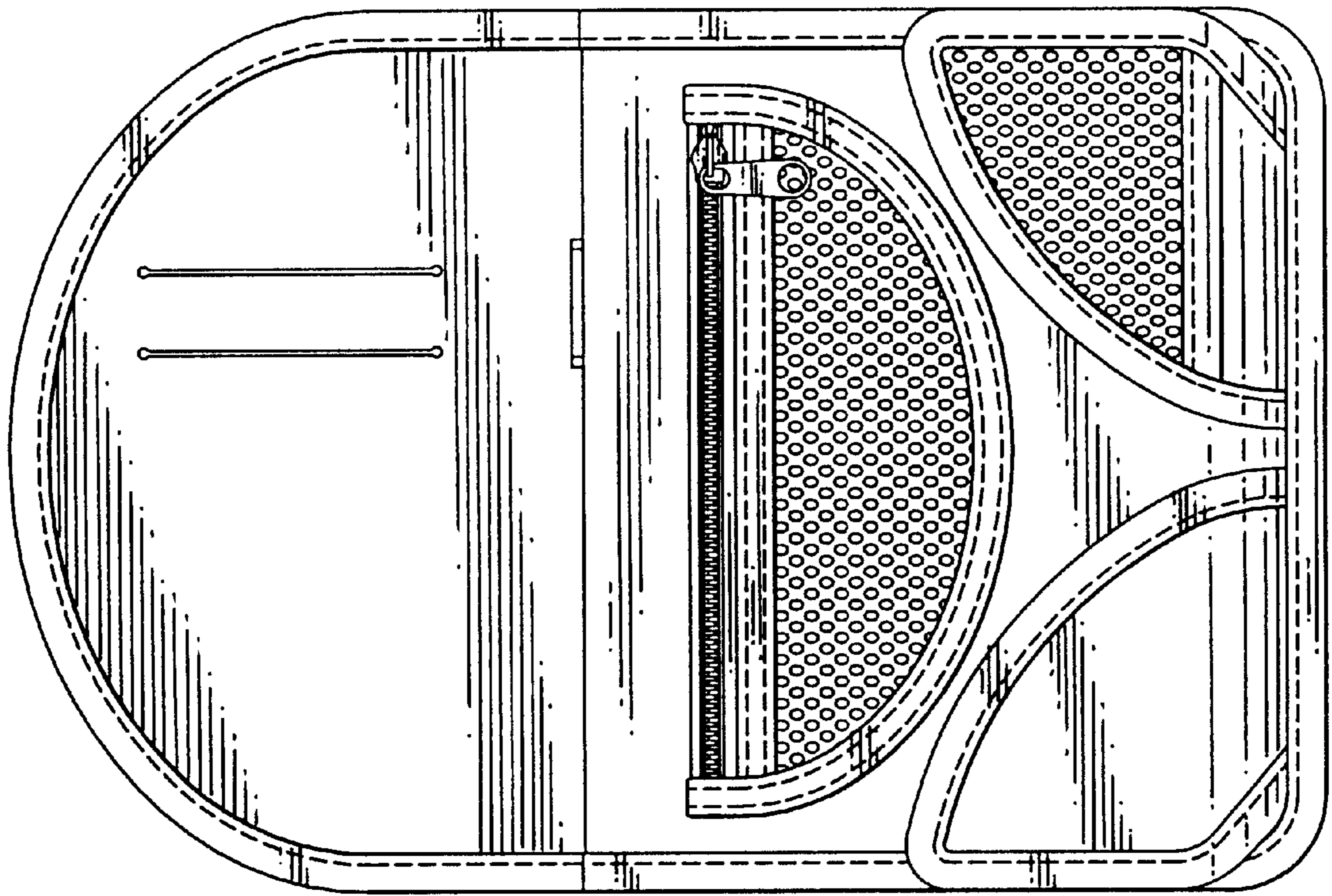

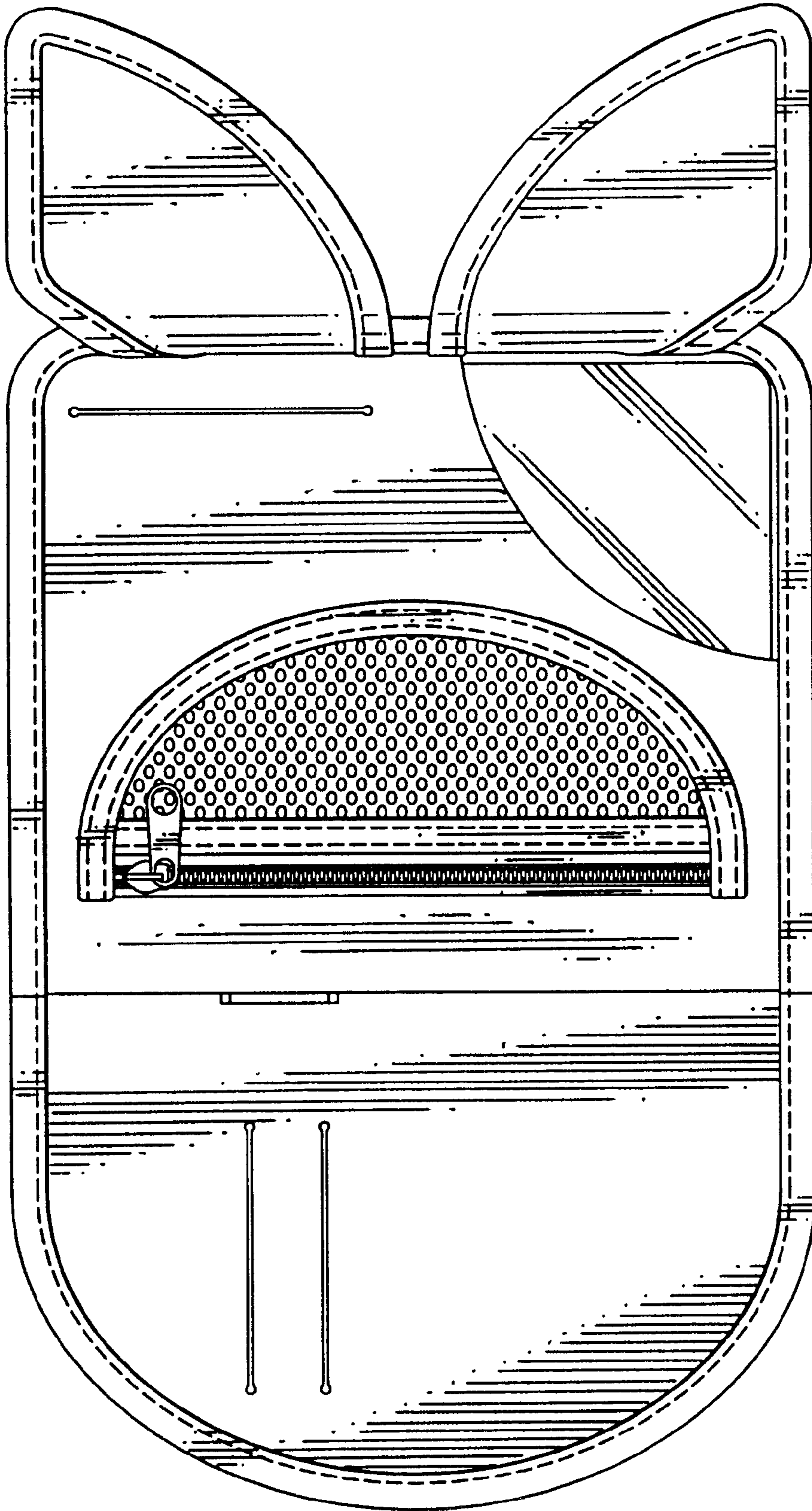

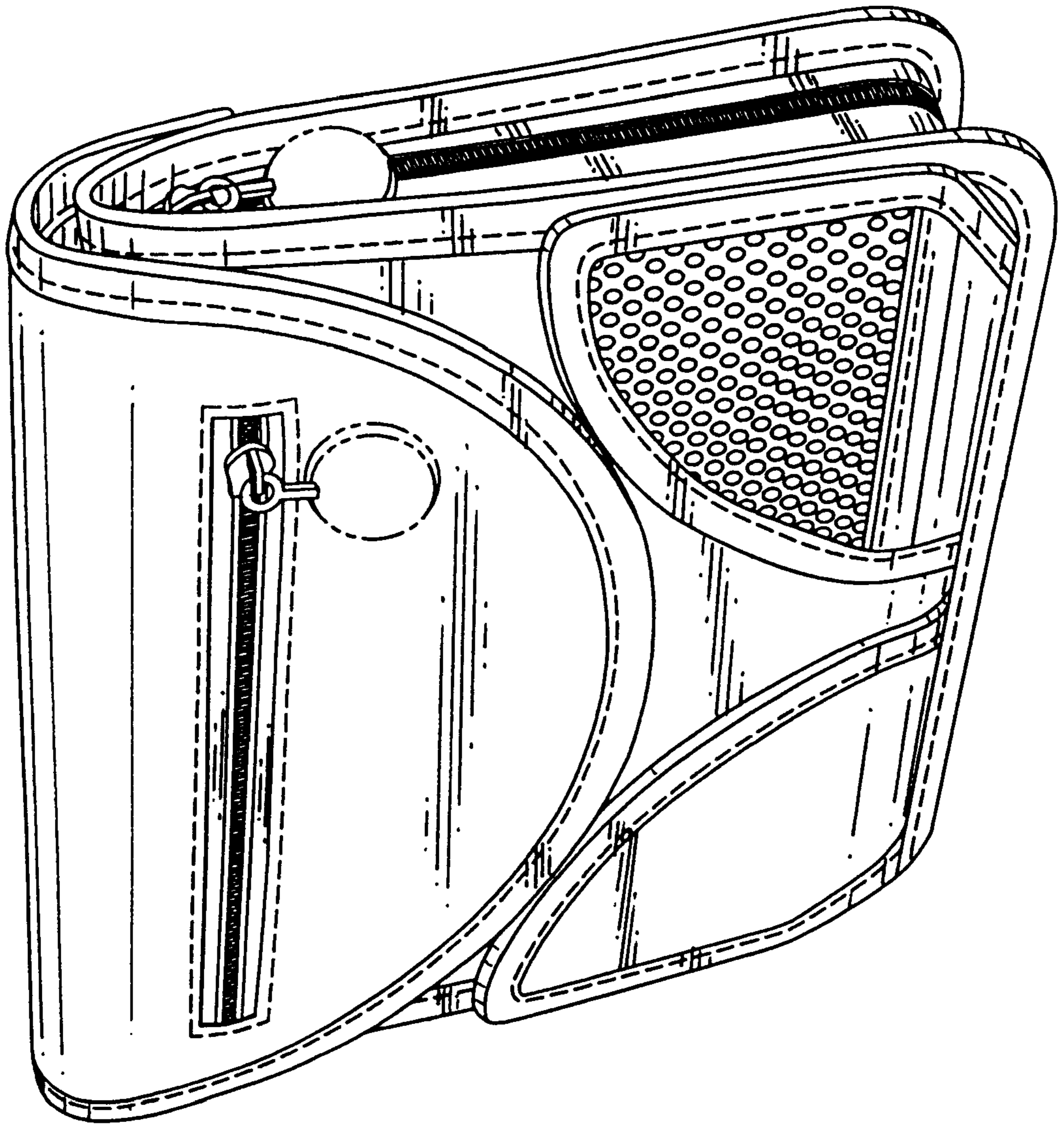
