FIG. 4 is a toe side elevational view thereof;

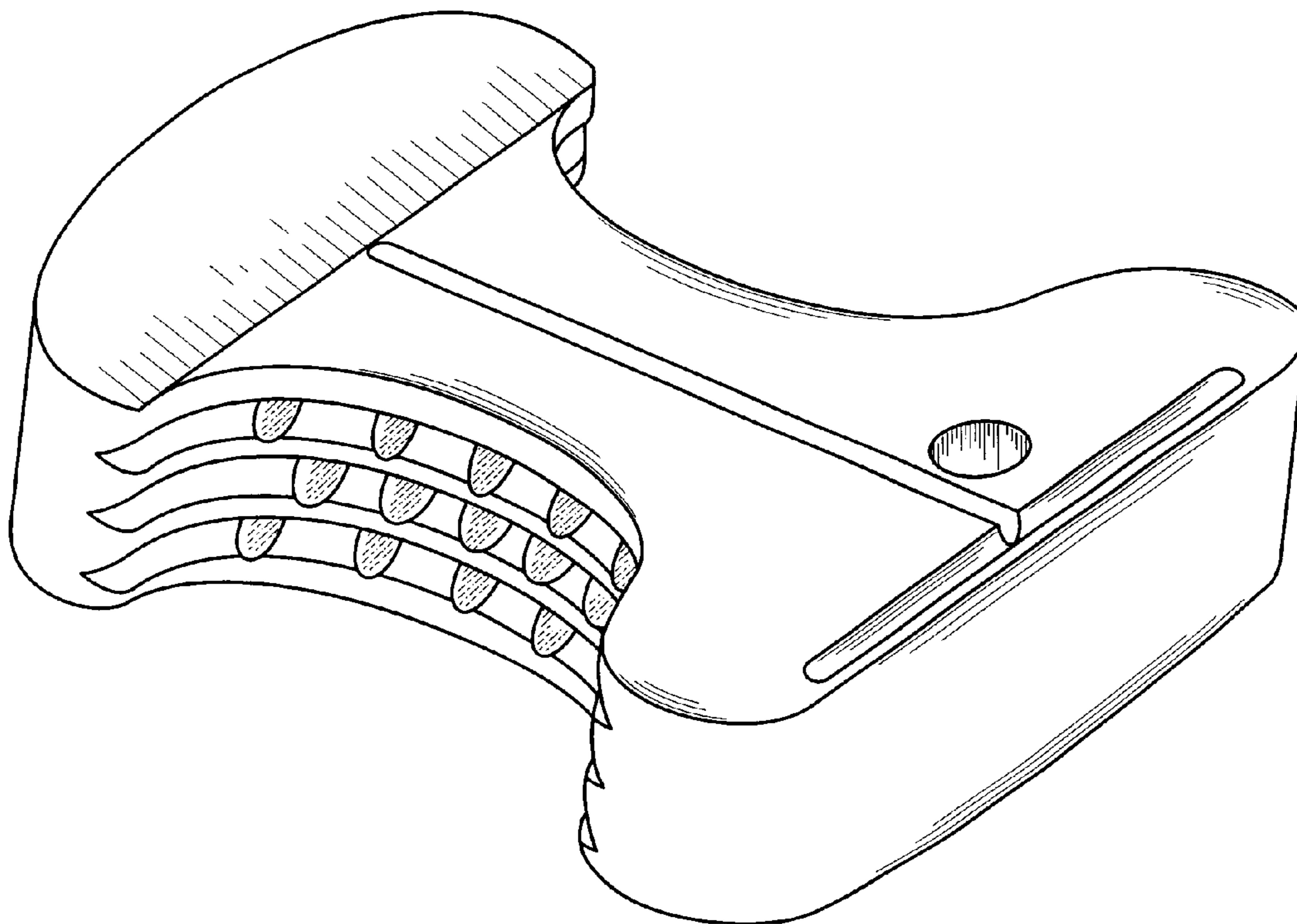
FIG. 5 is a heel side elevational view thereof;

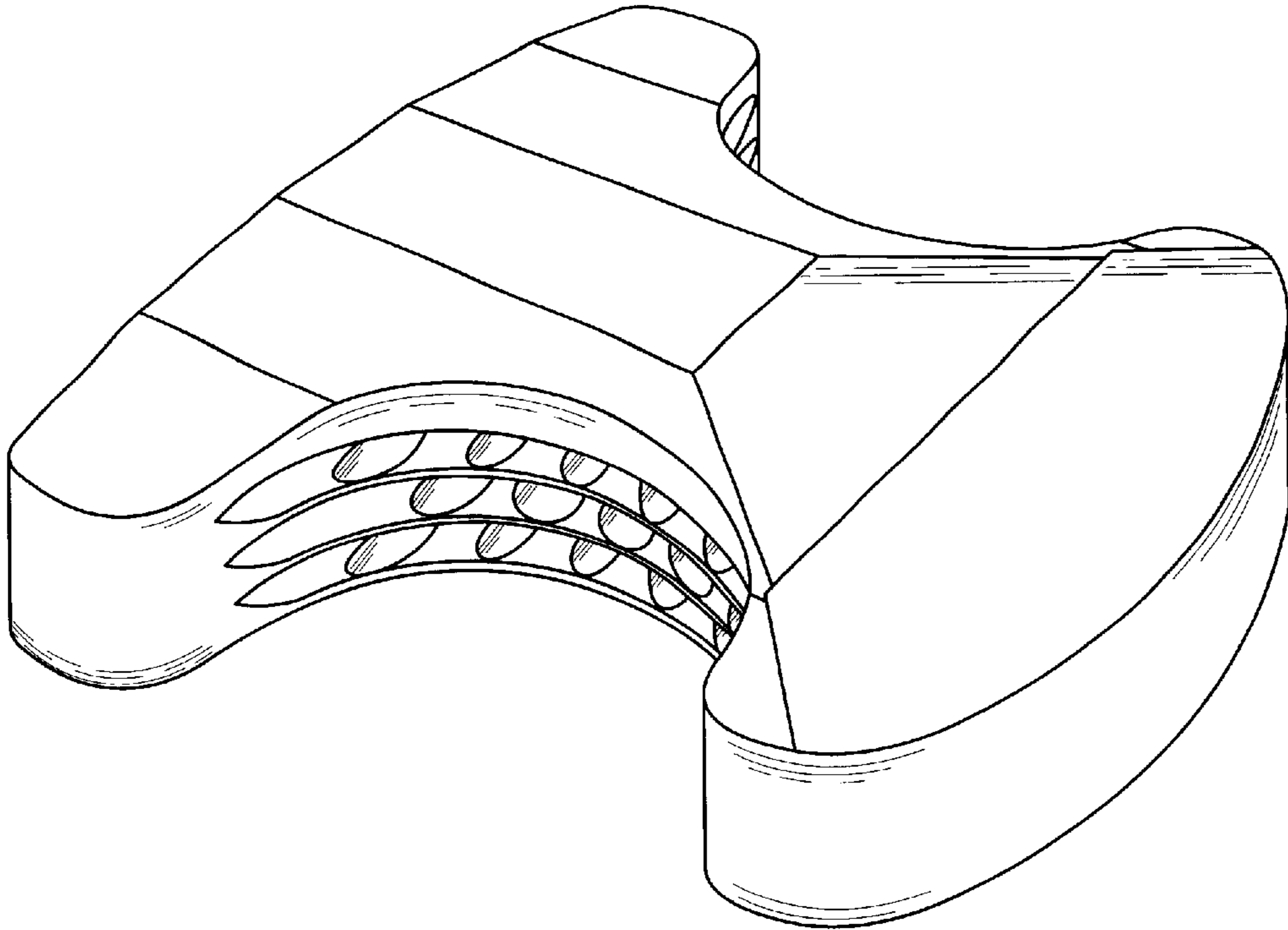
FIG. 6 is a rear elevational view thereof;

FIG. 7 is a front elevational view thereof; and,

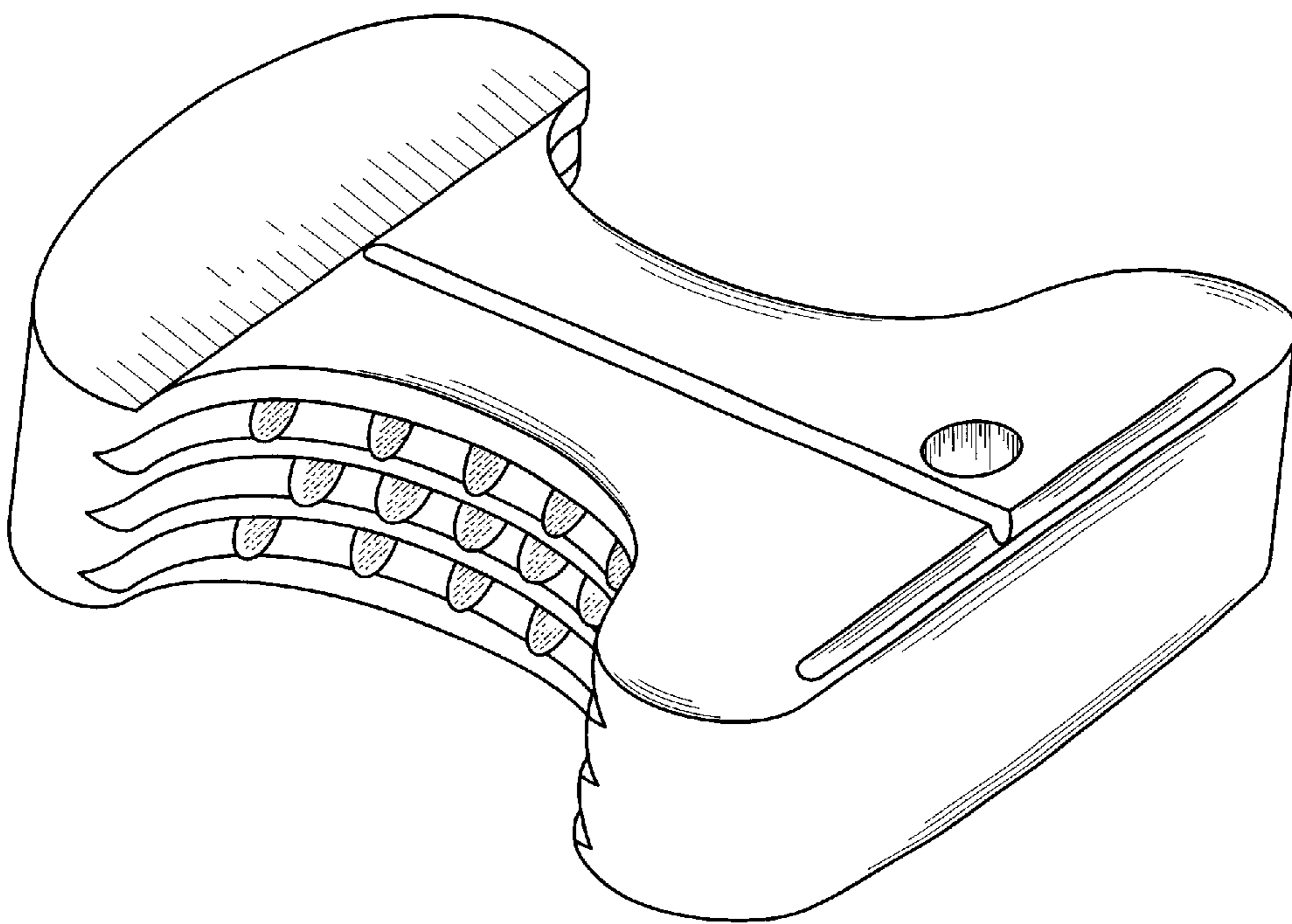
FIG. 8 is a perspective view of the front, top and a side thereof.

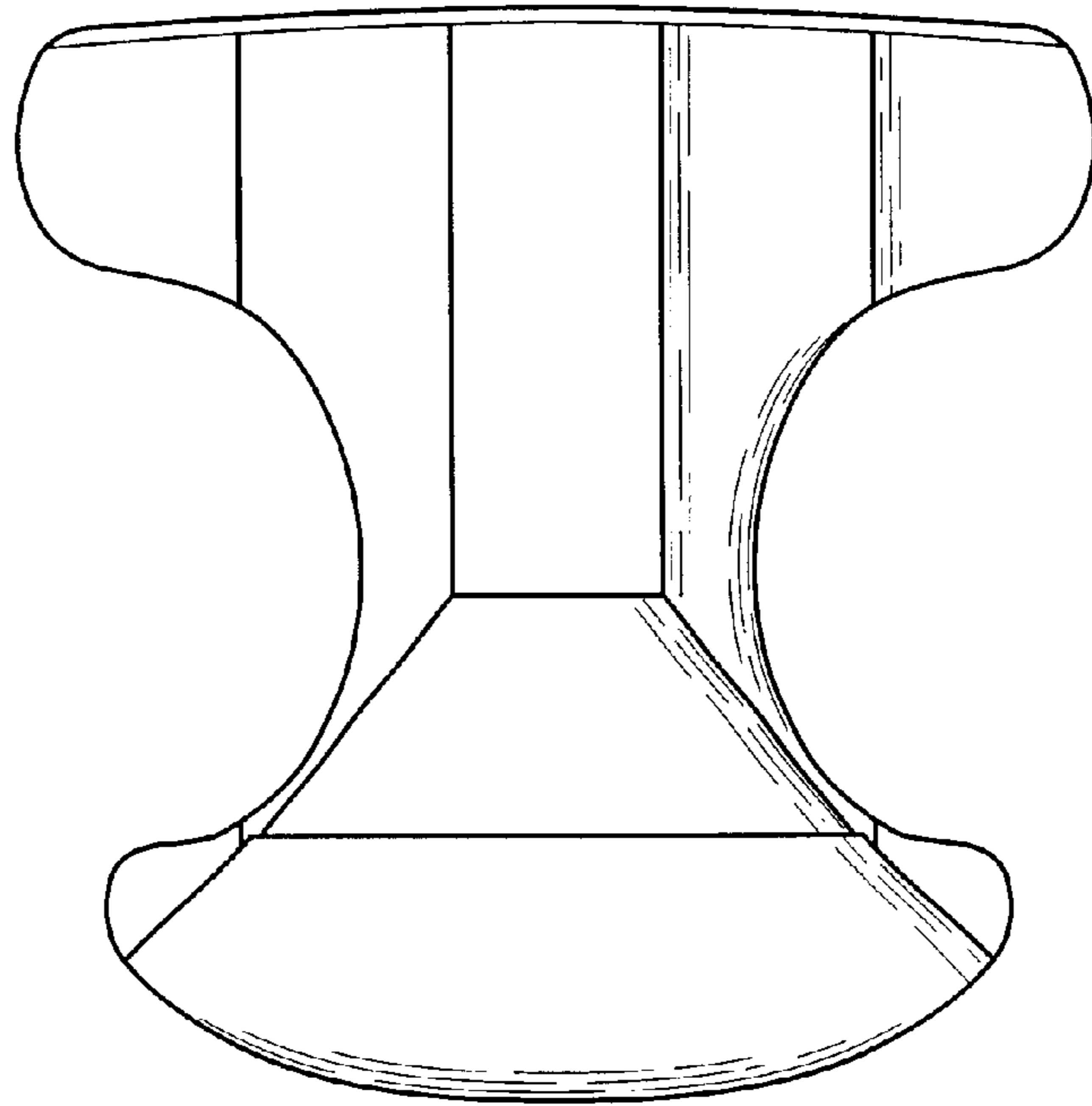




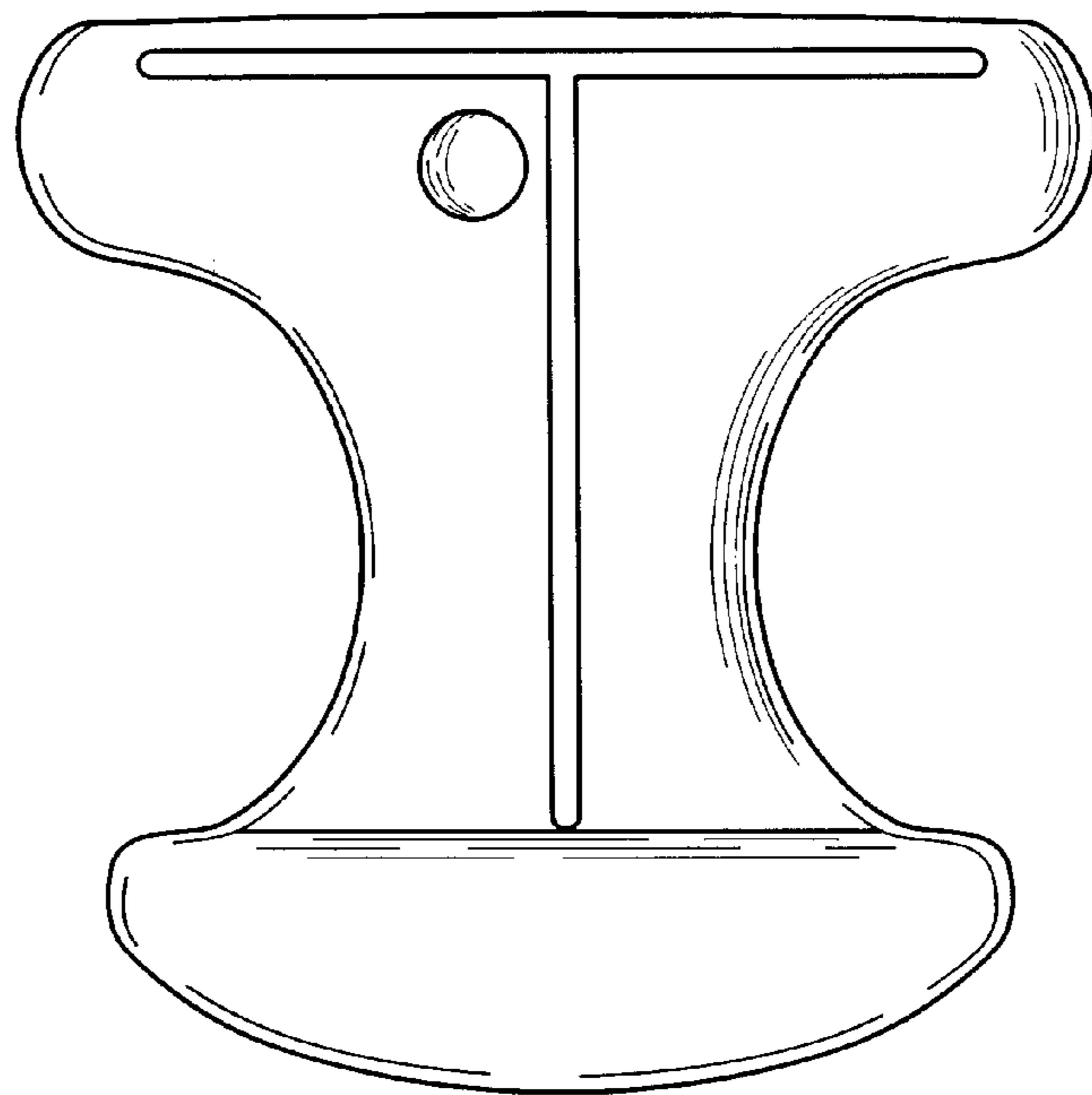

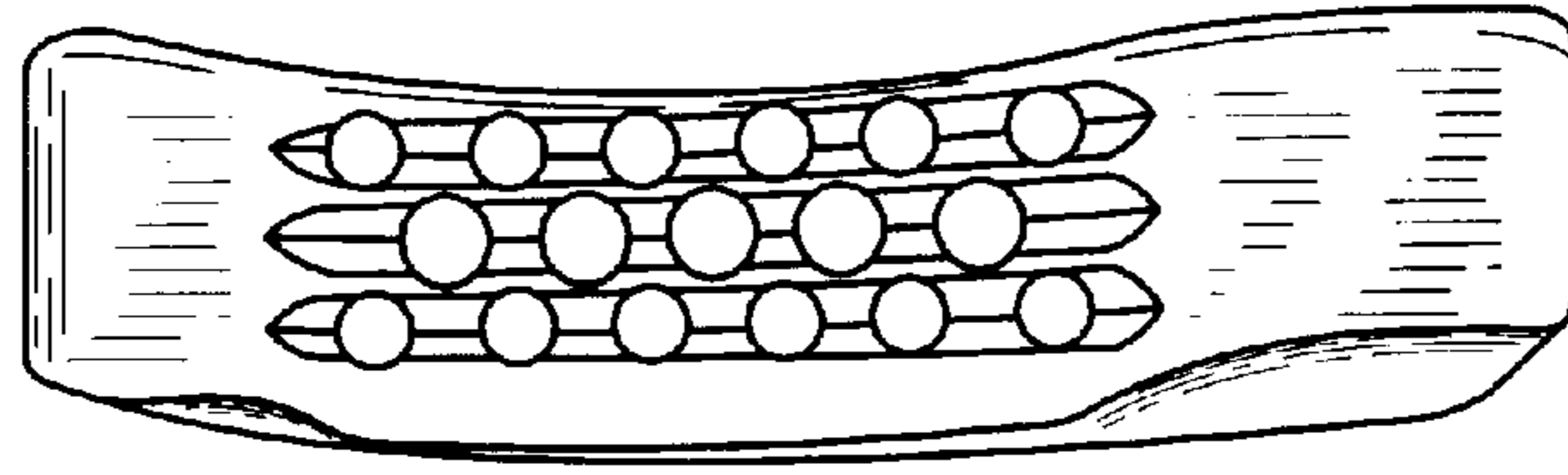

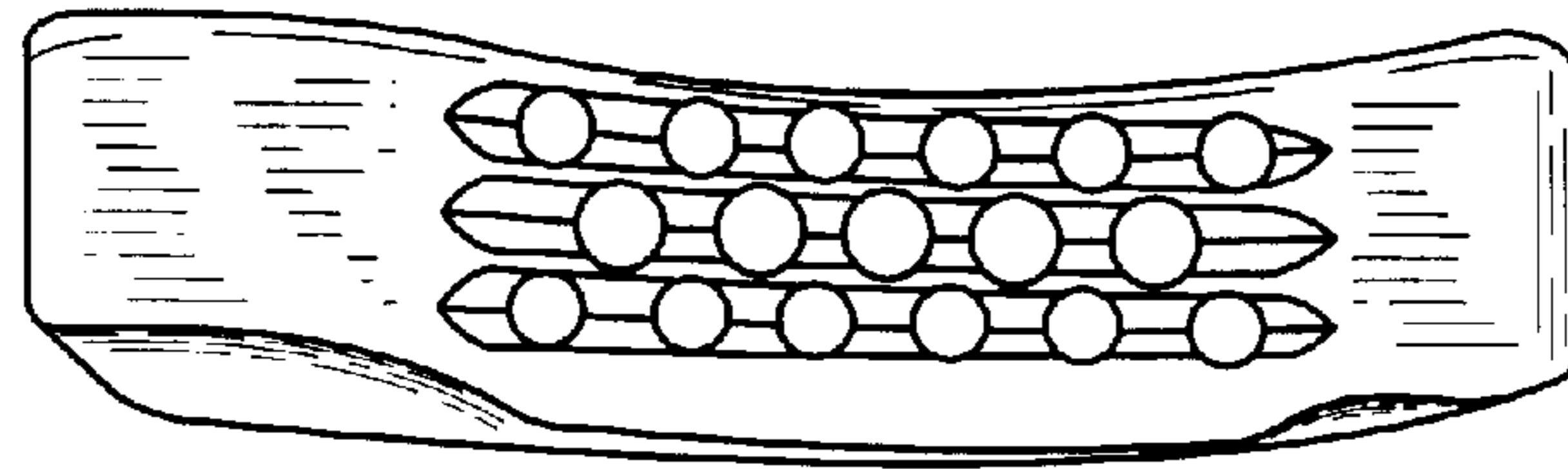

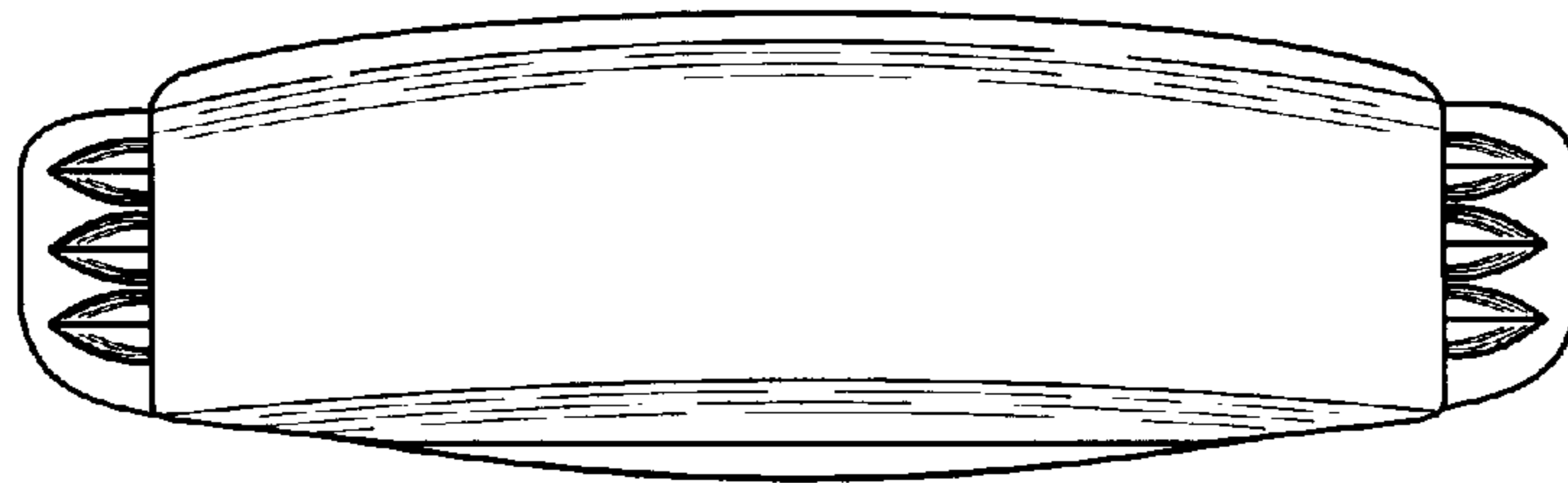

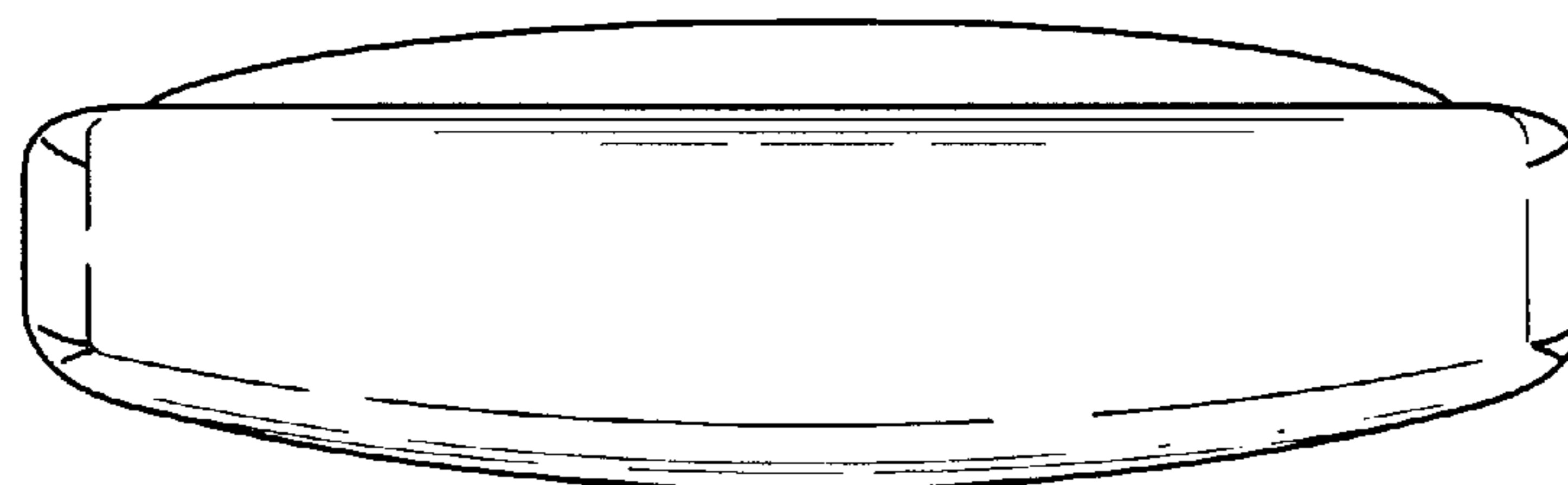
