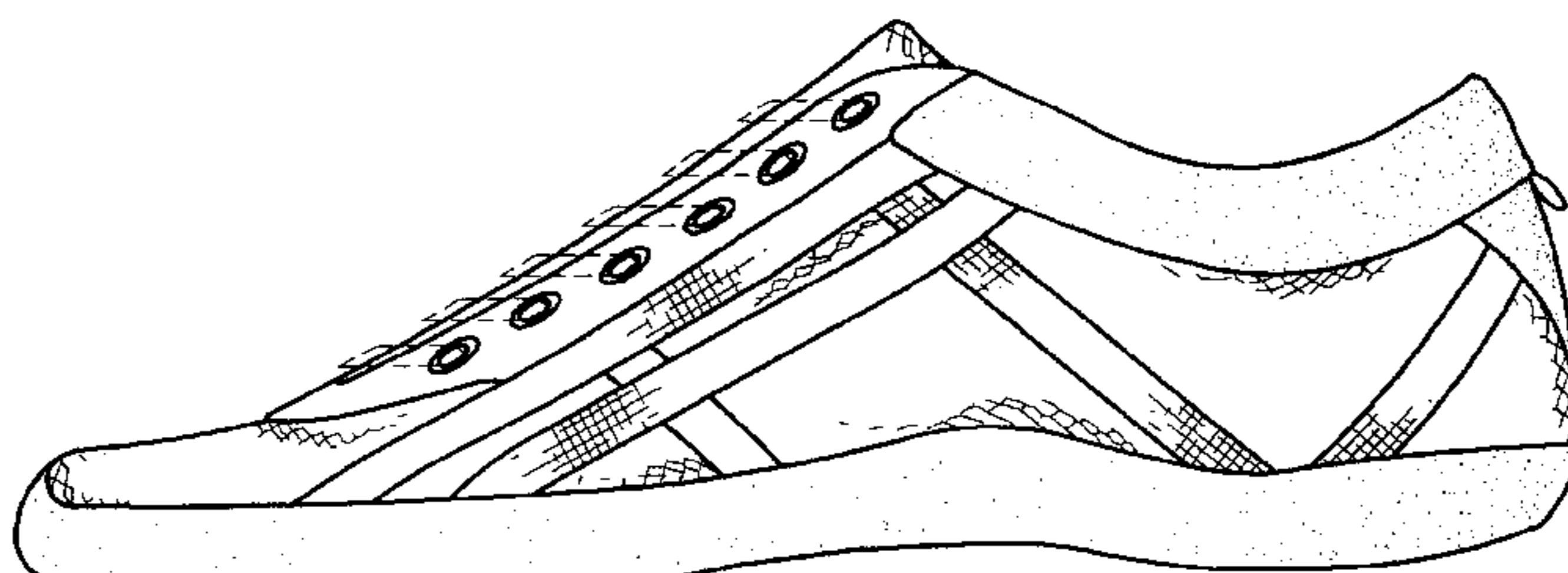
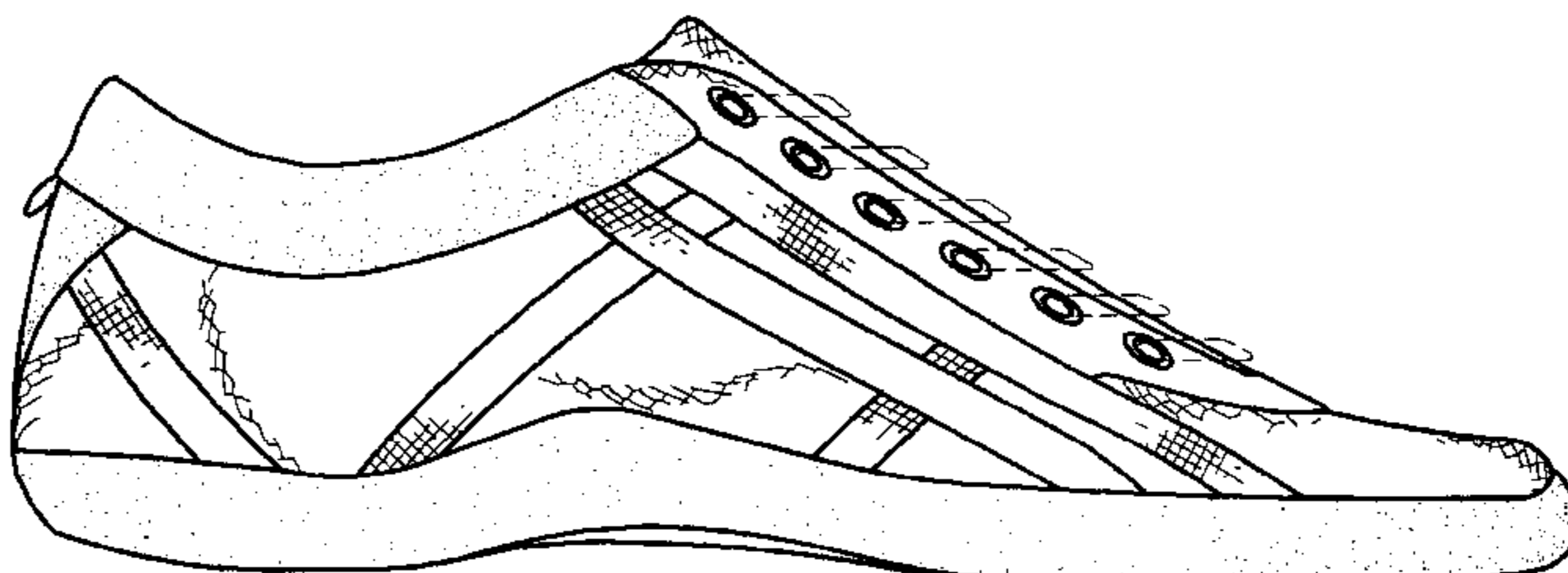
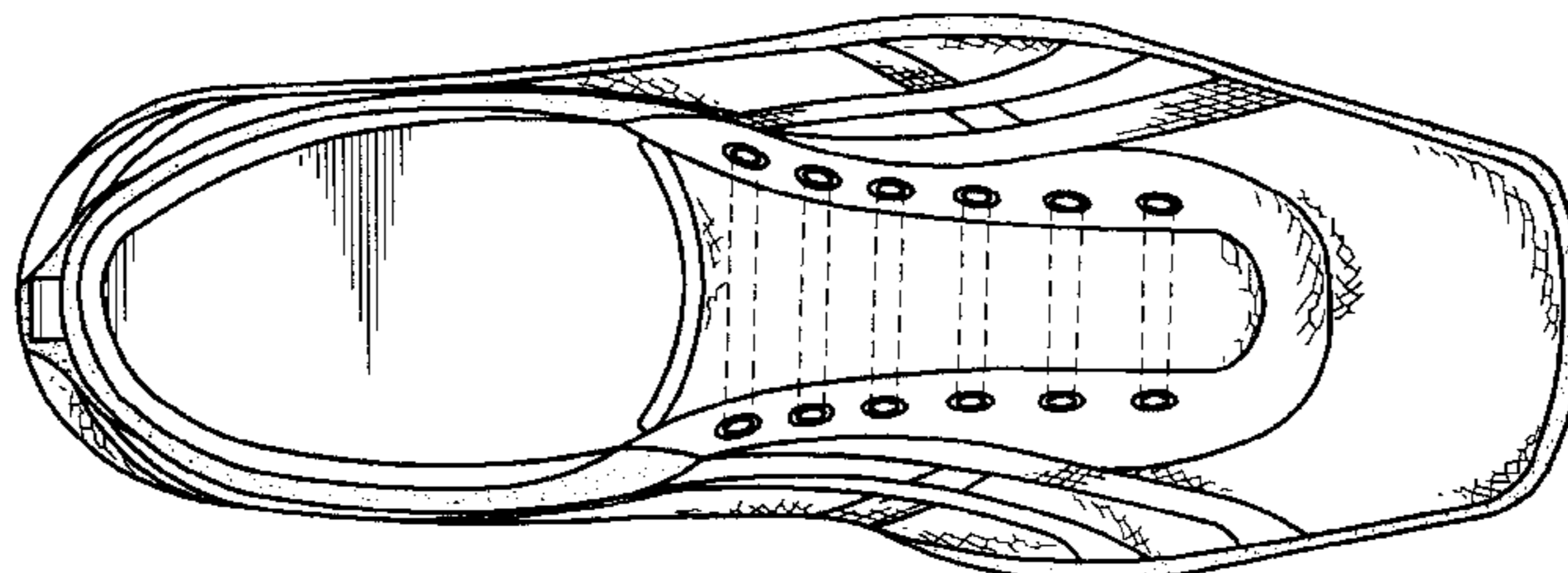

DESCRIPTION

FIG. 1 is a top plan view of a preferred embodiment of a footwear upper showing our new design; FIG. 2 is a right side elevational view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is a front elevational view thereof; and, FIG. 5 is a rear elevational view thereof. 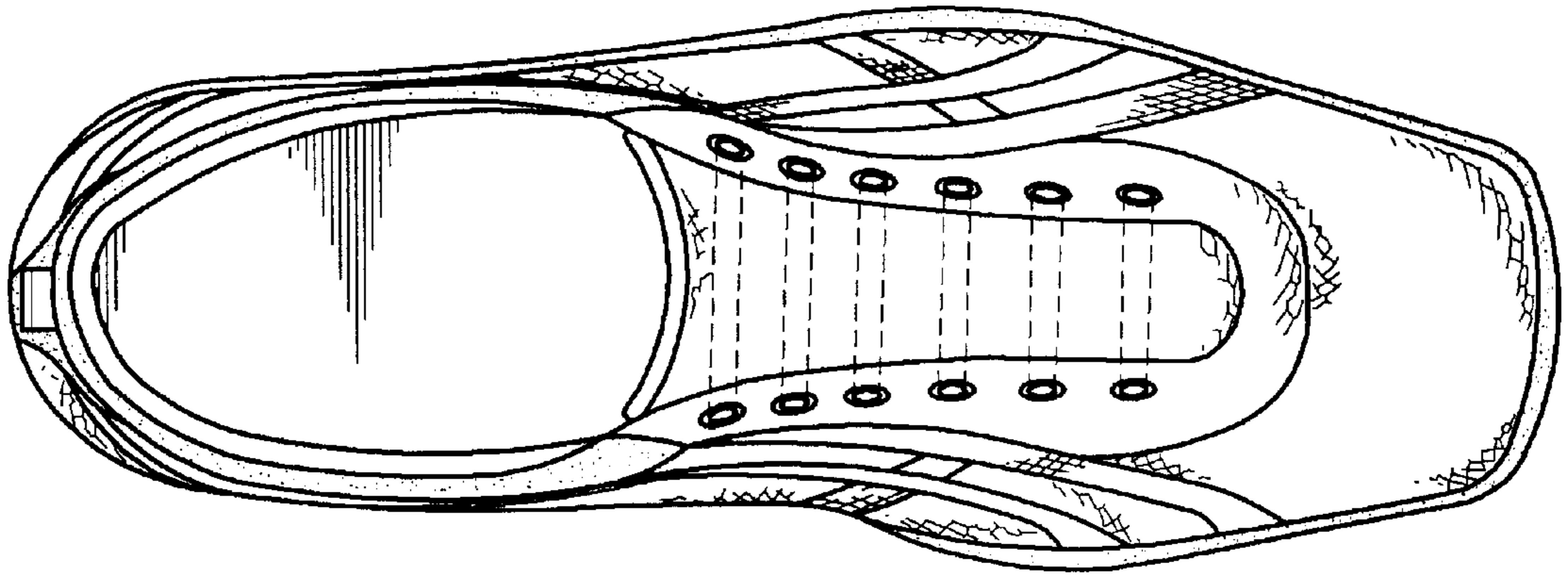

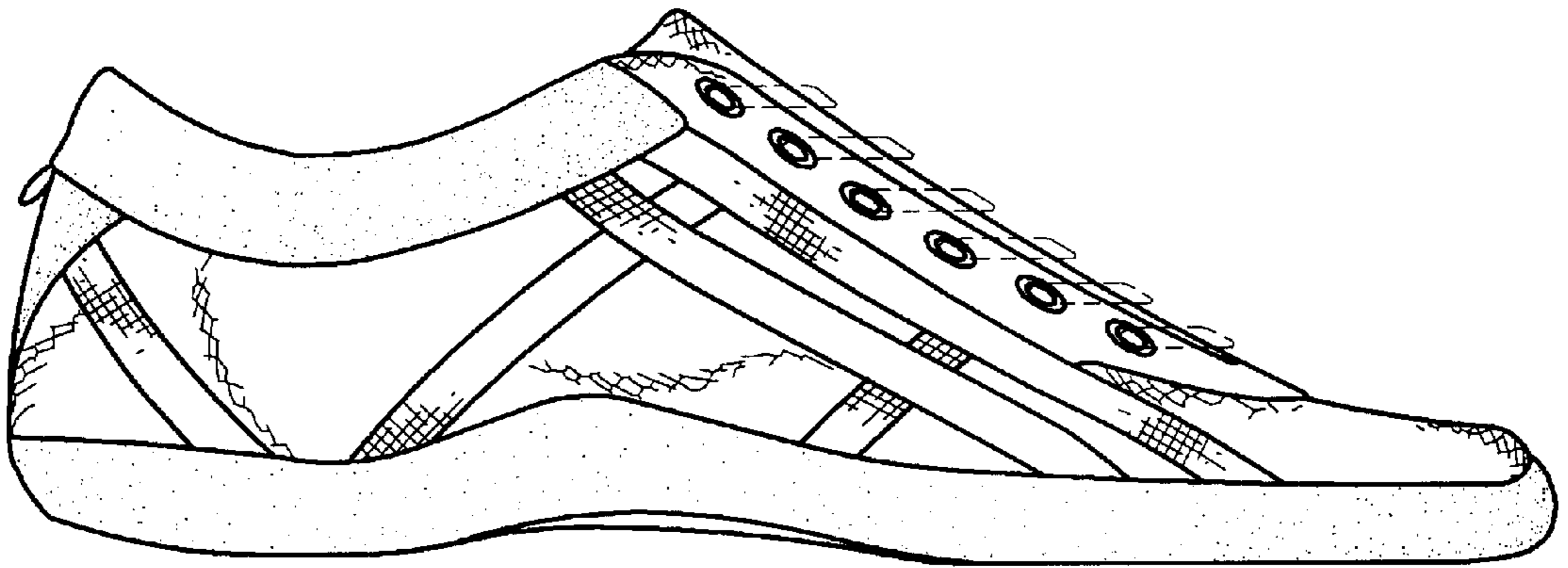

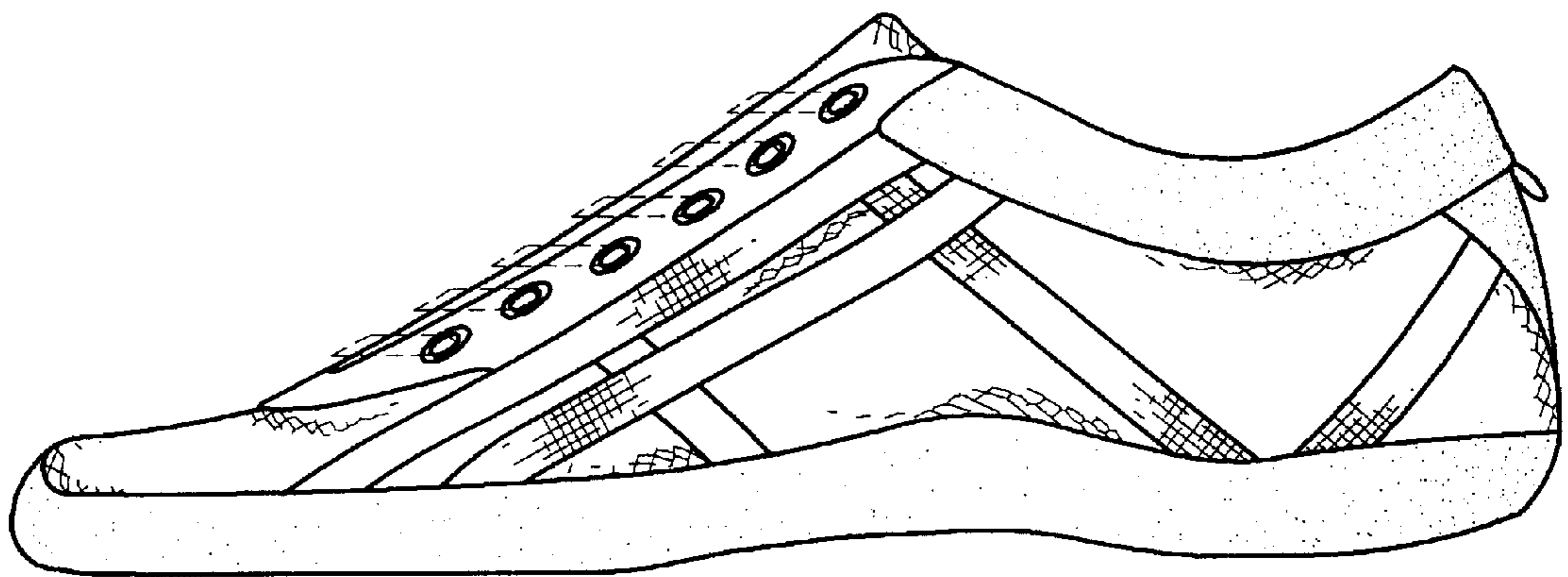

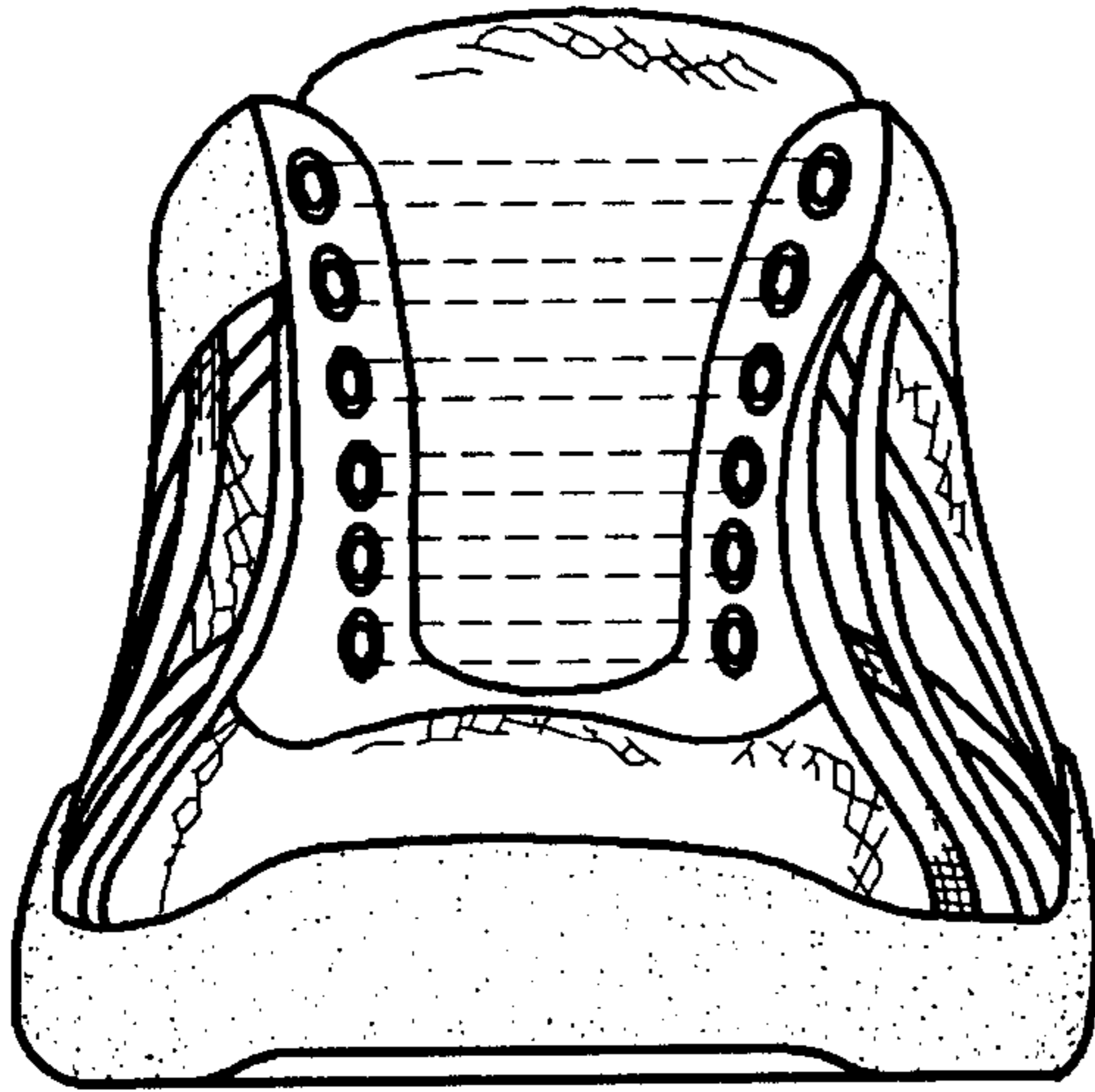

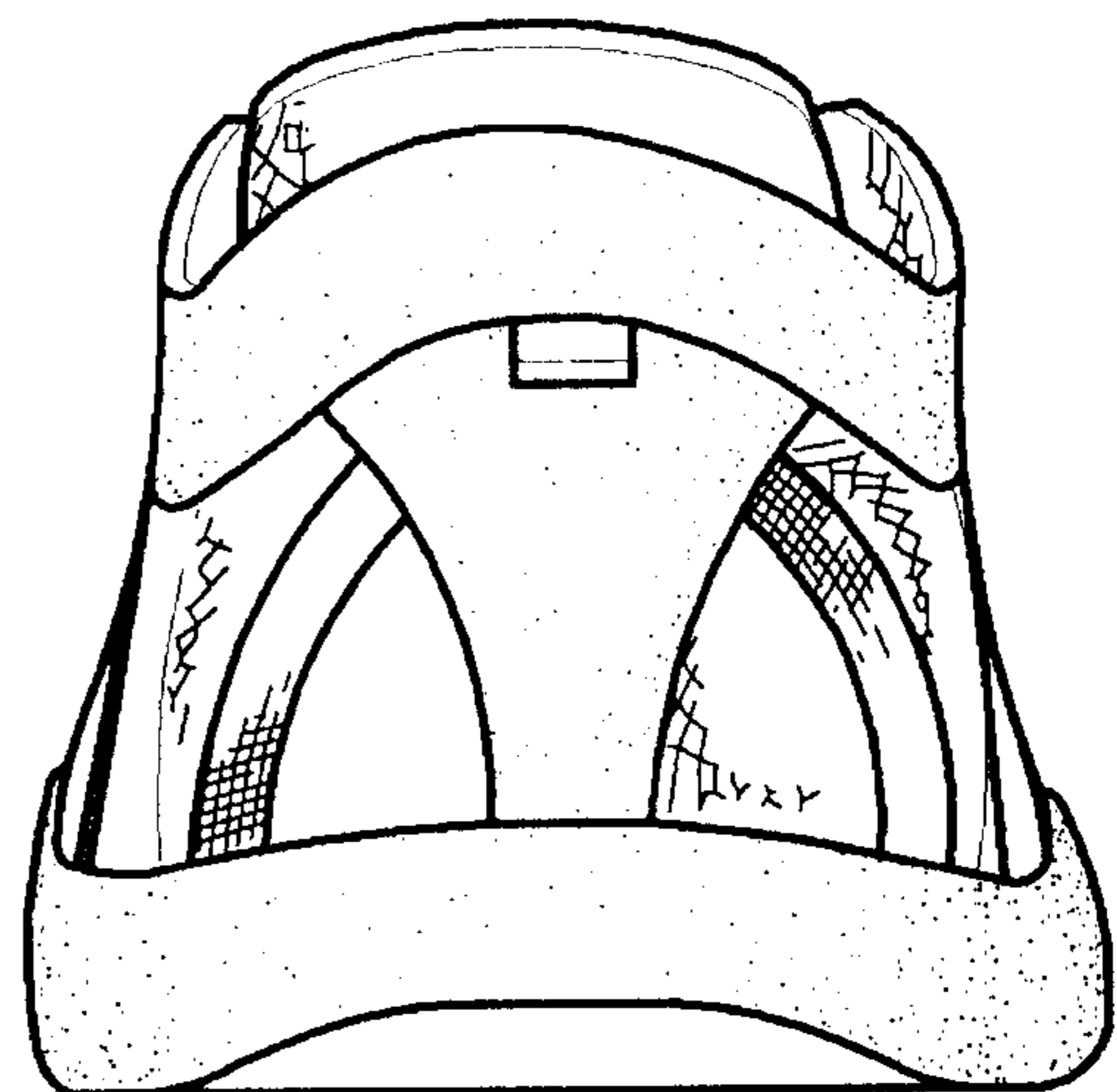
