DESCRIPTION

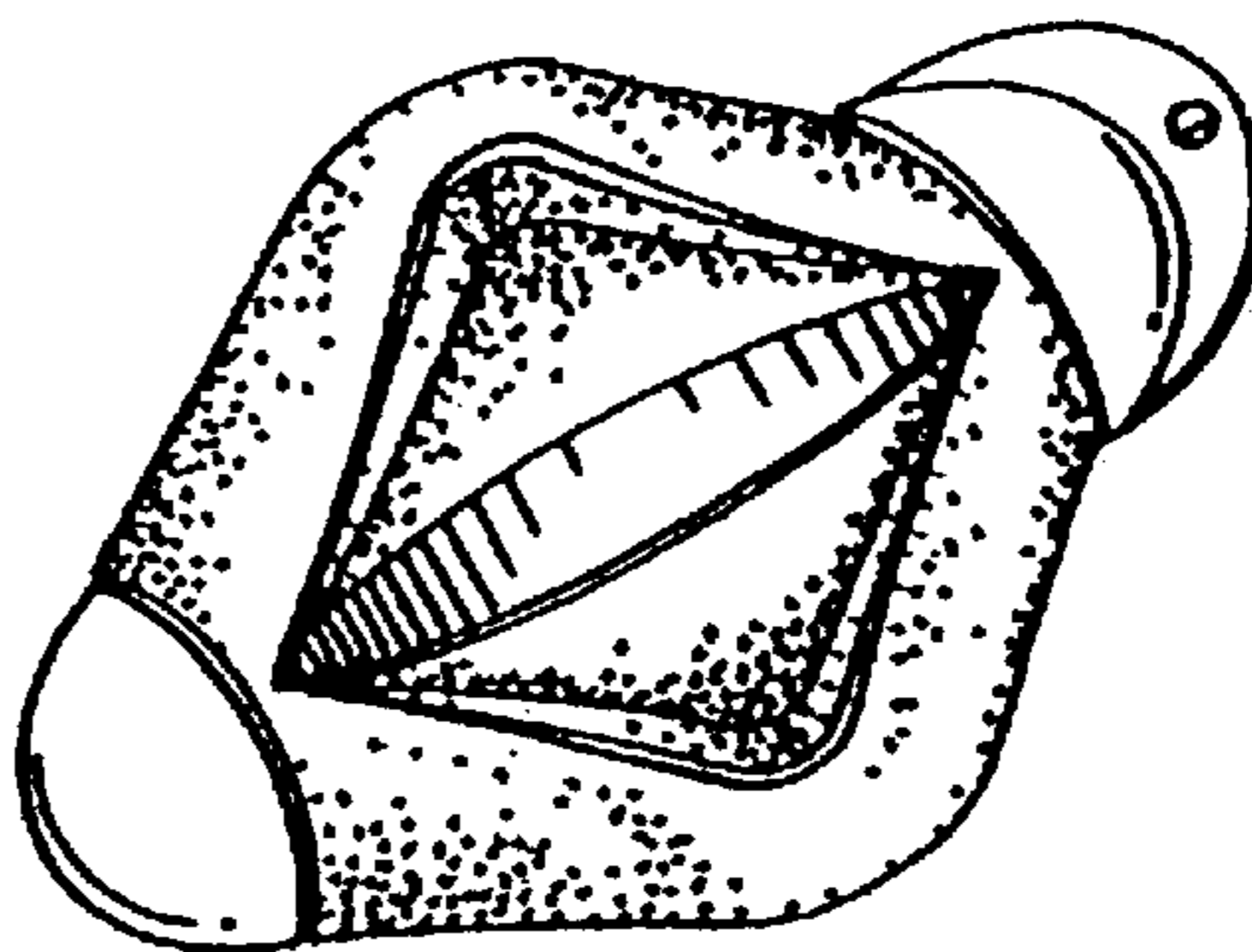
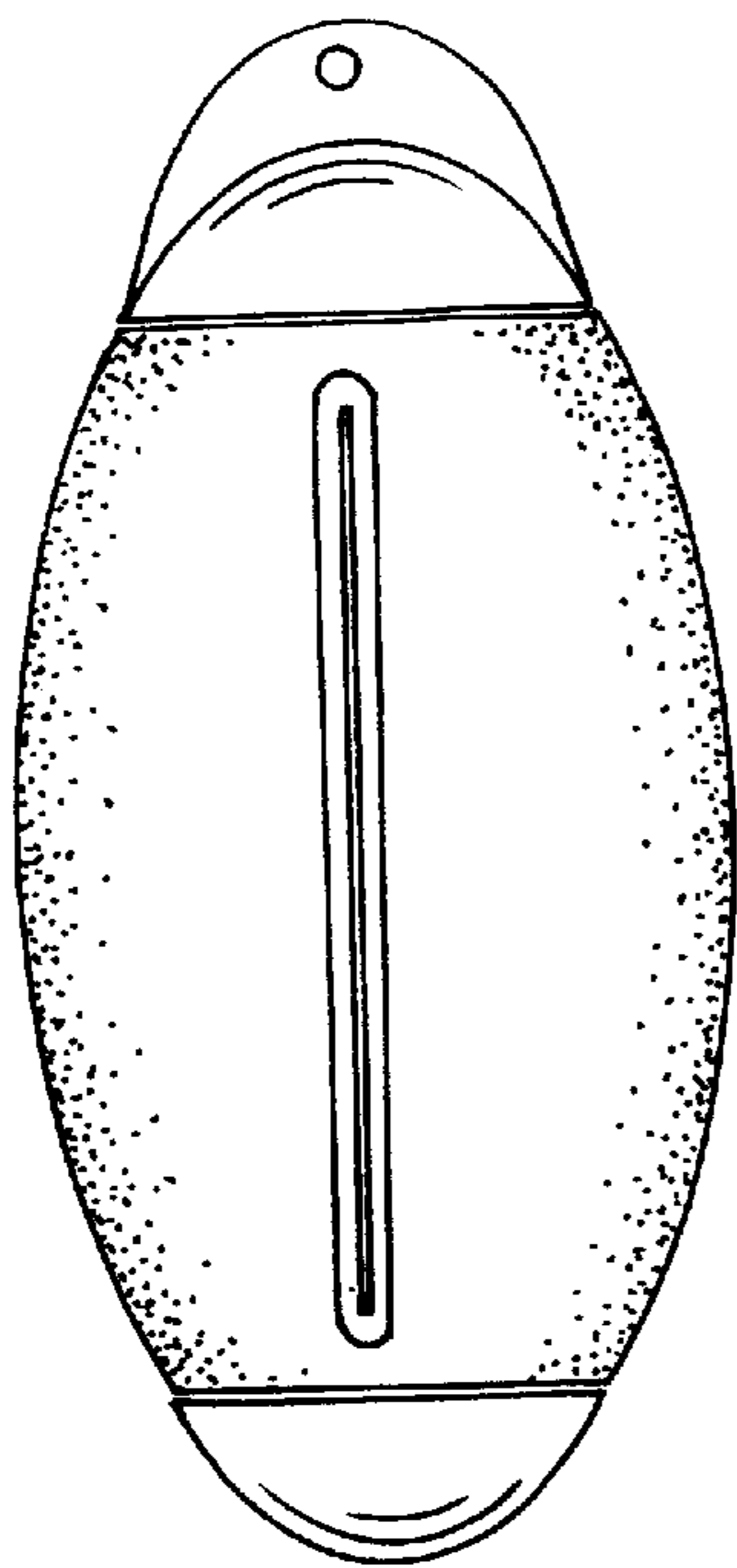
FIG. 1 is a perspective view of a case showing my new design;

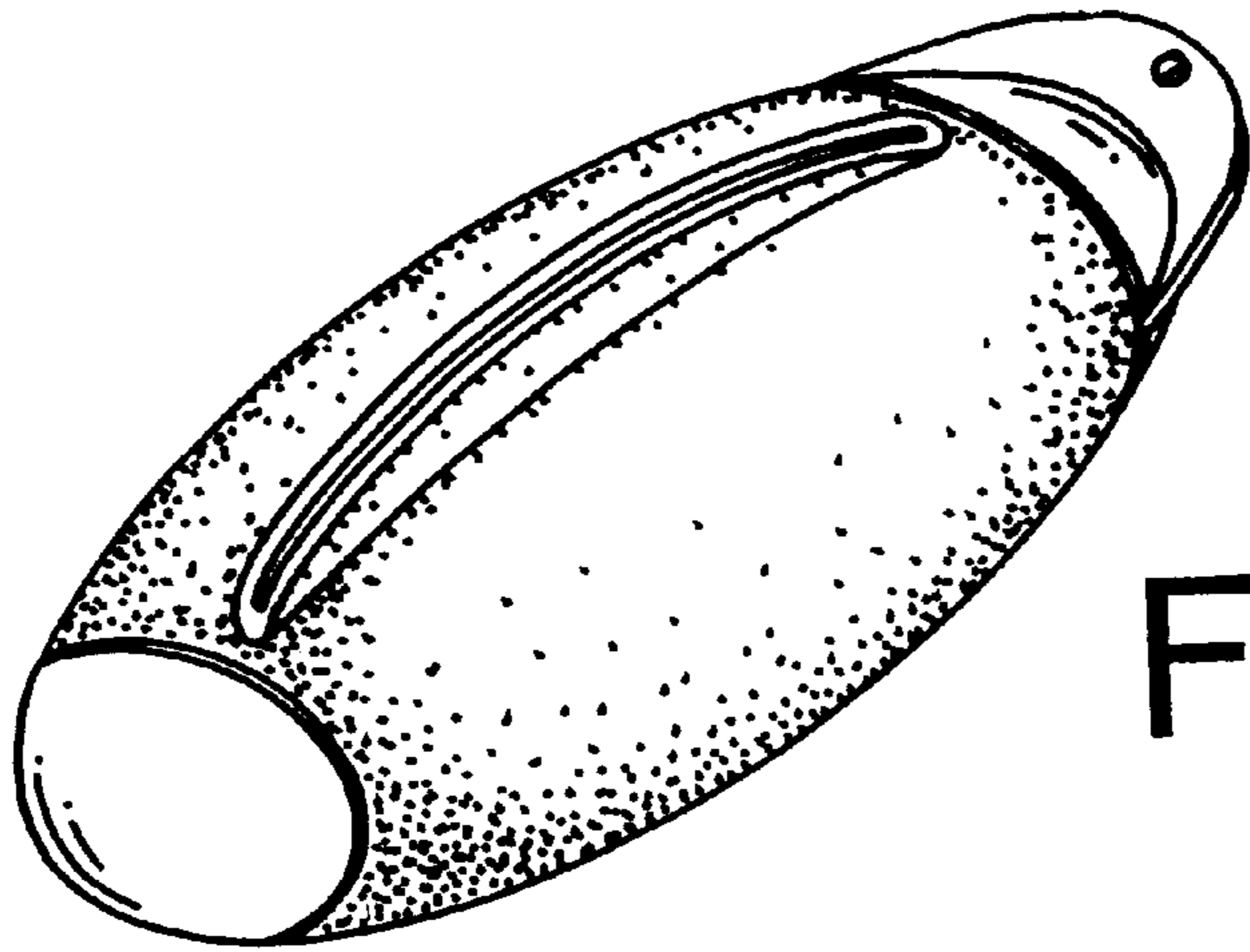

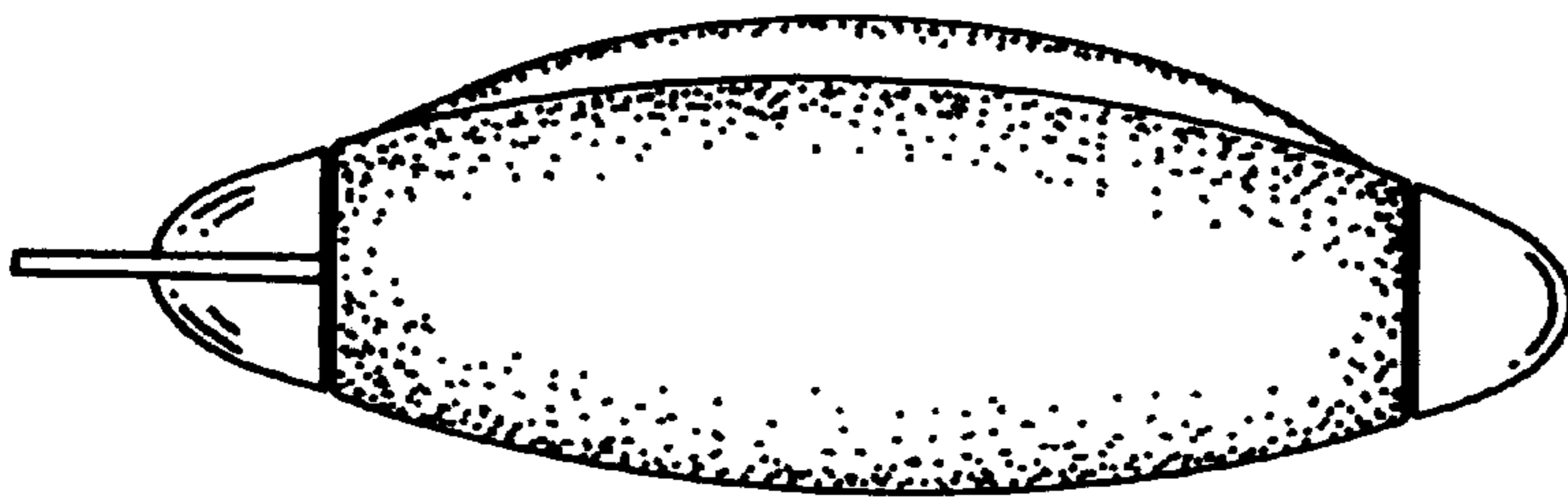

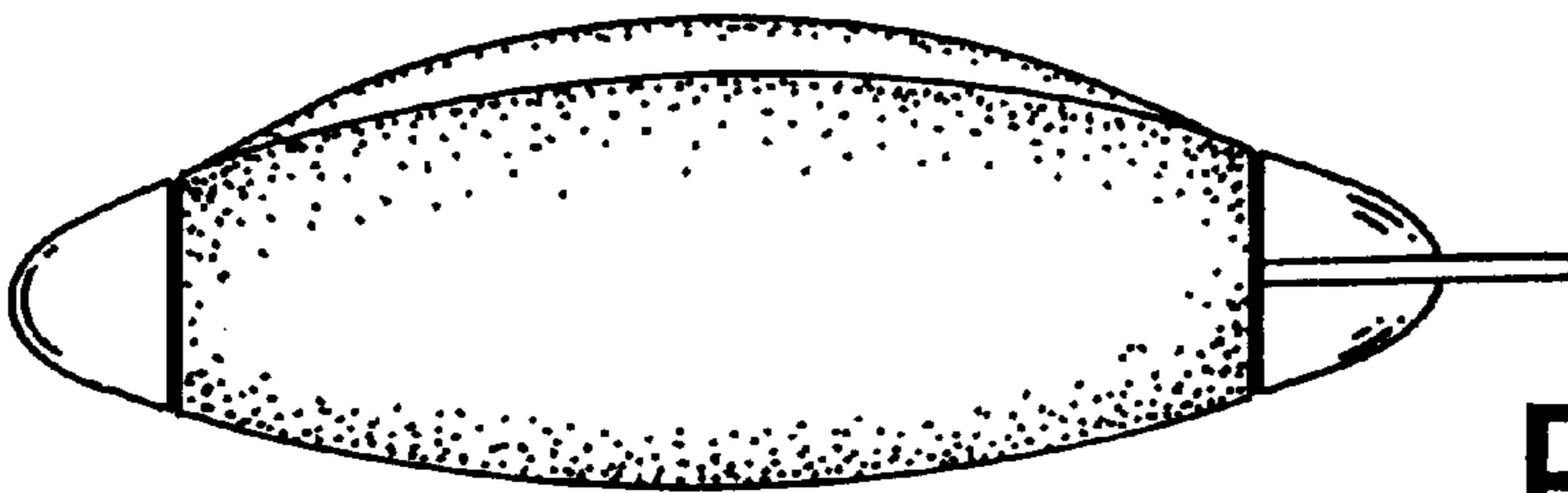

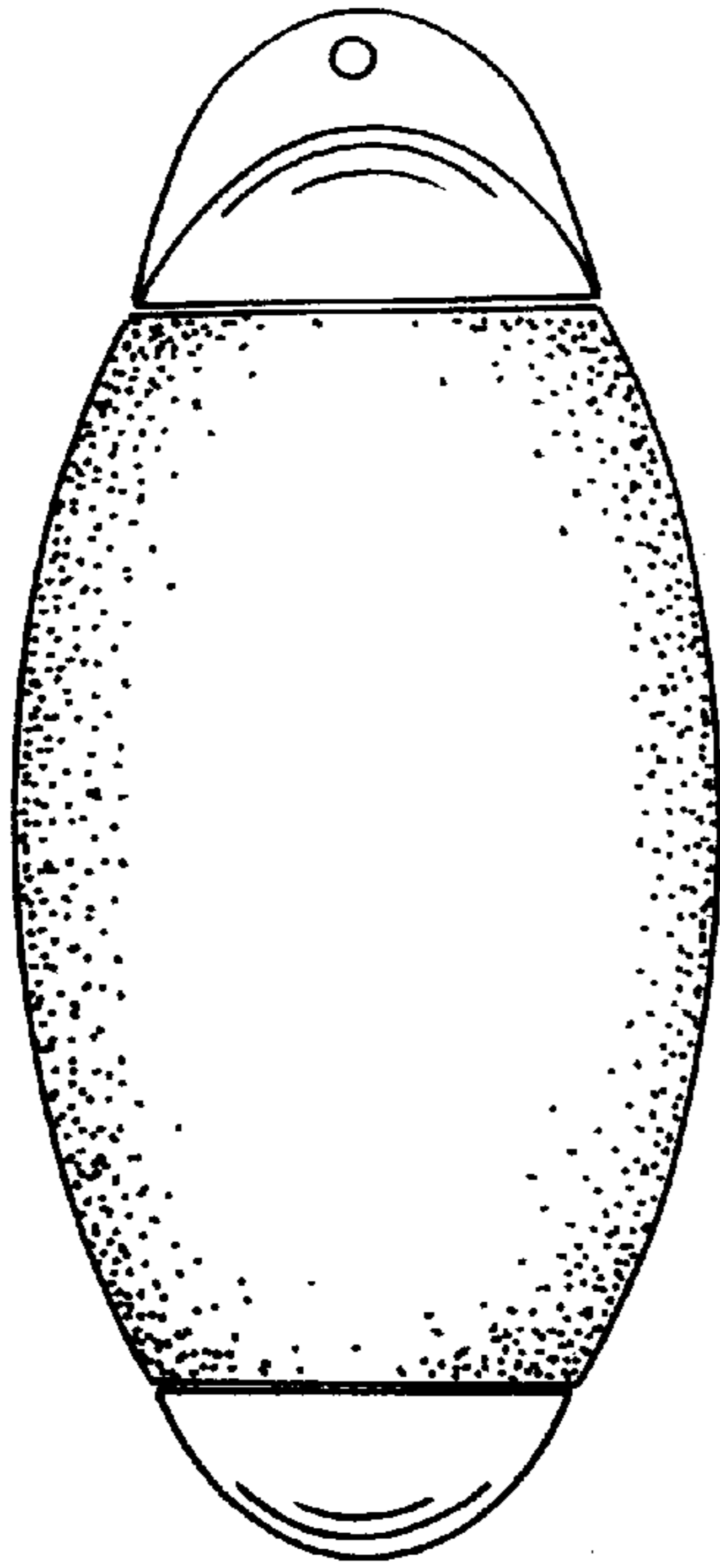

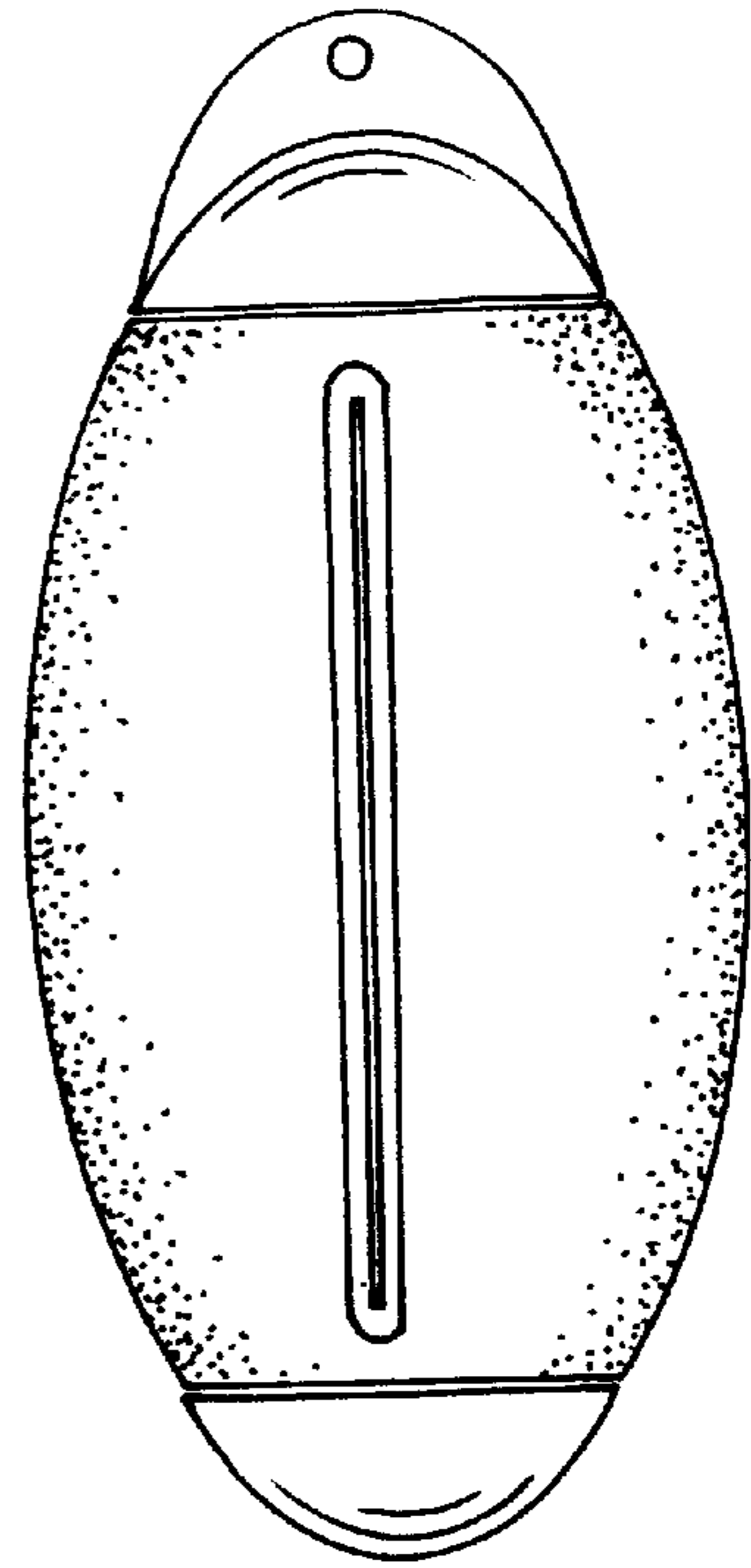

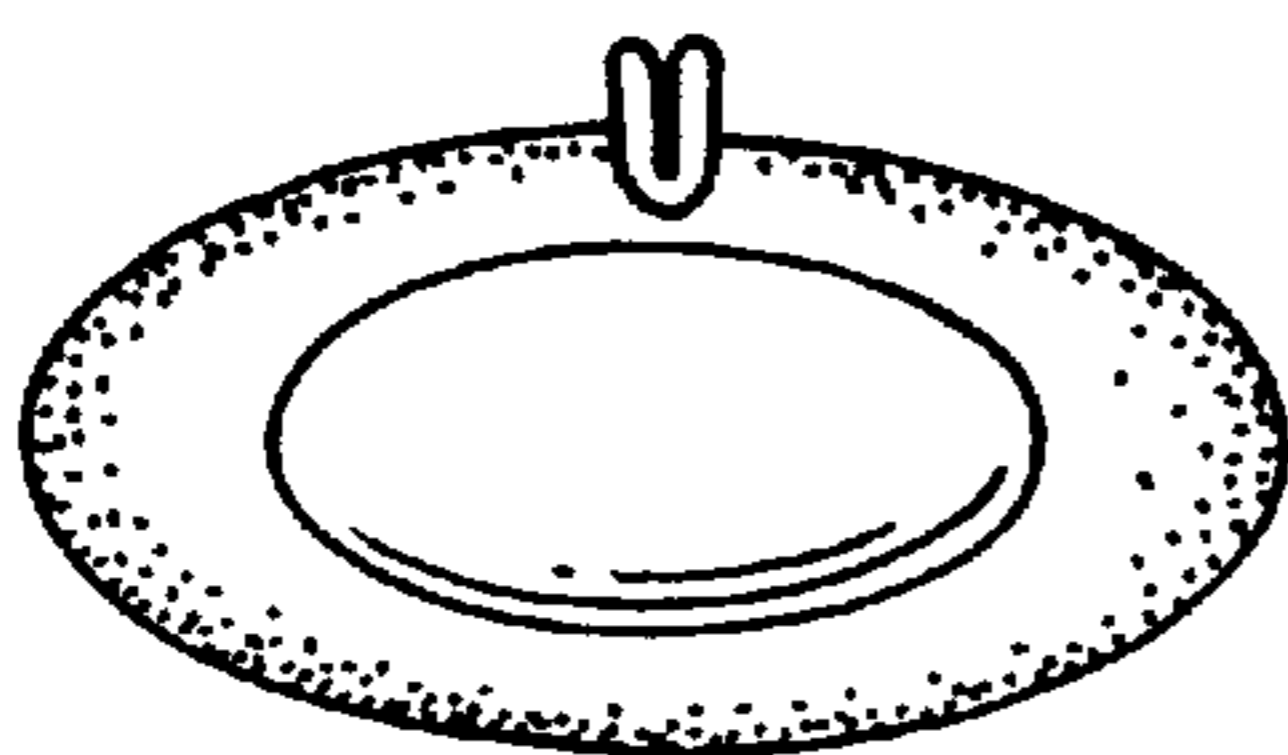

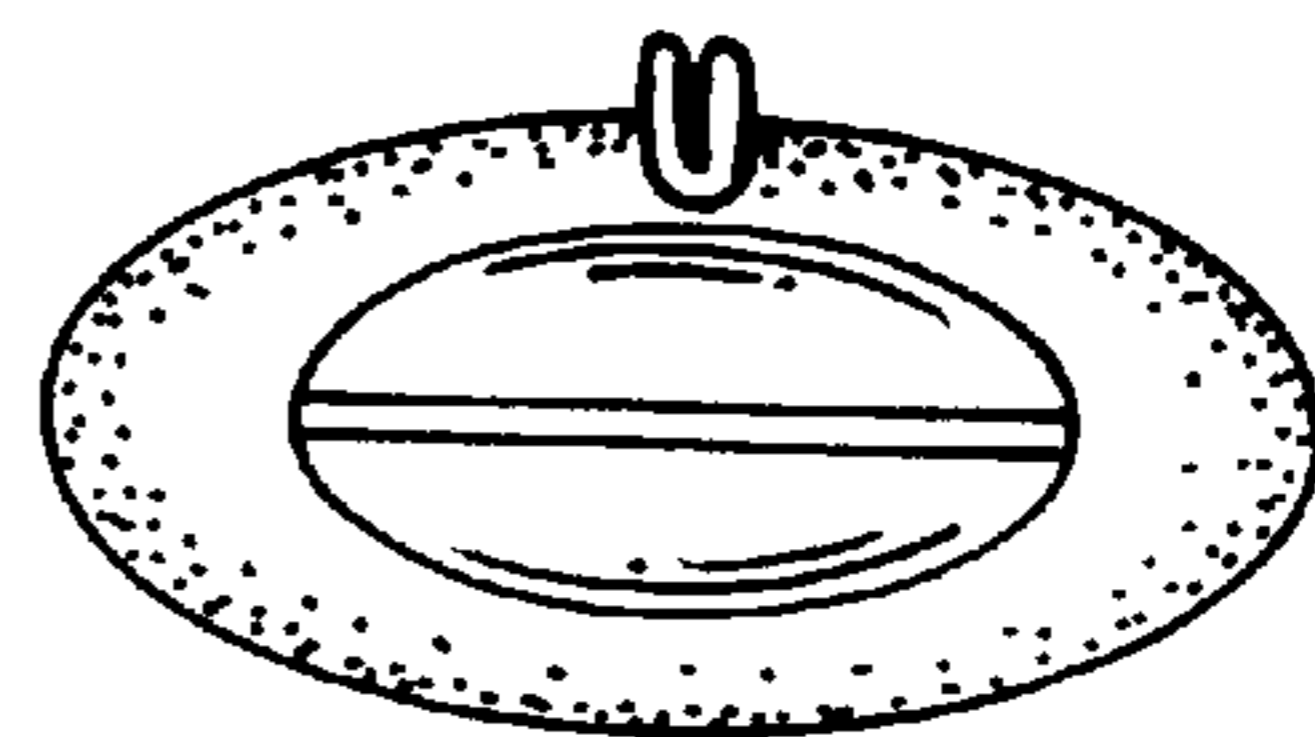

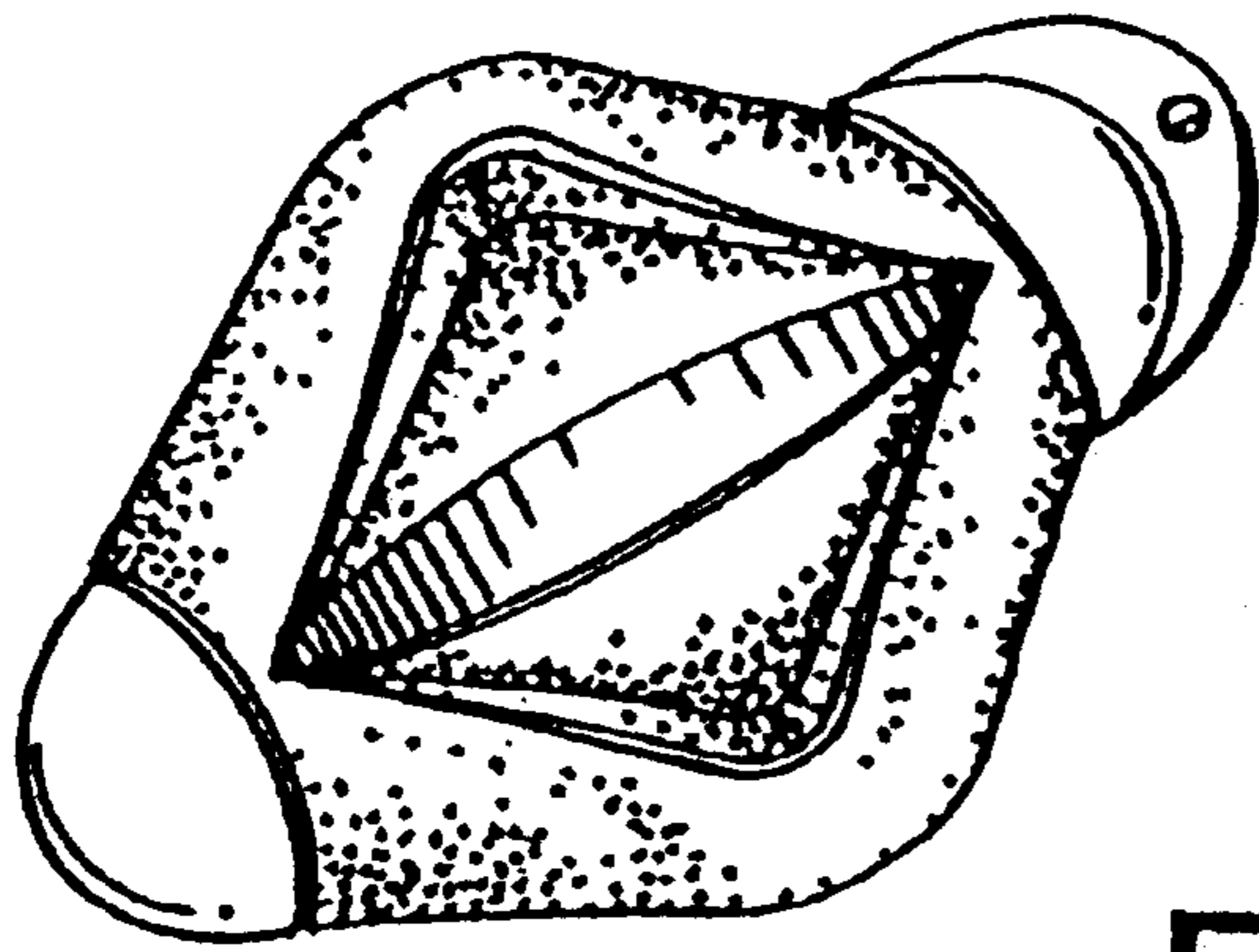
