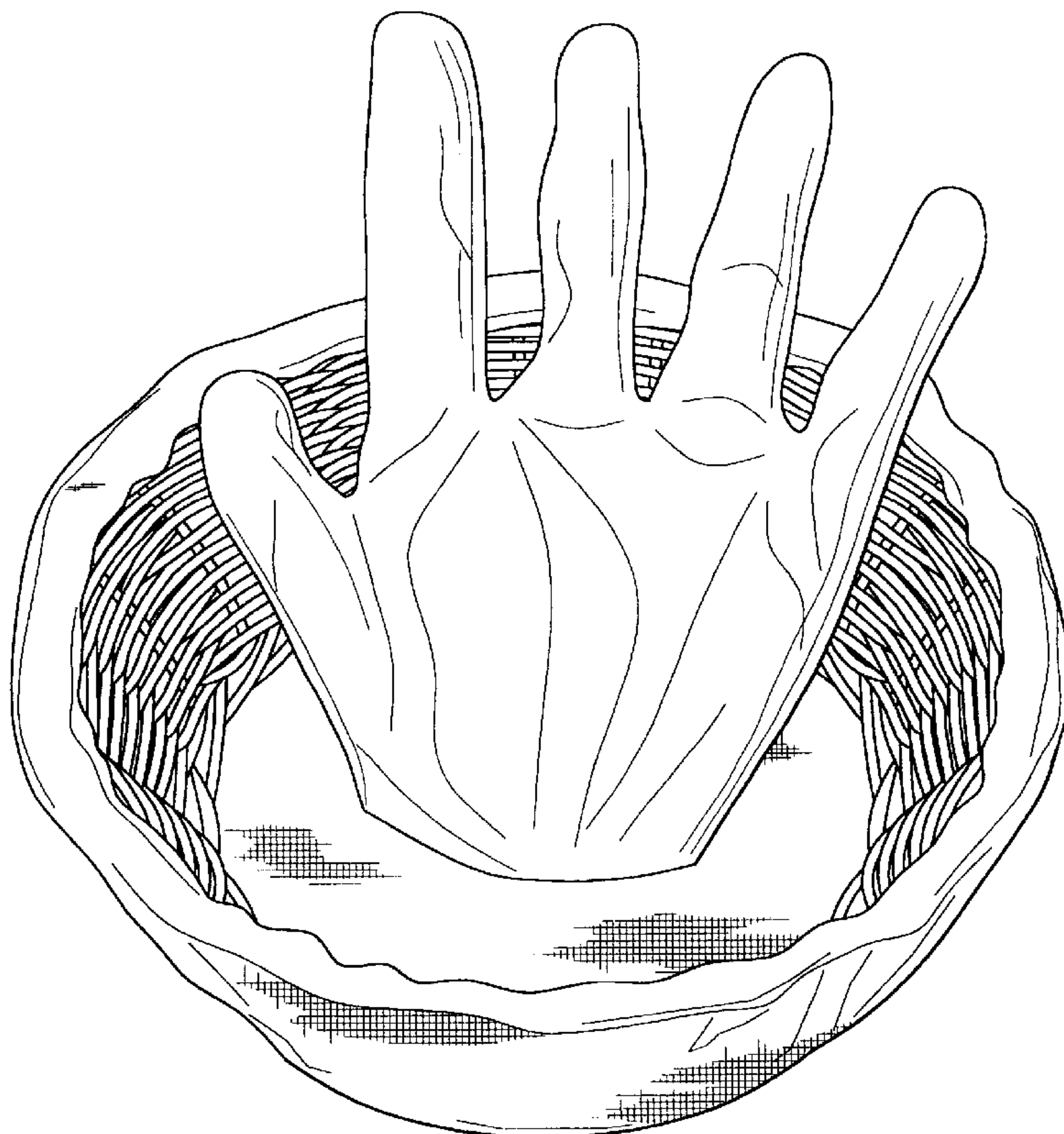
(57) **CLAIM**

The ornamental design for a novelty basket with puppet hand, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a novelty basket with puppet hand according to a first embodiment of my invention; FIG. 2 is a top view thereof; FIG. 3 is a front view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a rear view thereof; FIG. 7 is a bottom view thereof; FIG. 8 is a perspective view of a novelty basket with puppet hand according to a second embodiment of my invention; and, FIG. 9 is a perspective view of a novelty basket with puppet hand according to a third embodiment of my invention.

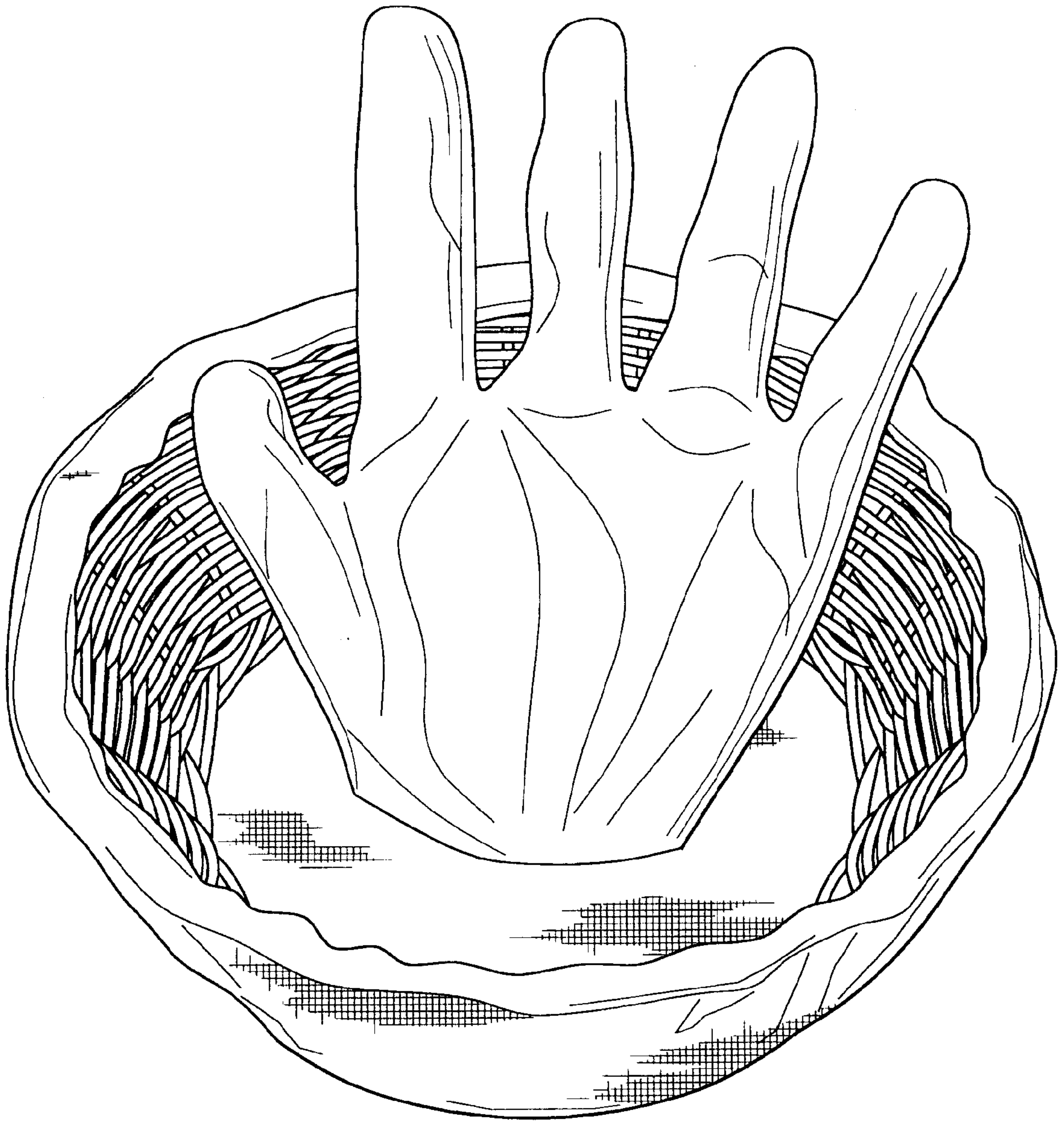

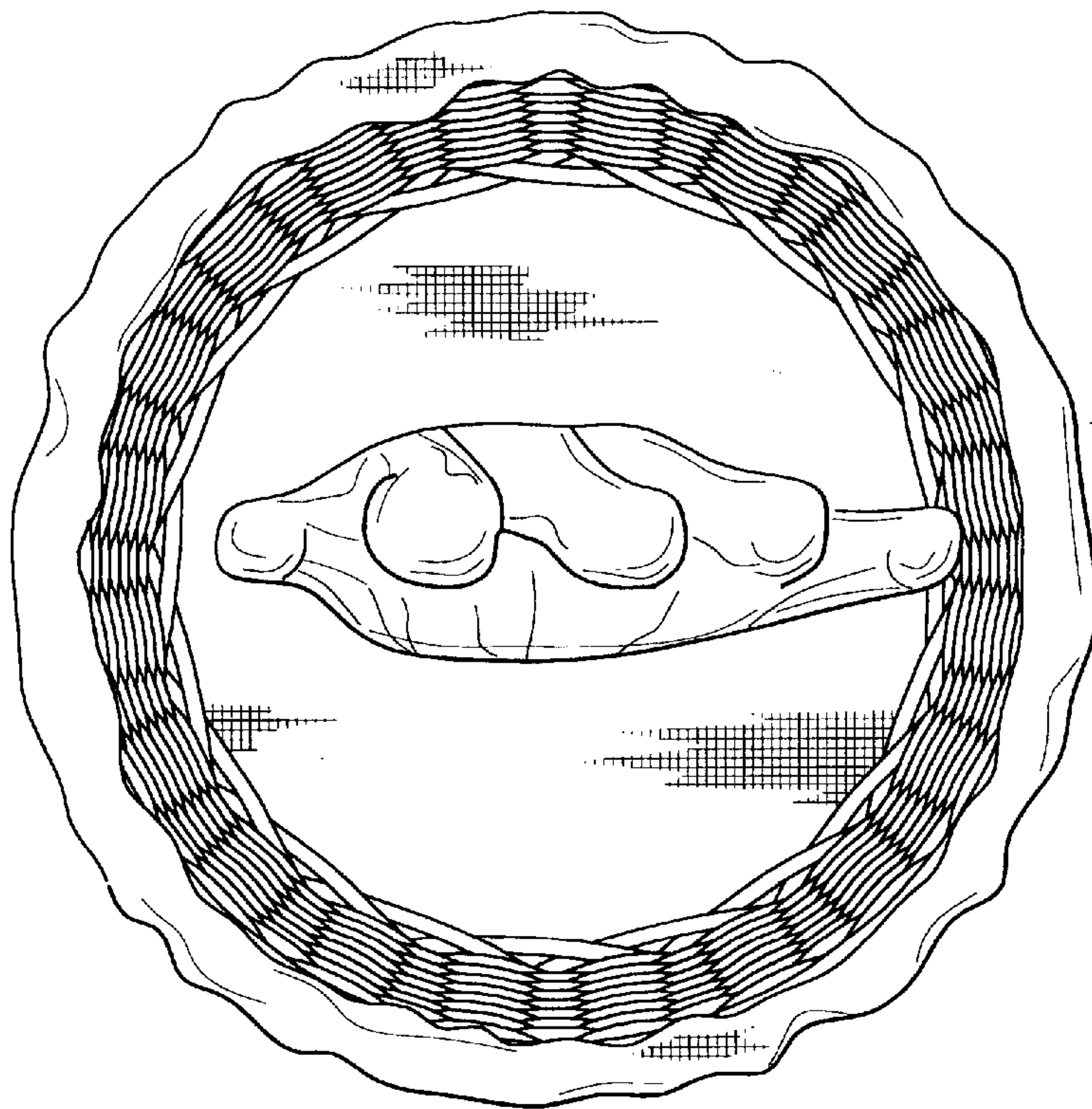

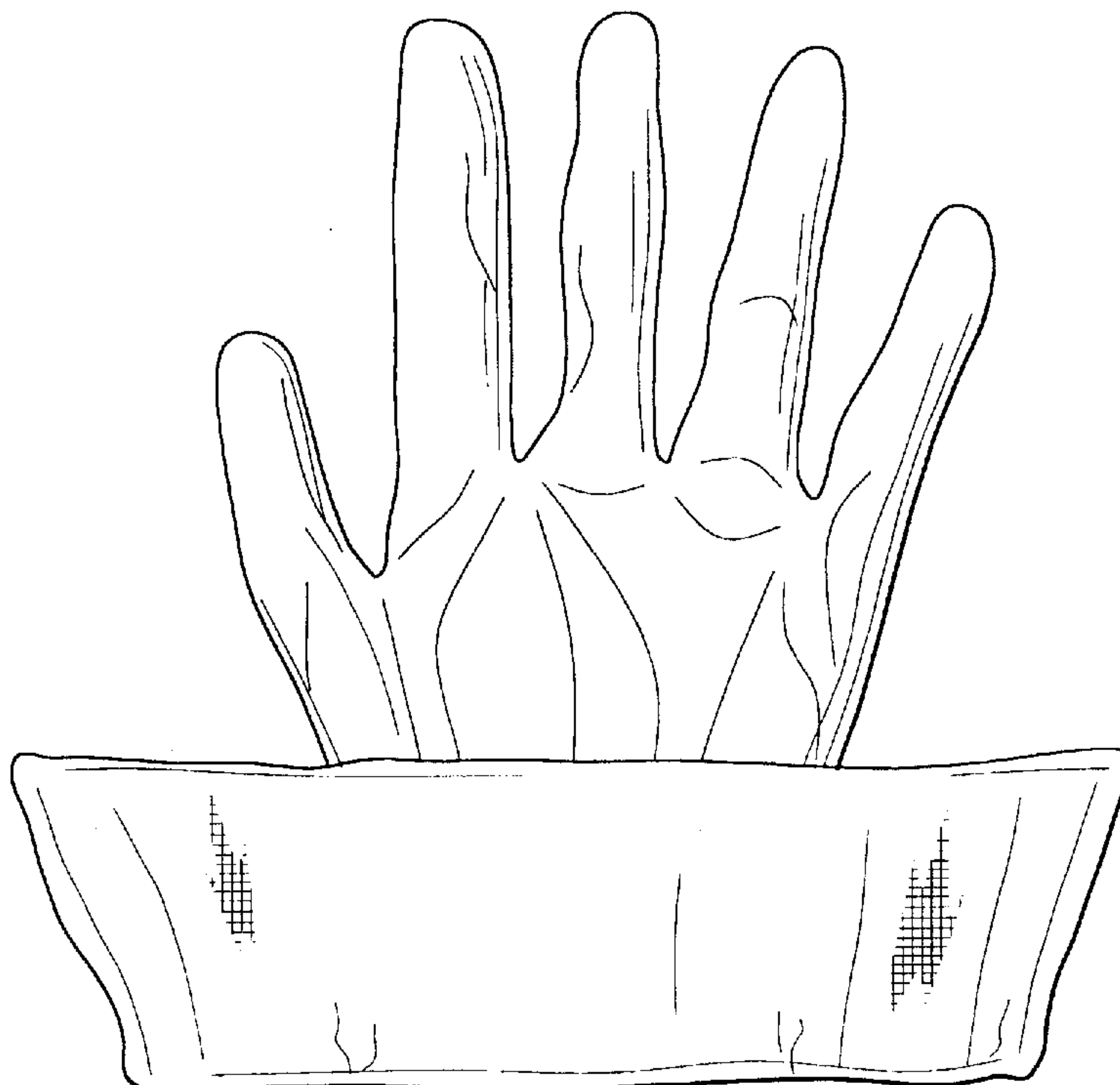

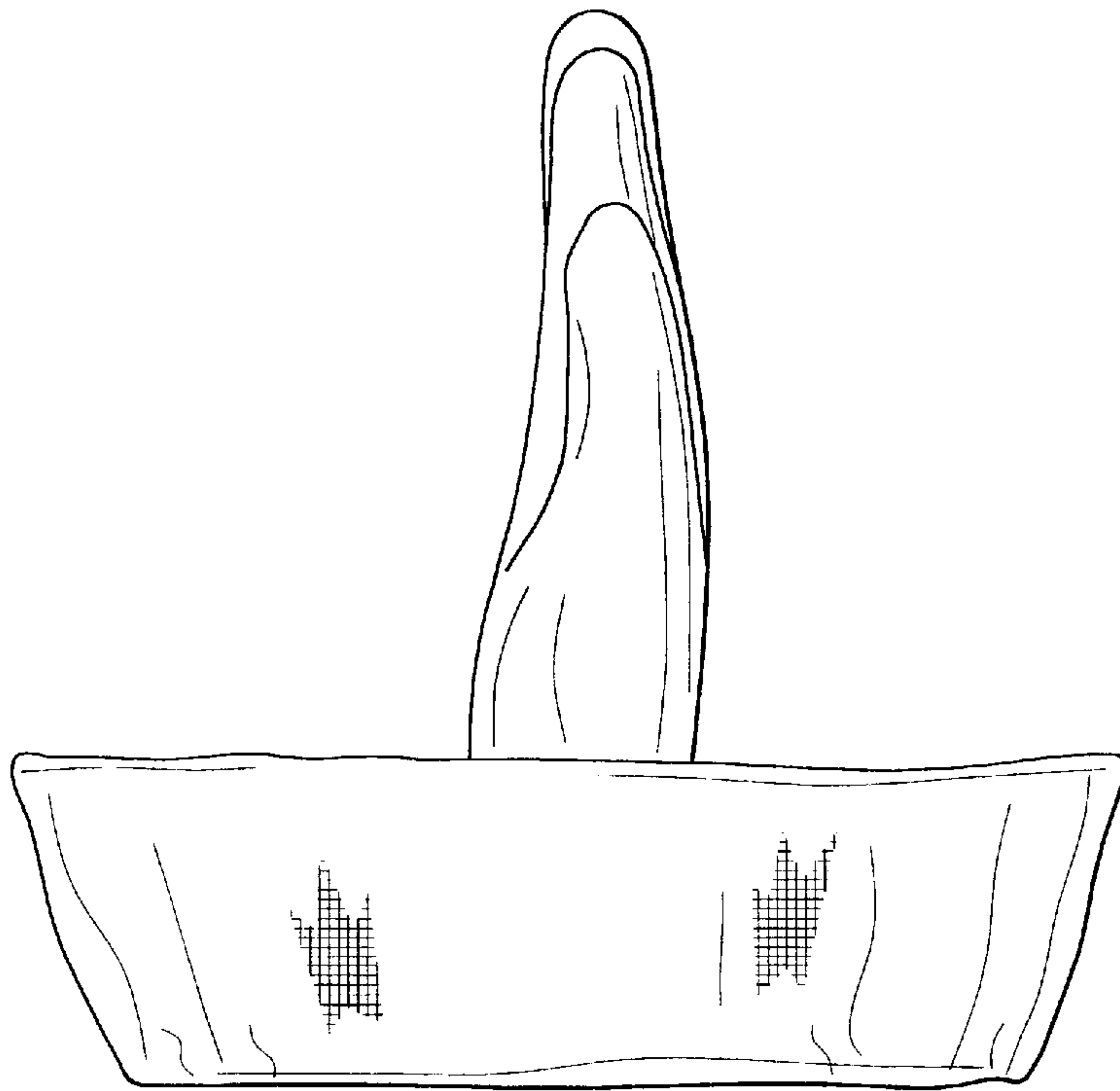

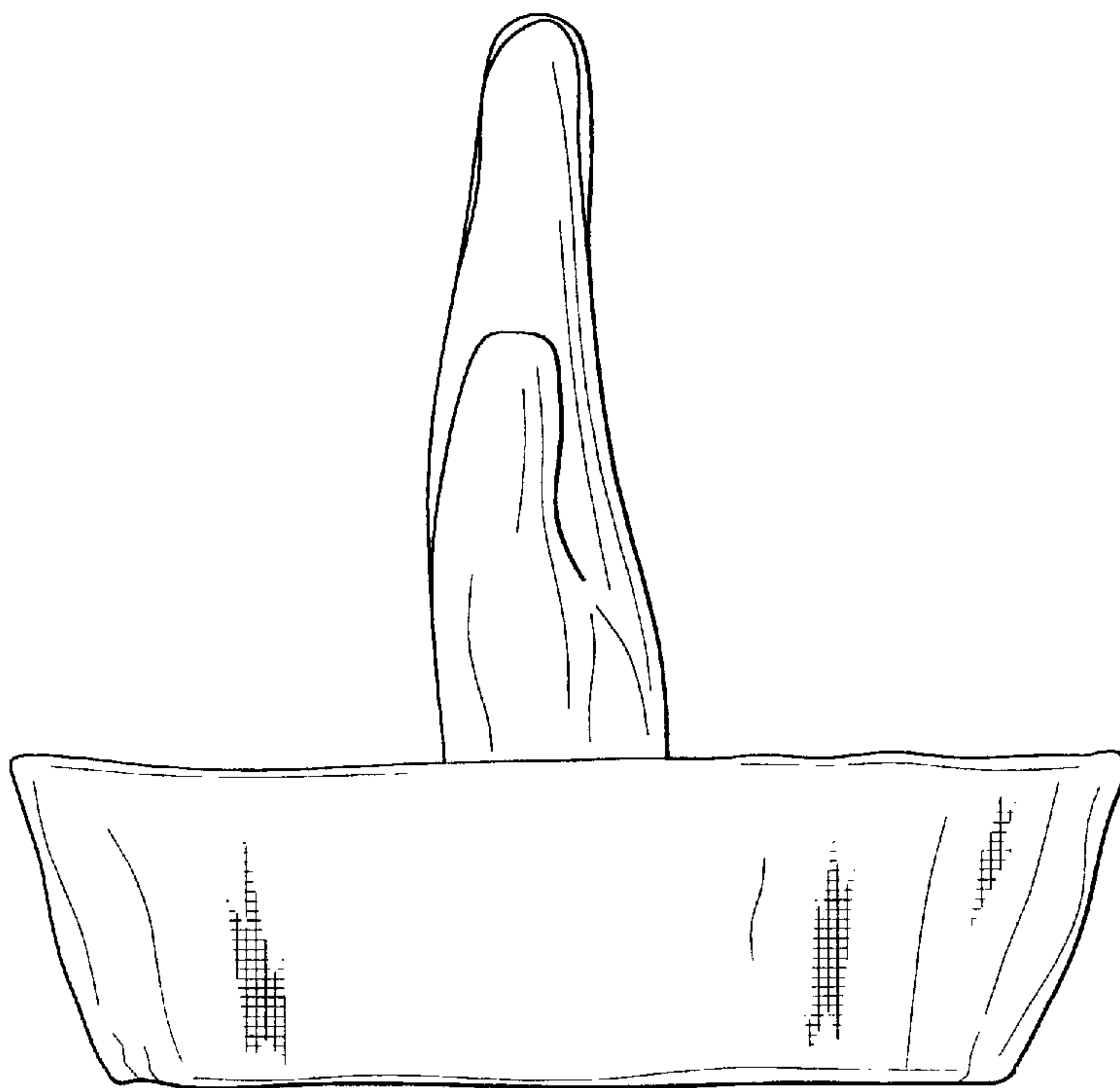

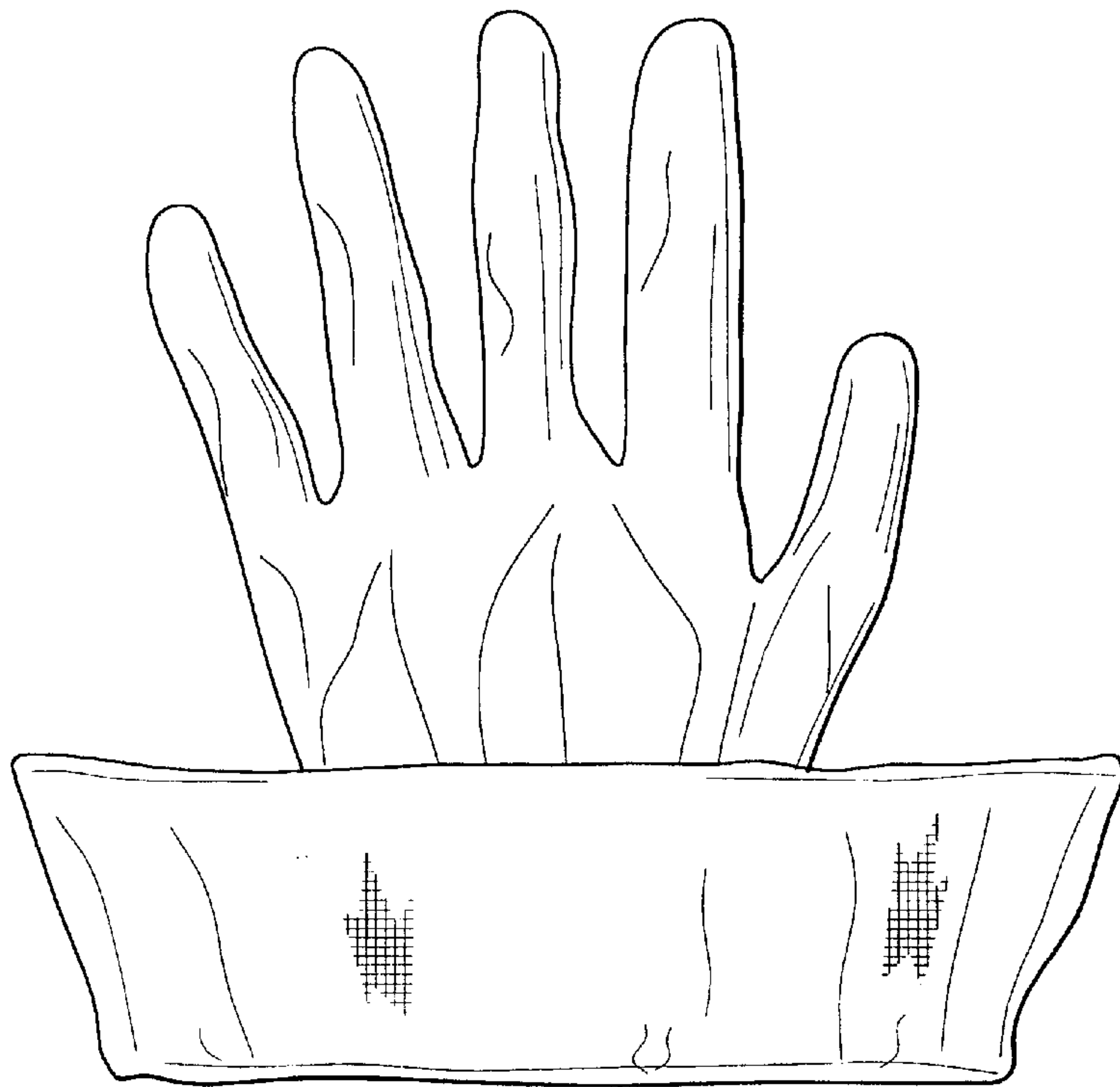

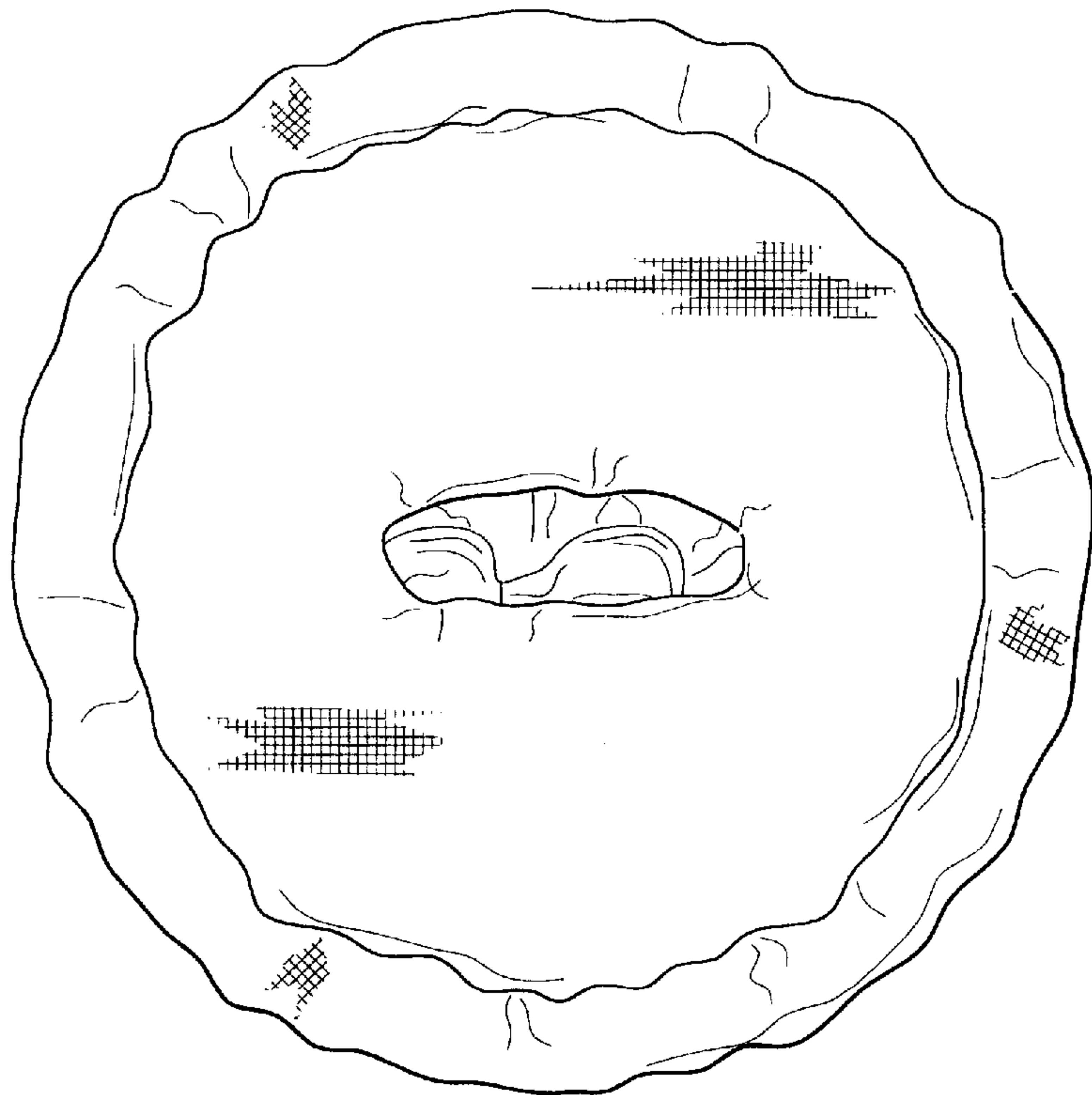

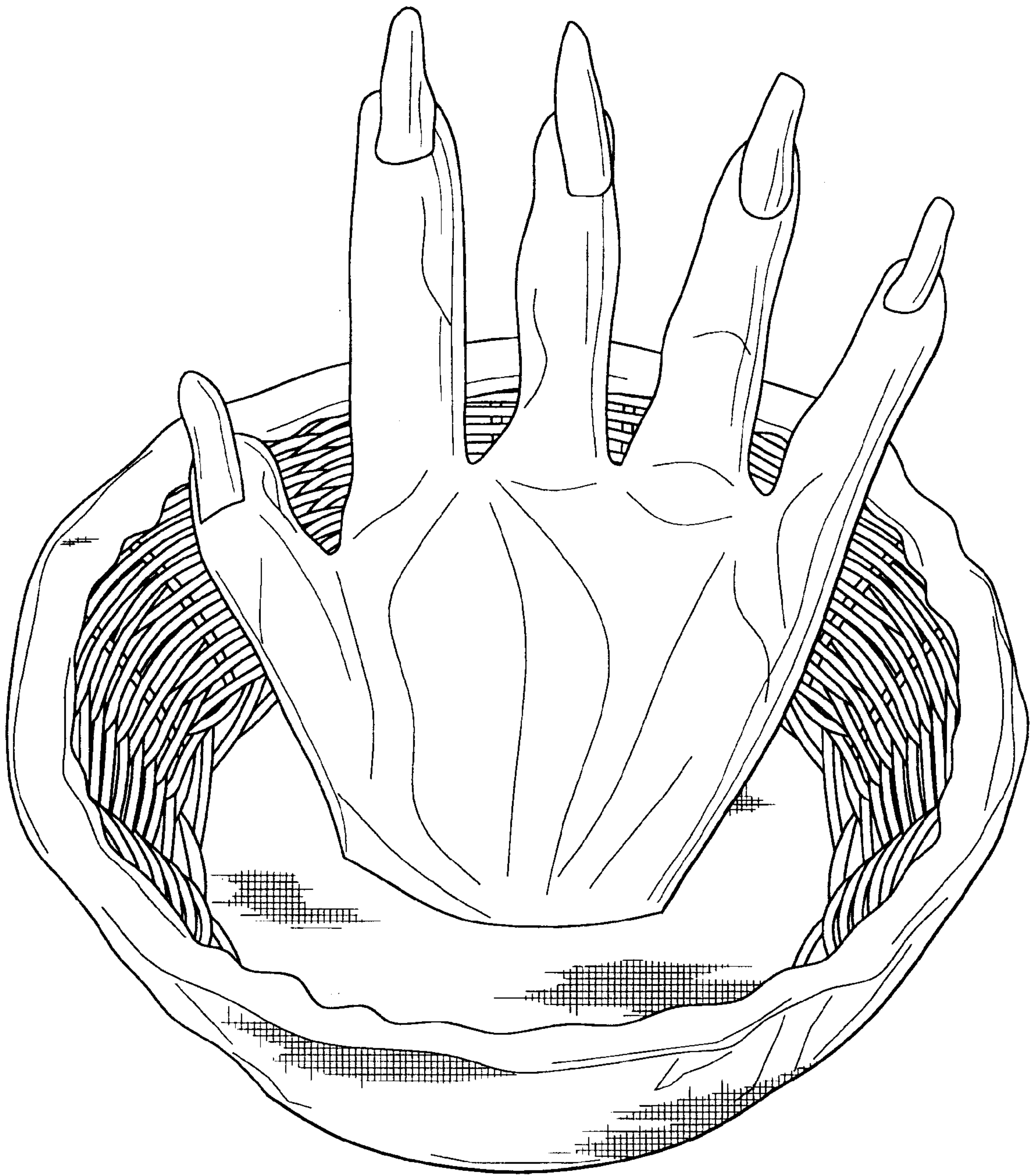

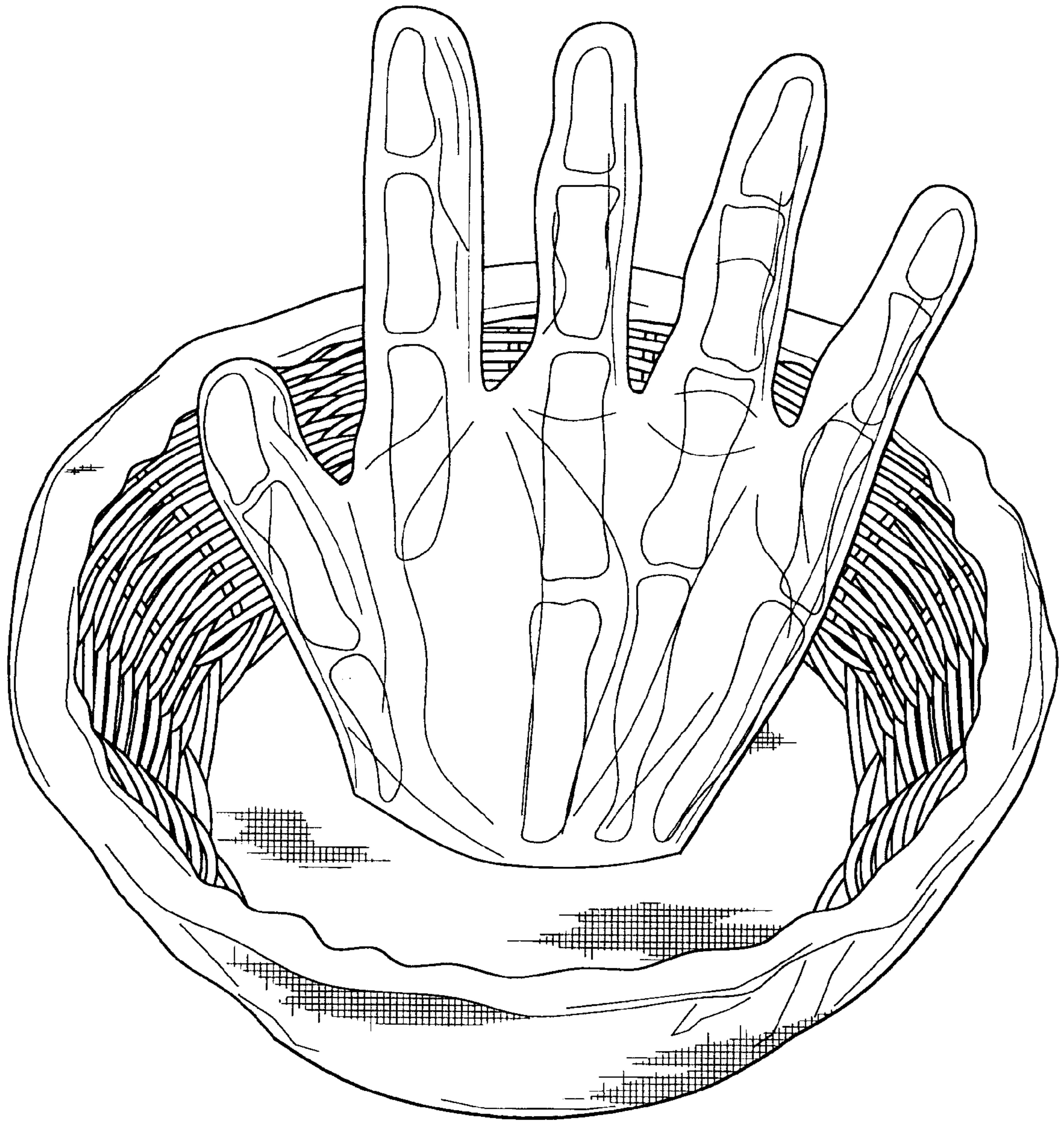
