(57) **CLAIM**

The ornamental design for a toothbrush, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a toothbrush showing our new design;

FIG. 2 is an enlarged front elevation view of the head portion of the toothbrush shown in FIG. 1;

FIG. 3 is a left side elevation view thereof, the right side being a mirror image of FIG. 1;

FIG. 4 is an enlarged left side elevation view of the head portion of the toothbrush shown in FIG. 3;

FIG. 5 is a back elevation view of FIG. 1;

FIG. 6 is an enlarged back elevation view of the head portion of the toothbrush shown in FIG. 5;

FIG. 7 is a top view of FIG. 1.

FIG. 8 is a bottom view of FIG. 1;

FIG. 9 is front, left side perspective view of FIG. 1, as seen from the bottom end thereof;

FIG. 10 is an enlarged front, left side perspective view of the head portion of the toothbrush shown in FIG. 9;

FIG. 11 is a back, right side perspective view of FIG. 1, as seen from the bottom thereof;

FIG. 12 is an enlarged back, right side perspective view of the head portion the toothbrush shown in FIG. 11;

FIG. 13 is a front elevation view of a toothbrush showing the second embodiment of my new design;

FIG. 14 is an enlarged front elevation view of the head portion of the toothbrush shown in FIG. 13;

FIG. 15 is a left side elevation view thereof, the right side being a mirror image of FIG. 13;

FIG. 16 is an enlarged left side elevation view of the head portion of the toothbrush shown in FIG. 15;

FIG. 17 is a back elevation view of FIG. 13;

FIG. 18 is an enlarged back elevation view of the head portion of the toothbrush shown in FIG. 17;

FIG. 19 is a top view of FIG. 13;

FIG. 20 is a bottom view of FIG. 13;

FIG. 21 is front, left side perspective view thereof, as seen from the bottom of FIG. 13;

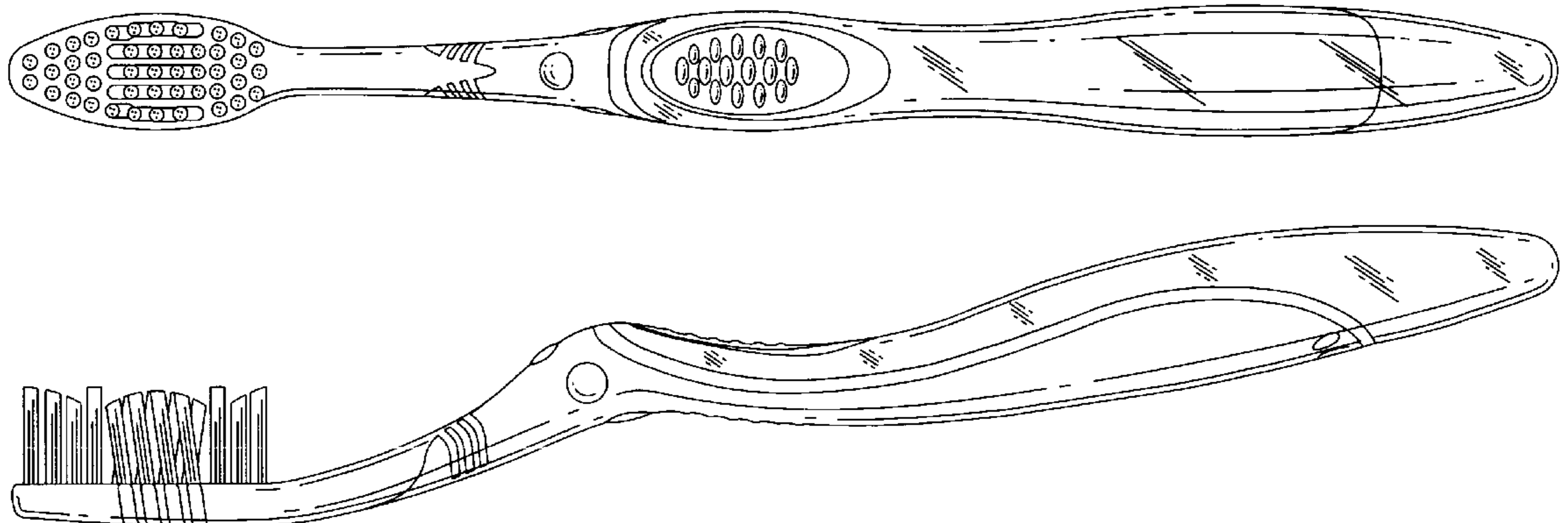
FIG. 22 is an enlarged front, left side perspective view of the head portion of the toothbrush shown in FIG. 21;

FIG. 23 is a back, right side perspective view thereof, as seen from the bottom of FIG. 13; and,

FIG. 24 is an enlarged back, right side perspective view of the head portion of the toothbrush shown in FIG. 23.

In FIGS. 13-24, the bristles of the toothbrush are shown in broken lines for illustrative purposes only and form no part of the claimed design.

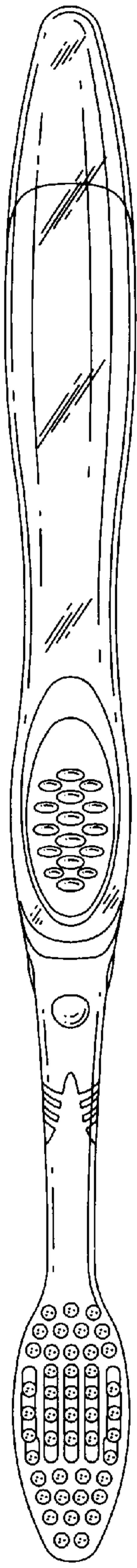

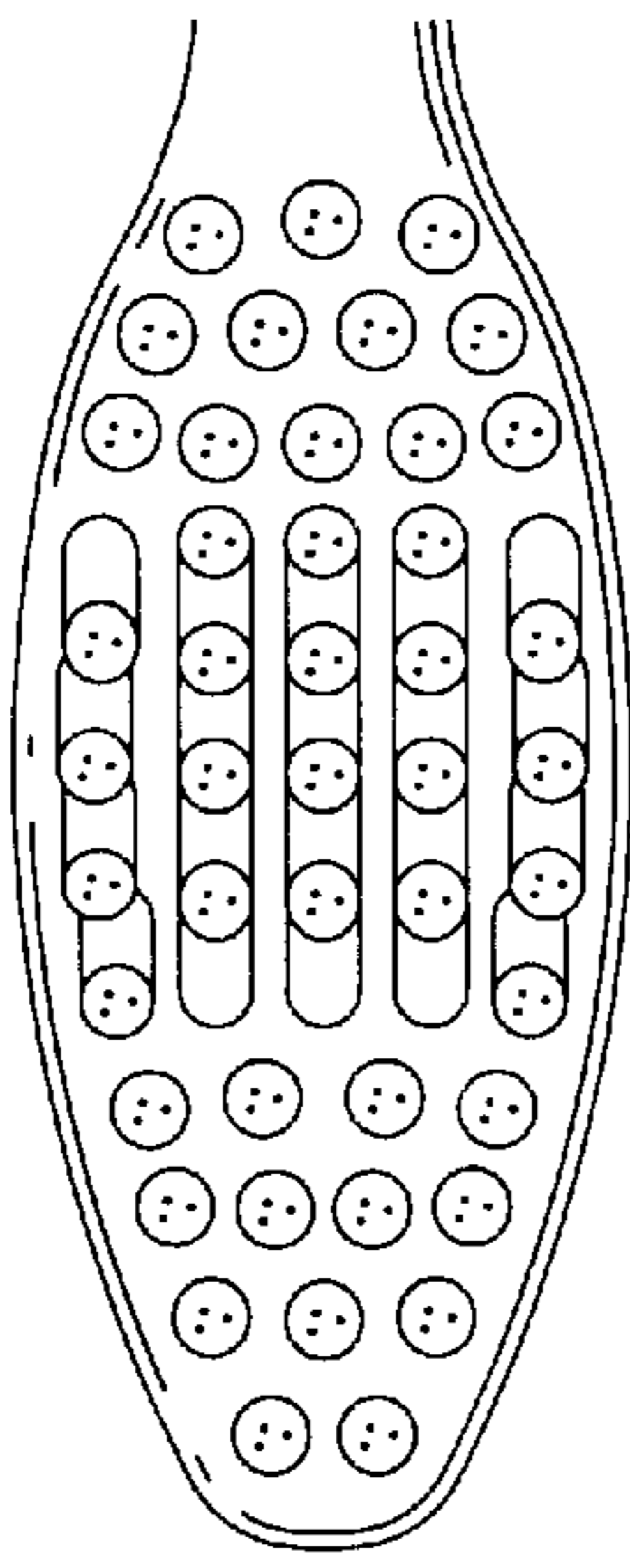

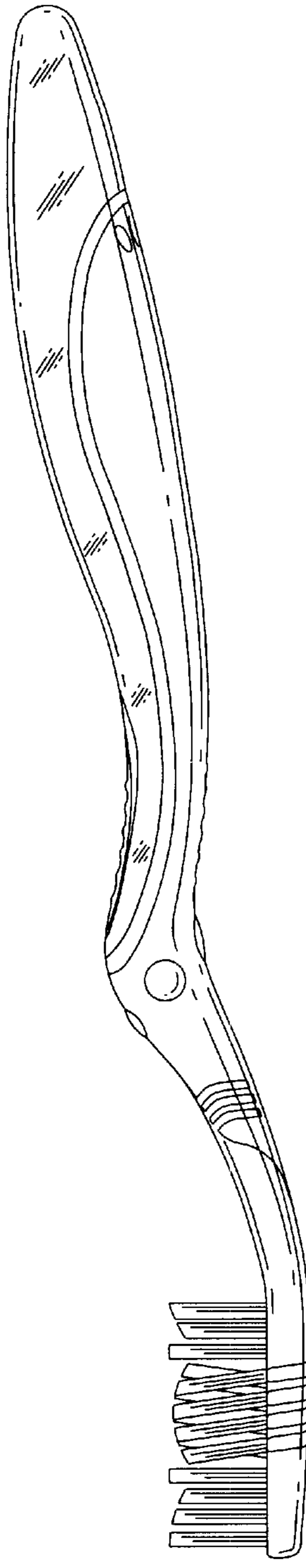

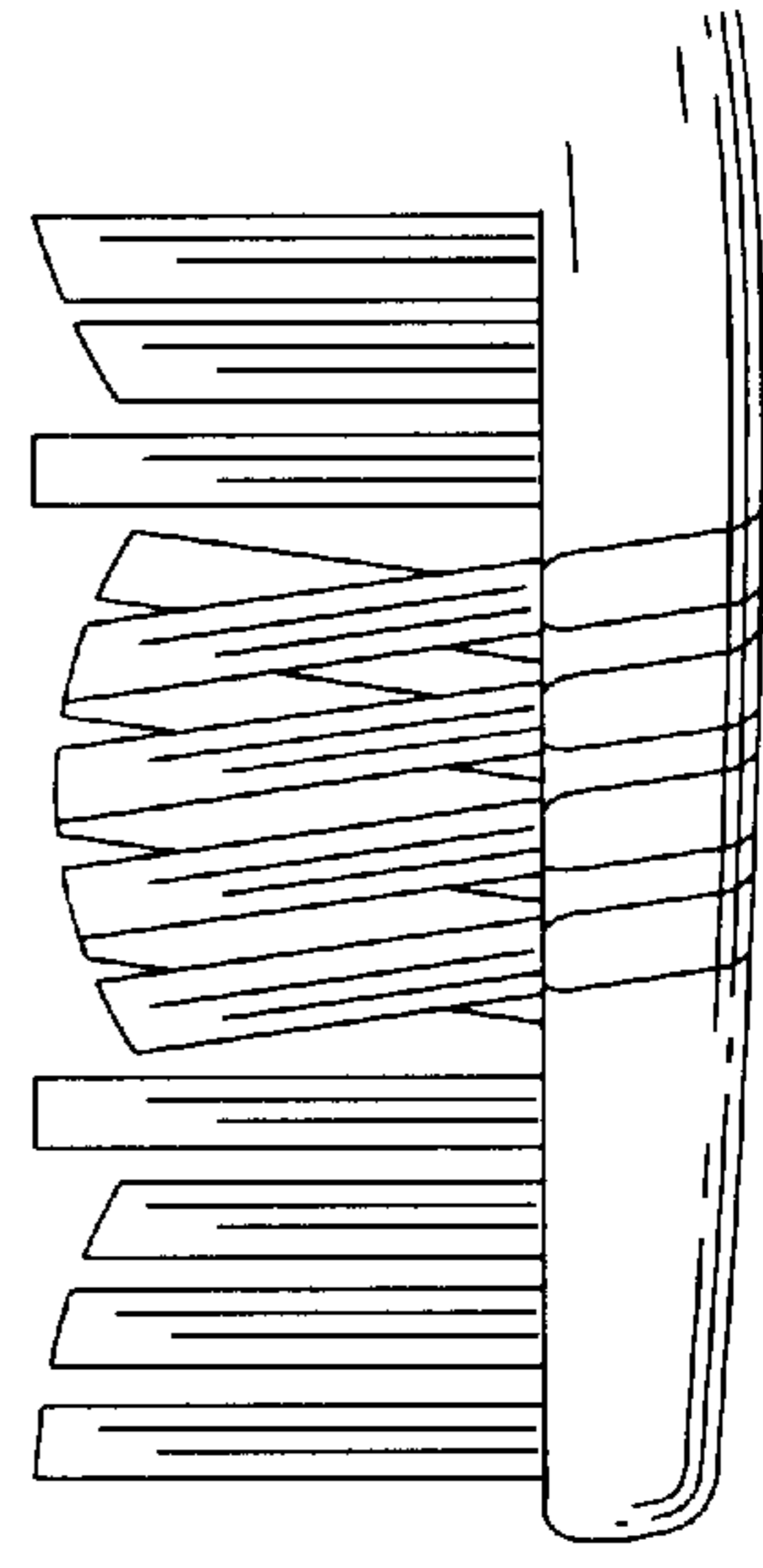

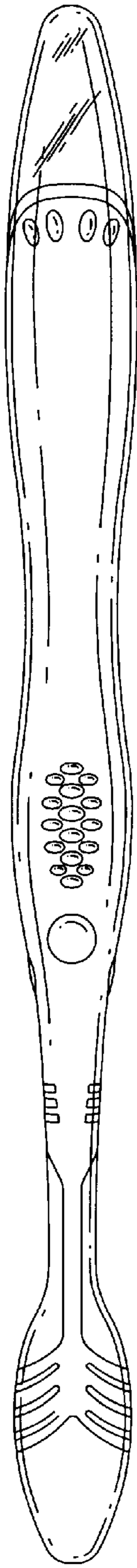

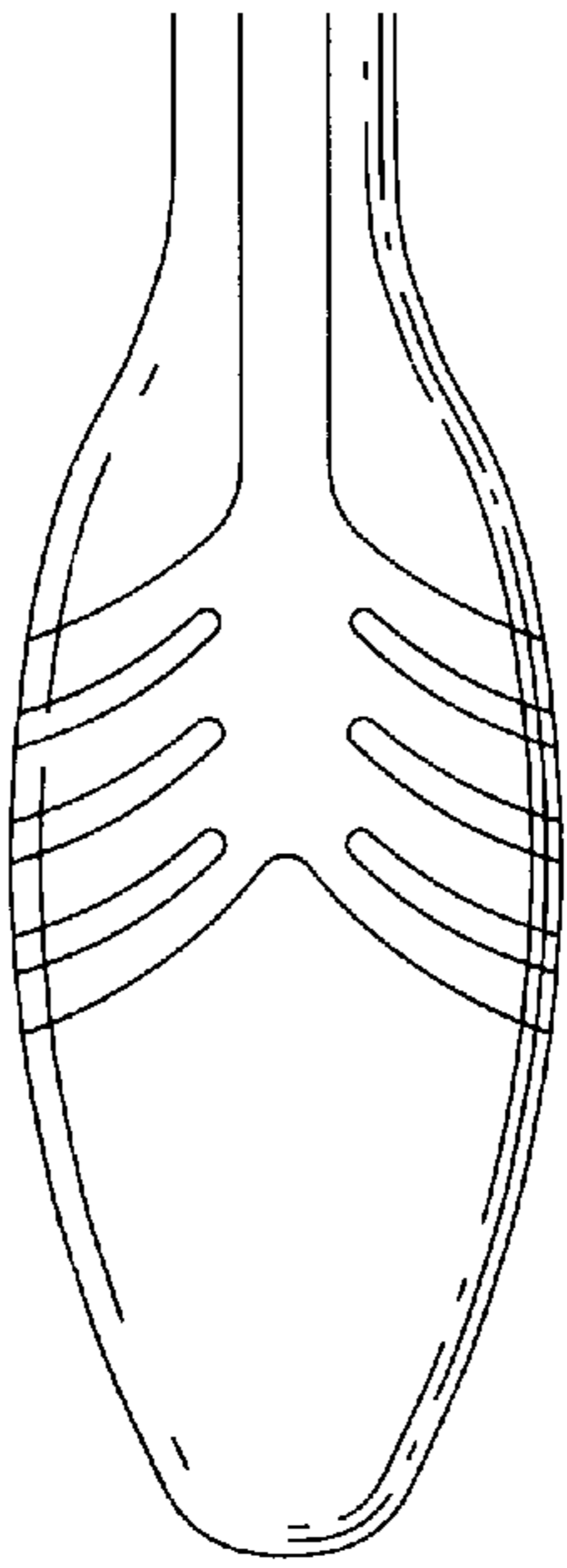

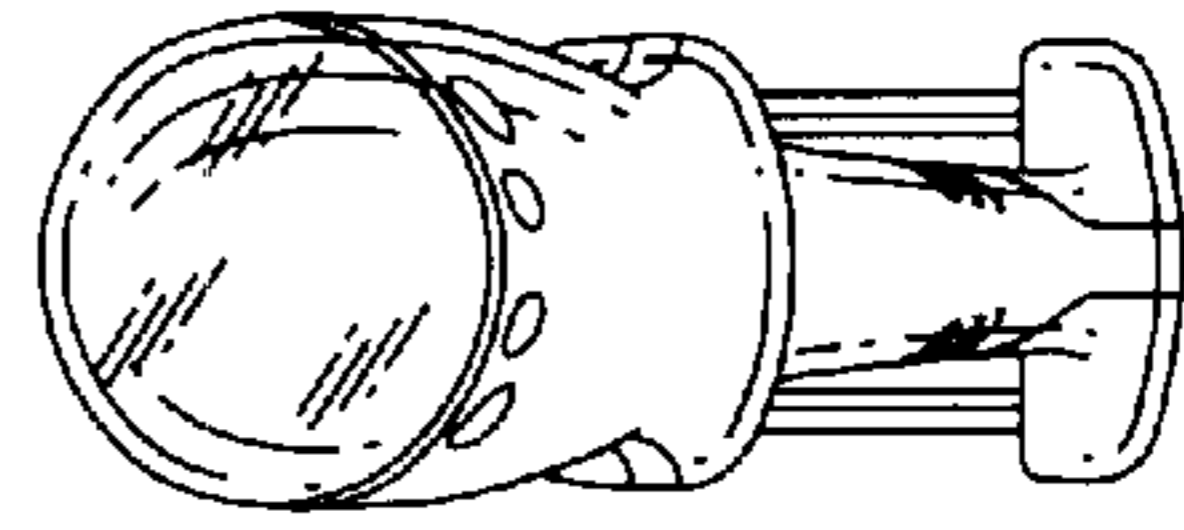

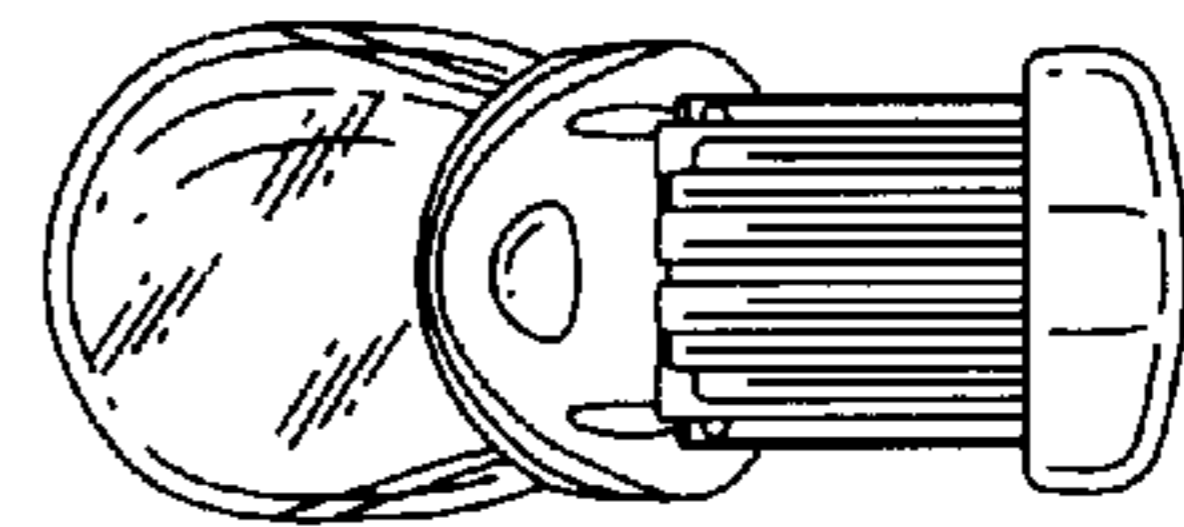

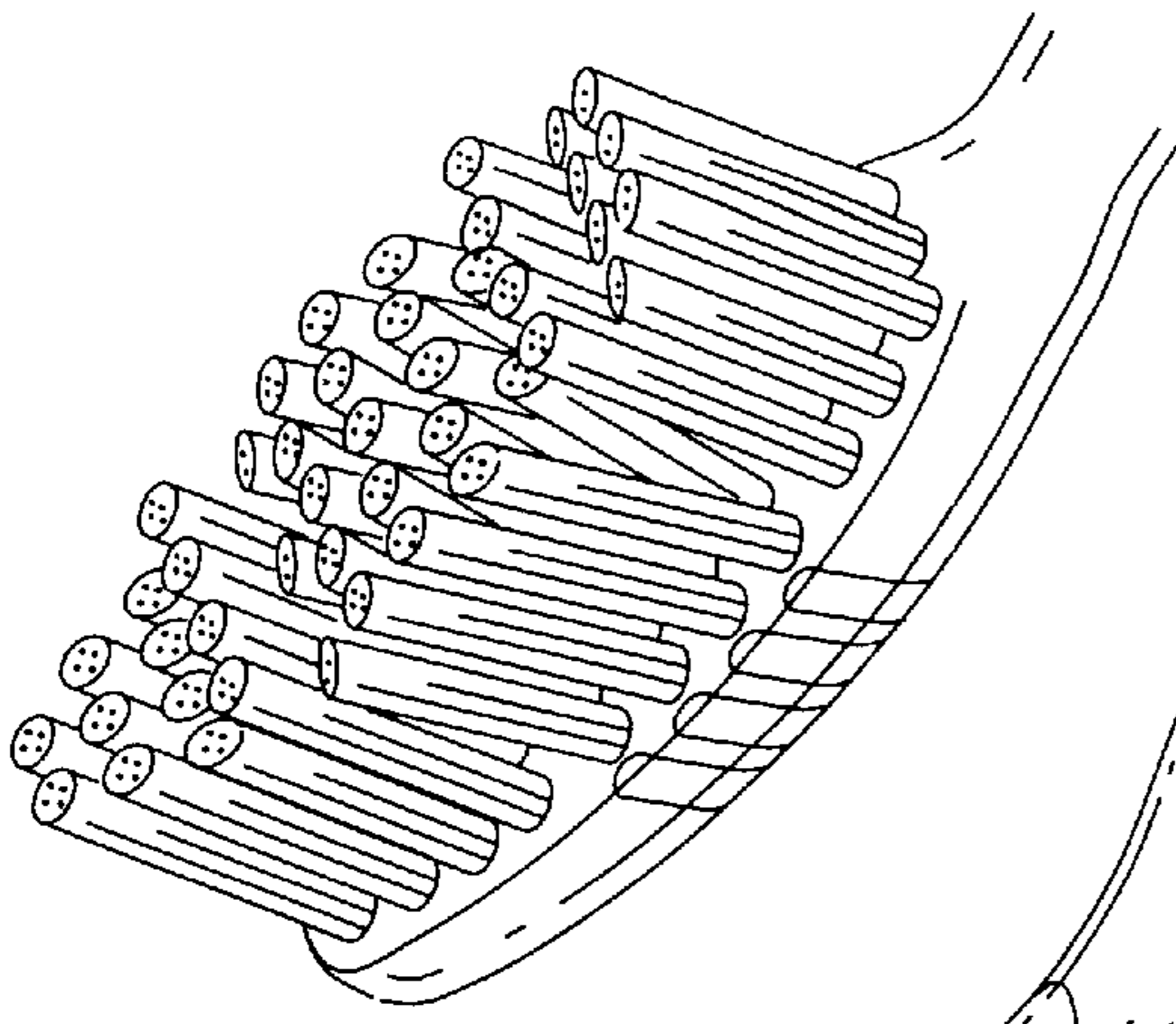

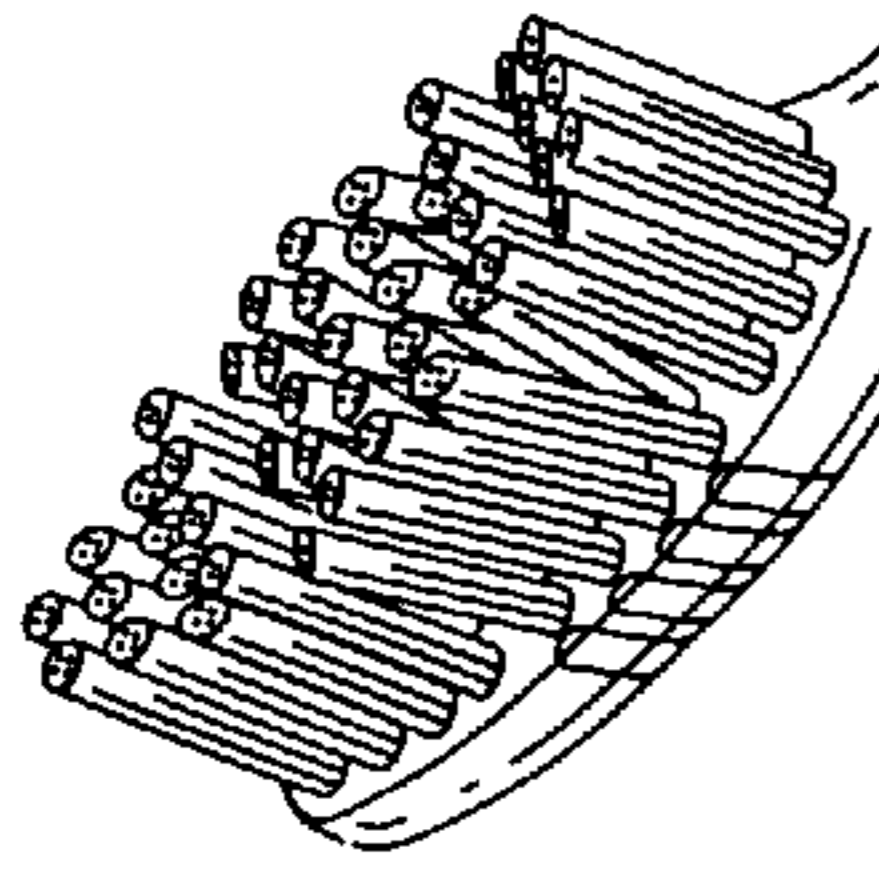

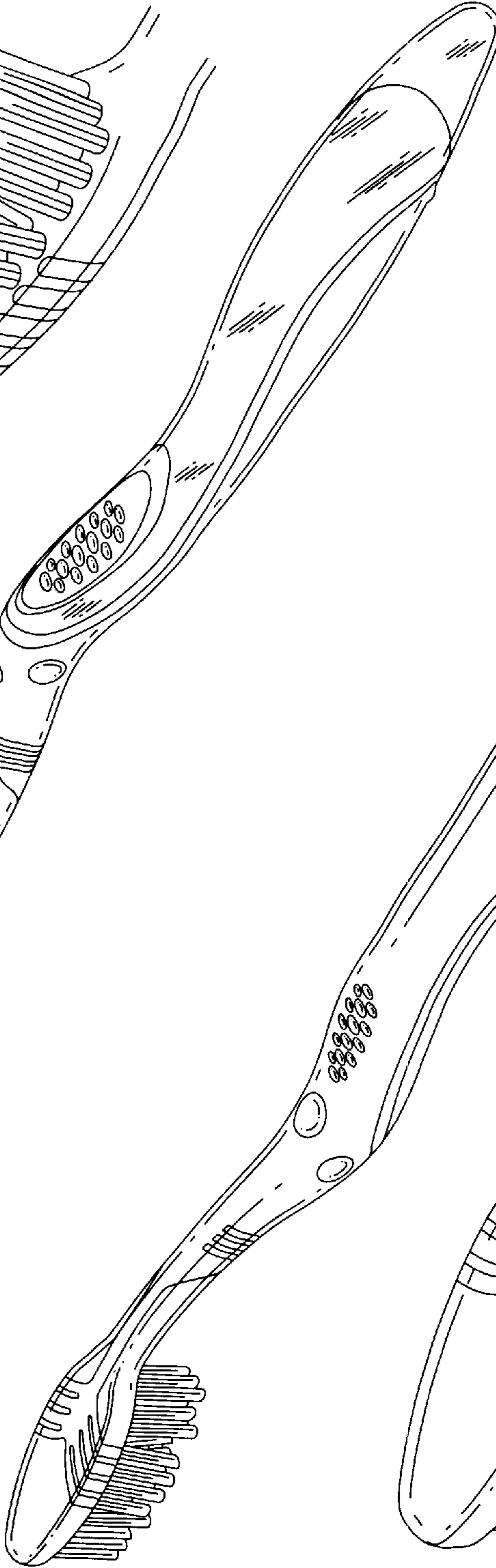

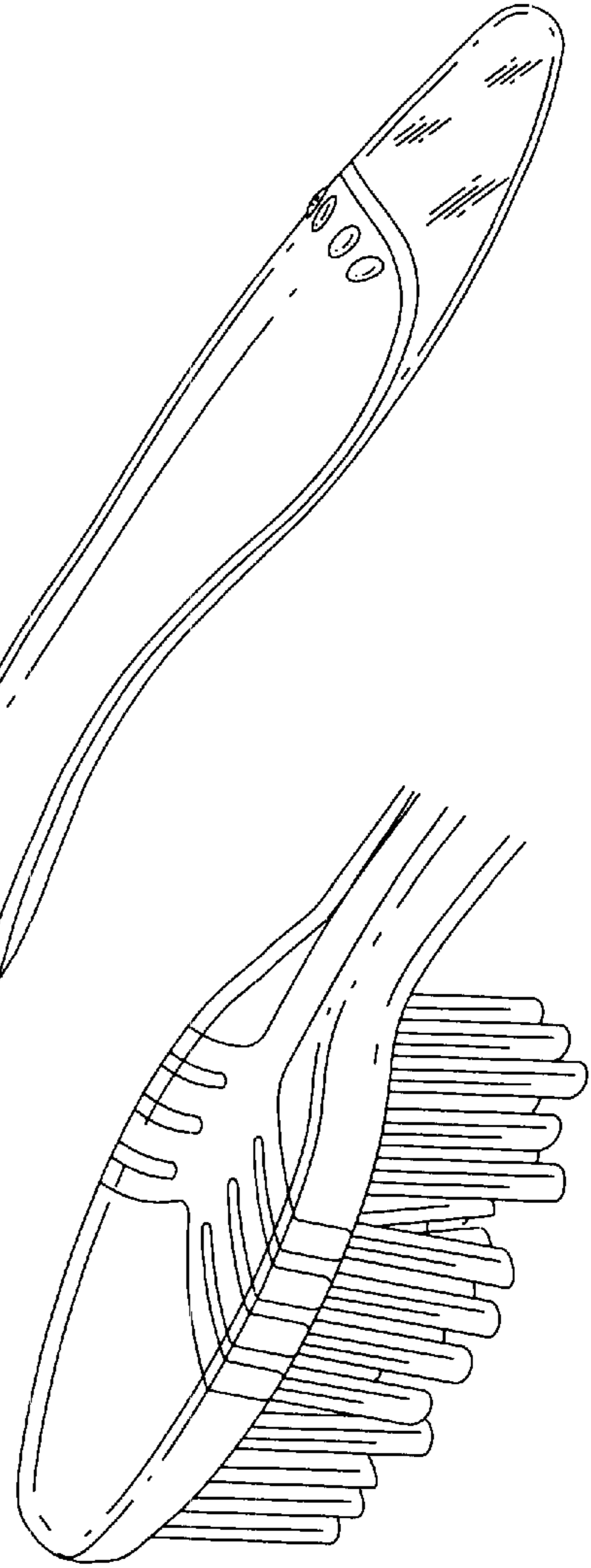

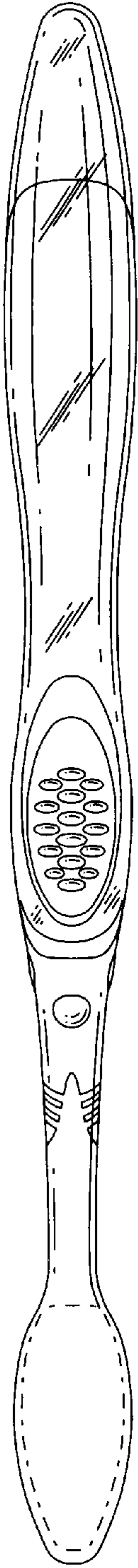

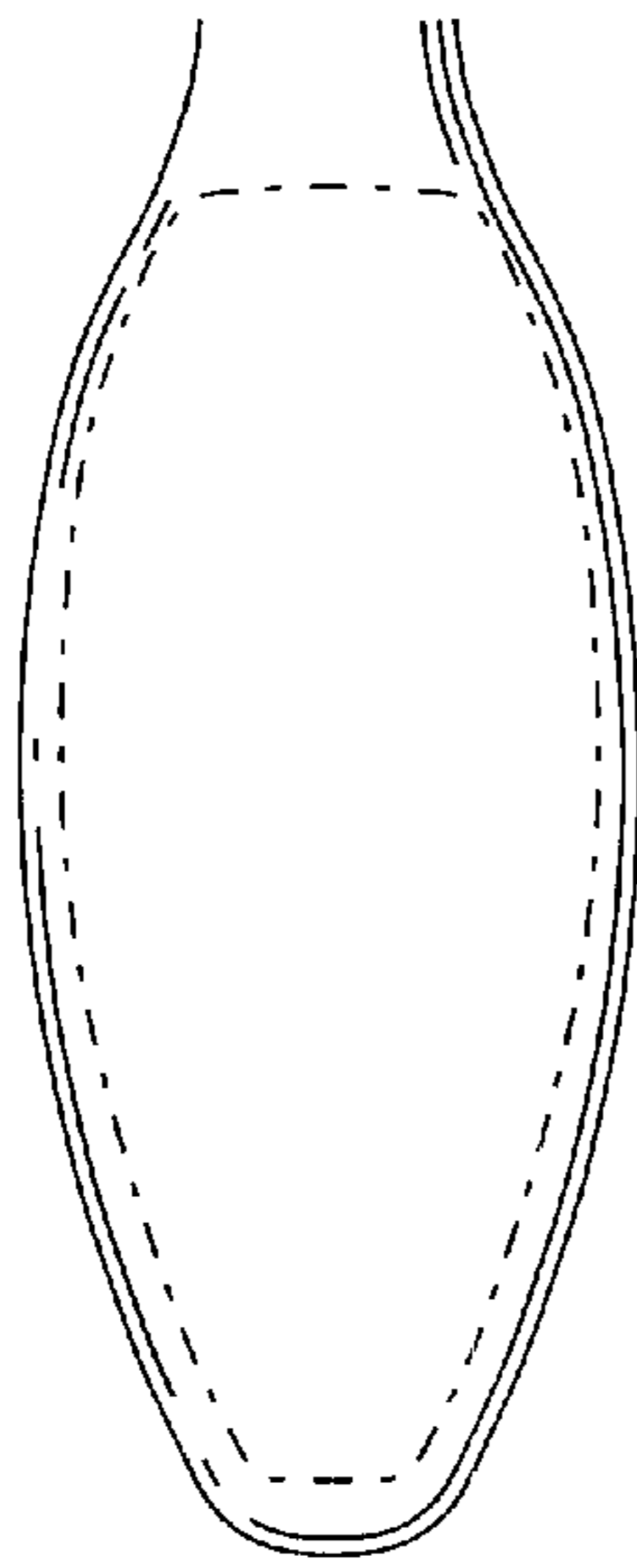

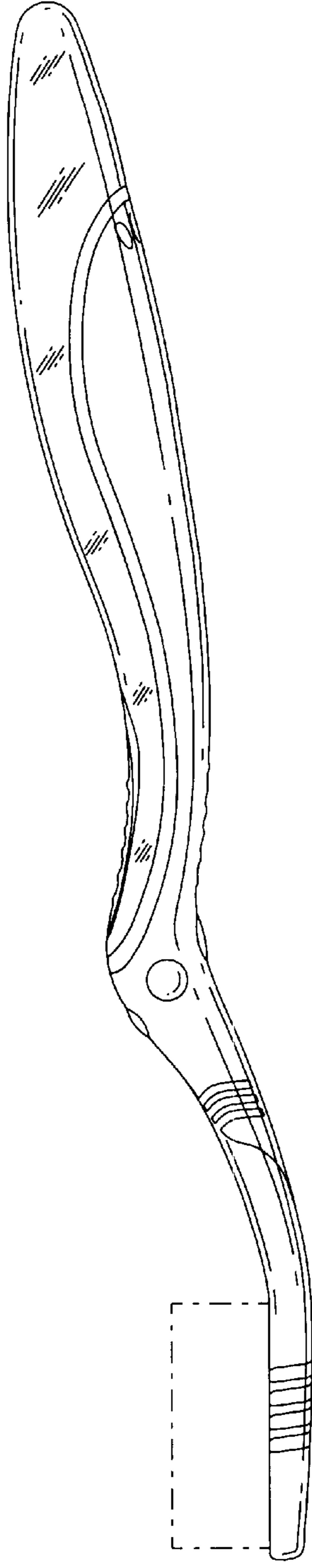

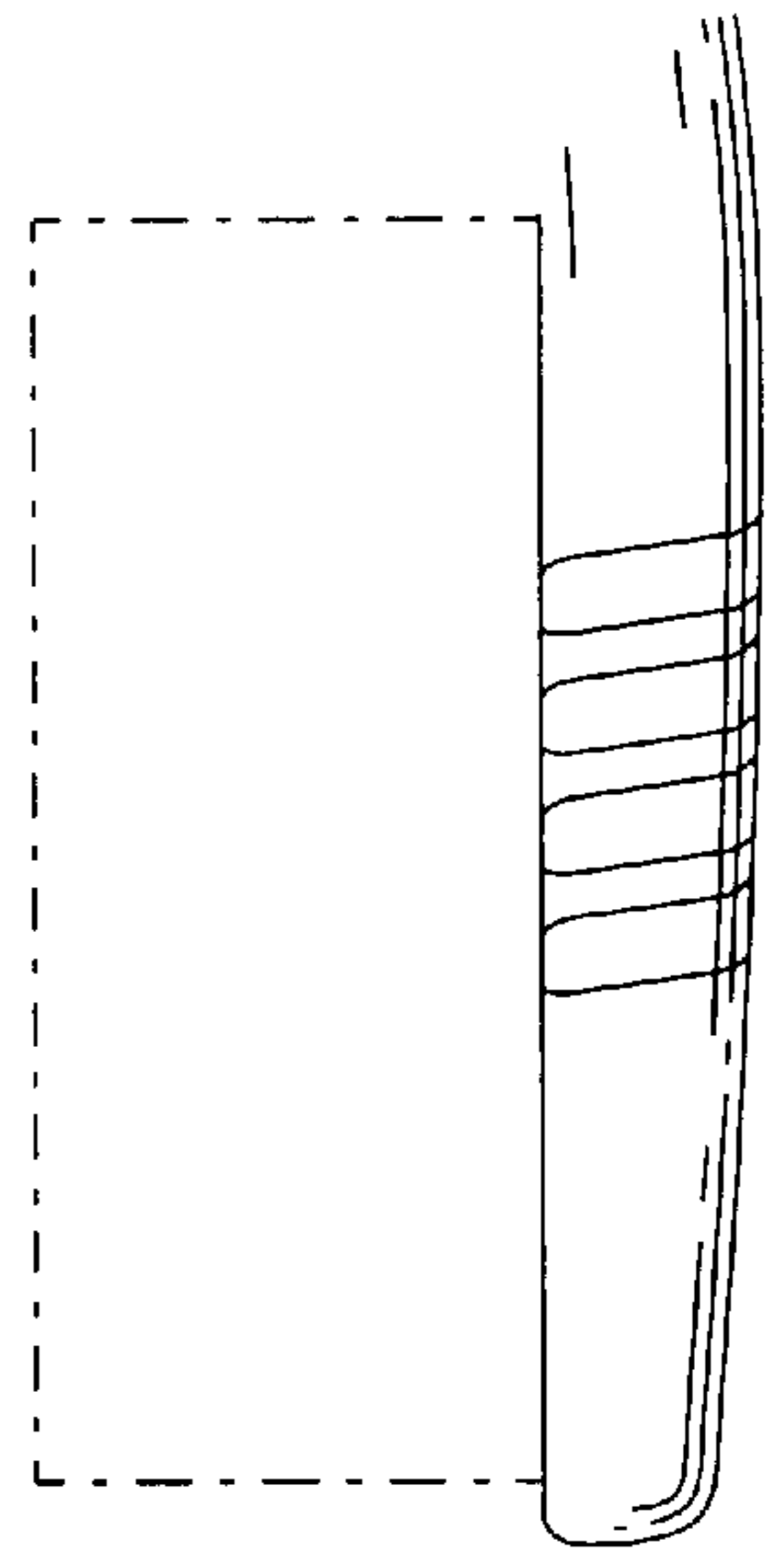

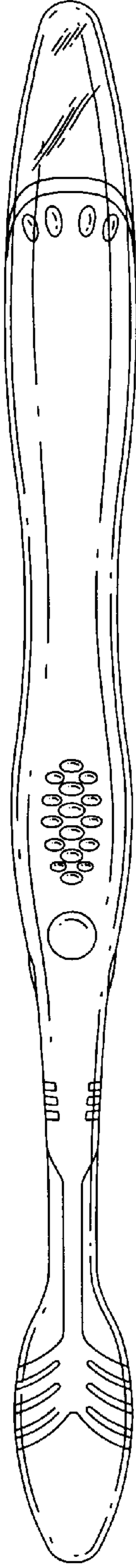

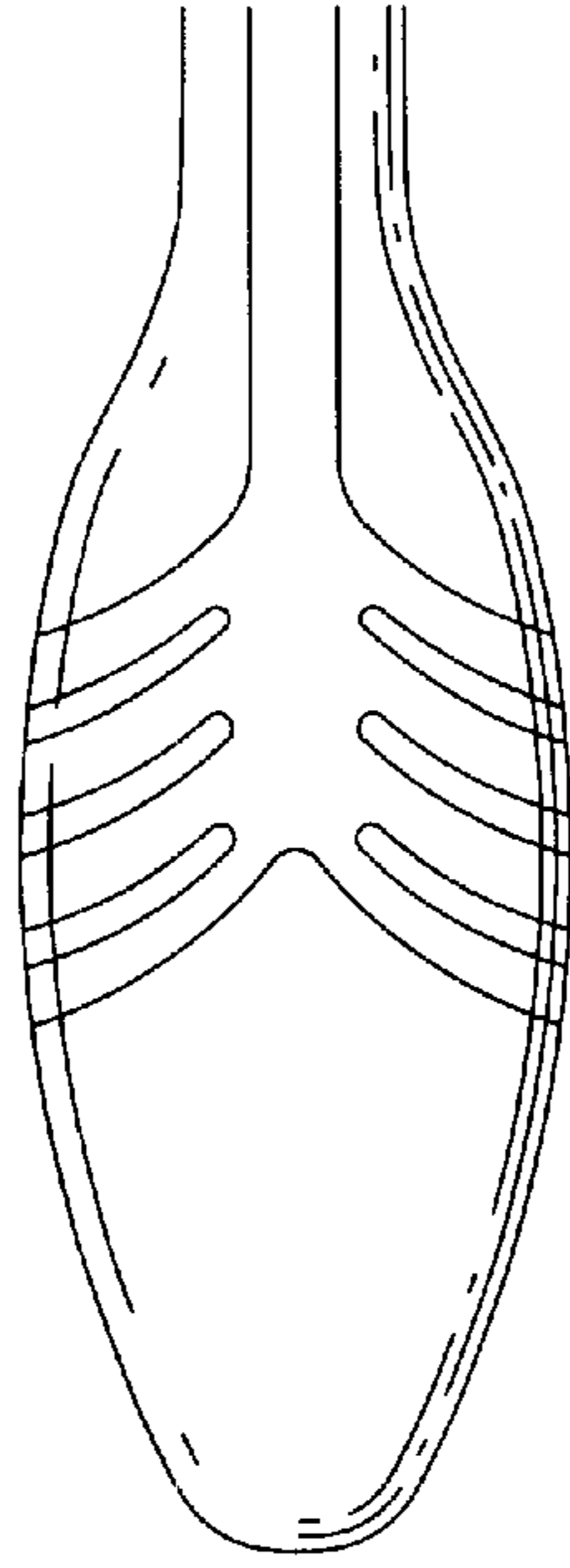

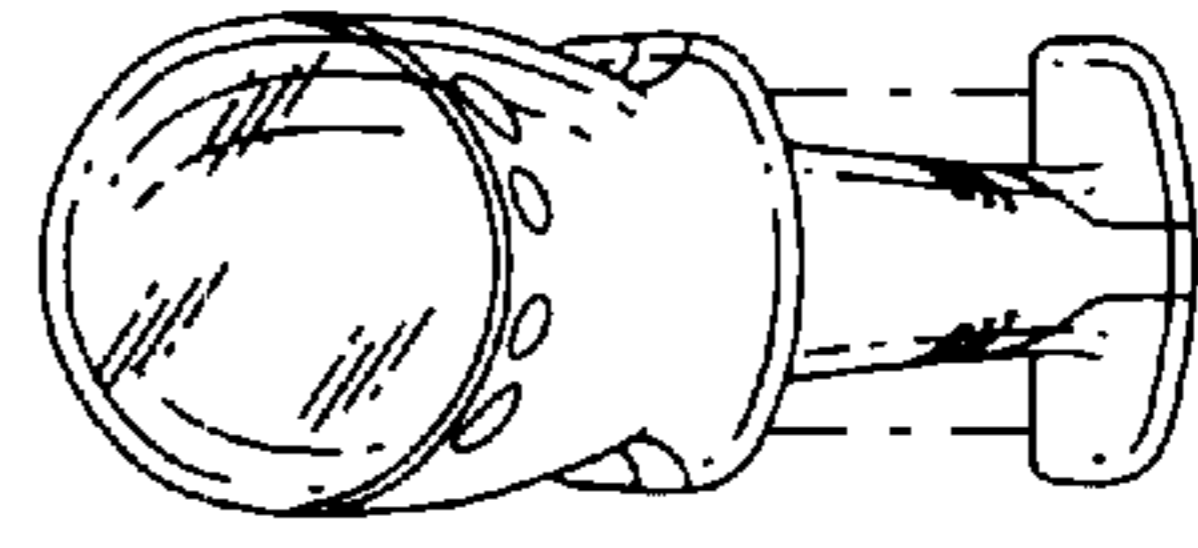

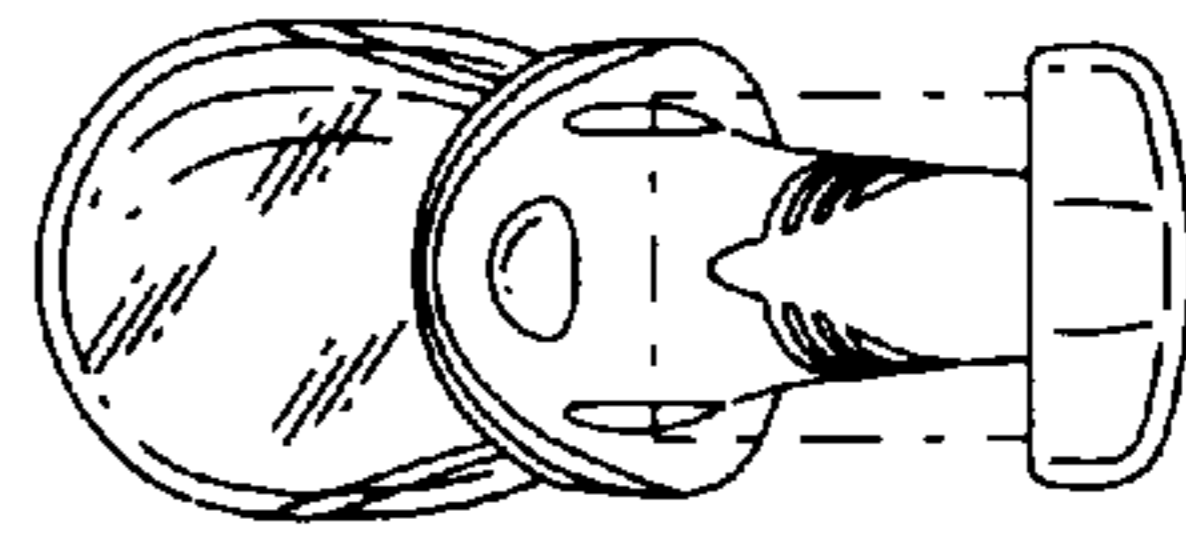

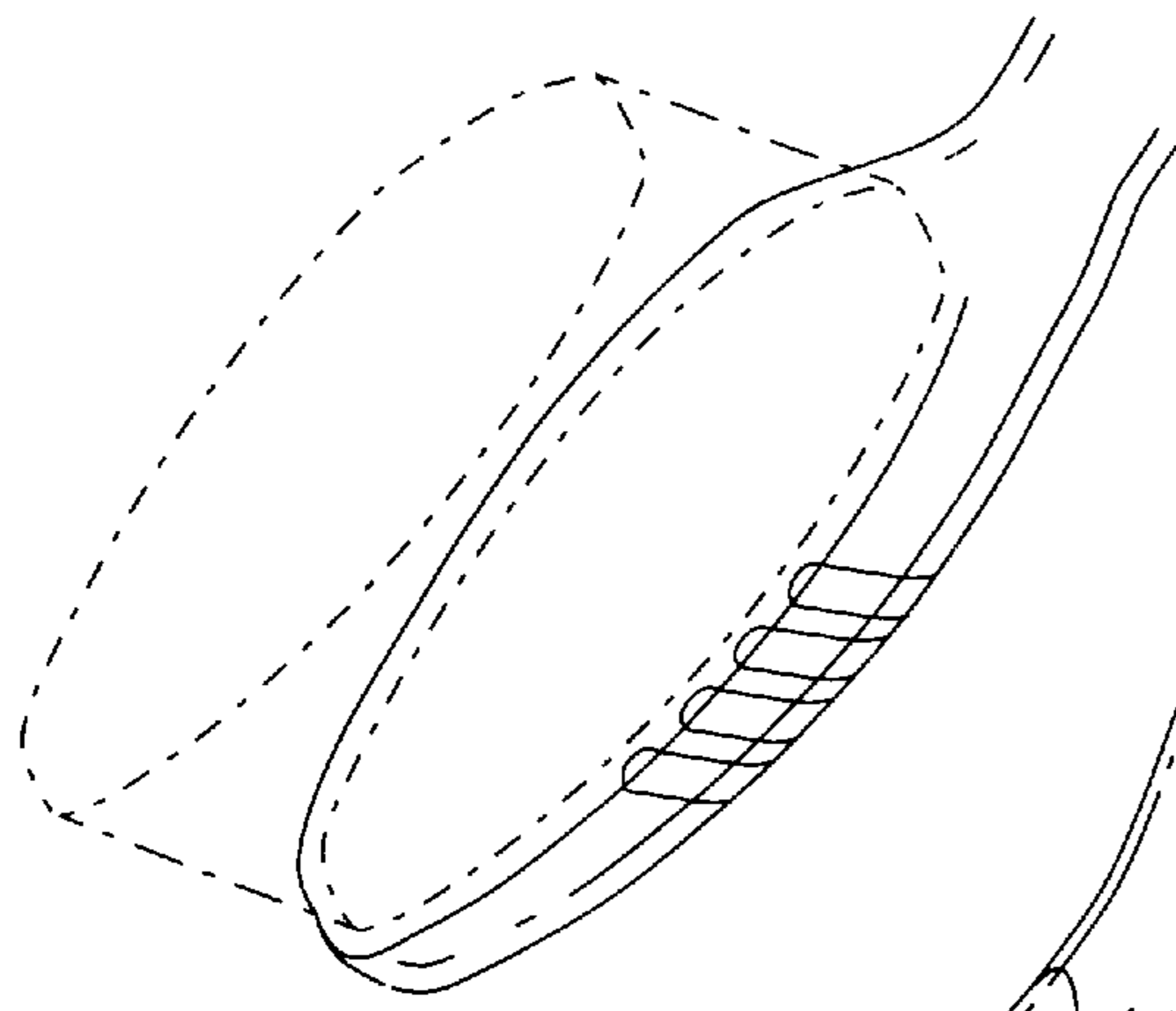

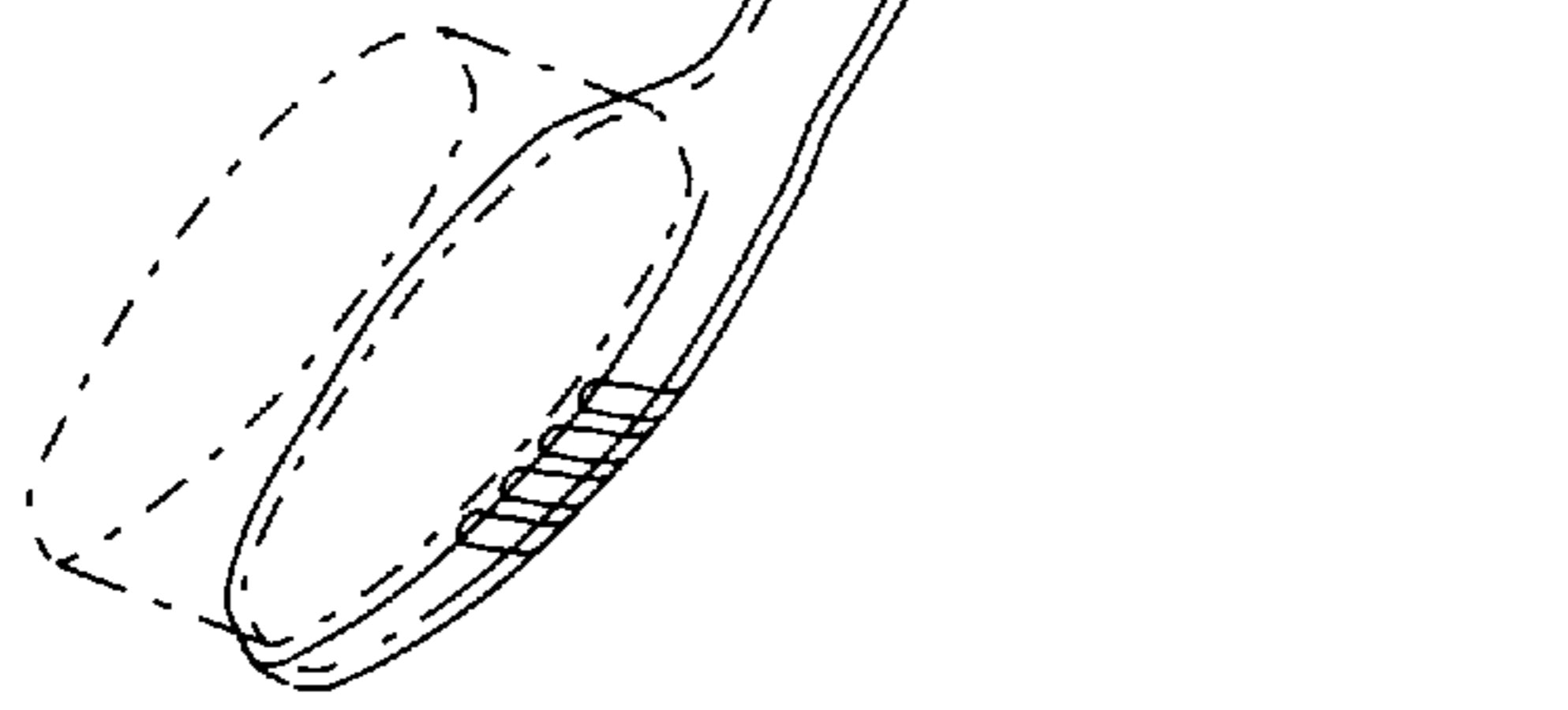

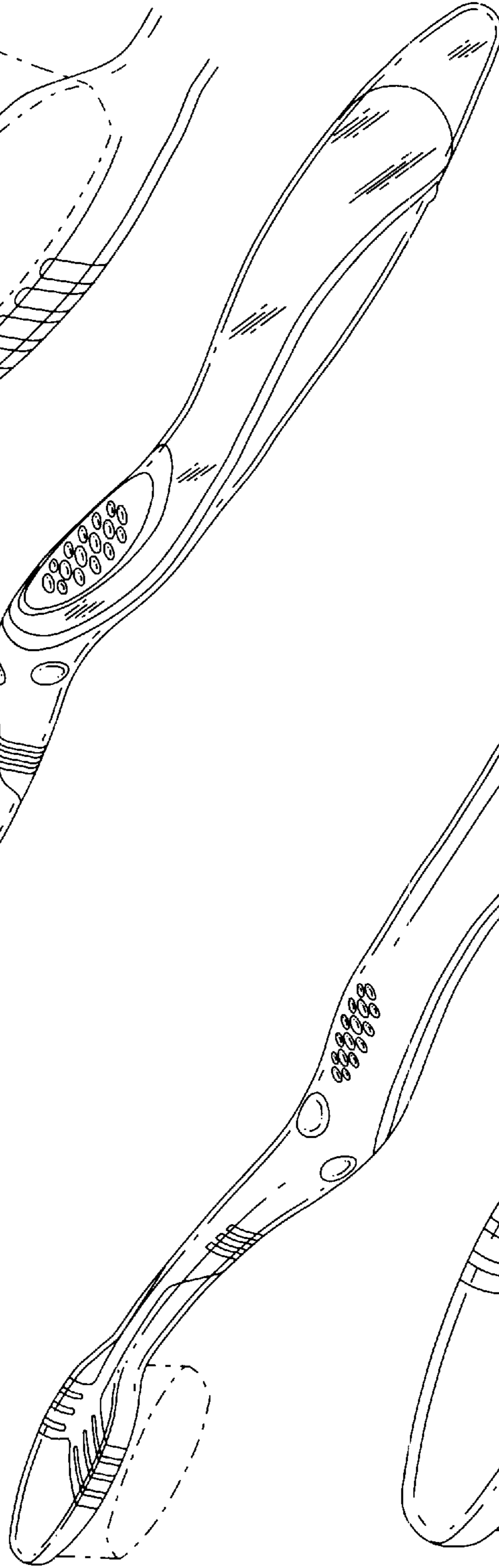
