(57) **CLAIM**

The ornamental design for an ice dispenser and ice/beverage dispenser, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of an ice/beverage dispenser showing my design.

FIG. 2 is a left-side elevational view of the embodiment of FIG. 1;

FIG. 3 is a front elevational view of the embodiment of FIG. 1;

FIG. 4 is a right-side elevational view, showing the side opposite that in FIG. 2;

FIG. 5 is a rear elevational view, showing the side opposite that in FIG. 3;

FIG. 6 is a top plan view of the embodiment of FIG. 1;

FIG. 7 is a bottom plan view of the embodiment of FIG. 1;

FIG. 8 is a front perspective view of a second embodiment of the ice/beverage dispenser.

FIG. 9 is a left-side elevational view of the embodiment of FIG. 8;

FIG. 10 is a front elevational view of the embodiment of FIG. 8;

FIG. 10 is a front elevational view of the embodiment of FIG. 8;

FIG. 11 is right-side elevational view showing the side opposite that in FIG. 9;

FIG. 12 is a rear elevational view showing the side opposite that in FIG. 10; and

FIG. 13 is a top plan view of the embodiment of FIG. 8; and,

FIG. 14 is a bottom plan view of the embodiment of FIG. 8.

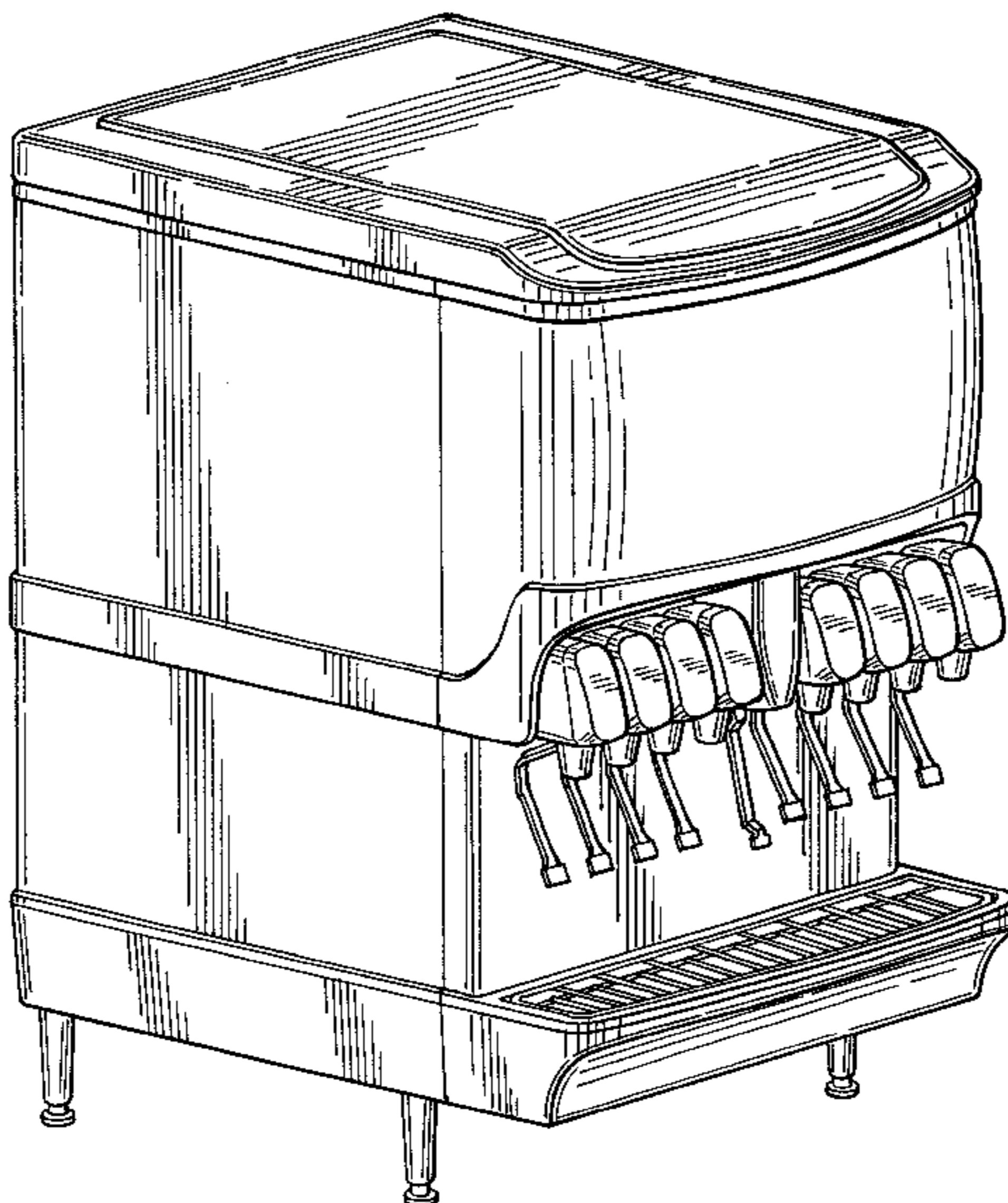

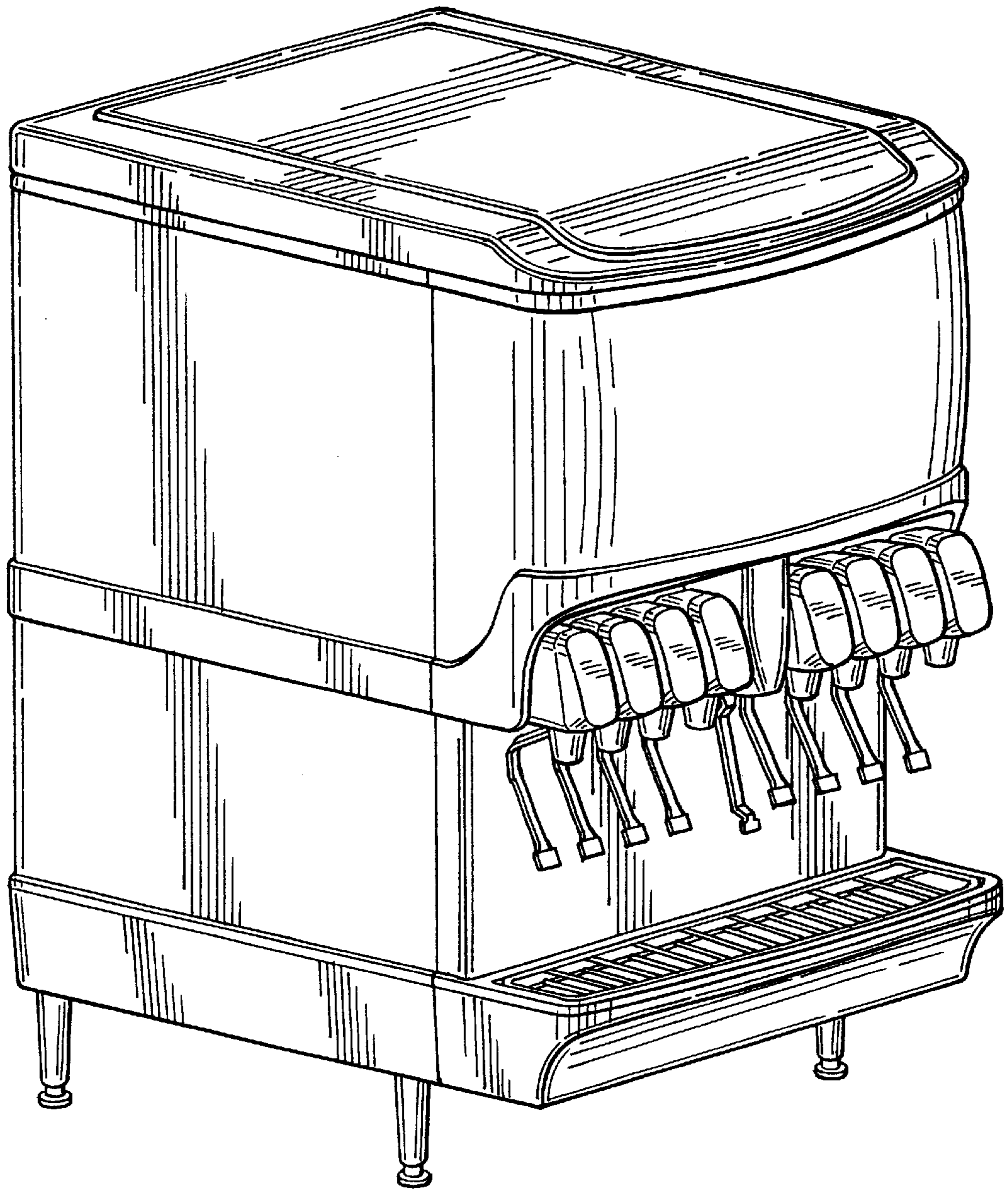

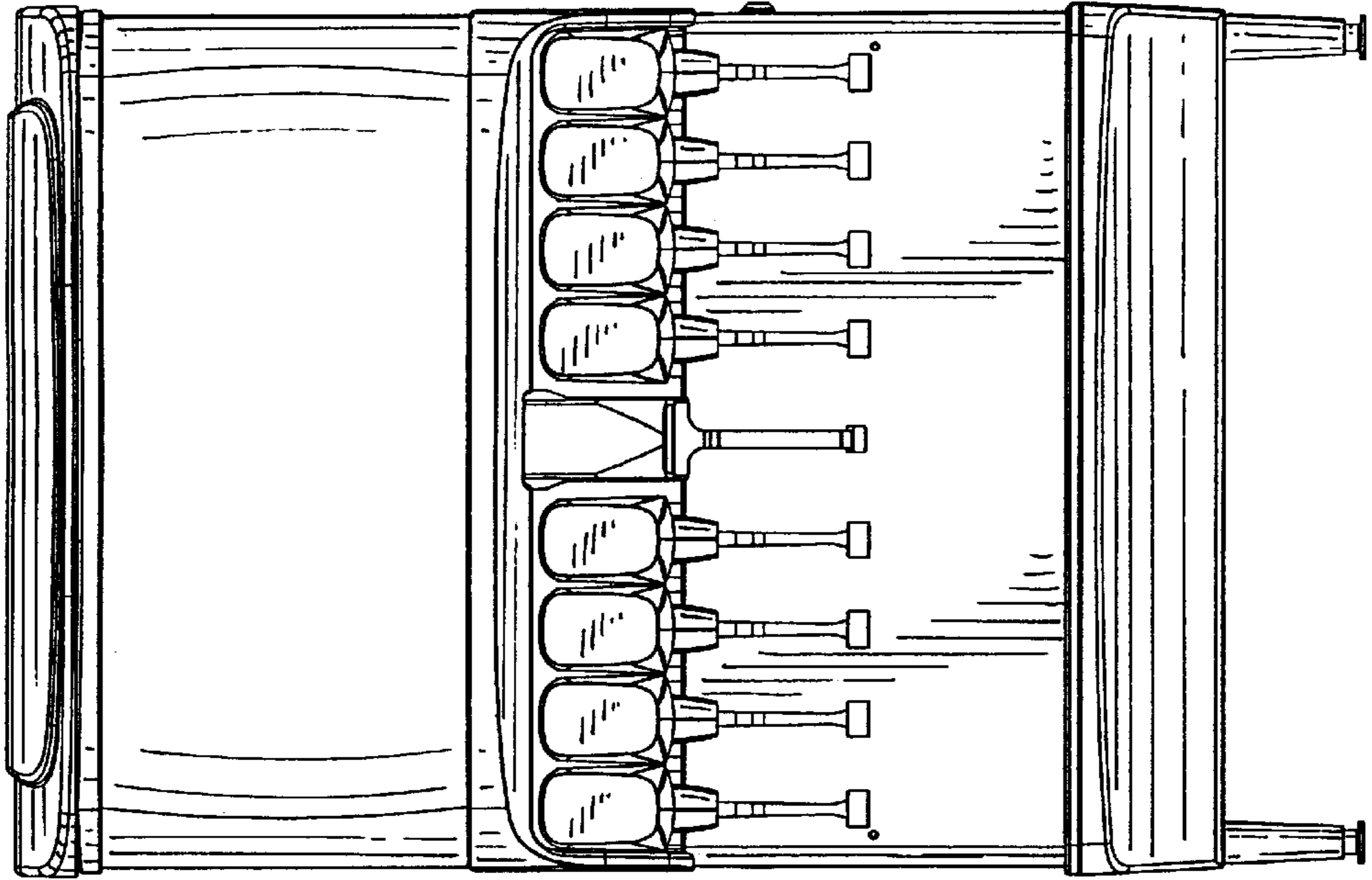

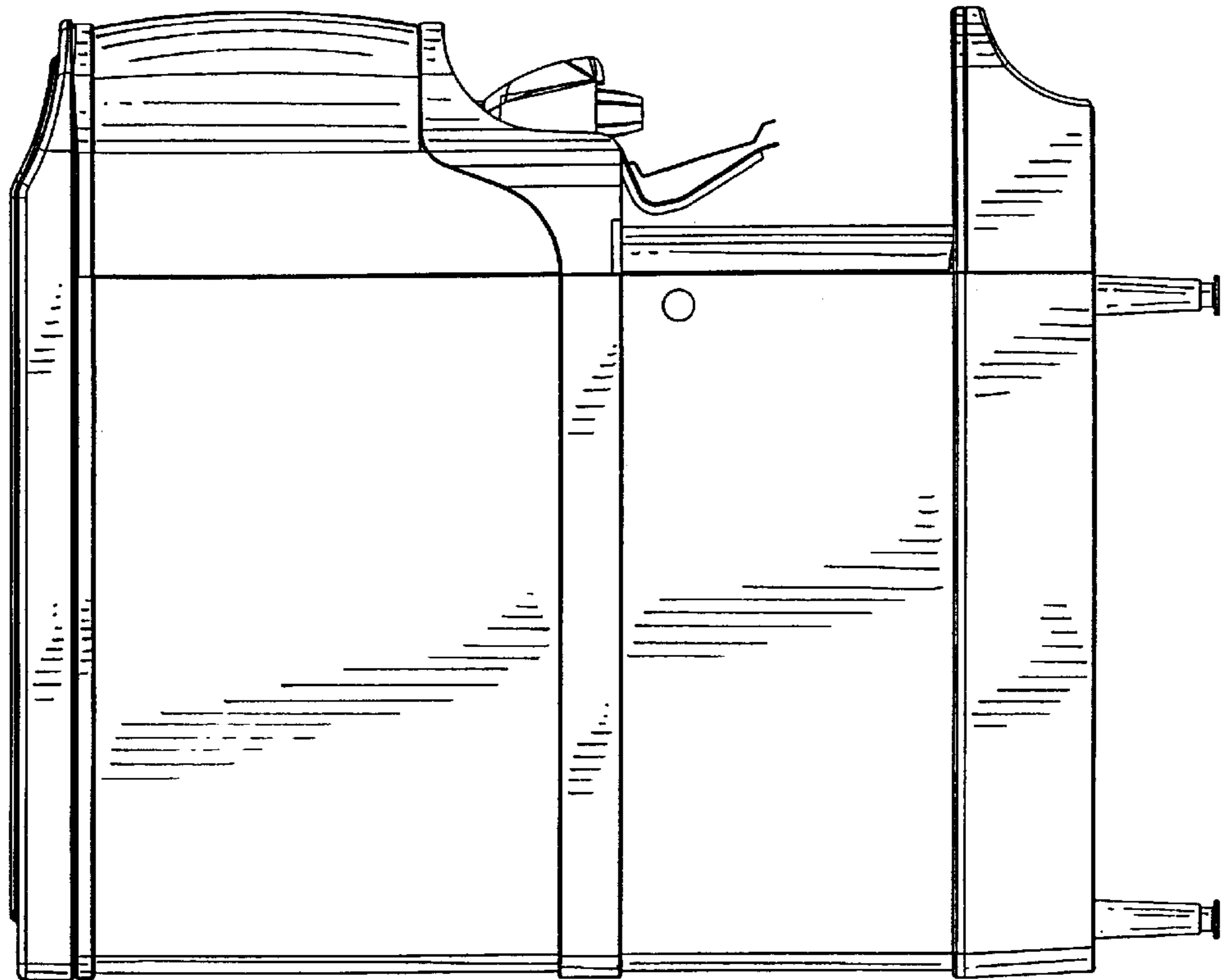

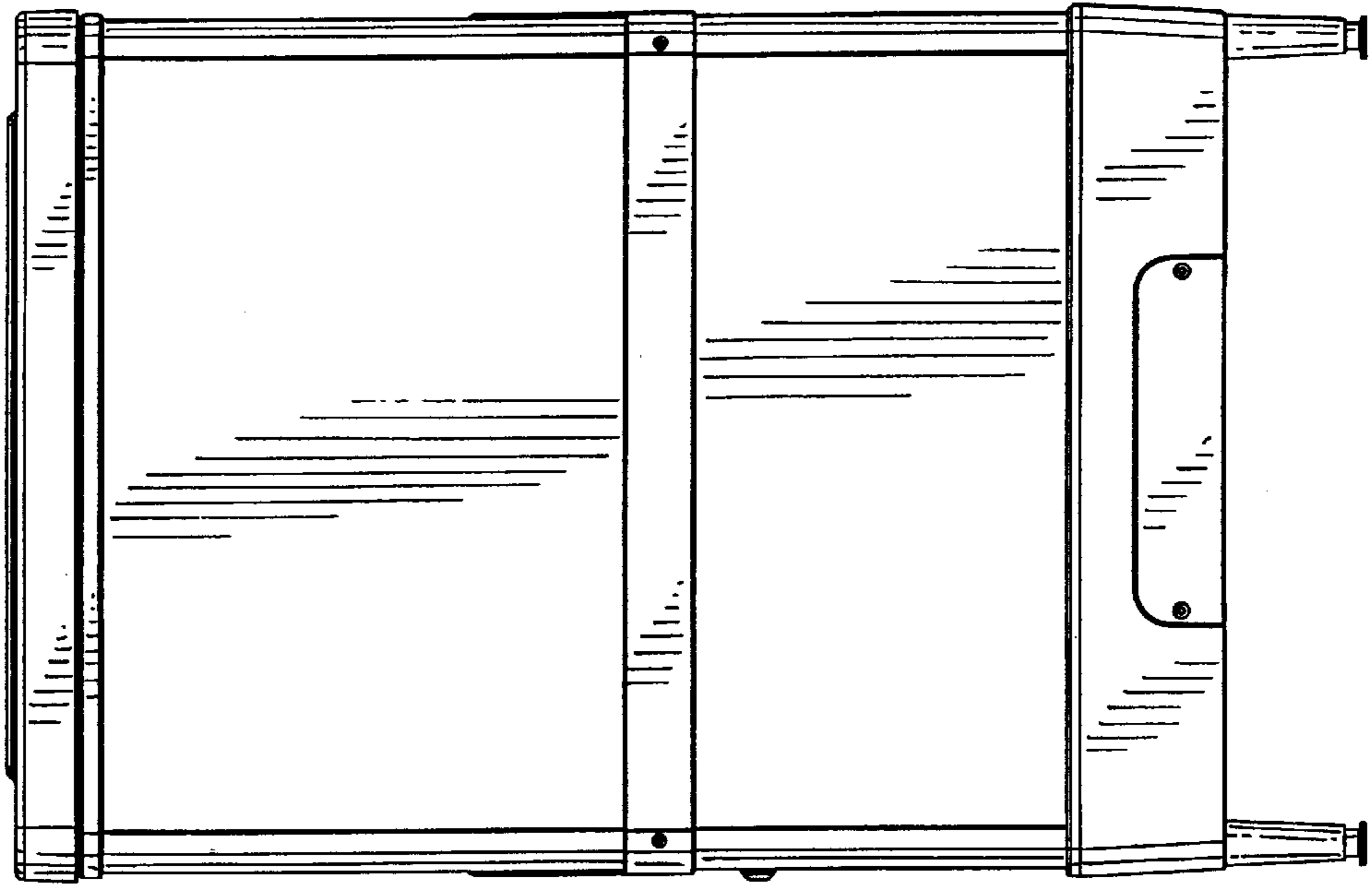

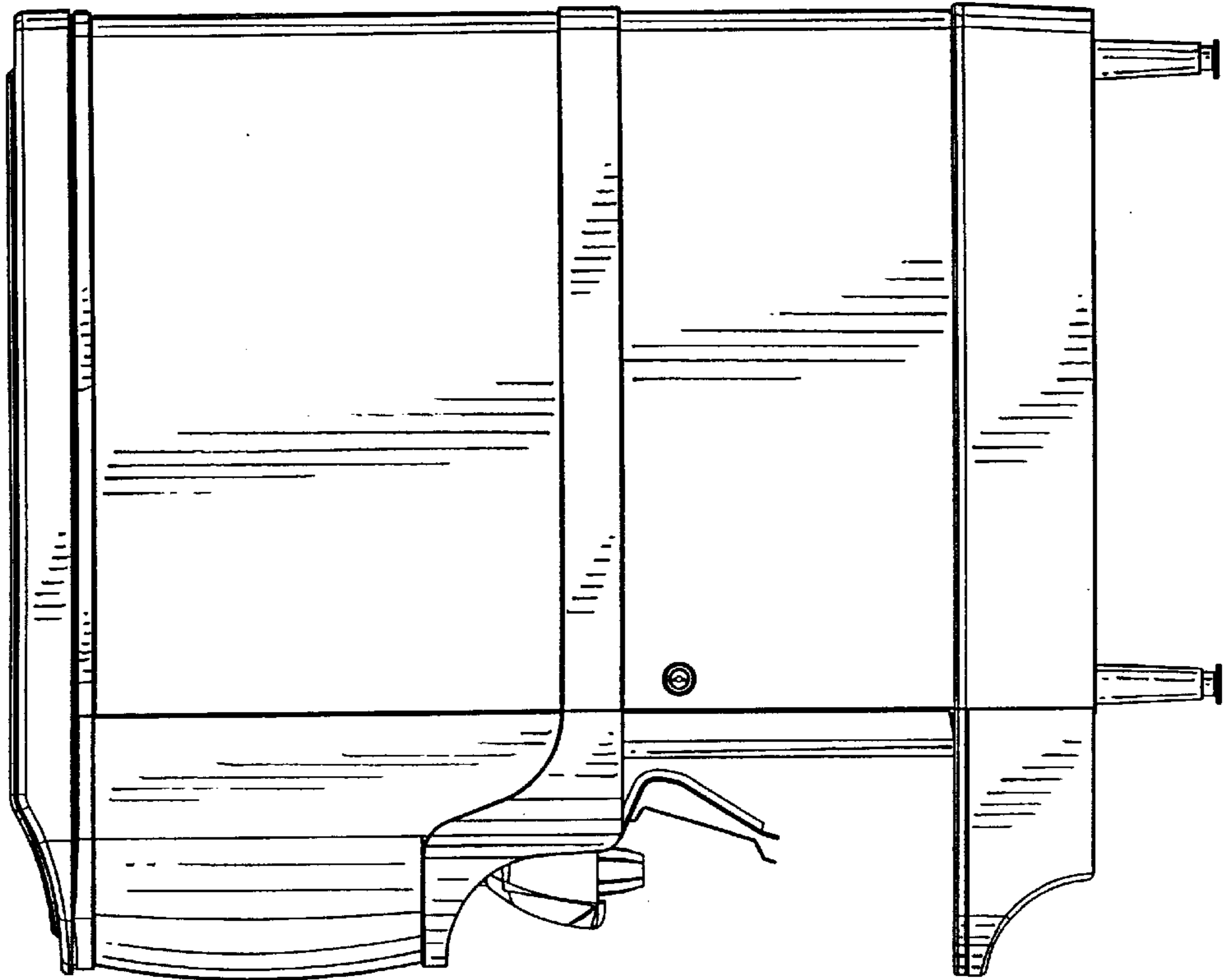

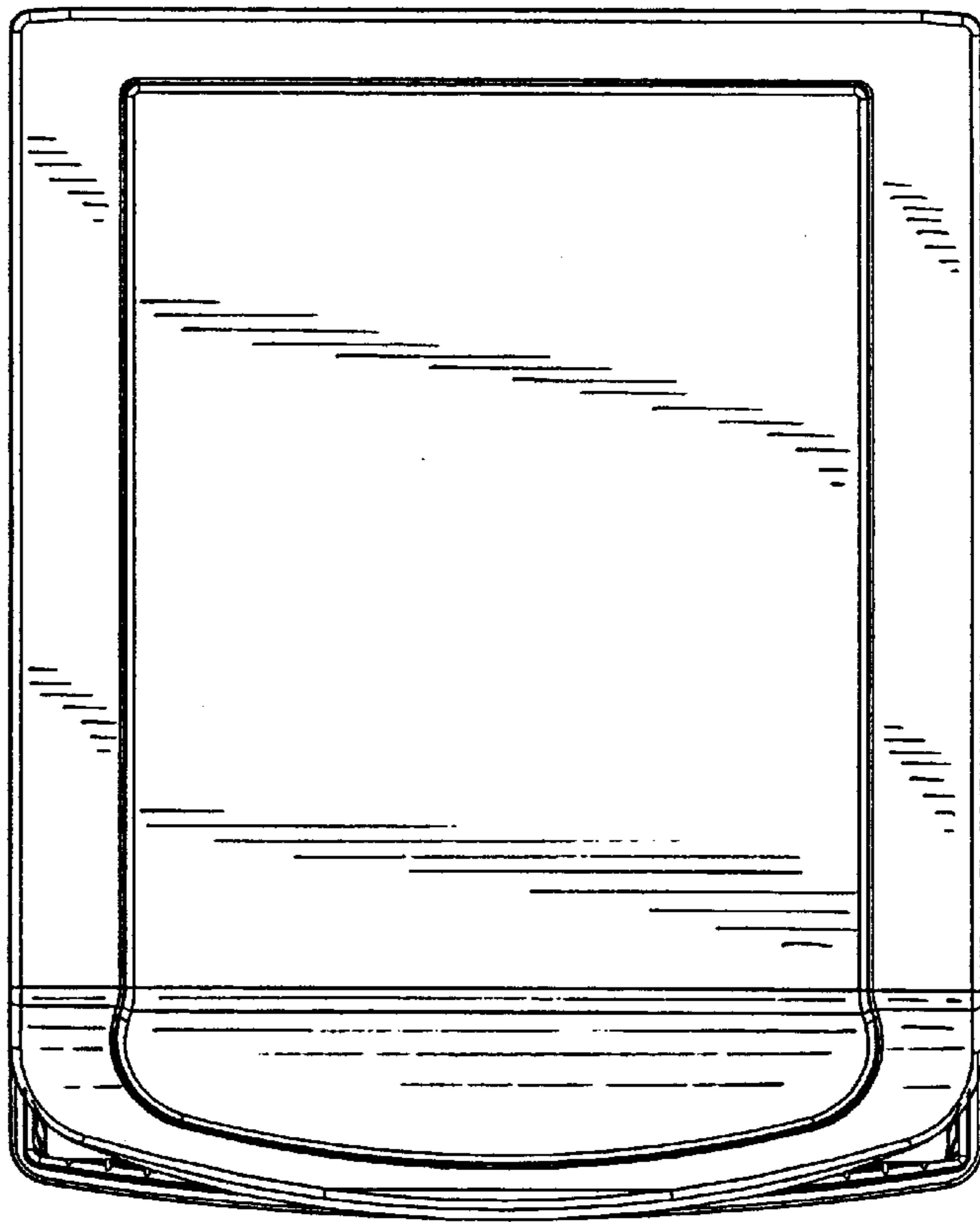

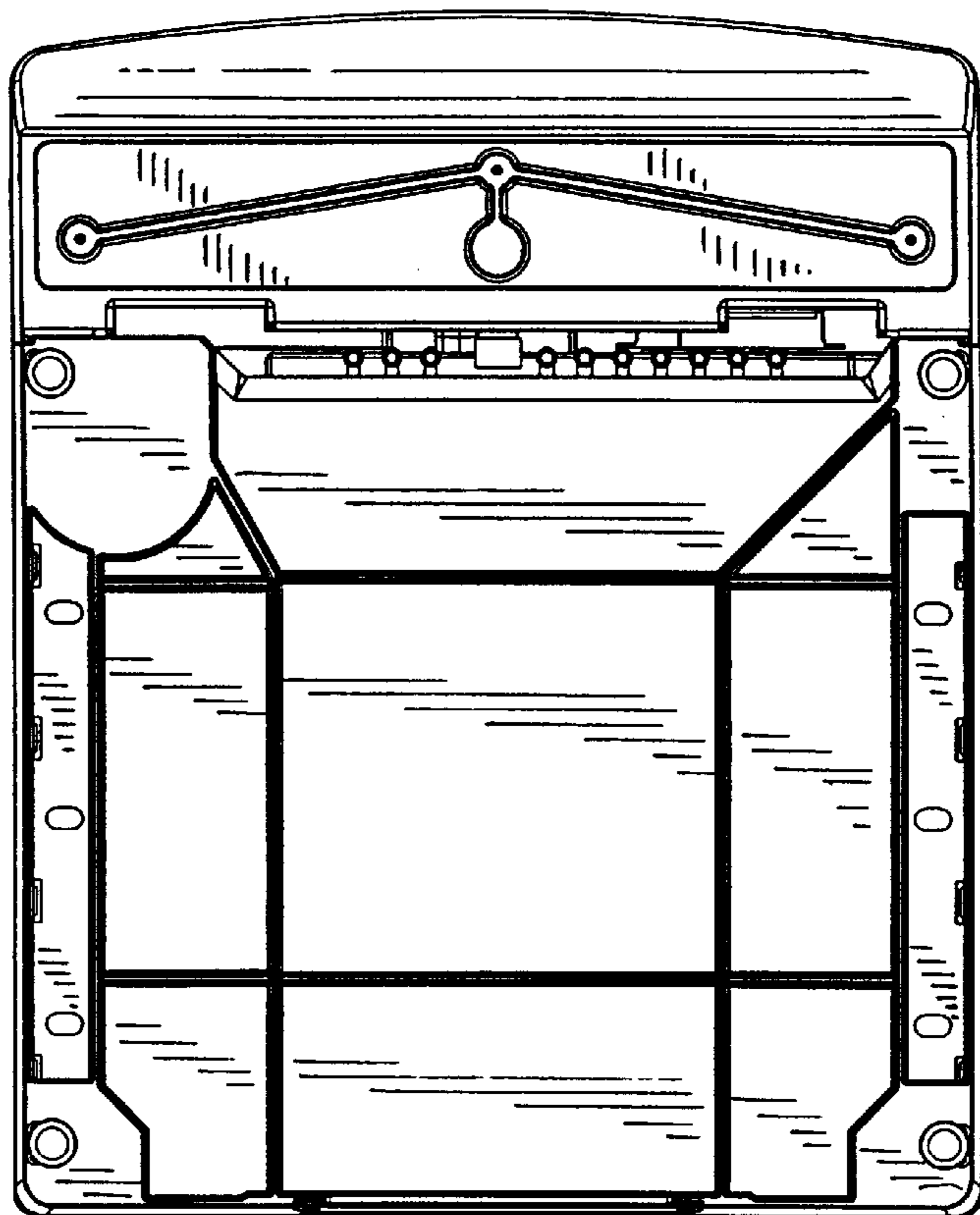

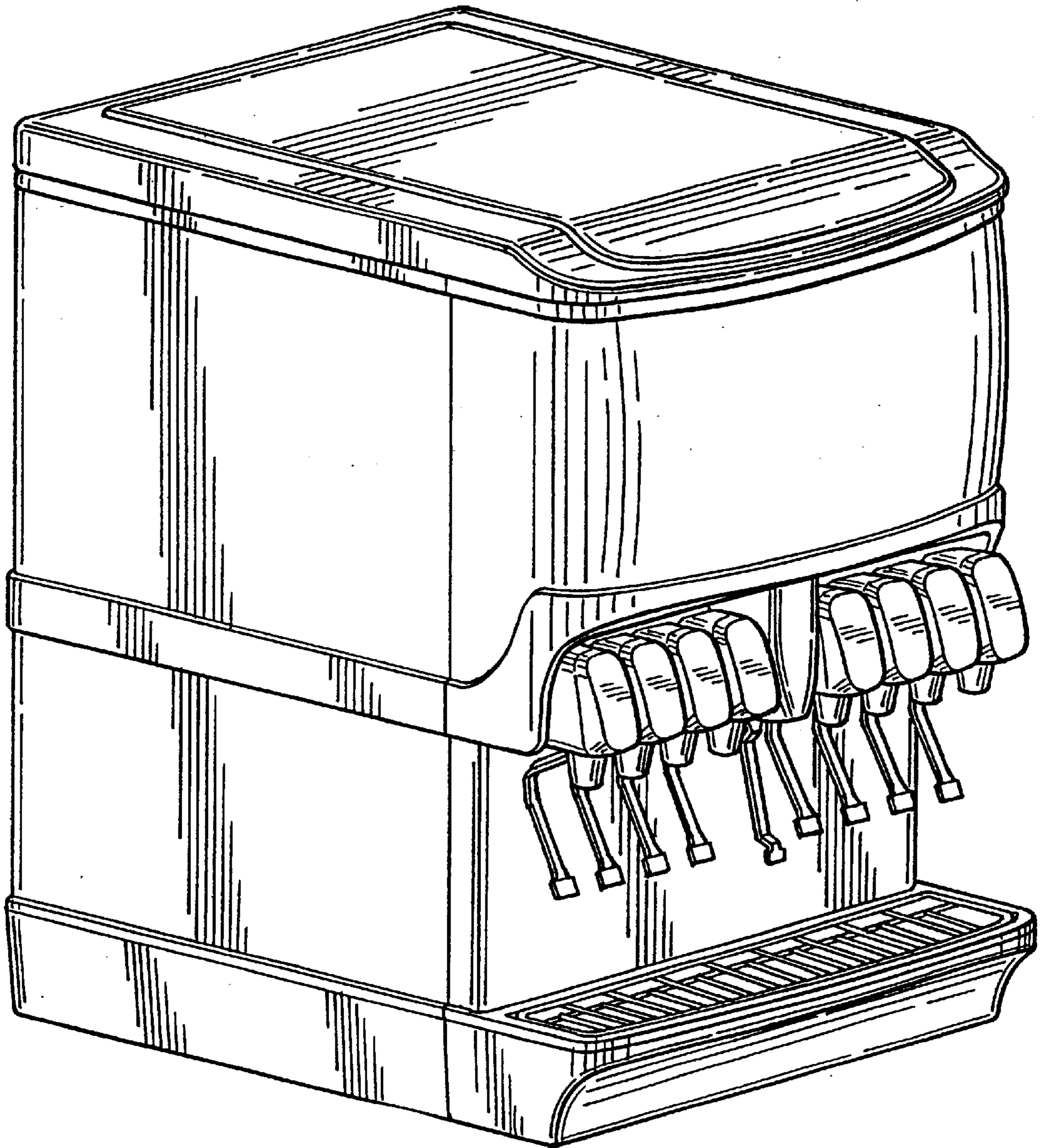

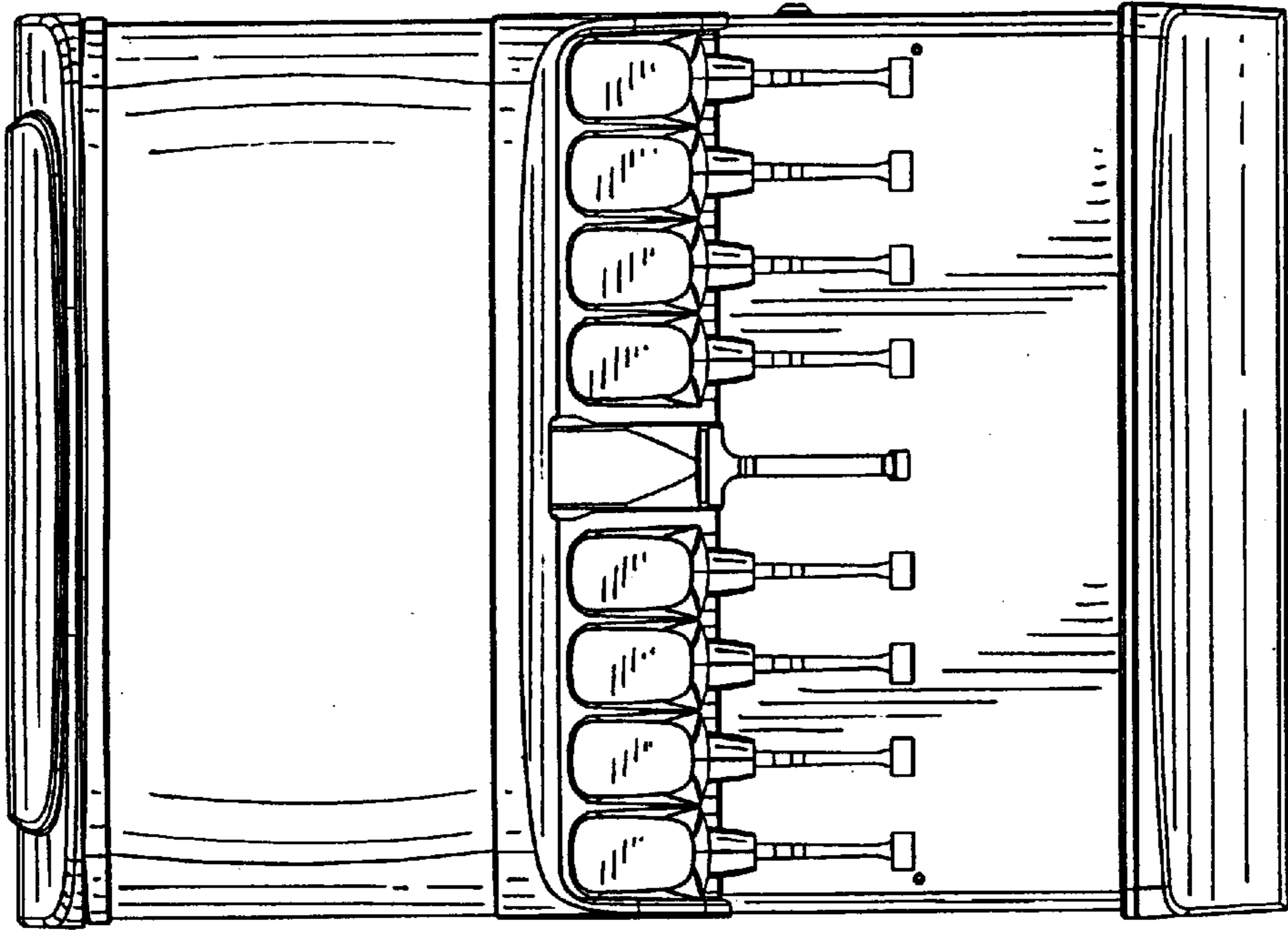

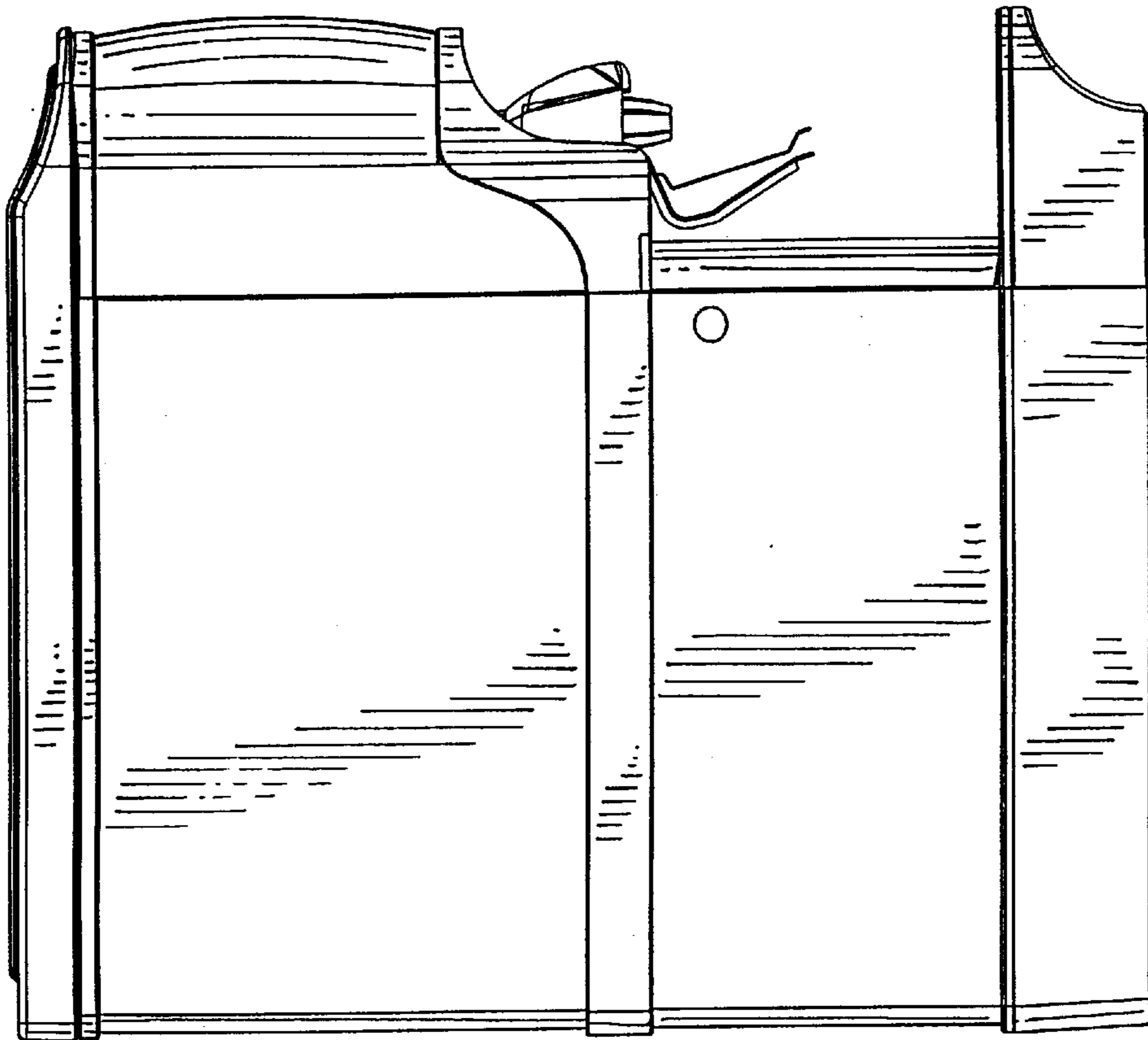

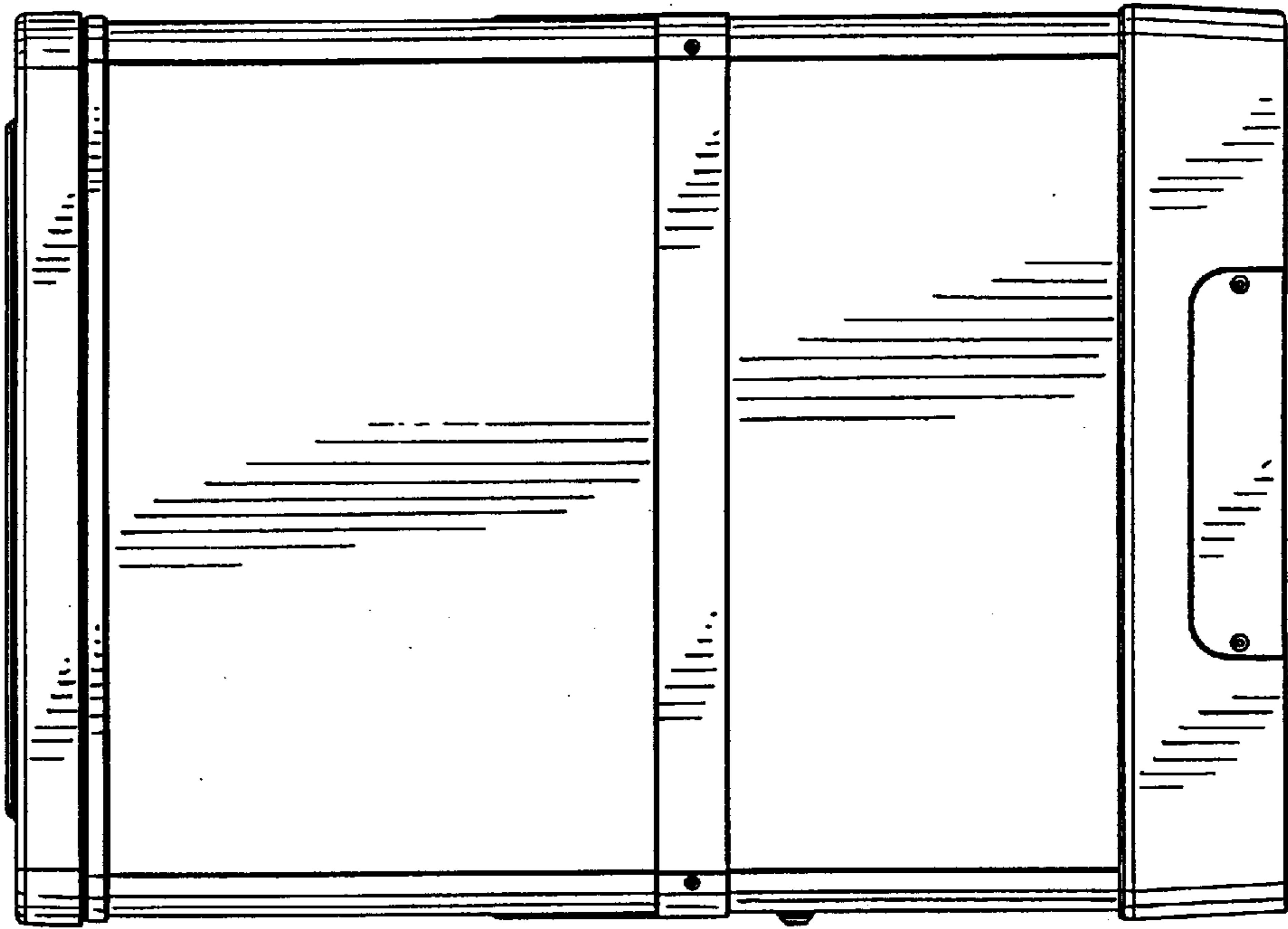

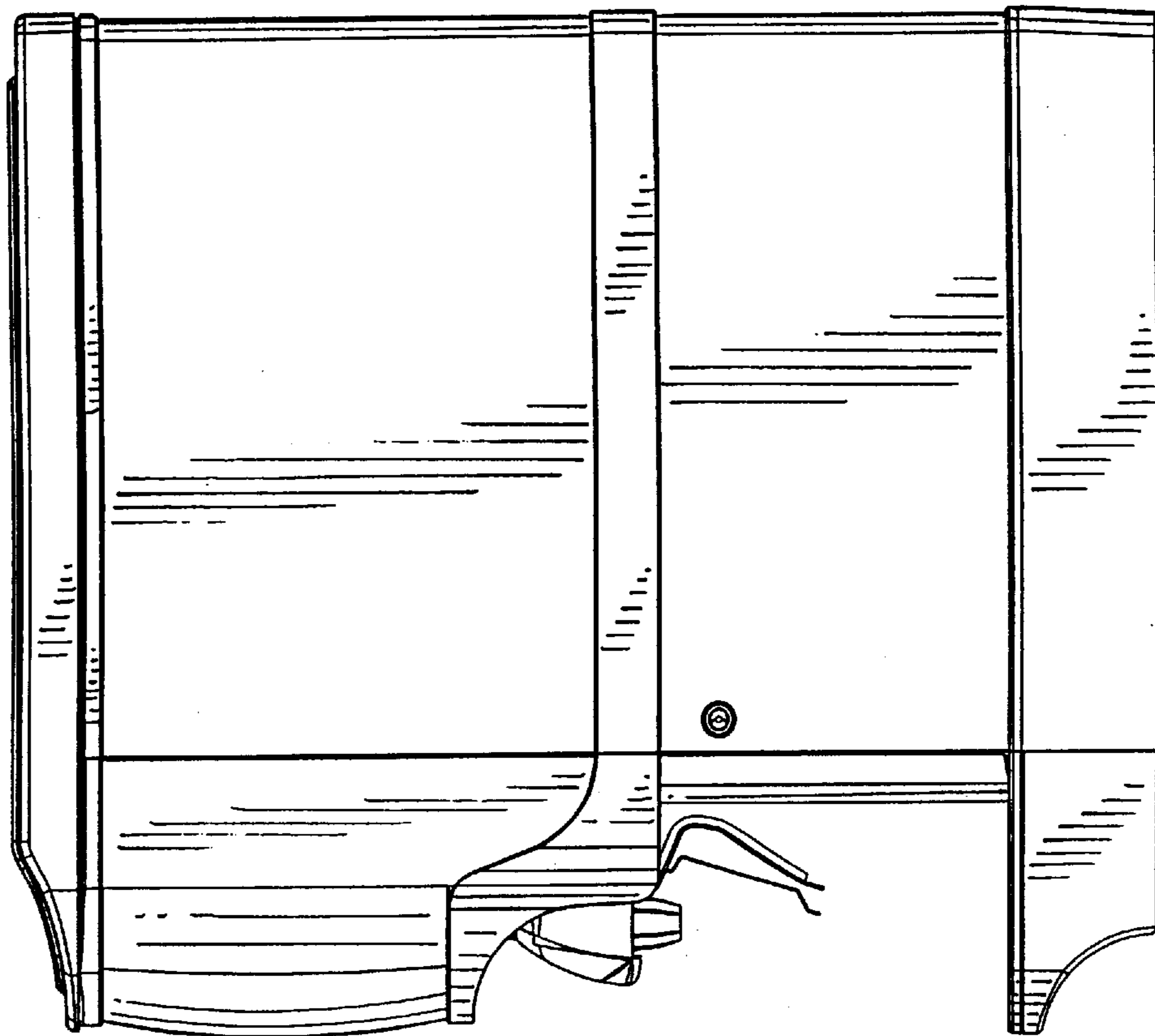

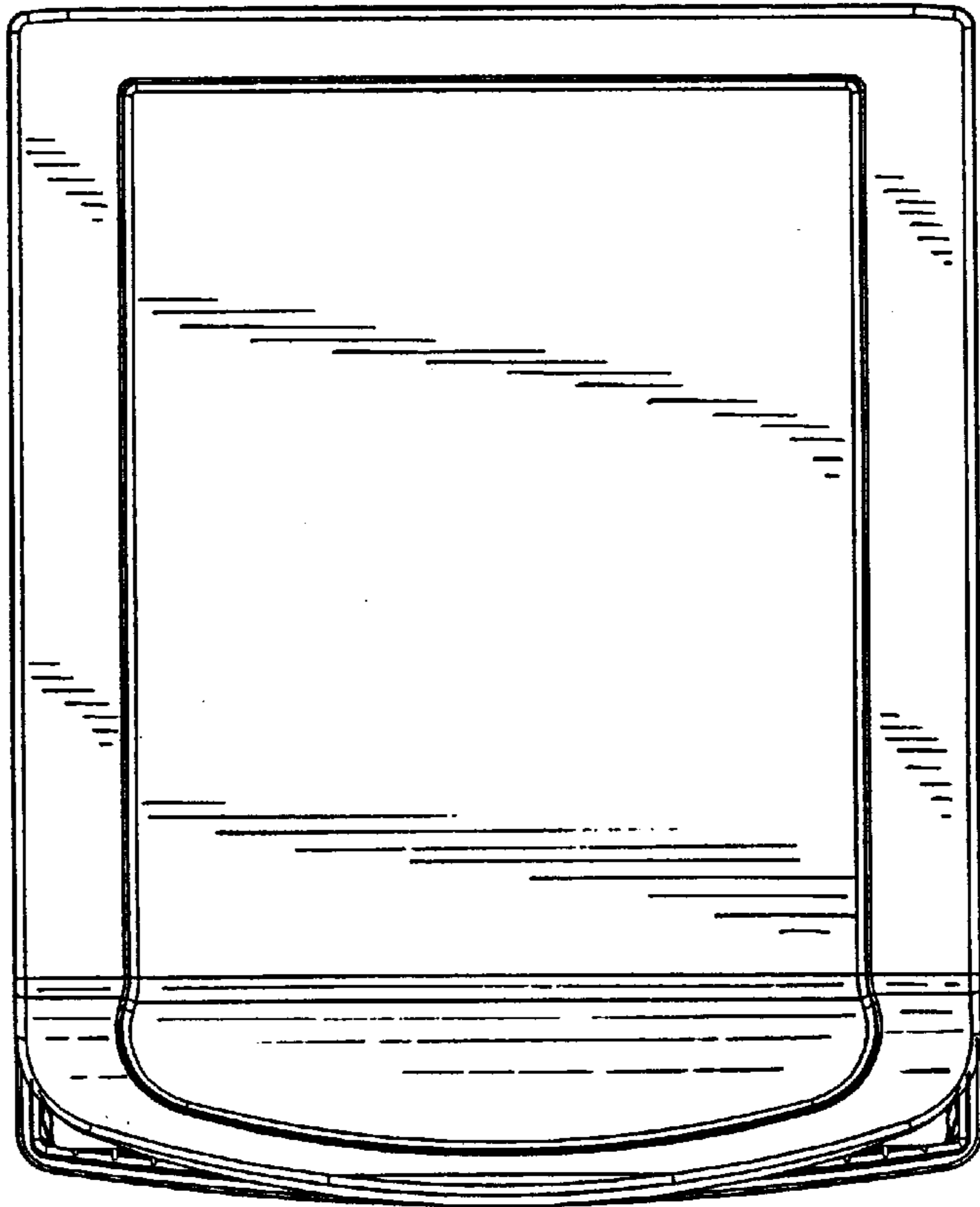
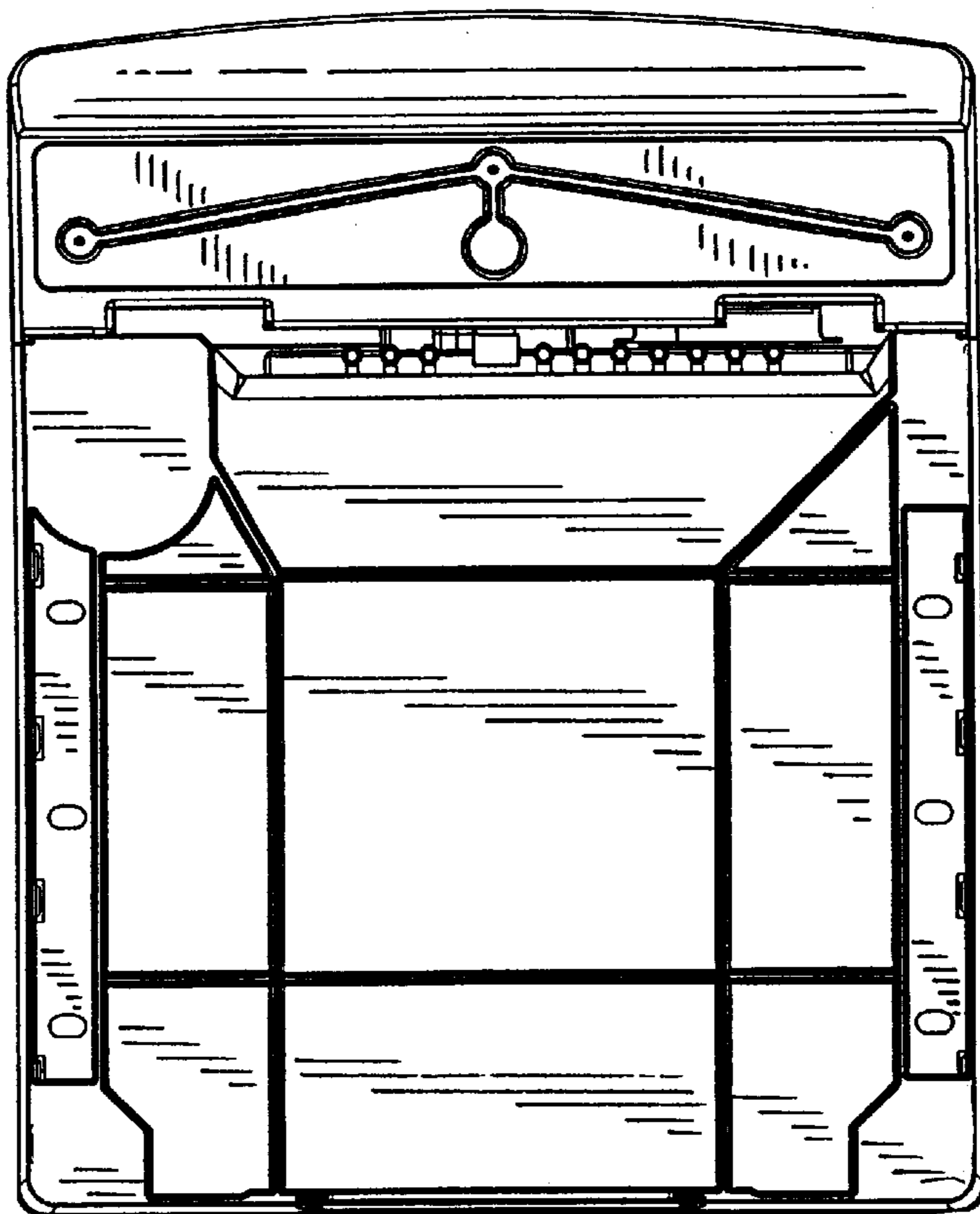
