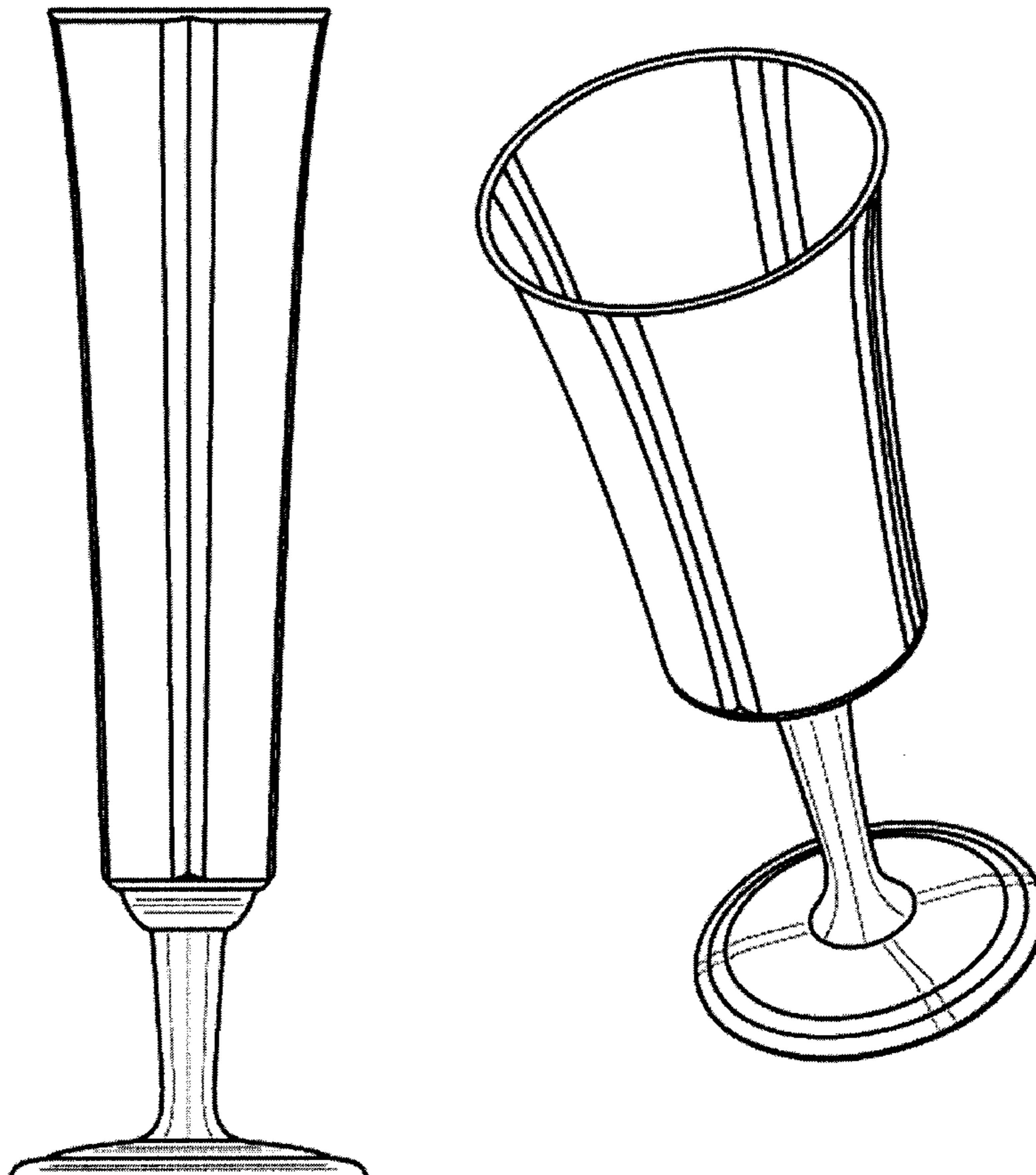
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a side view of our one-piece flute with new design; FIG. 2 is a perspective view of a flute with our new design; FIG. 3 is a top view of a flute with our new design; FIG. 4 is a bottom view of a flute with our new design; FIG. 5 is a side view of a goblet with our new design; FIG. 6 is a perspective view of a goblet with our new design; FIG. 7 is a top view of a goblet with our new design; and, FIG. 8 is a bottom view of a goblet with our new design.

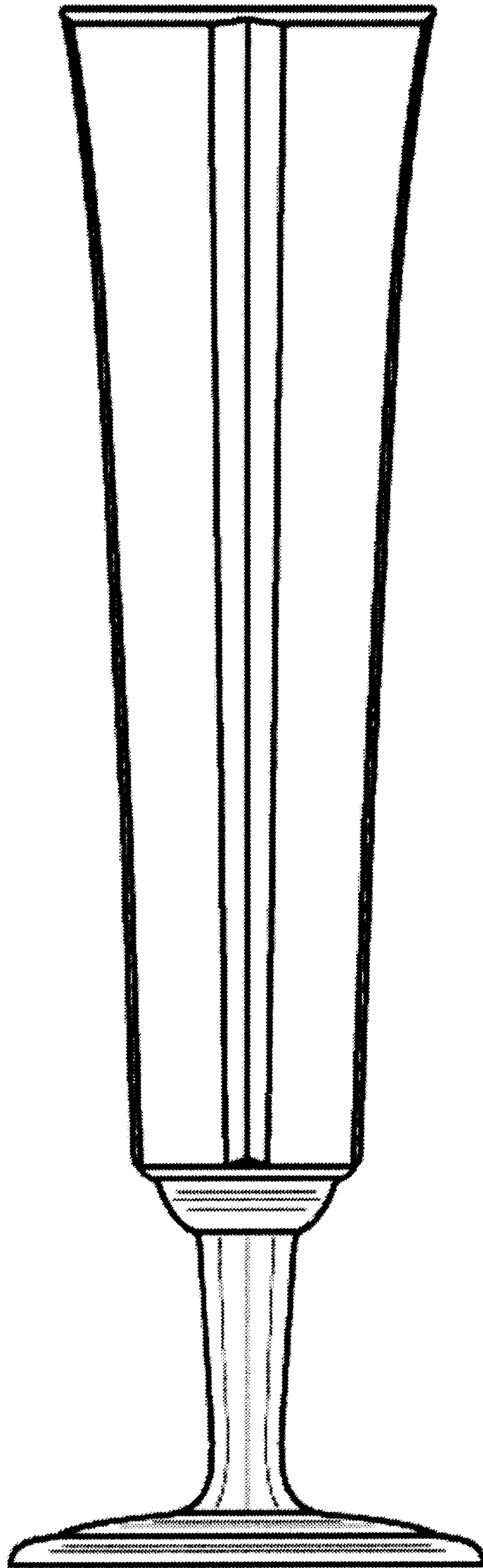

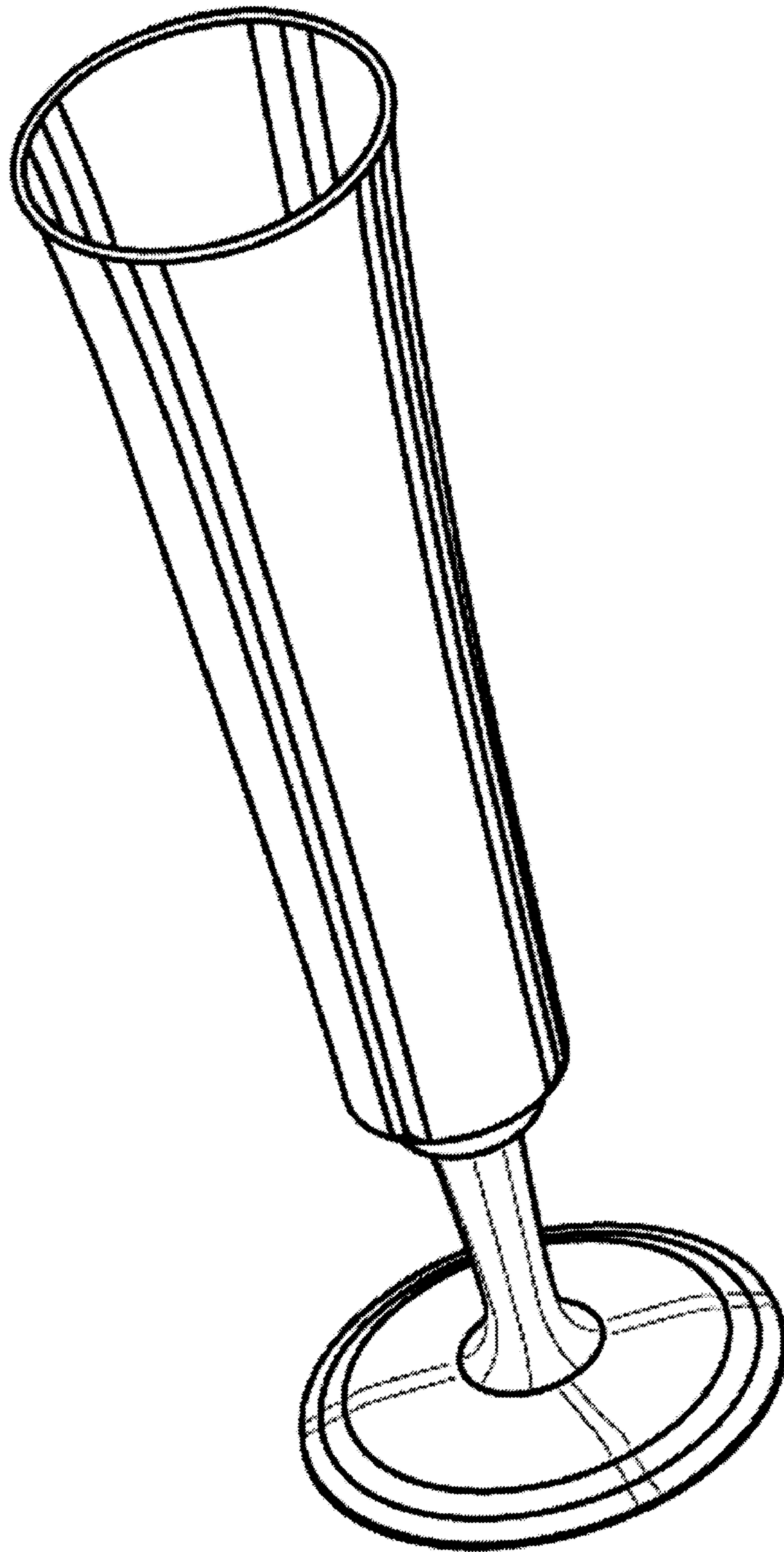

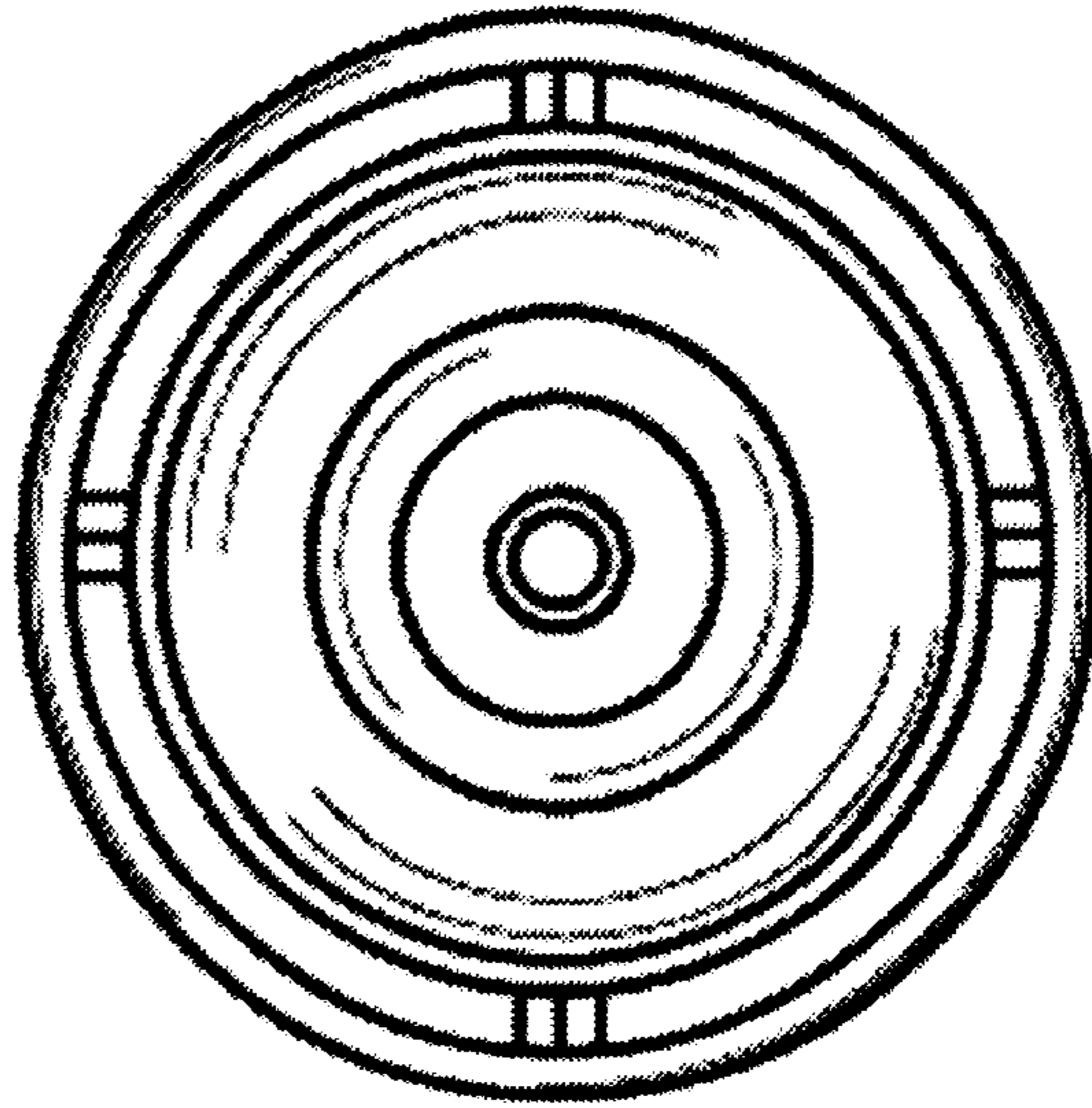

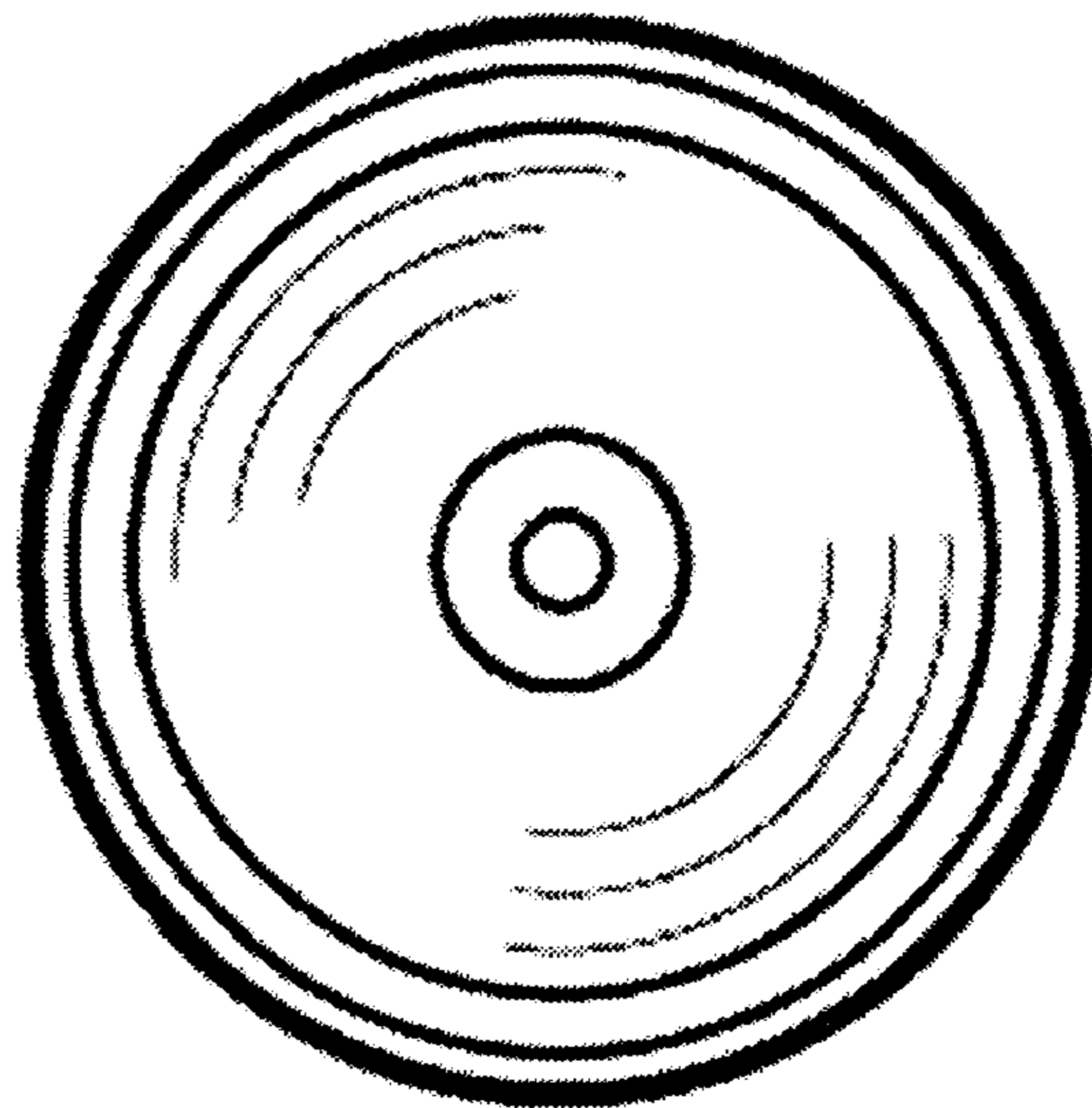

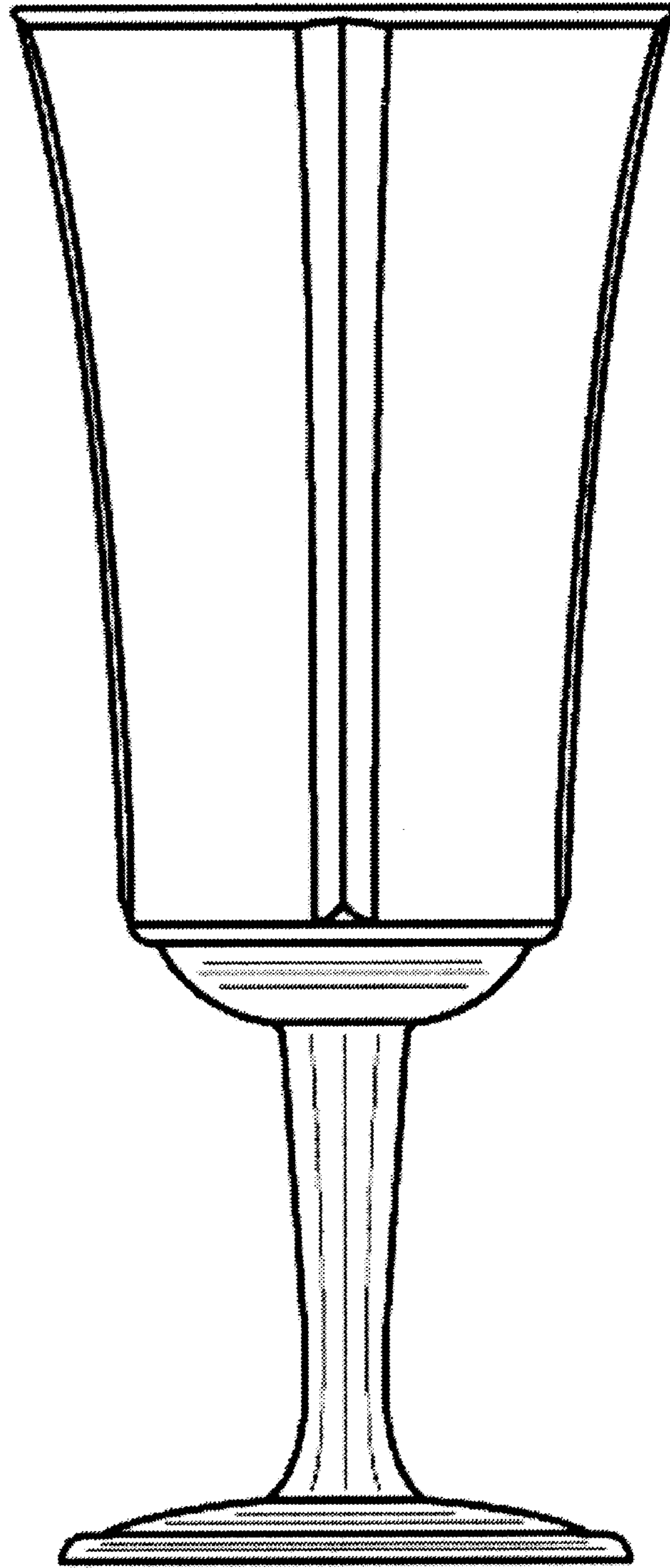

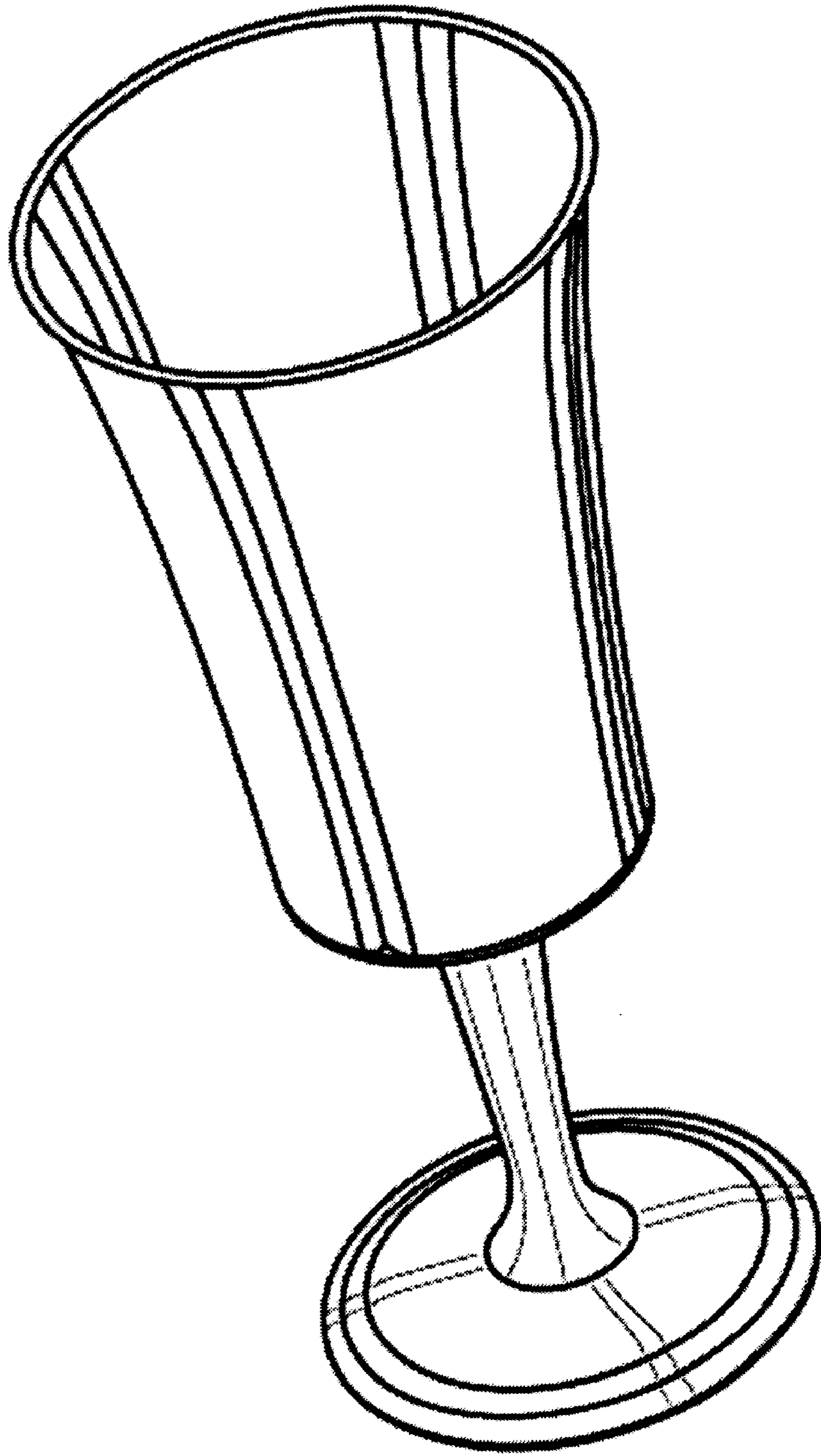

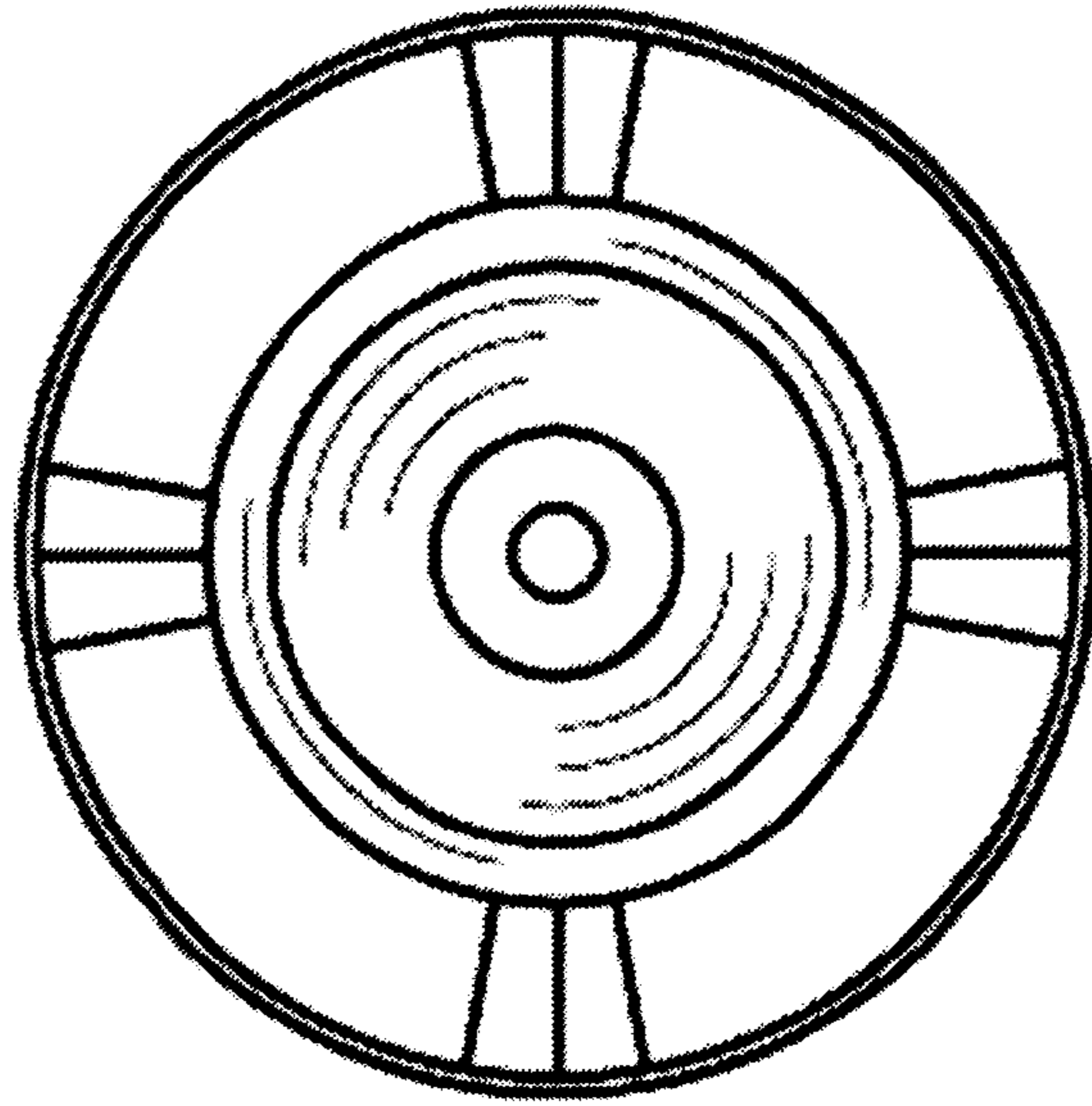

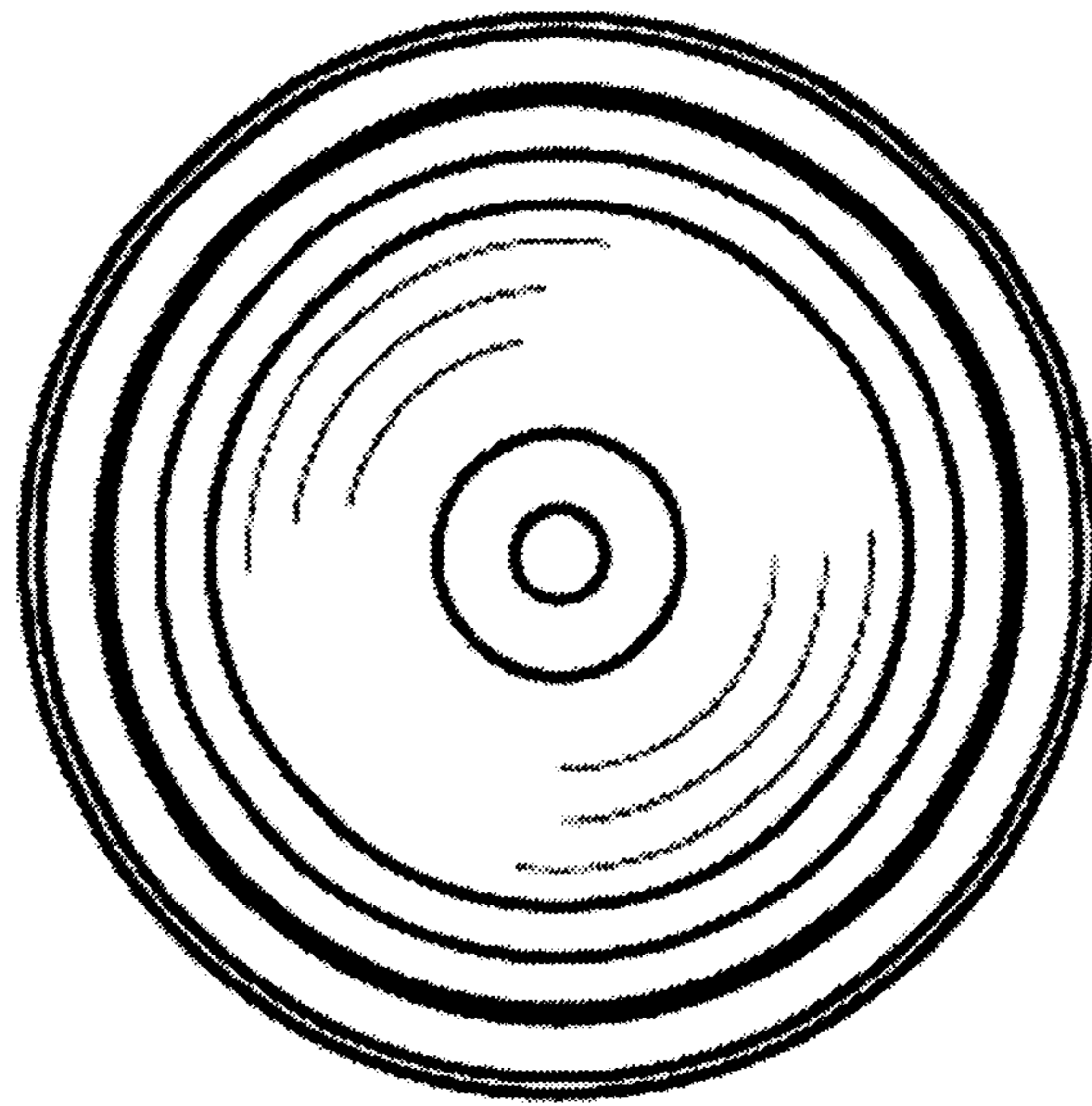
