FIG. 10 is a rear view of the embodiment of FIG. 6.

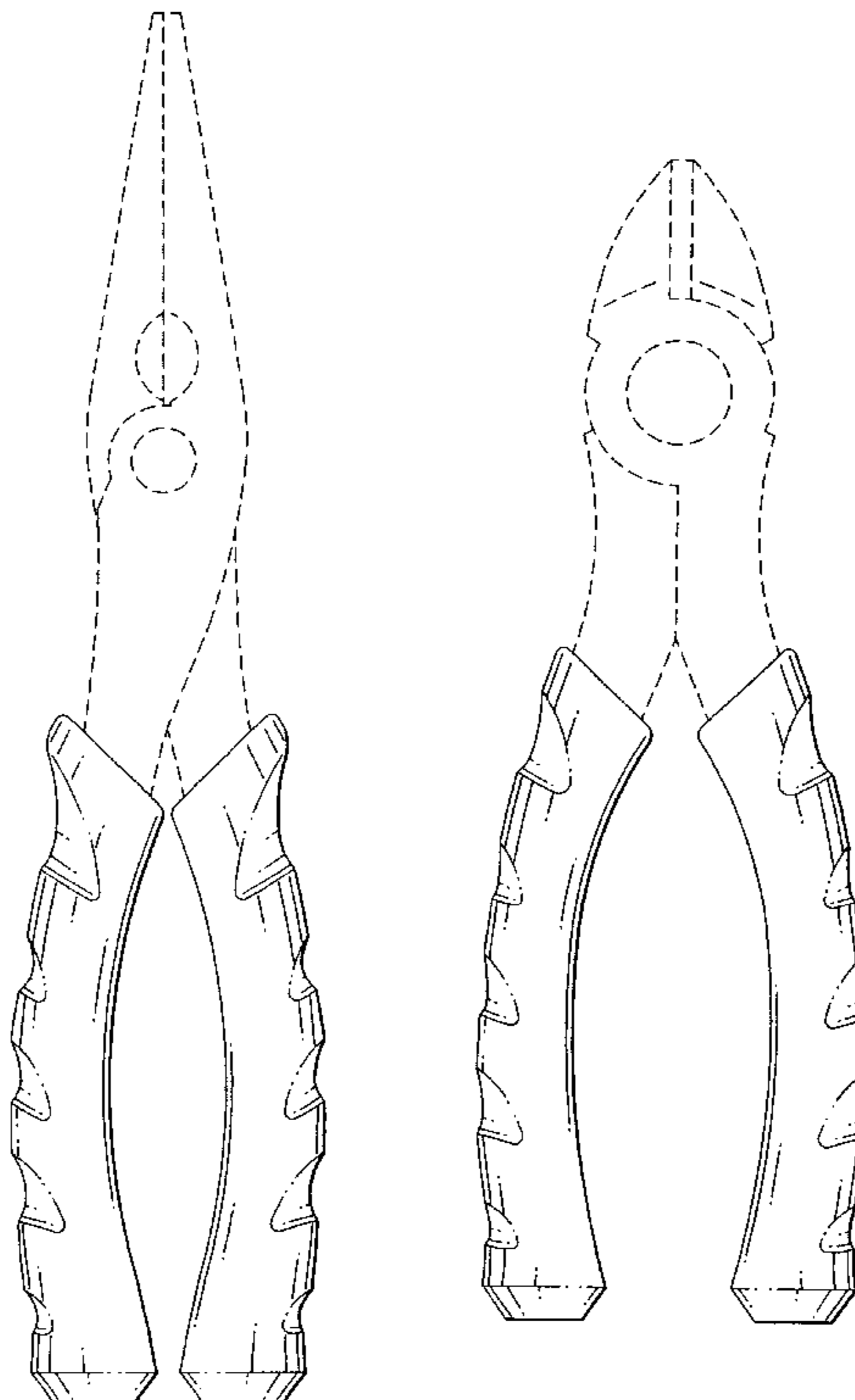

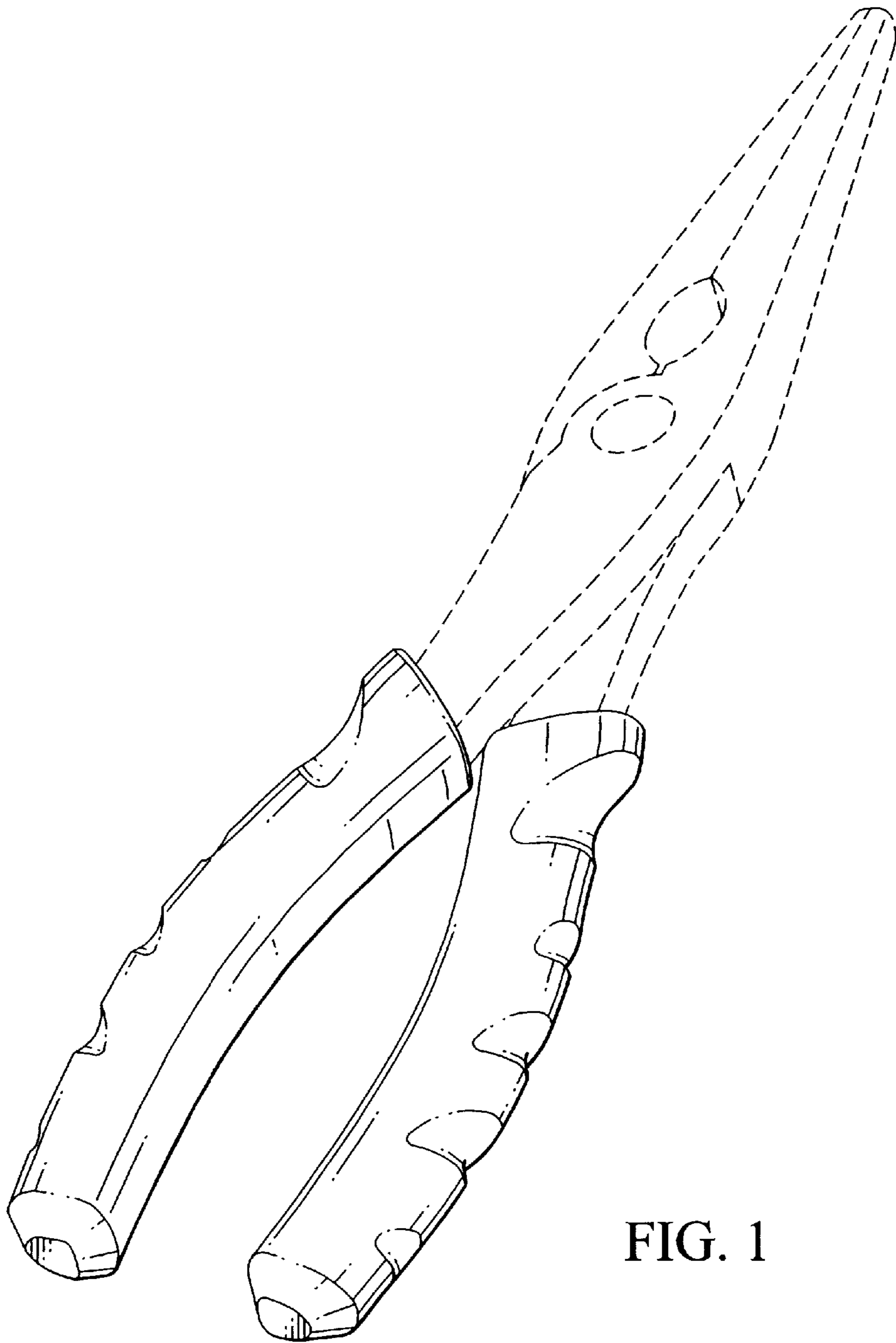
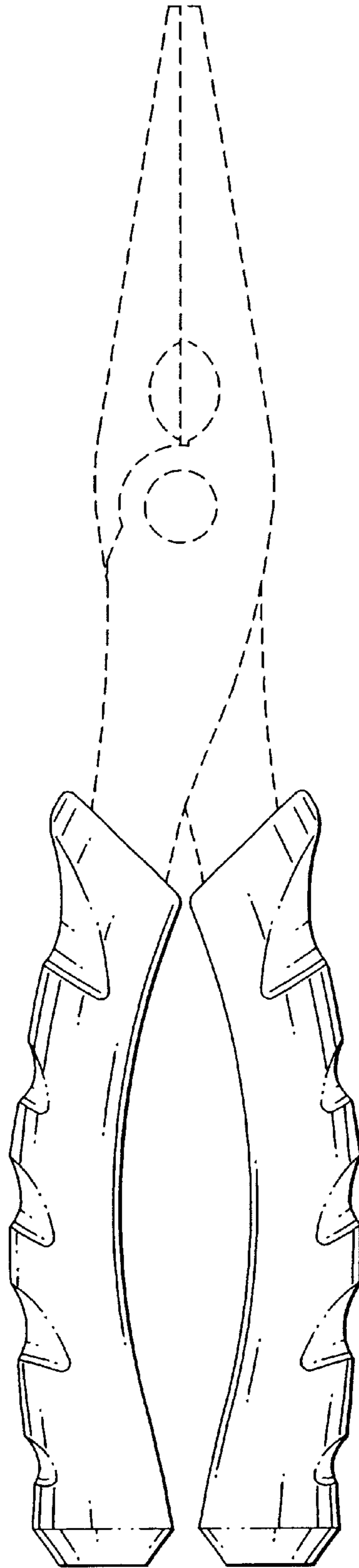

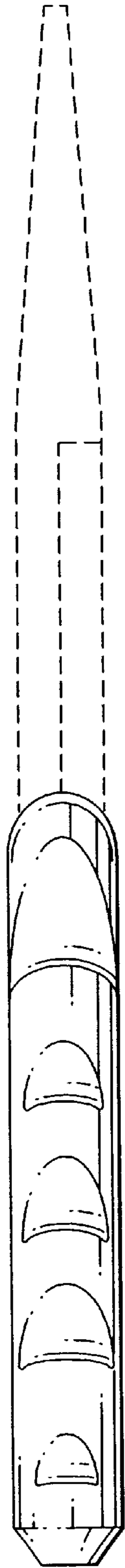

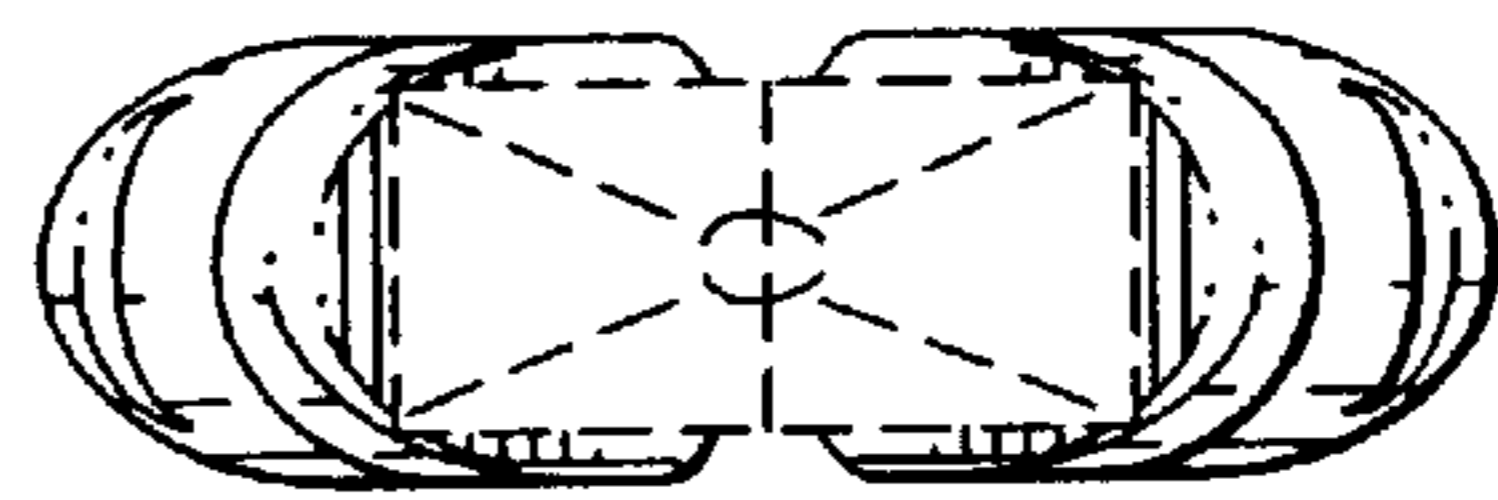

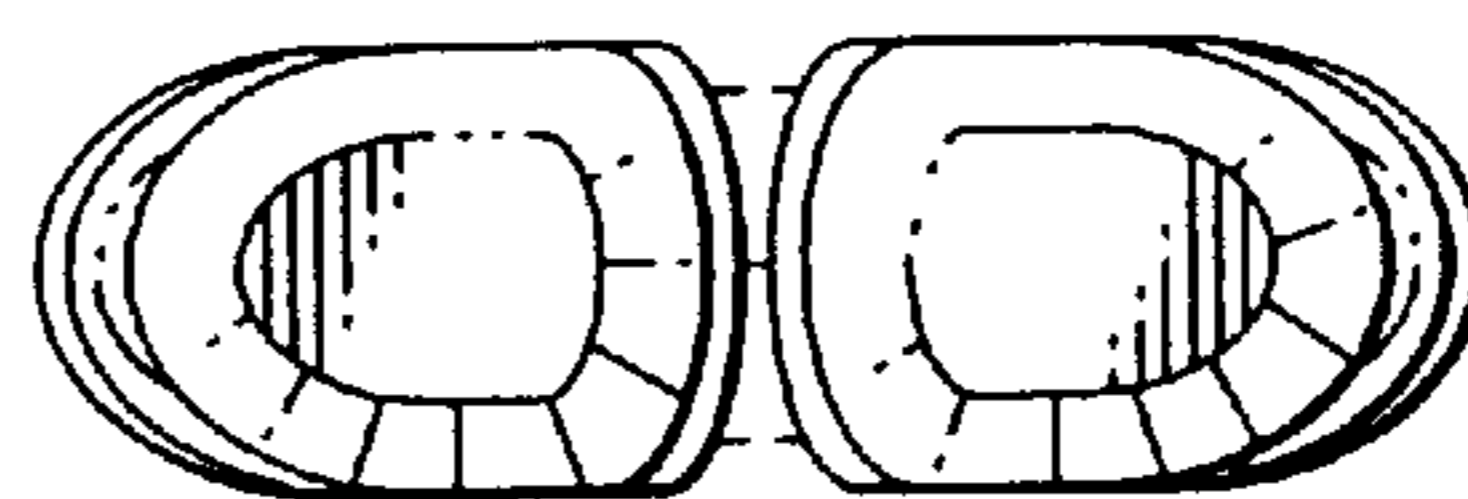

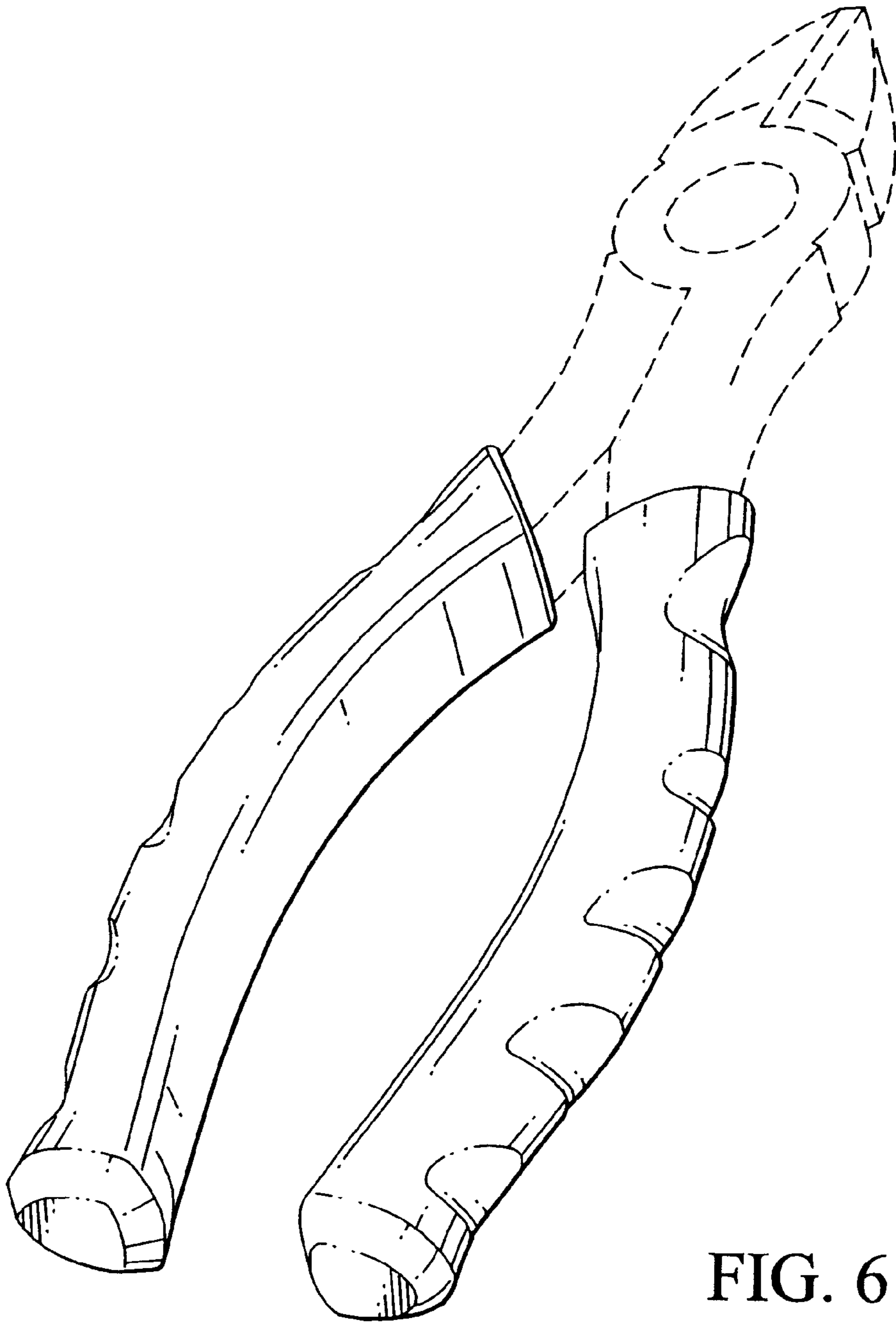
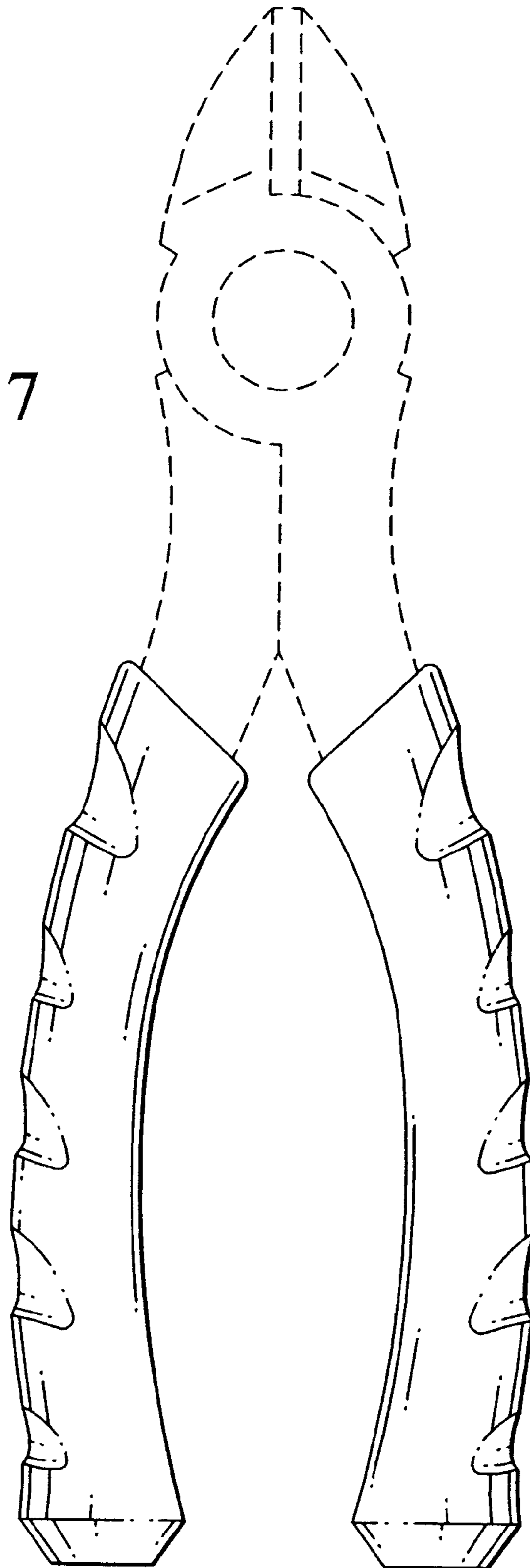

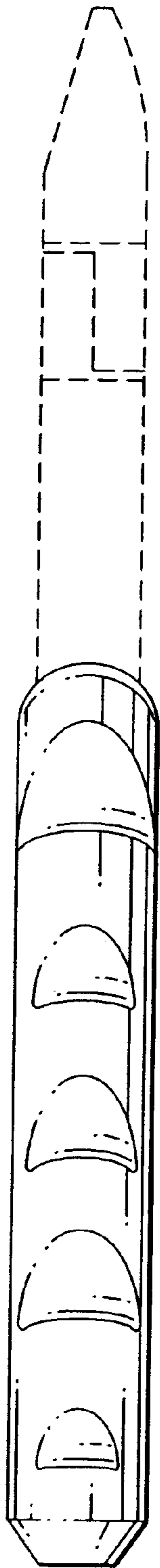

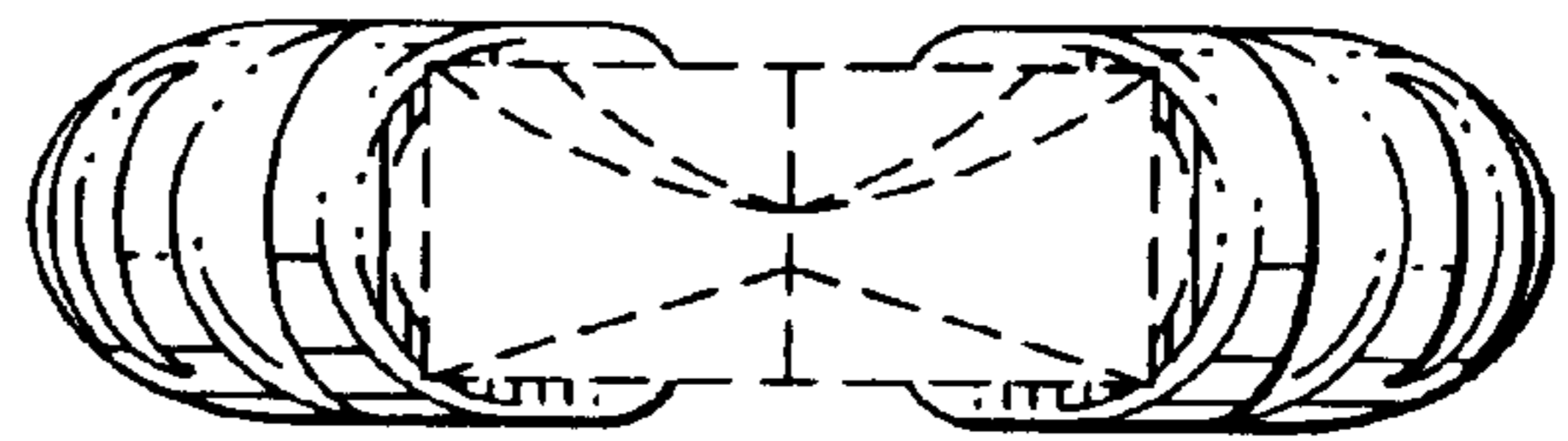

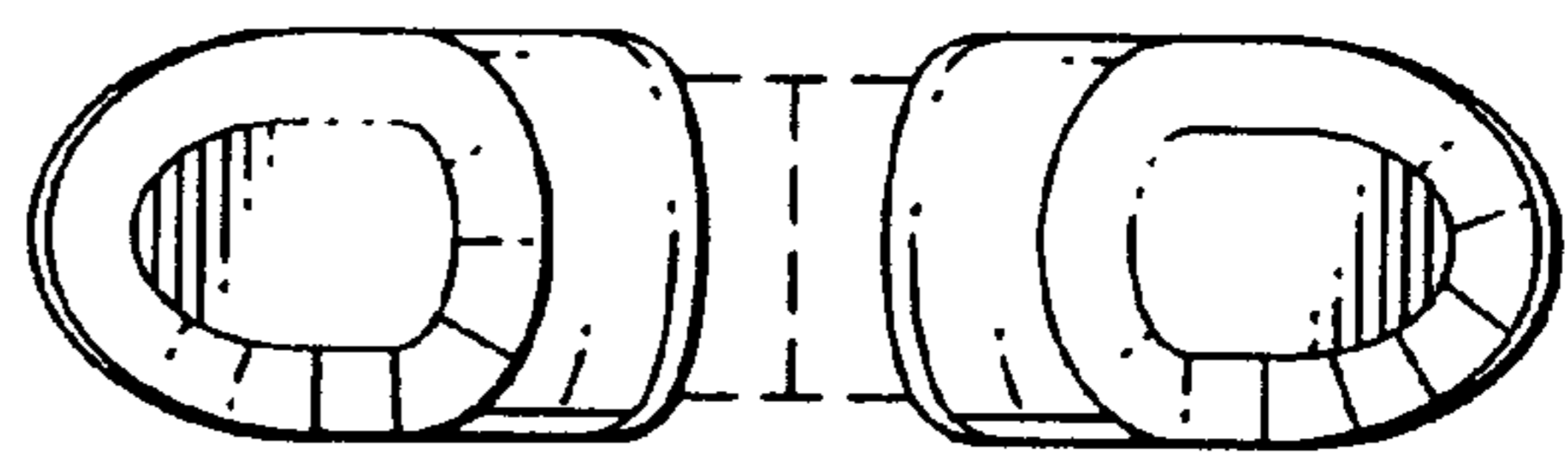
