(57) **CLAIM**

The ornamental design for a plastic container with a beaded neck, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, right, top perspective view of a plastic container with a beaded neck according to the present invention;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a right side elevational view thereof;

FIG. 4 is a rear elevational view thereof;

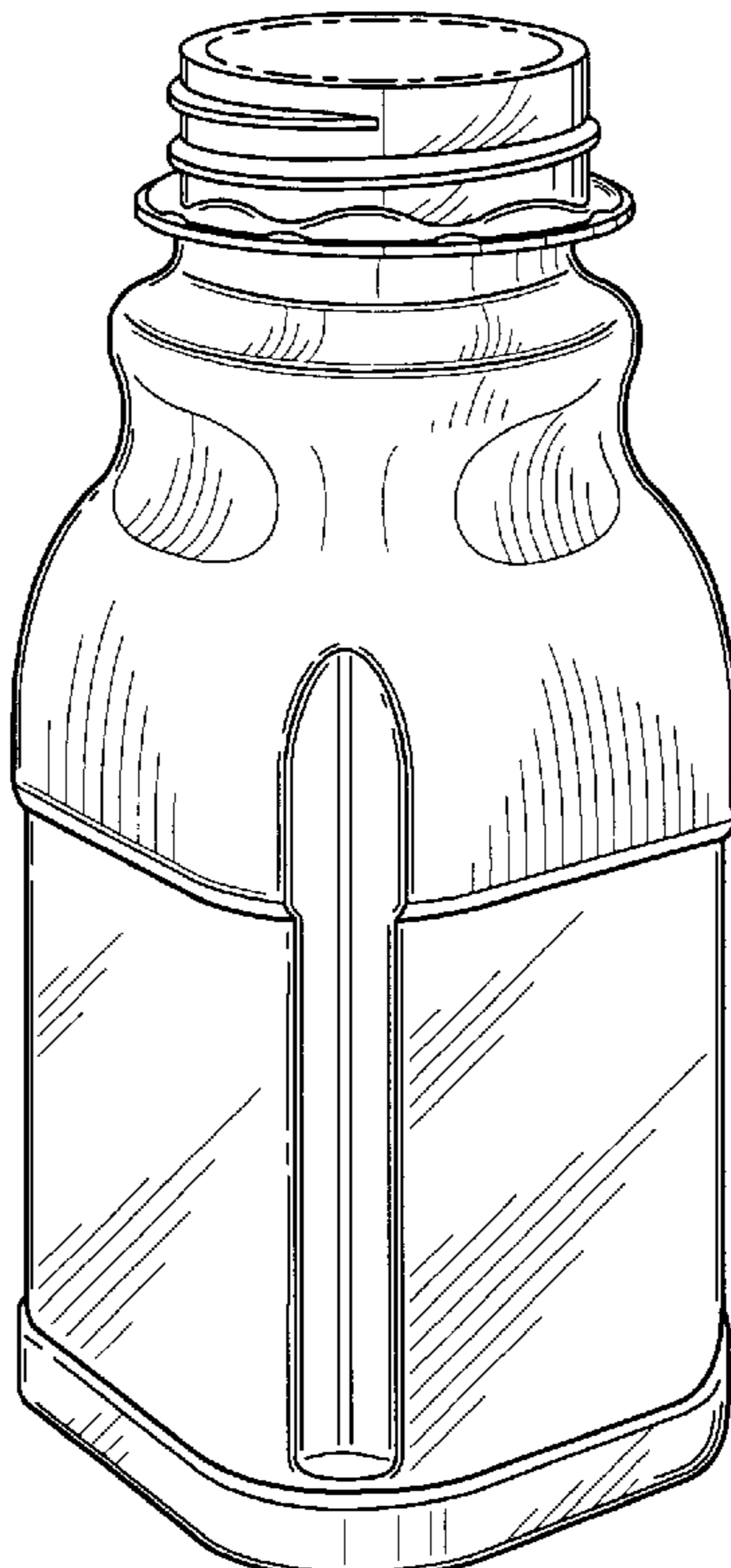
FIG. 5 is a left side elevational view thereof;

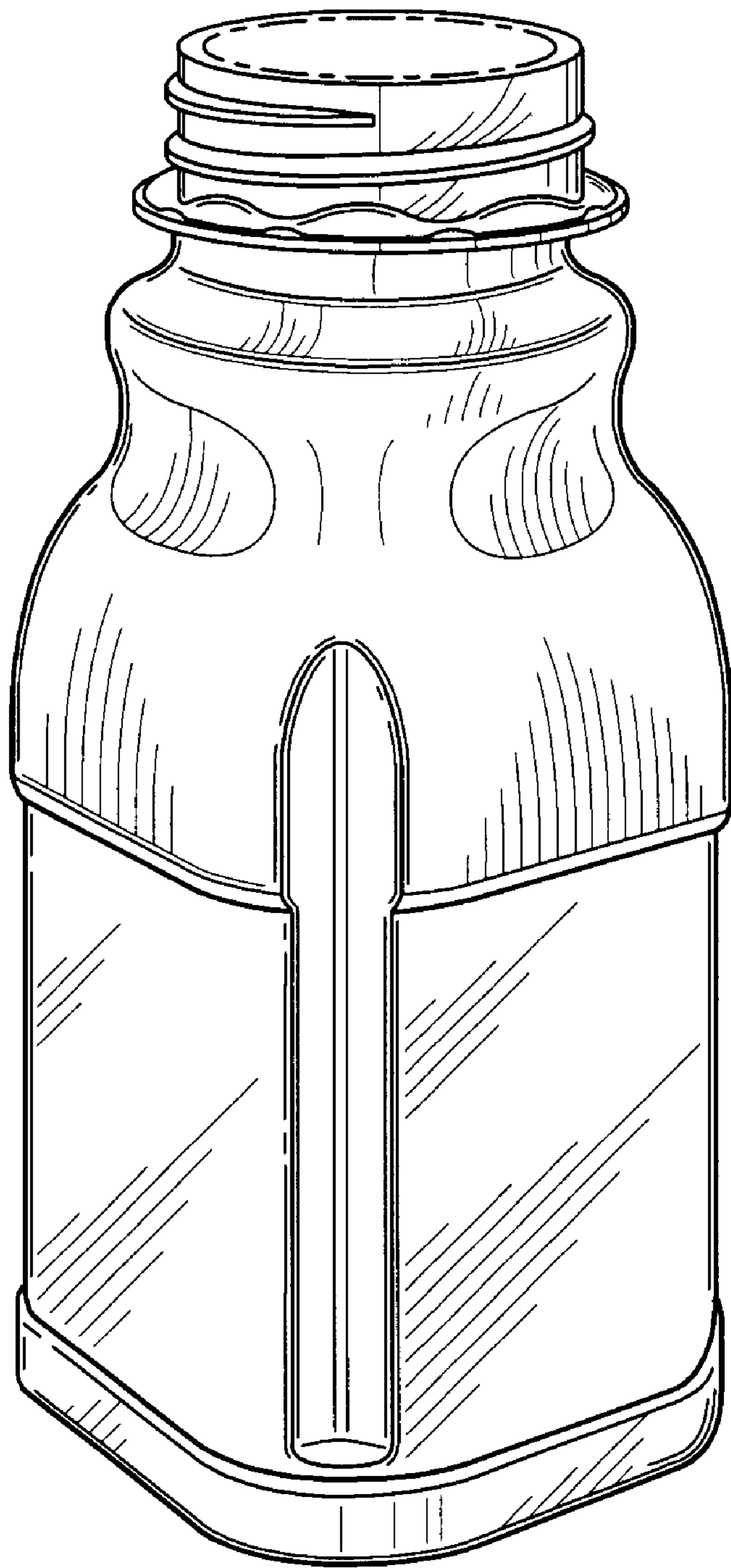

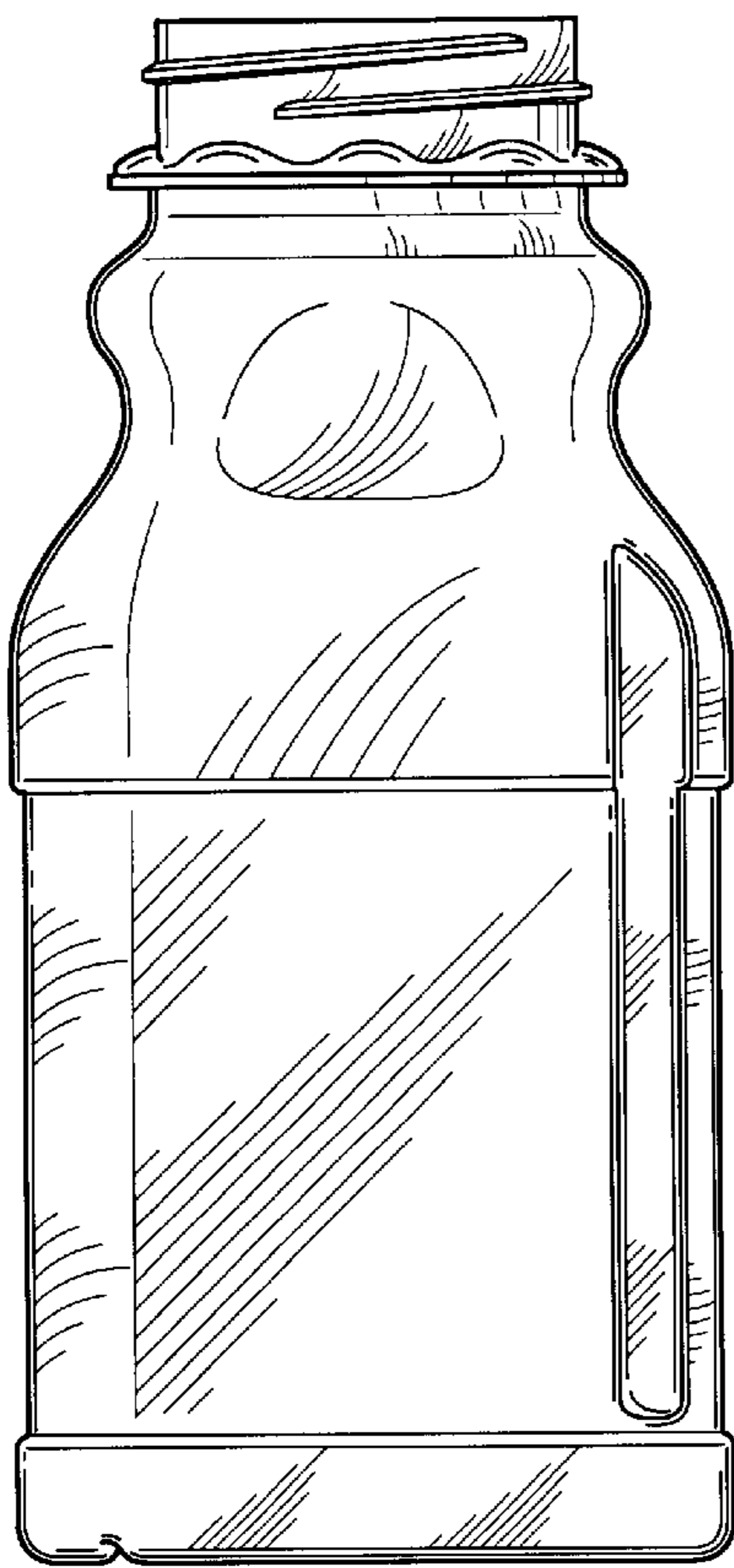

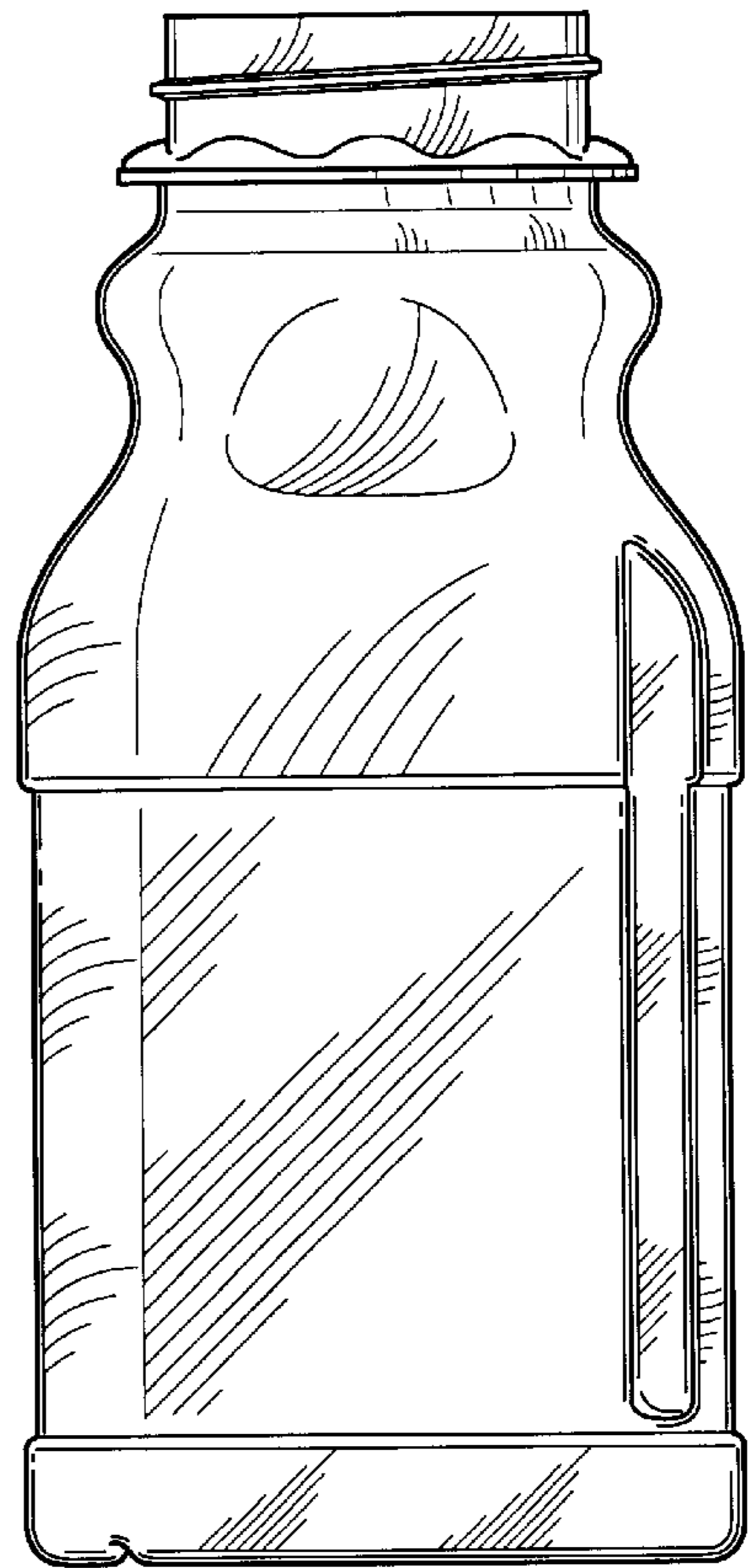

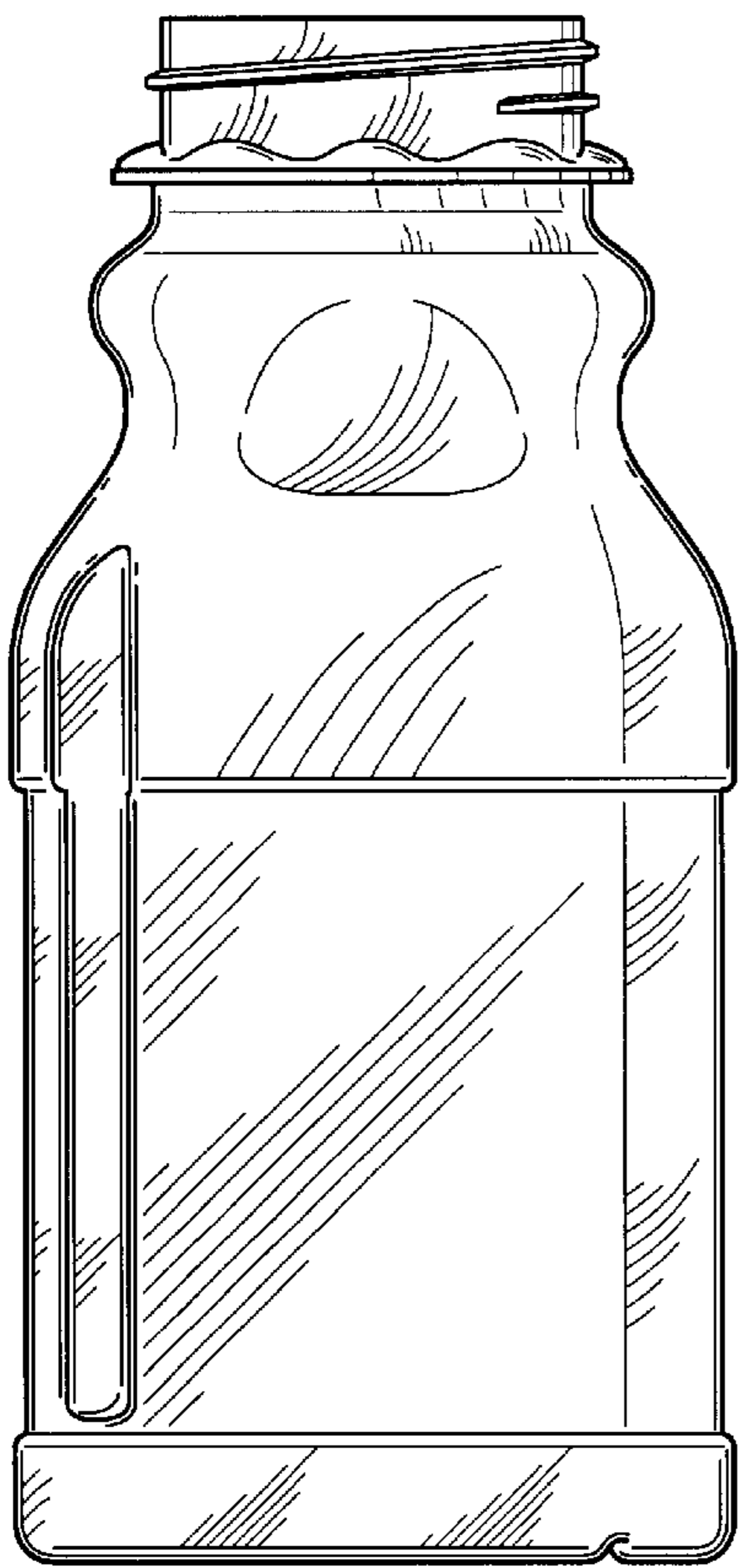

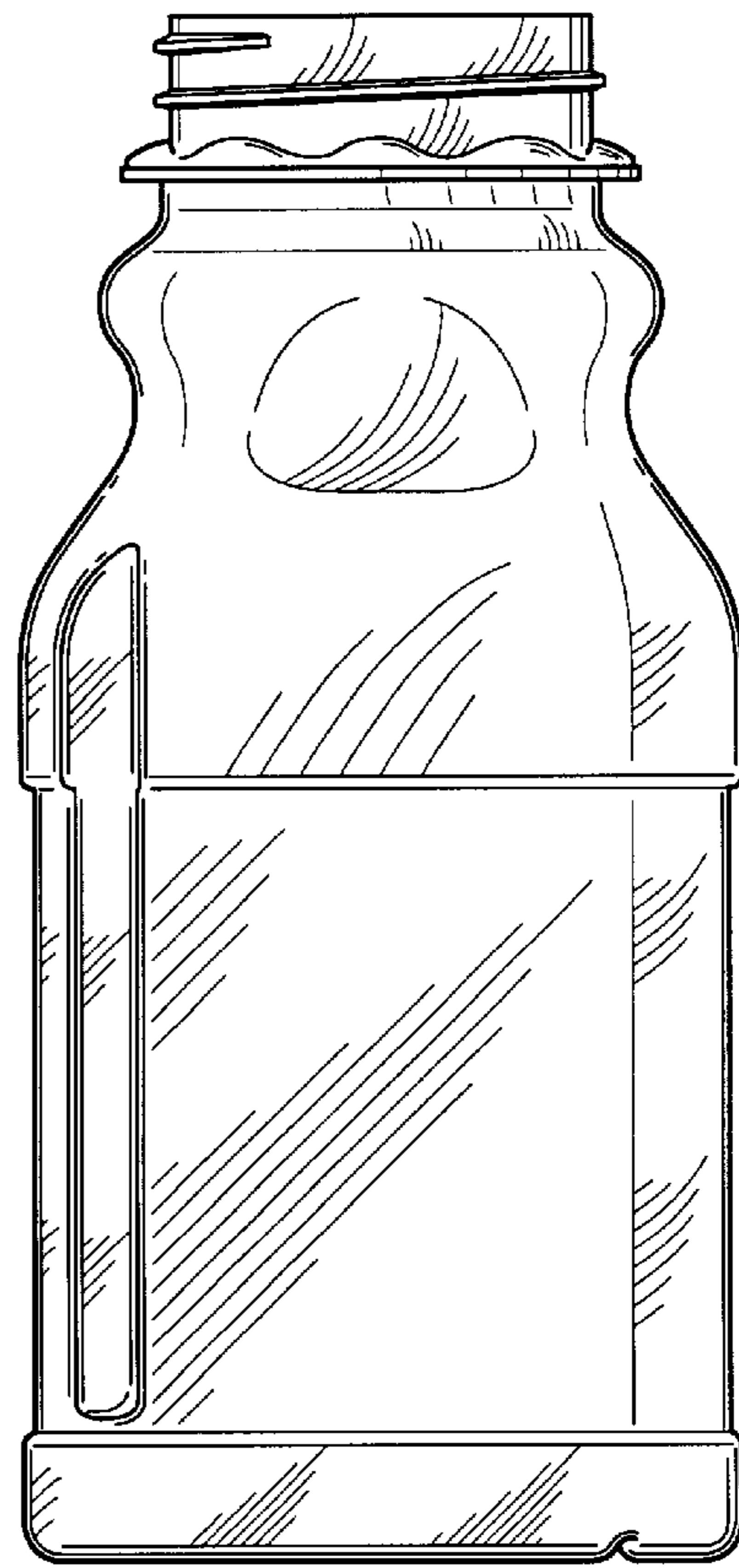

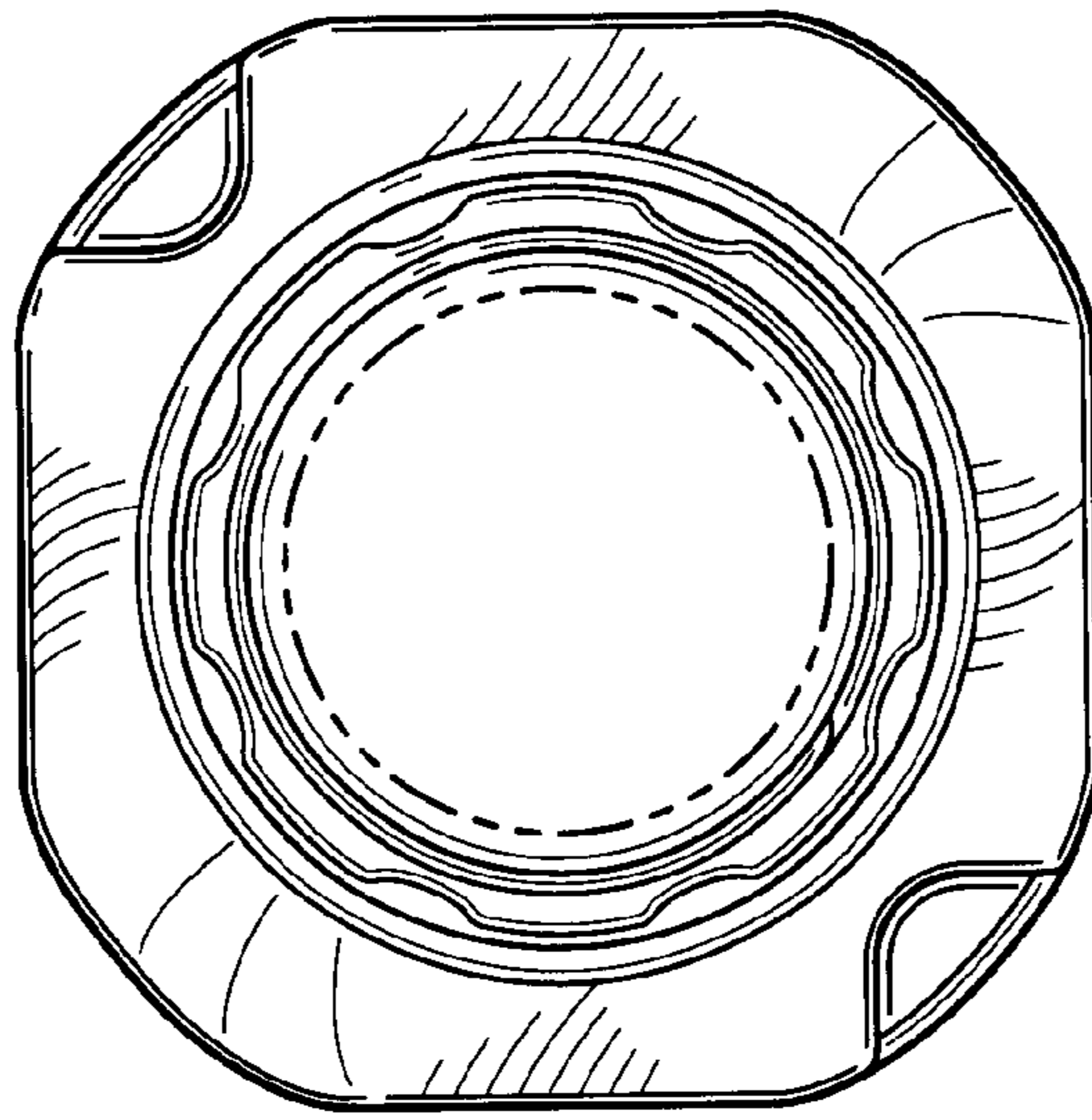

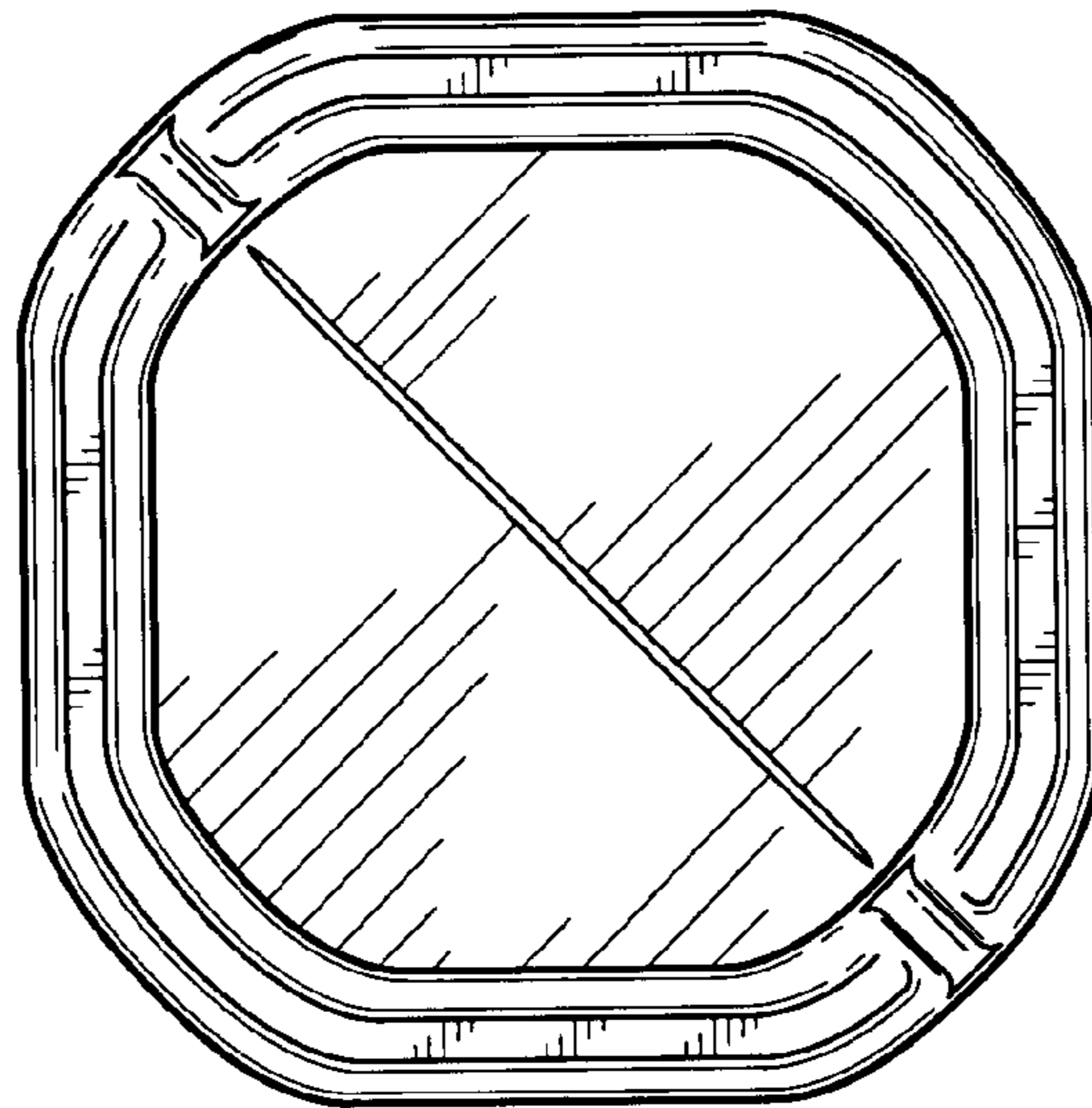
