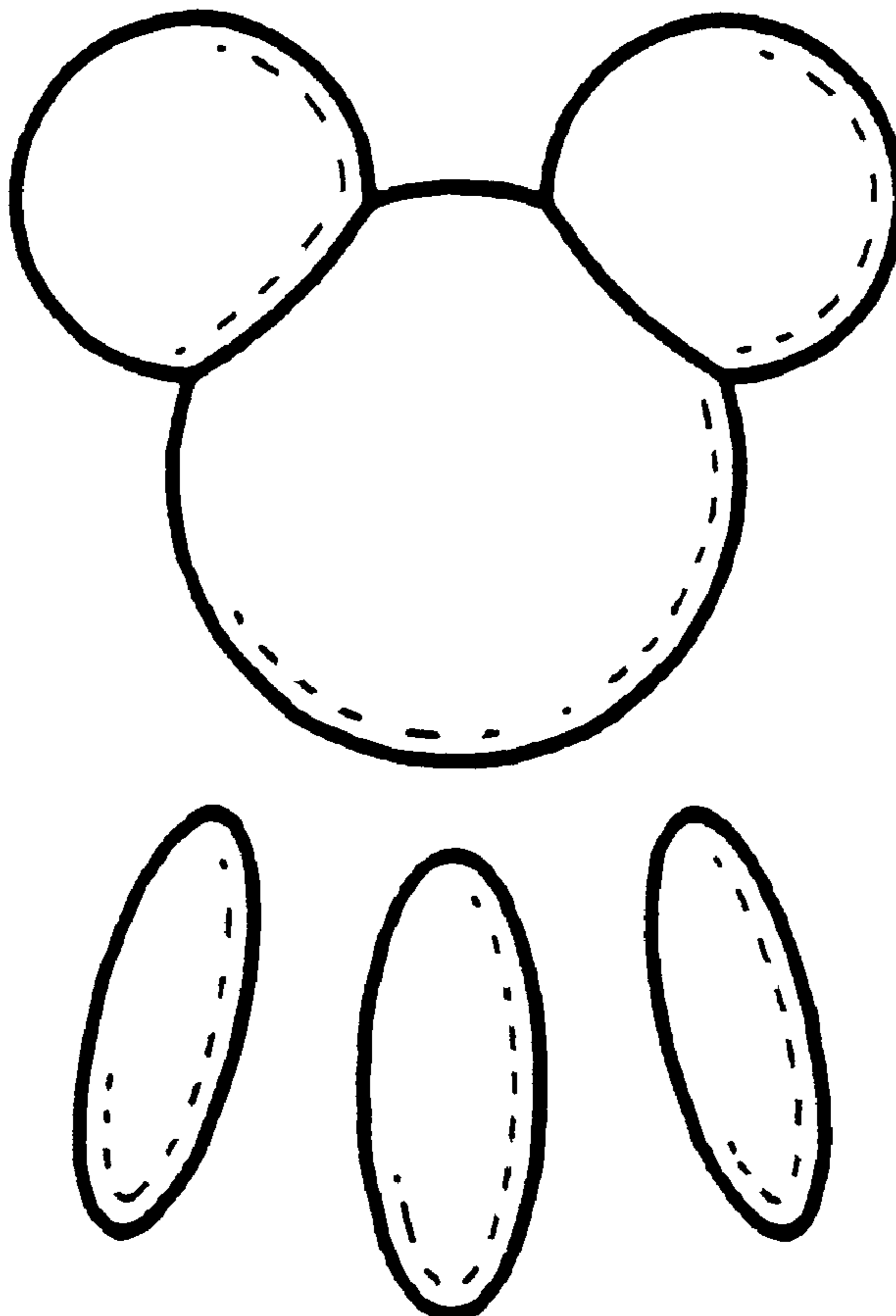
The ornamental design for a set of buttons for operating an electric device, as shown and described.

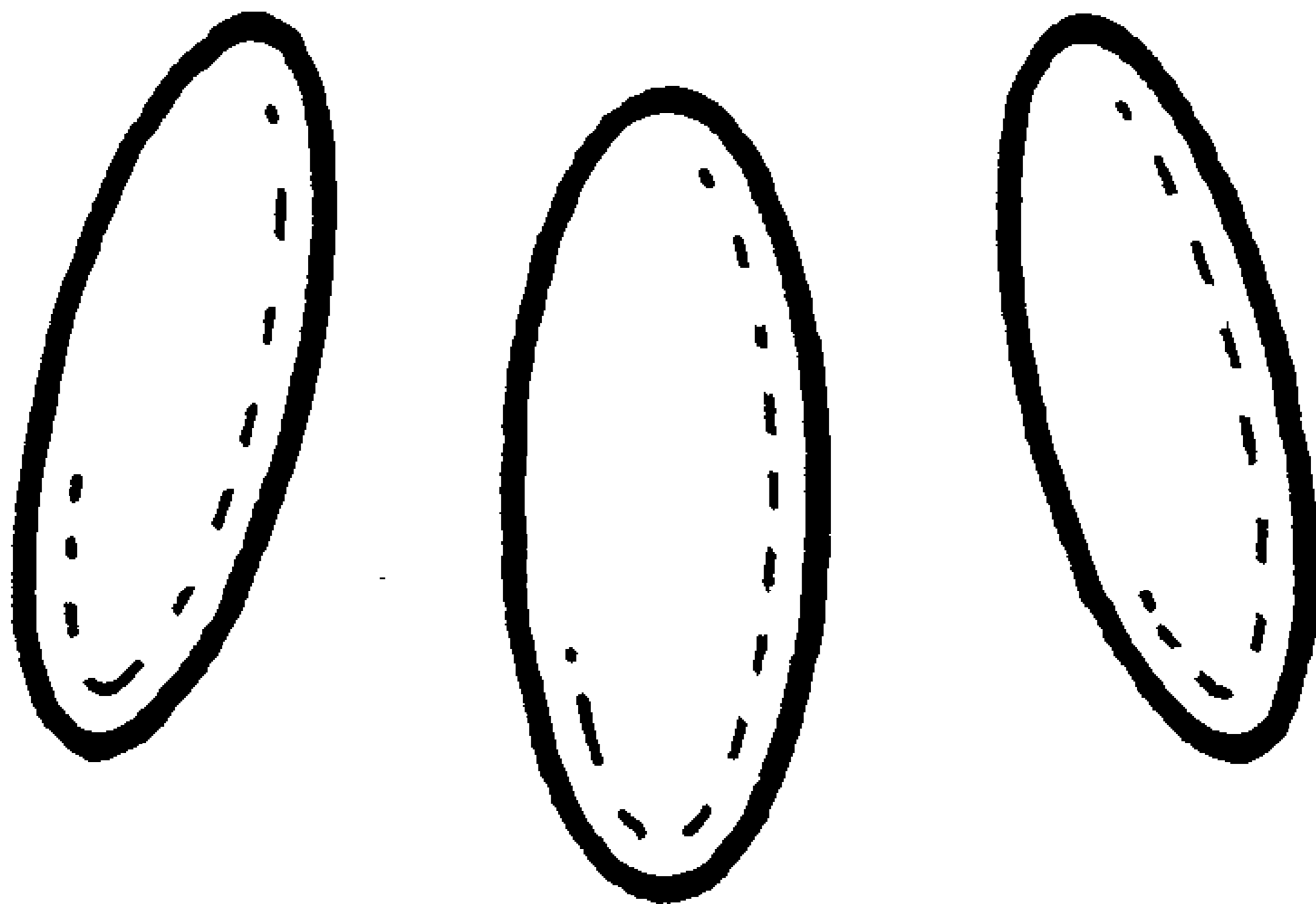
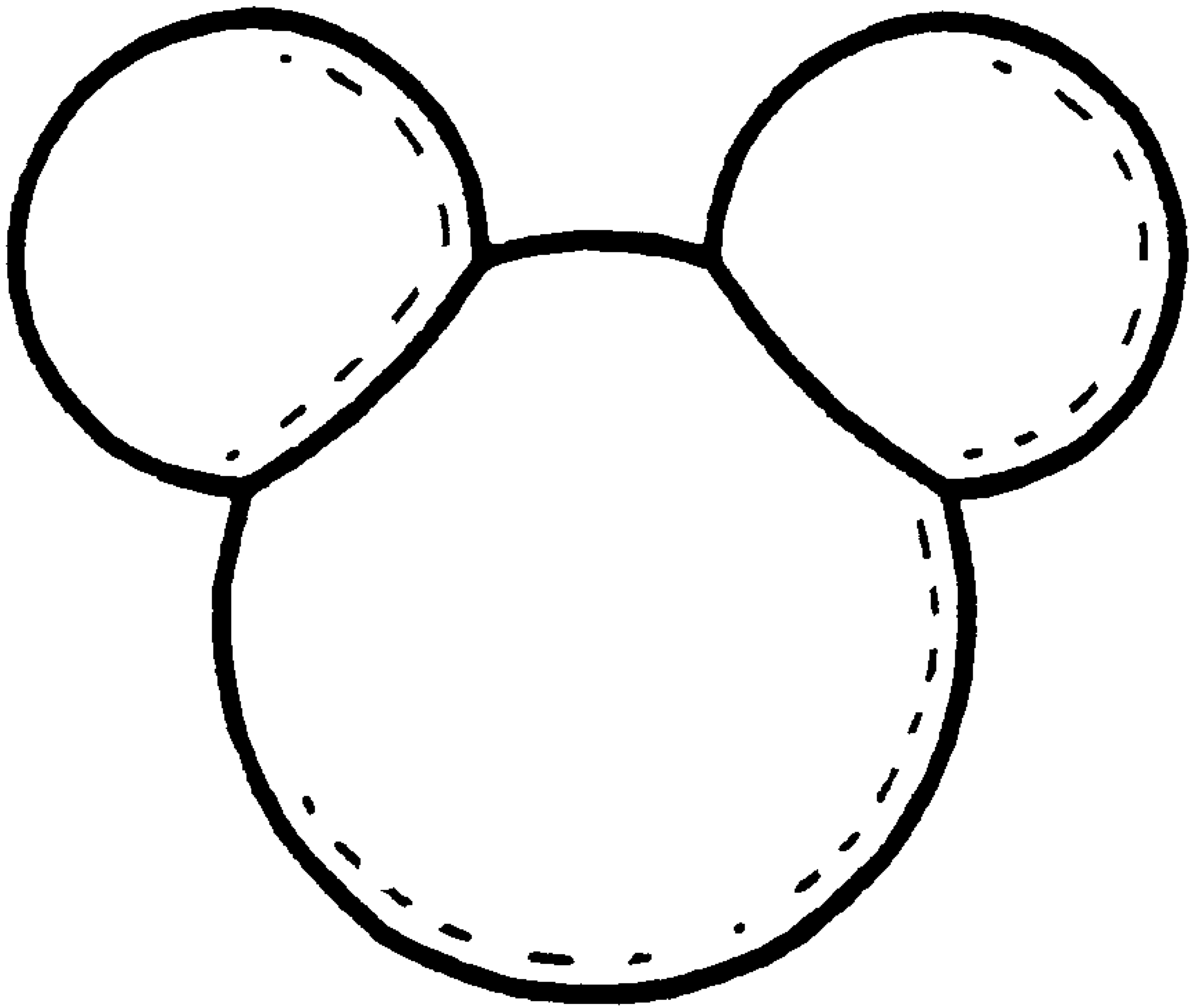
DESCRIPTION
