FIG. 2 is a second perspective view of the mobile payment terminal of FIG. 1.

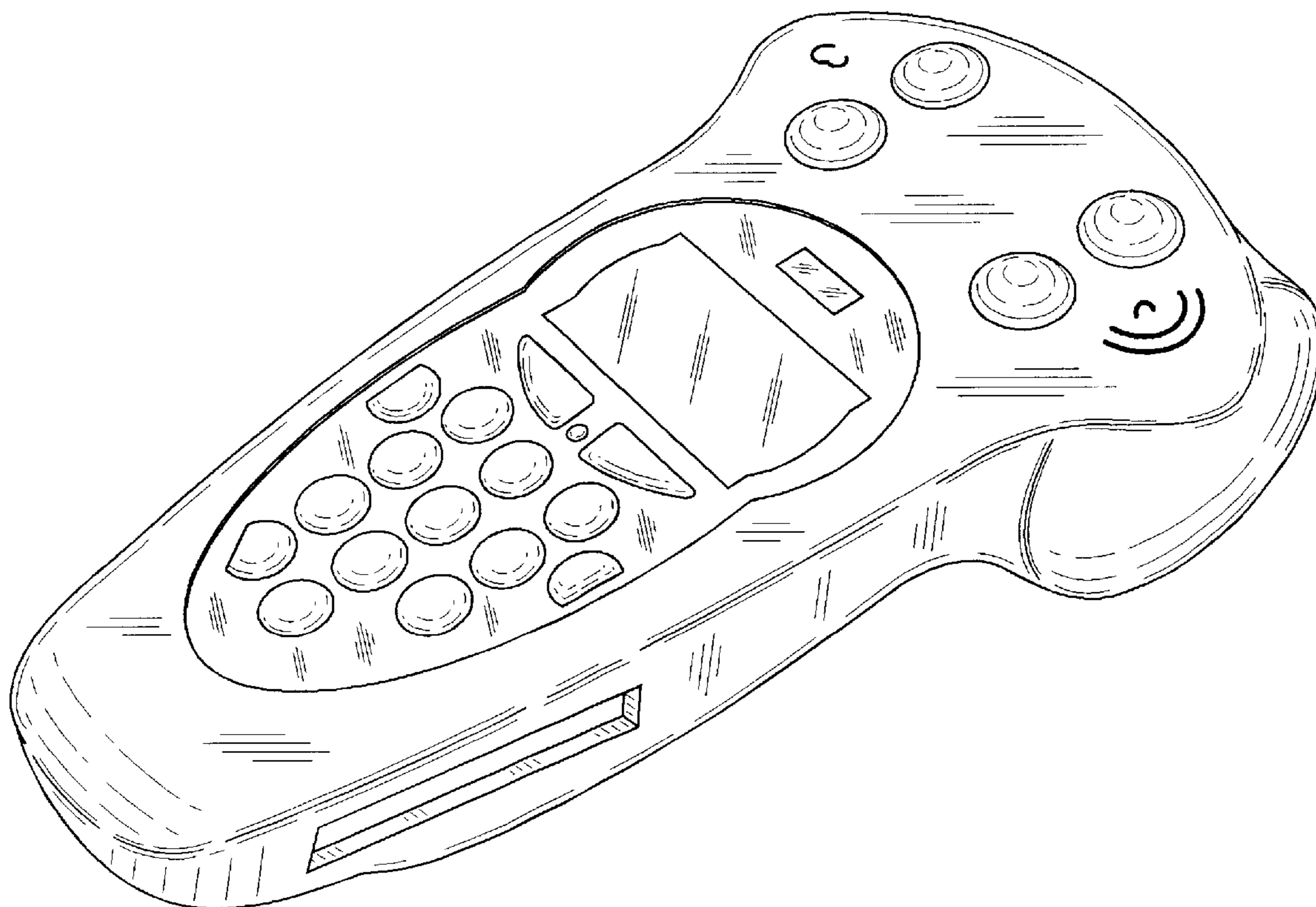
FIG. 3 is a third perspective view of the mobile payment terminal of FIG. 1.

FIG. 5 is a top plan view of the mobile payment terminal of FIG. 1; and,

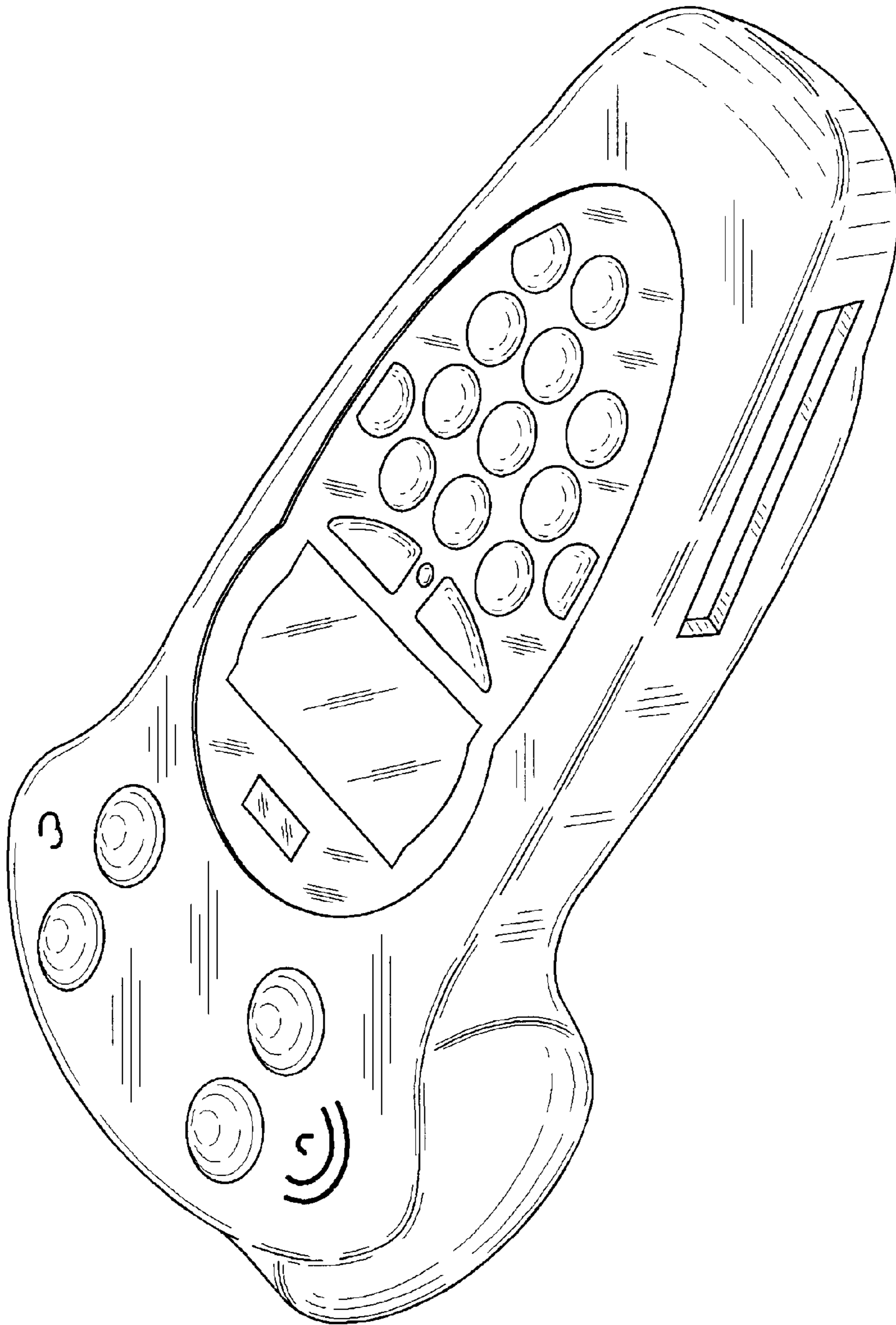
FIG. 6 is a bottom view of the mobile payment terminal of FIG. 1.

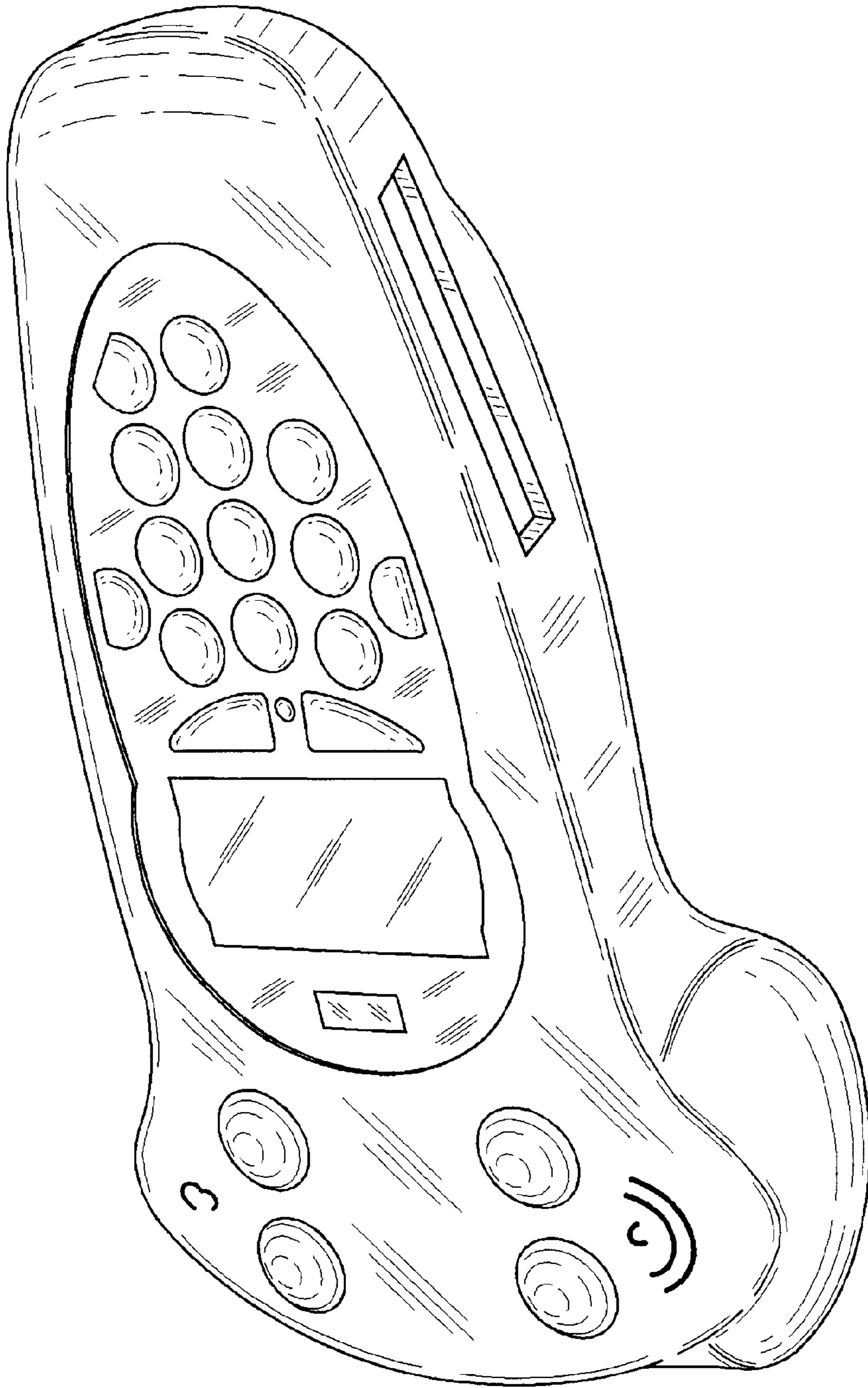




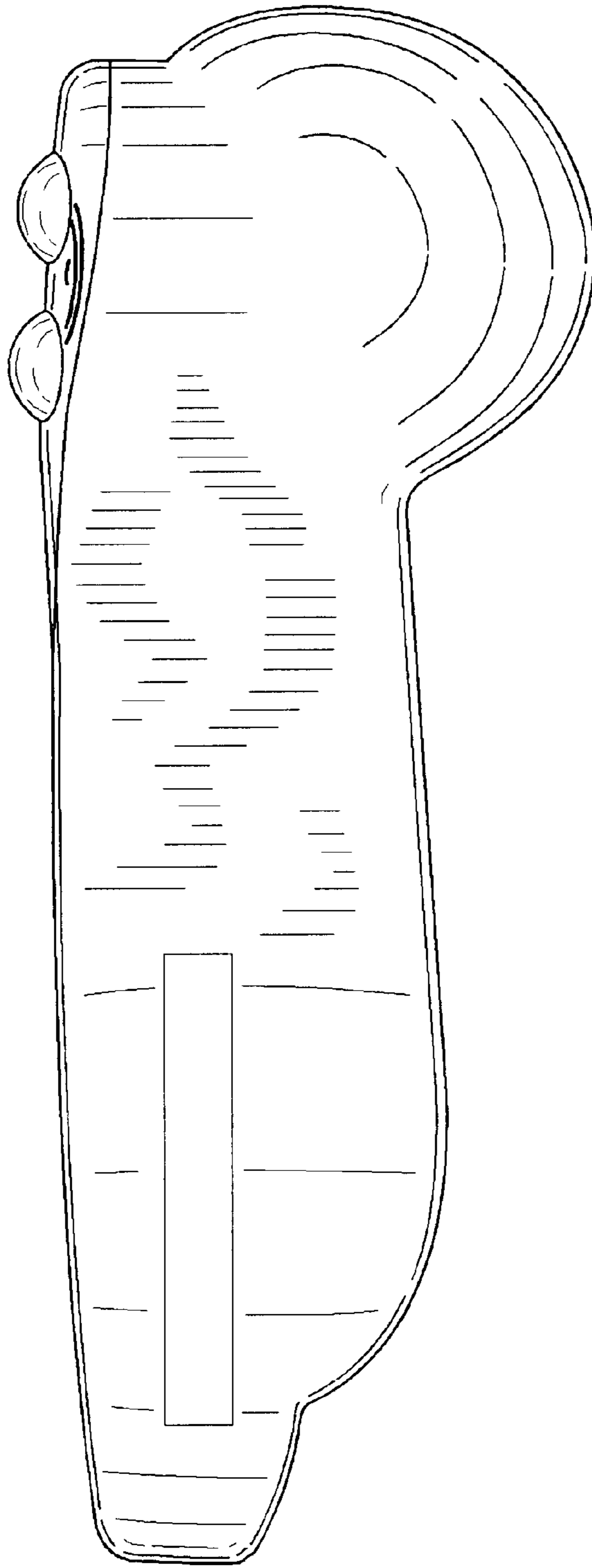

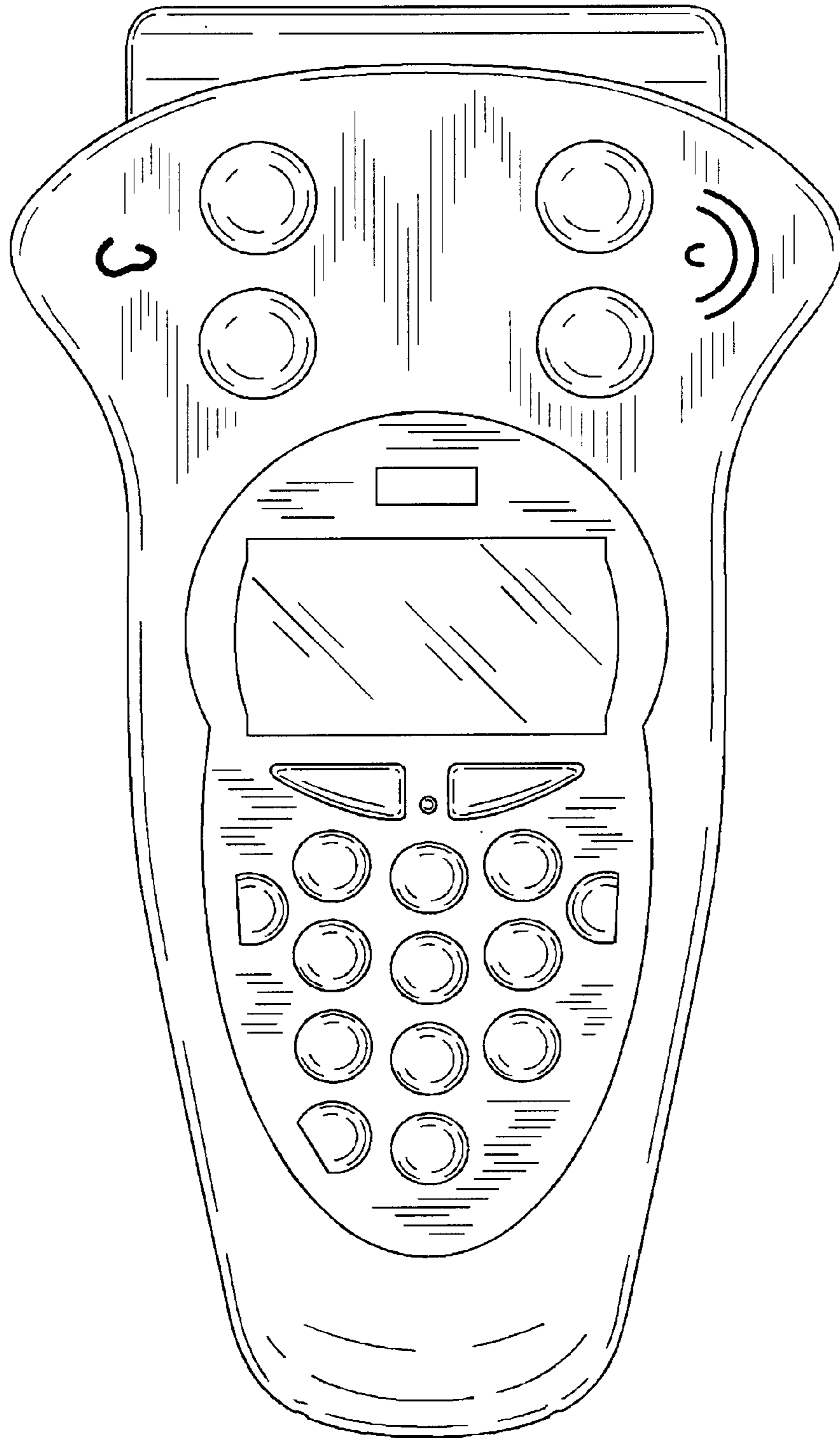

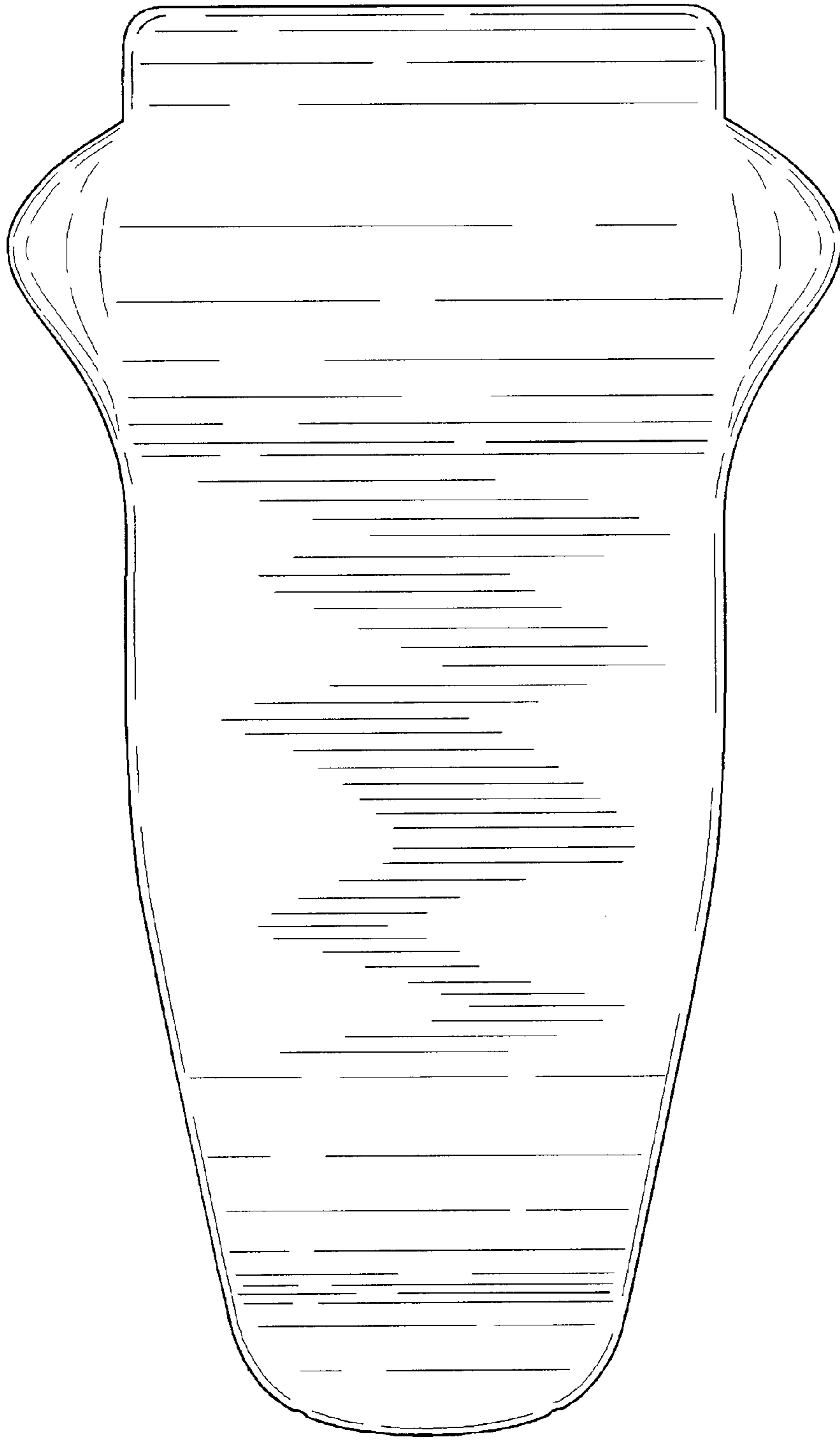
