The ornamental design for a clip for attachment to a clipboard holding paper and other objects, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing the top left and front of the clip for attachment to a clipboard holding paper and other objects;

FIG. 4 is a left side elevational view thereof;

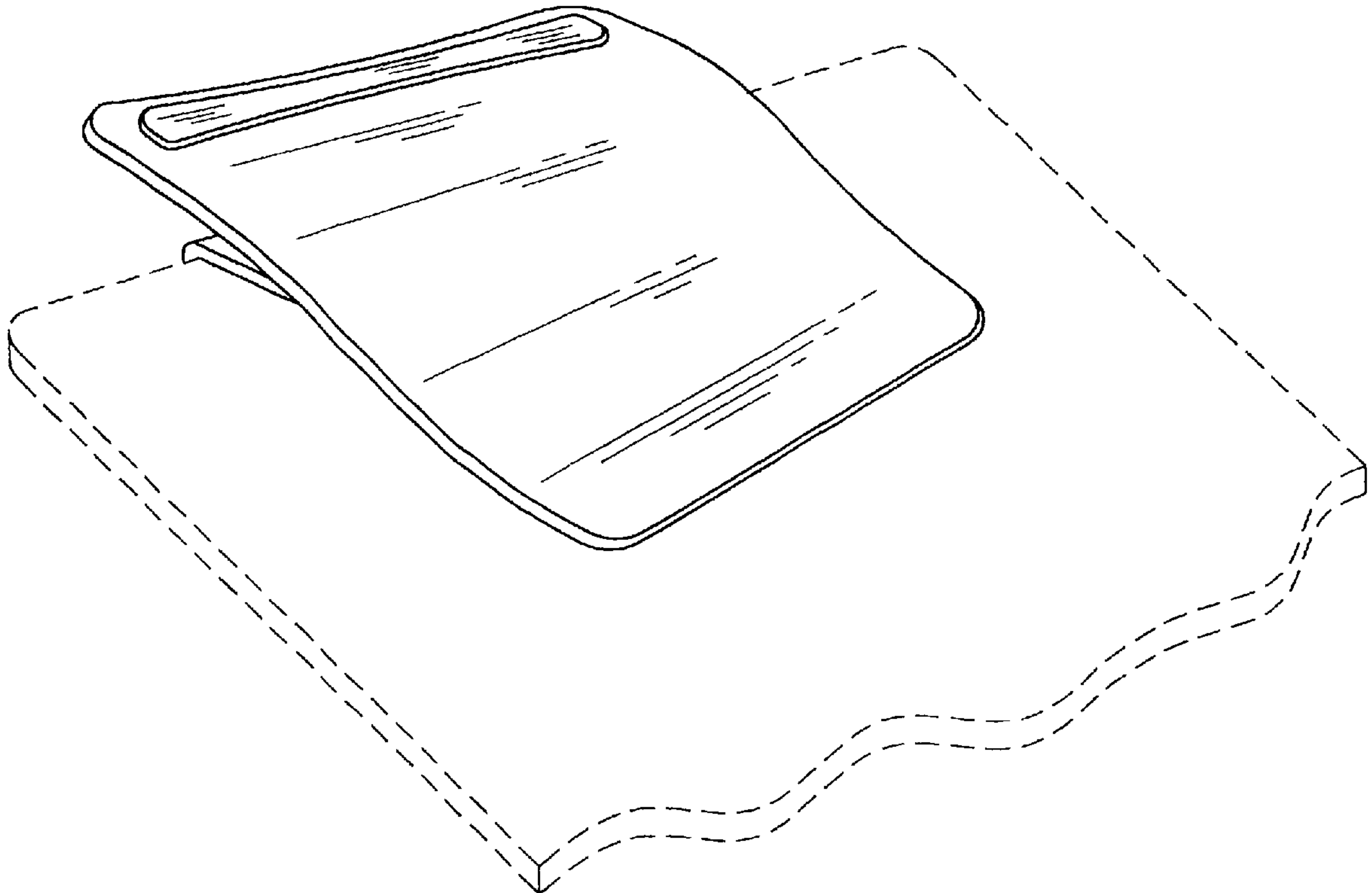
FIG. 5 is a right side elevational view thereof;

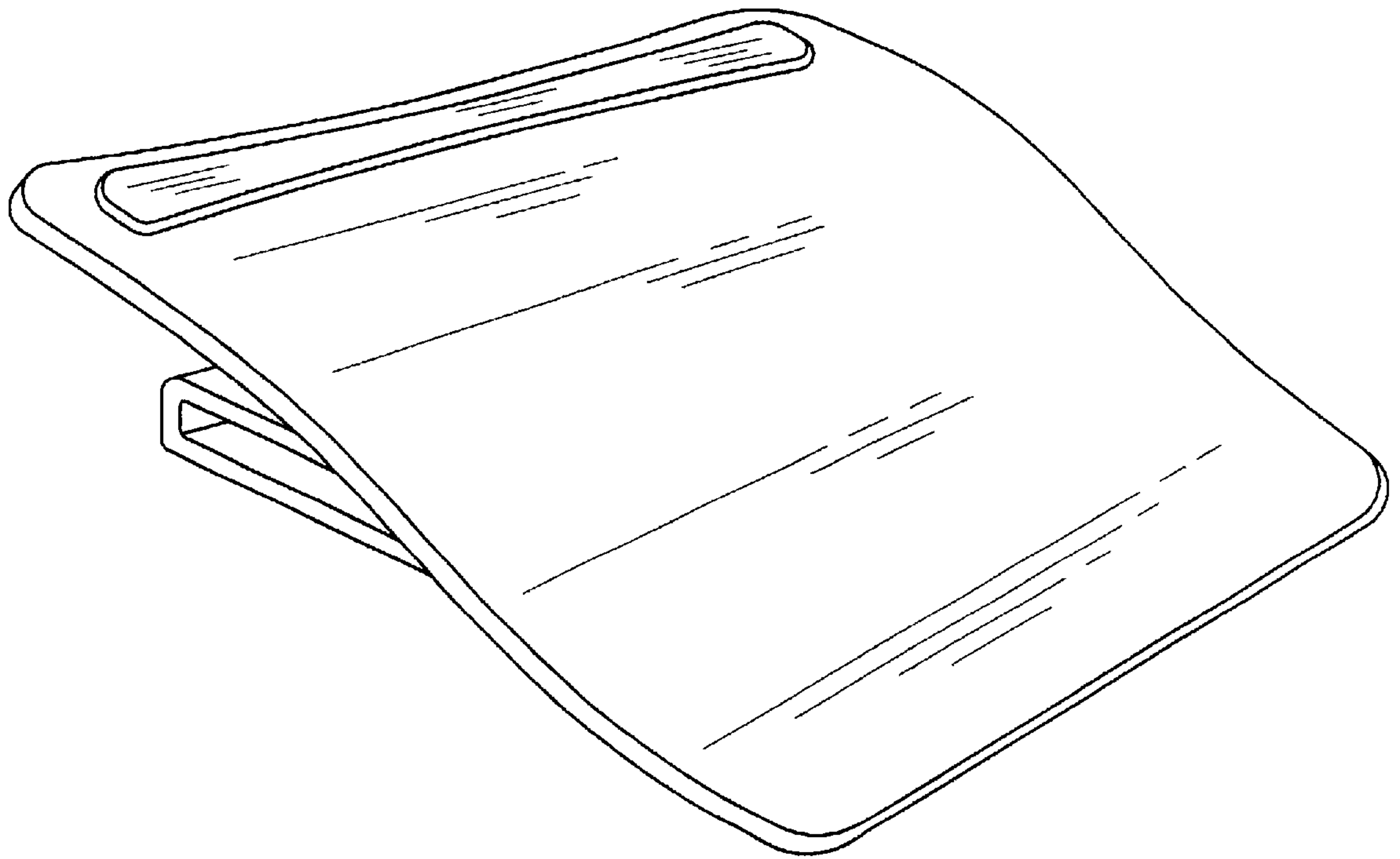

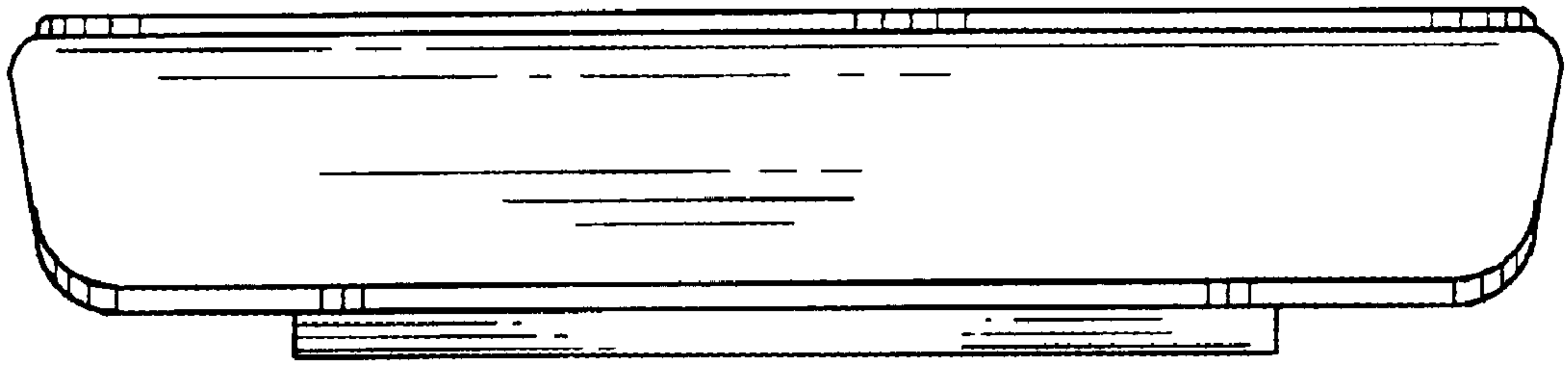

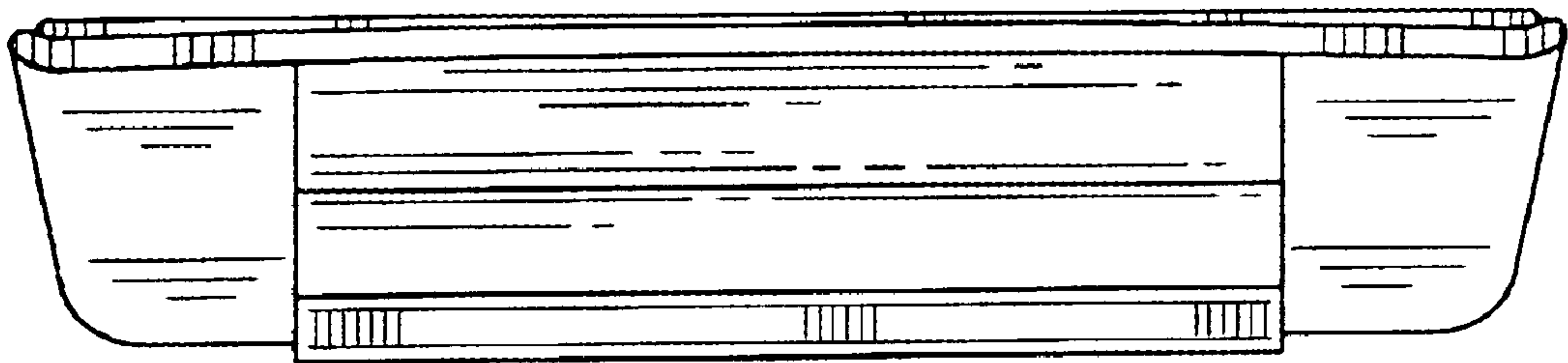

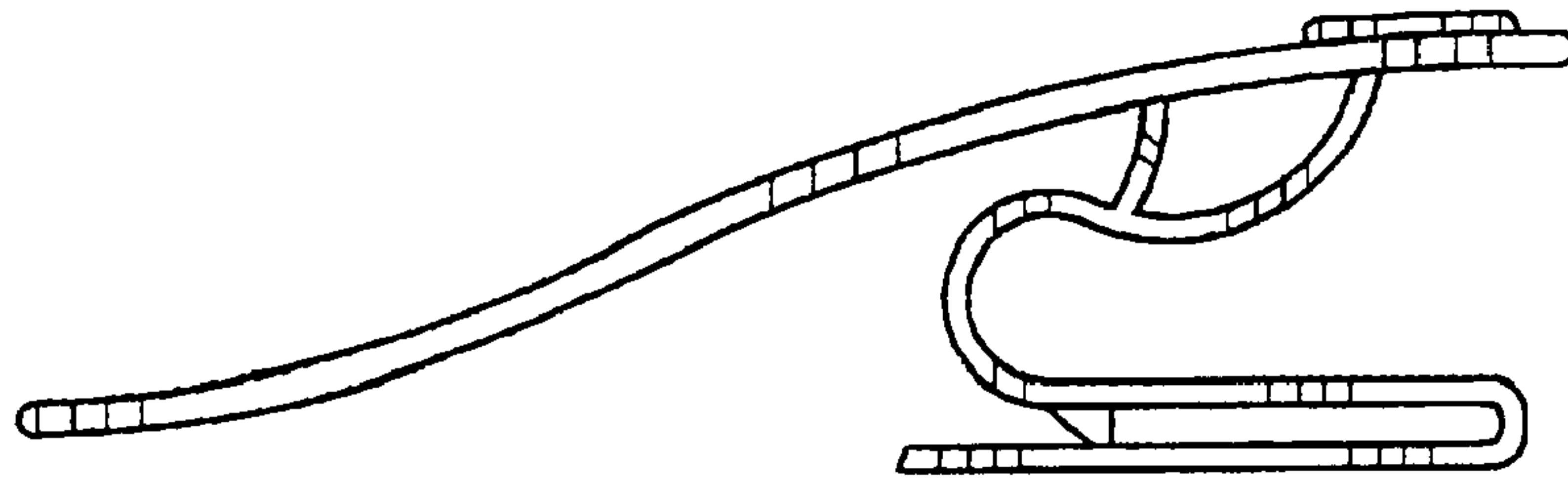

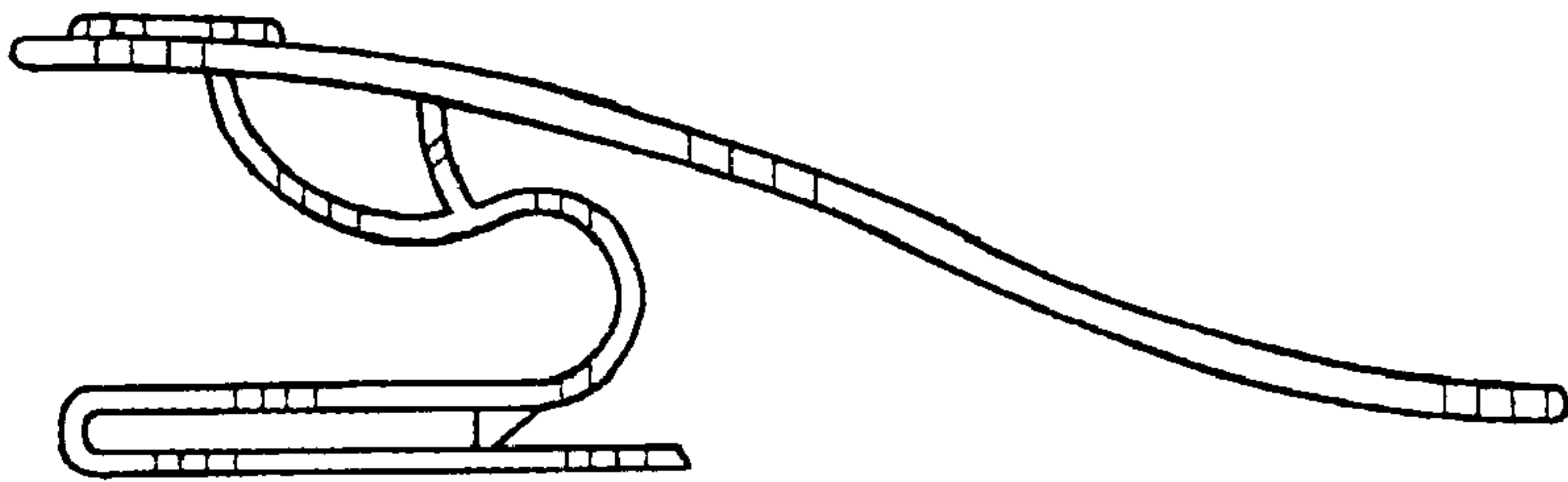

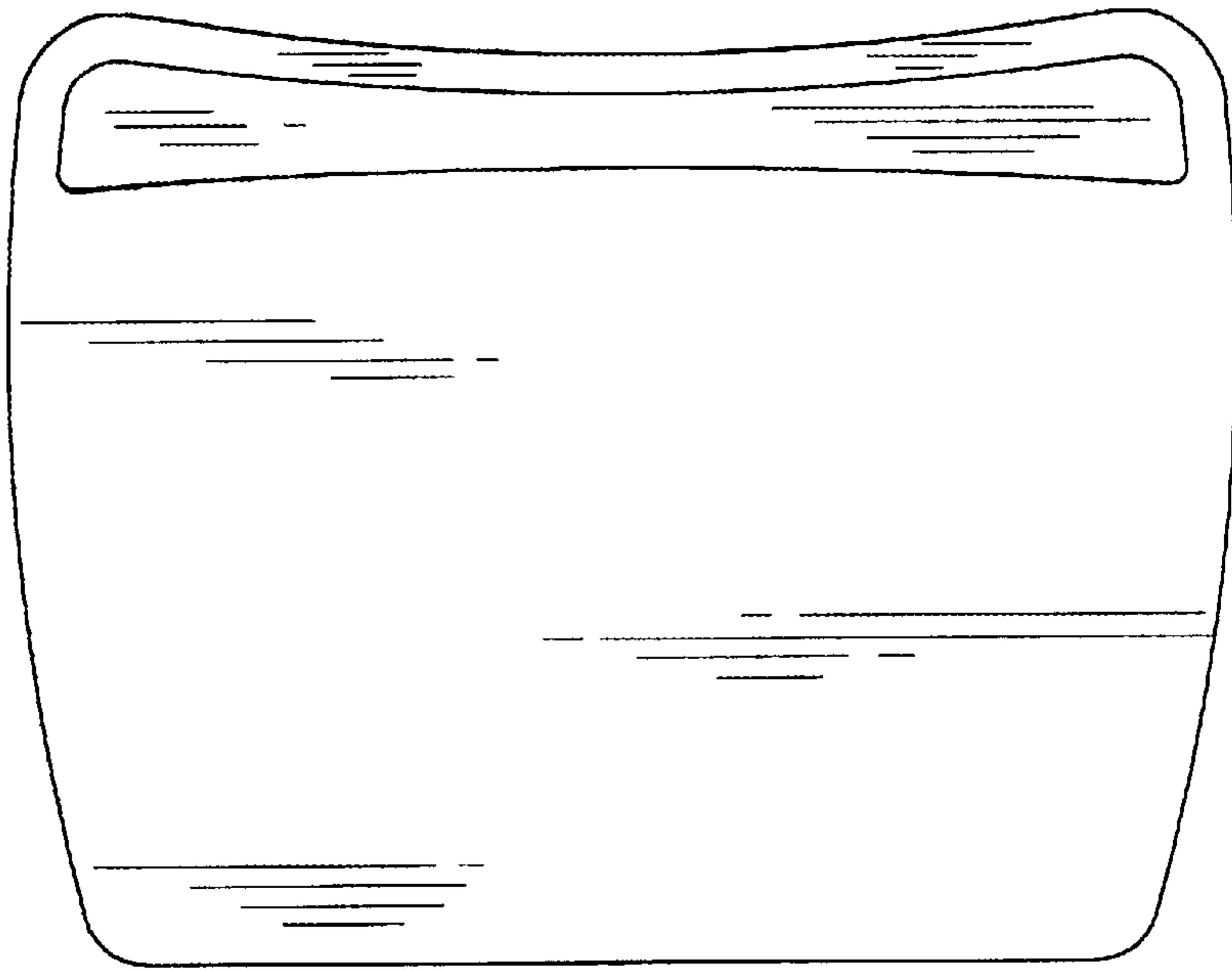

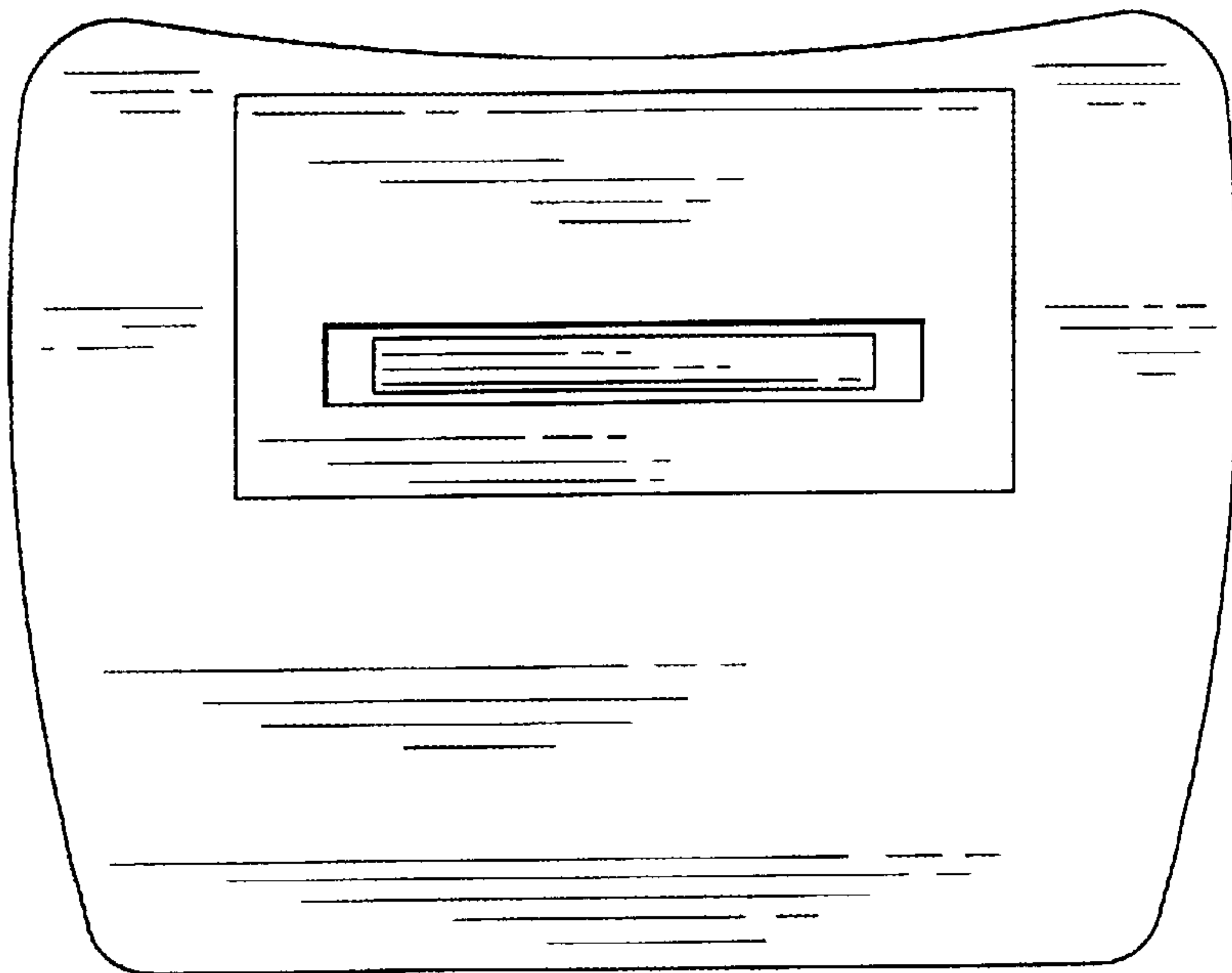

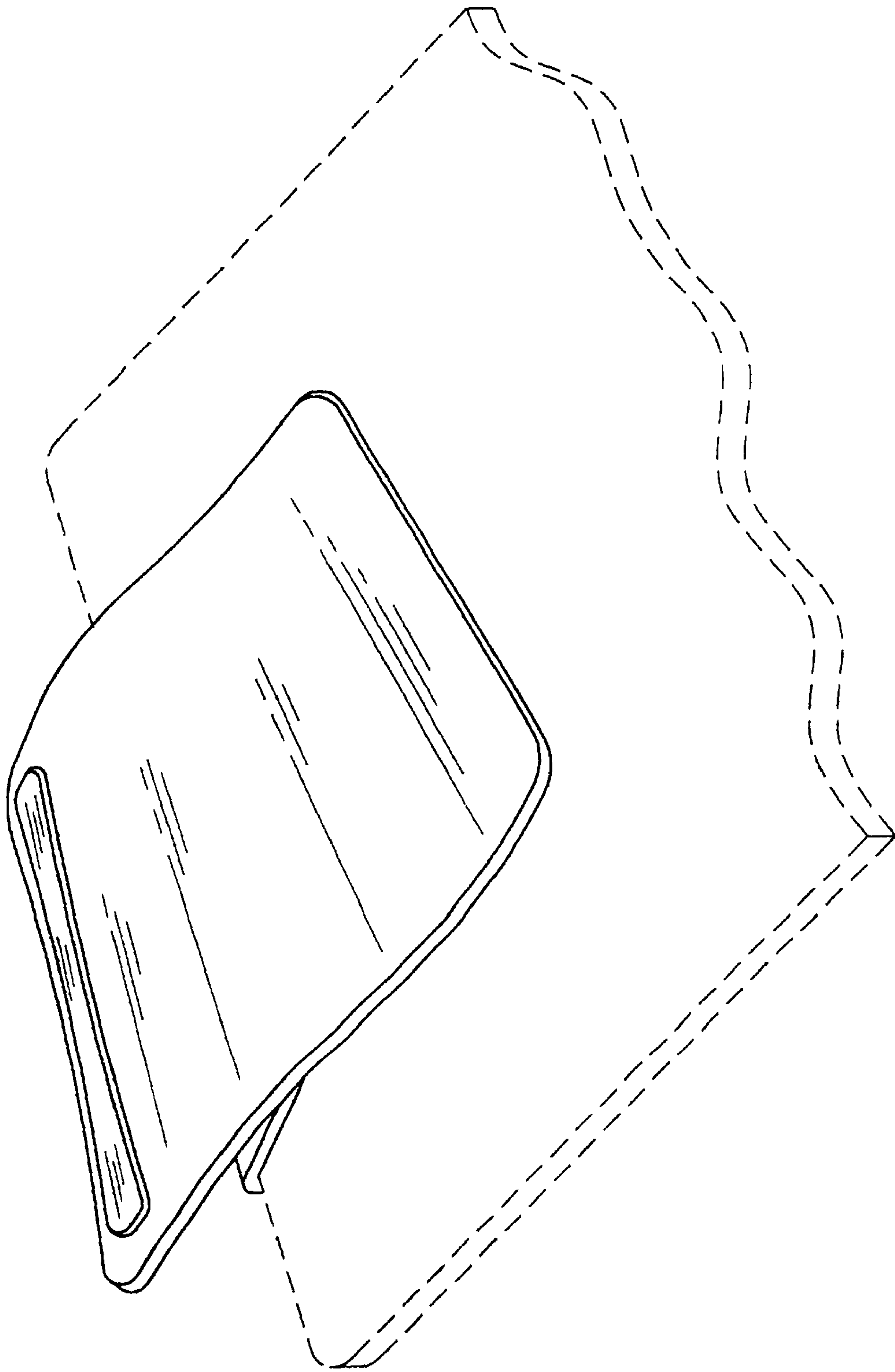
