(57) **CLAIM**

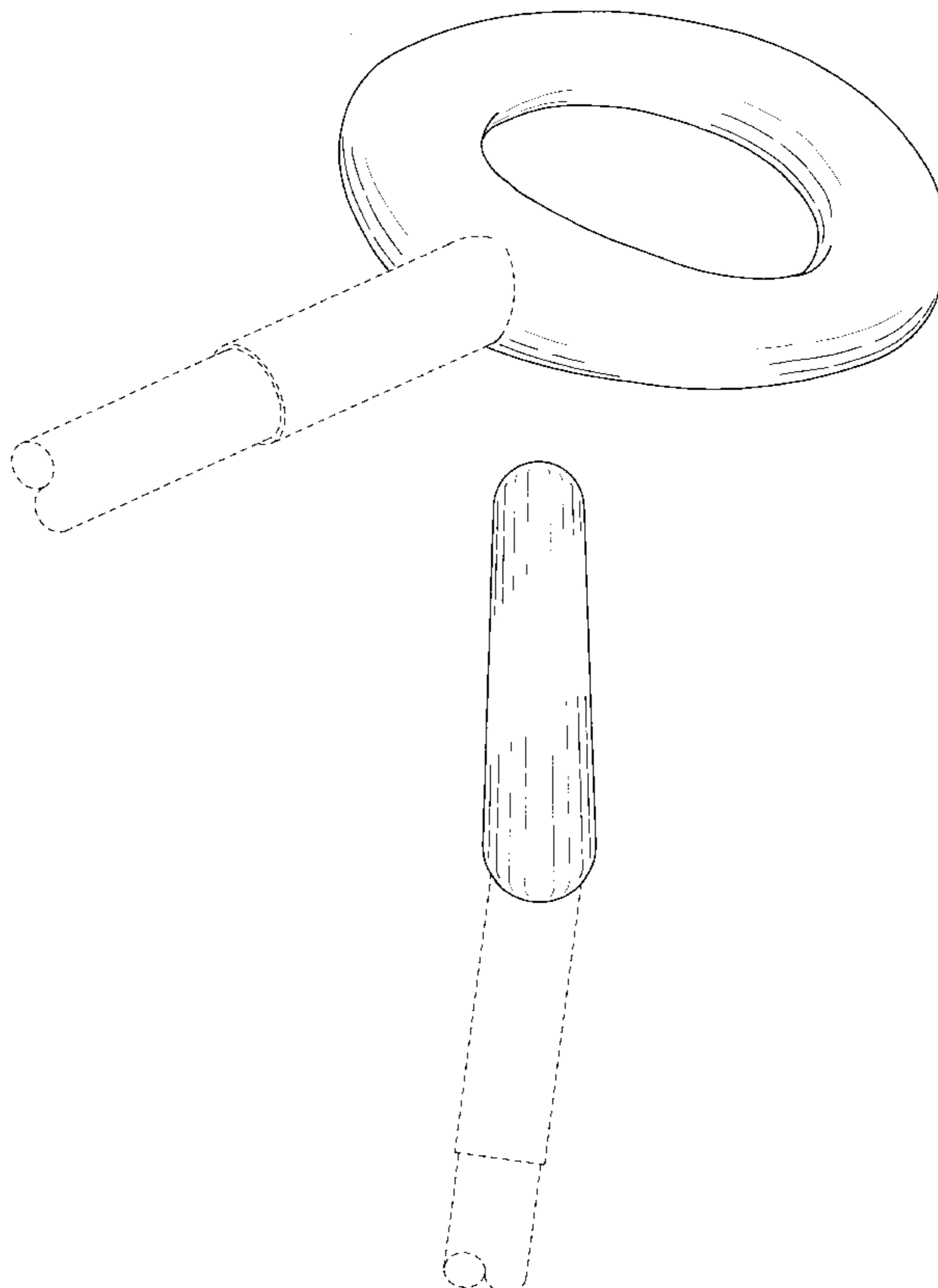
We claim the ornamental design for the handle for a hand tool, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a handle for a hand tool; FIG. 2 is a front view of the handle for a hand tool shown in FIG. 1, the rear view of the handle is substantially identical; FIG. 3 is a right side view of the handle for a hand tool shown in FIG. 1; FIG. 4 is a left side view of the handle for a hand tool shown in FIG. 1; FIG. 5 is a top view of the handle for a hand tool shown in FIG. 1; and, FIG. 6 is a bottom view of the handle for a hand tool shown in FIG. 1.

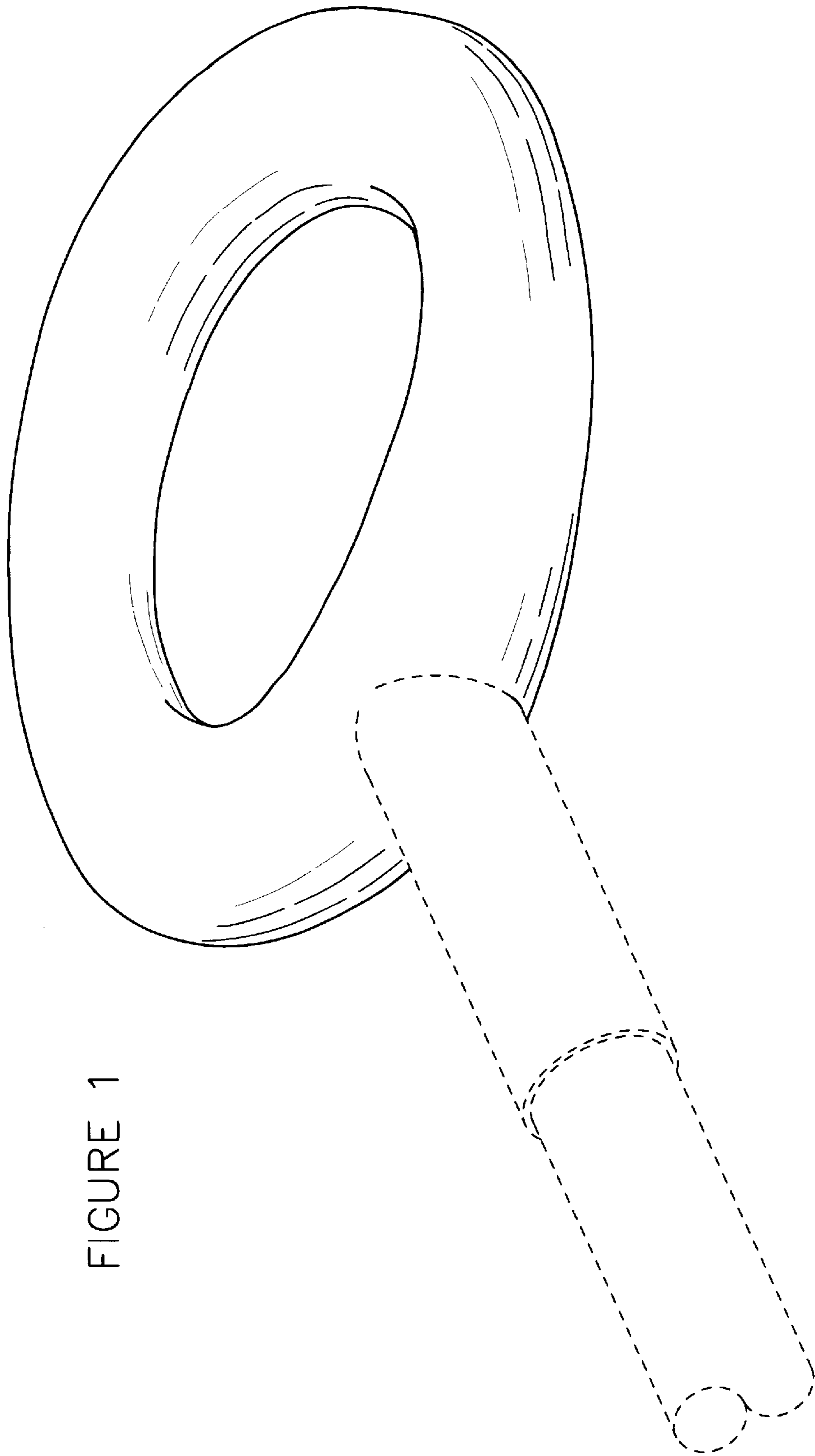

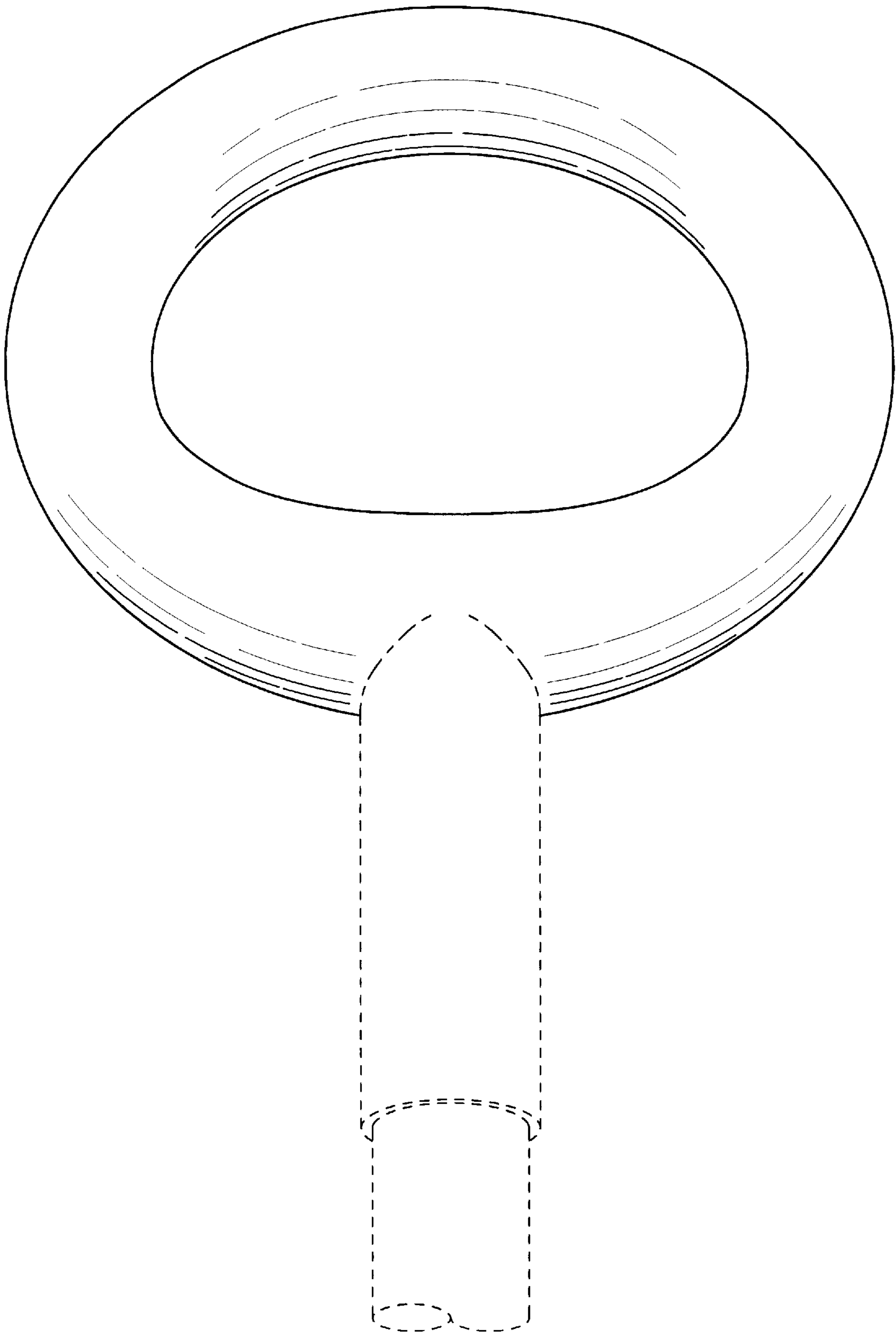

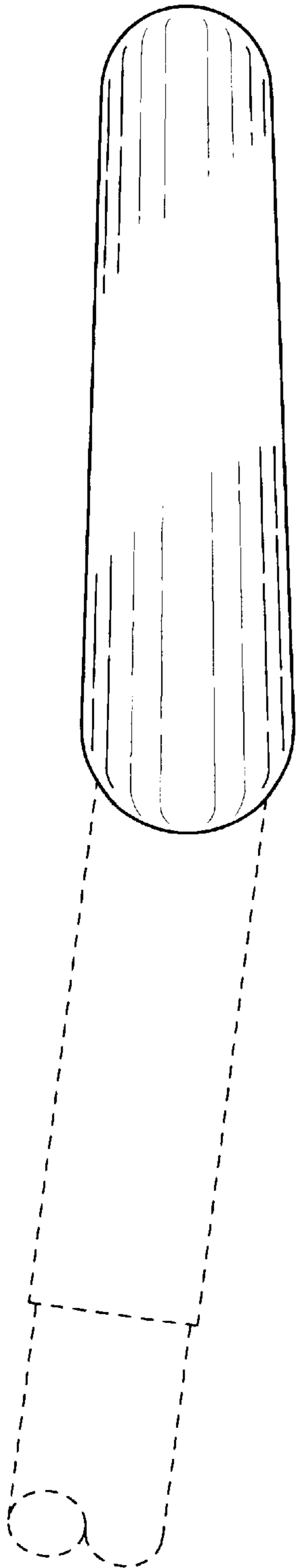

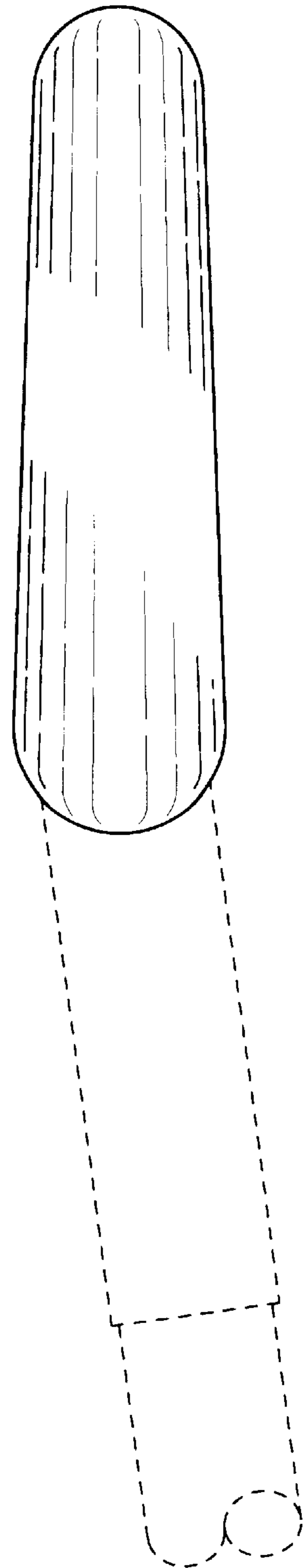

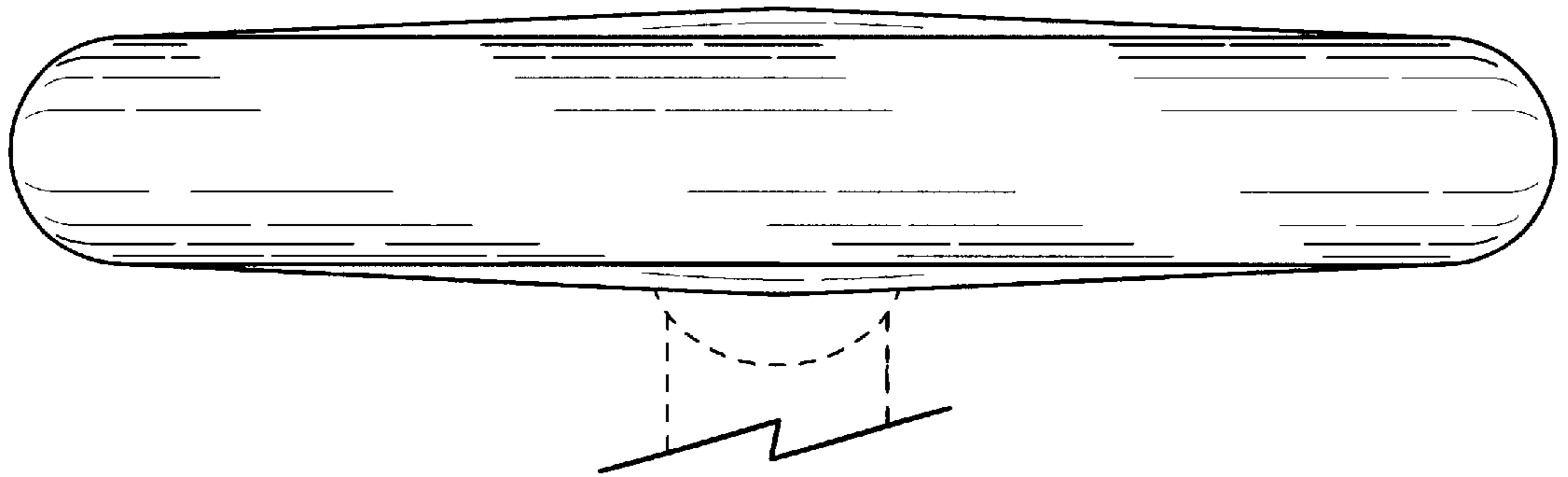
